1.3 is a rear elevation view thereof;

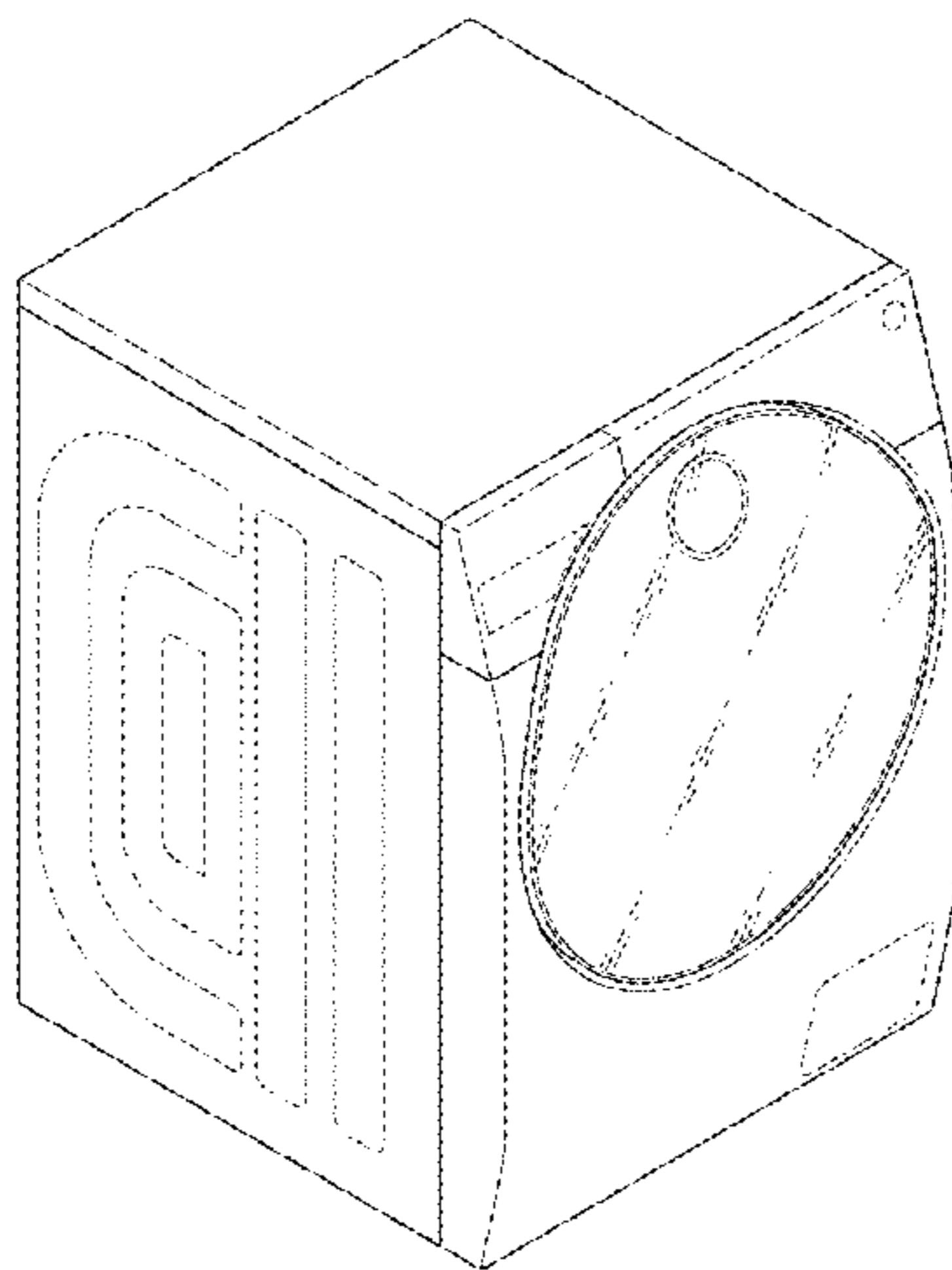
1.4 is a left-side elevation view thereof;

1.7 is a bottom plan view thereof.

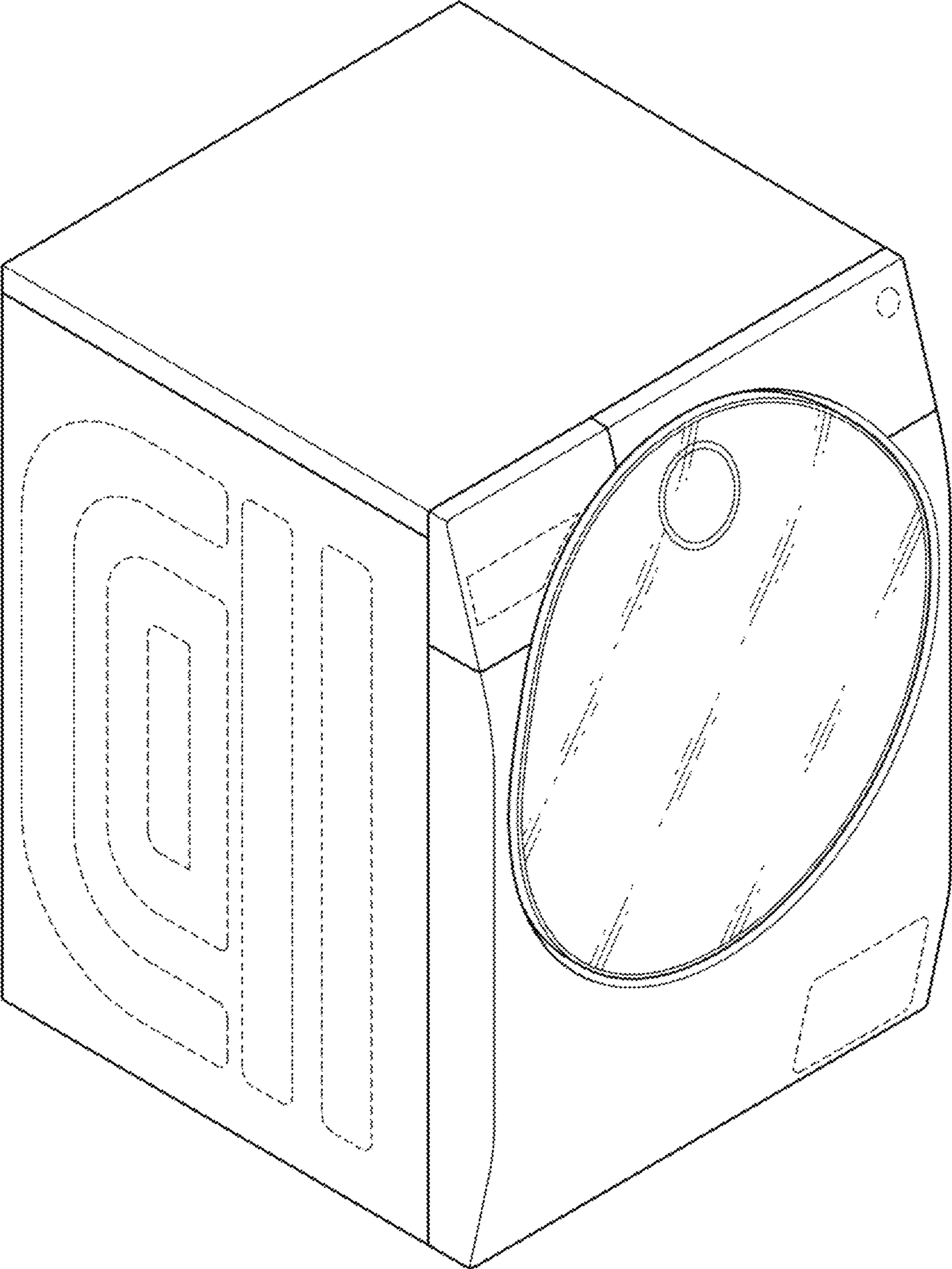

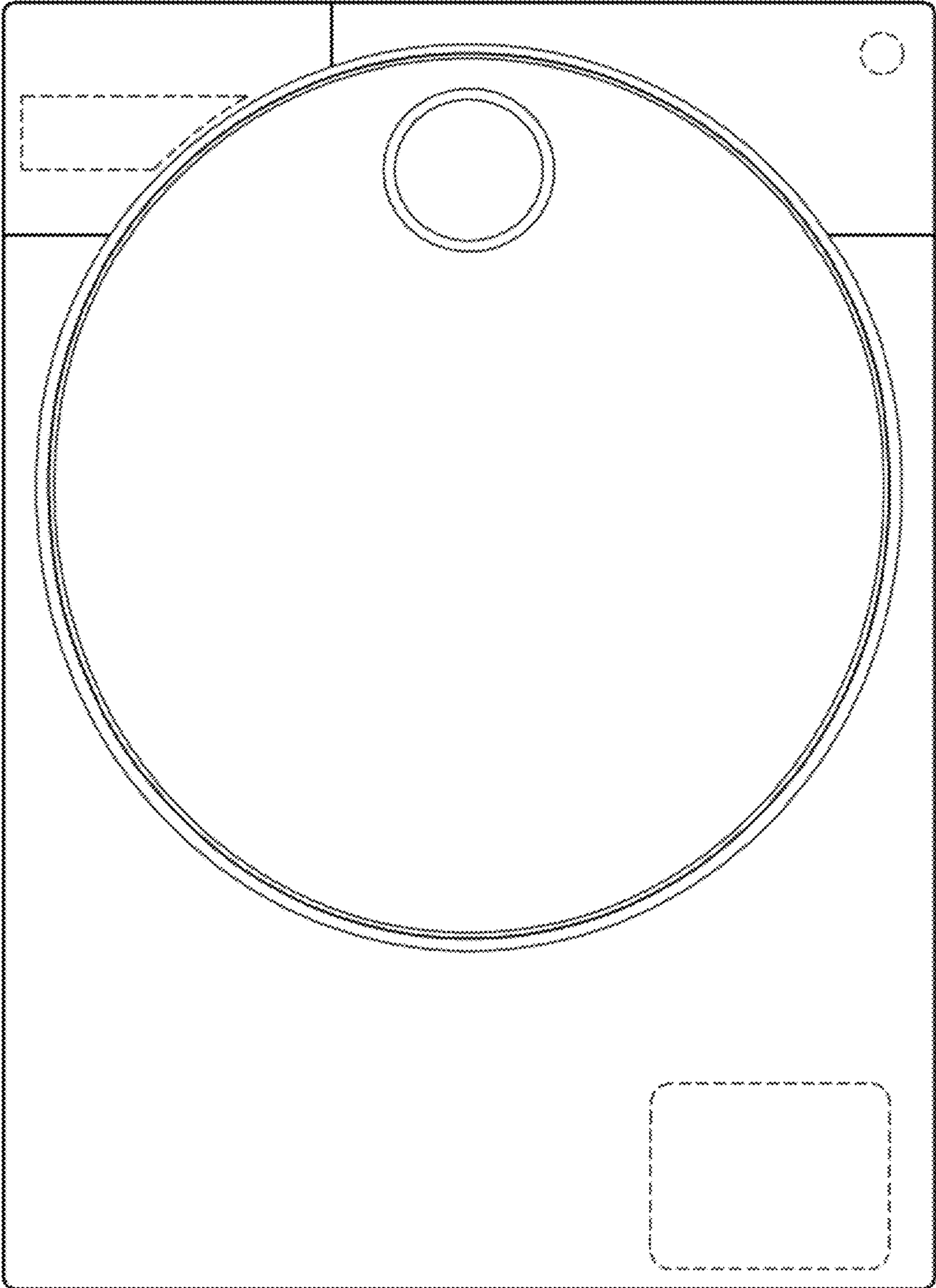
The broken lines in the figures illustrating portions of the washing machine form no part of the claimed design.

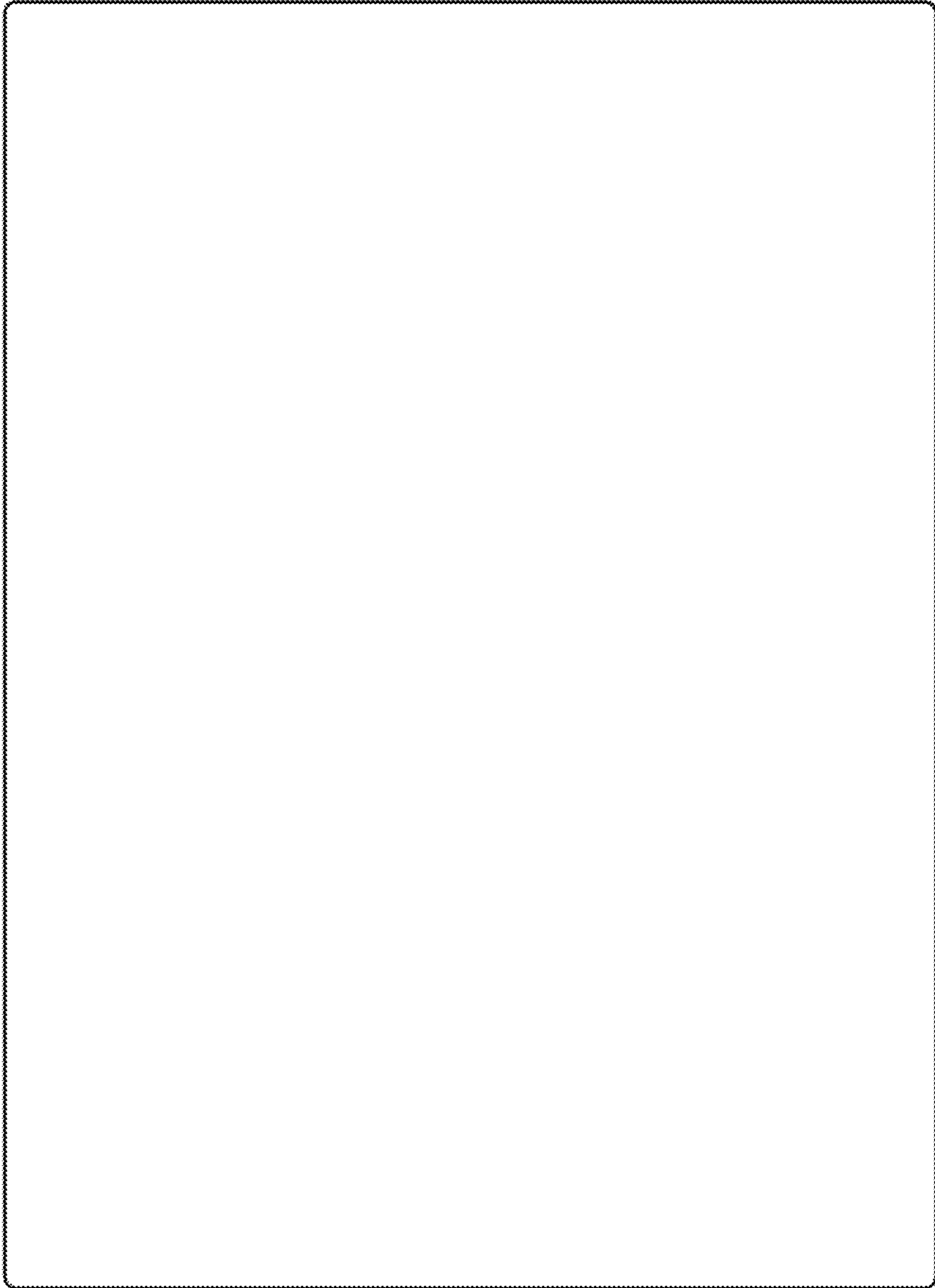

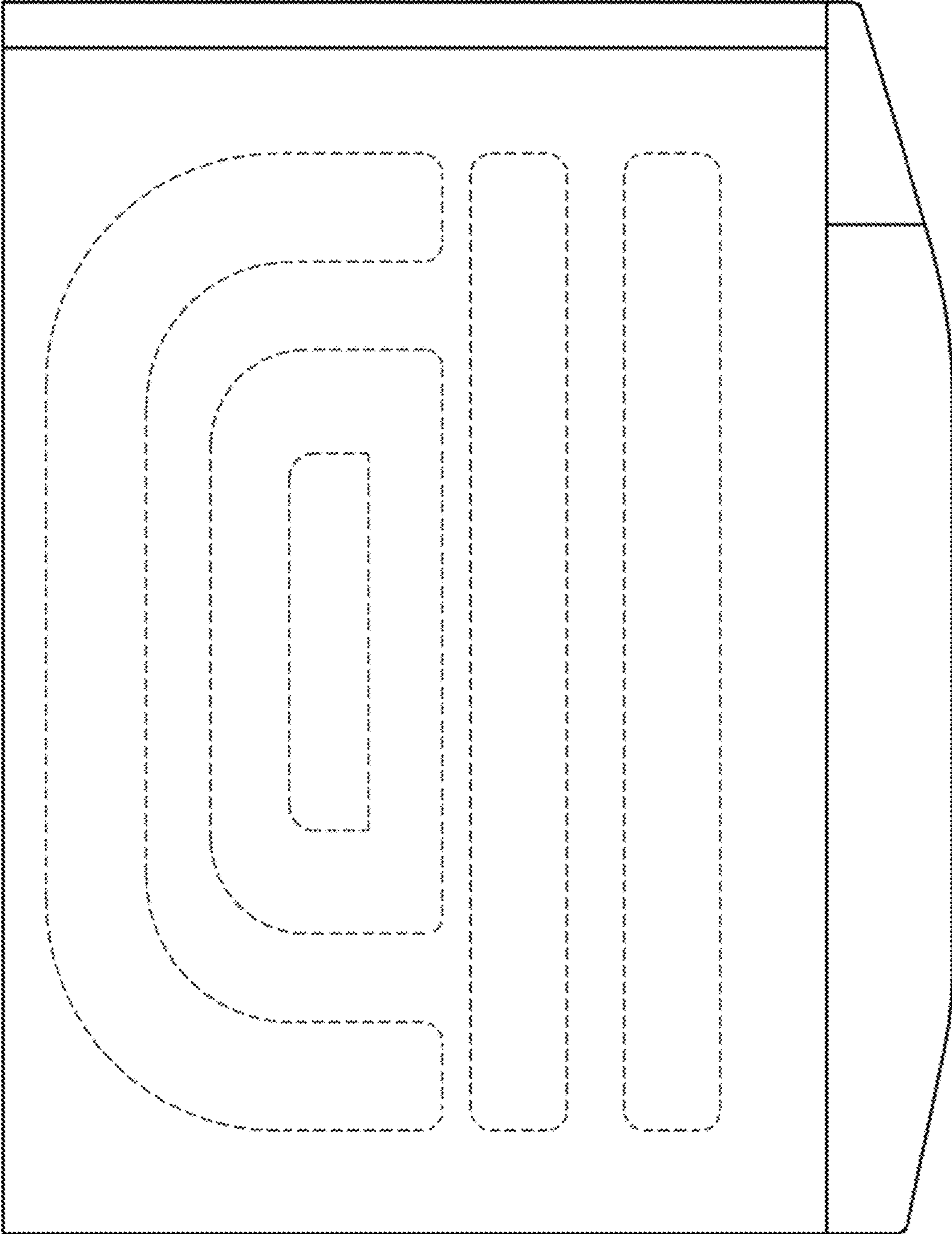

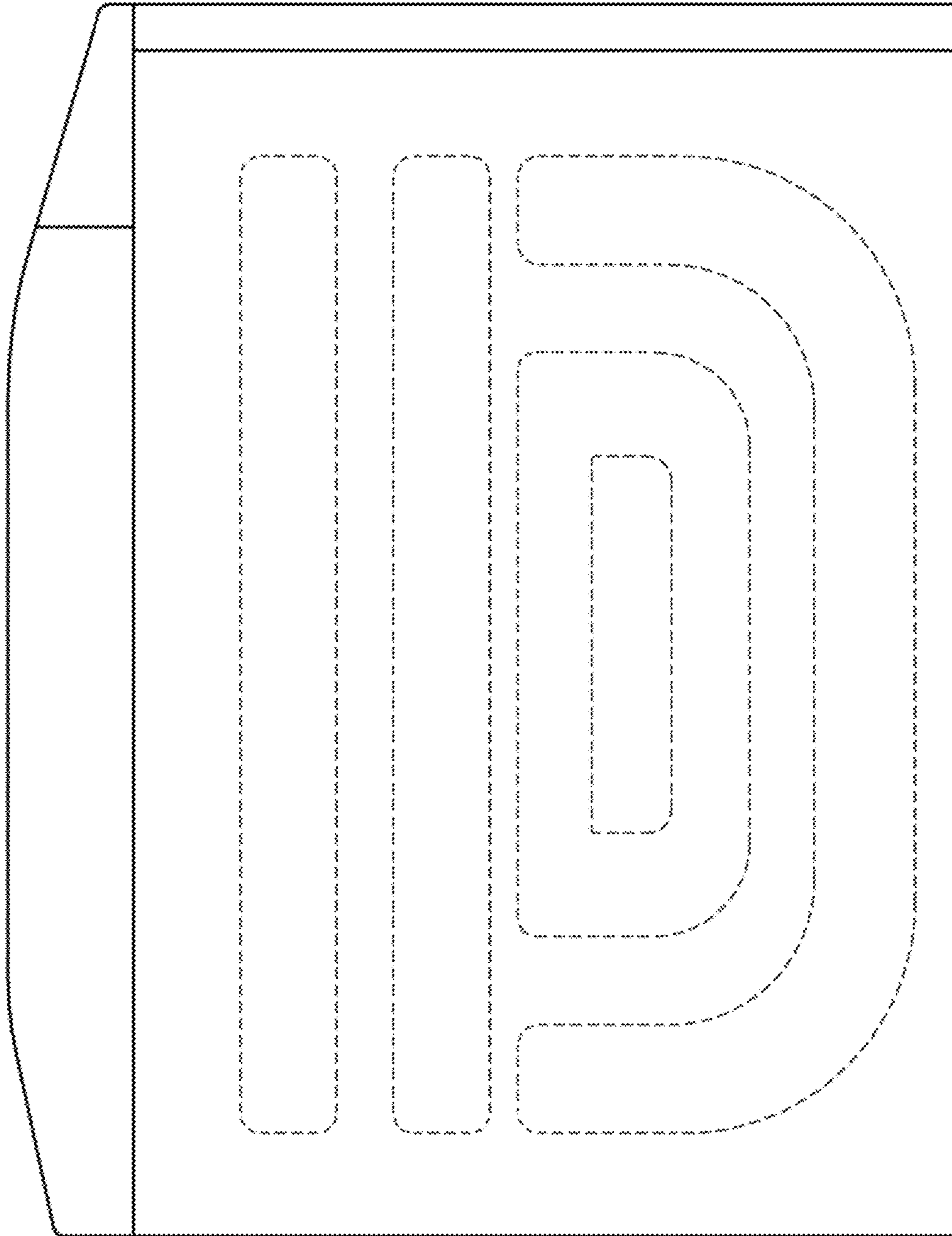

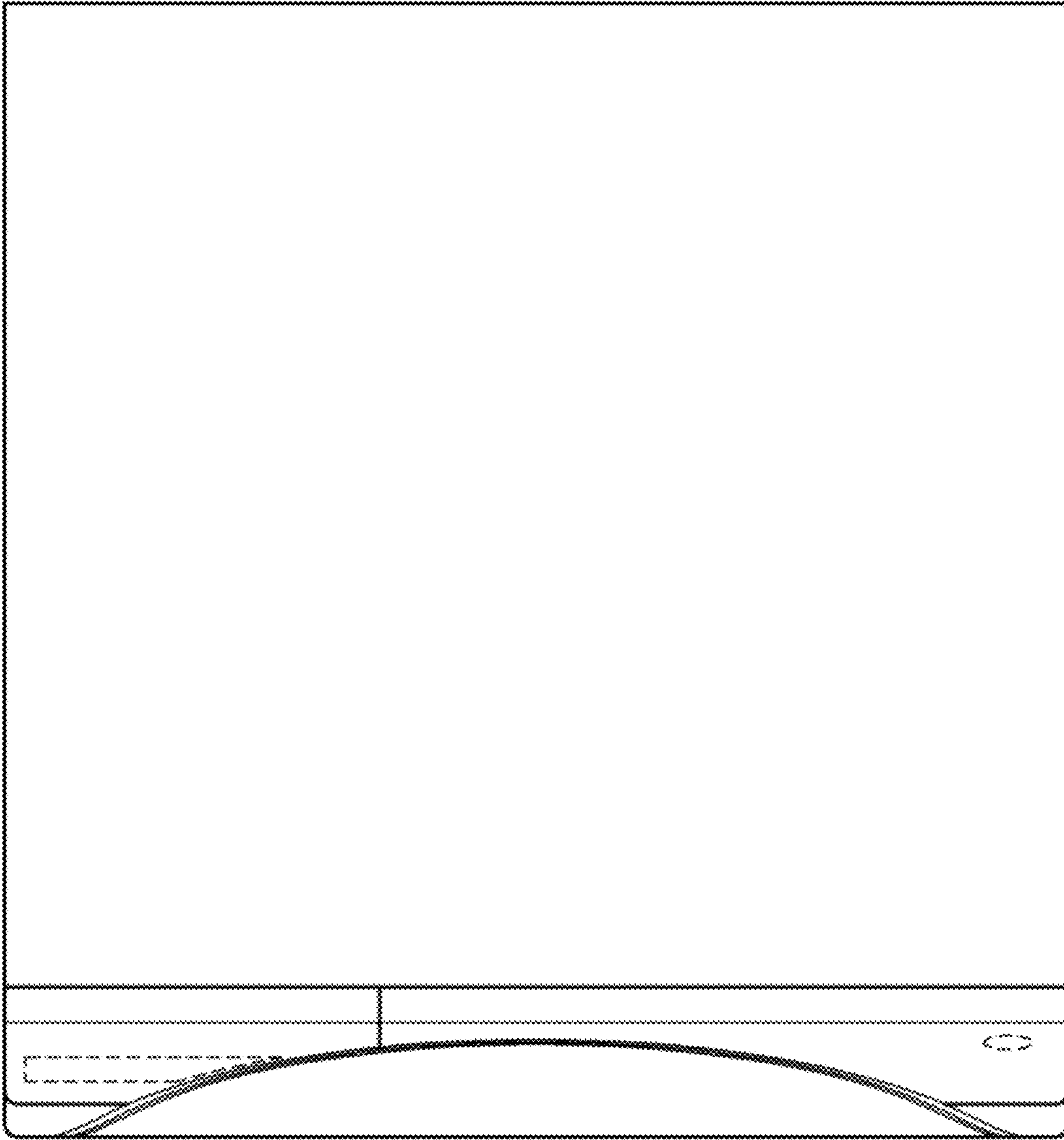
