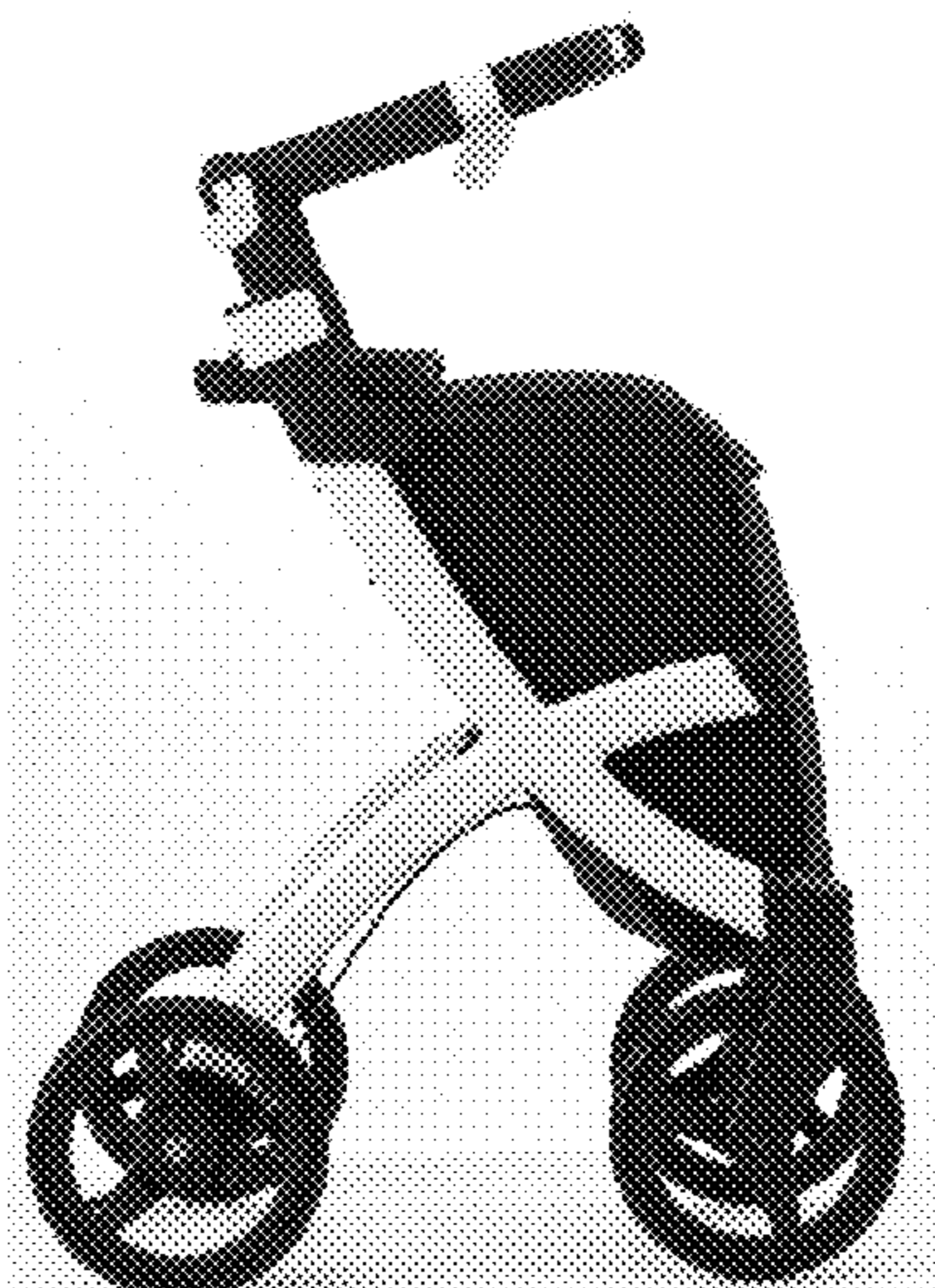
The ornamental design for a trolley, as shown and described.
