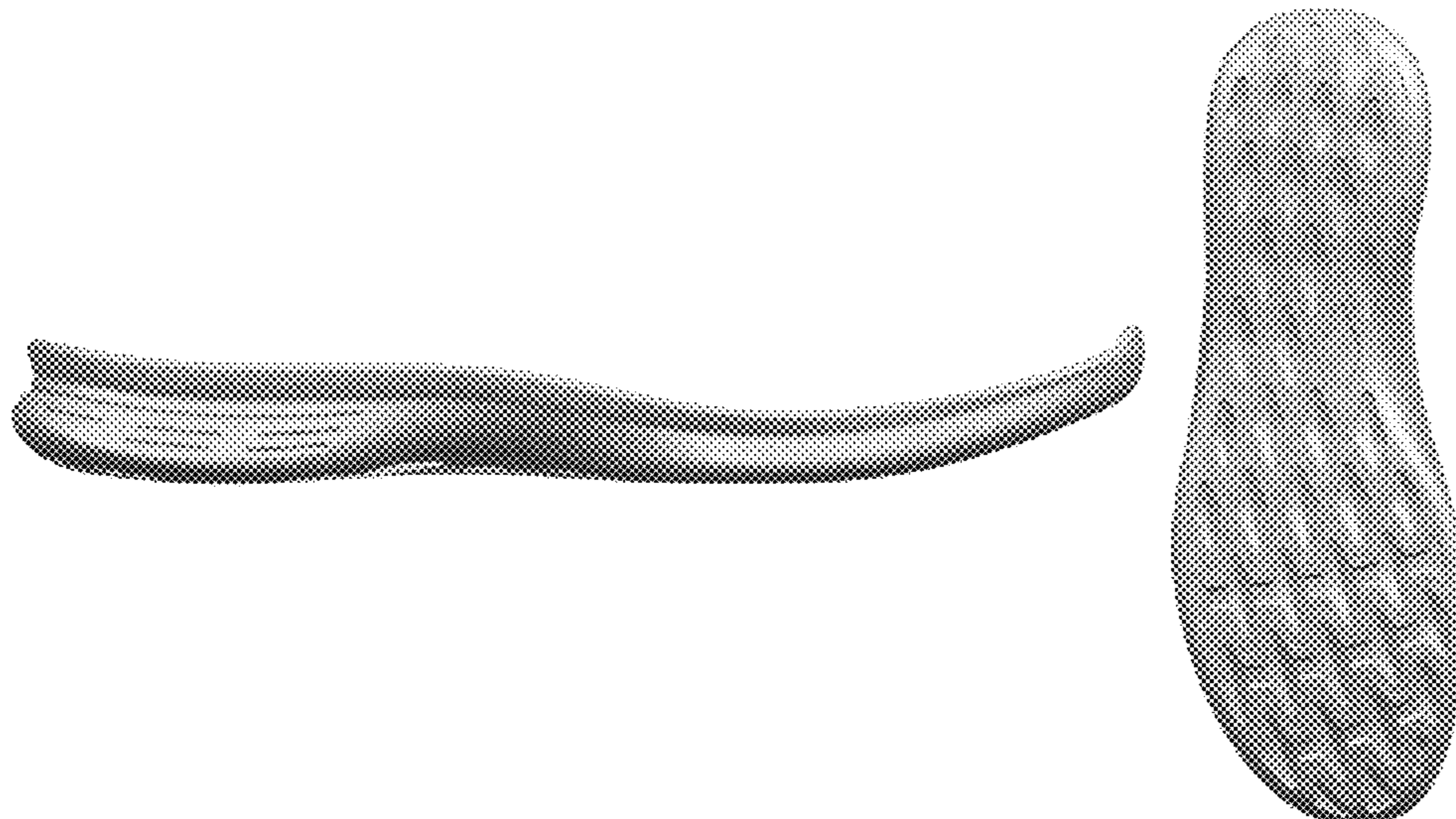

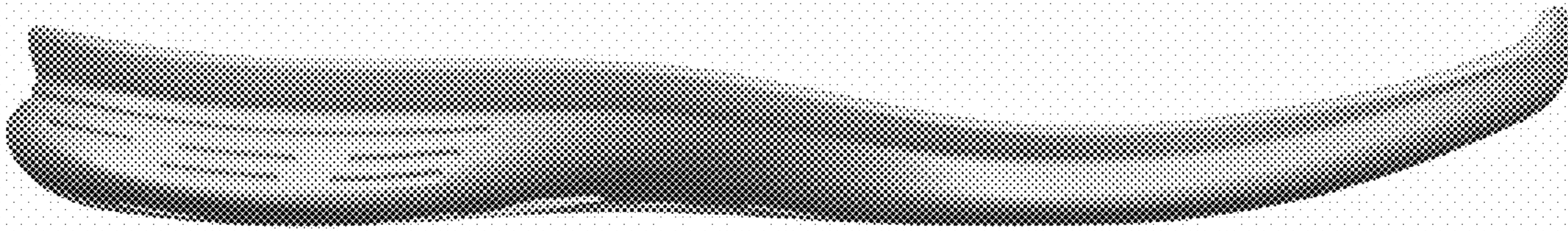
The ornamental design for a sole for footwear, as shown and described.

DESCRIPTION

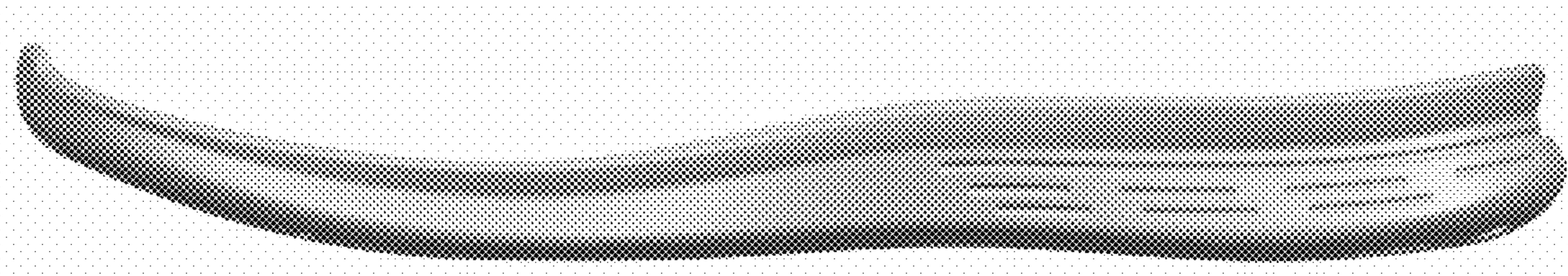
Fig. 16.1 is a left side elevation view of a sole for footwear showing my new design;

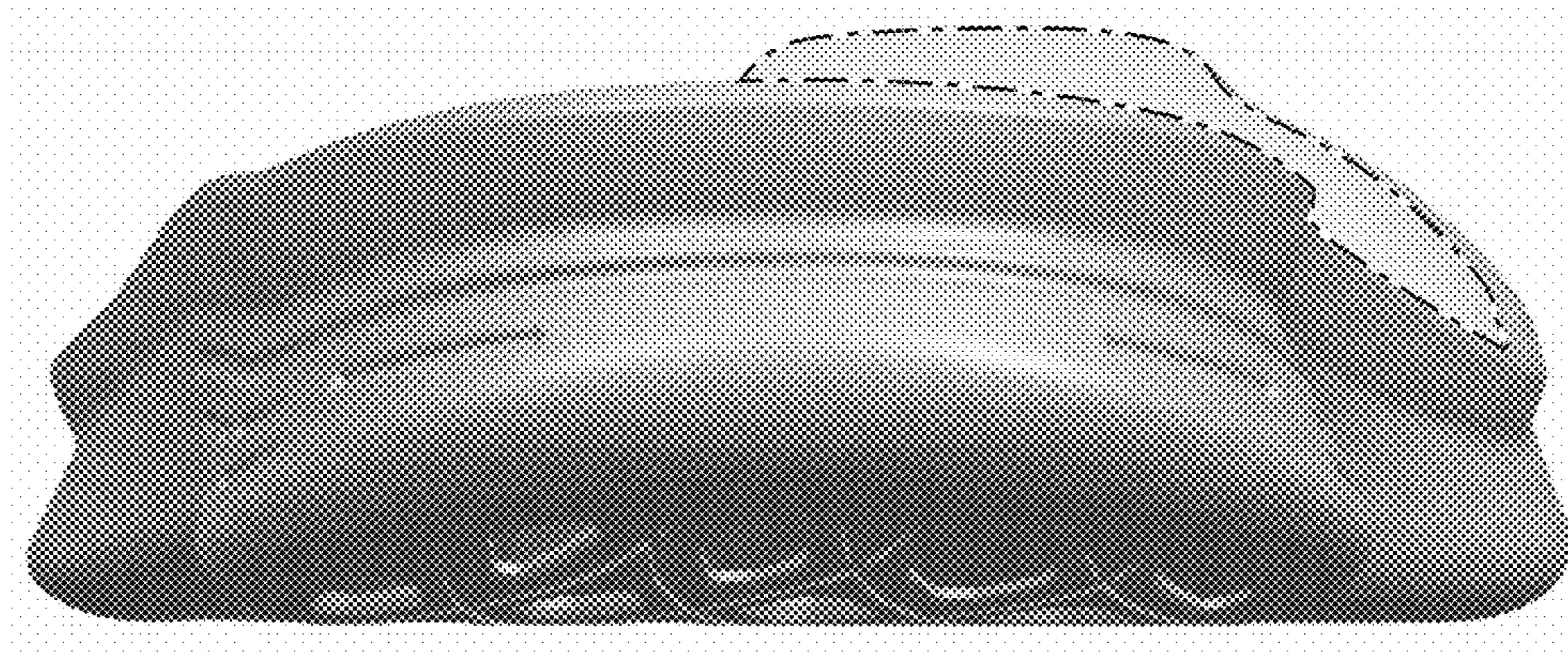




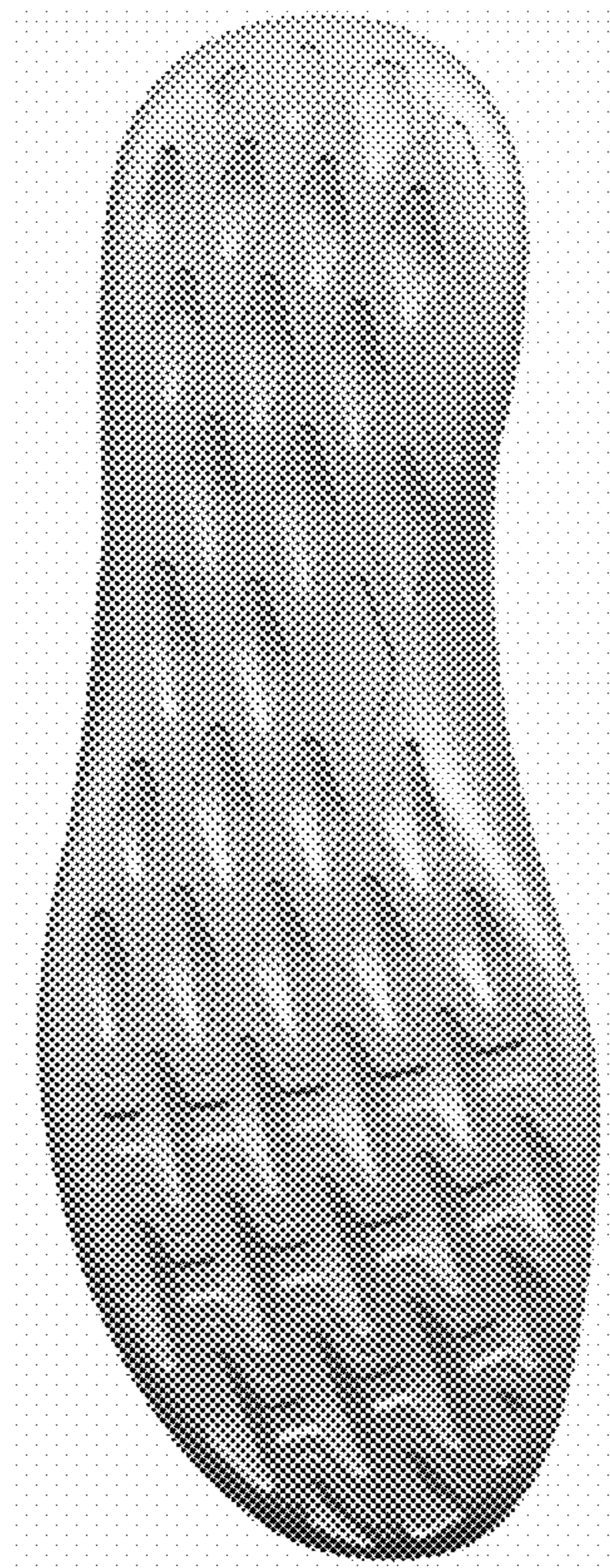

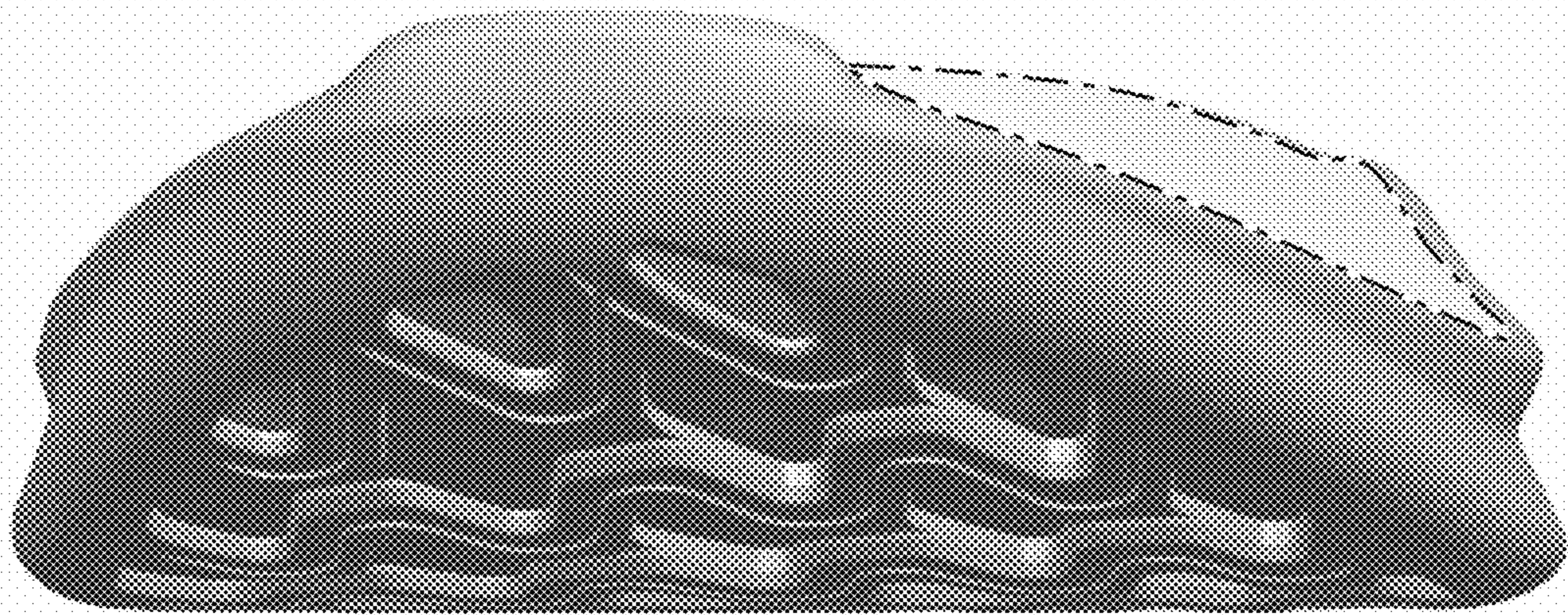
