(57) **CLAIM**

The ornamental design for a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe outsole showing my new design;

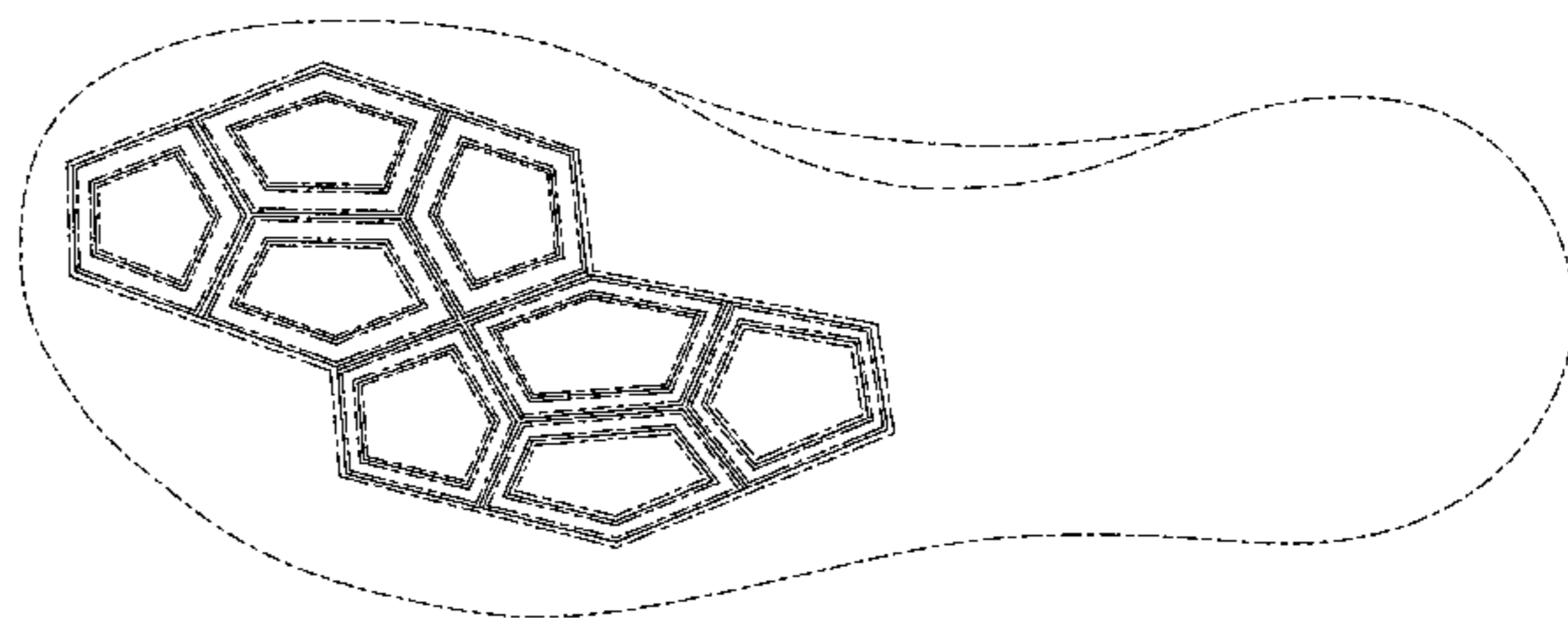
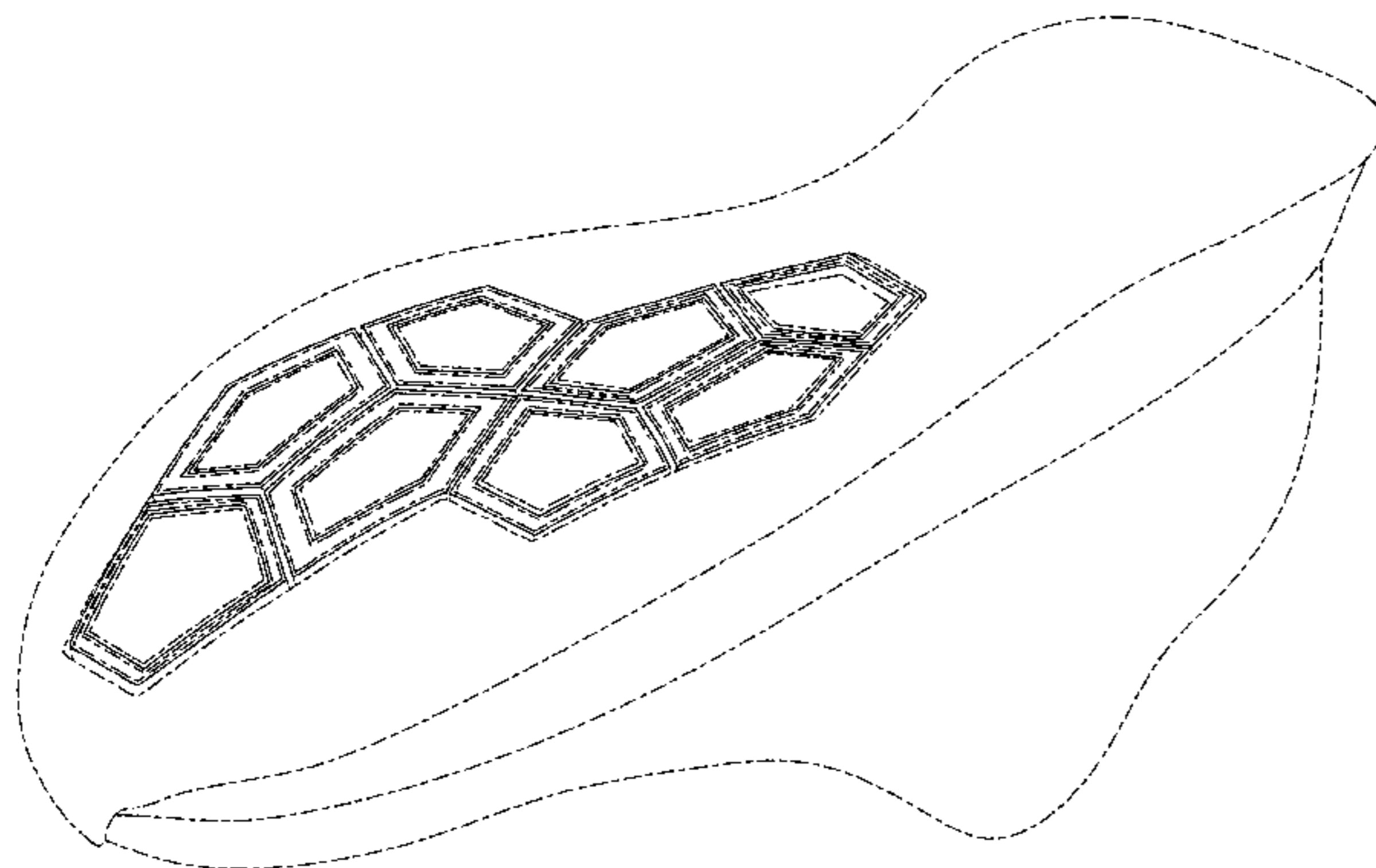
FIG. 2 is a bottom view thereof;

FIG. 3 is a front view thereof; and,

FIG. 4 is the front perspective view of FIG. 1 with the broken lines omitted from the claimed area for clarity purposes to better depict the claimed edges.

The broken lines immediately surrounding the claimed area represent an unclaimed boundary of the design. The broken lines immediately inside the outer pentagon-shaped elements and immediately outside of the inner pentagon elements, and the unshaded areas therebetween represent unclaimed subject matter and form no part of the claimed design. The broken lines immediately inside the inner pentagon-shaped elements and the unshaded areas therein represent unclaimed subject matter and form no part of the claimed design. The broken lines showing the remainder of the shoe represent unclaimed subject matter and form no part of the claimed design.

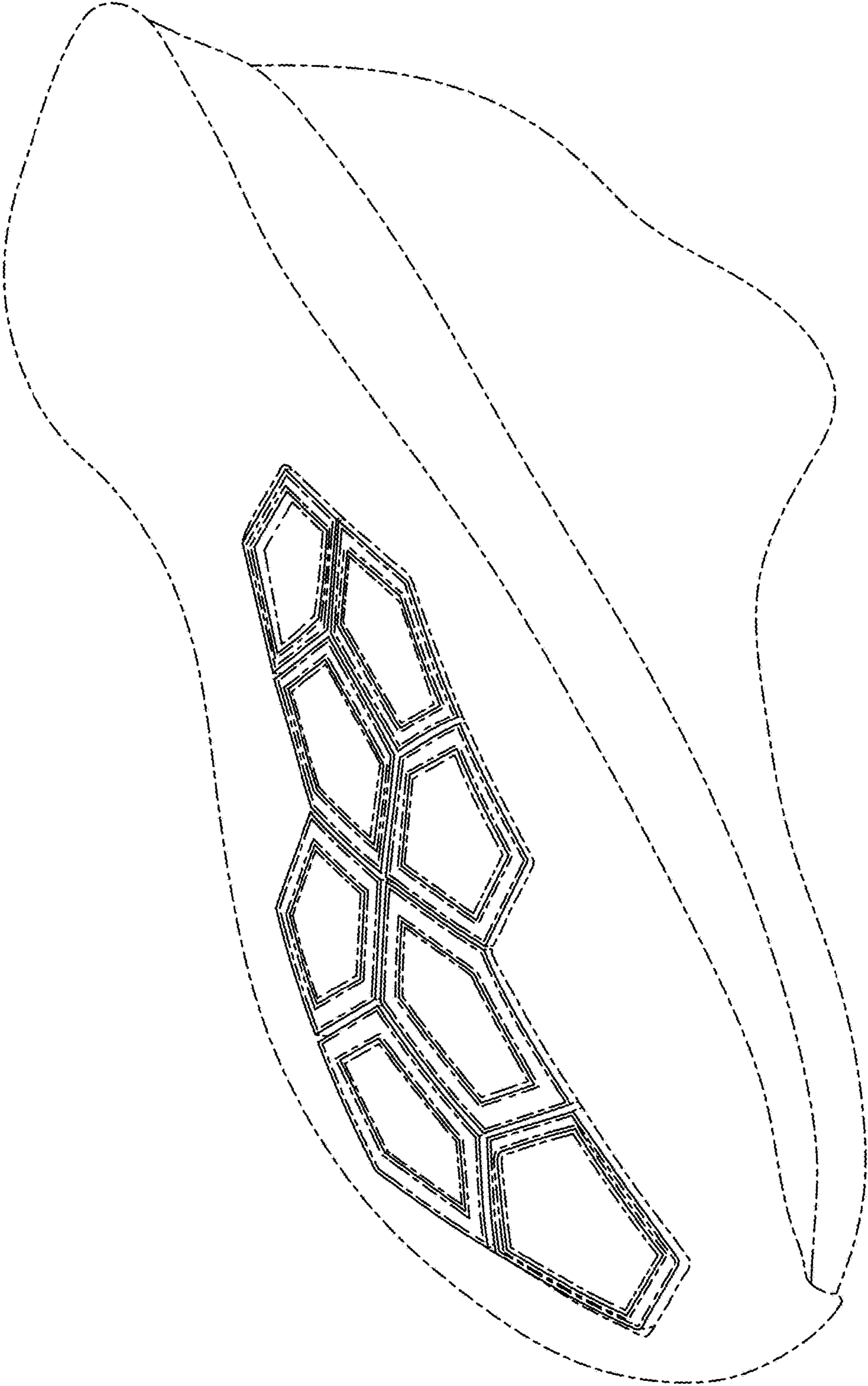

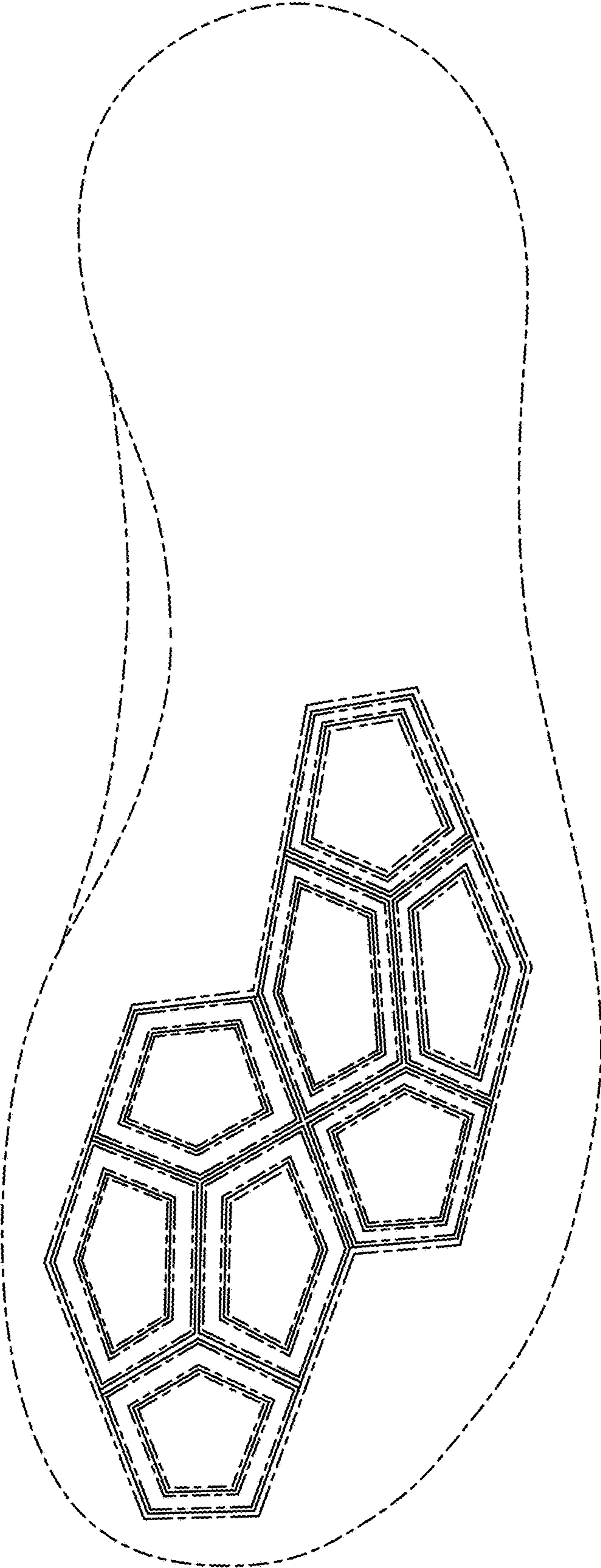

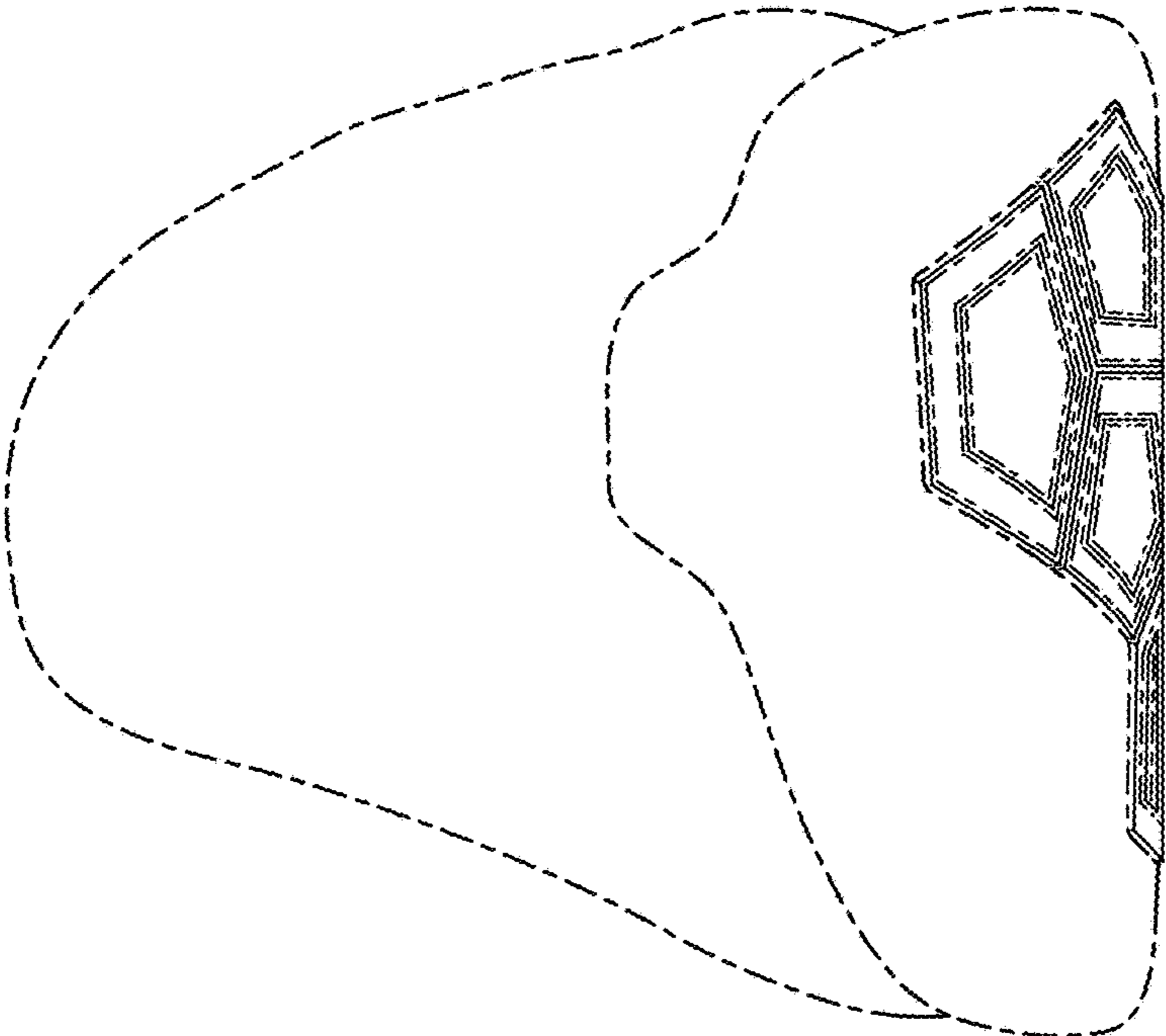

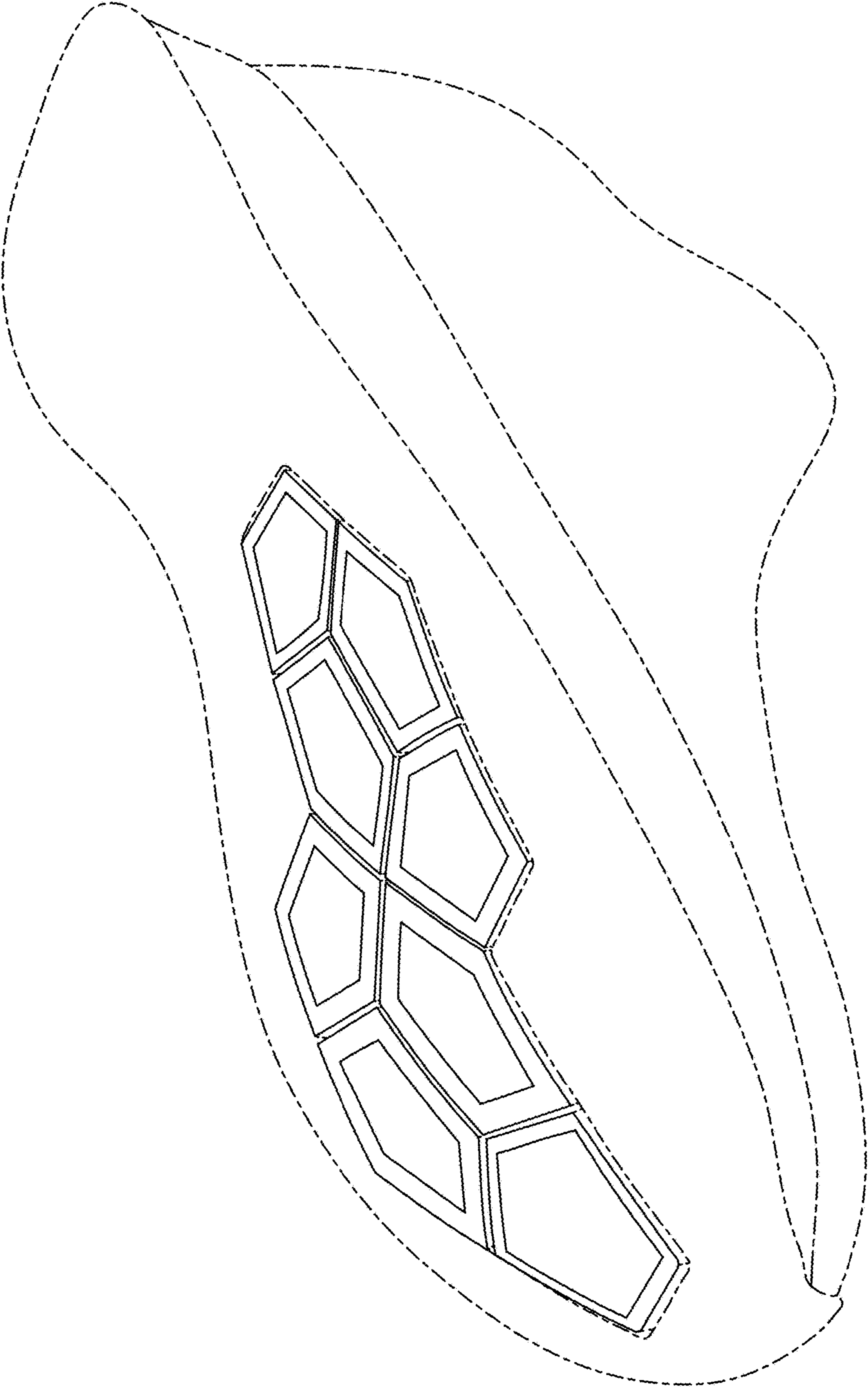
