DESCRIPTION

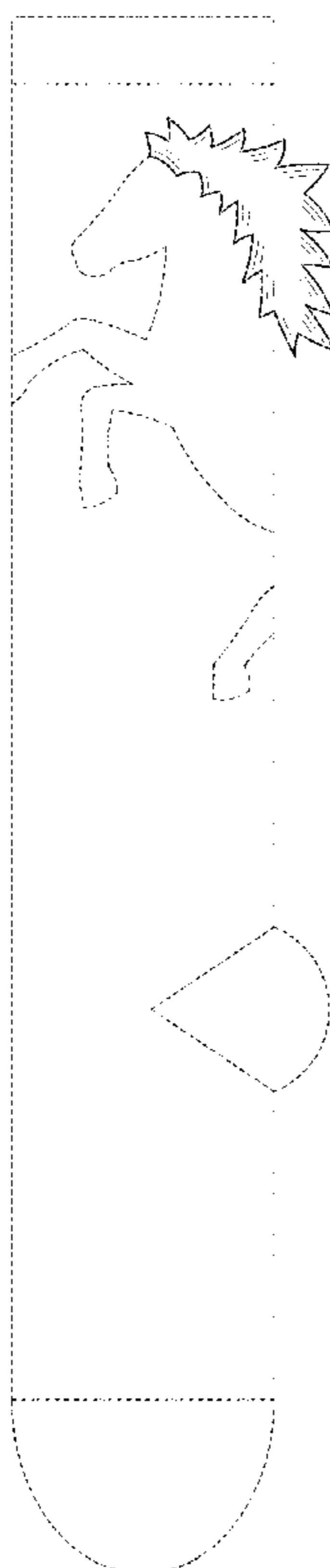
FIG. 1 is a partial view showing a side view of an animal hair sock showing a side of my new design;

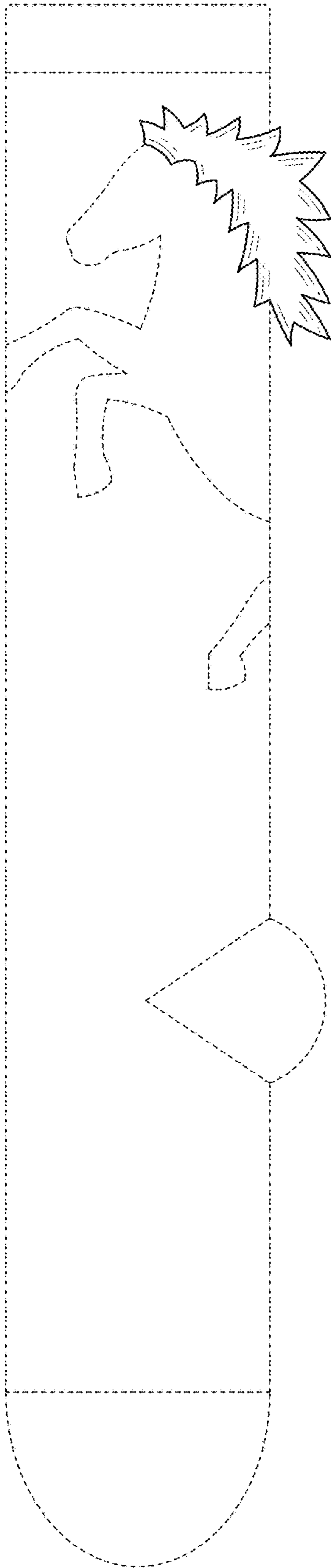

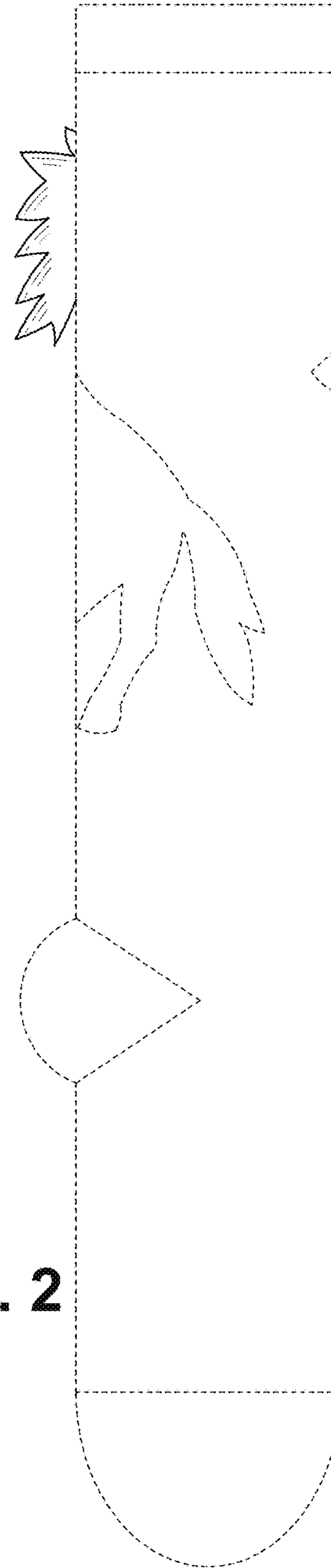

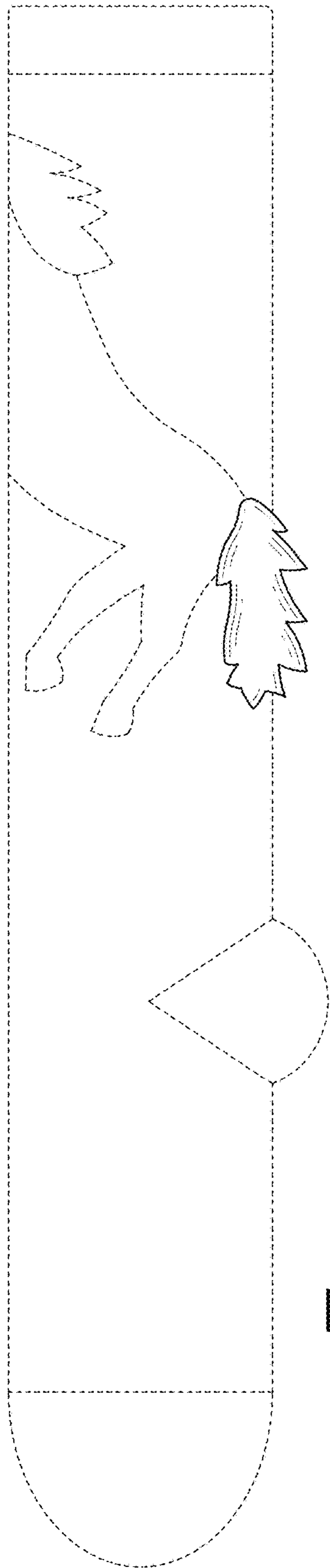

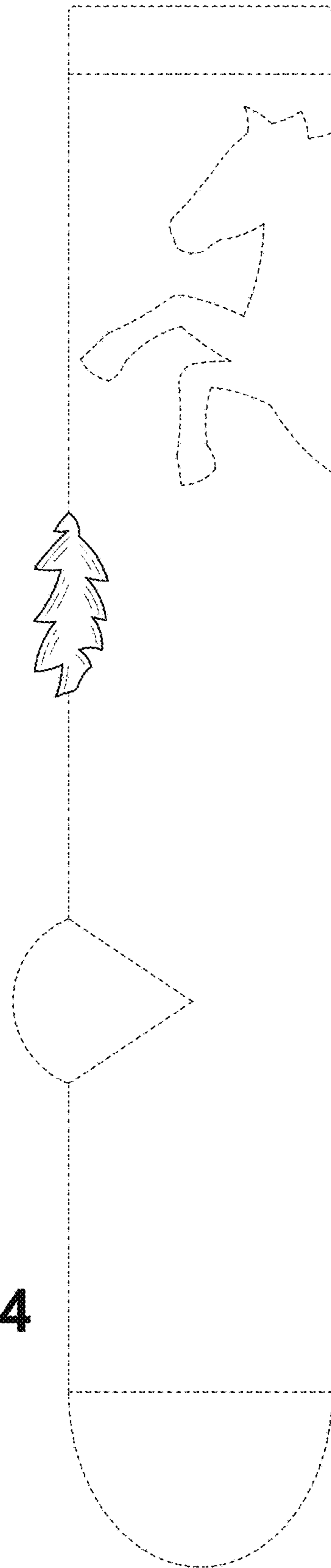
