DESCRIPTION

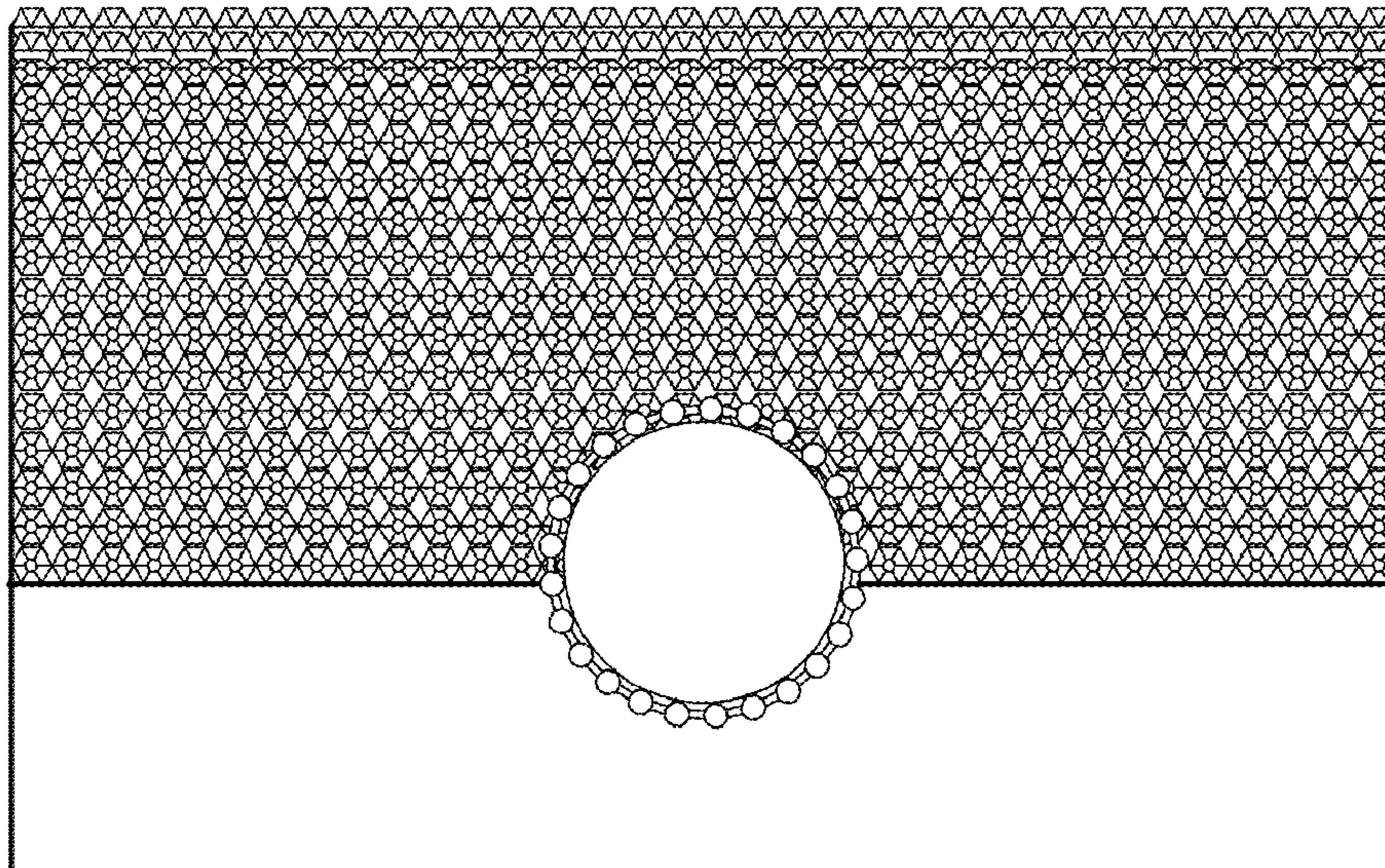
FIG. 1 is a top view of a clutch handbag showing my new design;

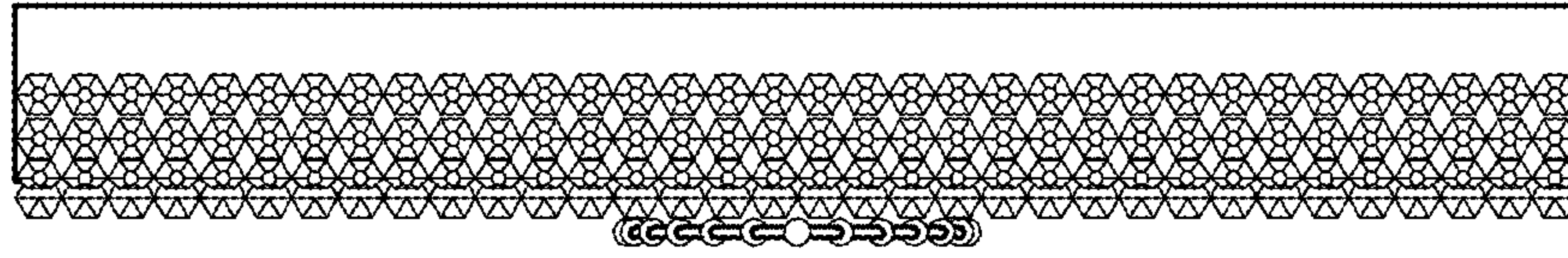

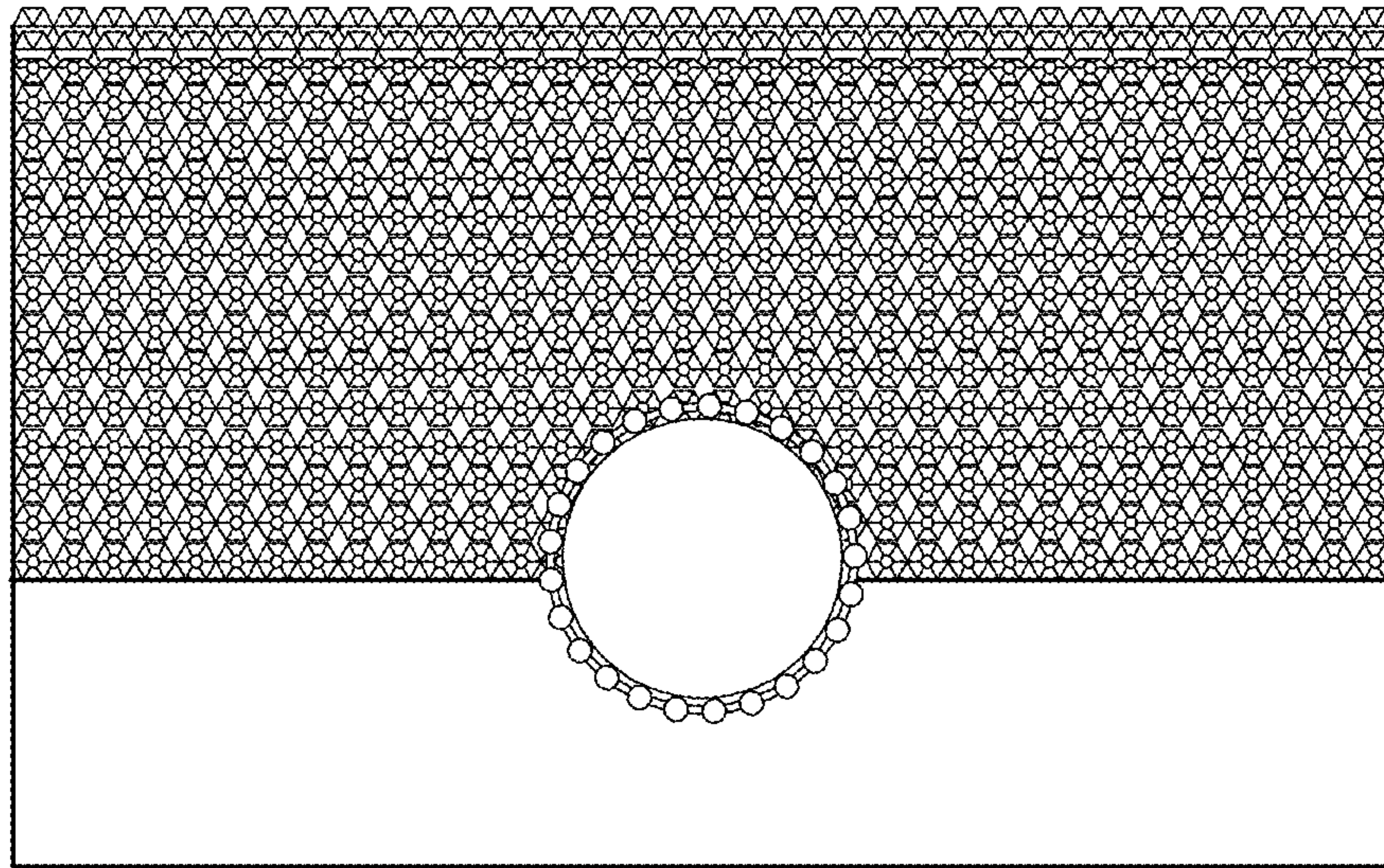

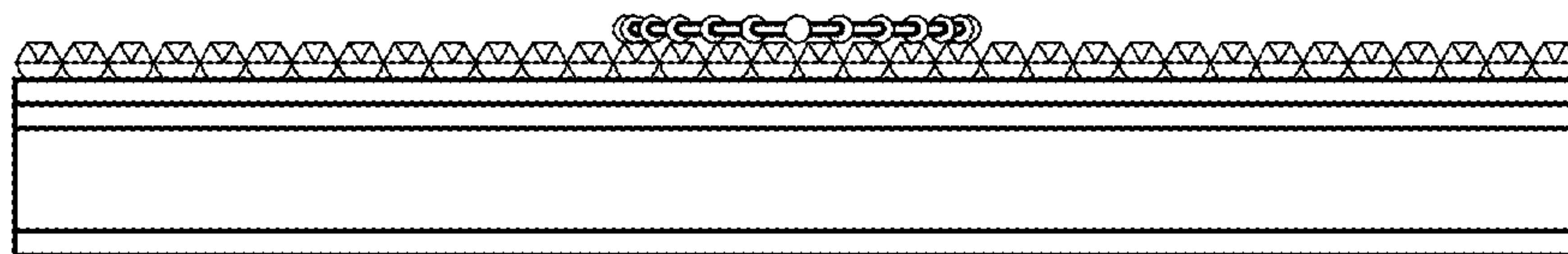

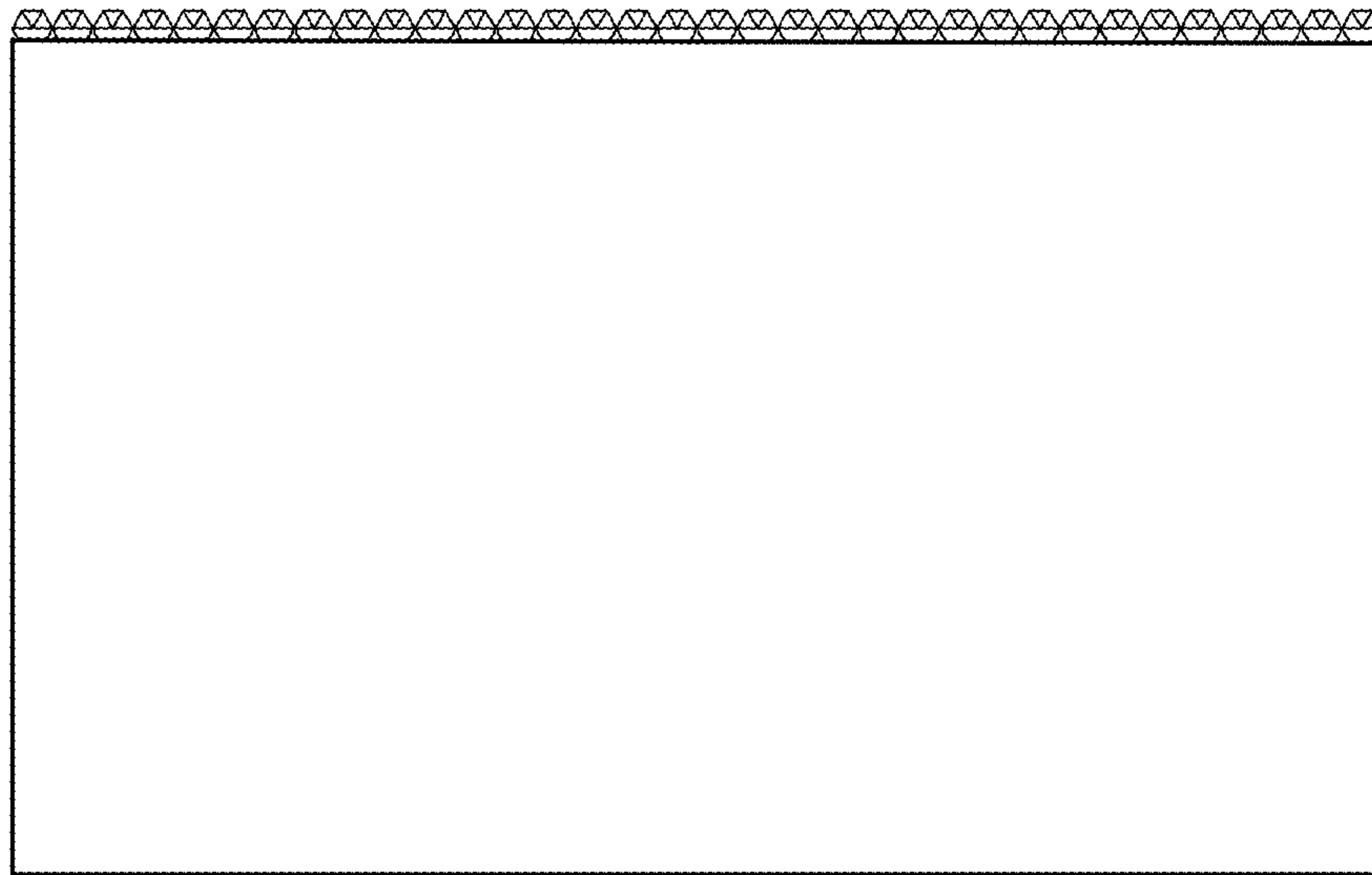

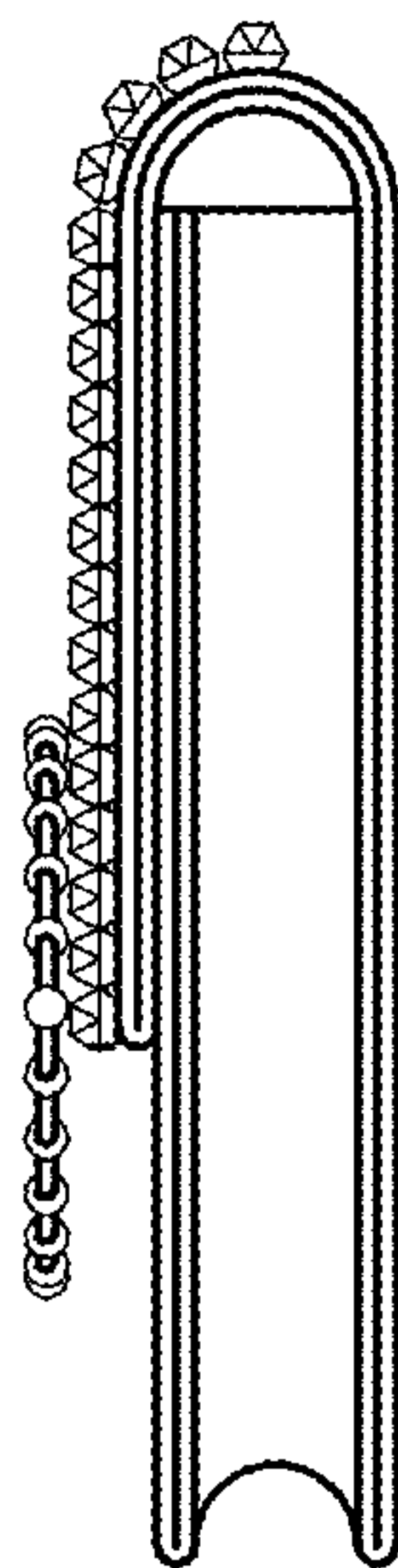
