DESCRIPTION

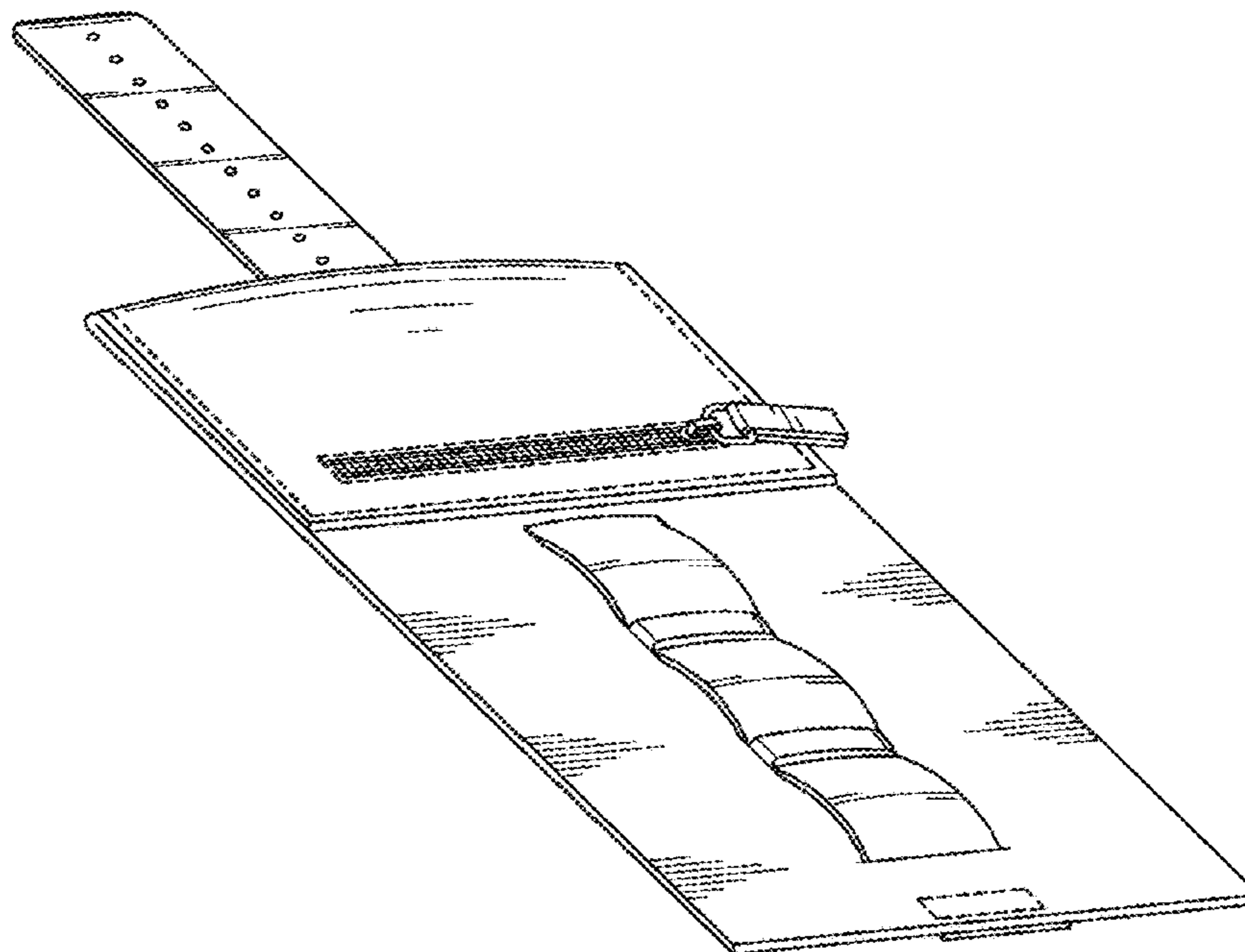
FIG. 1 is a perspective view of a collapsible organizer for storing one or more items, showing my new design;

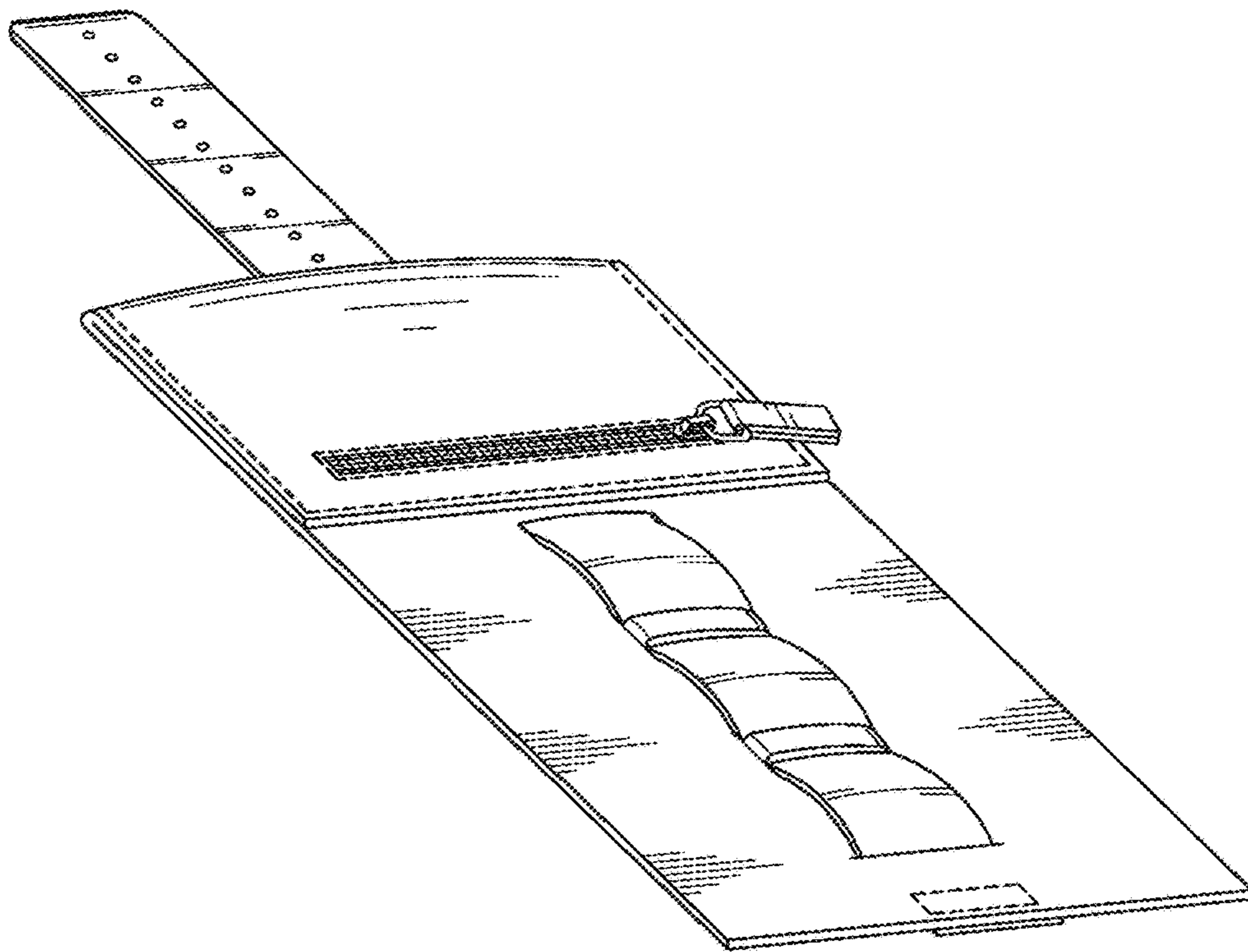

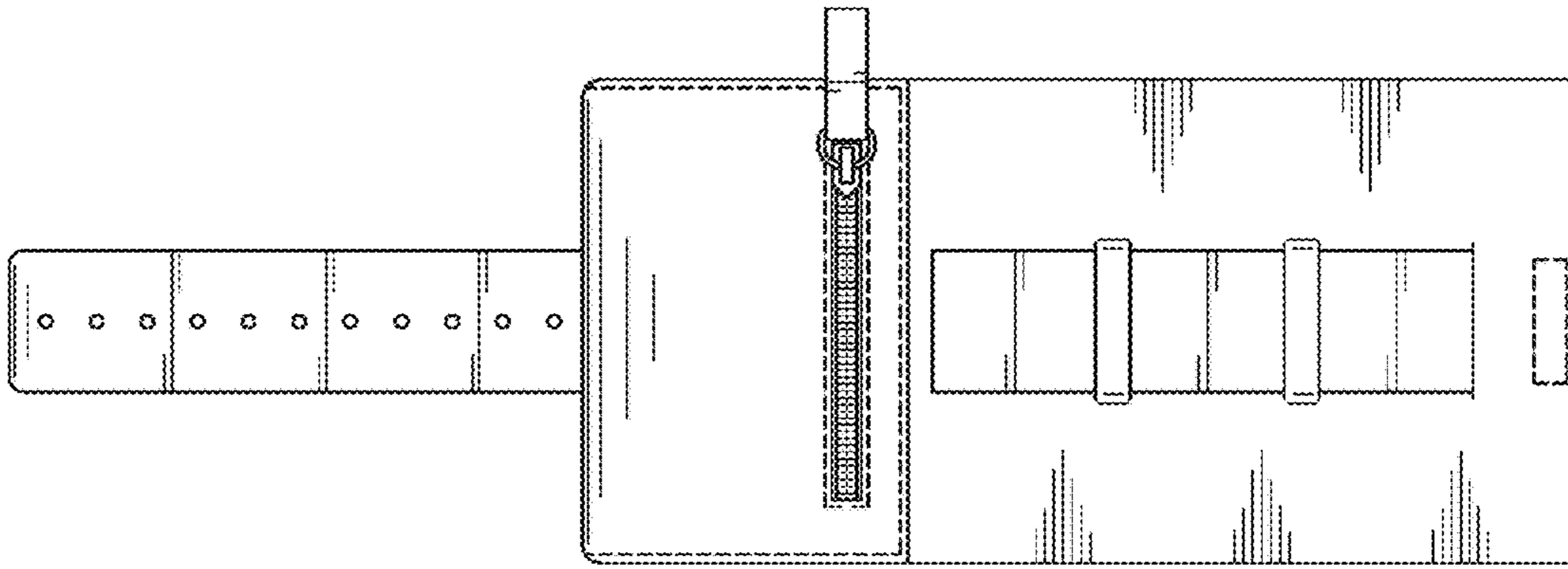

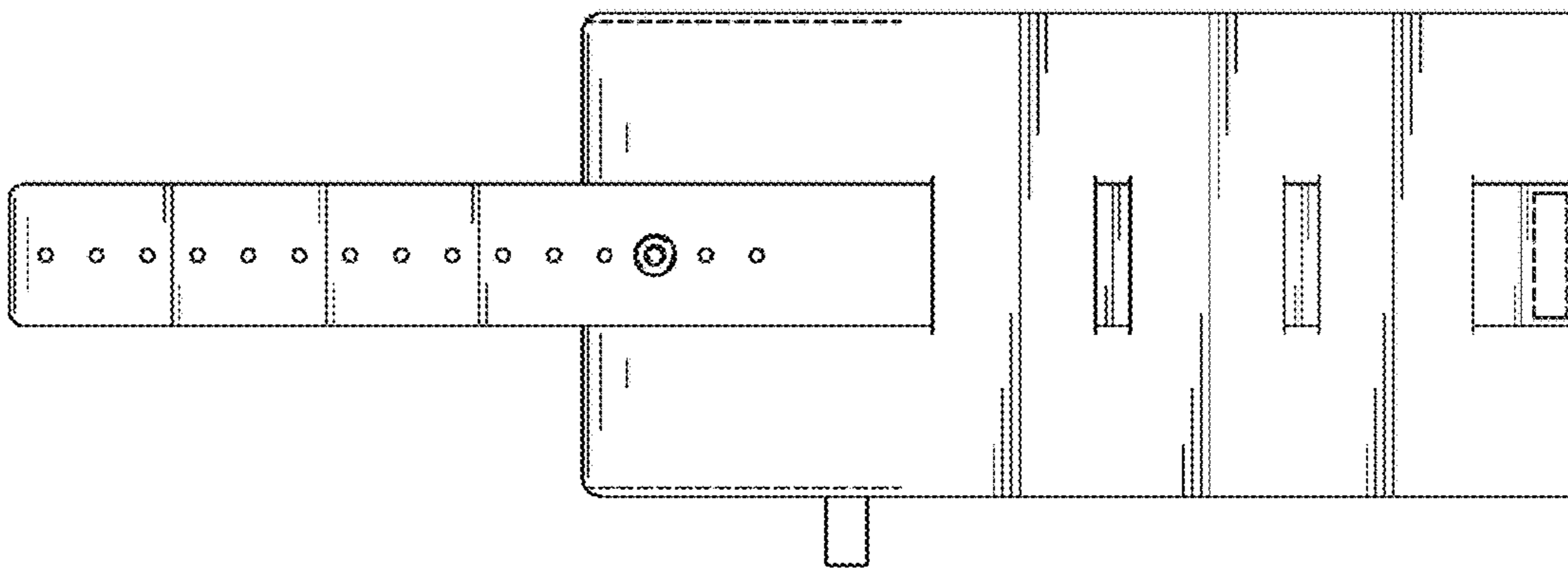

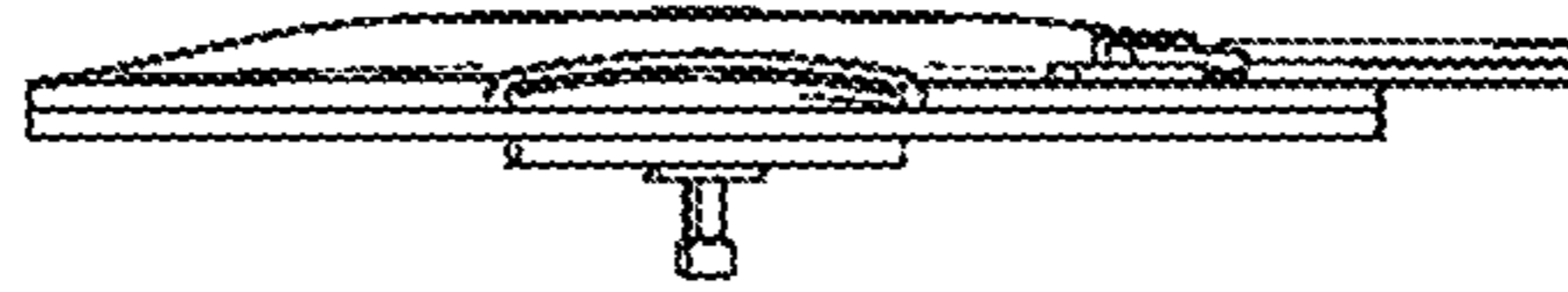

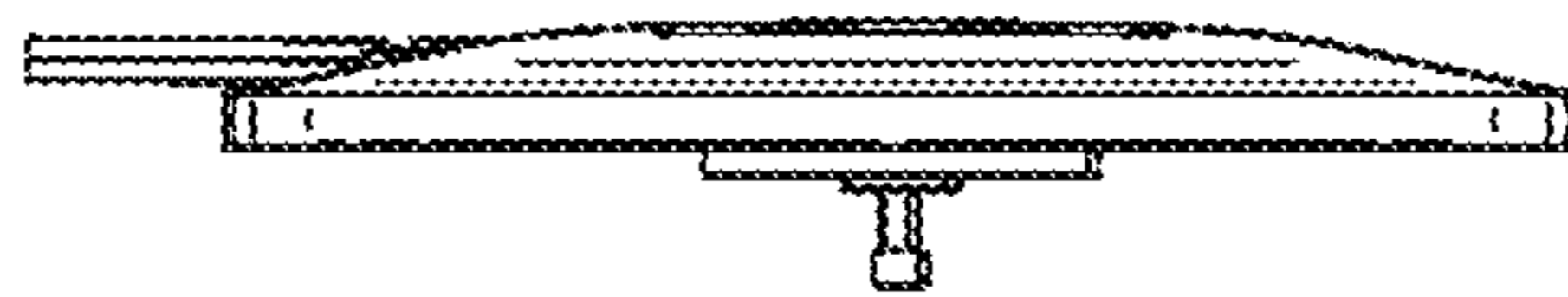
