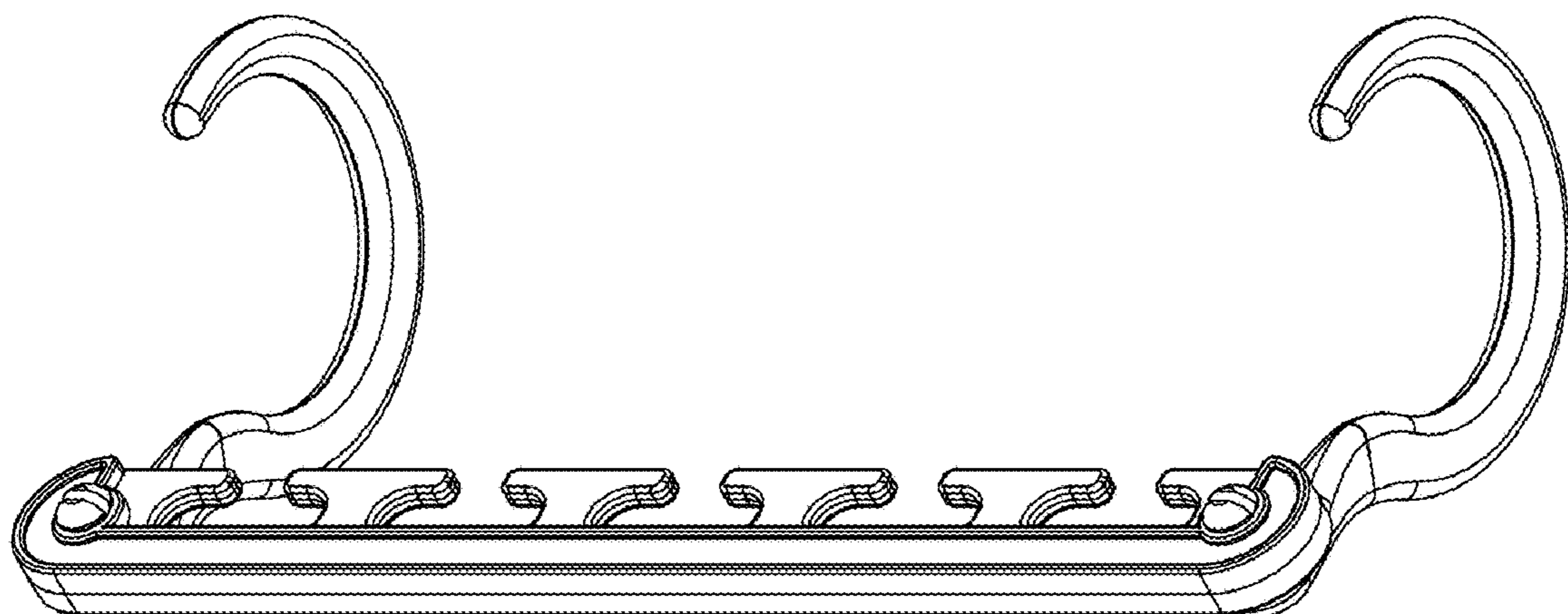
The ornamental design for a vertical drop hanger, as shown.

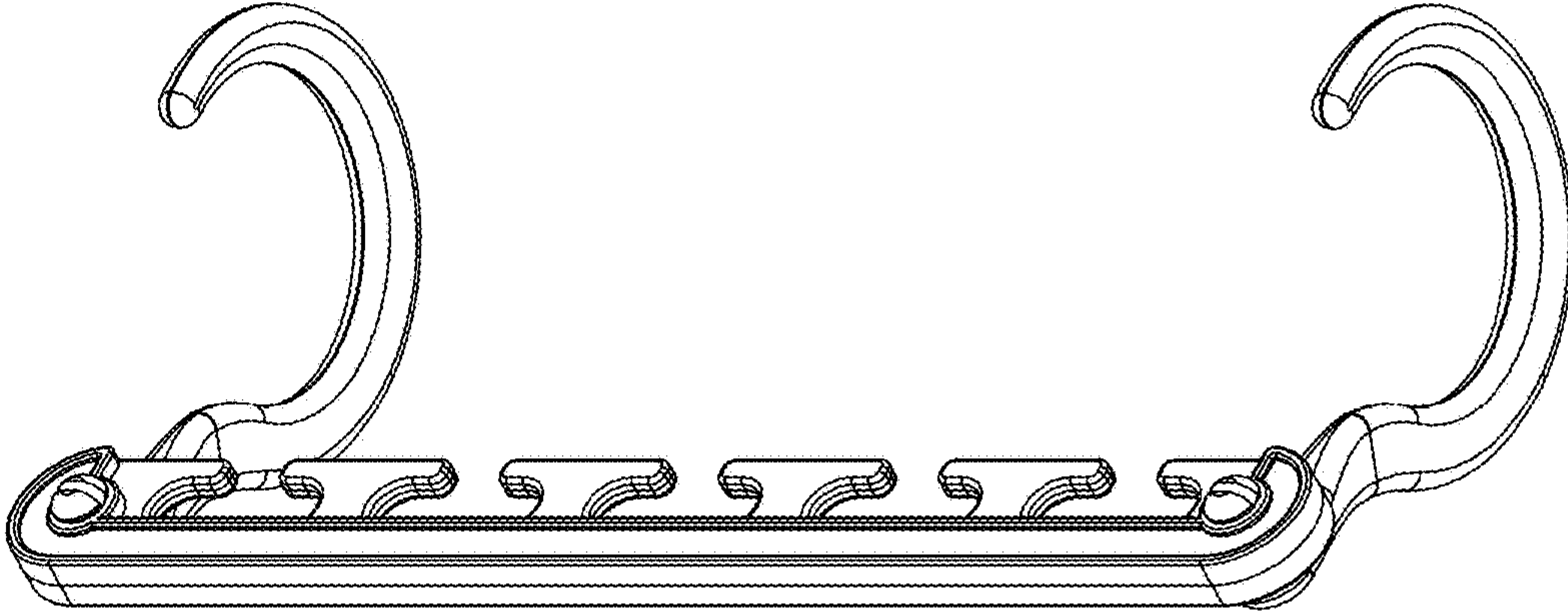

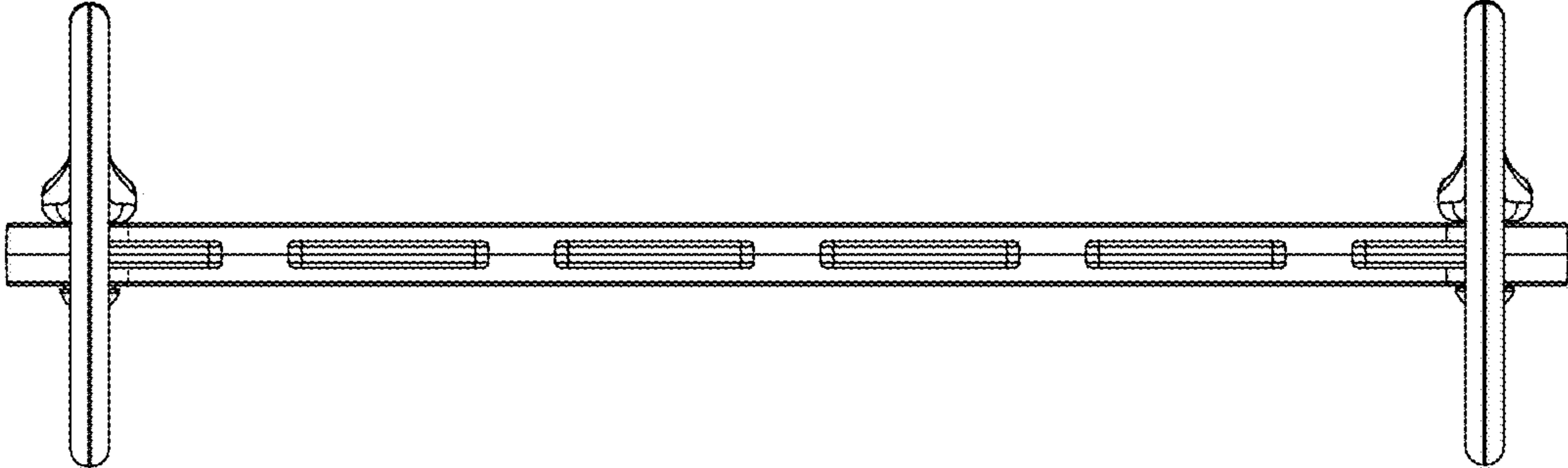

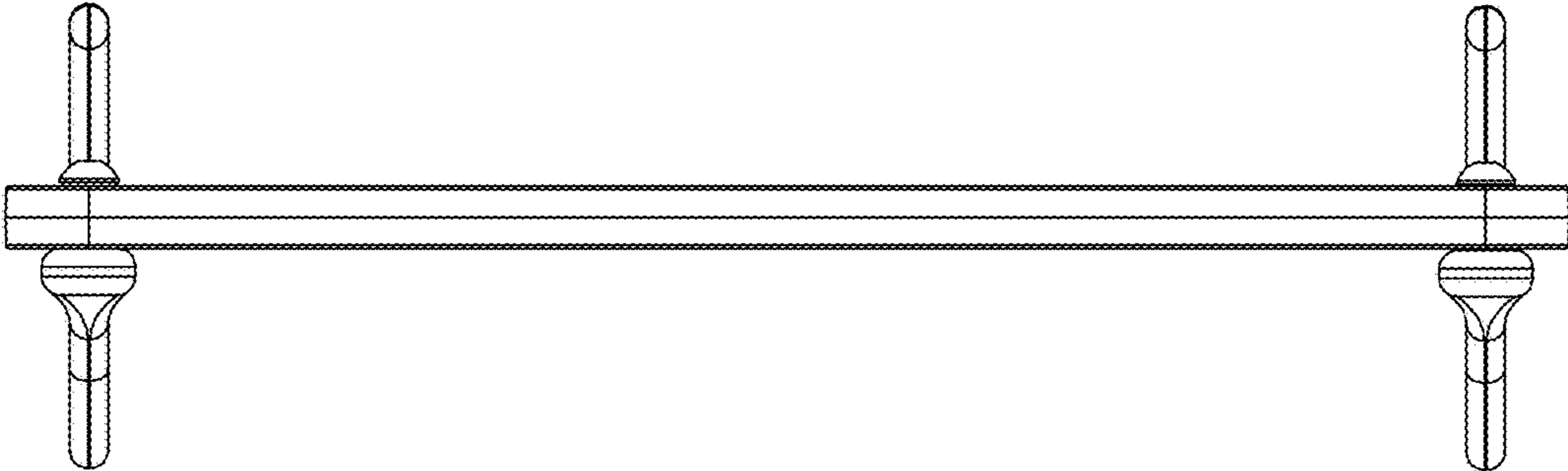

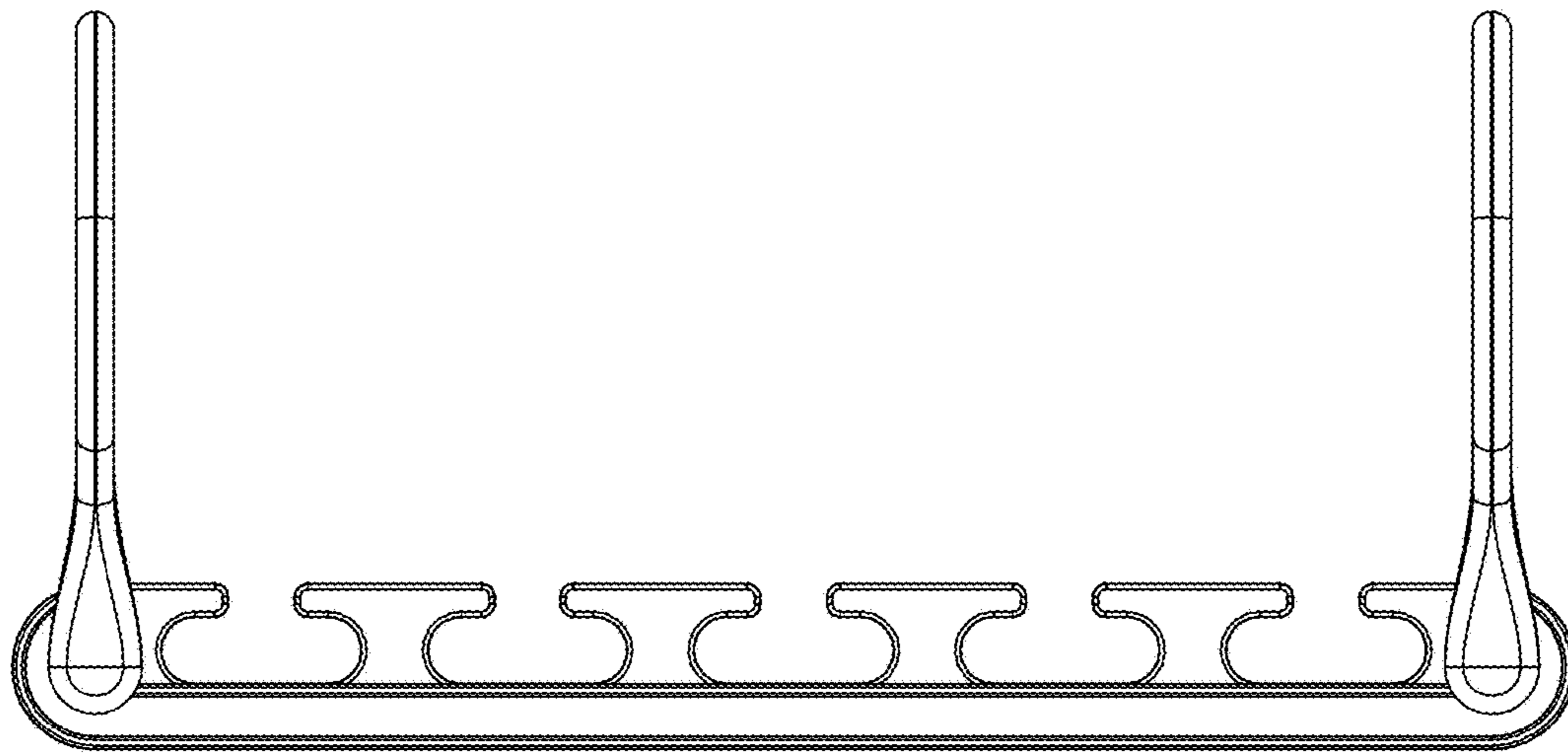

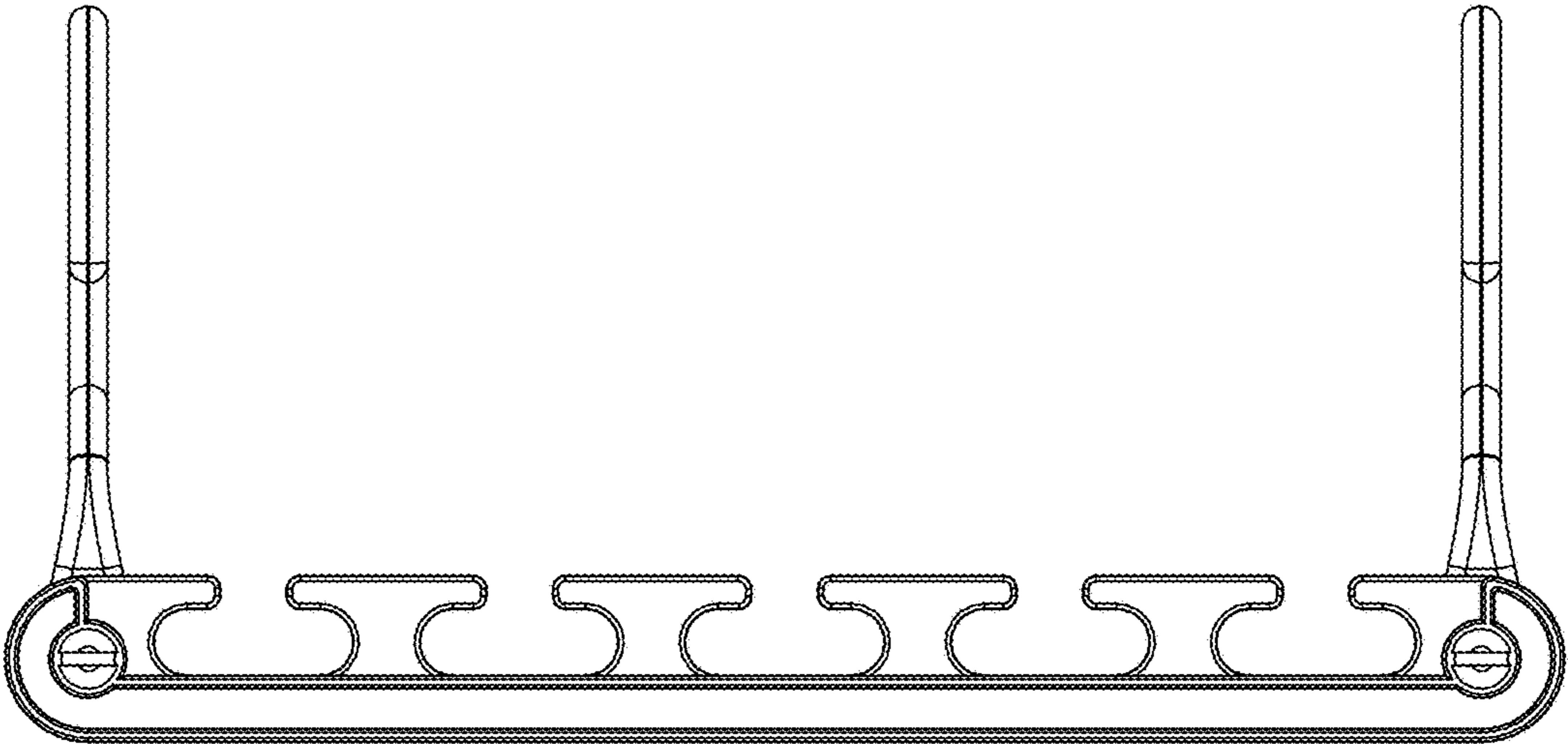

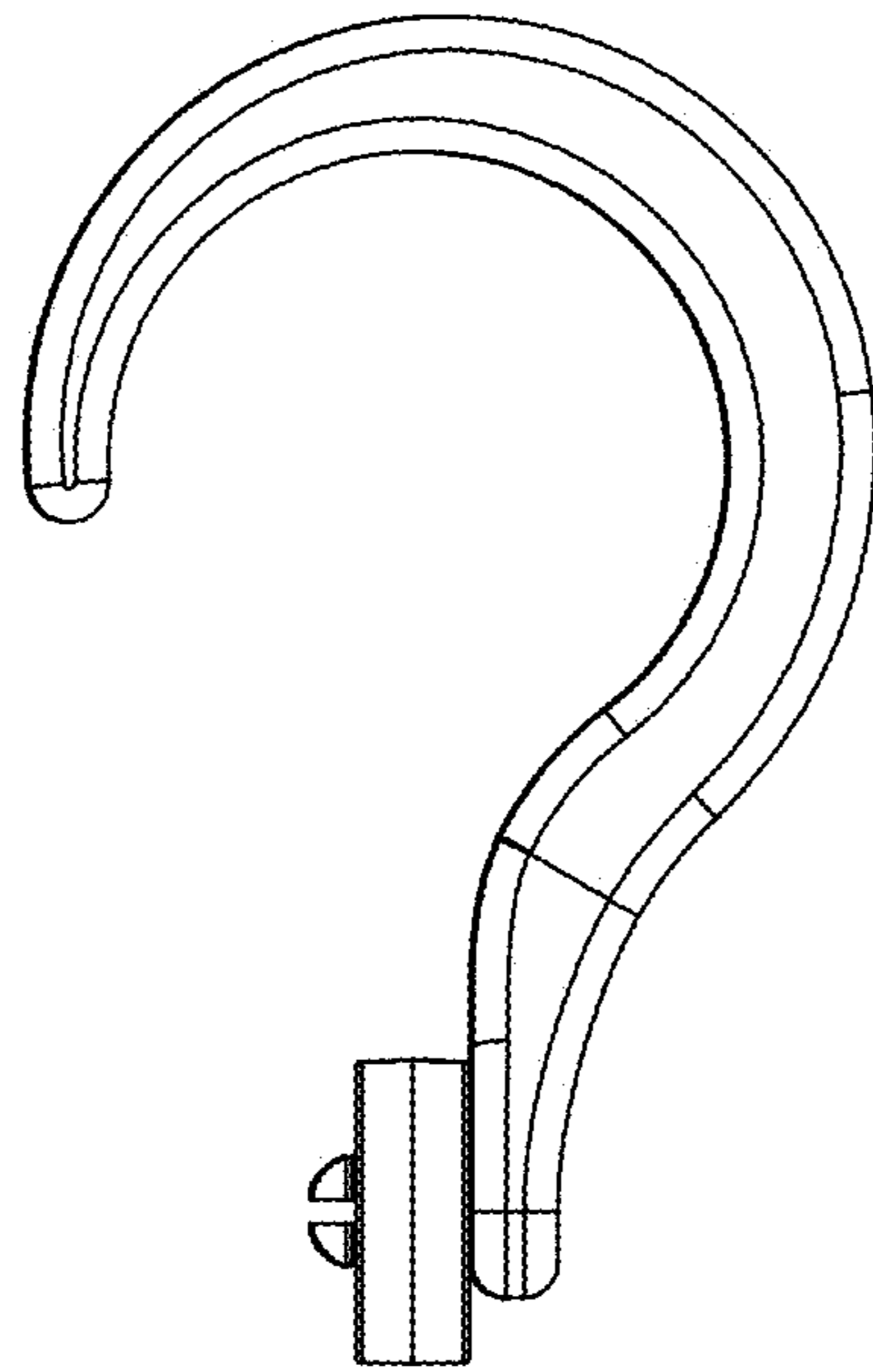

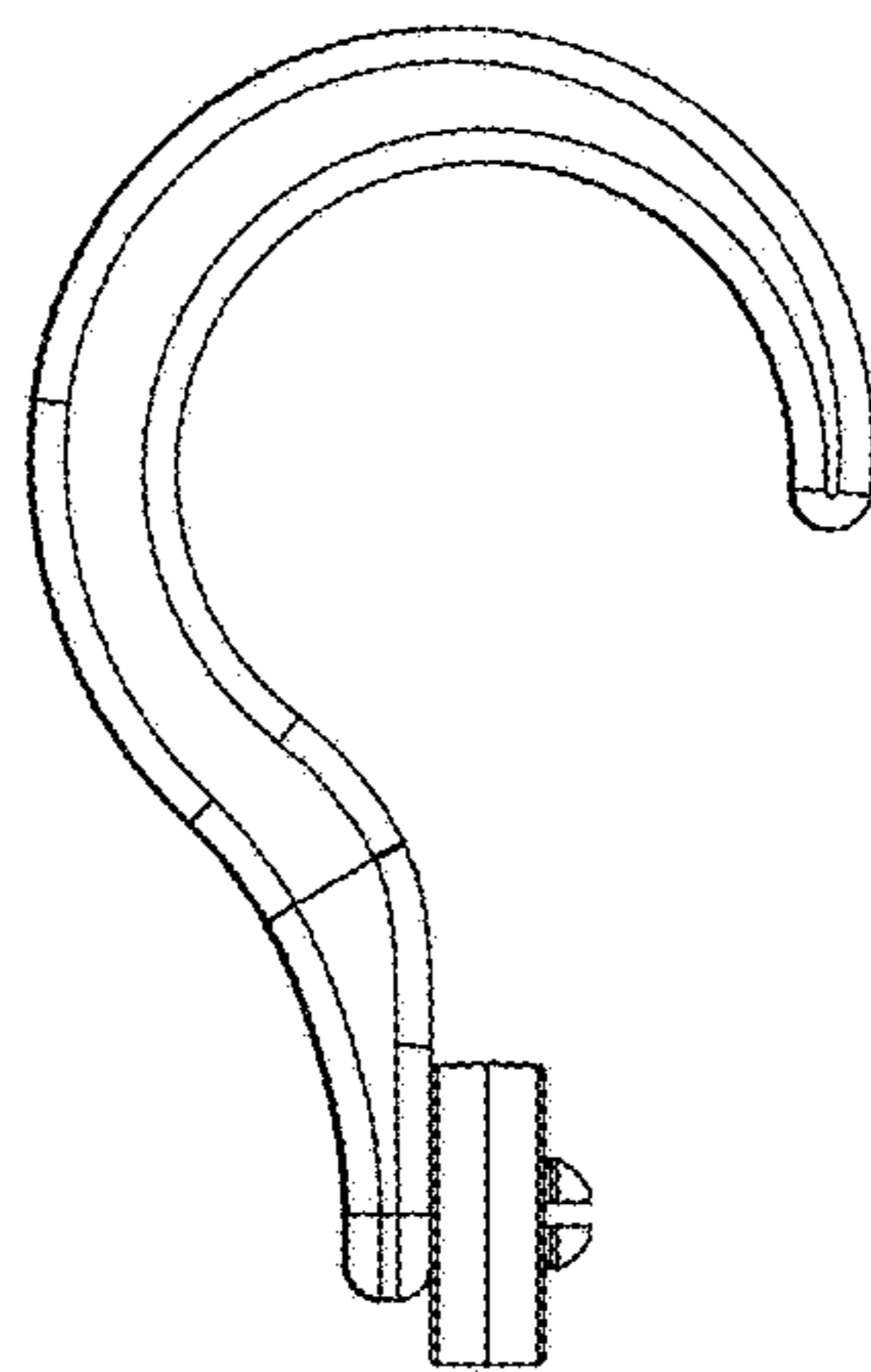
