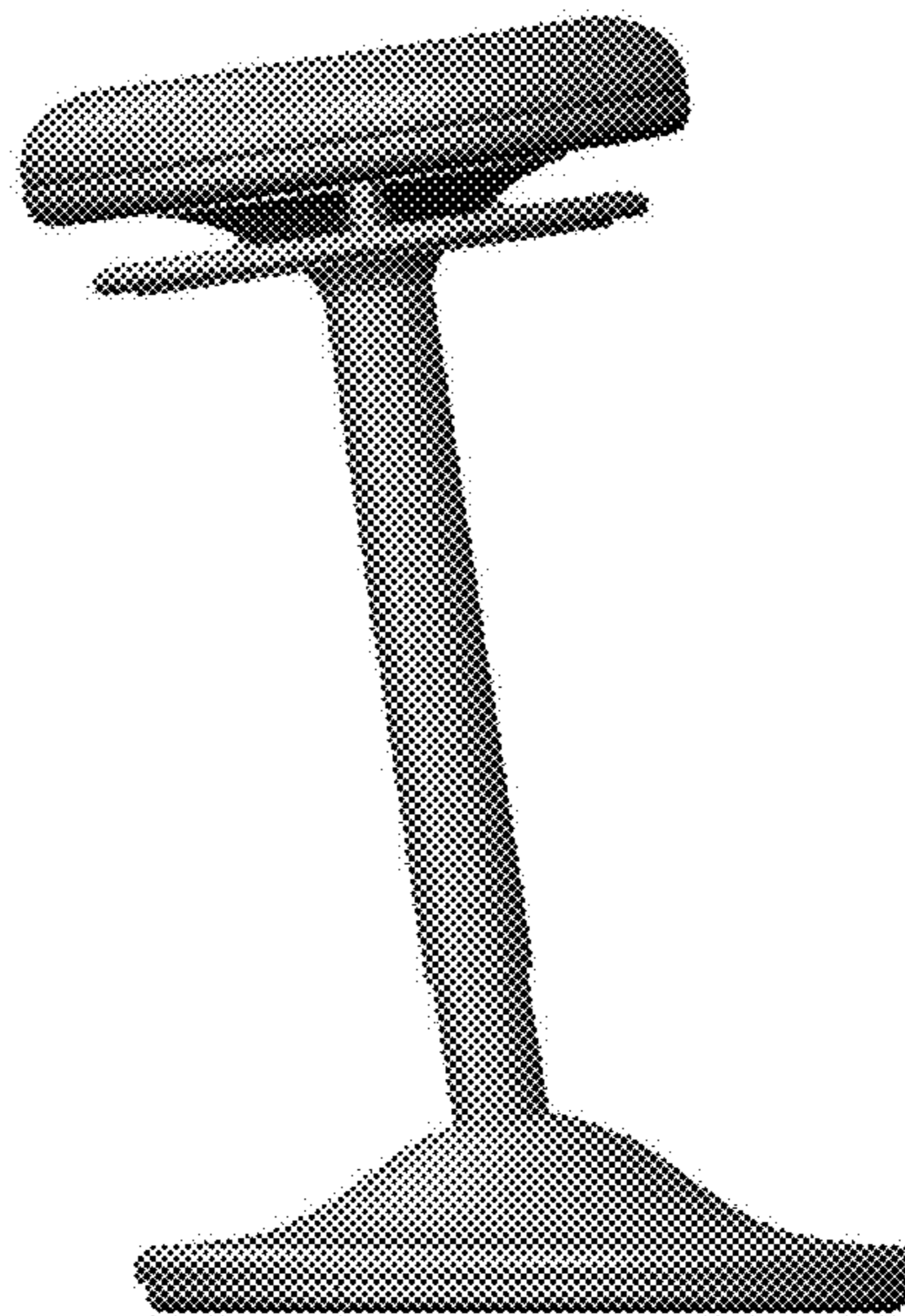
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a stool.
FIG. 2 is a front elevation view thereof.
FIG. 3 is a rear elevation view thereof.
FIG. 4 is a right side view thereof. A left side view is a mirror
image of the right side view.
FIG. 5 is a top plan view thereof.
FIG. 6 is a bottom plan view thereof; and,
FIG. 7 is a side view thereof in an alternate configuration of
use with the seat and the support pole tilted.

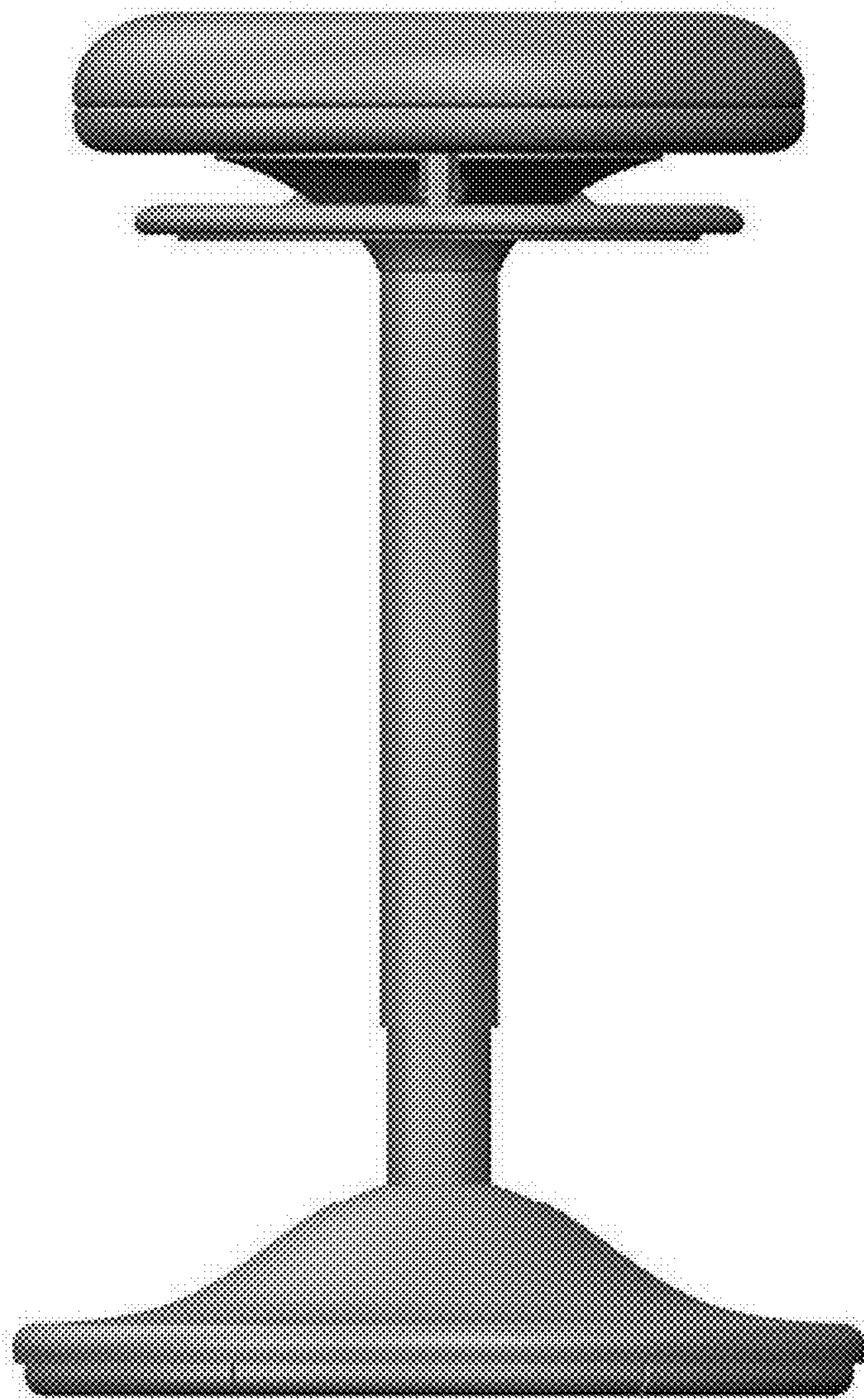

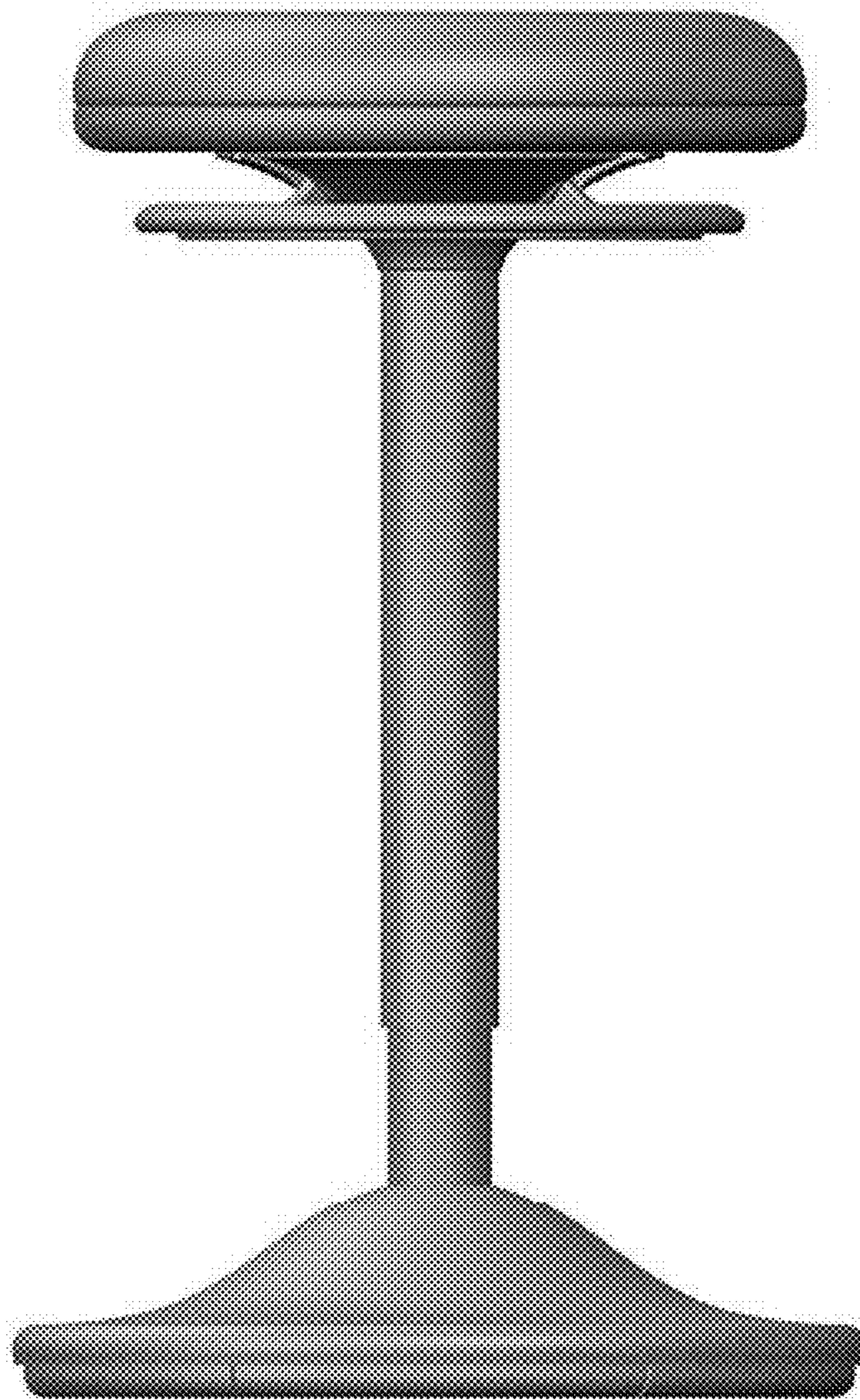

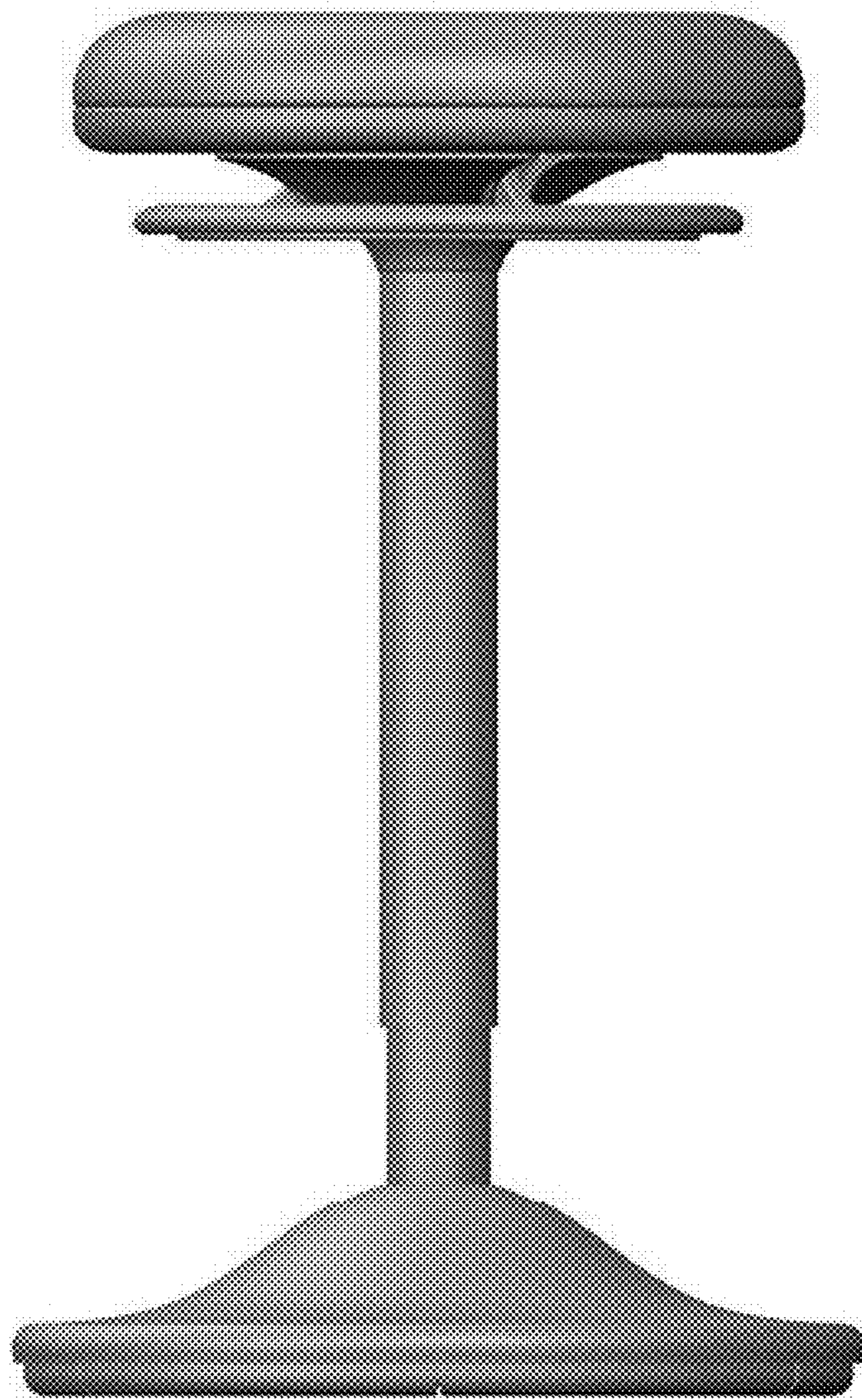

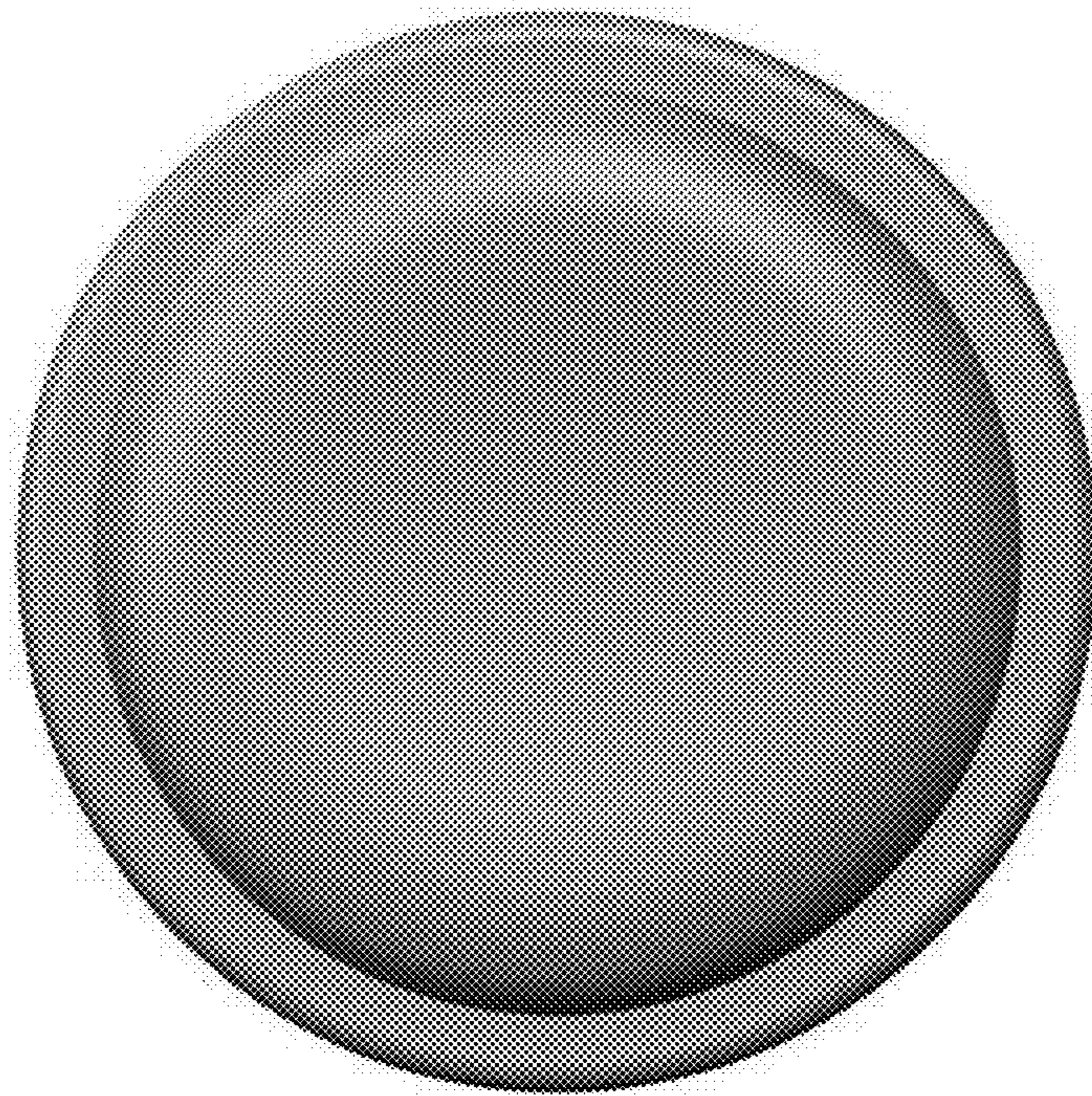

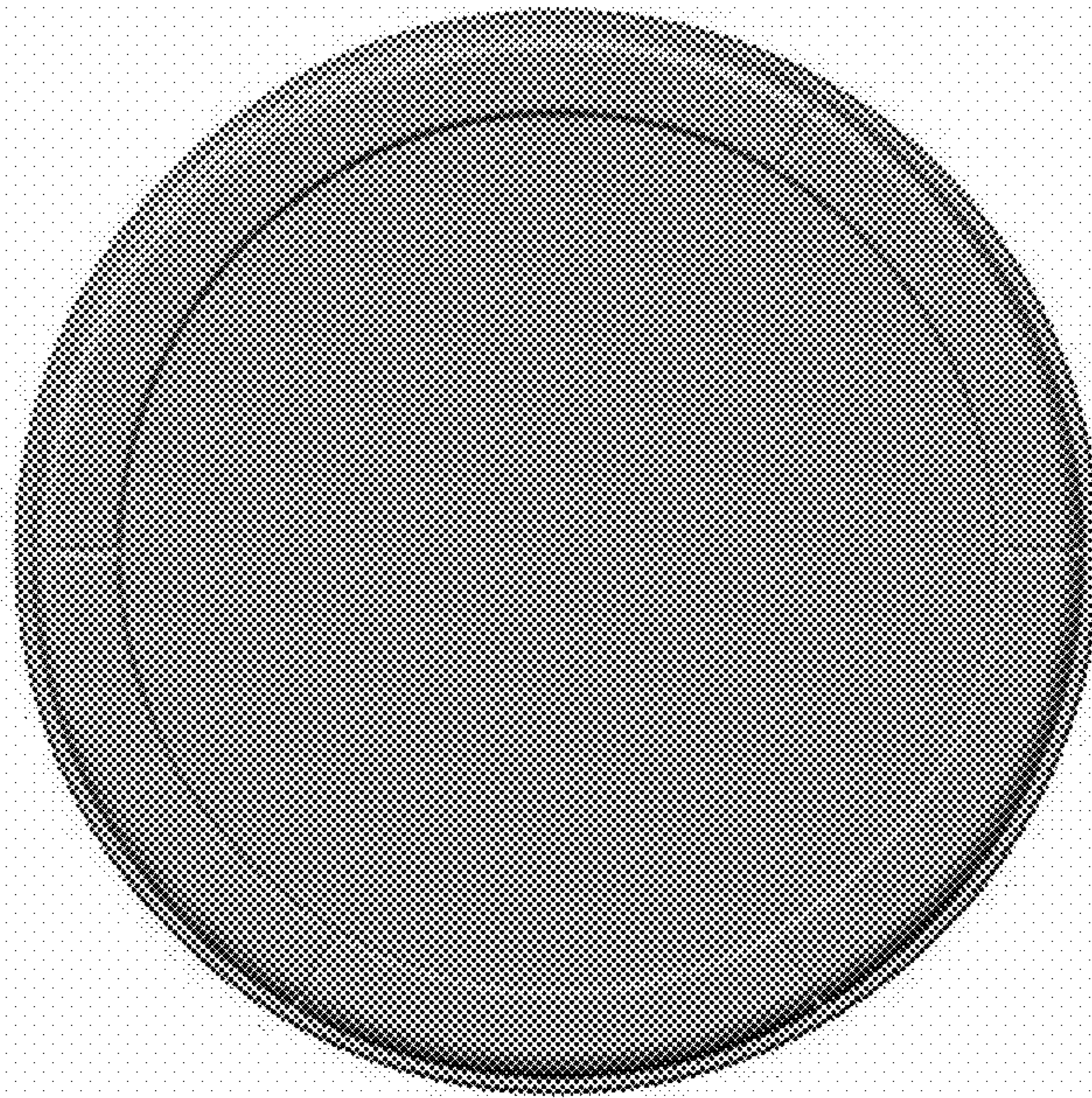
