FIG. 5 is a front elevational view of the seating shell;

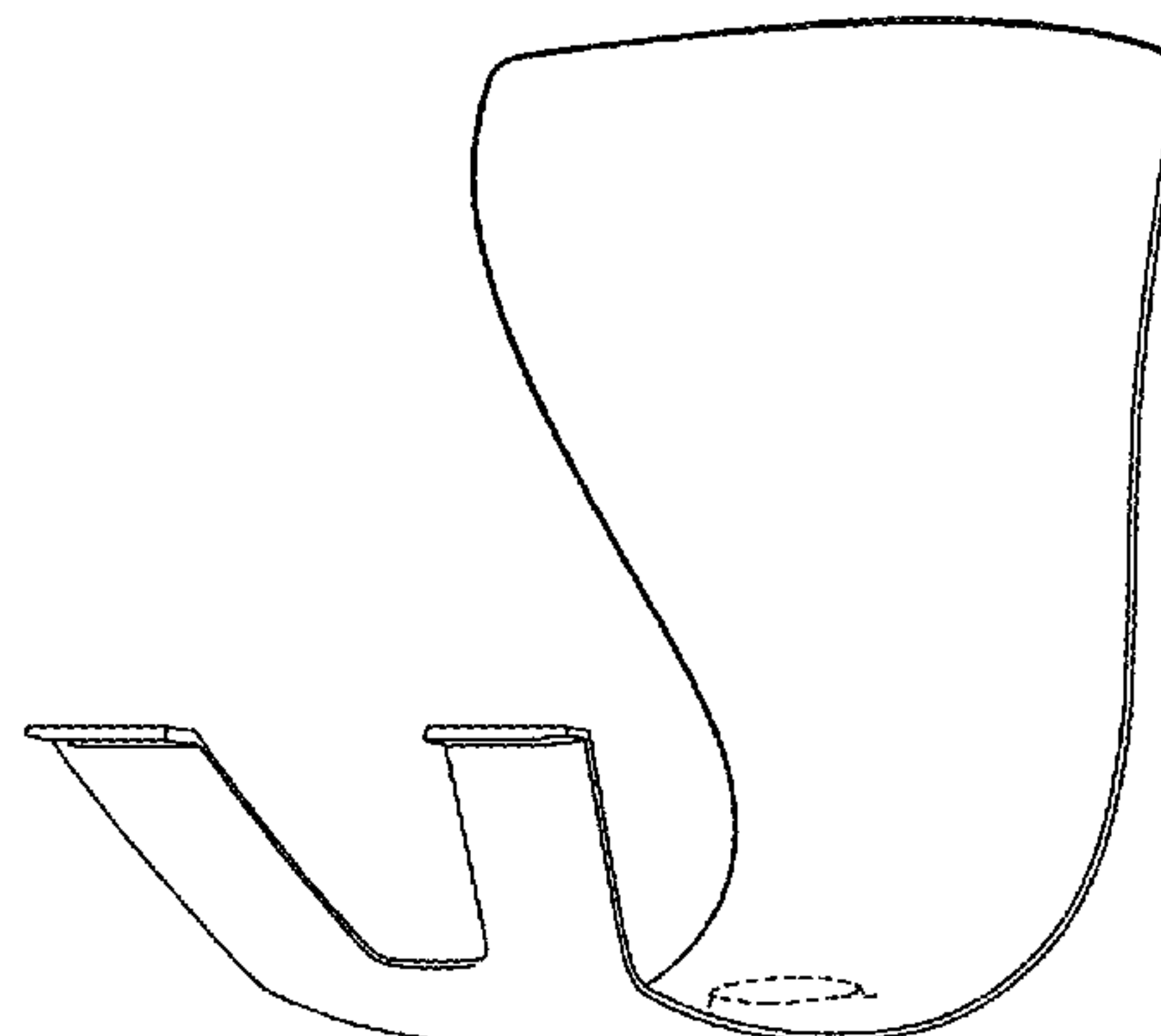
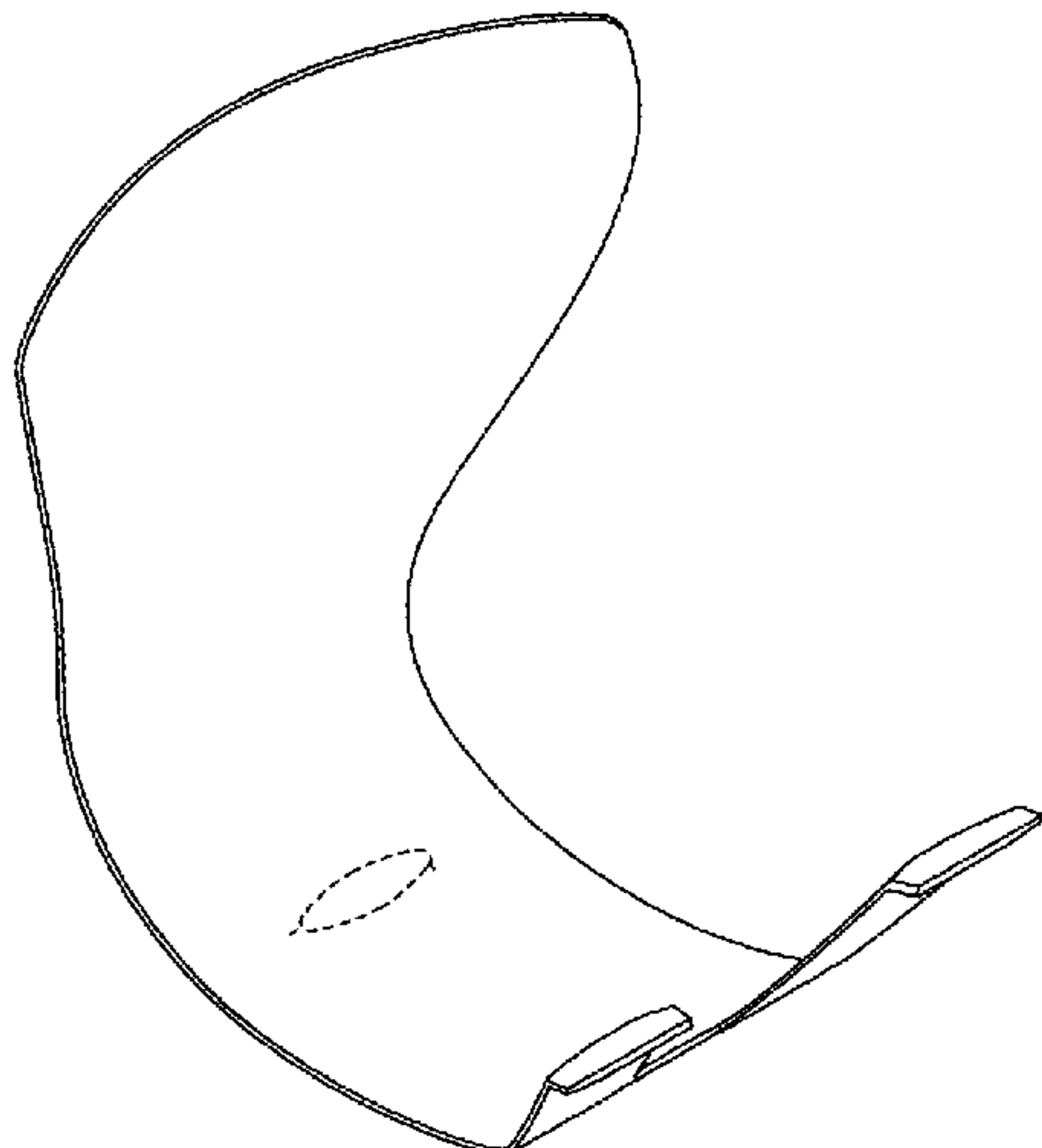
FIG. 6 is a side elevational view of the seating shell;

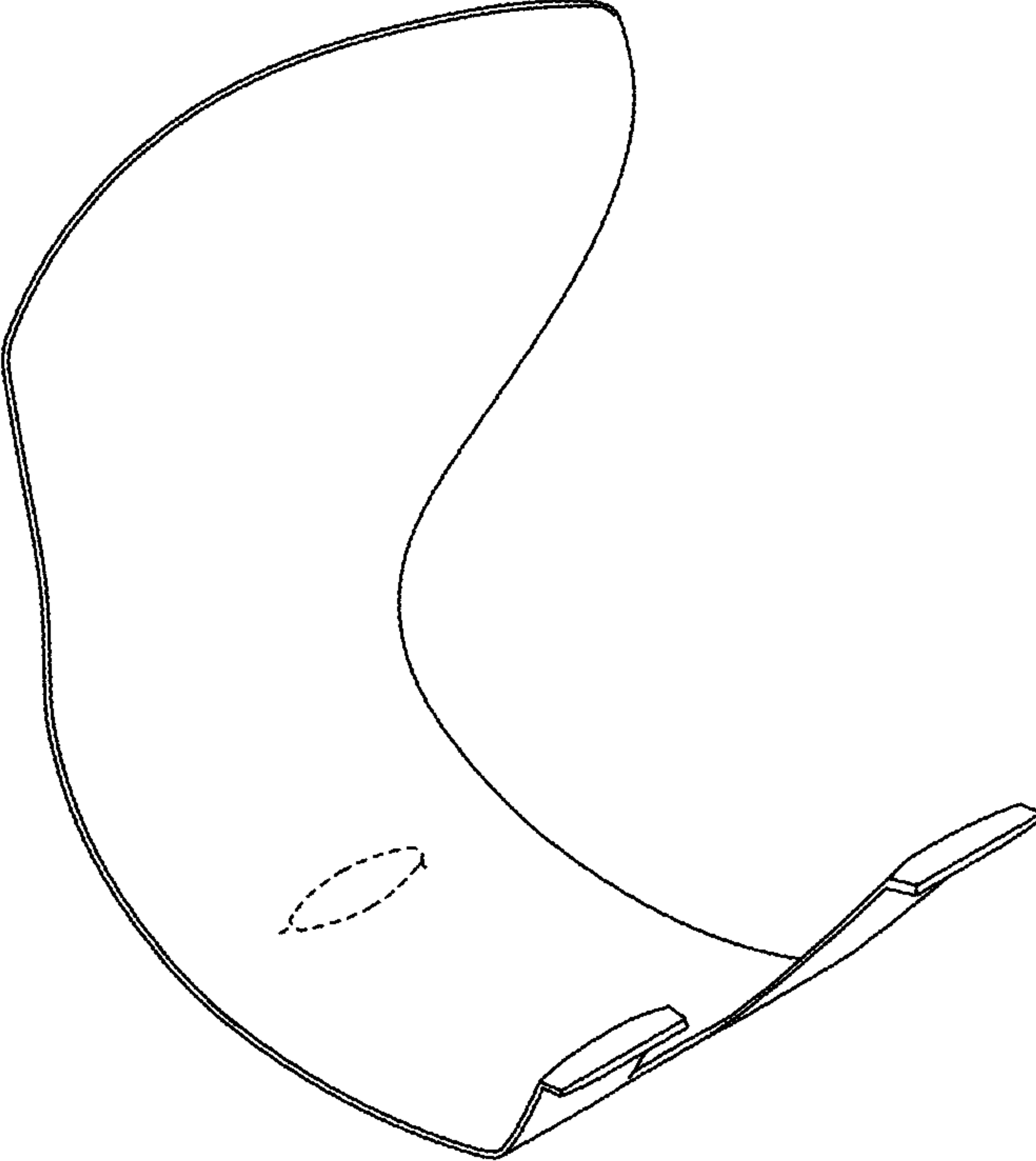

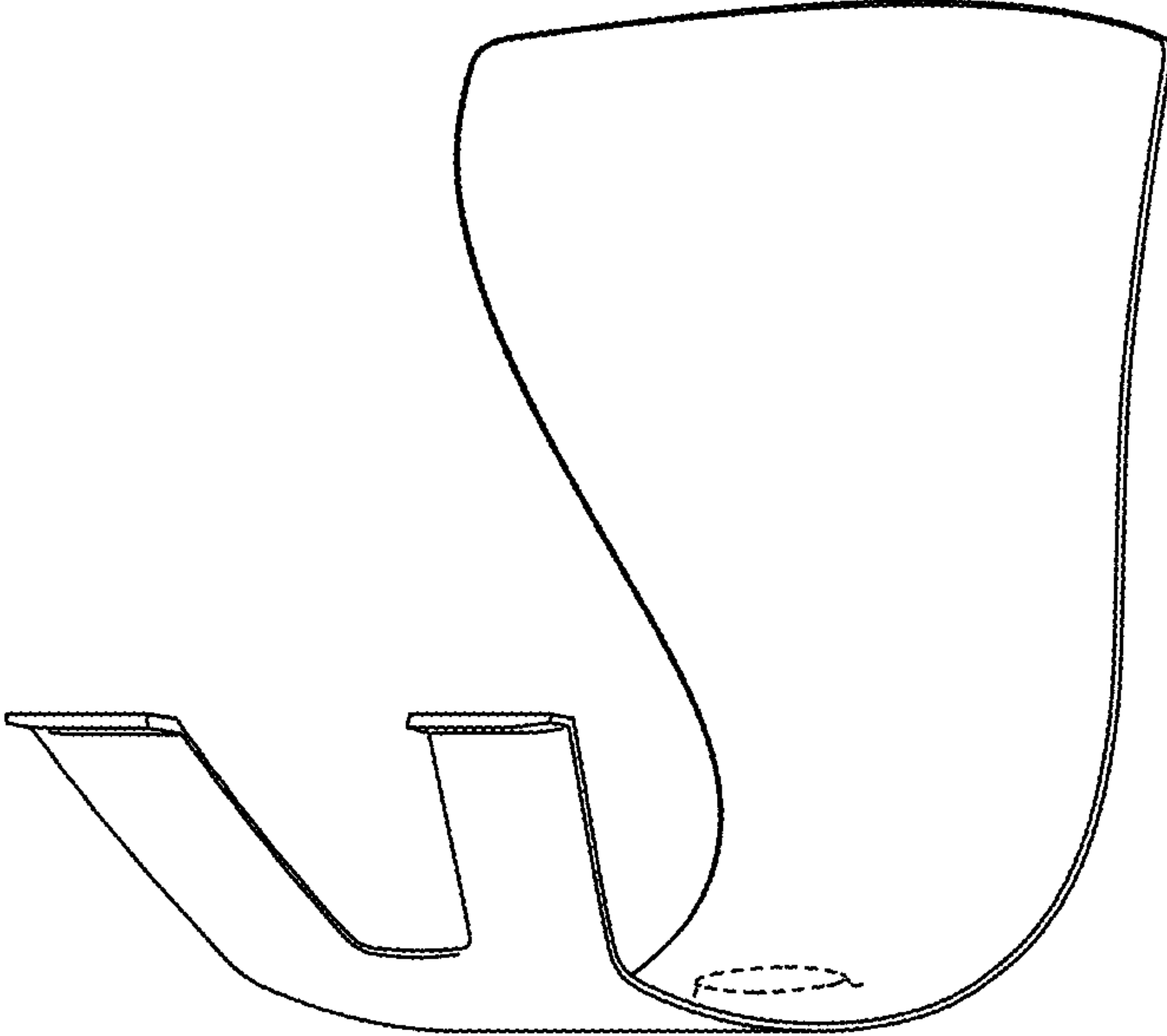
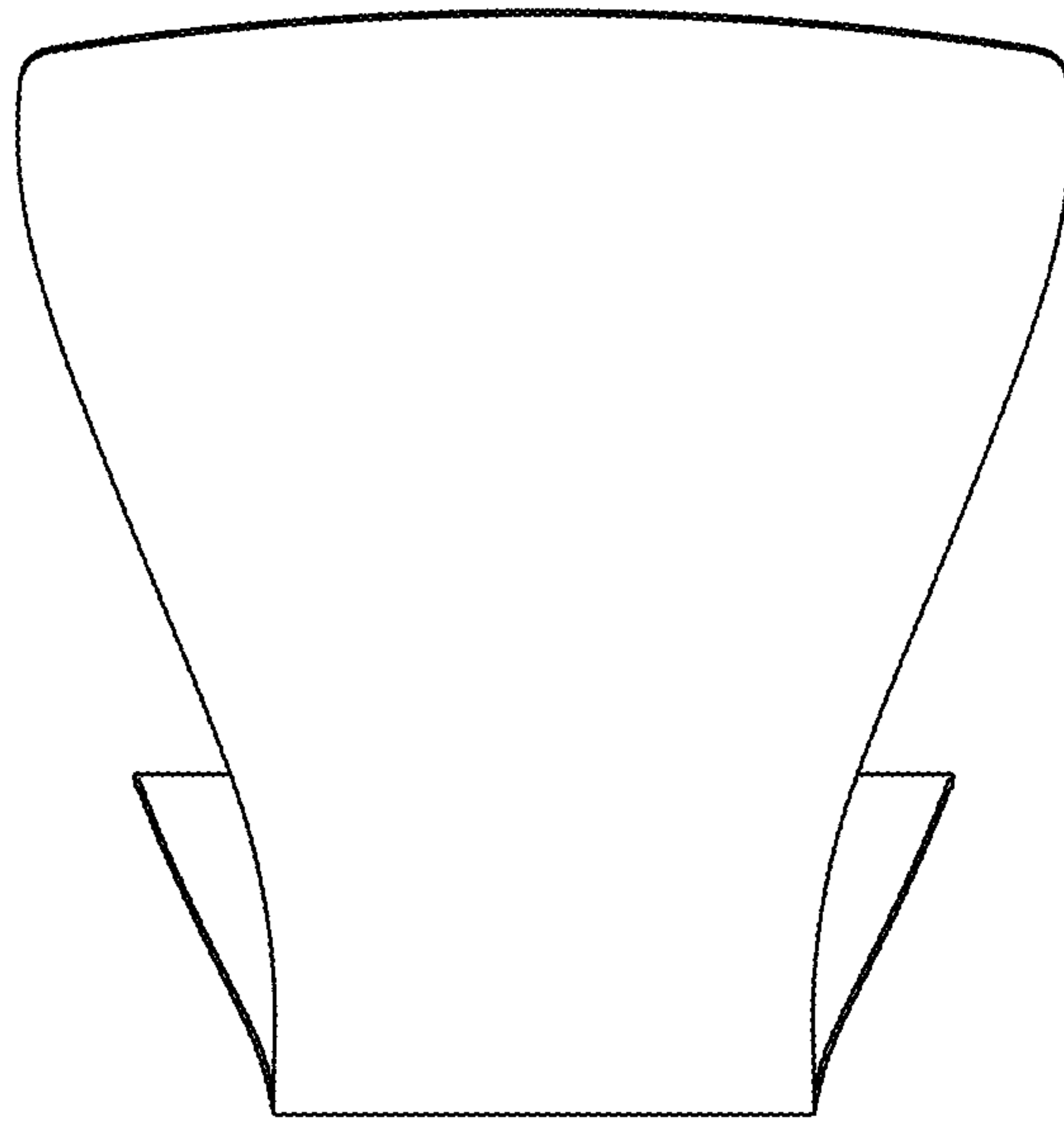
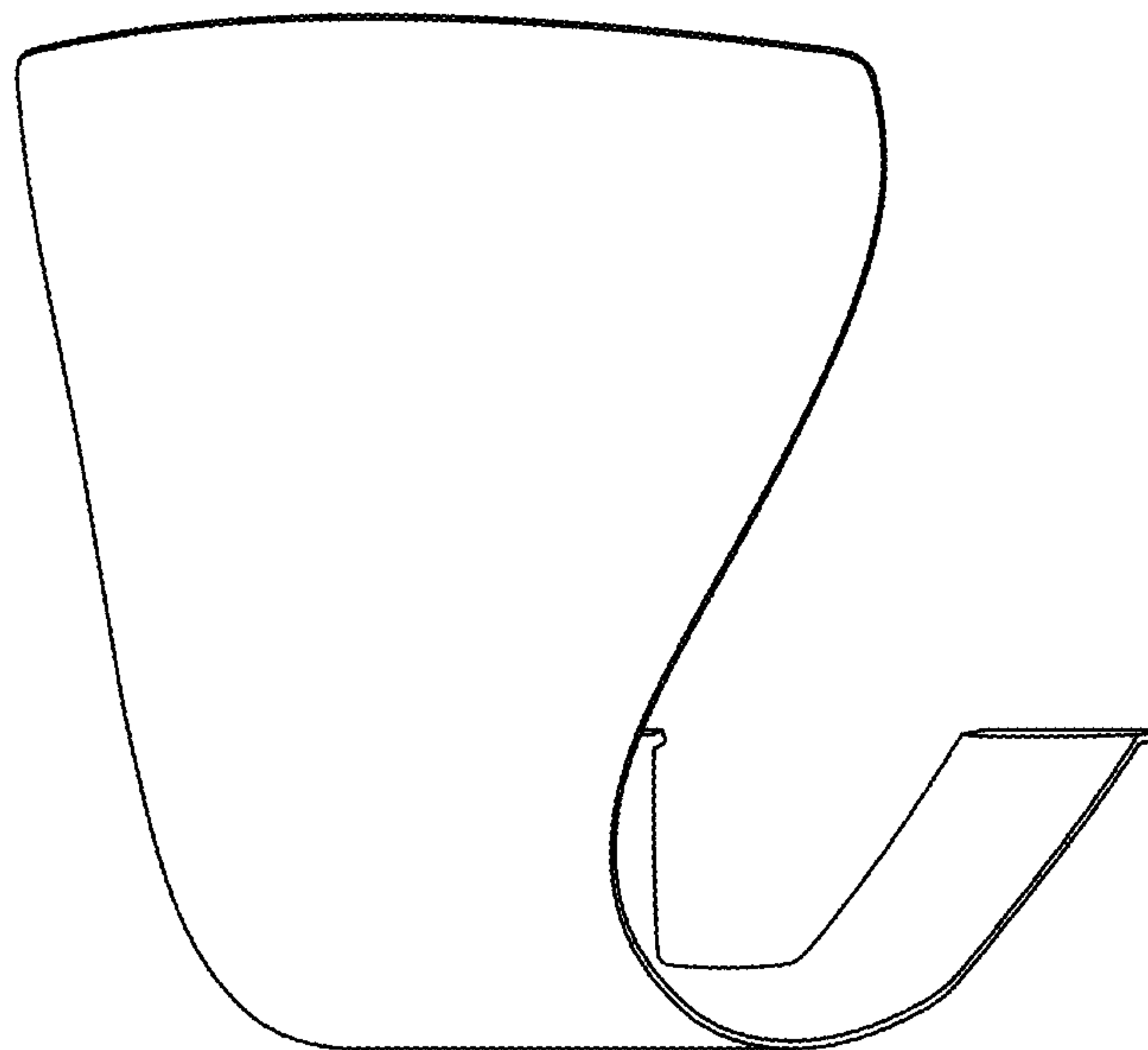

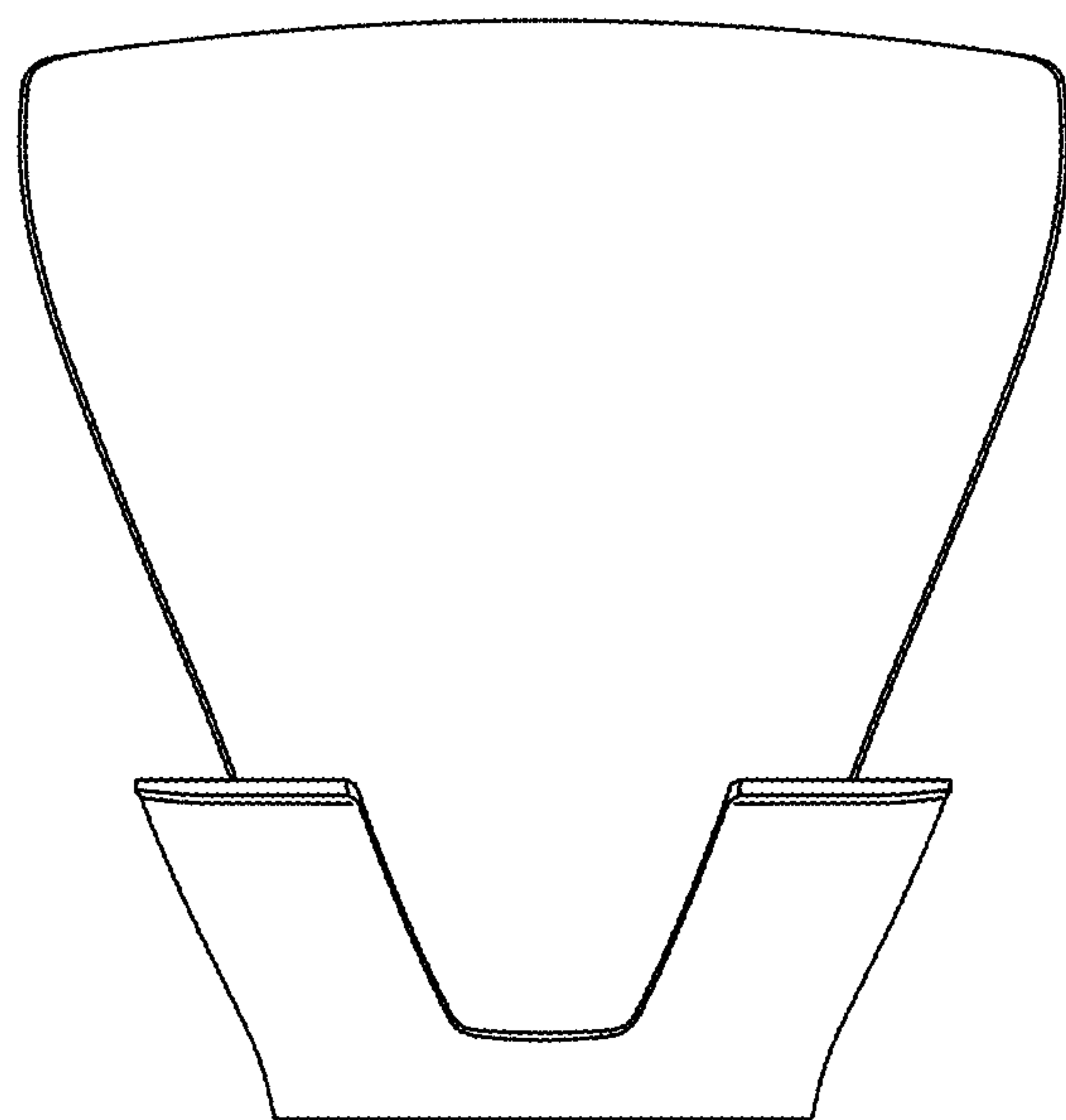

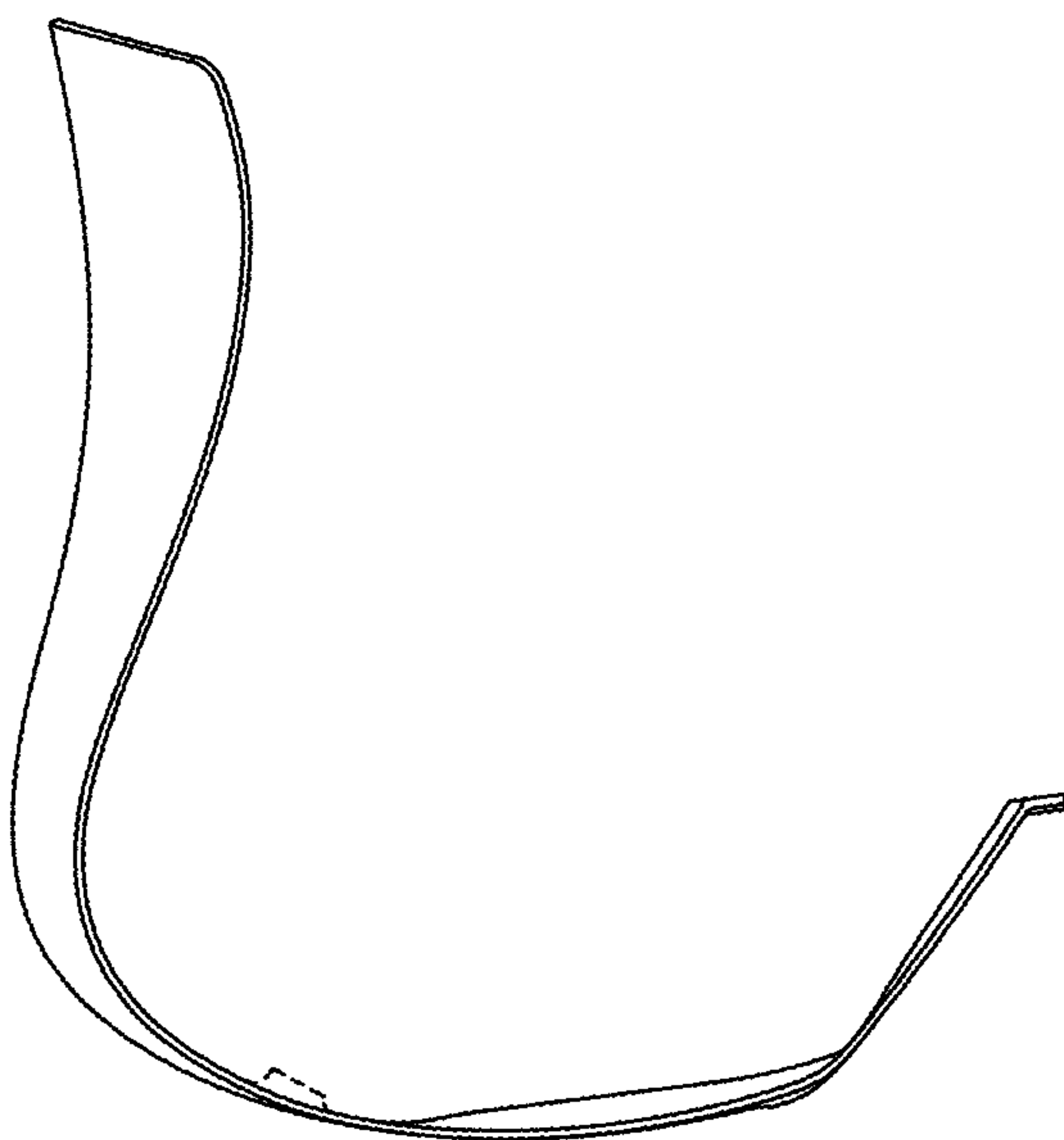

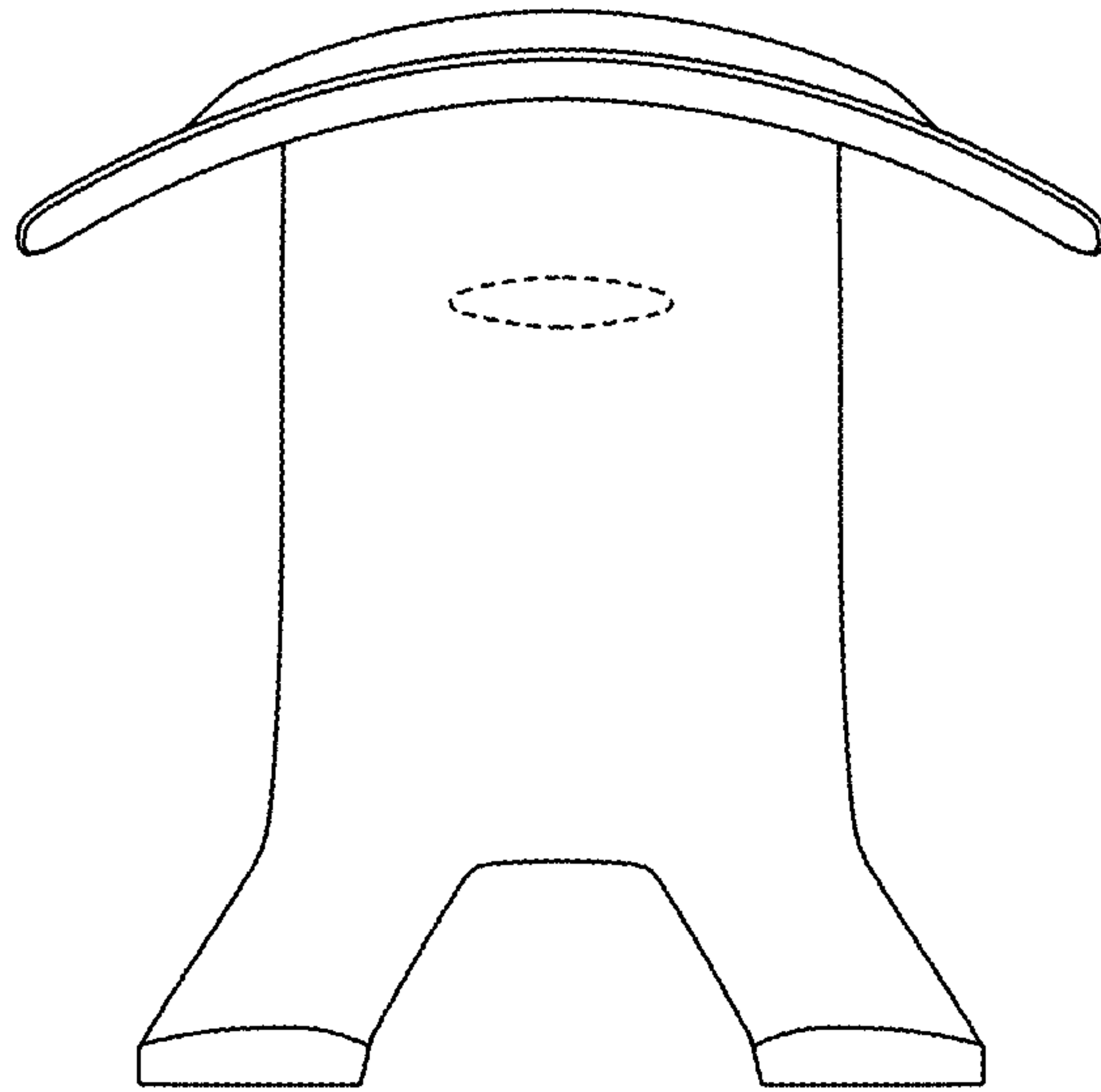

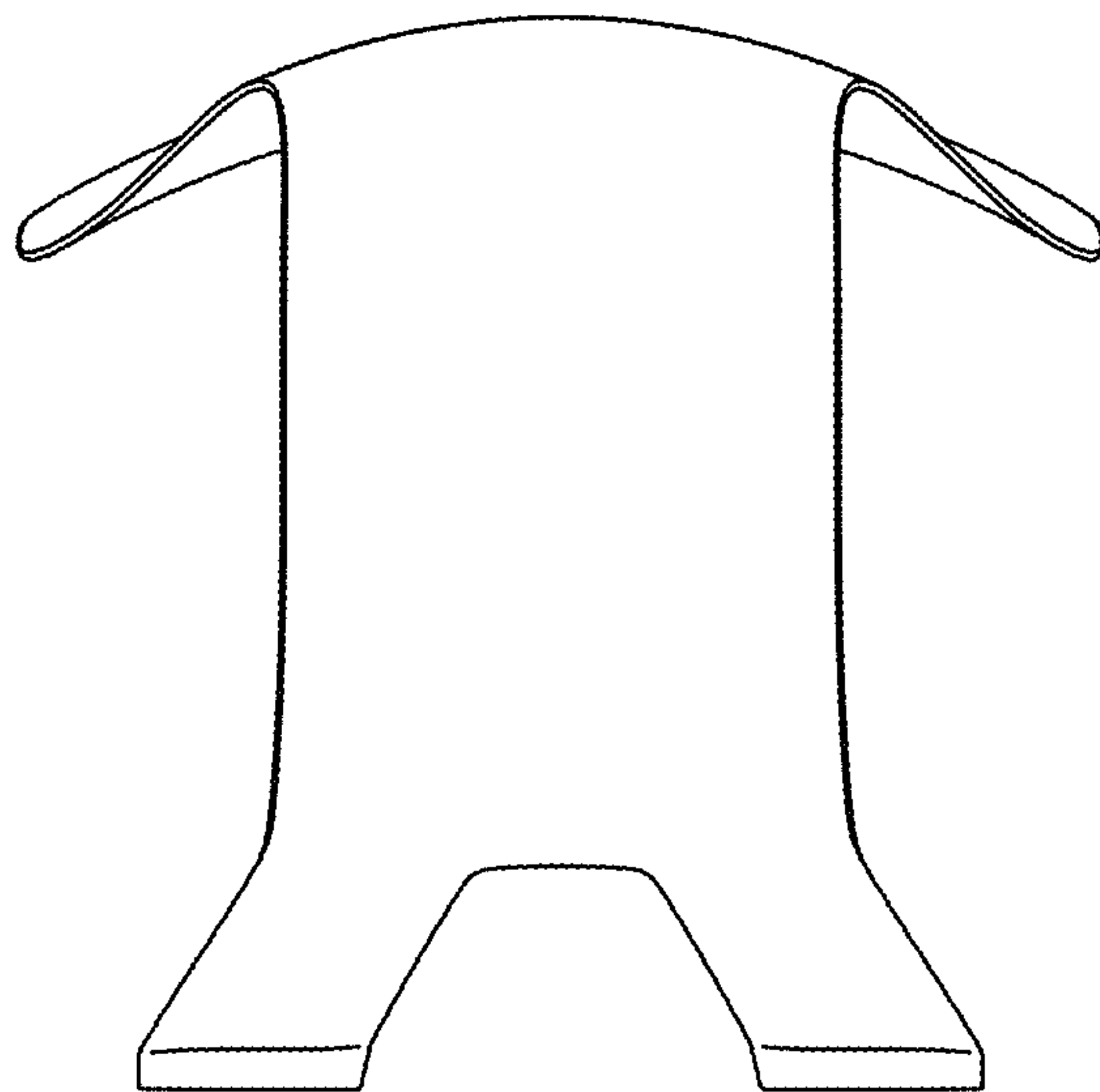
