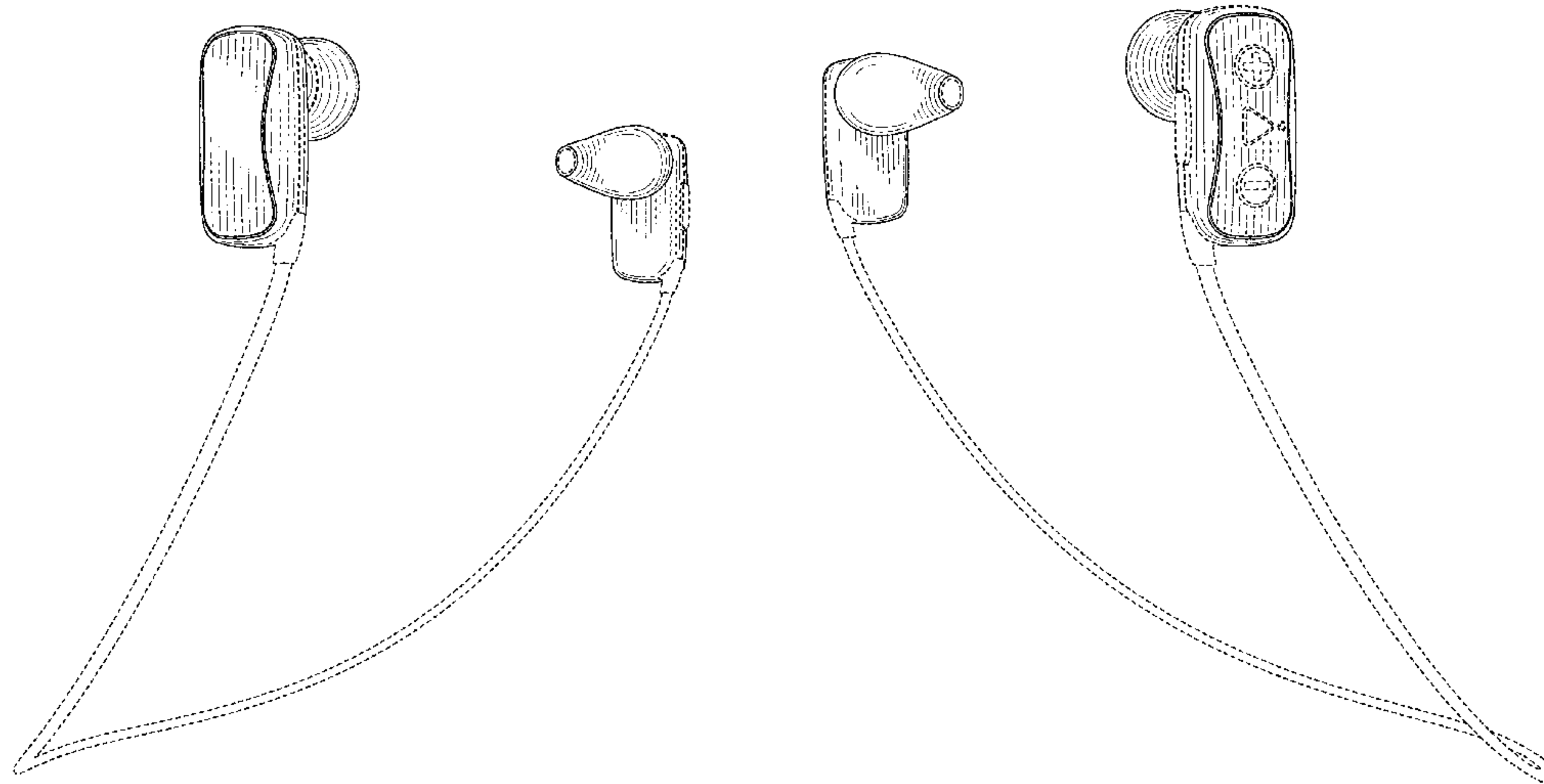
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a right side perspective view of pair of earphones showing my new design;

 FIG. 4 is a rear elevational view thereof;

 FIG. 6 is a bottom plan view thereof;

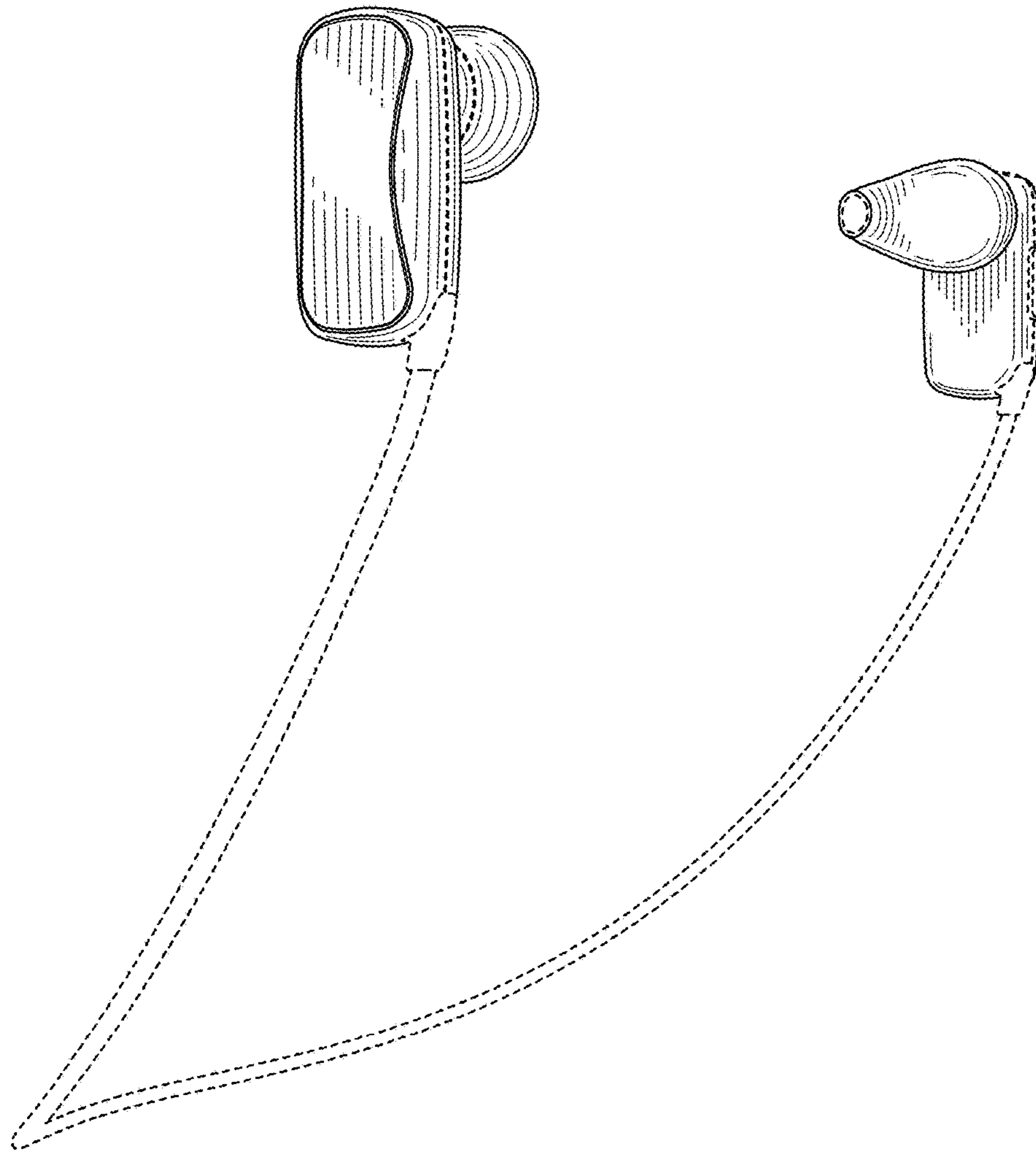
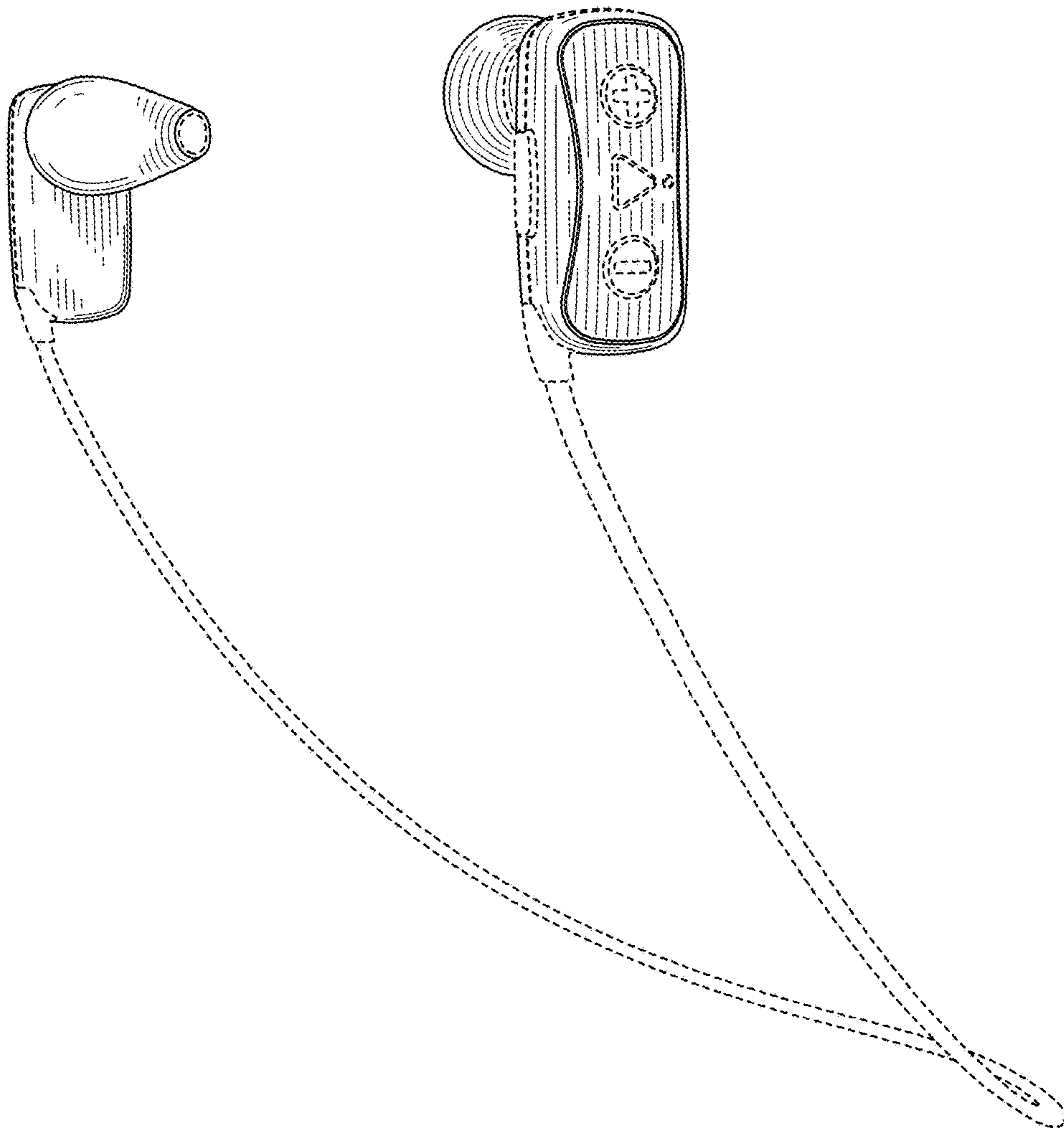

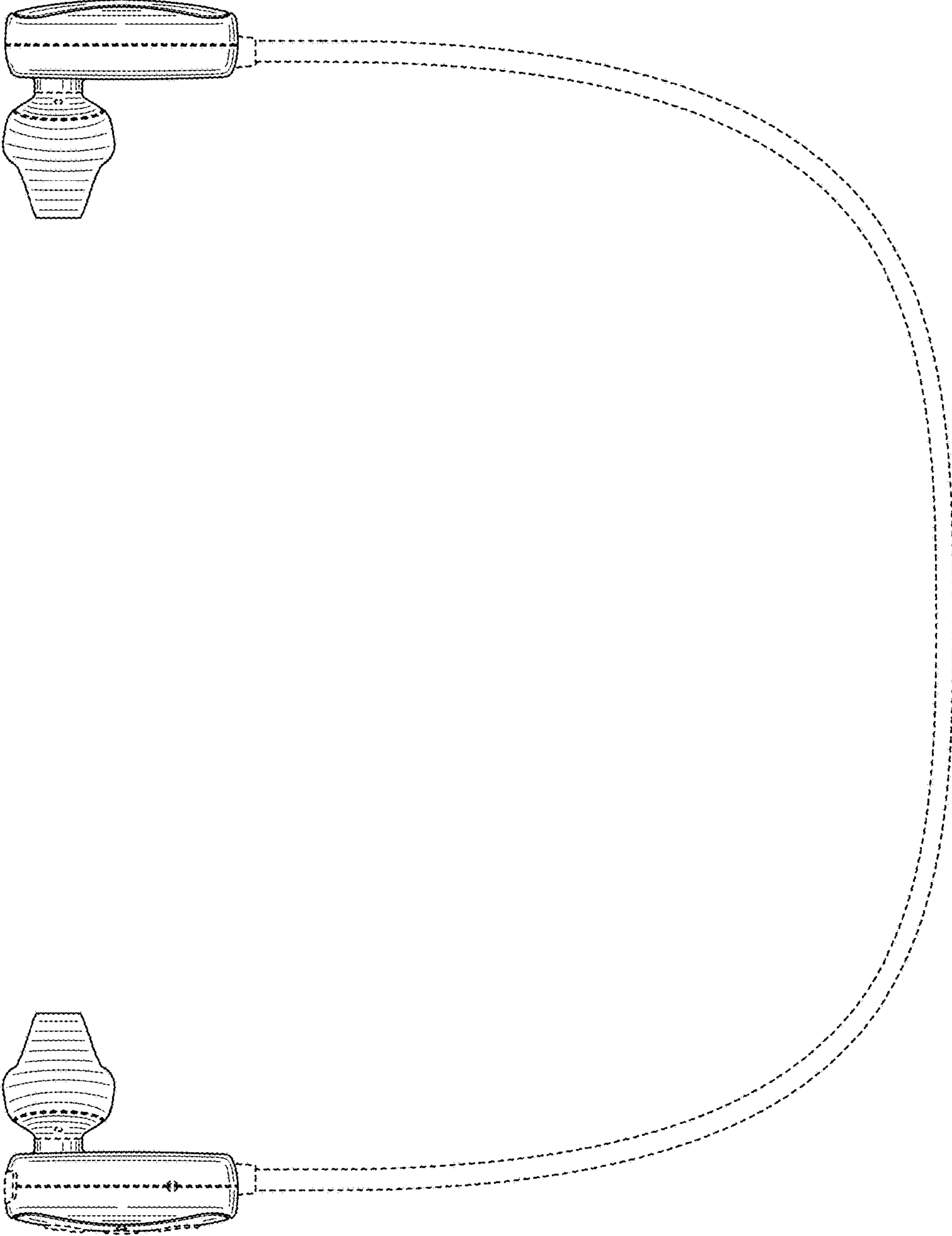

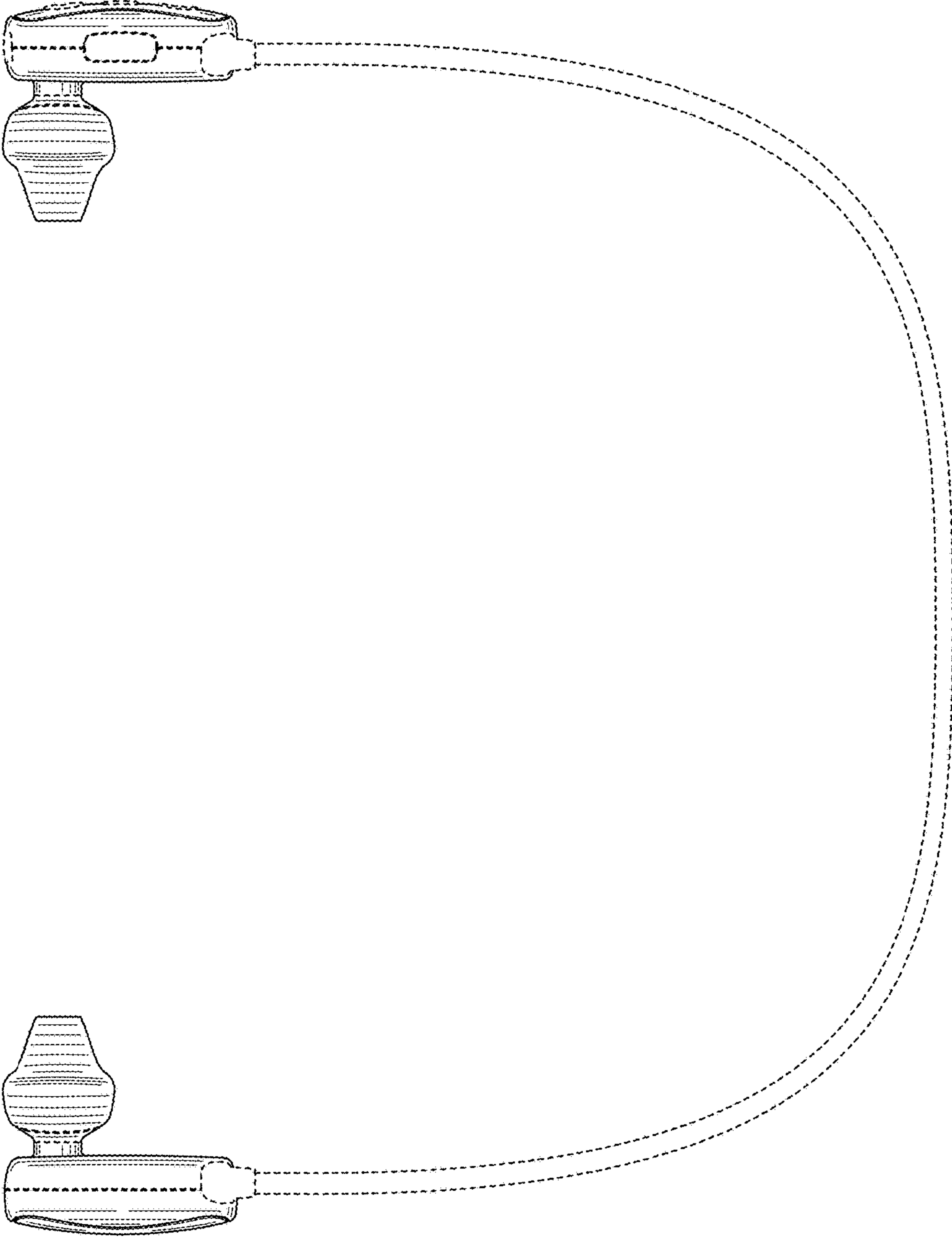

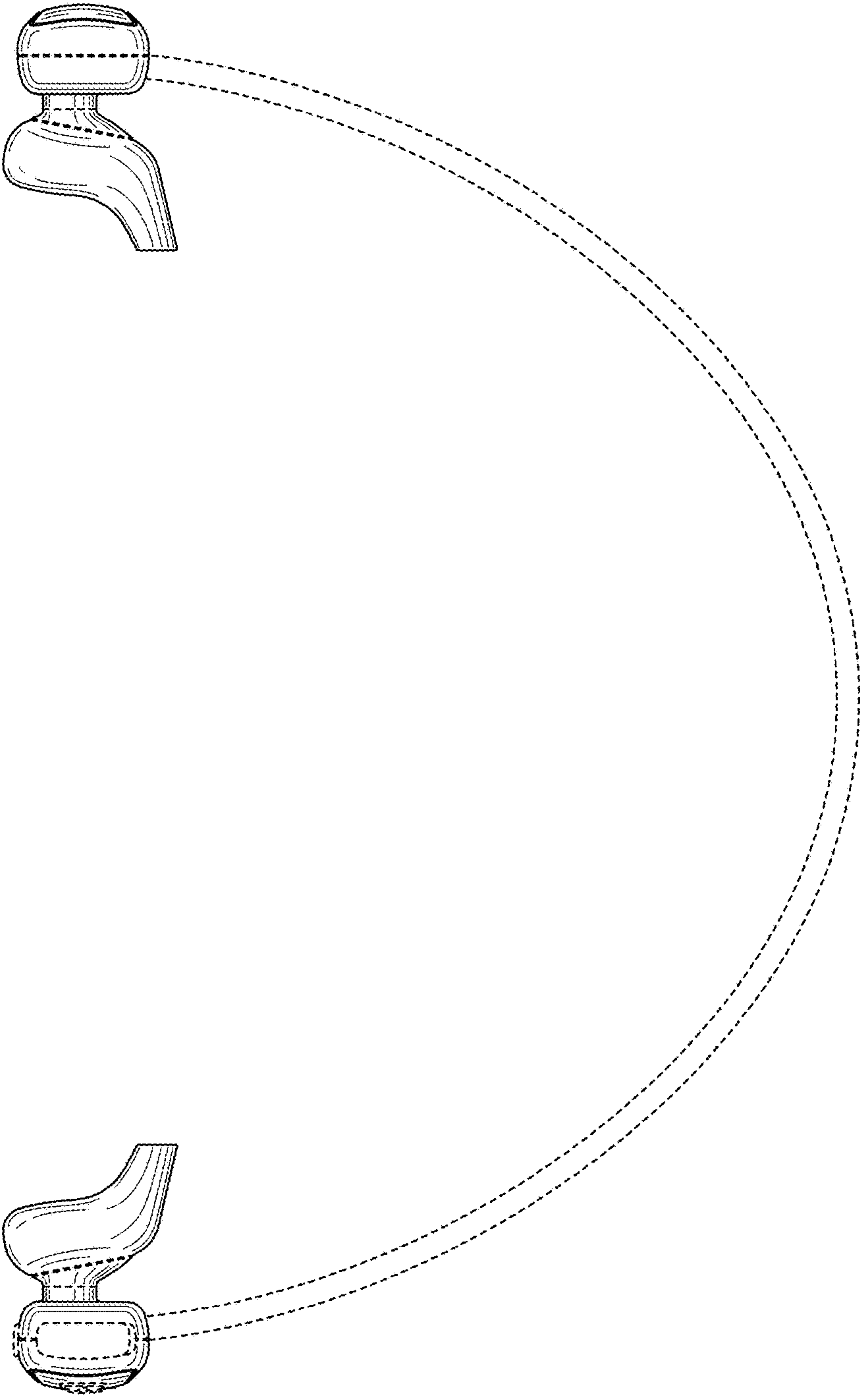

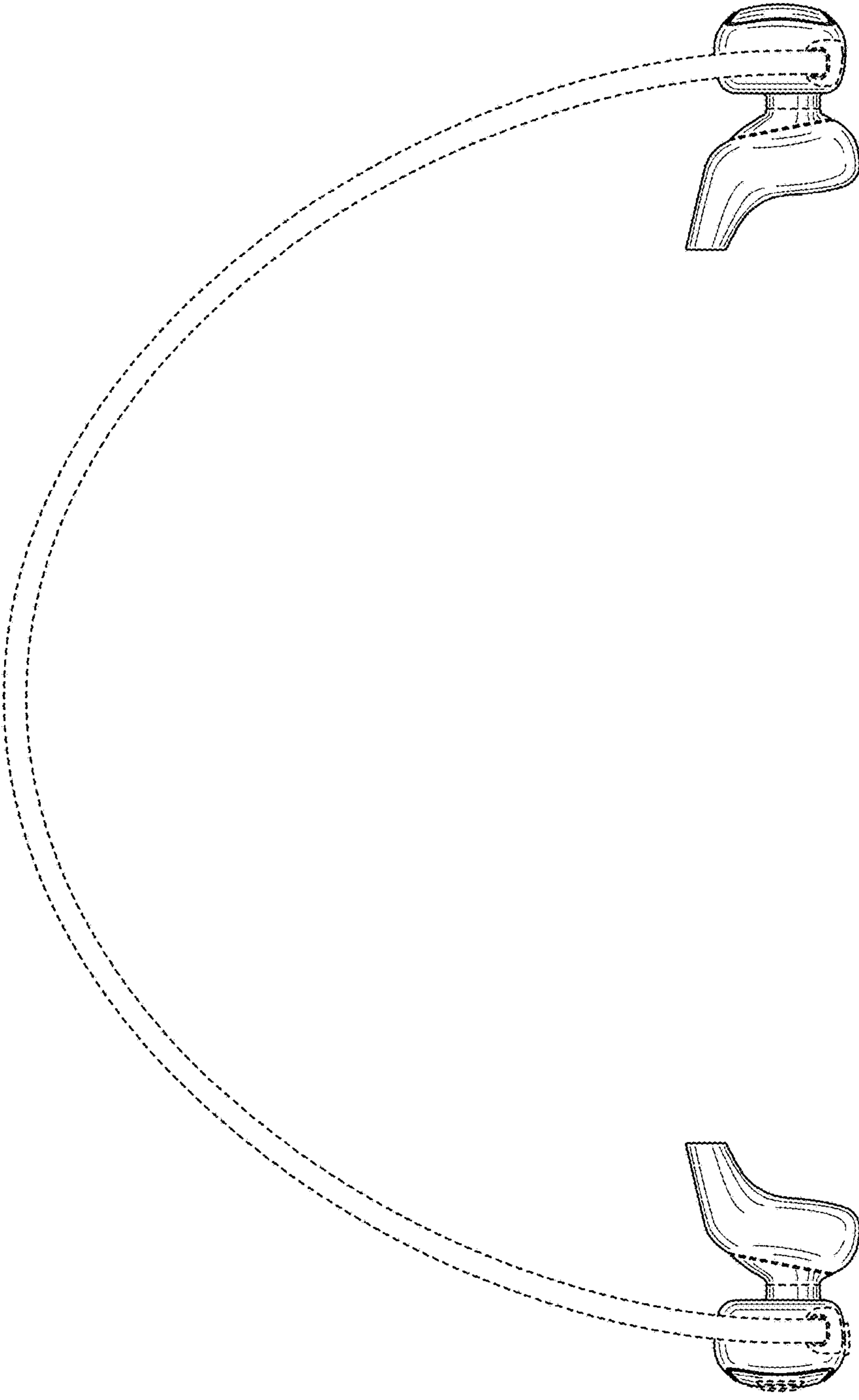

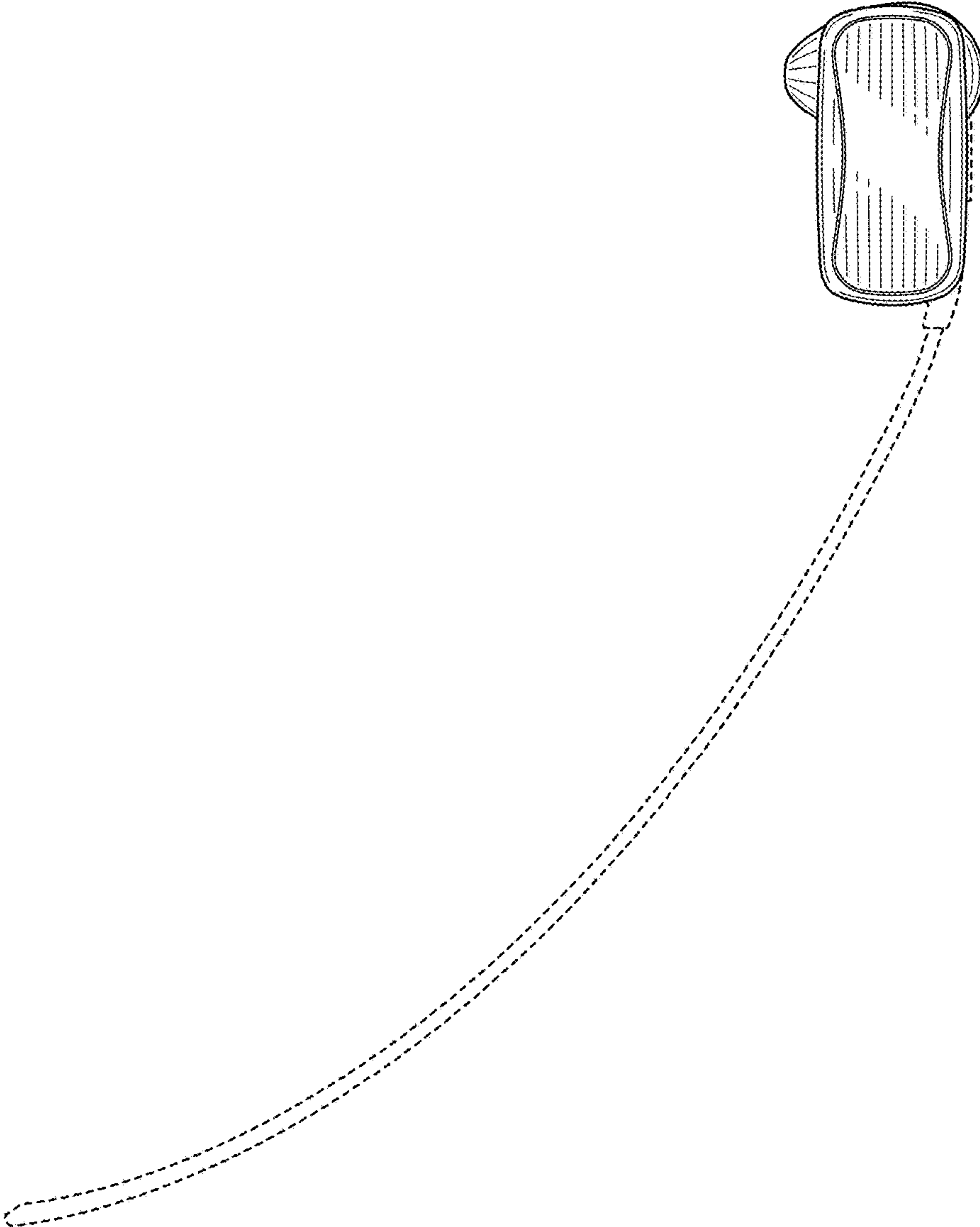
