(57) **CLAIM**

The ornamental design for a handling and/or processing station, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a handling and/or processing station.

FIG. 2 is a left-side view of the handling and/or processing station of FIG. 1.

FIG. 3 is a top view of the handling and/or processing station of FIG. 1.

FIG. 4 is a right-side view of the handling and/or processing station of FIG. 1.

FIG. 5 is a rear view of the handling and/or processing station of FIG. 1.

FIG. 6 is a bottom view of the handling and/or processing station of FIG. 1.

FIG. 7 is a front perspective view of the handling and/or processing station of FIG. 1.

FIG. 8 is a front perspective view of a handling and/or processing station that is the same as the handling and/or processing station of FIG. 7 but the handling and/or processing station of FIG. 8 is shown with a door open.

FIG. 9 is a front perspective view of a handling and/or processing station that is the same as the handling and/or processing station of FIG. 7 but the handling and/or processing station of FIG. 9 is shown with a door open and includes a conveyor positioned adjacent the door opening.

FIG. 10 is a front perspective view of a handling and/or processing station that is the same as the handling and/or processing station of FIG. 9 but the handling and/or processing station of FIG. 10 includes a component exiting the door opening and onto the conveyor.

FIG. 11 is a front perspective view of a handling and/or processing station that is the same as the handling and/or processing station of FIG. 7 but the handling and/or processing station of FIG. 11 is shown with a door open and includes a conveyor positioned adjacent the door opening.

FIG. 12 is a front perspective view of a handling and/or processing station that is the same as the handling and/or processing station of FIG. 1 but the handling and/or processing station of FIG. 12 includes a conveyor positioned adjacent the door.

FIG. 13 is a front view of a handling and/or processing station that is the same as the handling and/or processing station of FIG. 1 but the handling and/or processing station of FIG. 13 includes a conveyor positioned adjacent the door.

FIG. 14 is a front perspective view of the handling and/or processing station of FIG. 13.

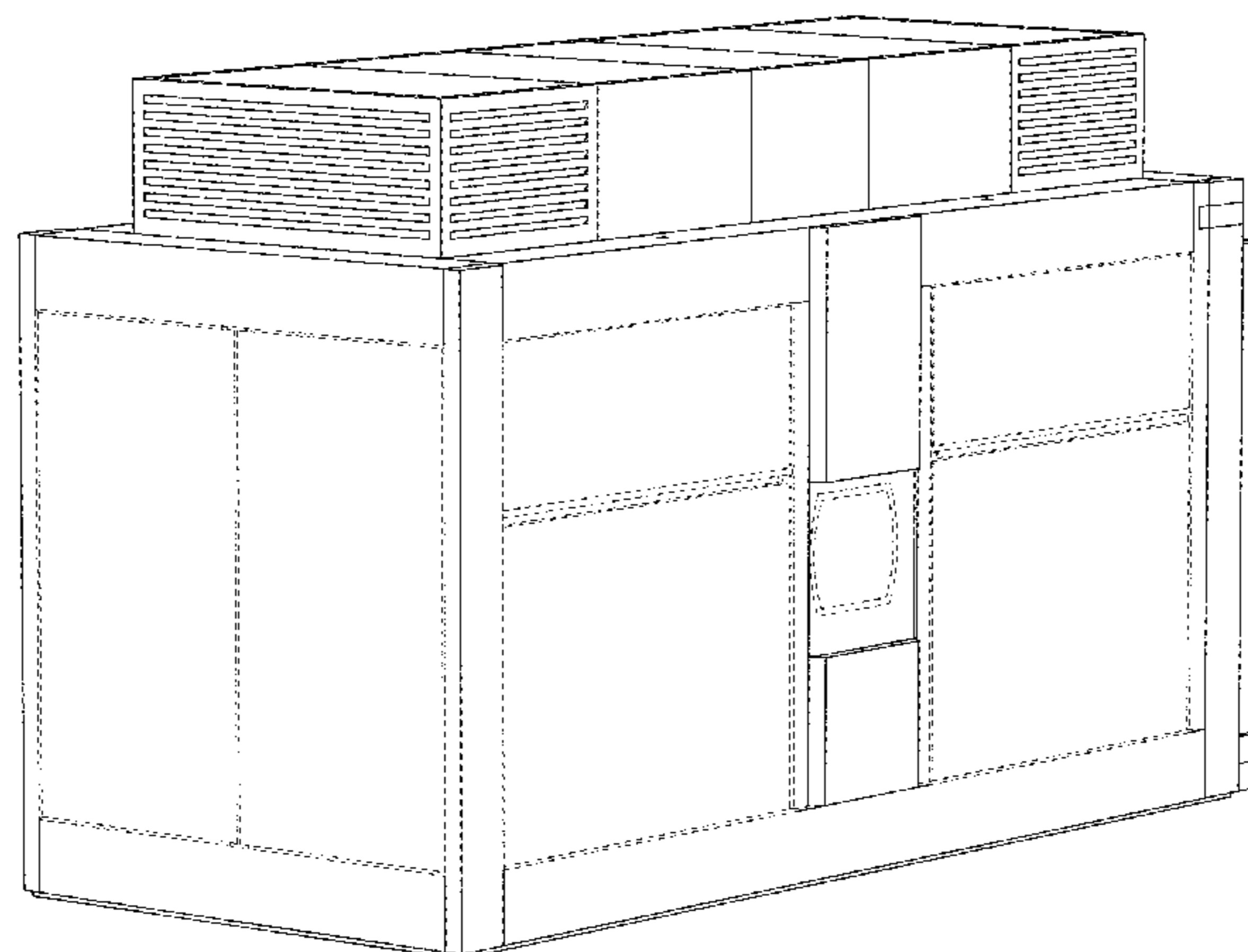


FIG. 15 is a rear view of the handling and/or processing station of FIG. 5.

FIG. 20 is a front view of the handling and/or processing station of FIG. 19.

FIG. 21 is a front perspective view of a handling and/or processing station that is the same as the handling and/or processing station of FIG. 1 but the handling and/or processing station of FIG. 21 includes a conveyor positioned adjacent a door and includes a control panel positioned adjacent a side of the handling and/or processing station; and,

FIG. 22 is a front perspective view of the handling and/or processing station of FIG. 1.

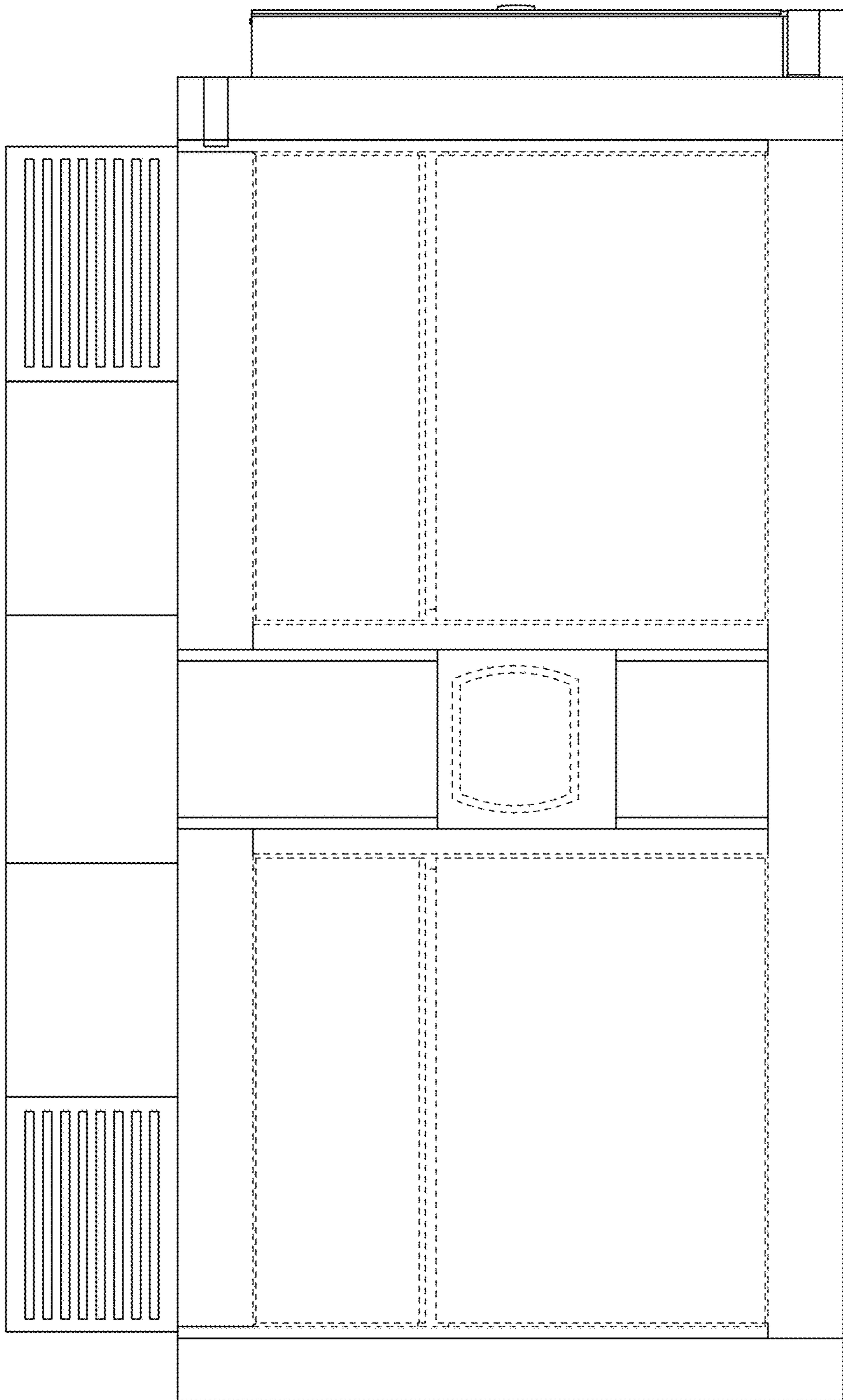

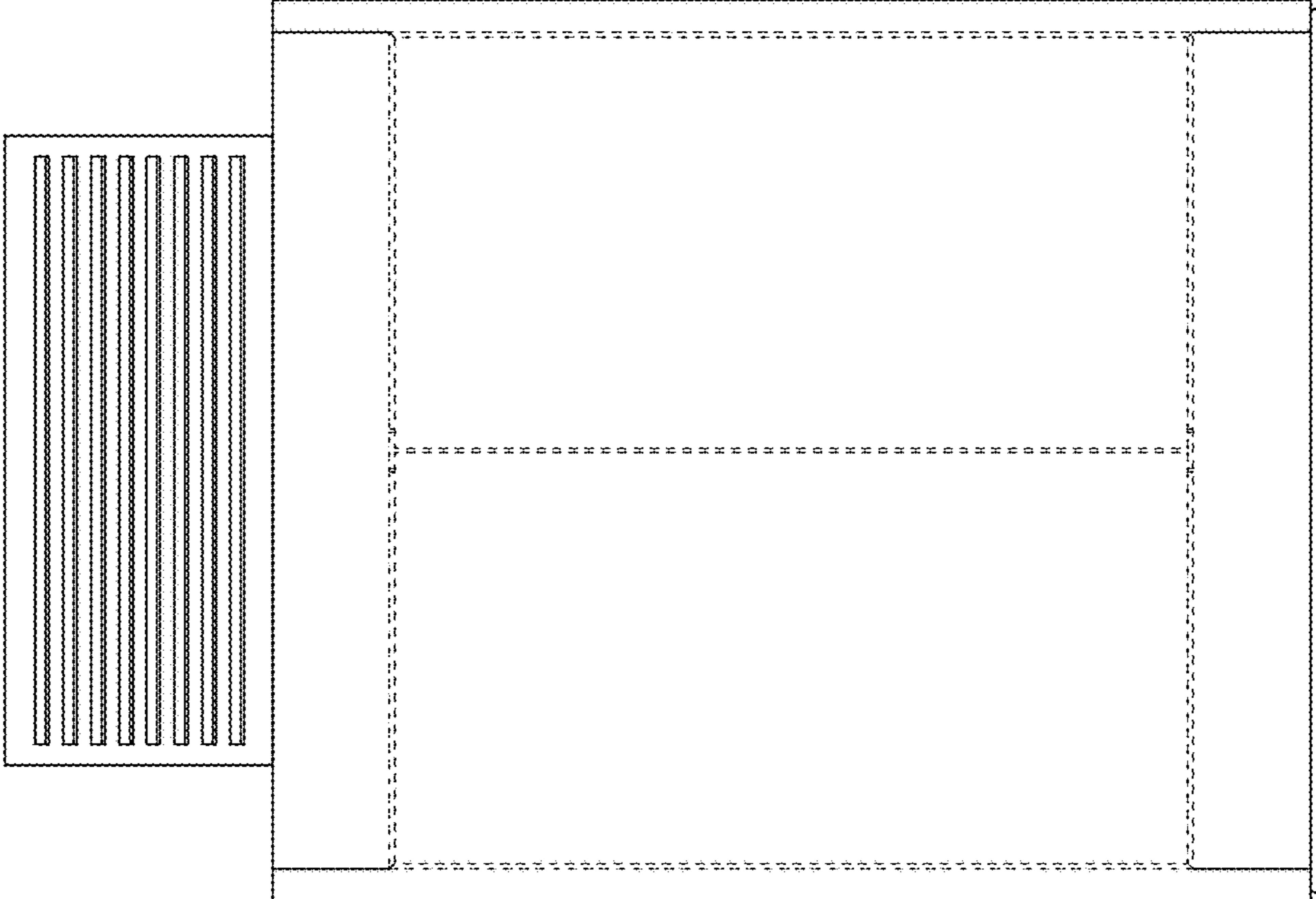

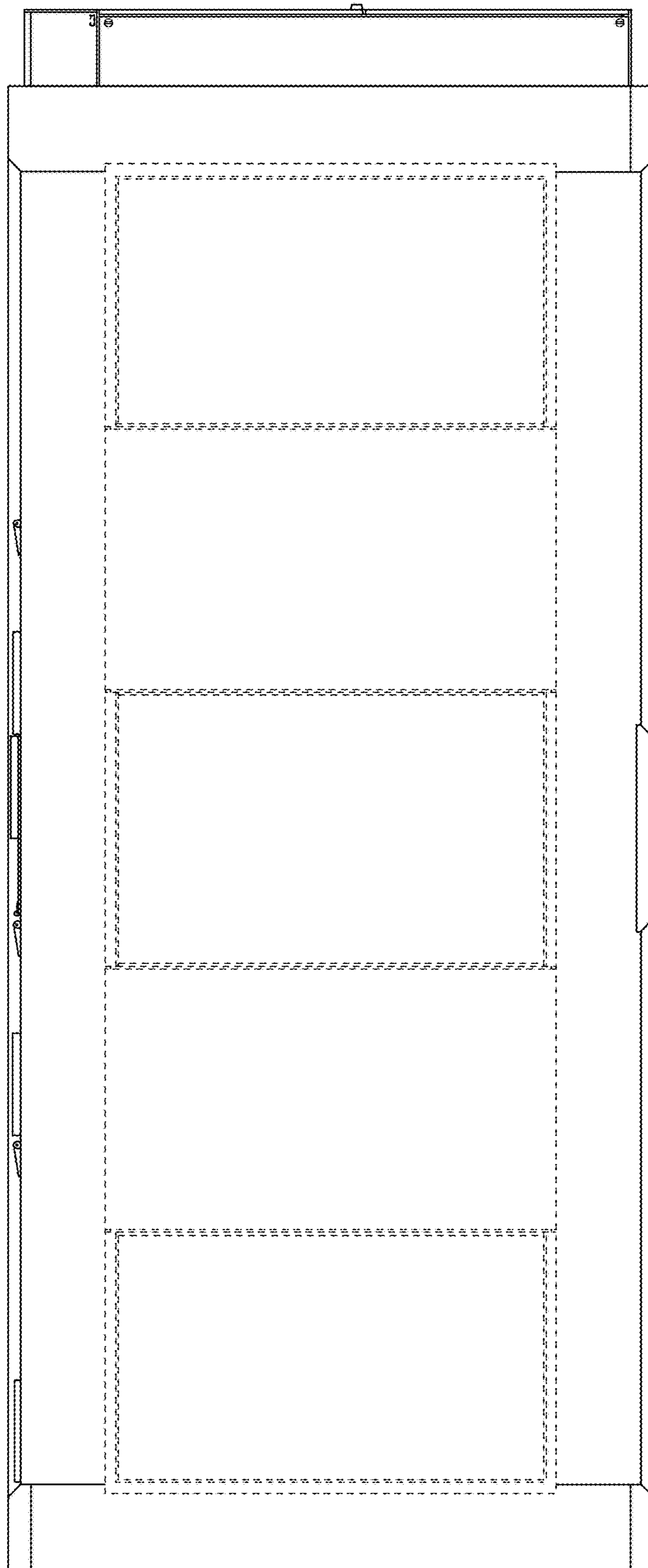

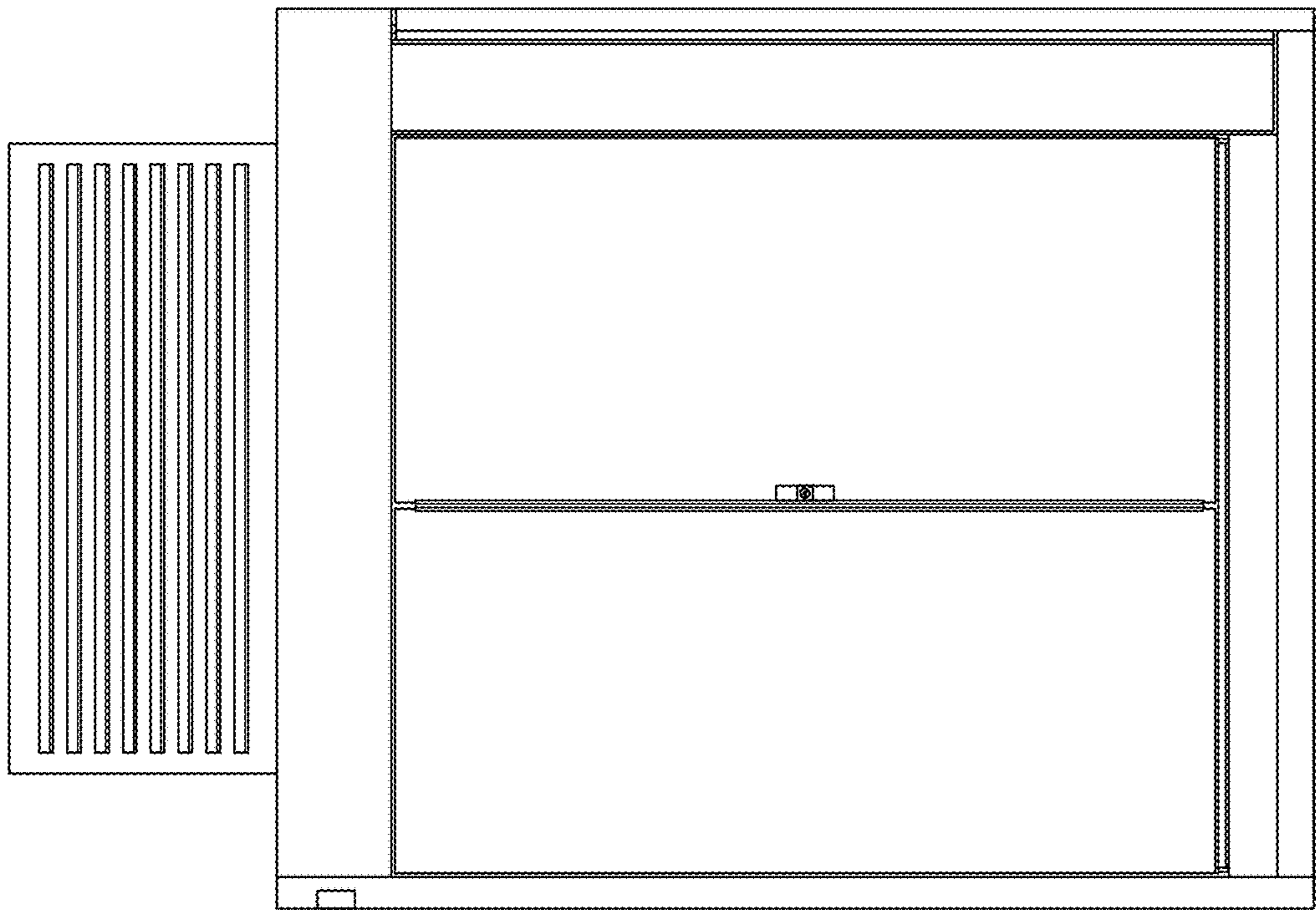

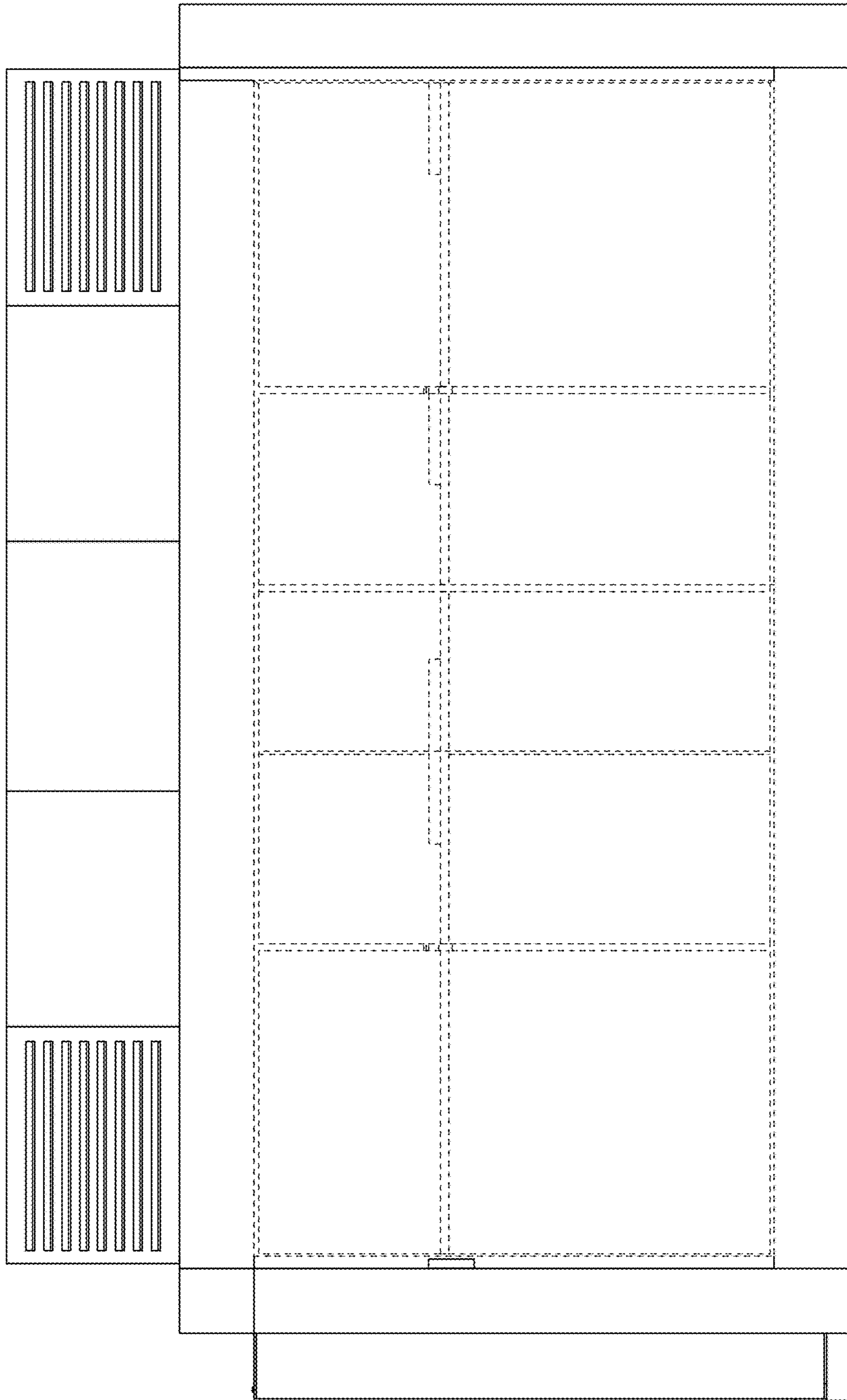

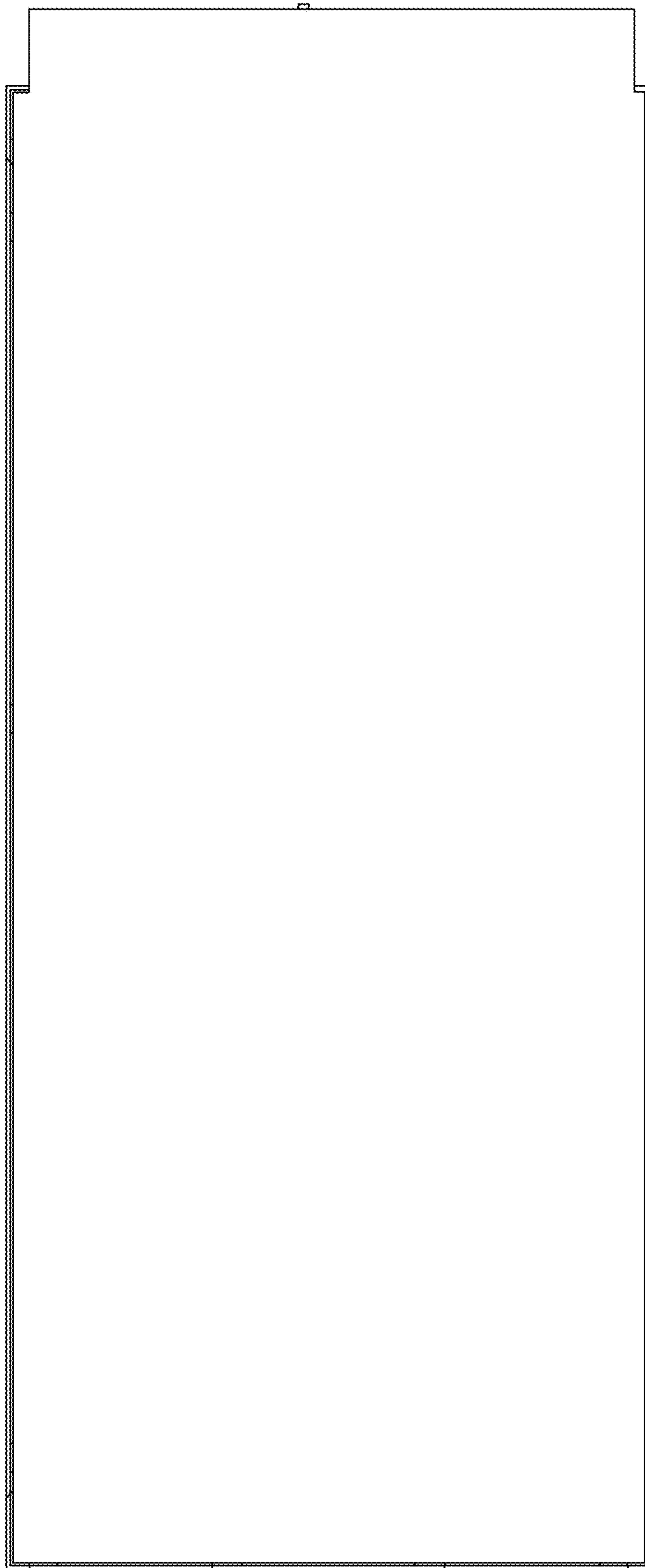

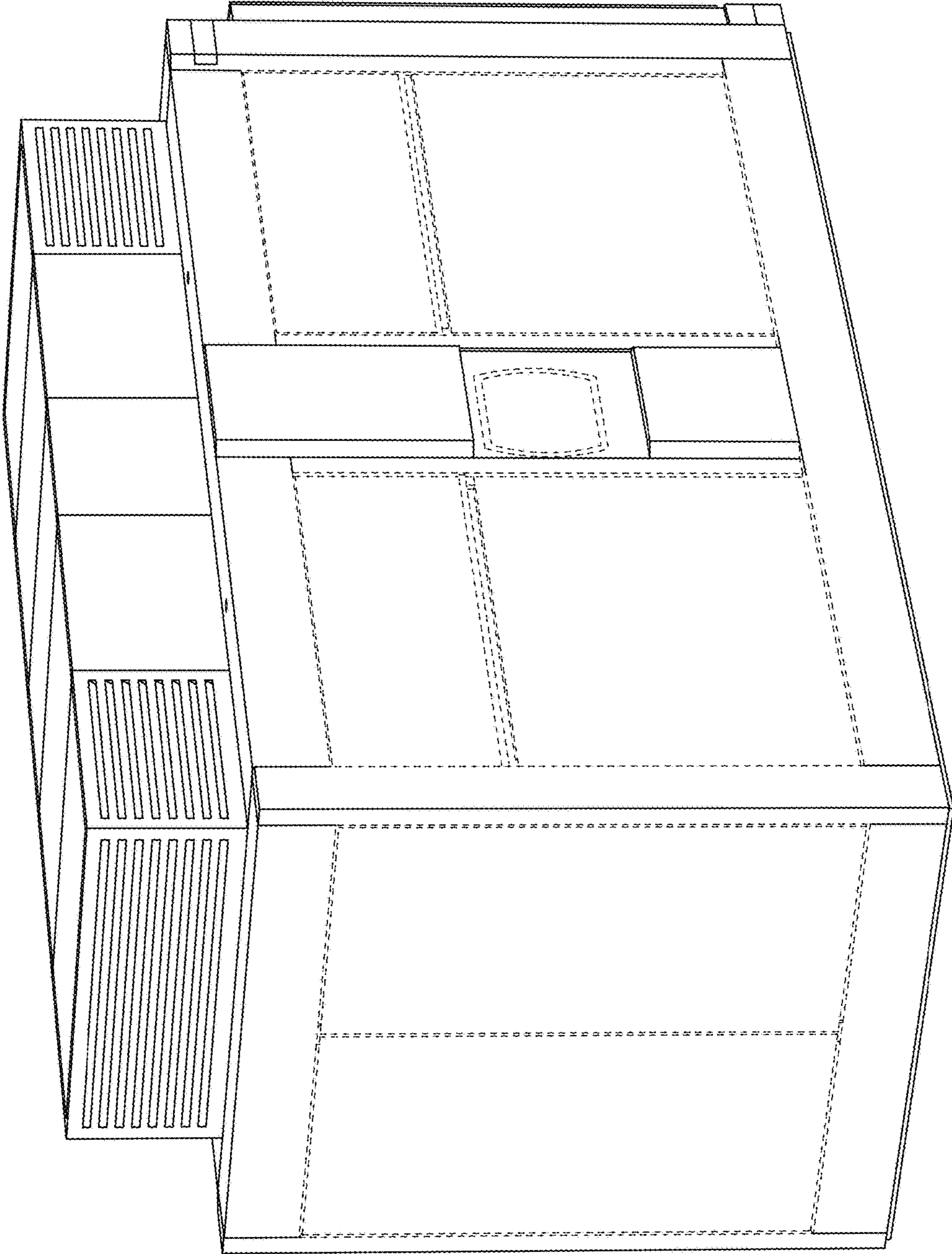

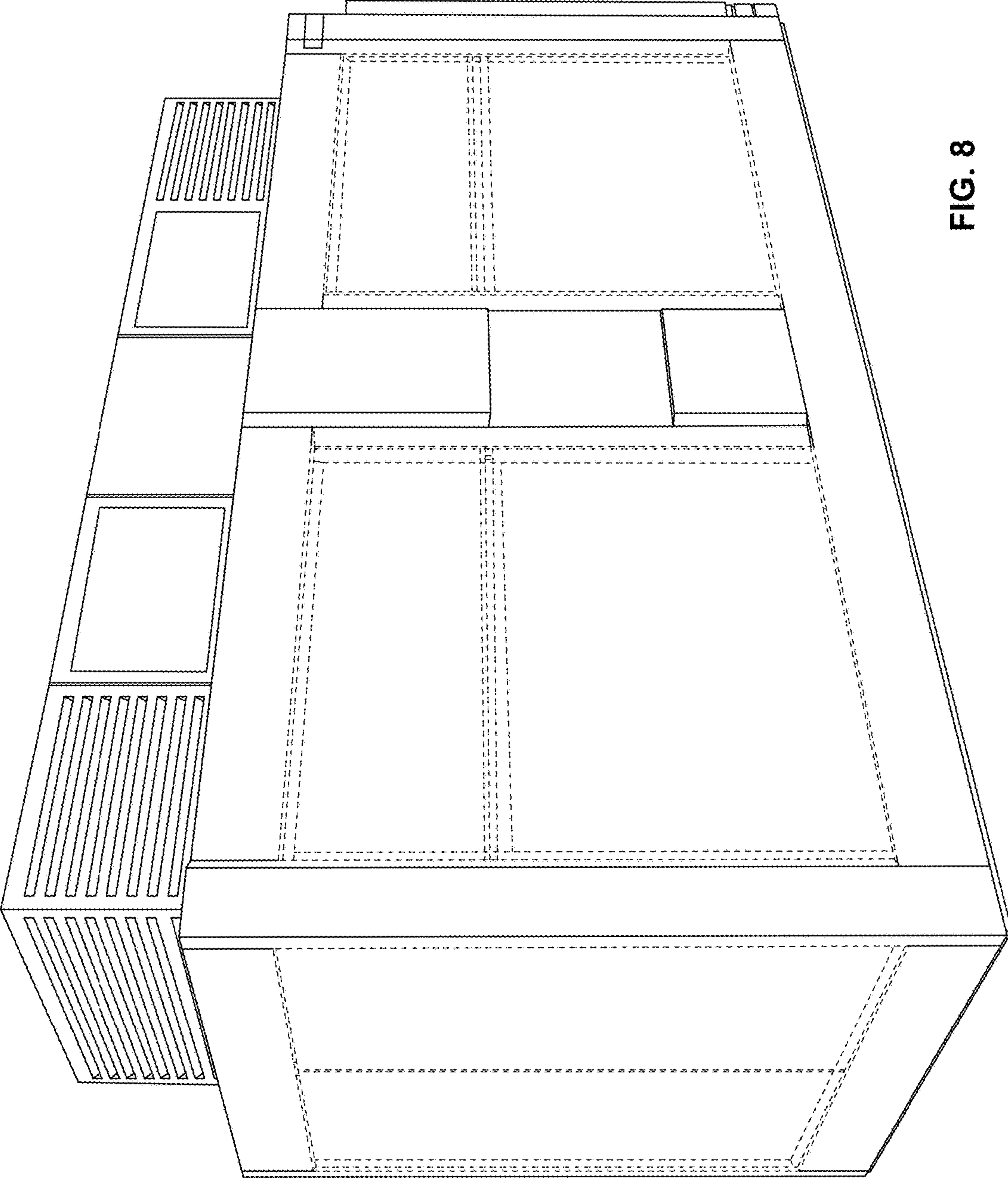

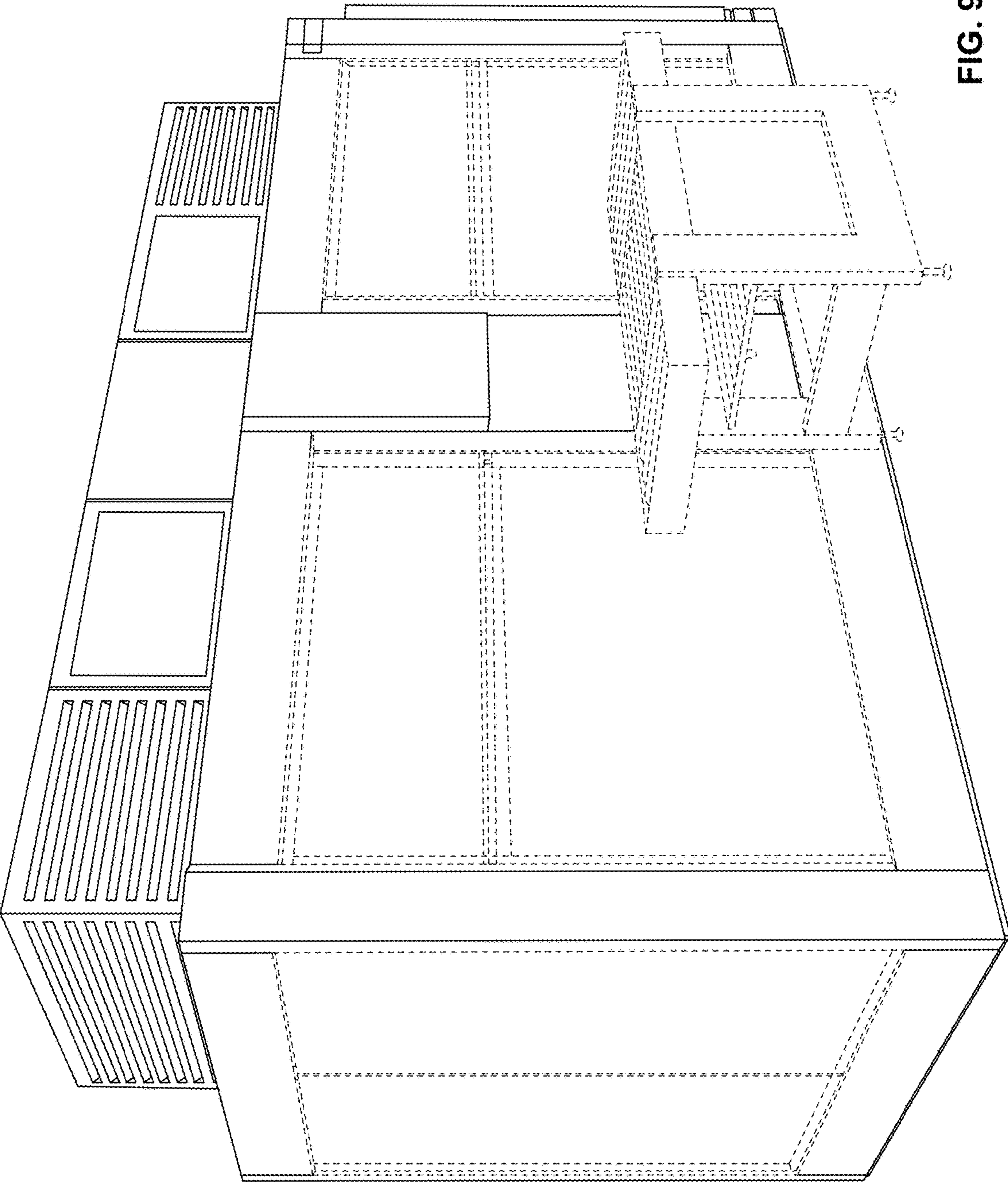

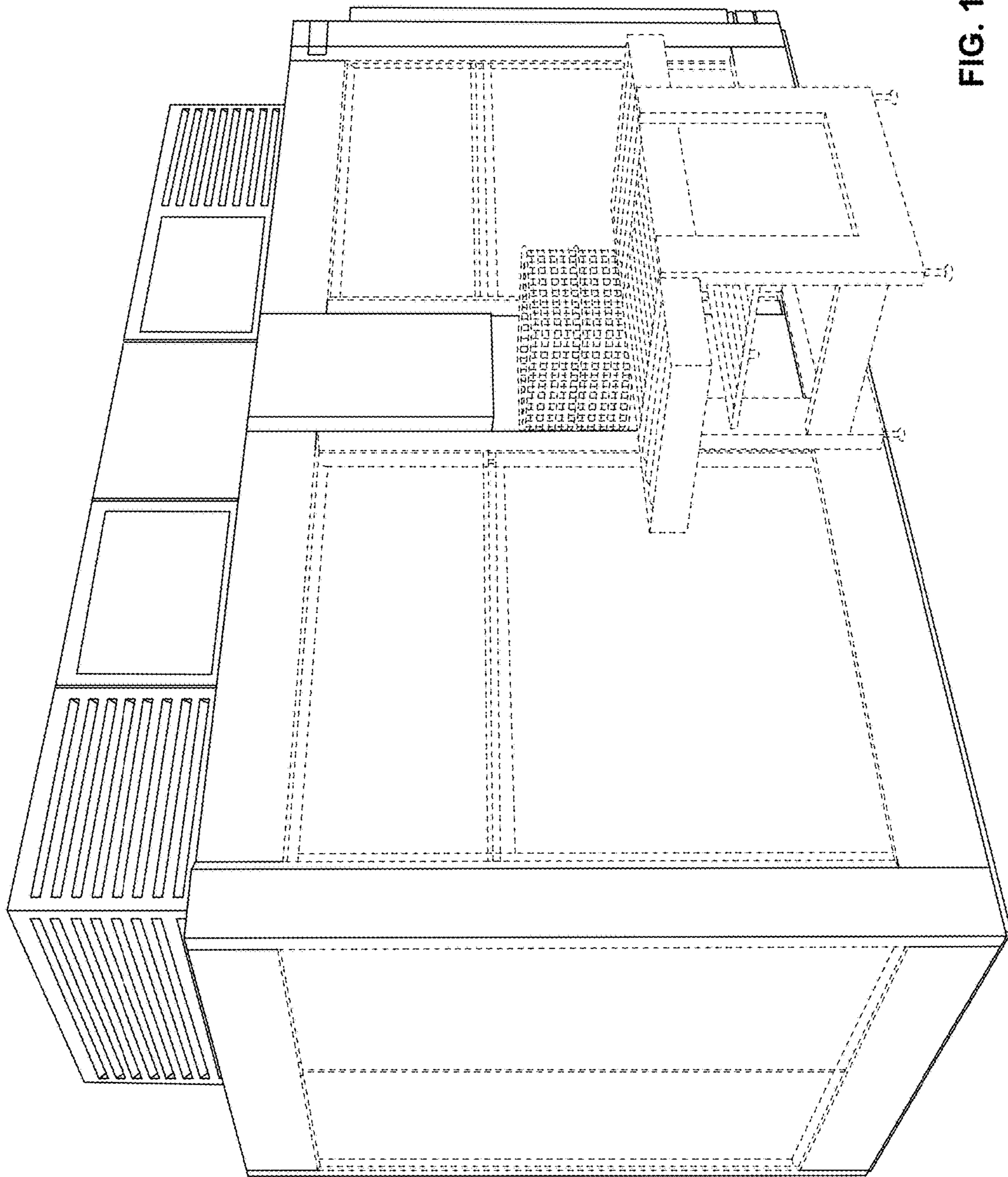

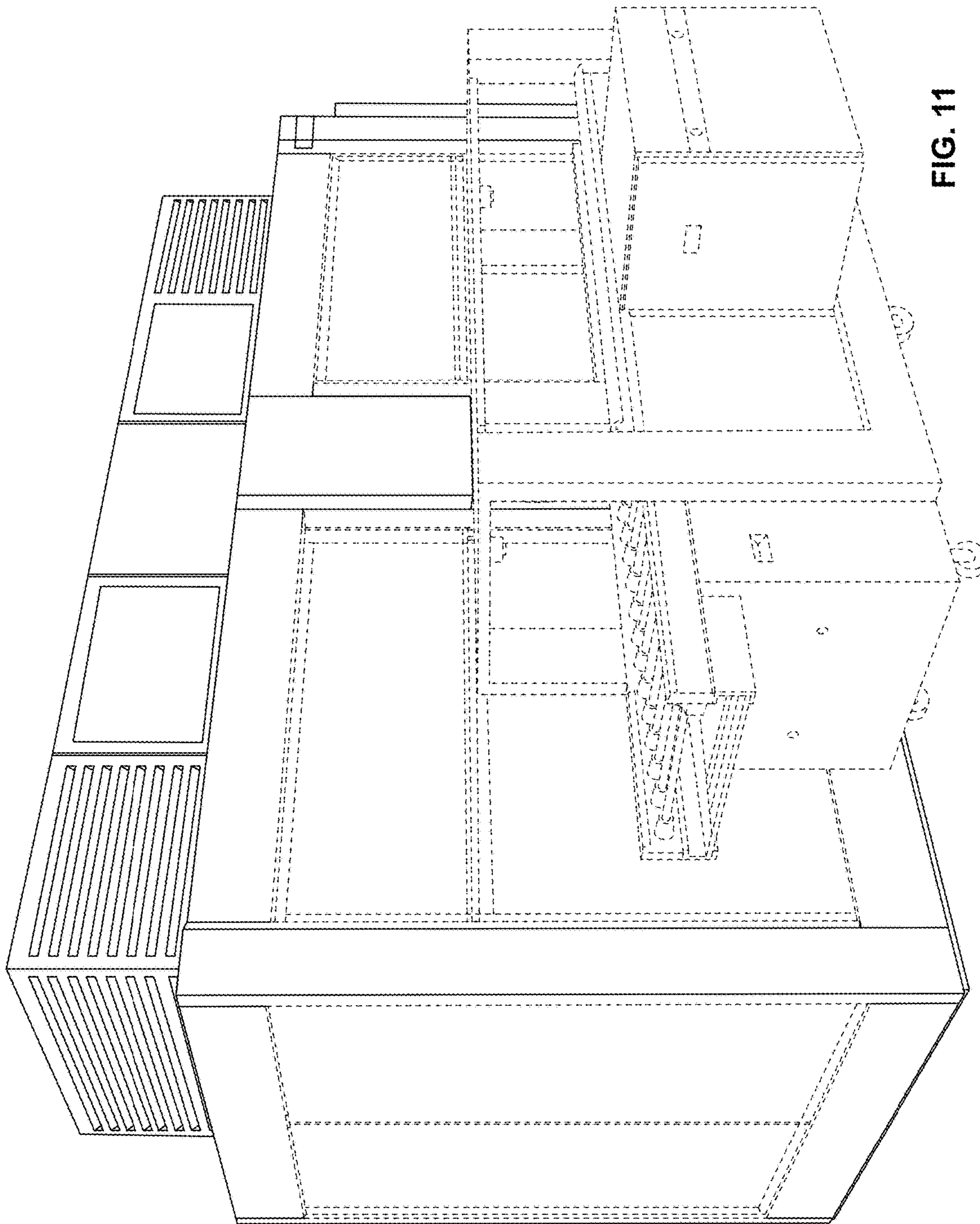

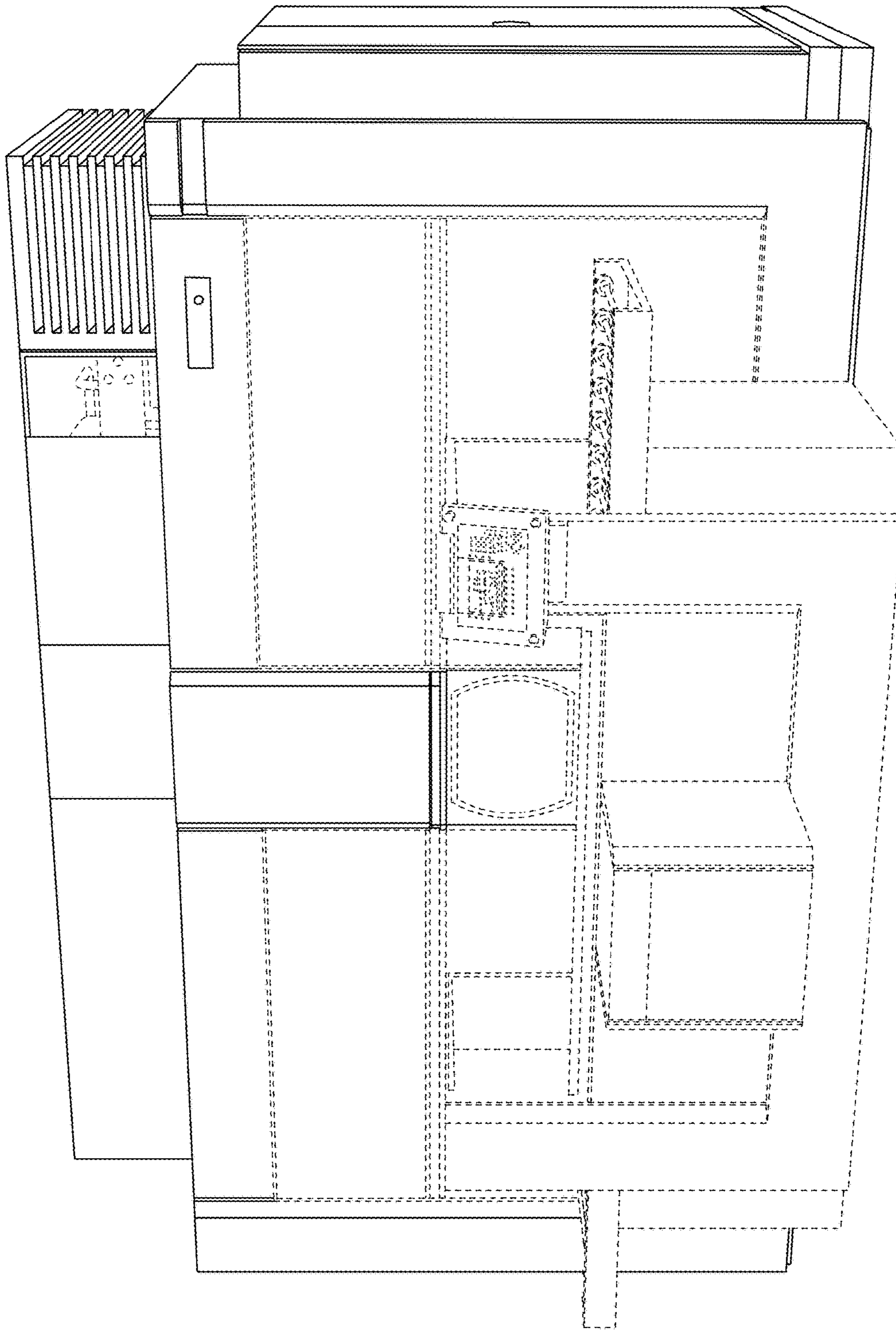

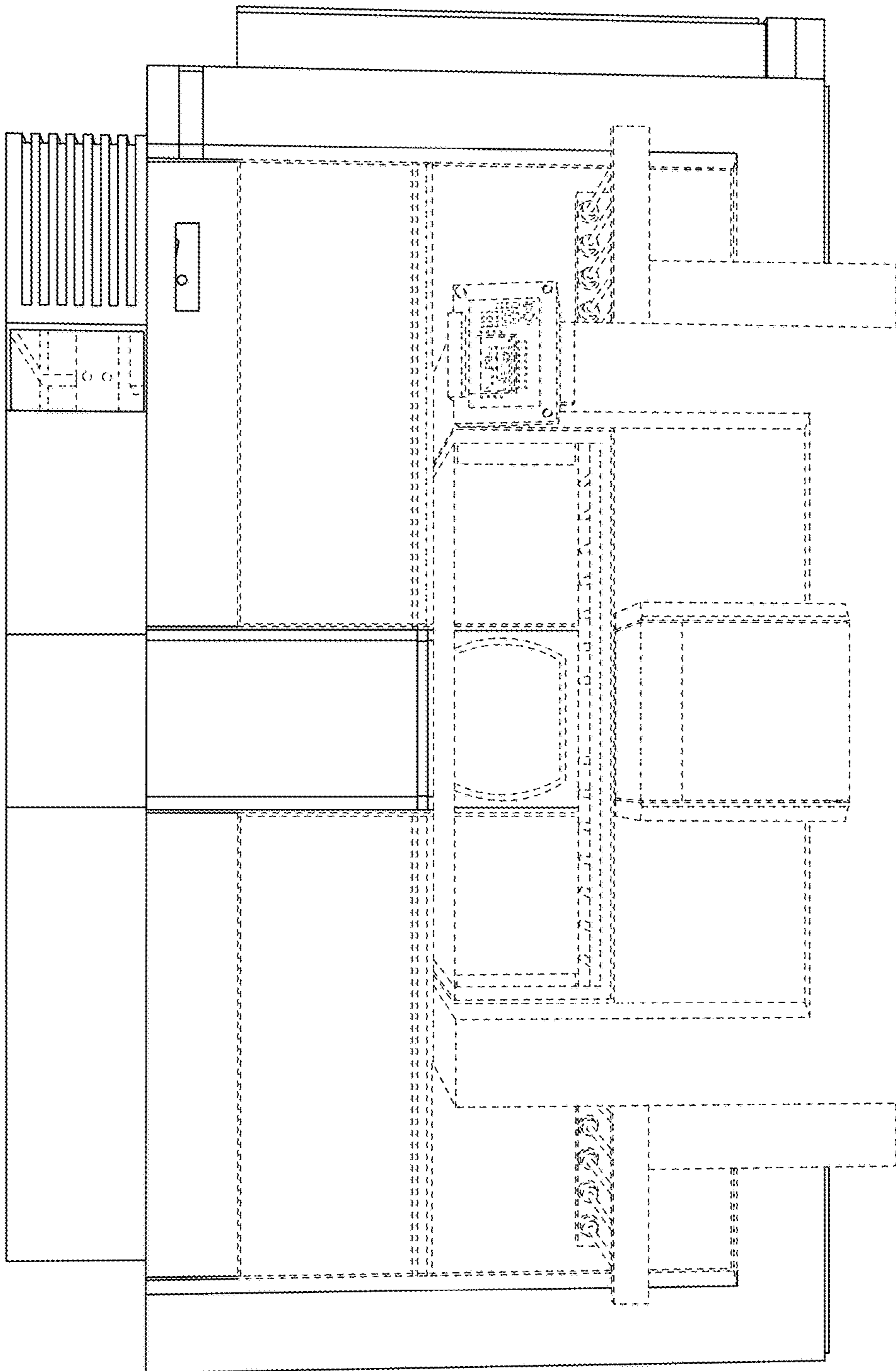

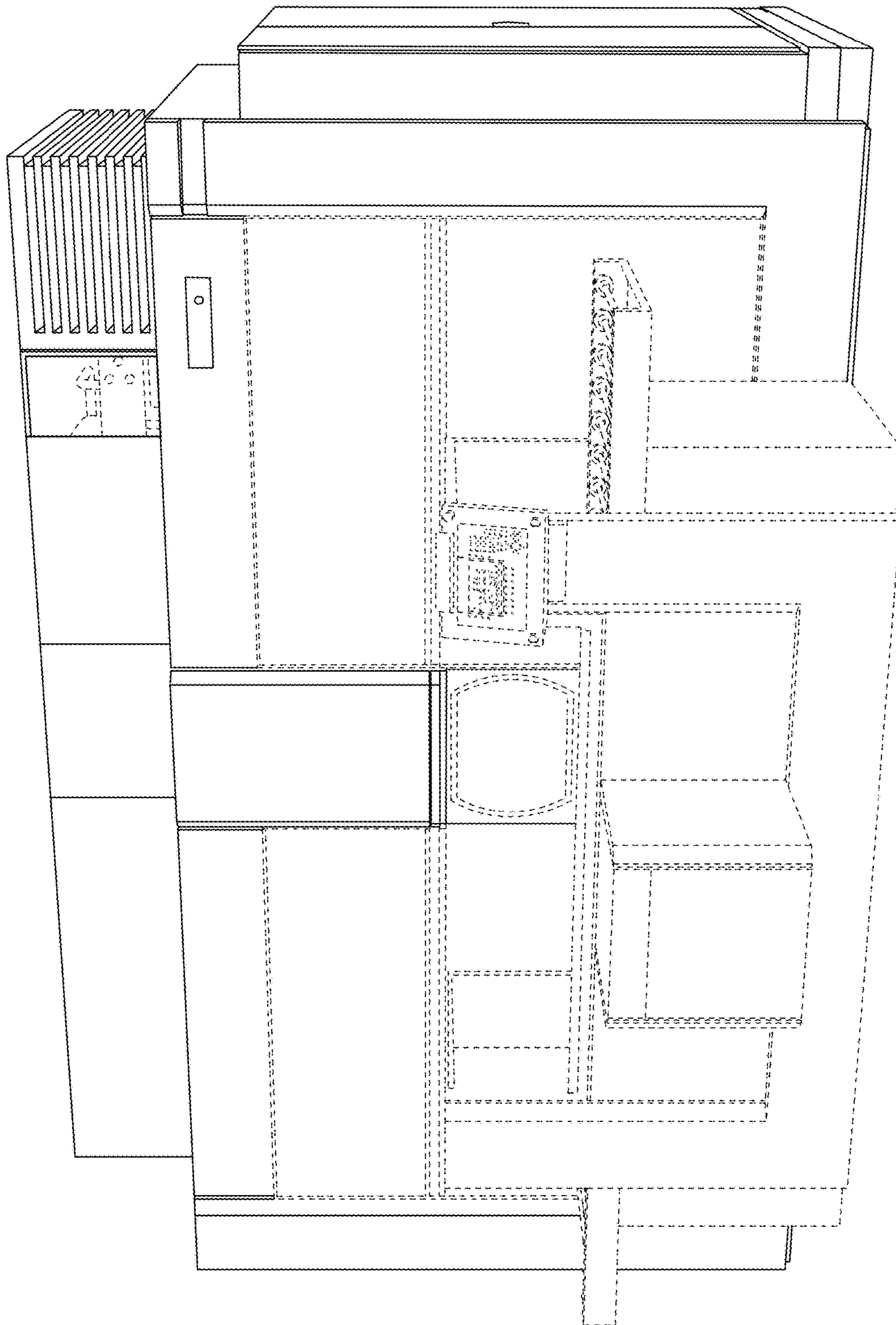

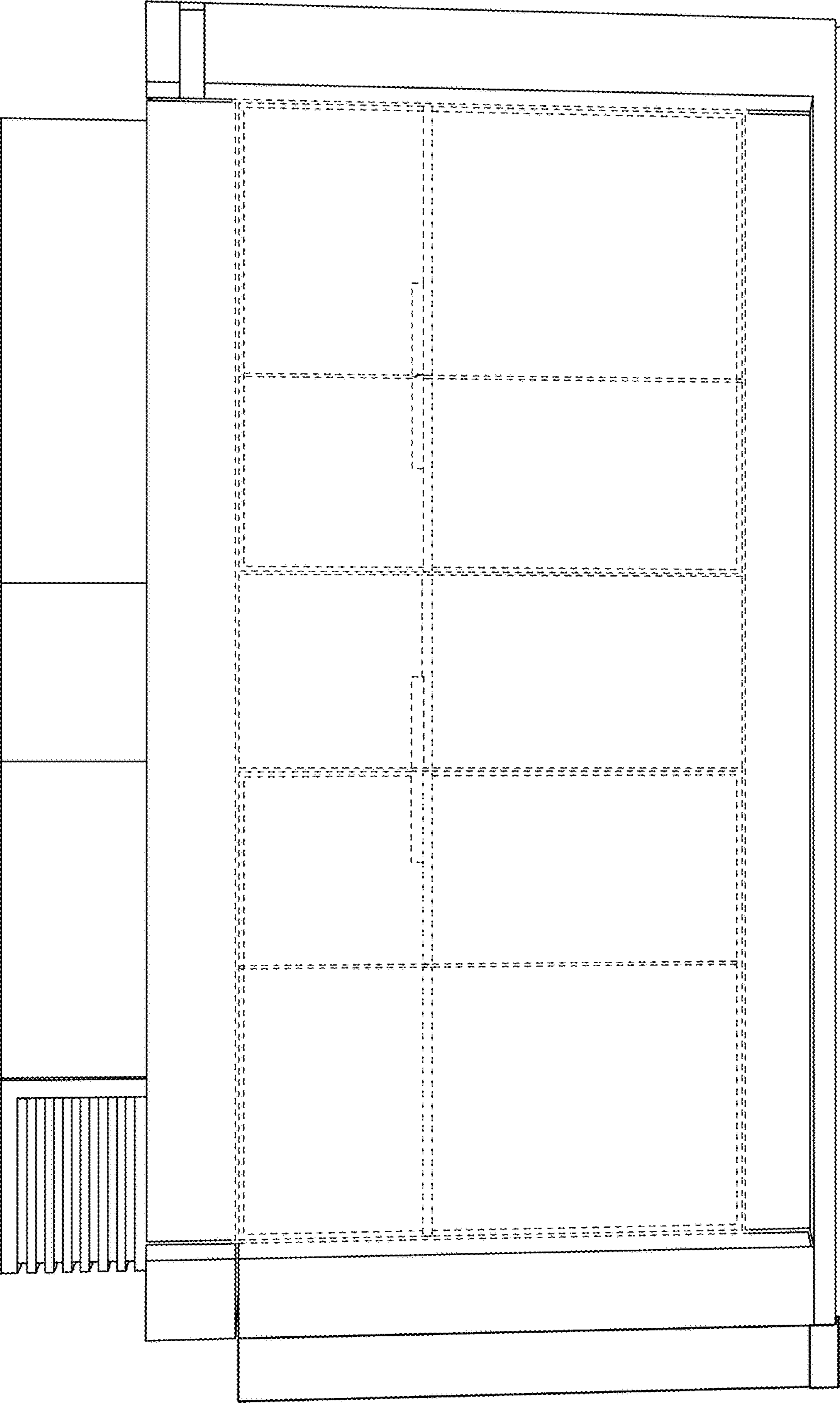

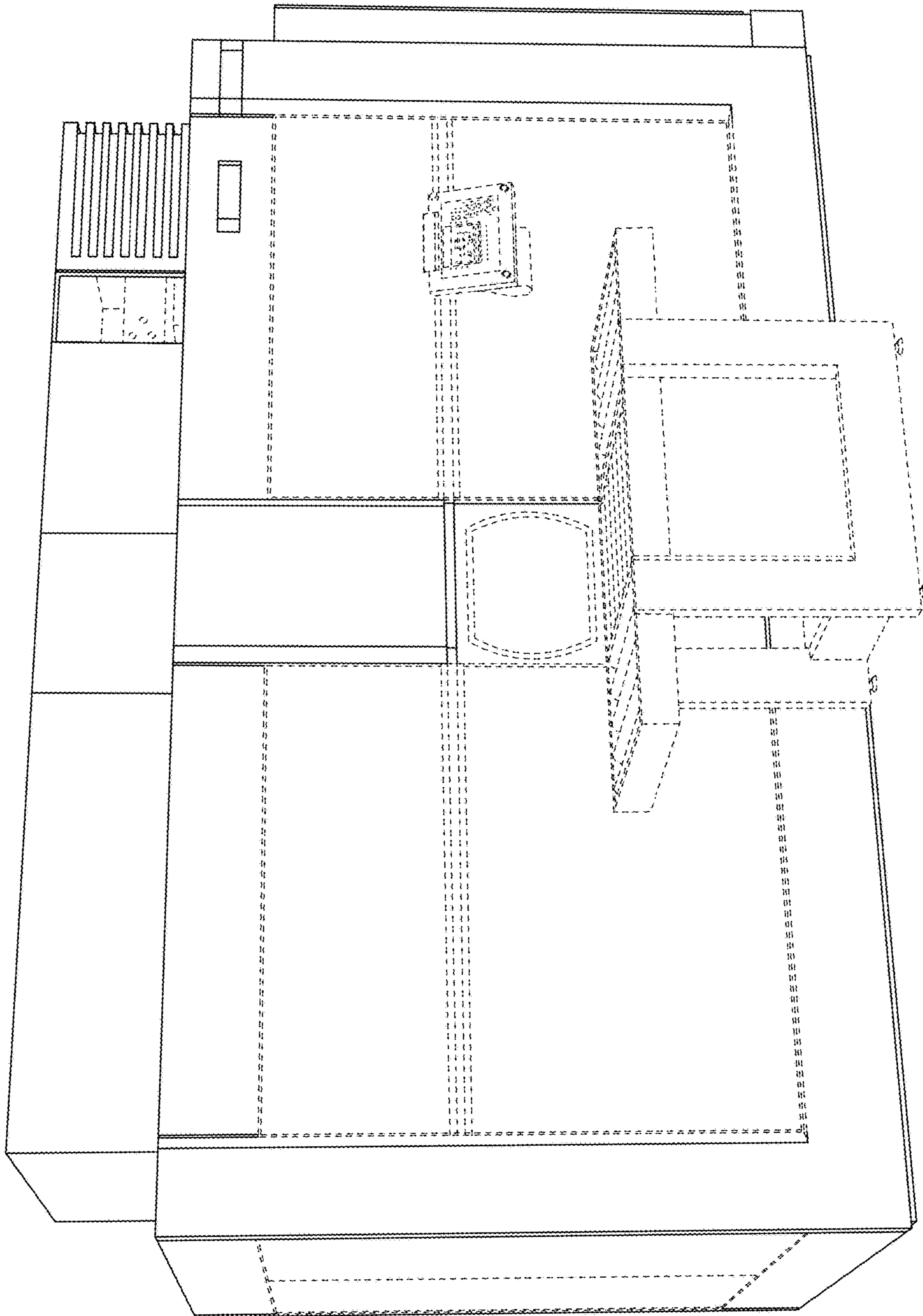

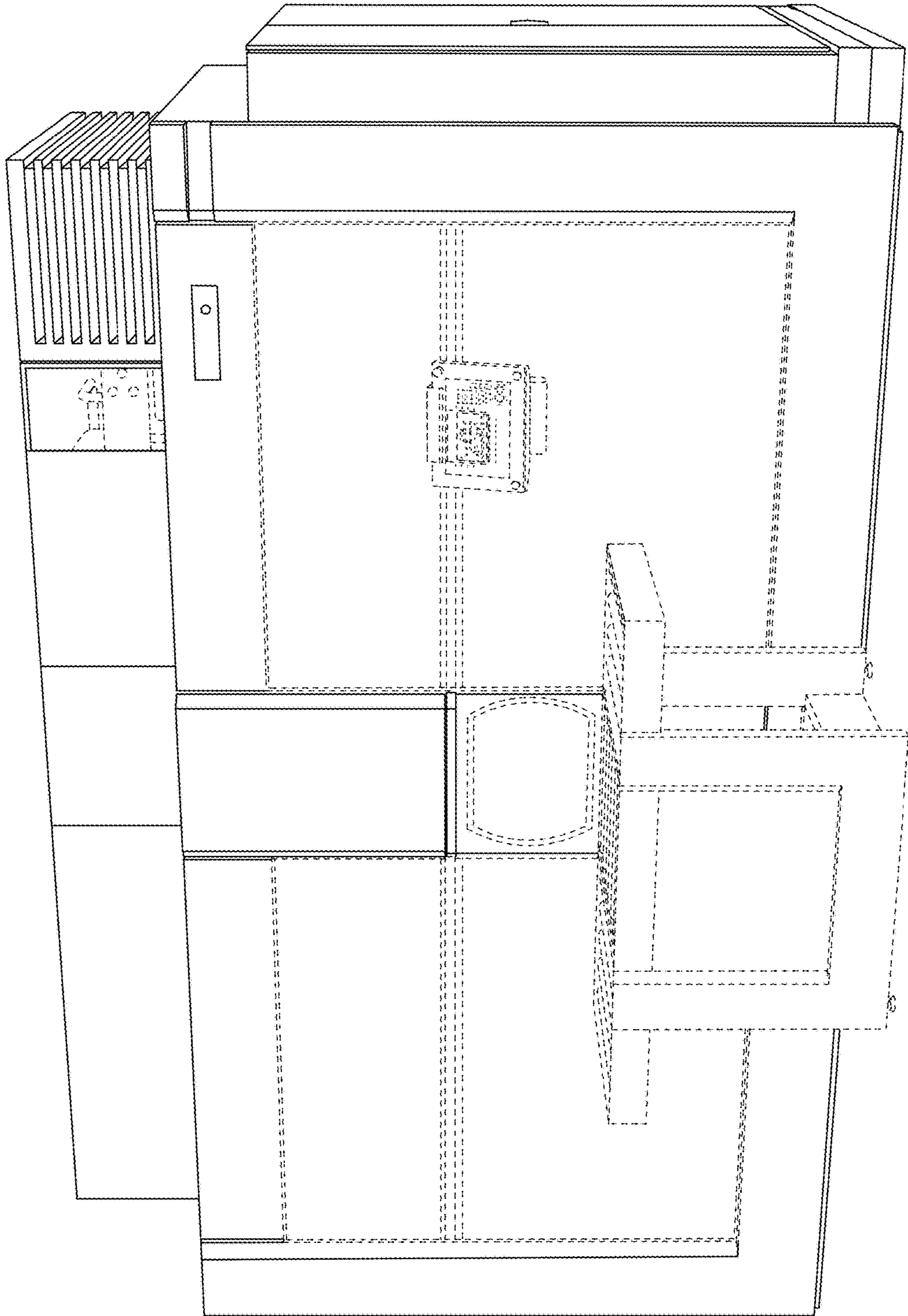

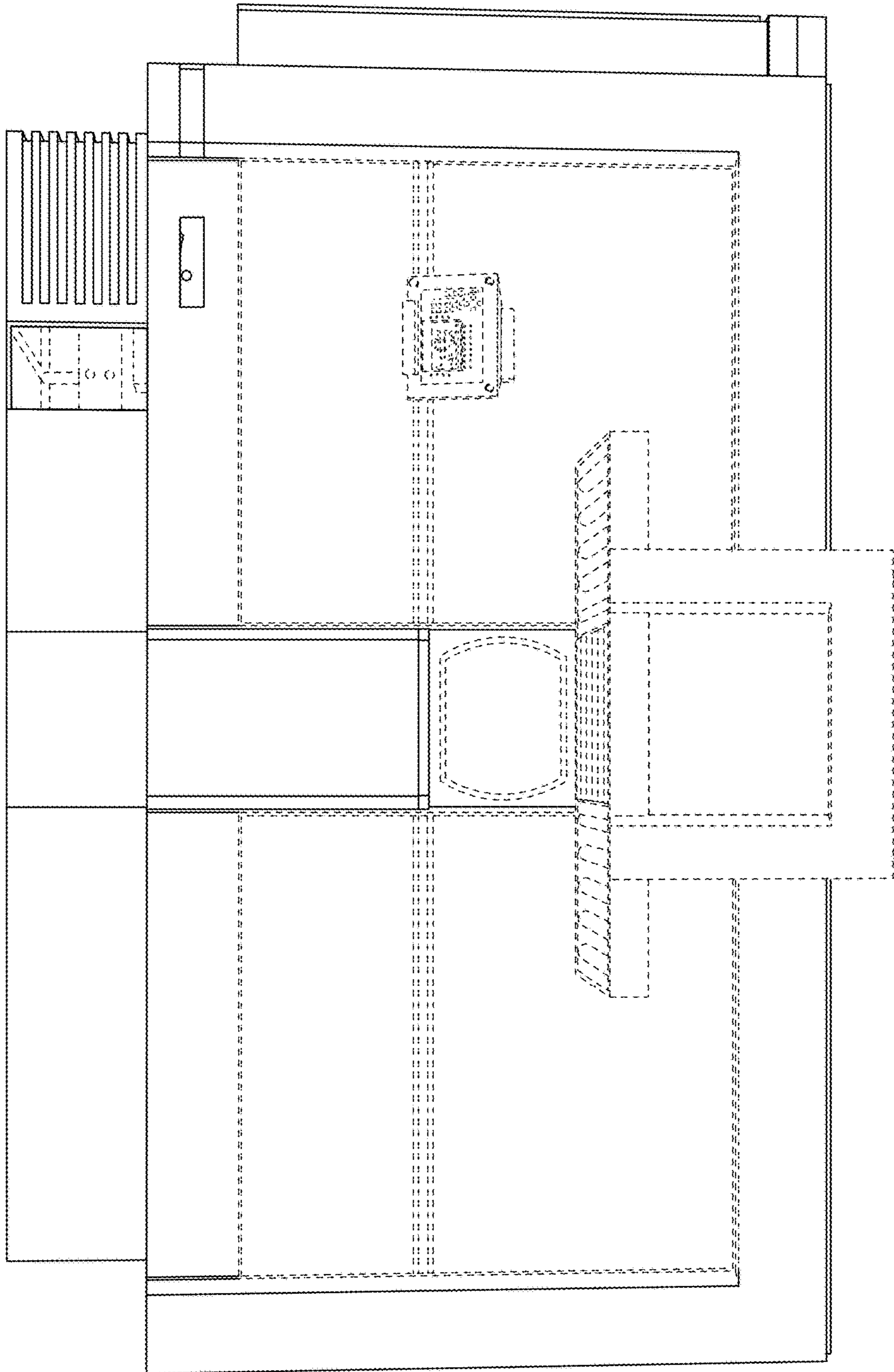

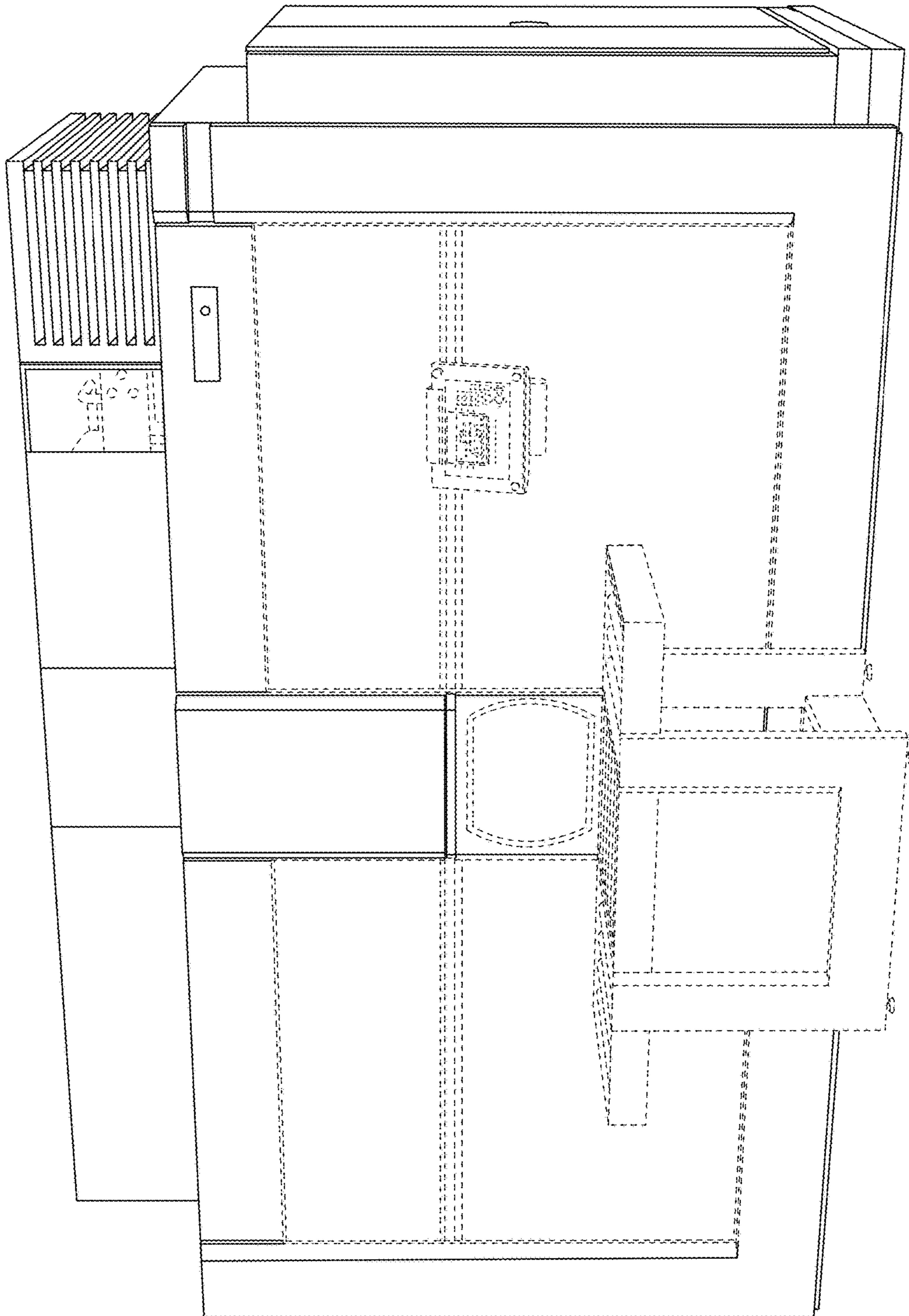

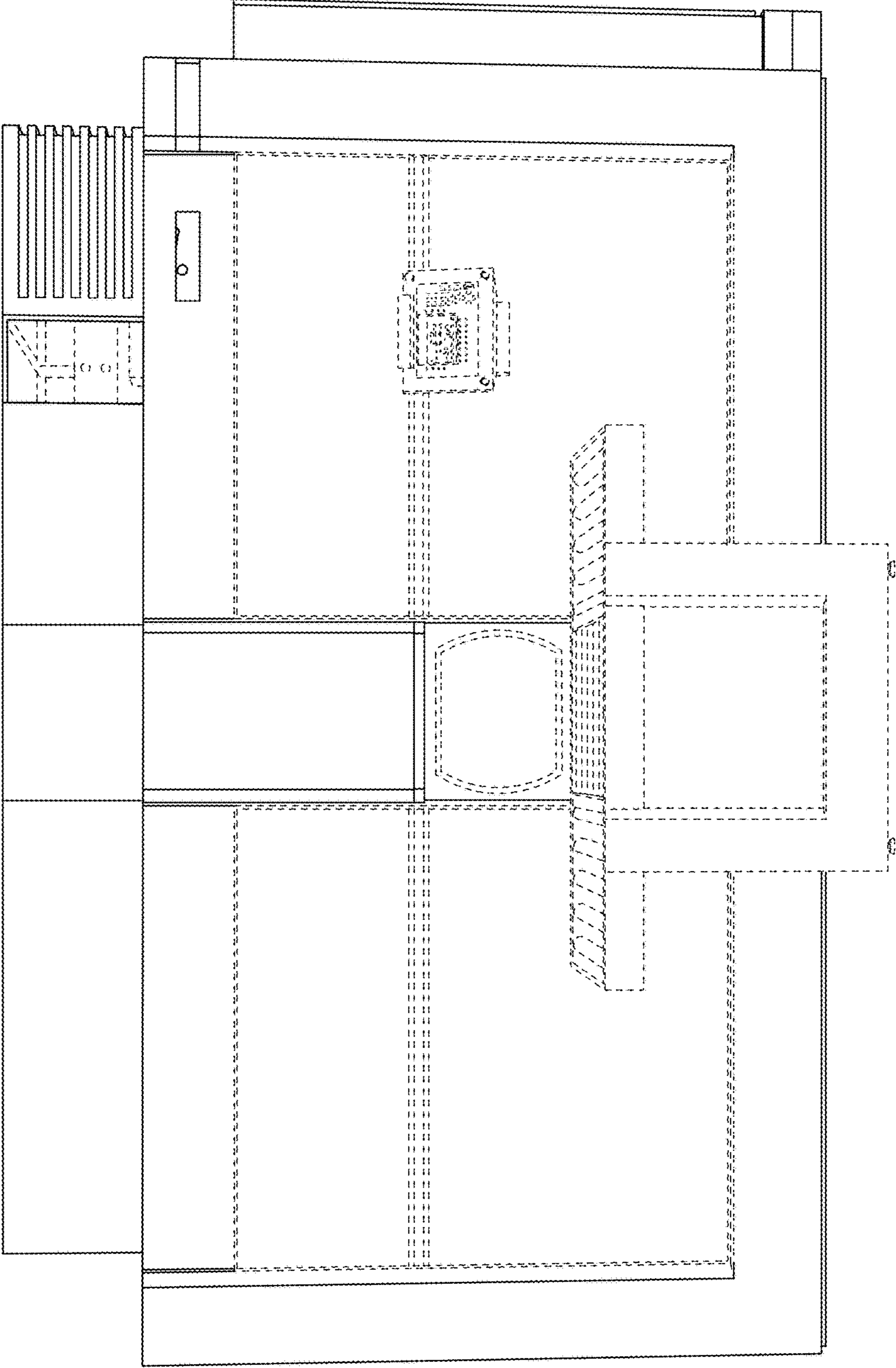

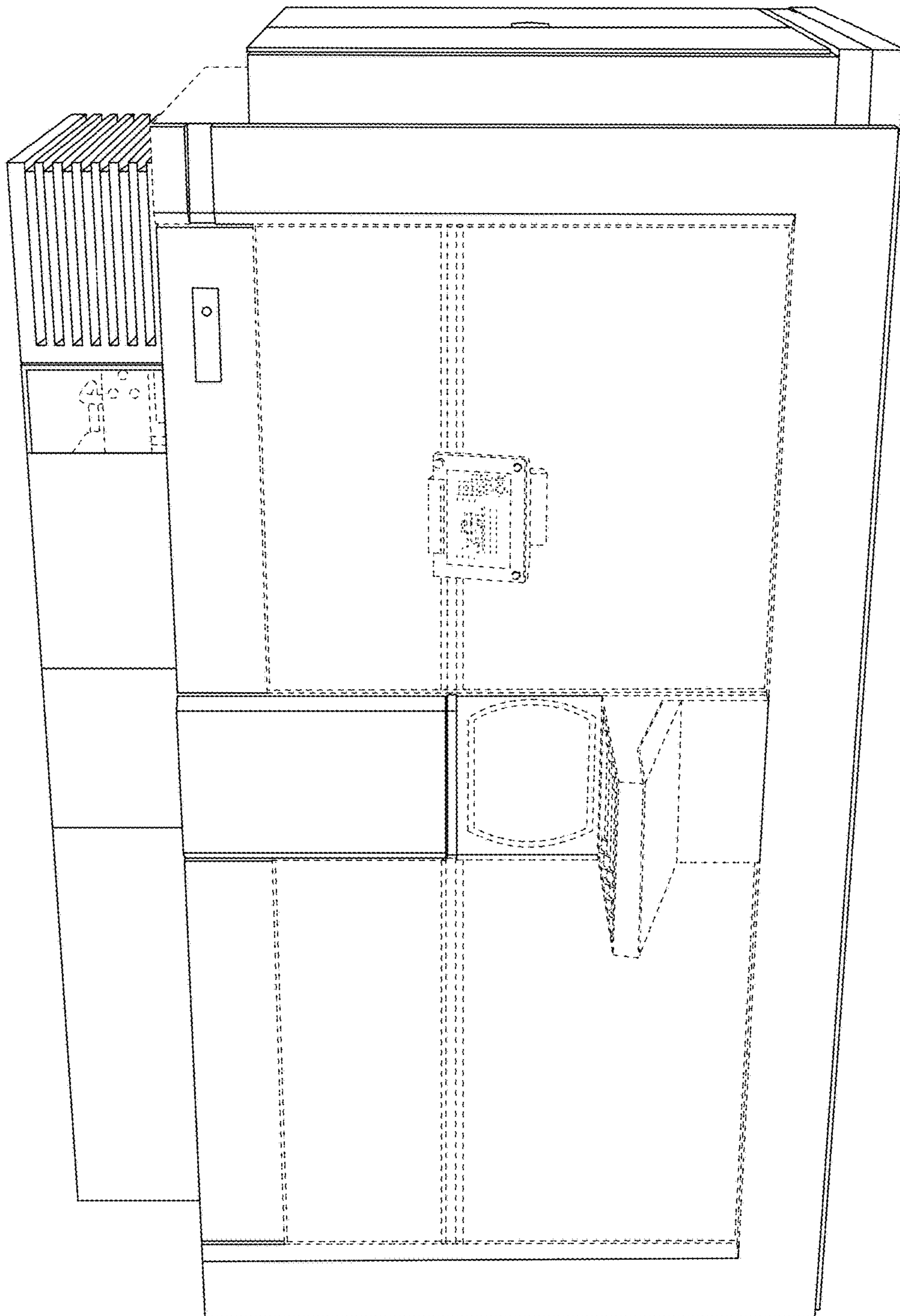

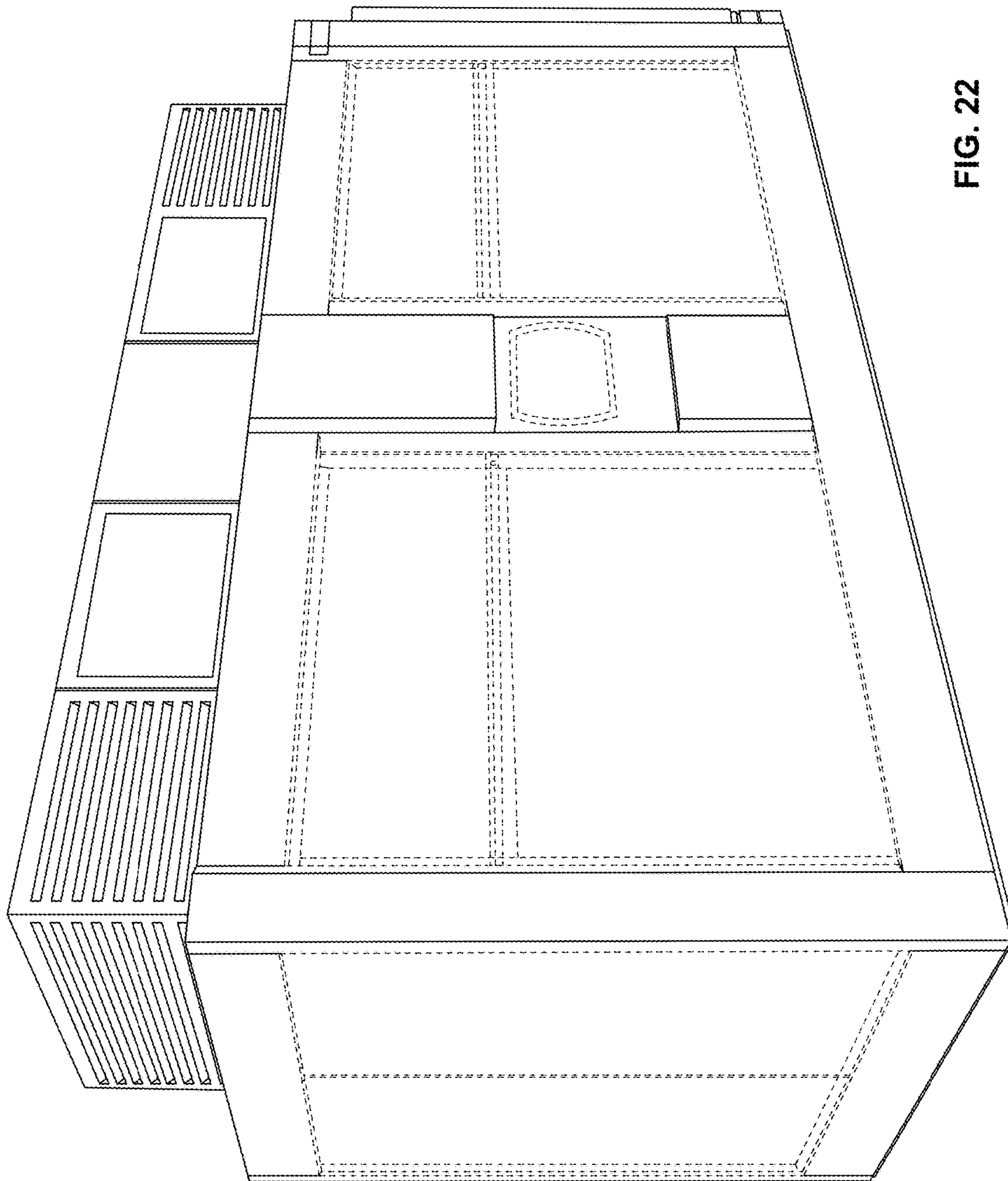
