(57) **CLAIM**

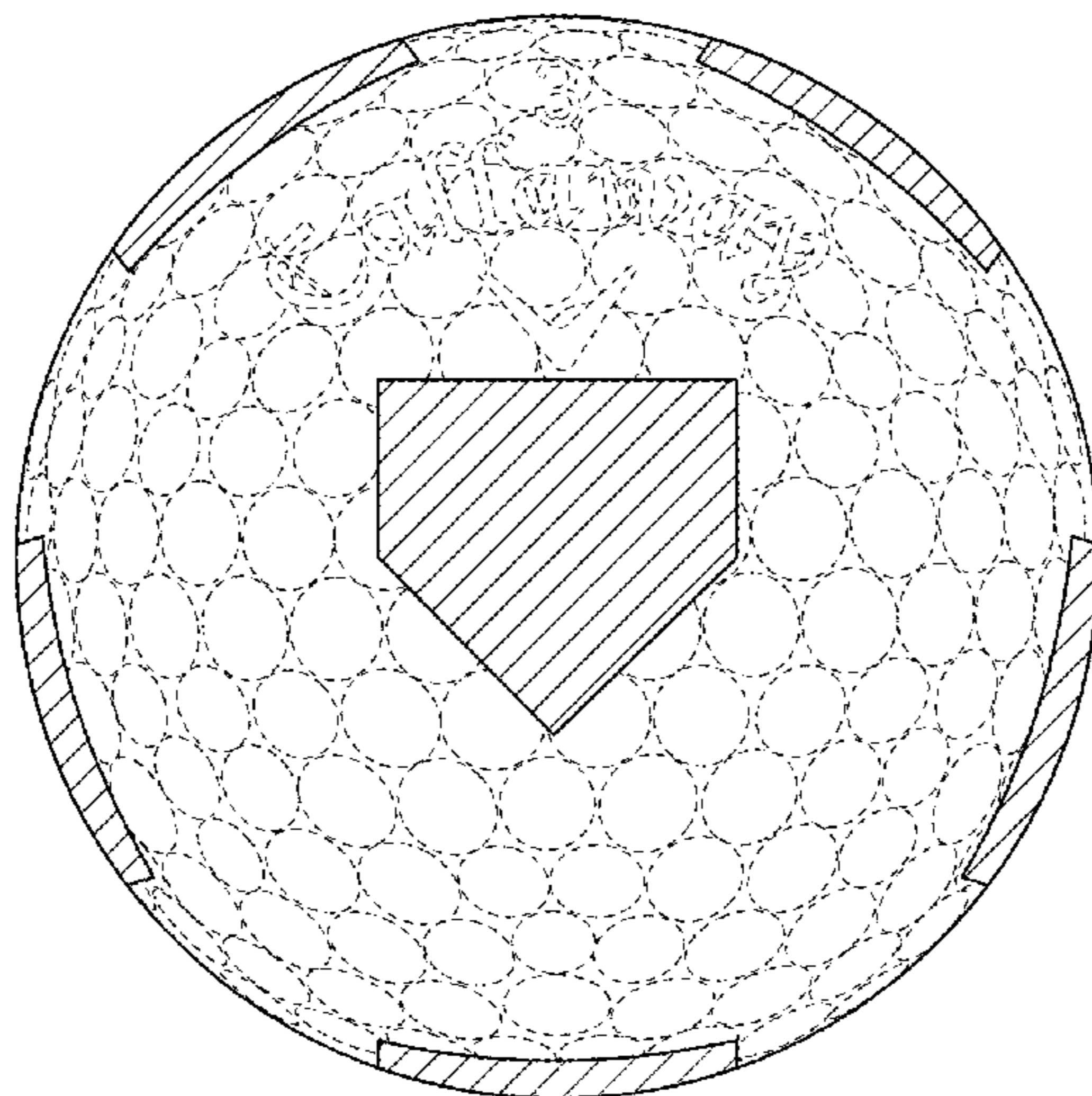
The ornamental design for a golf ball, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view showing our new design for a golf ball;
FIG. 2 is bottom plan view of FIG. 1;
FIG. 3 is a front elevation view of FIG. 1;
FIG. 4 is a rear elevation view of FIG. 1; and,
FIG. 5 is a side elevation view of FIG. 1.
The broken lines within the home-plate-shaped features and the spaces contained within these broken lines depict portions of the golf ball that form no part of the claimed design. All other broken lines depict portions of the golf ball that form no part of the claimed design.
The “Callaway V” logo, which forms no part of the claimed design, is a trademark of the Callaway Golf Company.

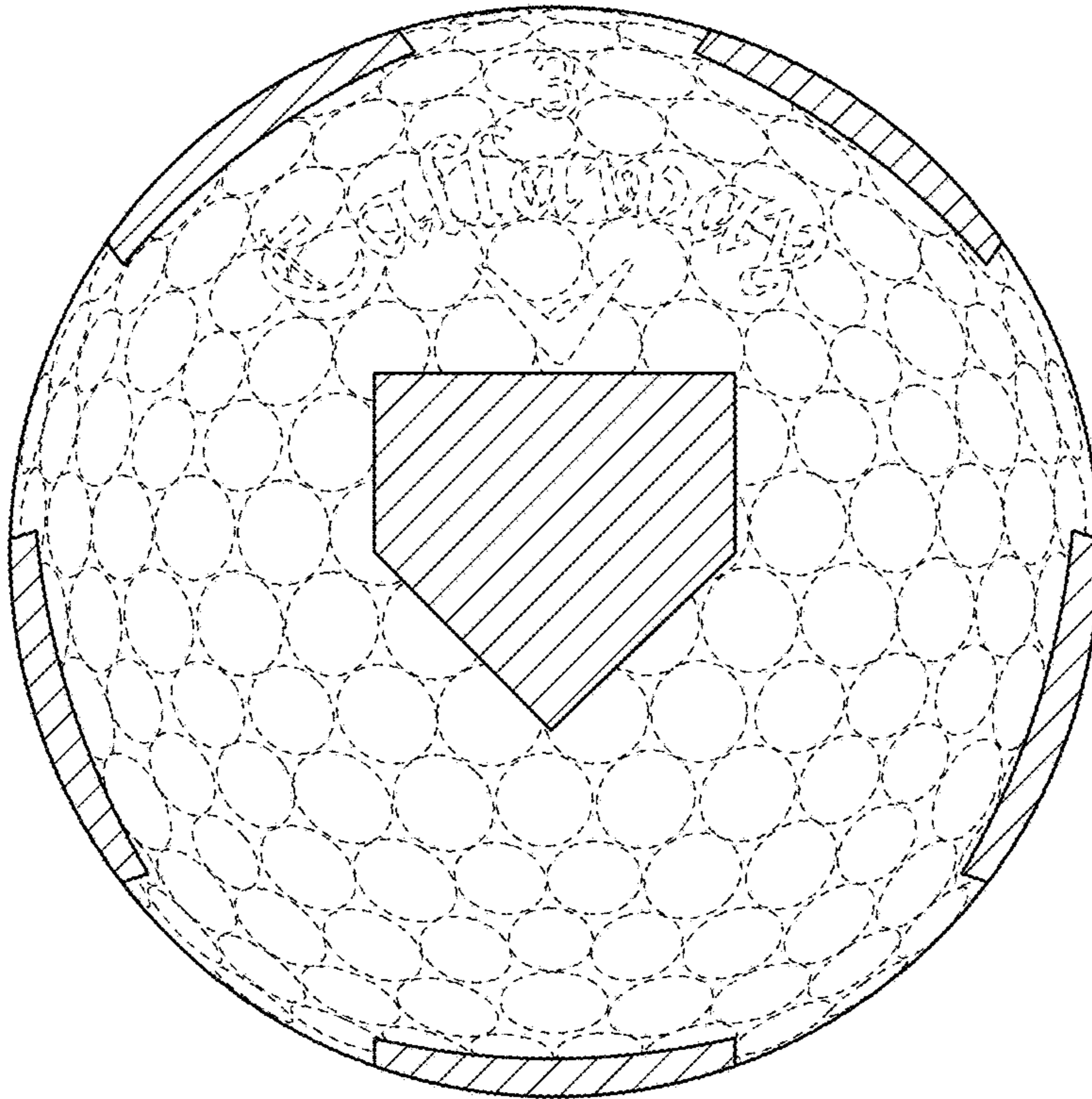

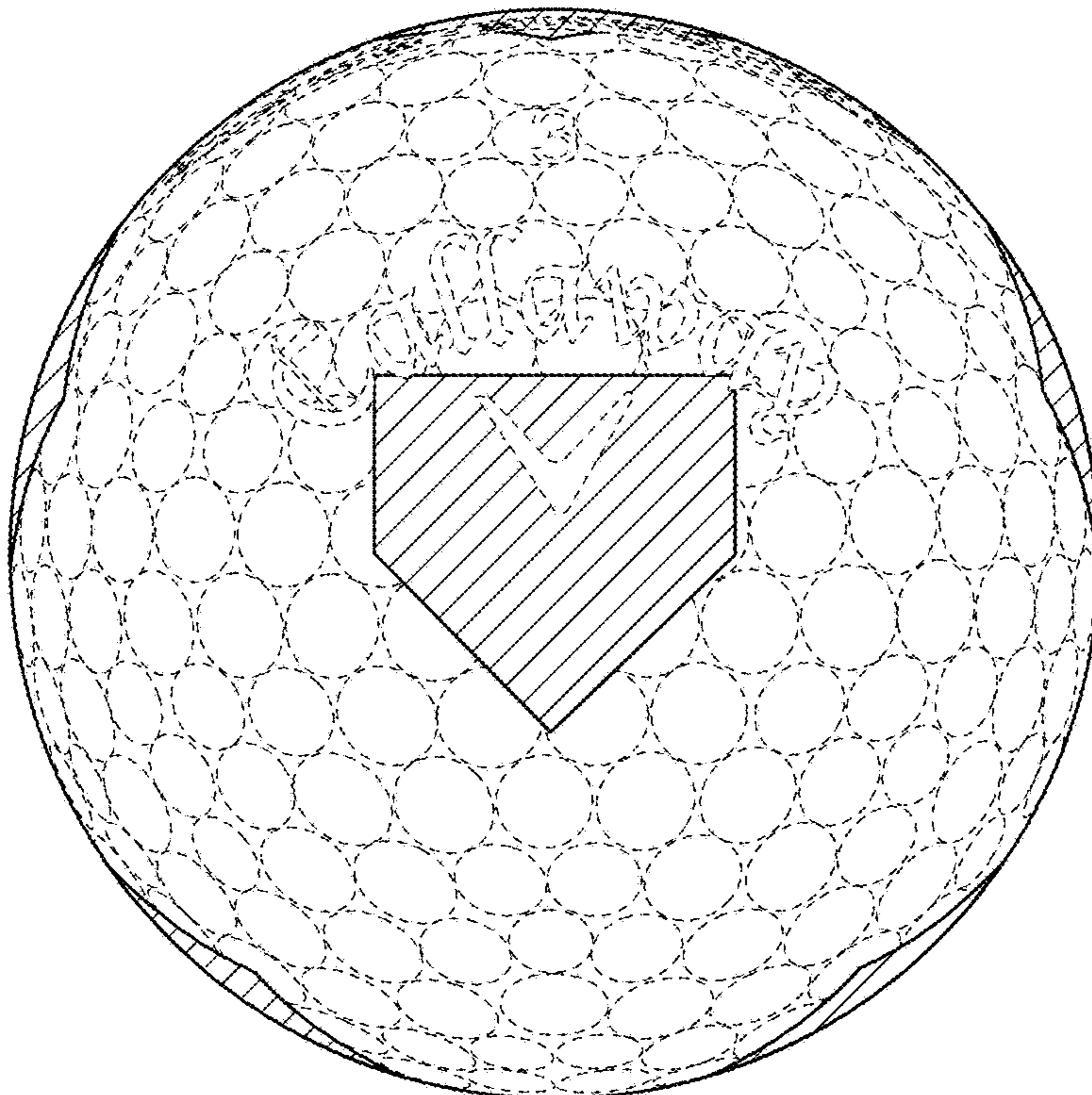

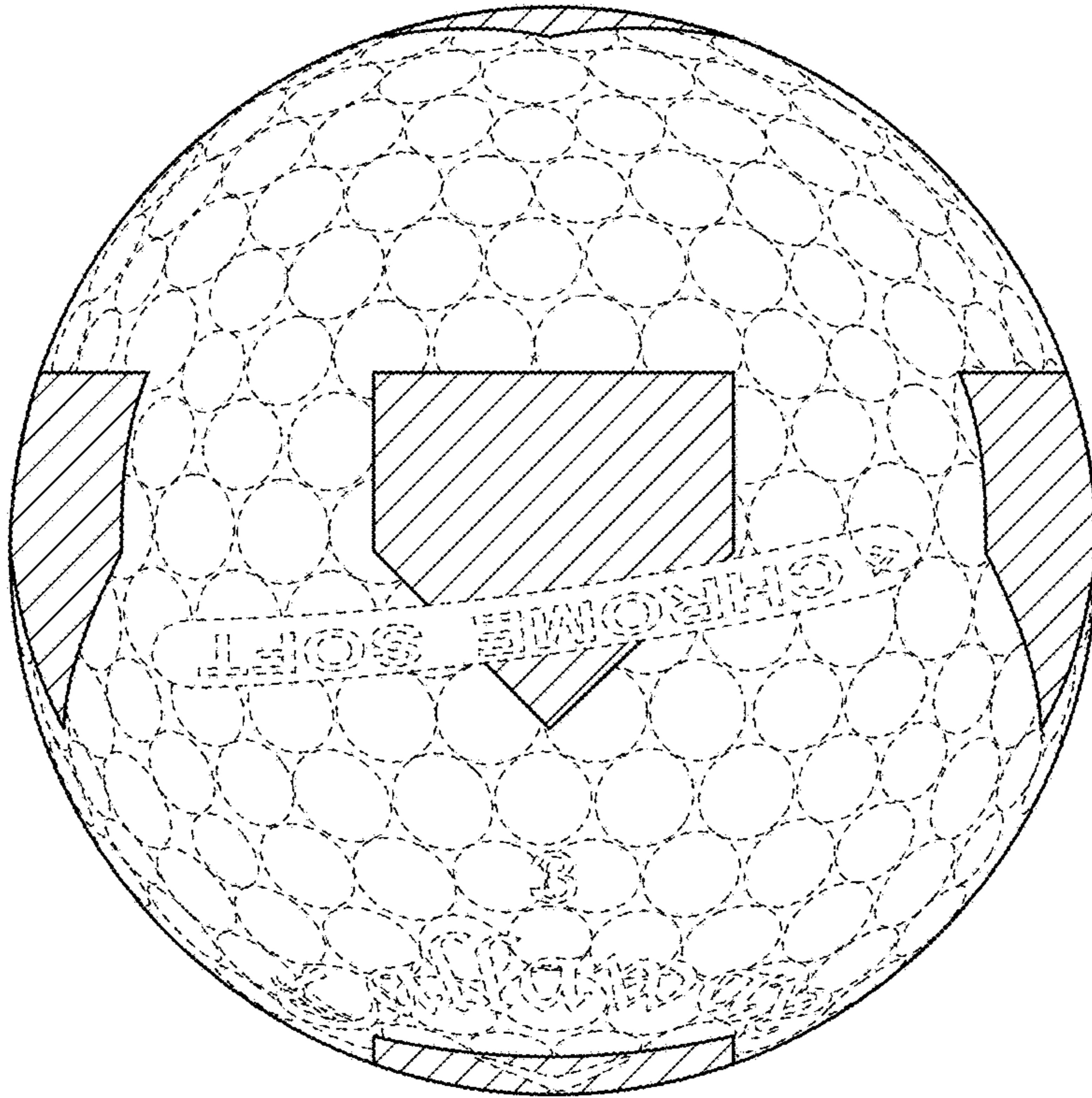

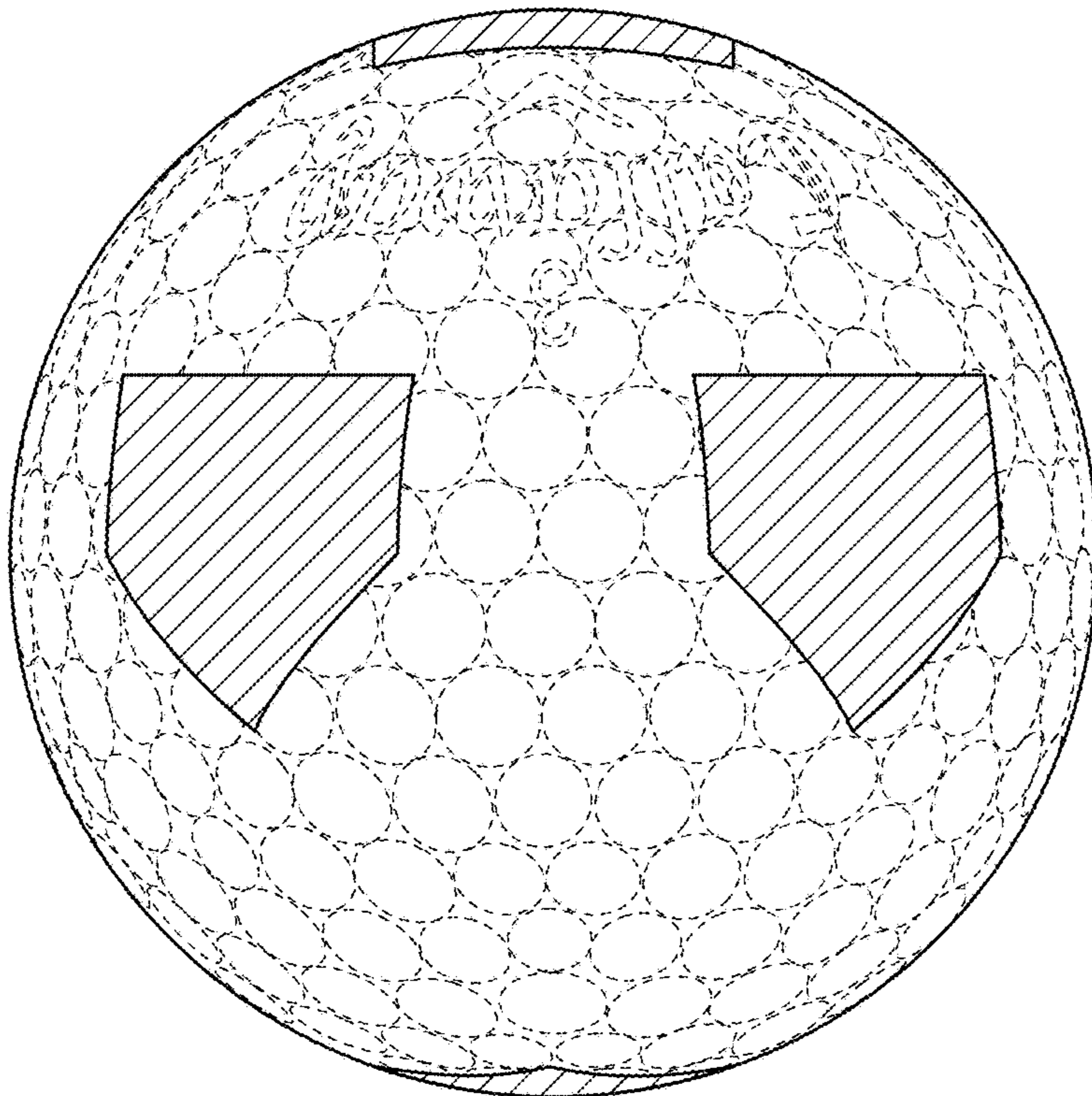

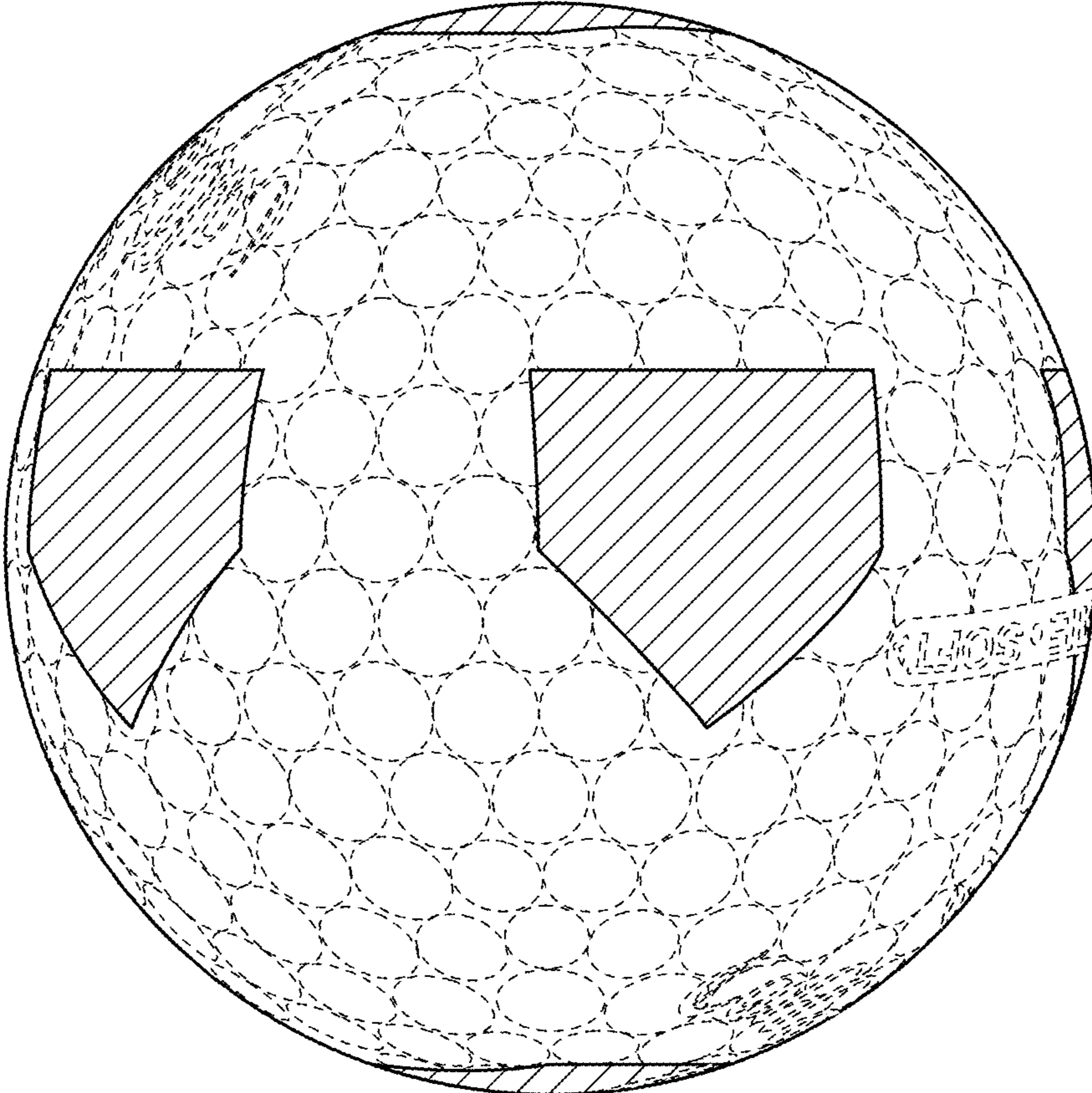
