The ornamental design for a body liner for anal leakage, as shown.

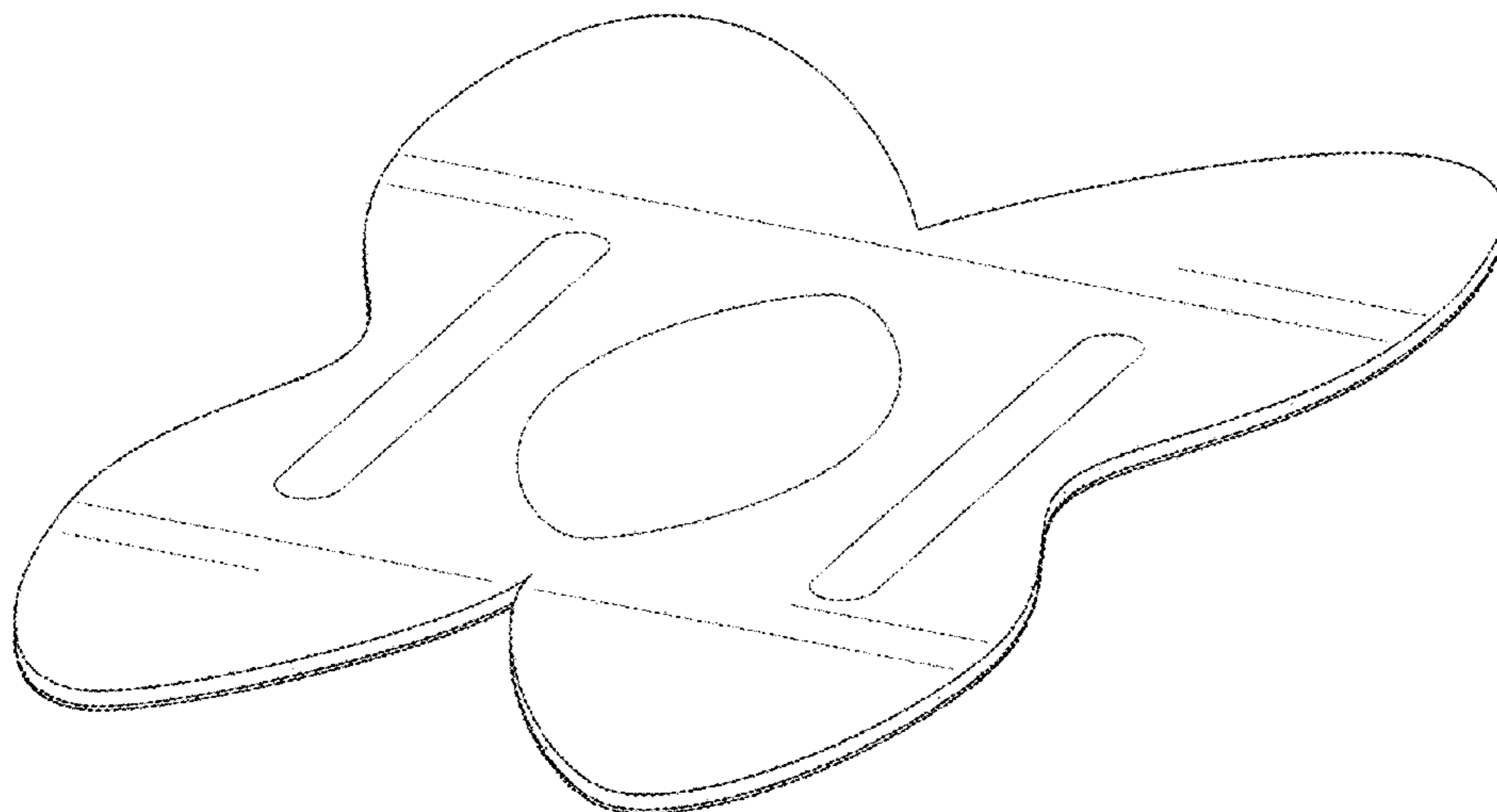
DESCRIPTION

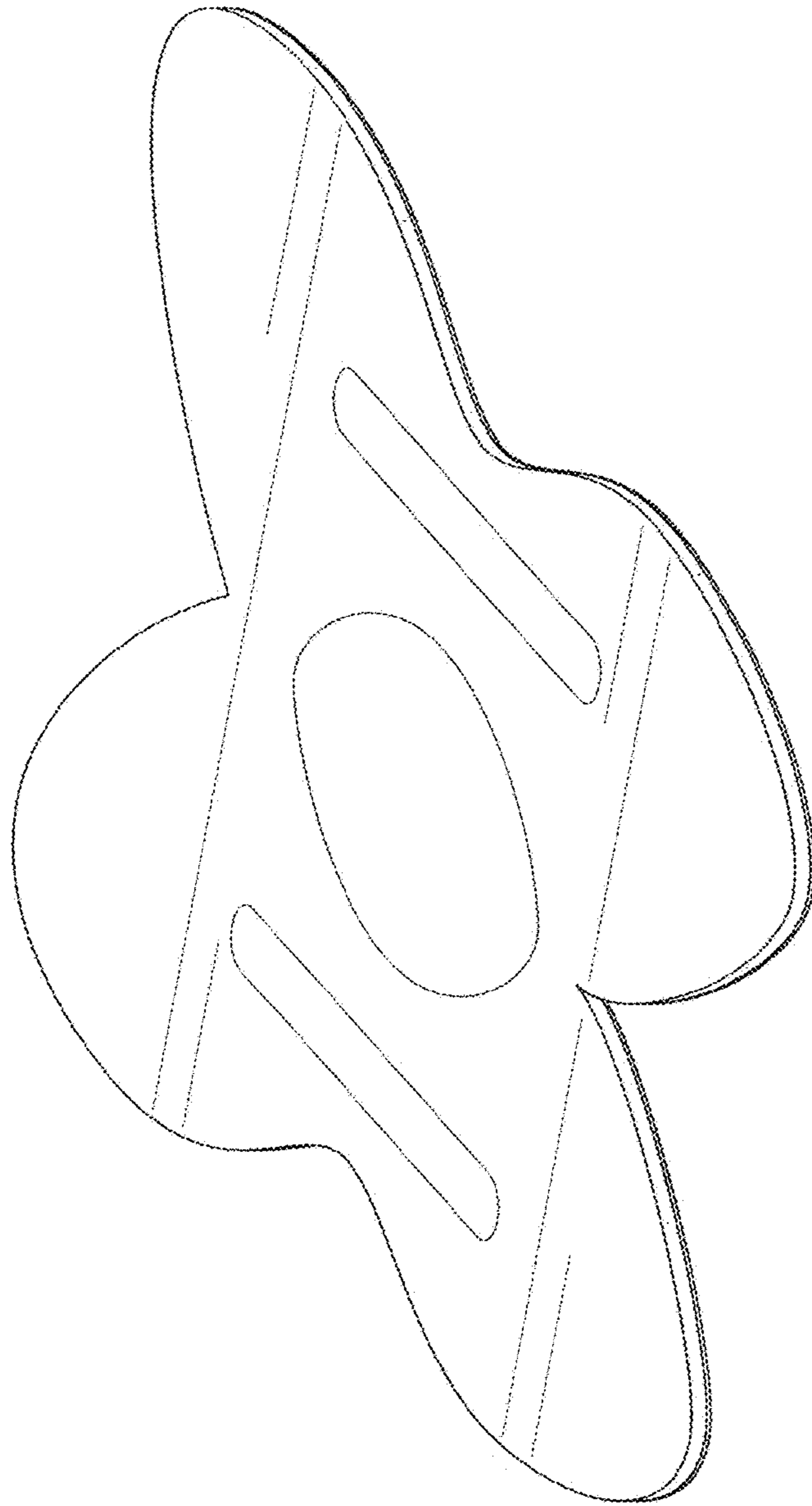

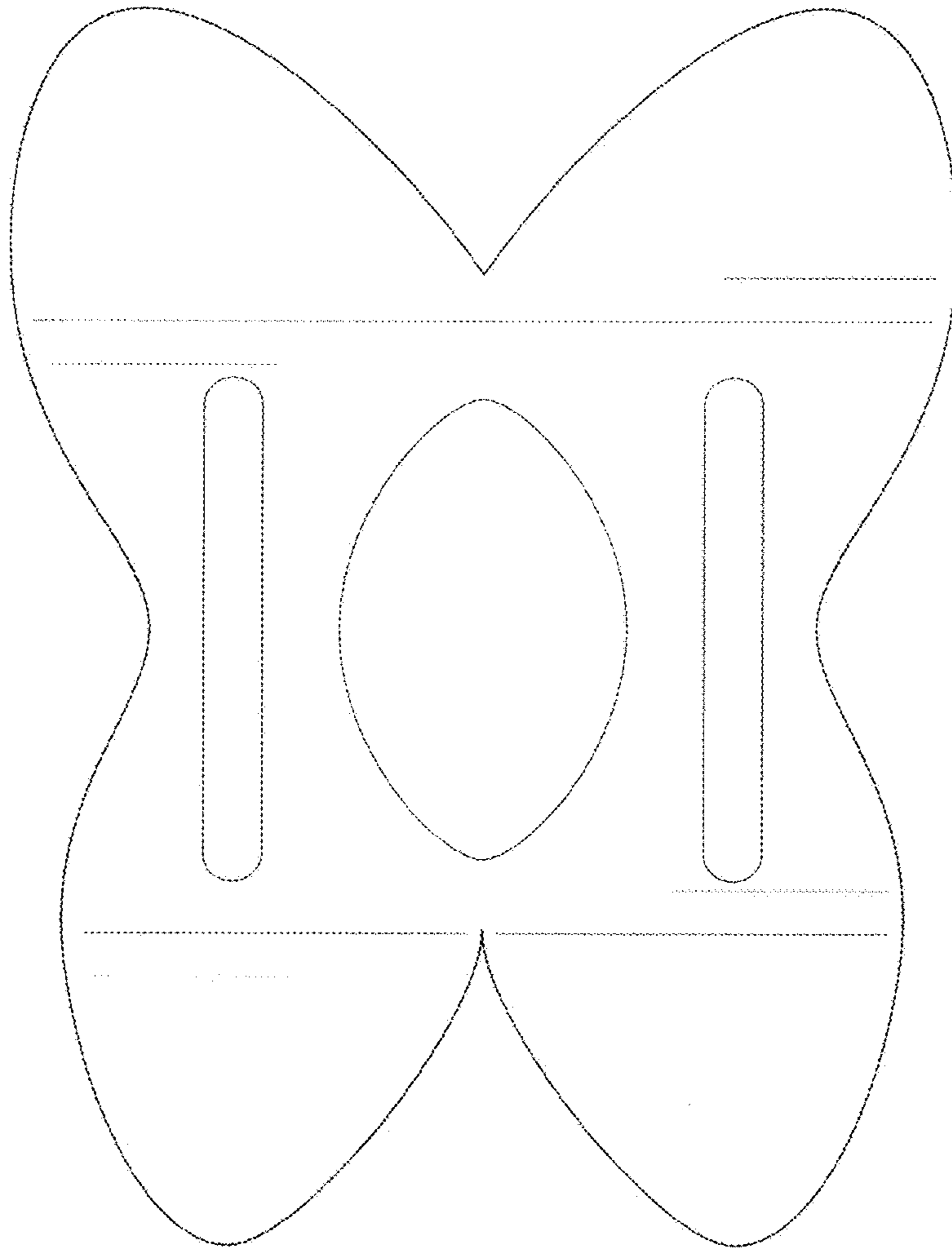

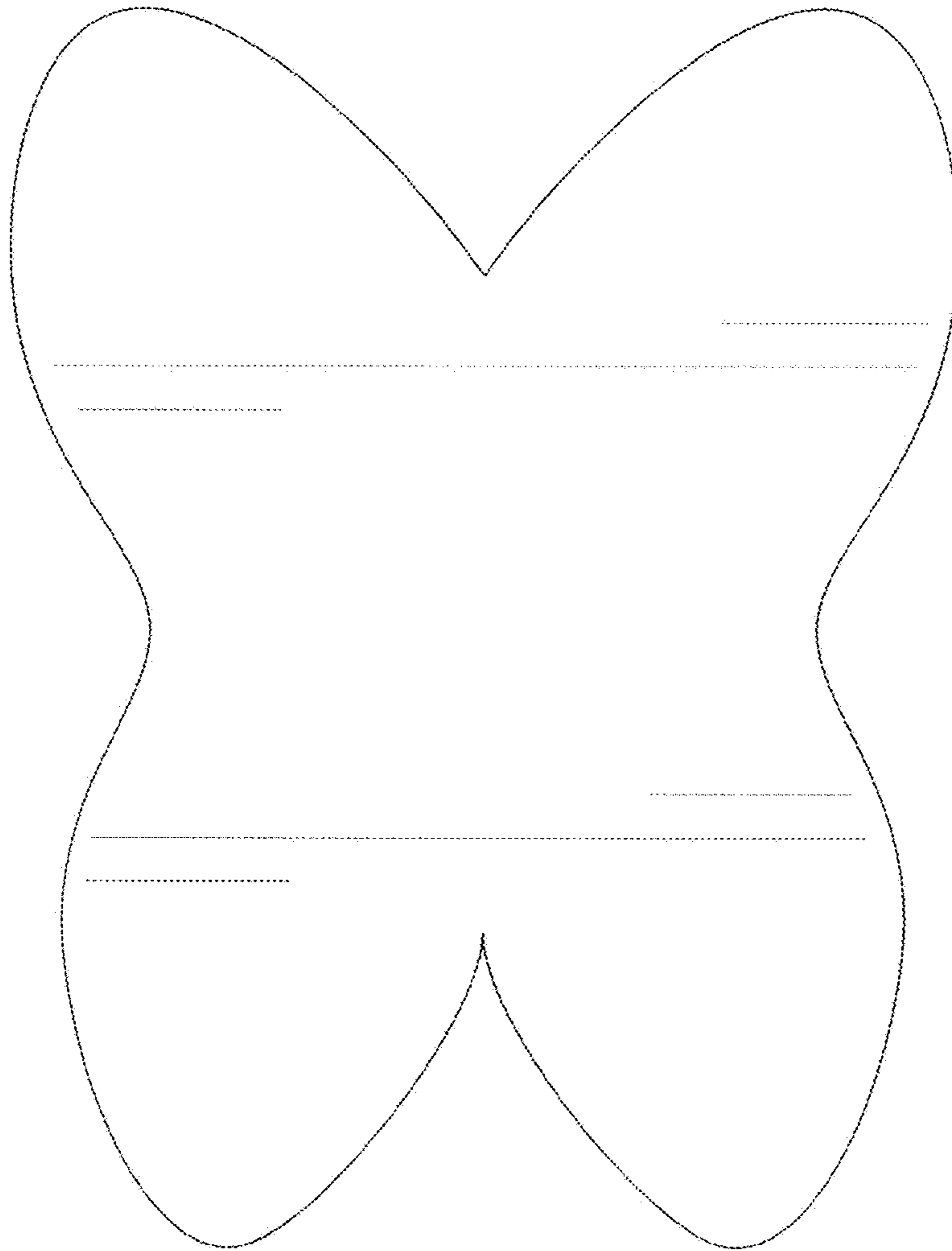

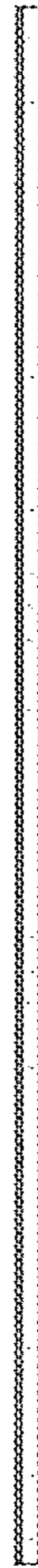

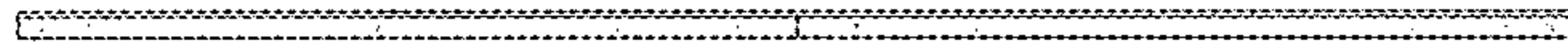

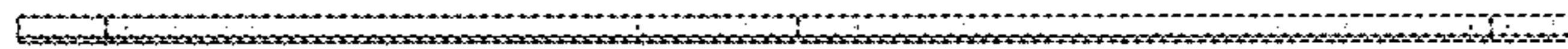
