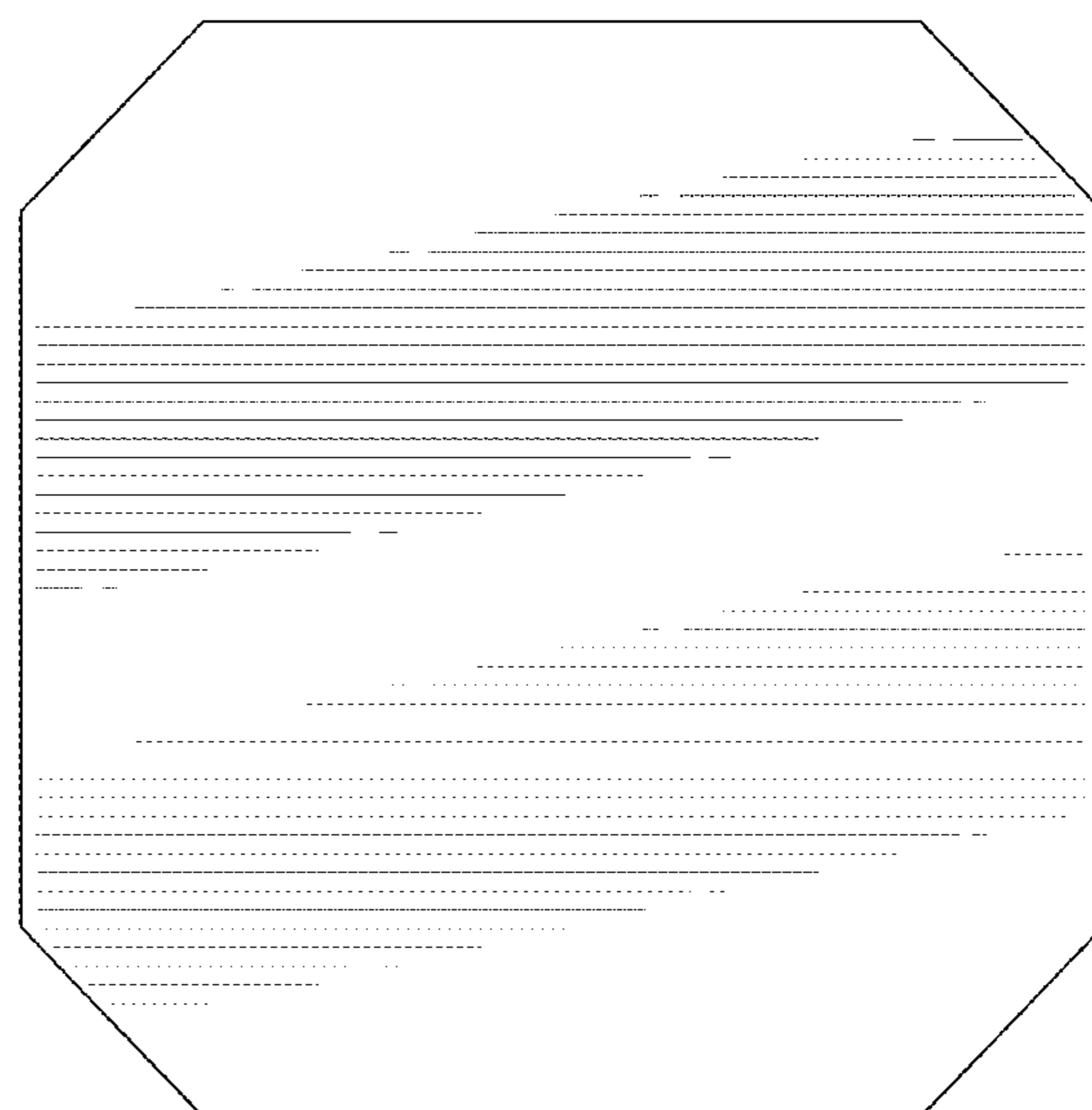
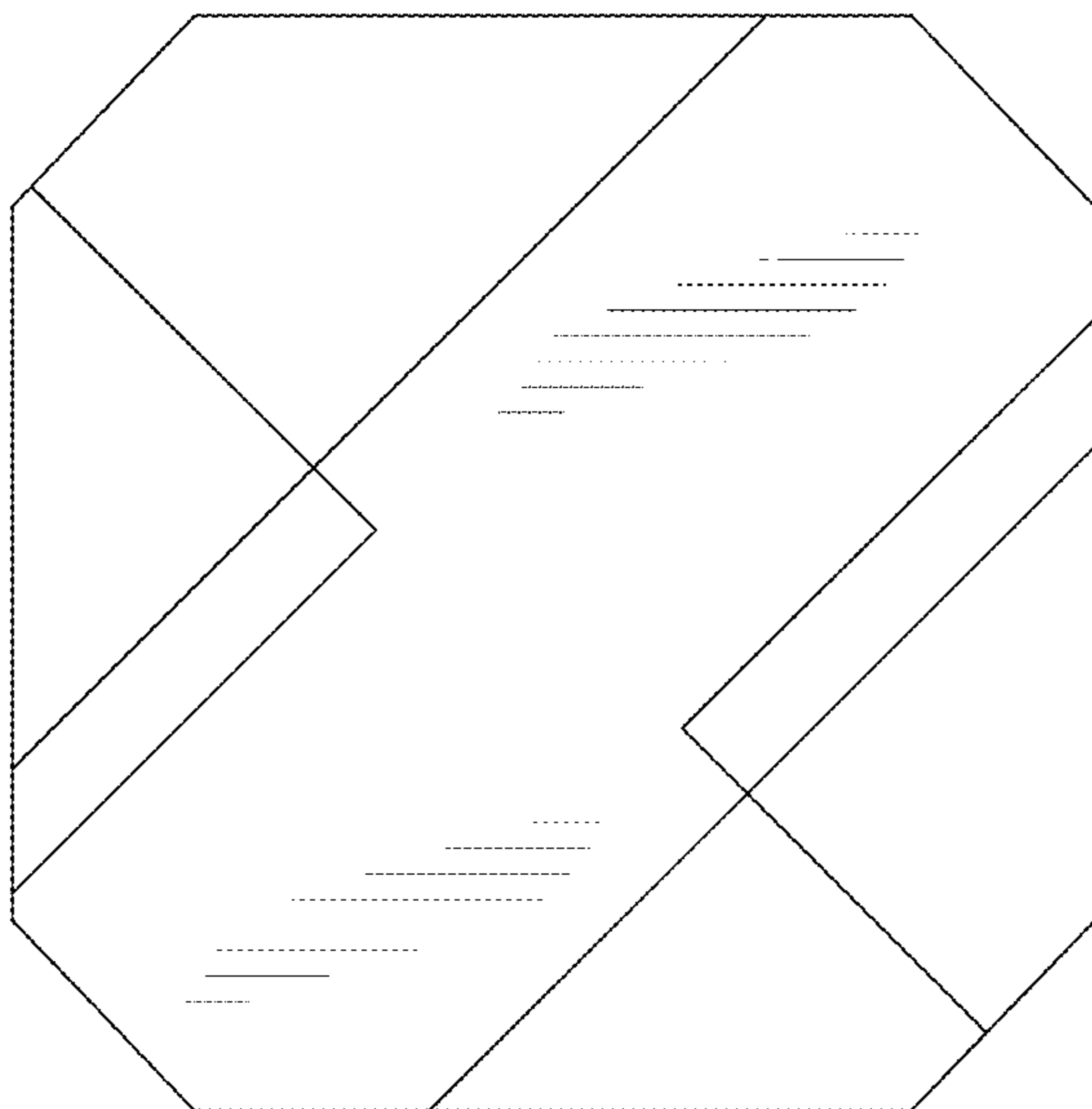

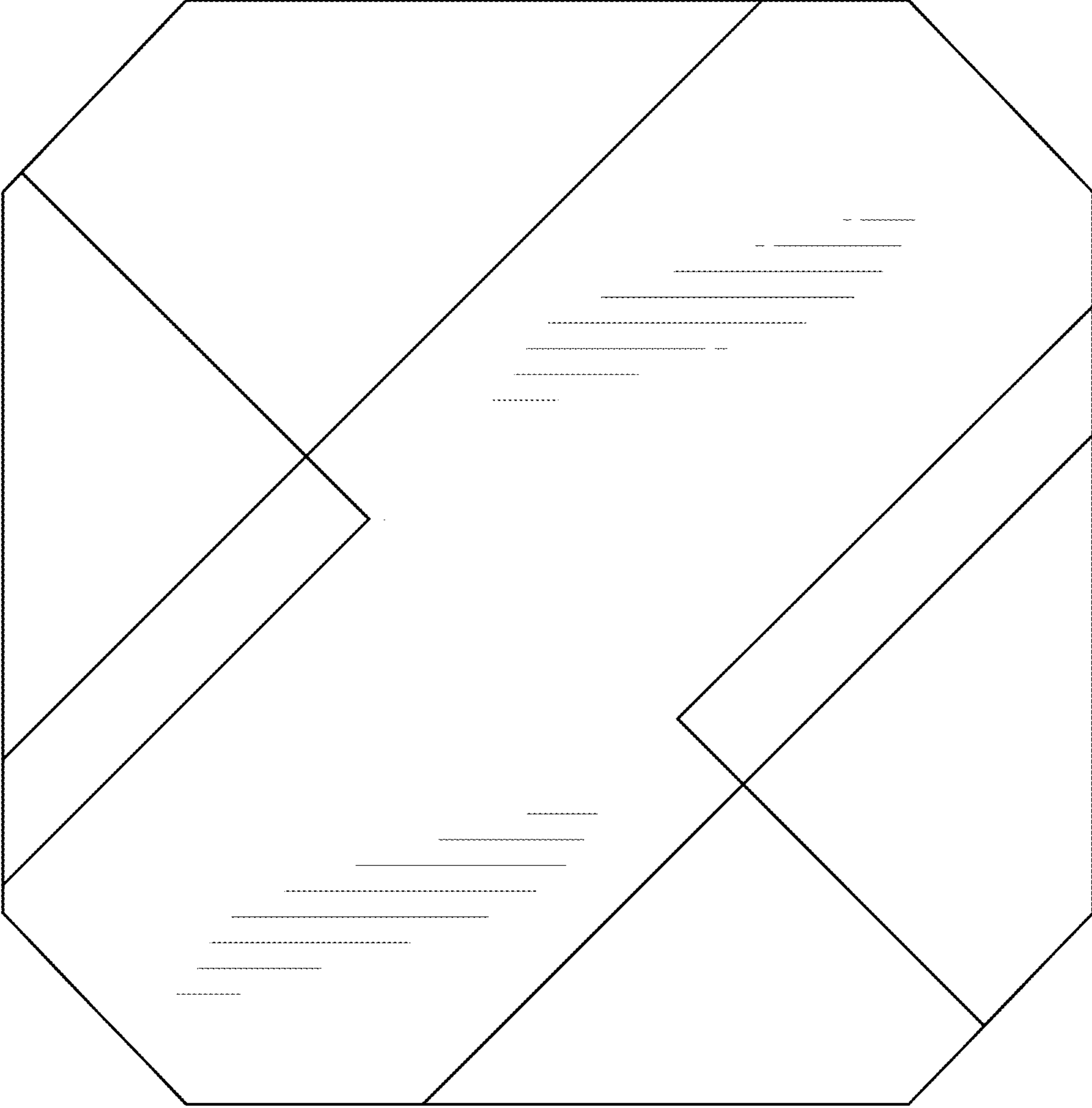
The ornamental design for a nutritional adhesive, as shown and described.

**DESCRIPTION**

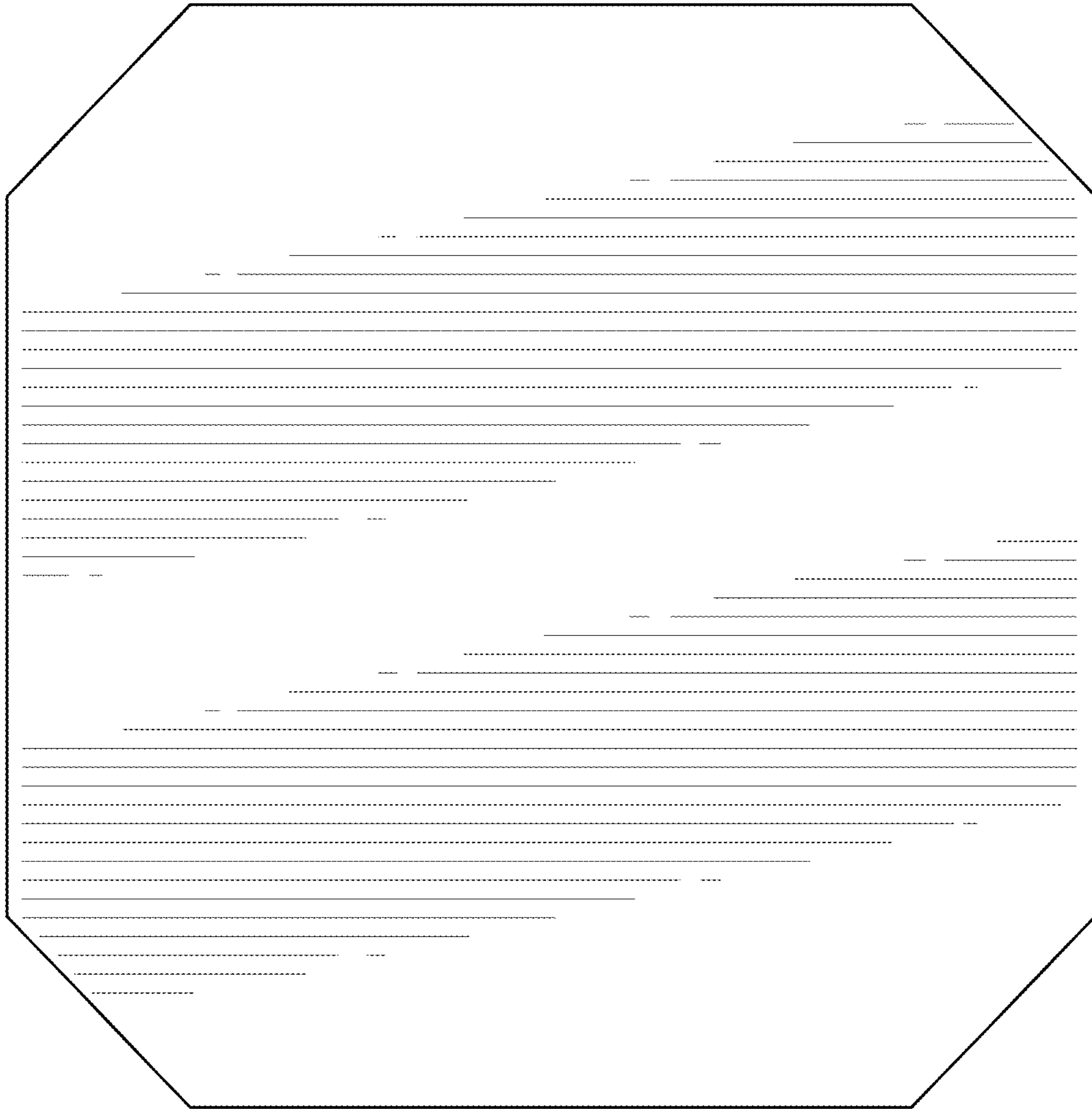
