DESCRIPTION

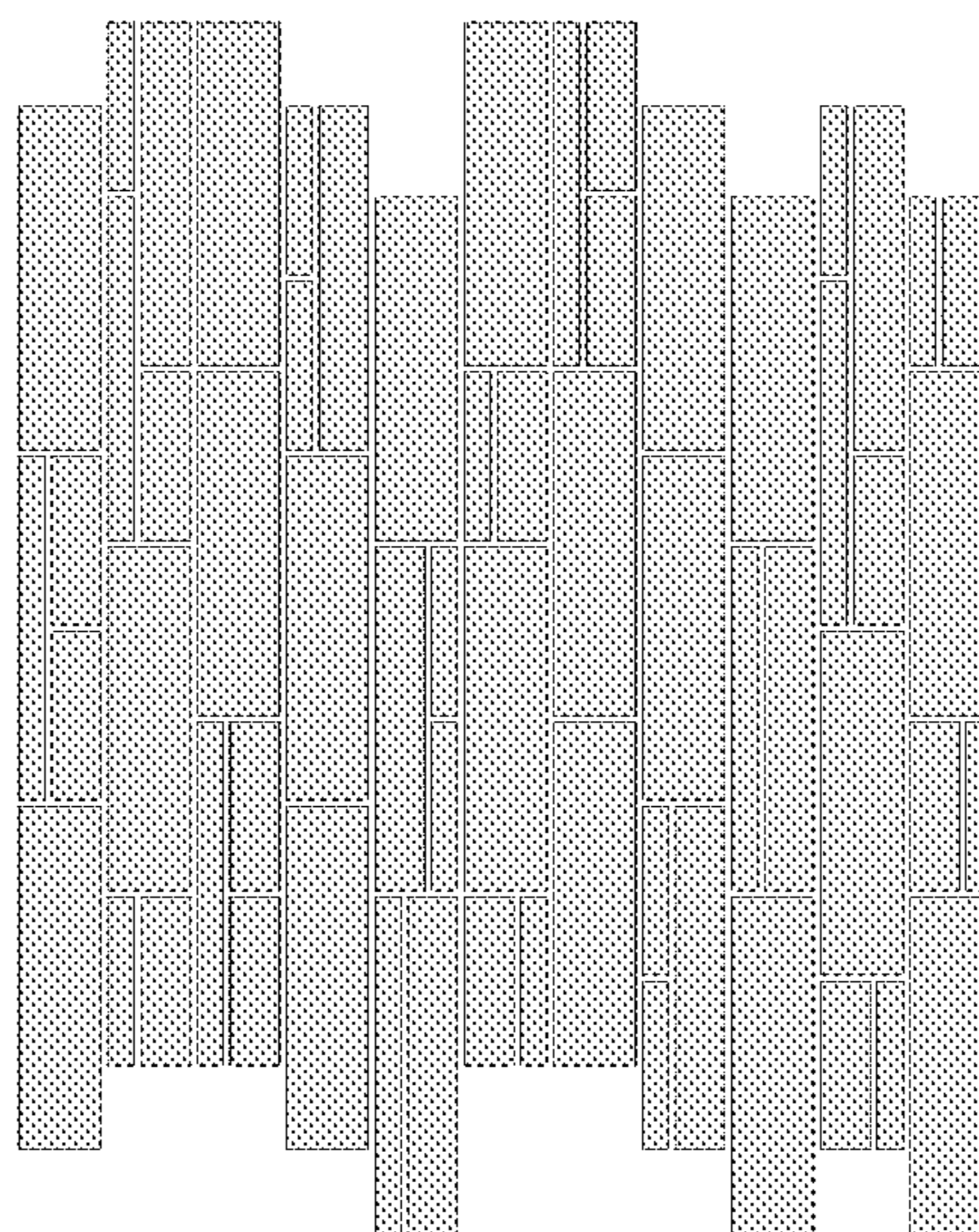
The sole FIGURE is a front elevational view of a set of tiles showing my new design.
