DESCRIPTION

FIG. 1 is a perspective view of the packaged detergent of our new design;

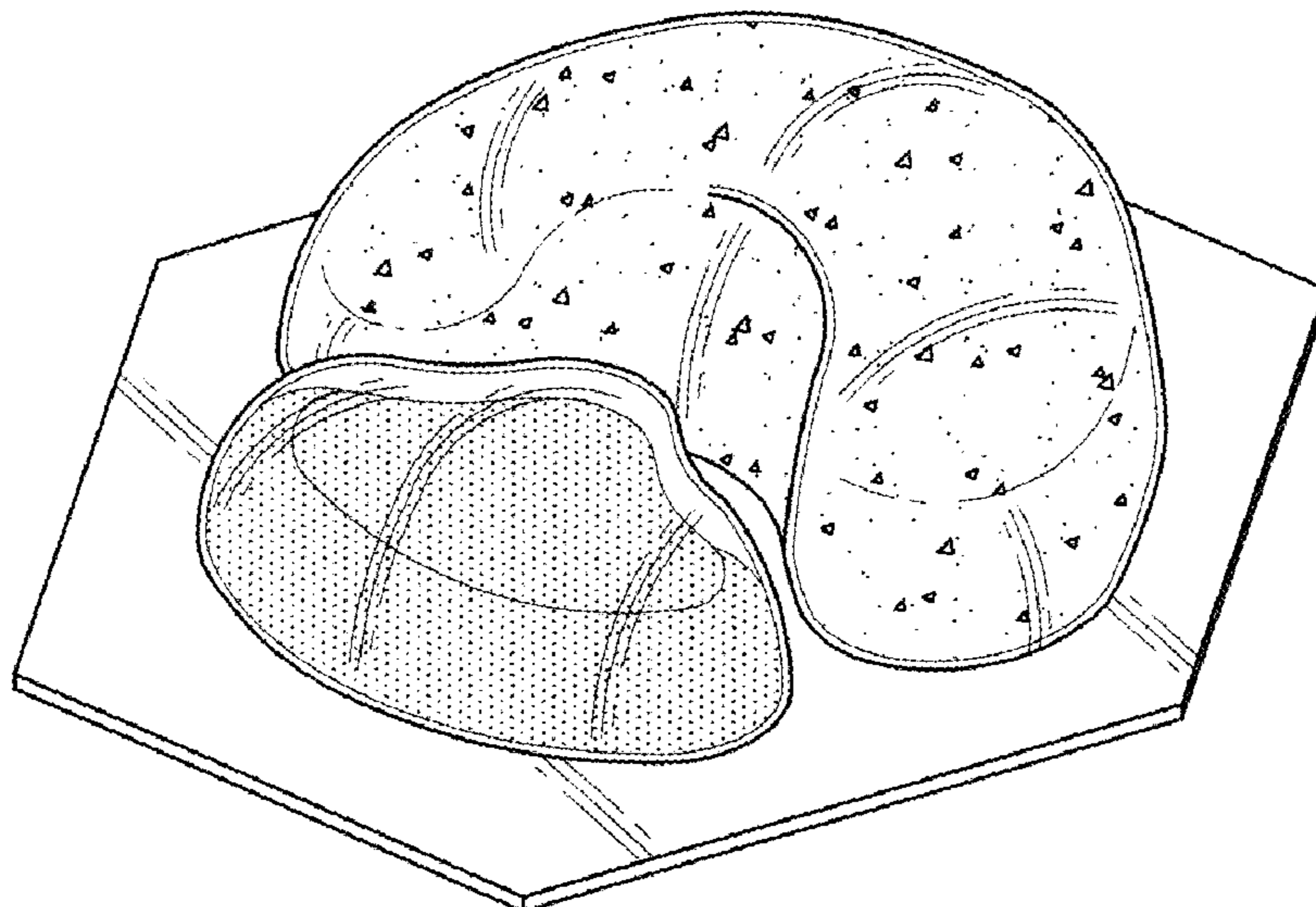

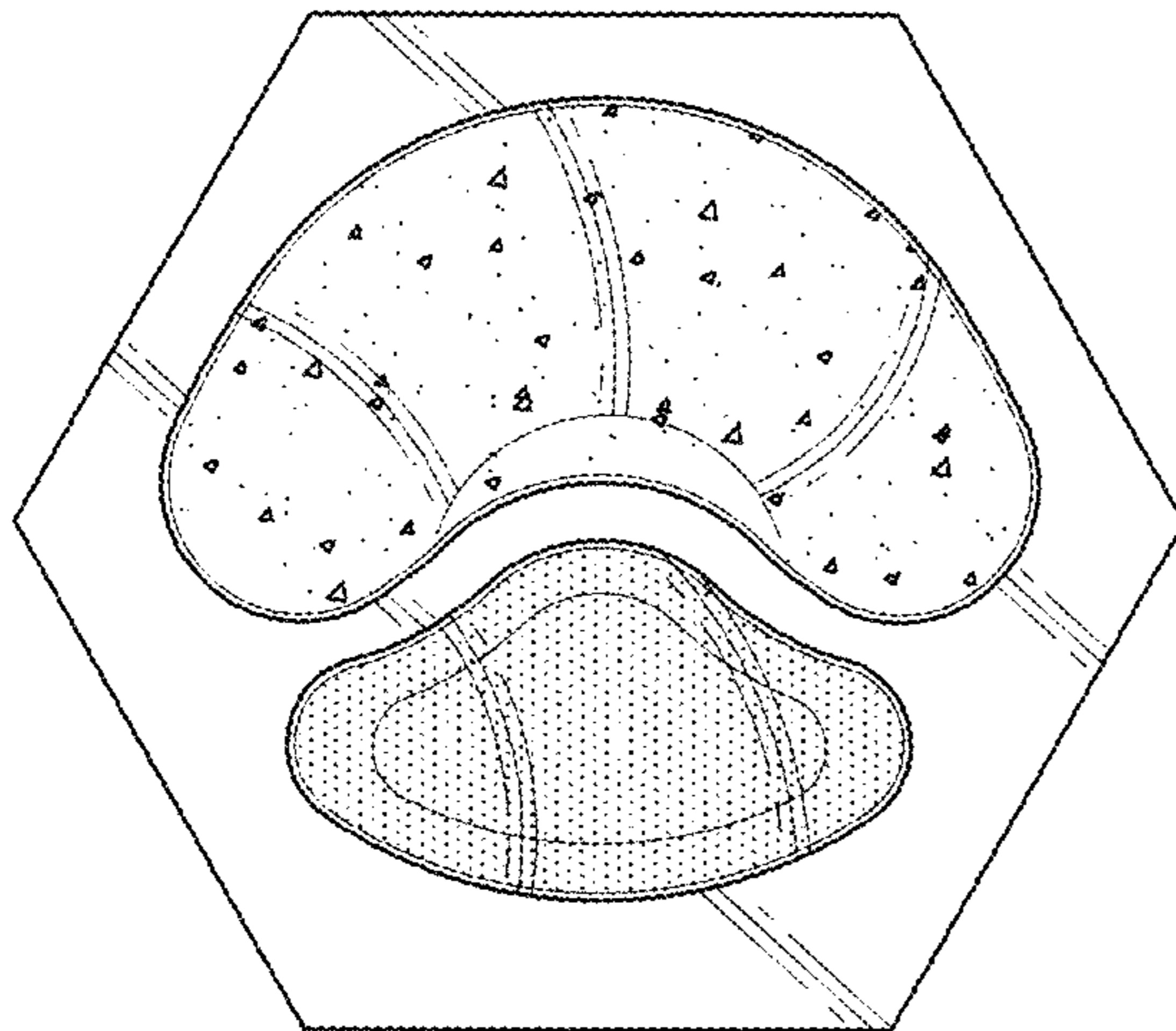
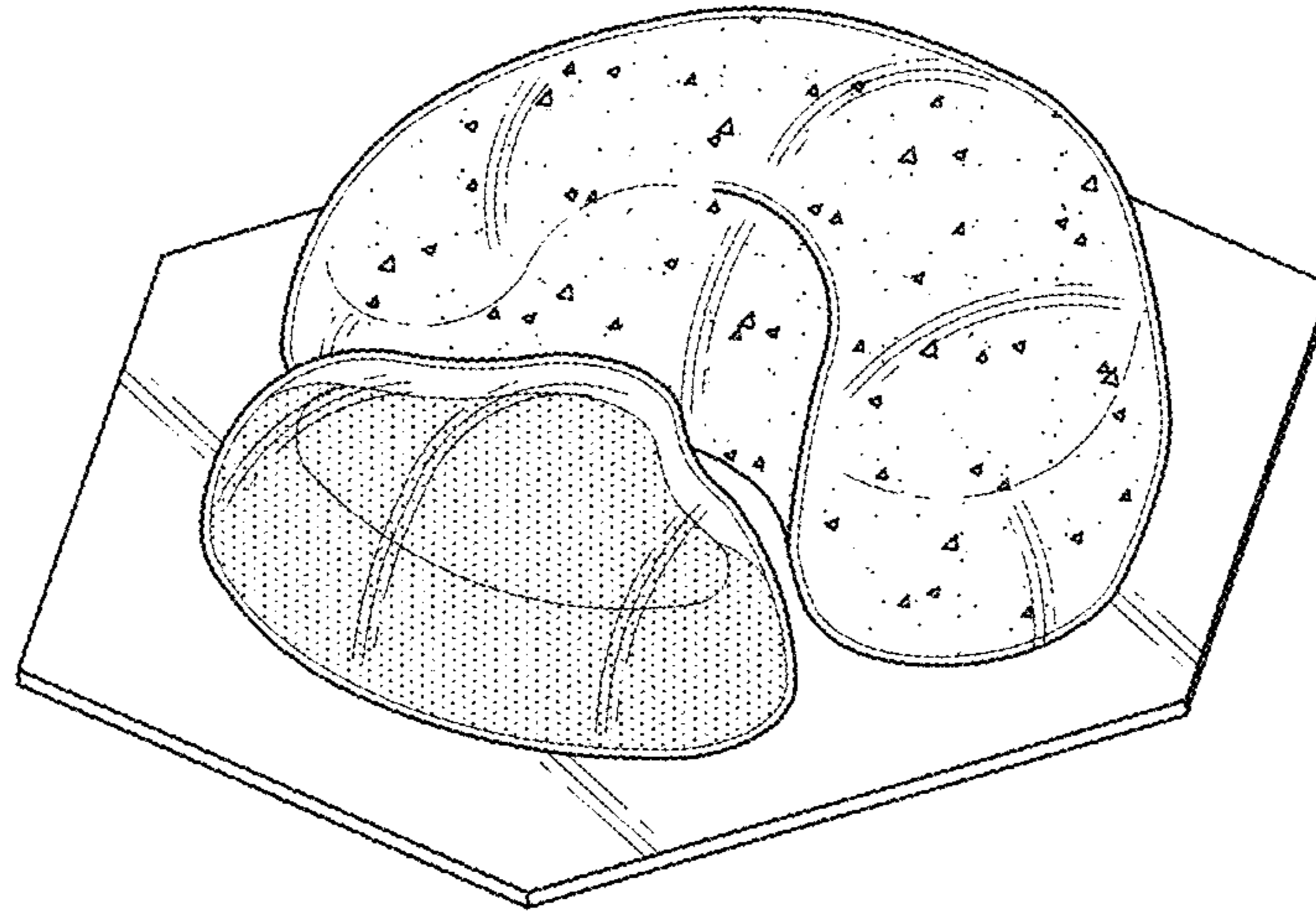
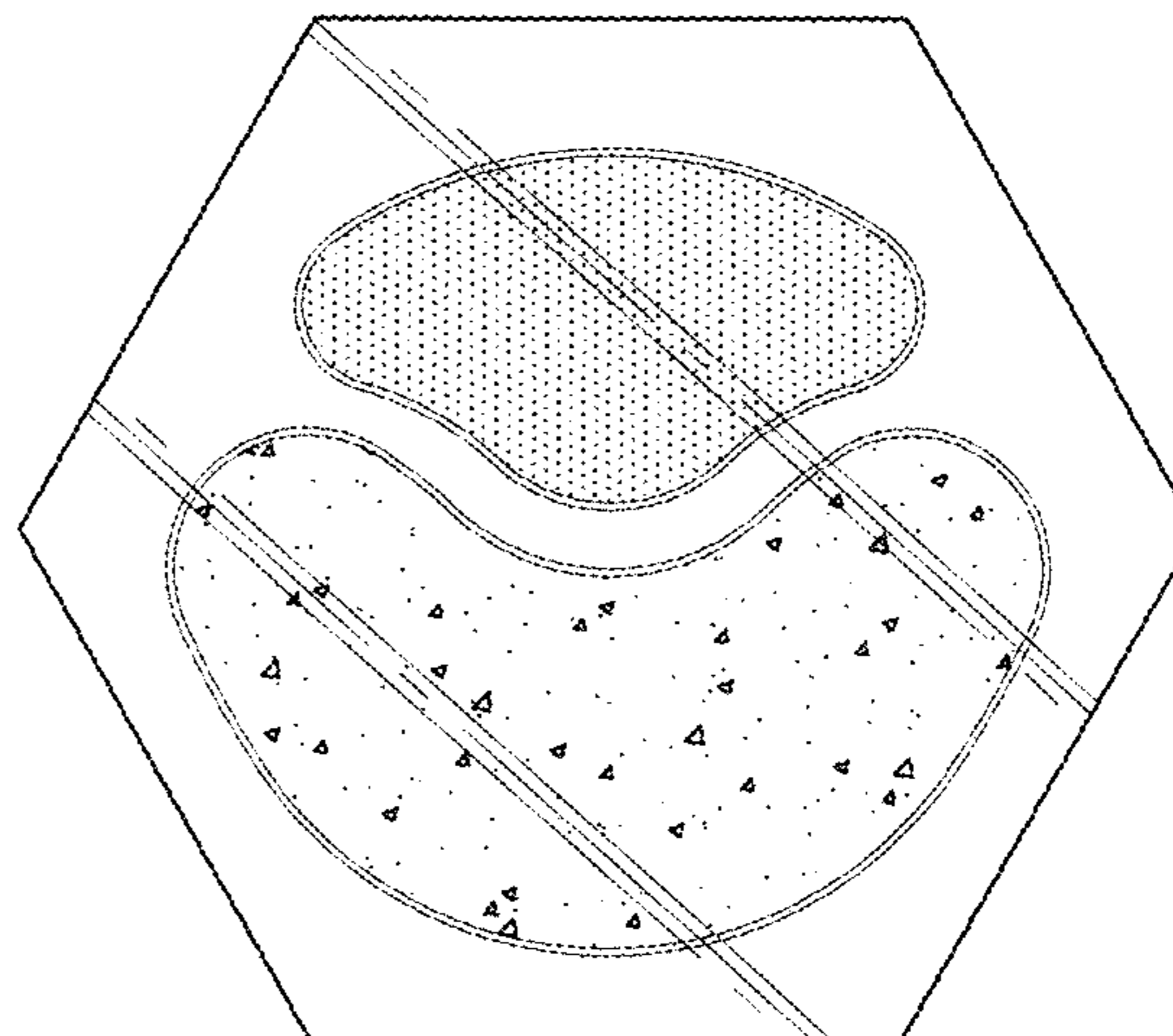

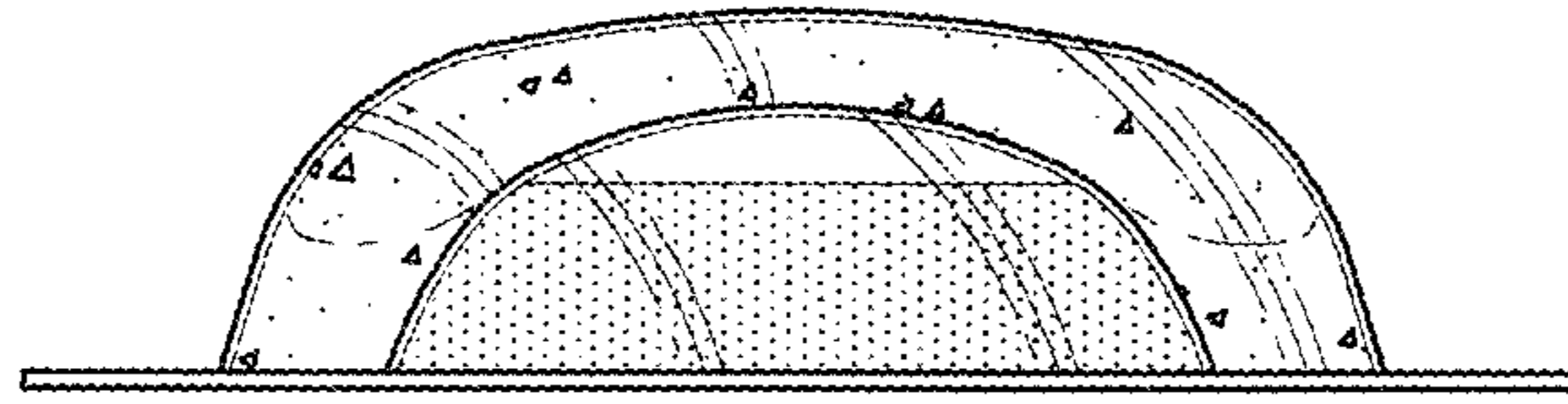

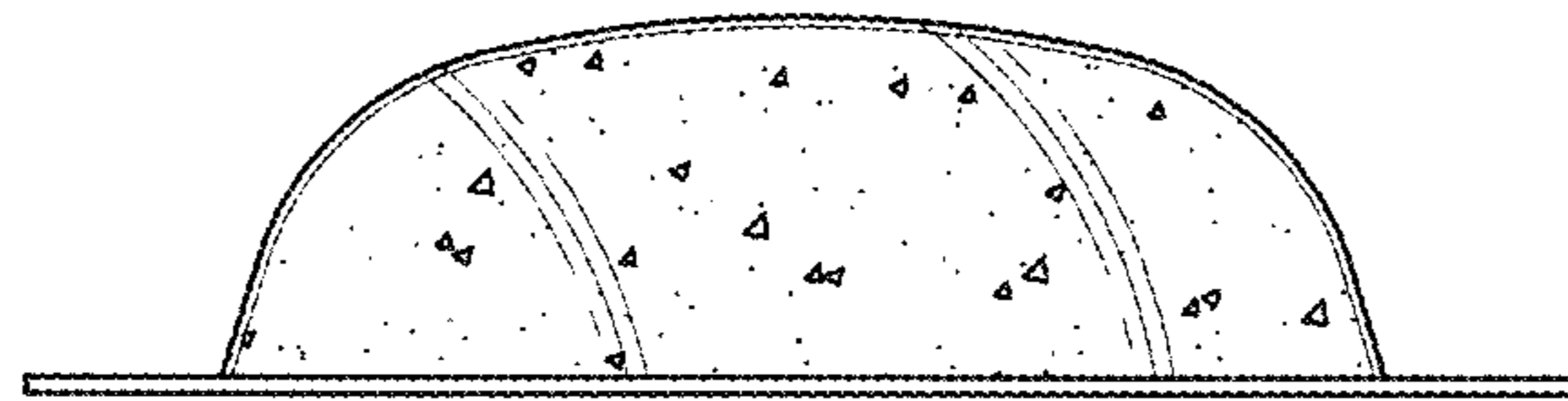

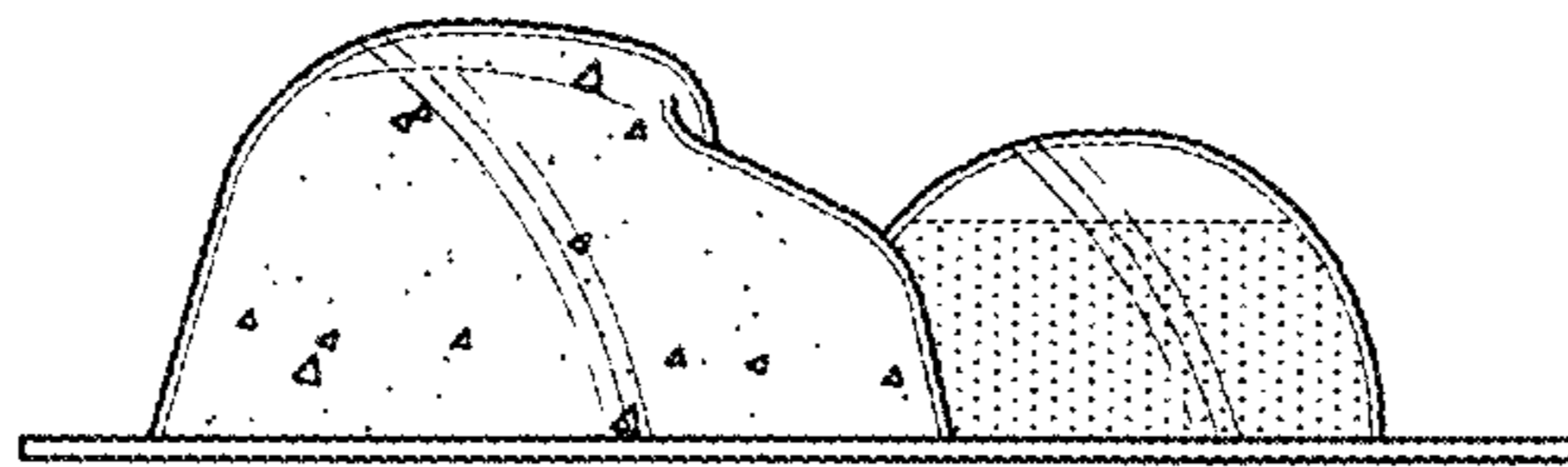

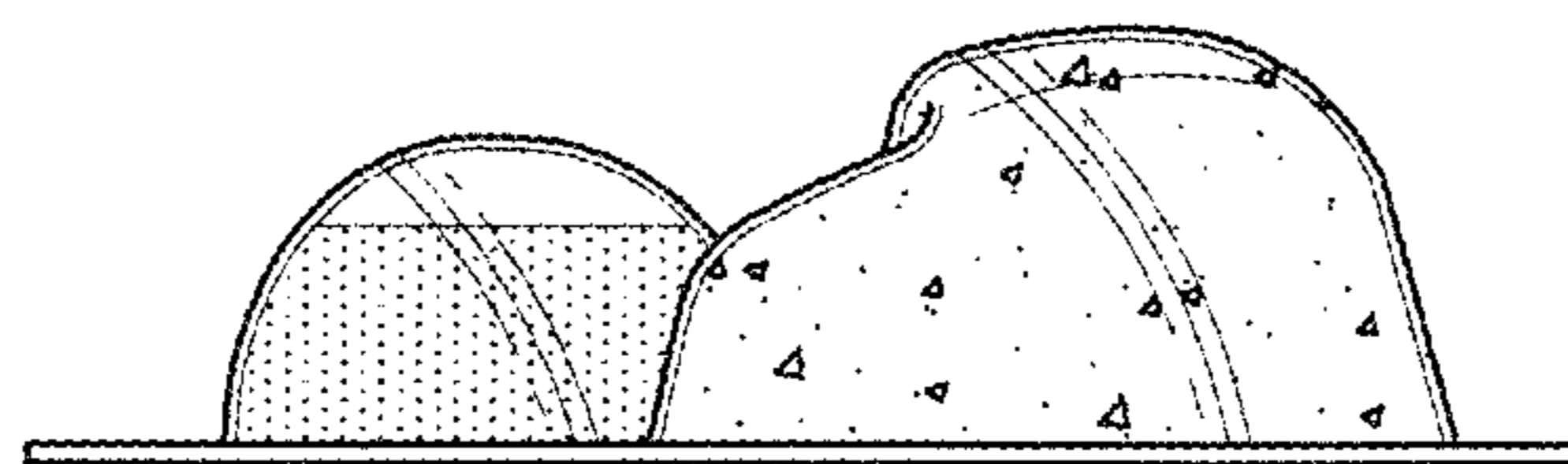
