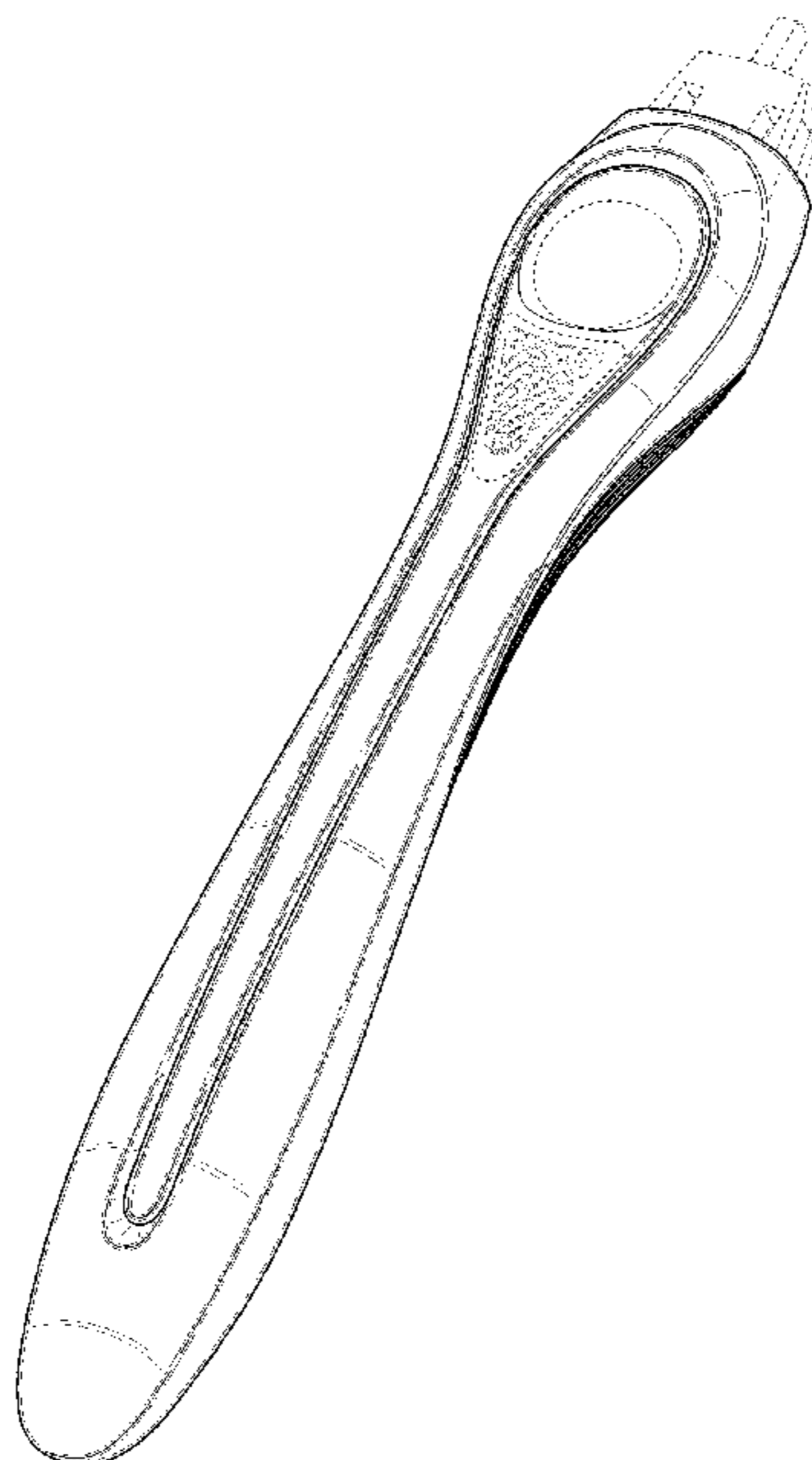

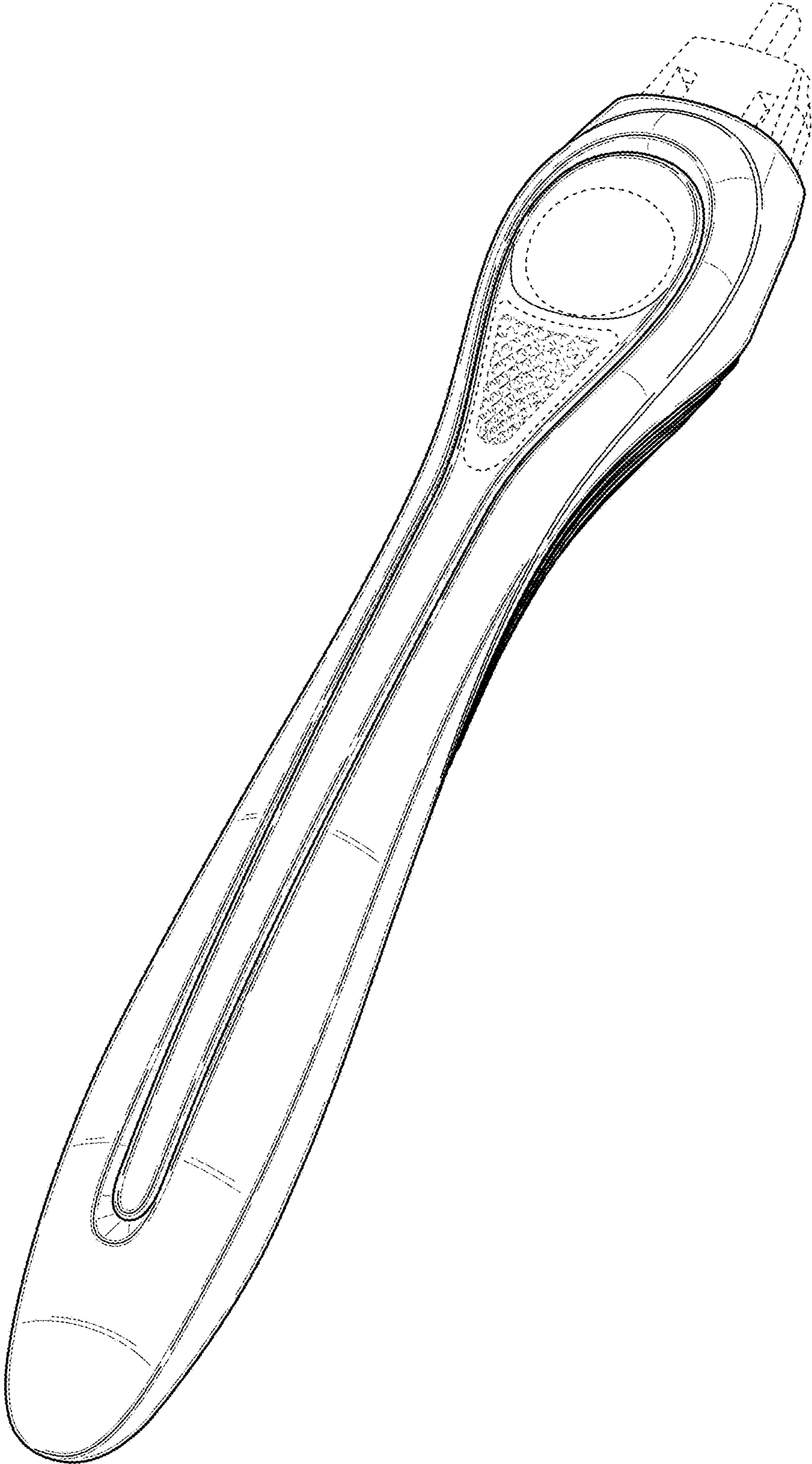
The ornamental design for a shaver handle, as shown and described.

**DESCRIPTION**

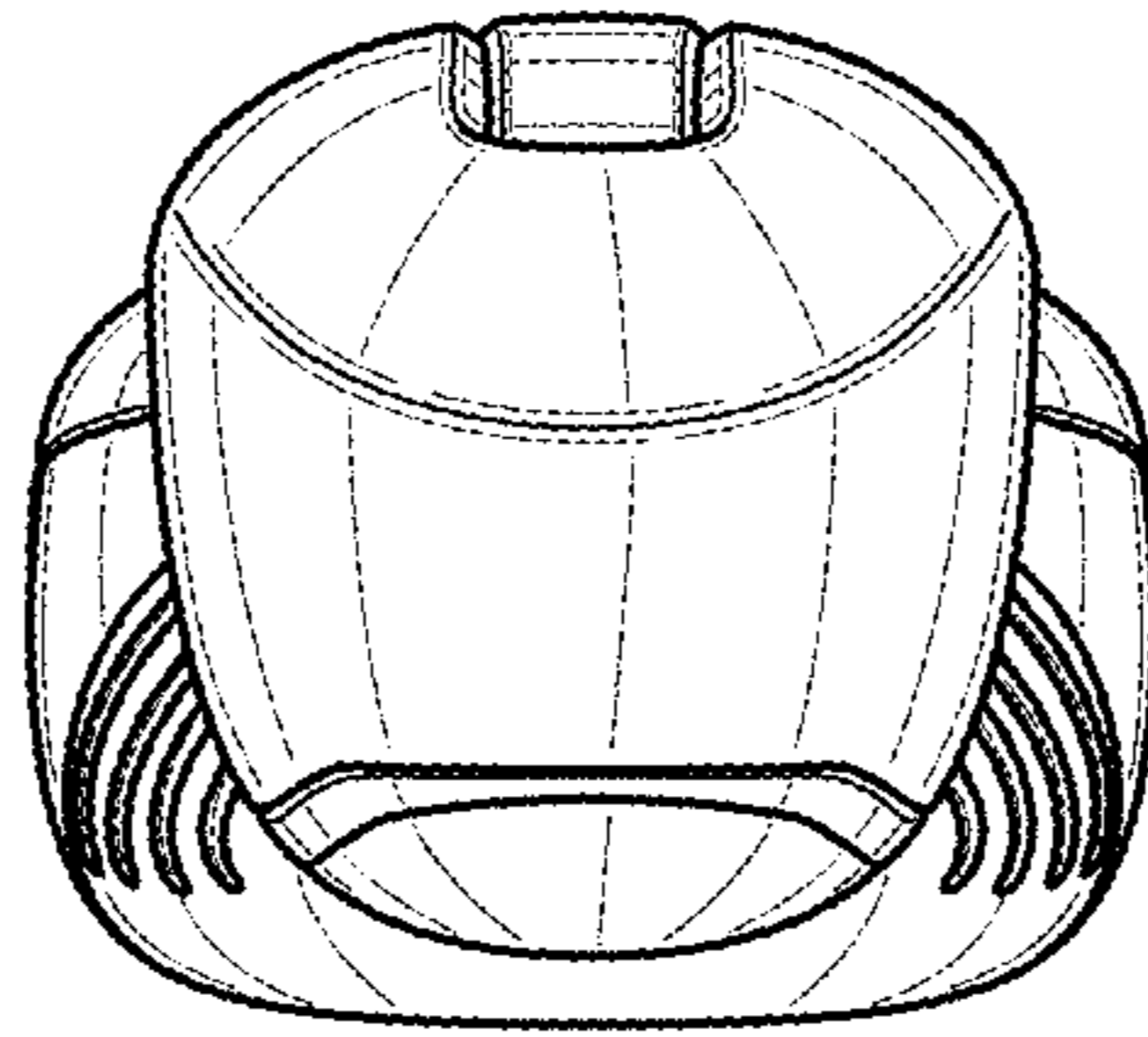
FIG. 1 is perspective view of an ornamental design for a shaver handle according to the present invention;

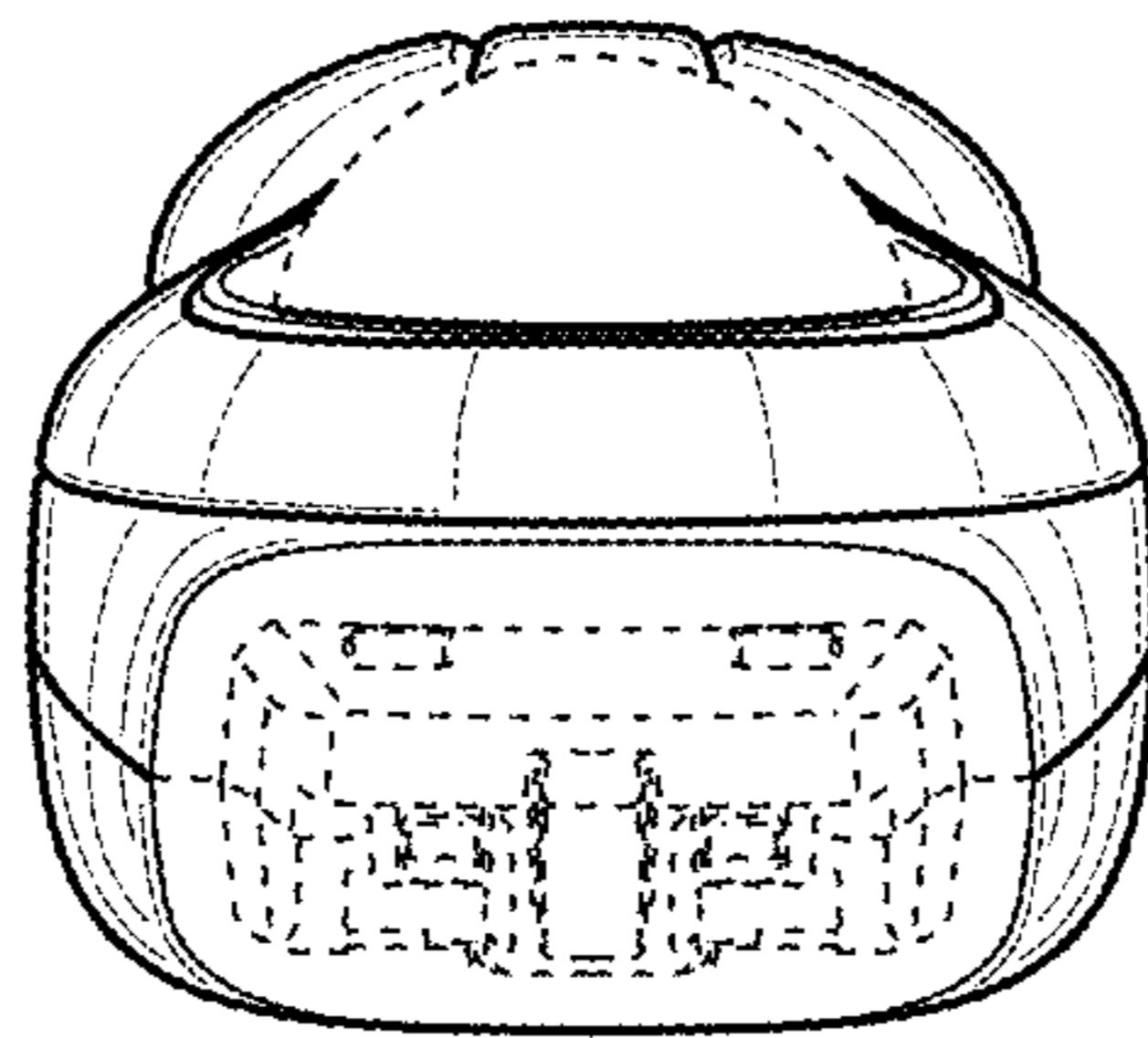

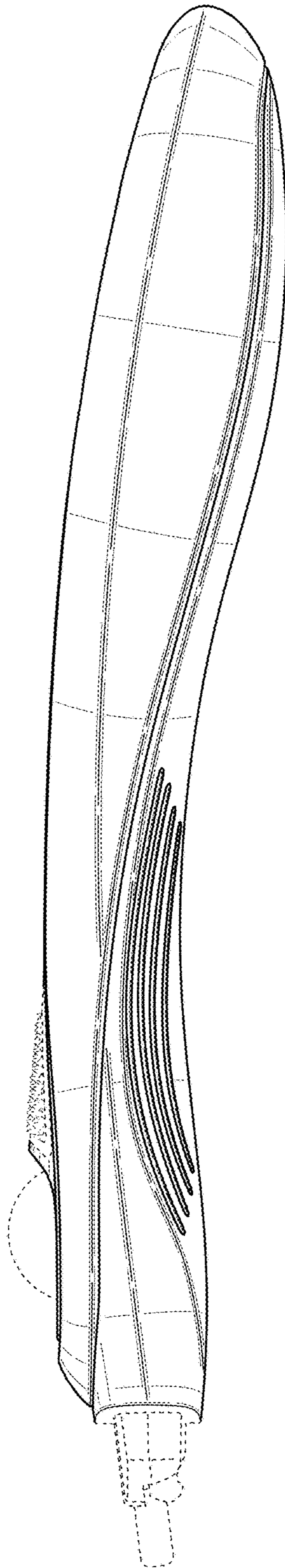

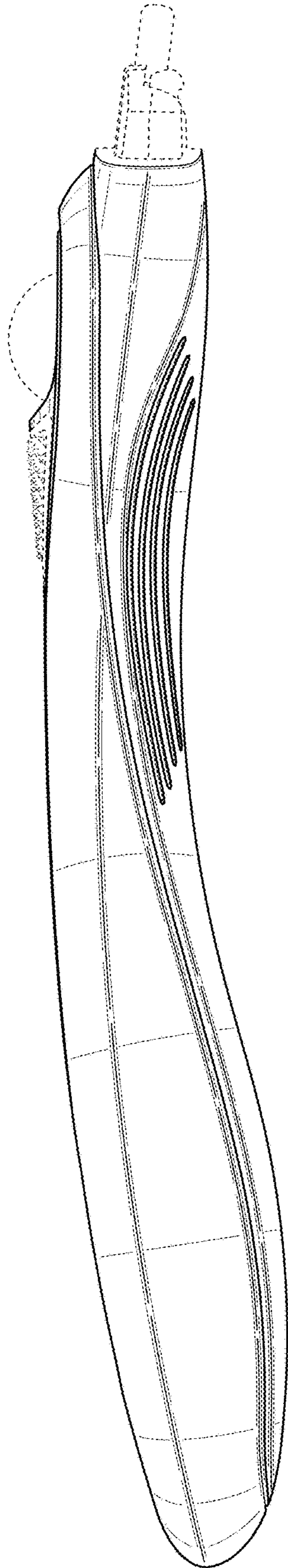
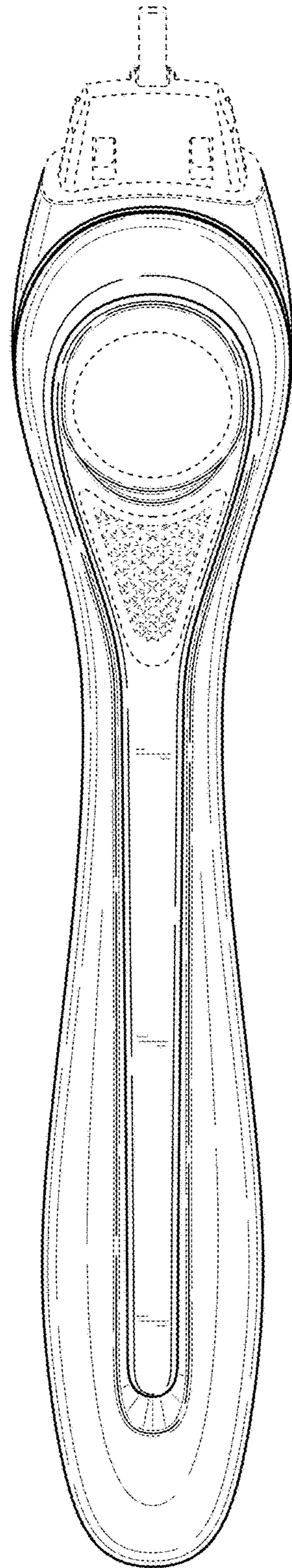
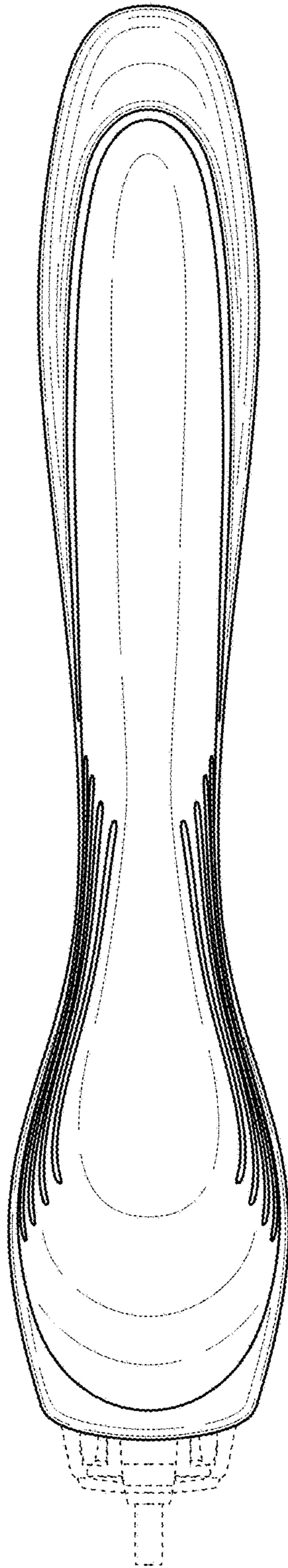
