Fig. 1.3 is a rear elevation view;

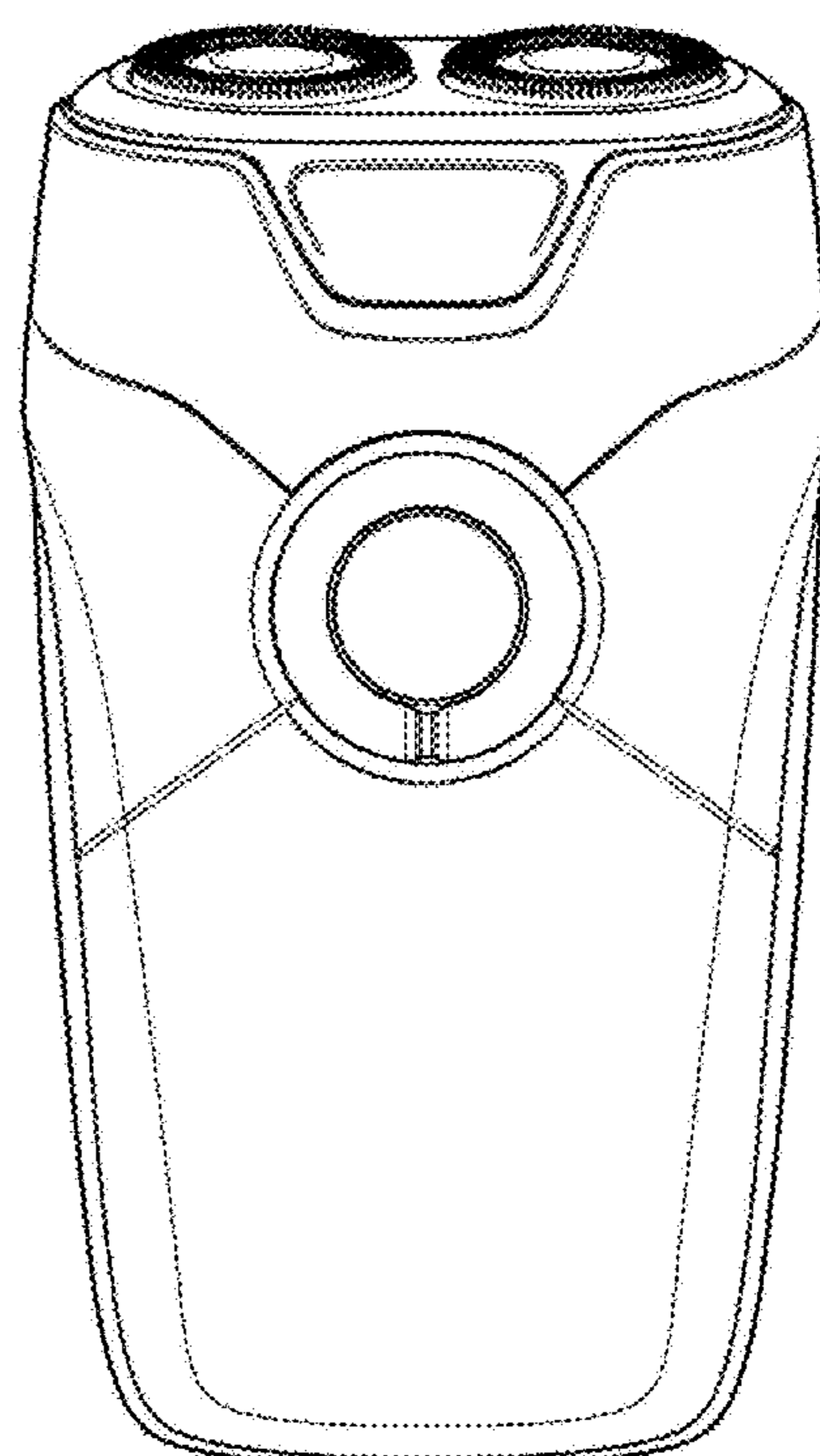
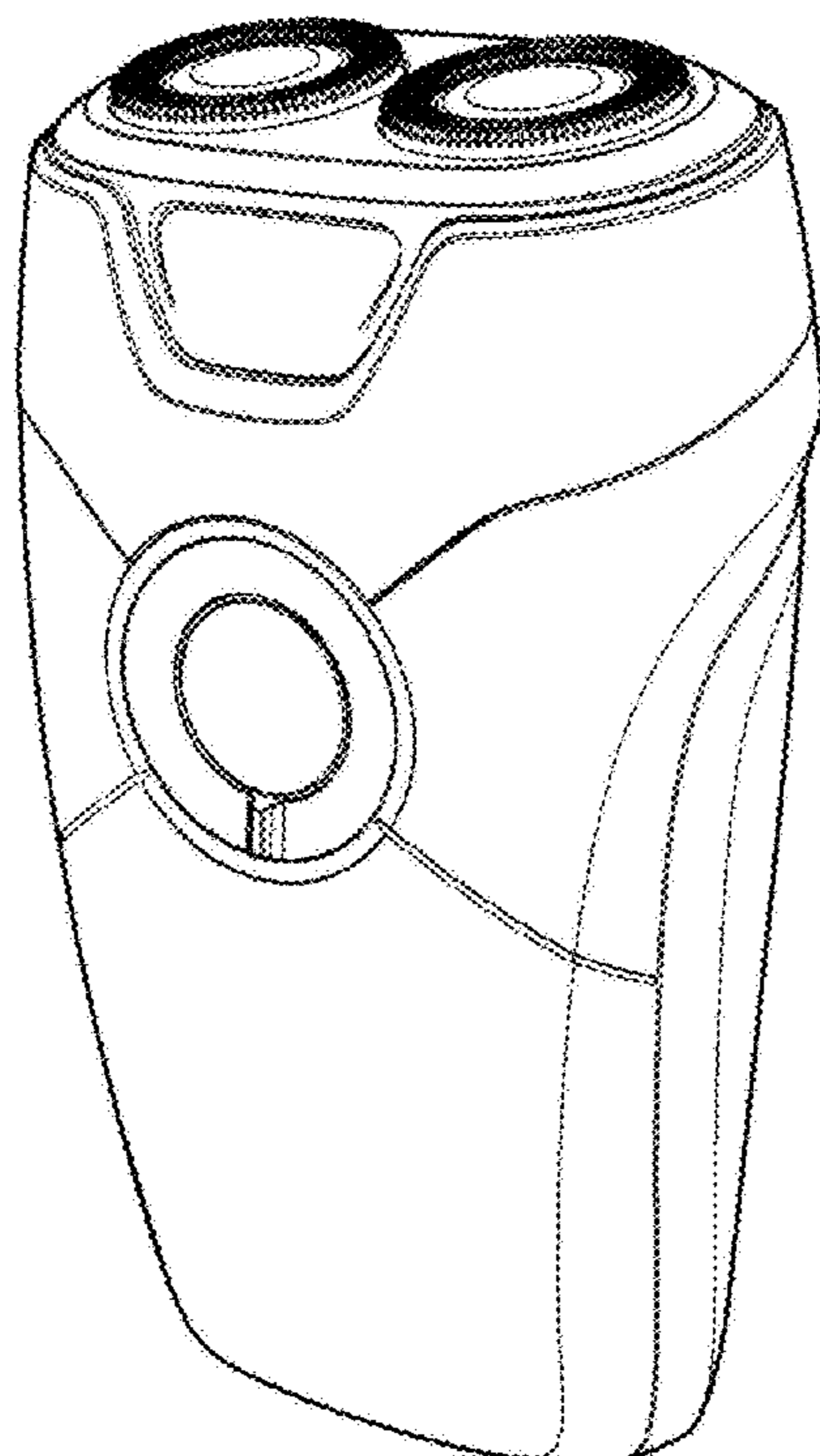
Fig. 1.4 is a left side elevation view;

Fig. 1.5 is a right side elevation view;

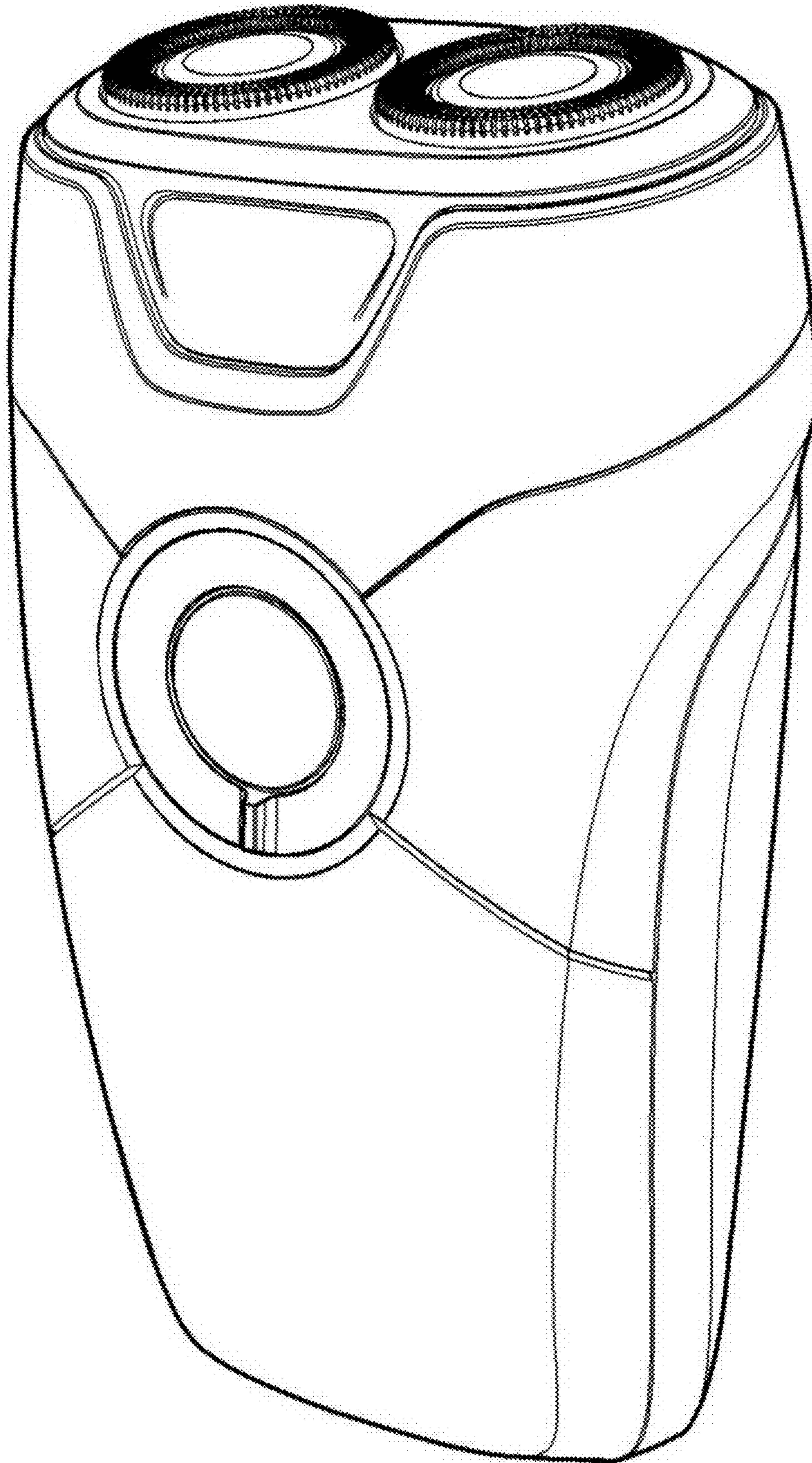
Fig. 1.6 is a top plan view;

Fig. 1.7 is a bottom plan view.

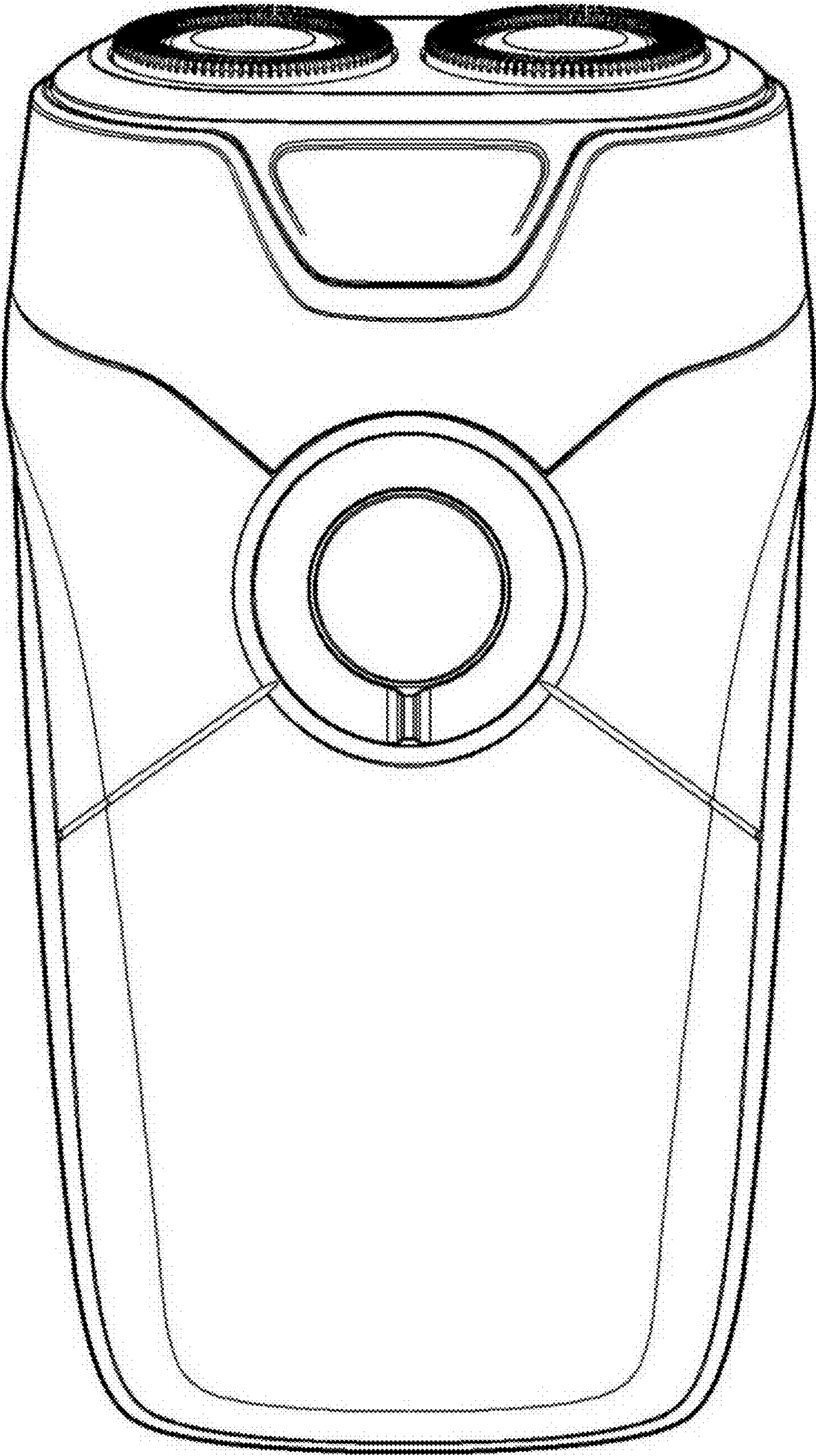

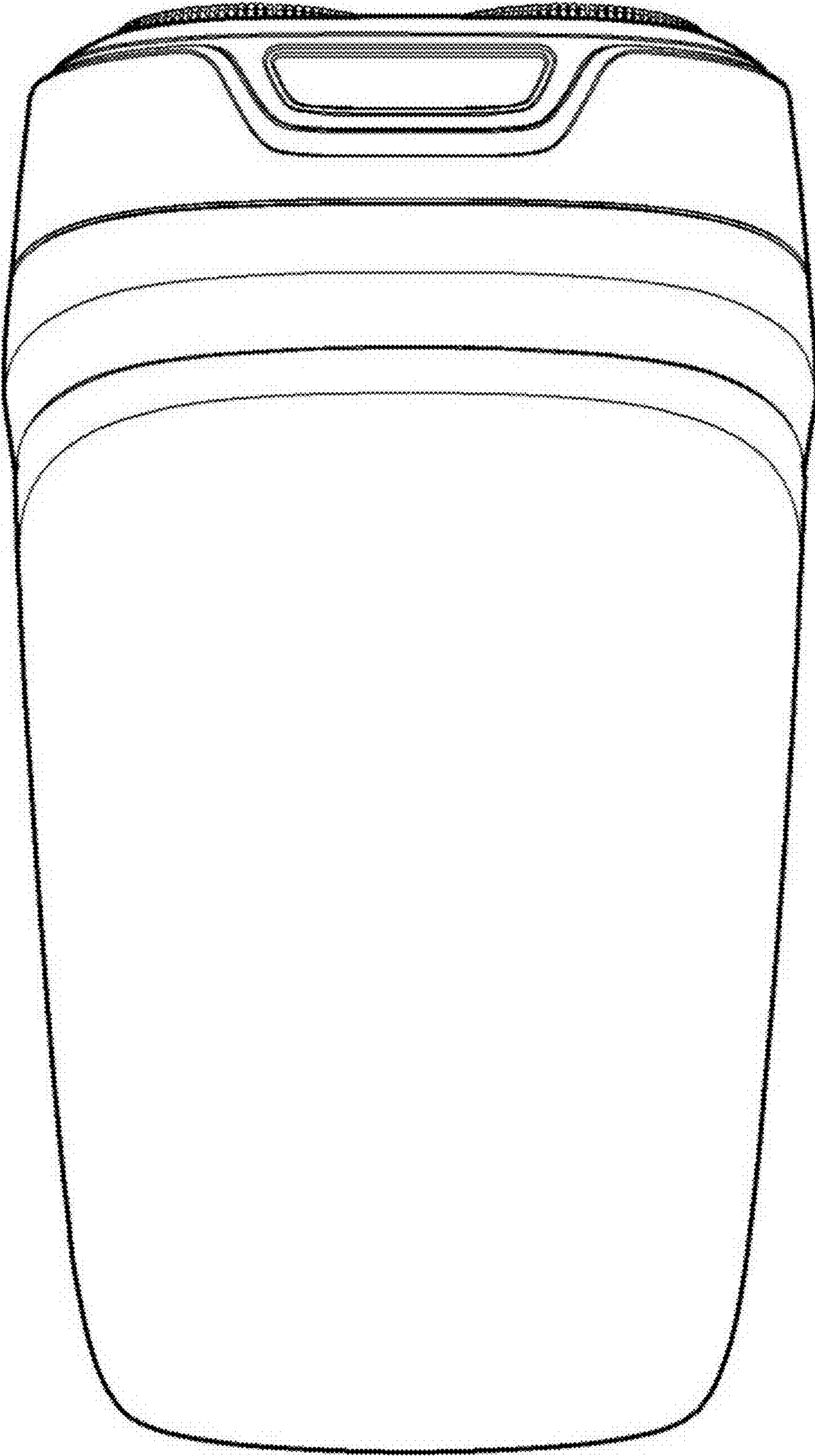

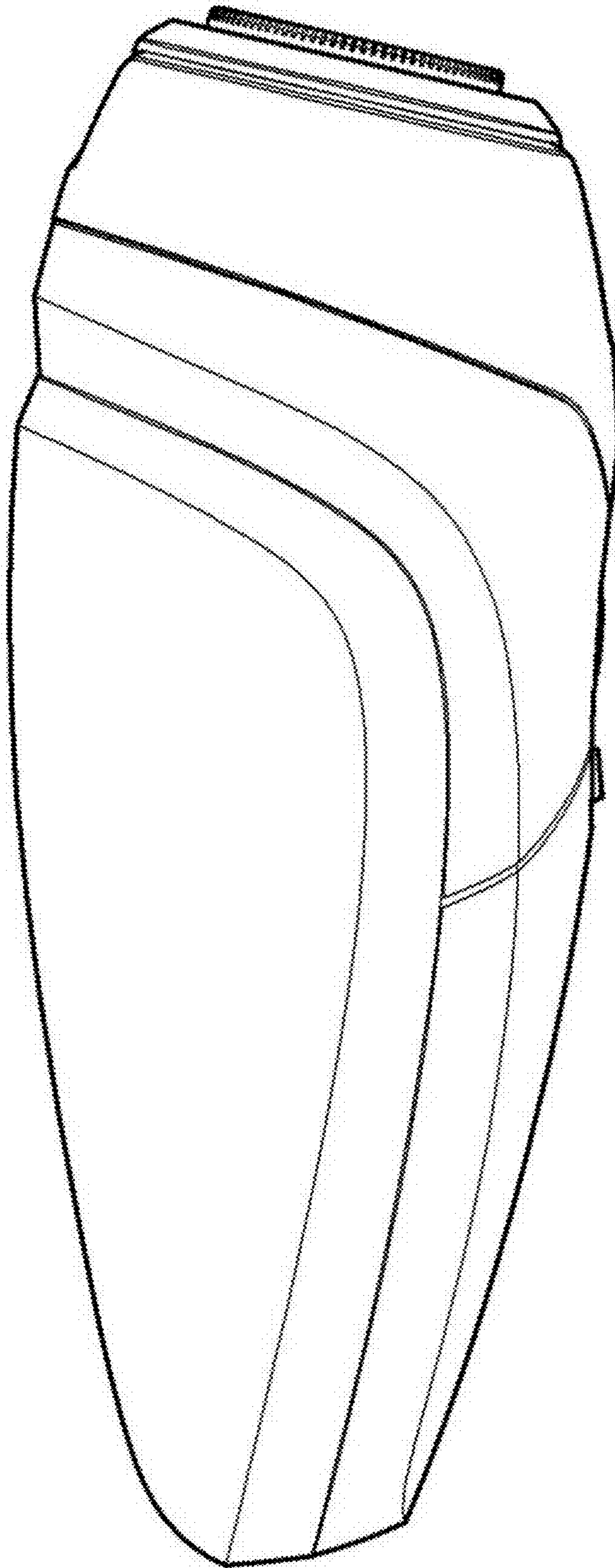

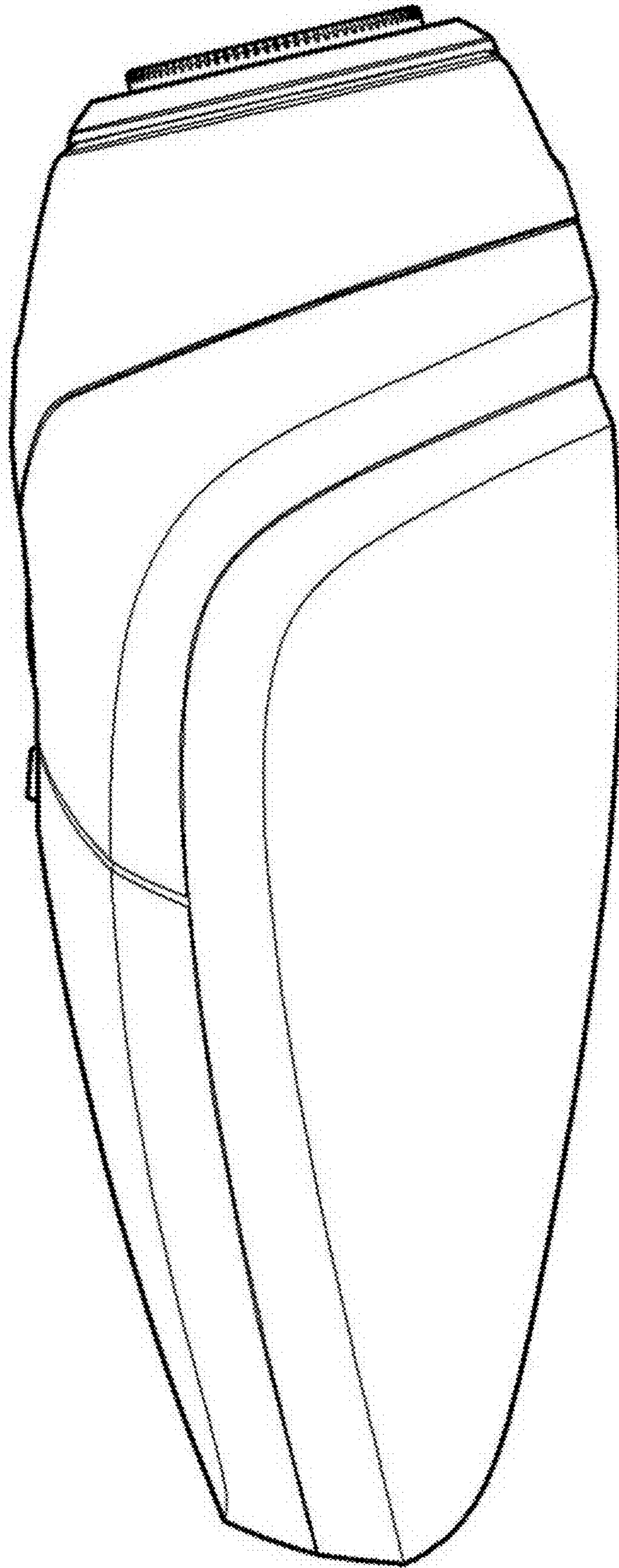

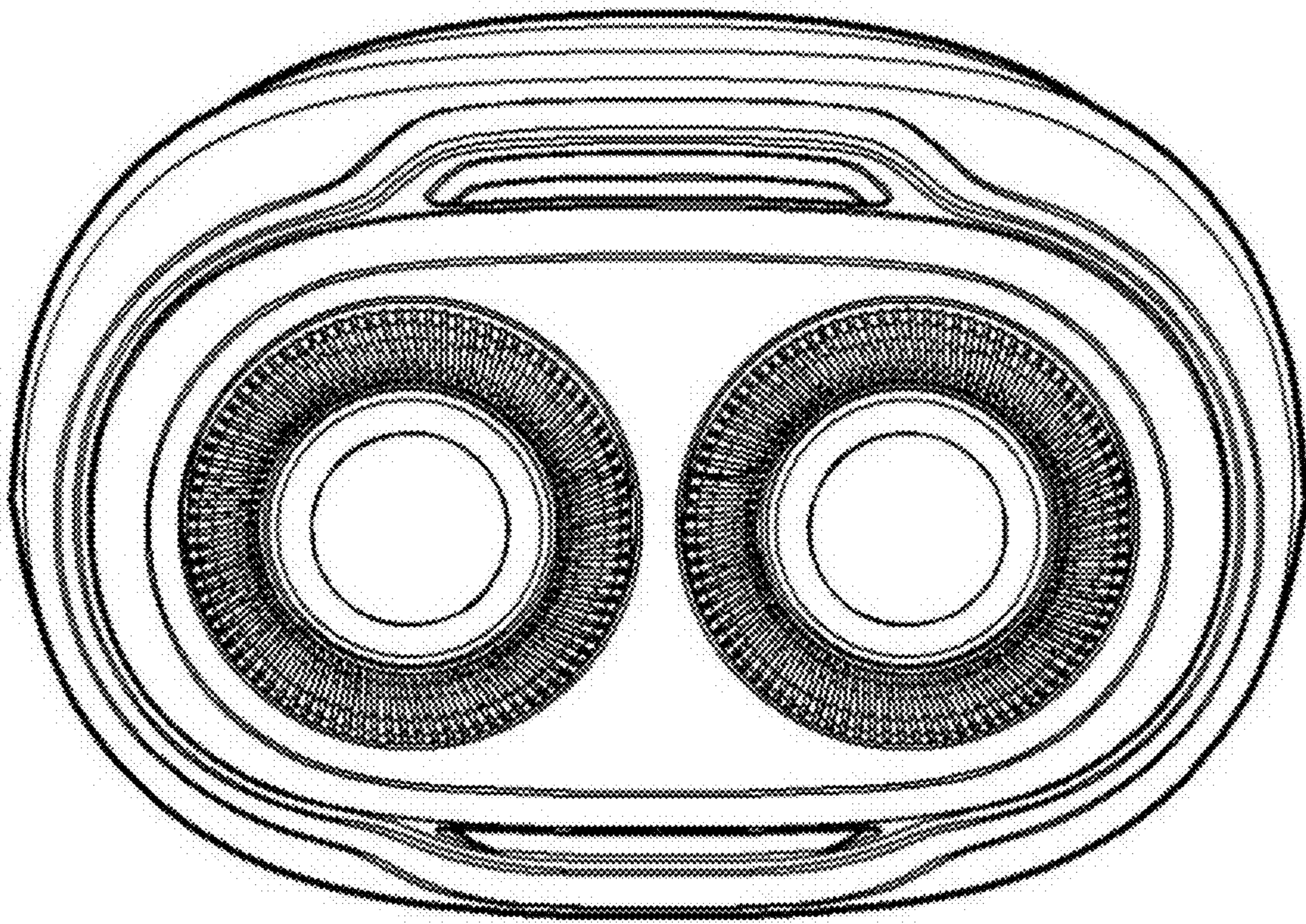
