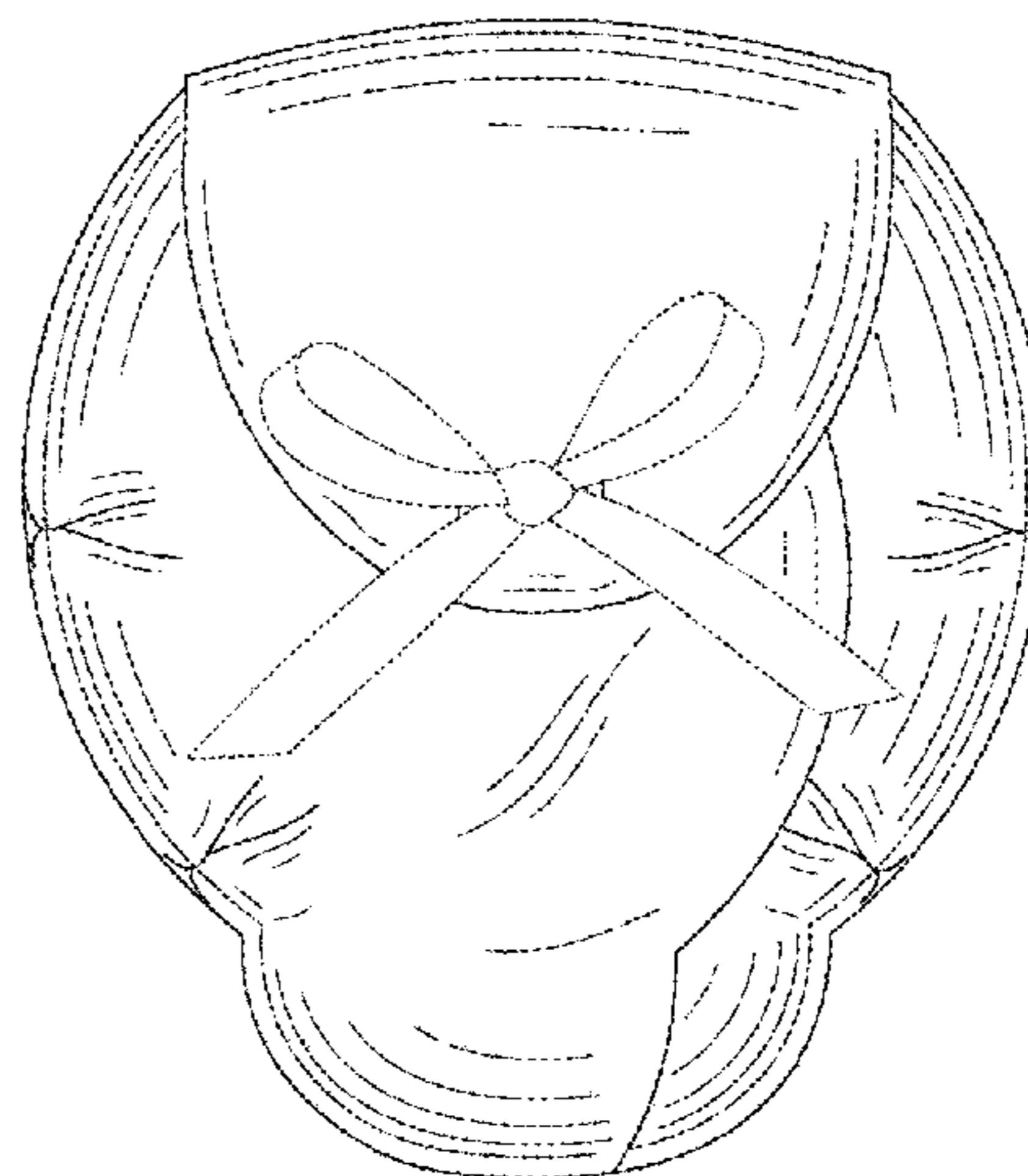
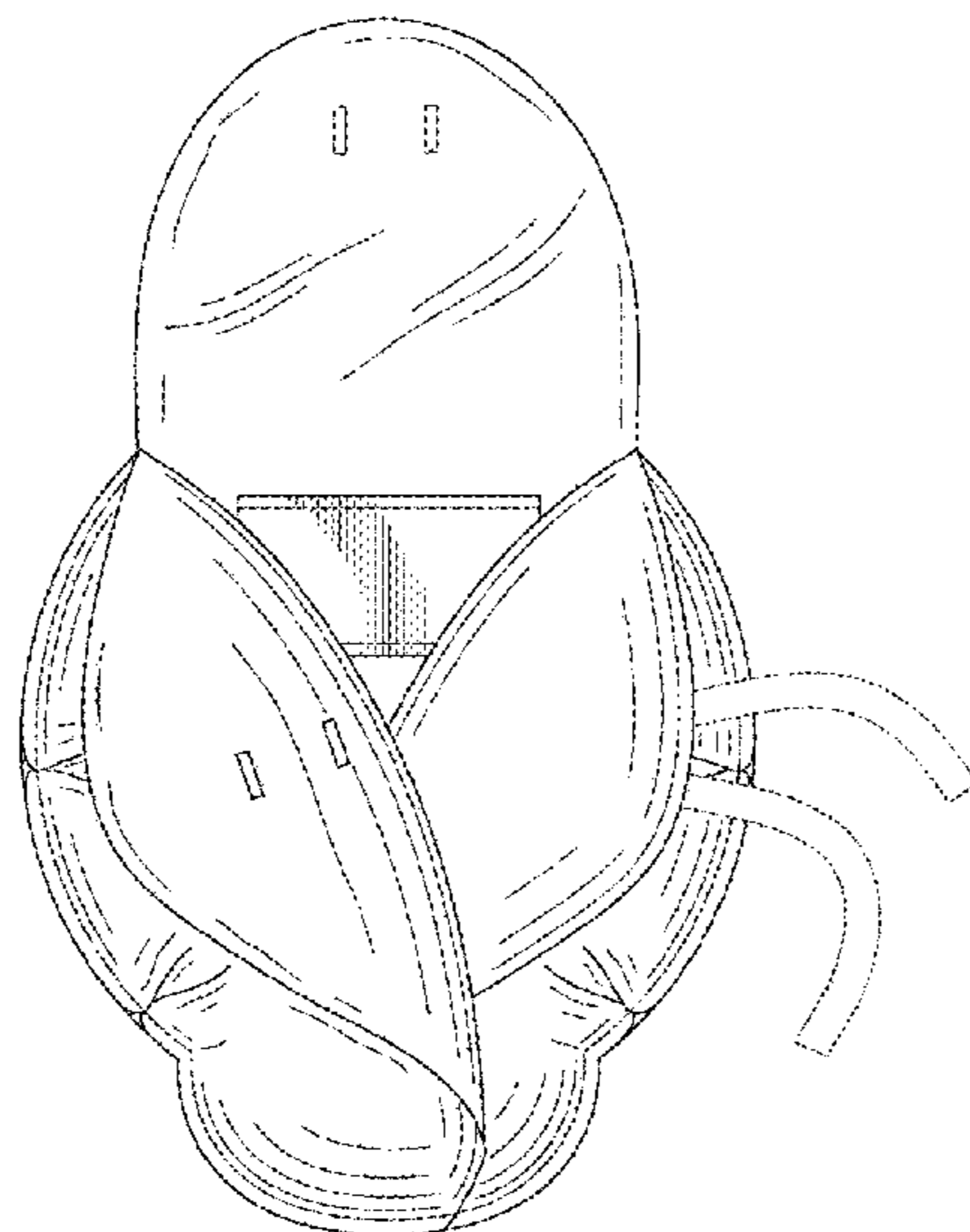
The ornamental design for a pet burial or cremation bag, as shown and described.

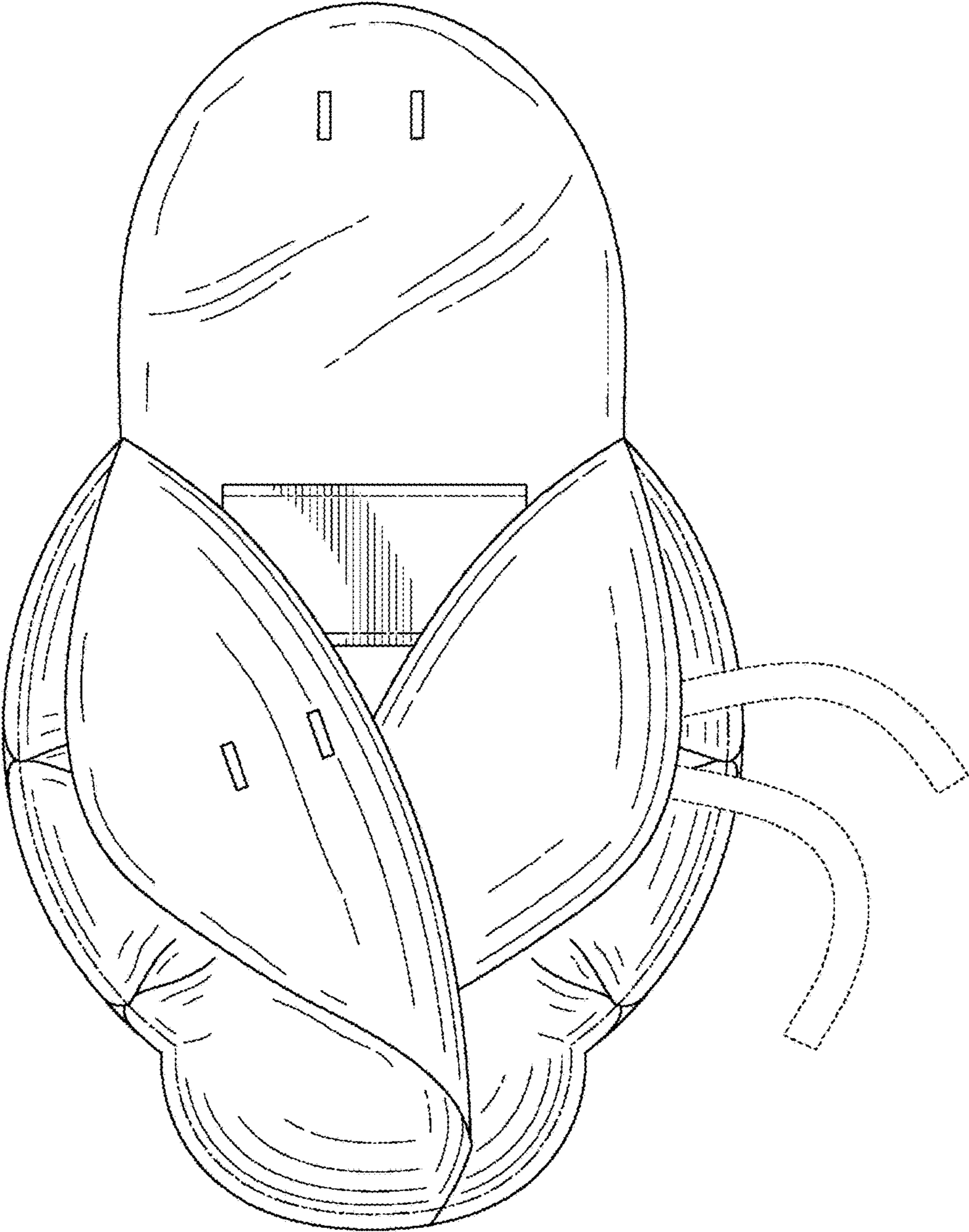

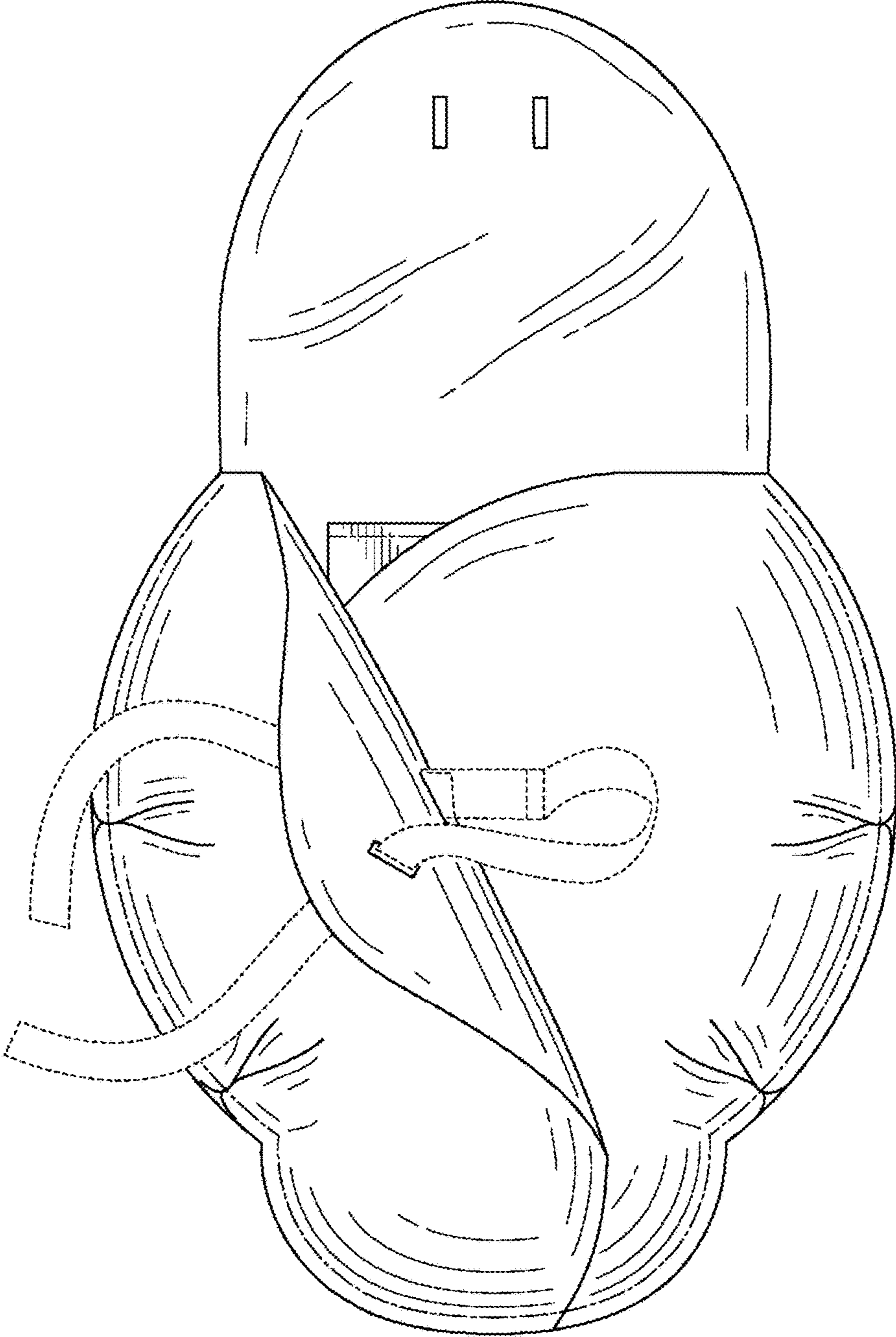

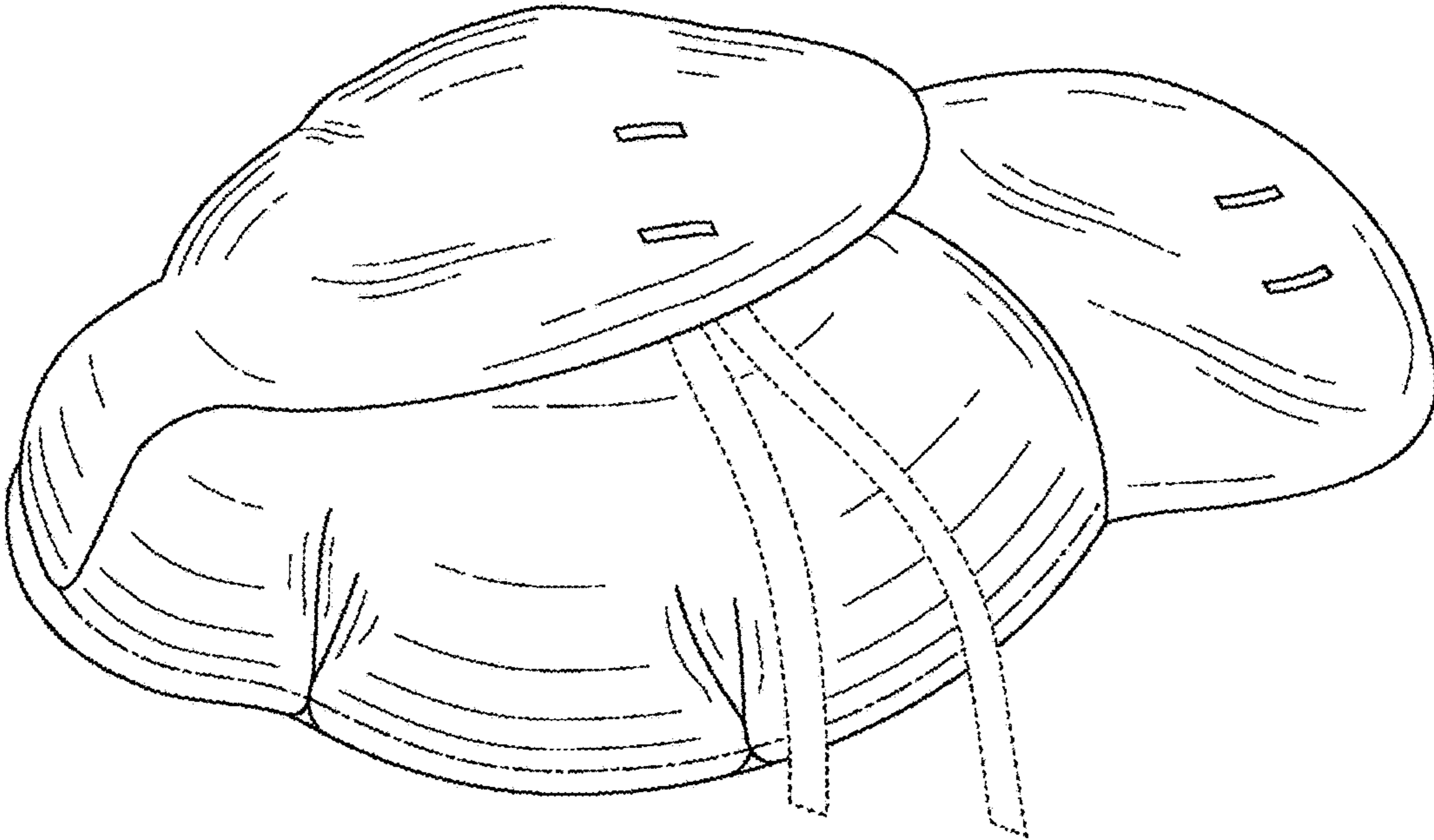

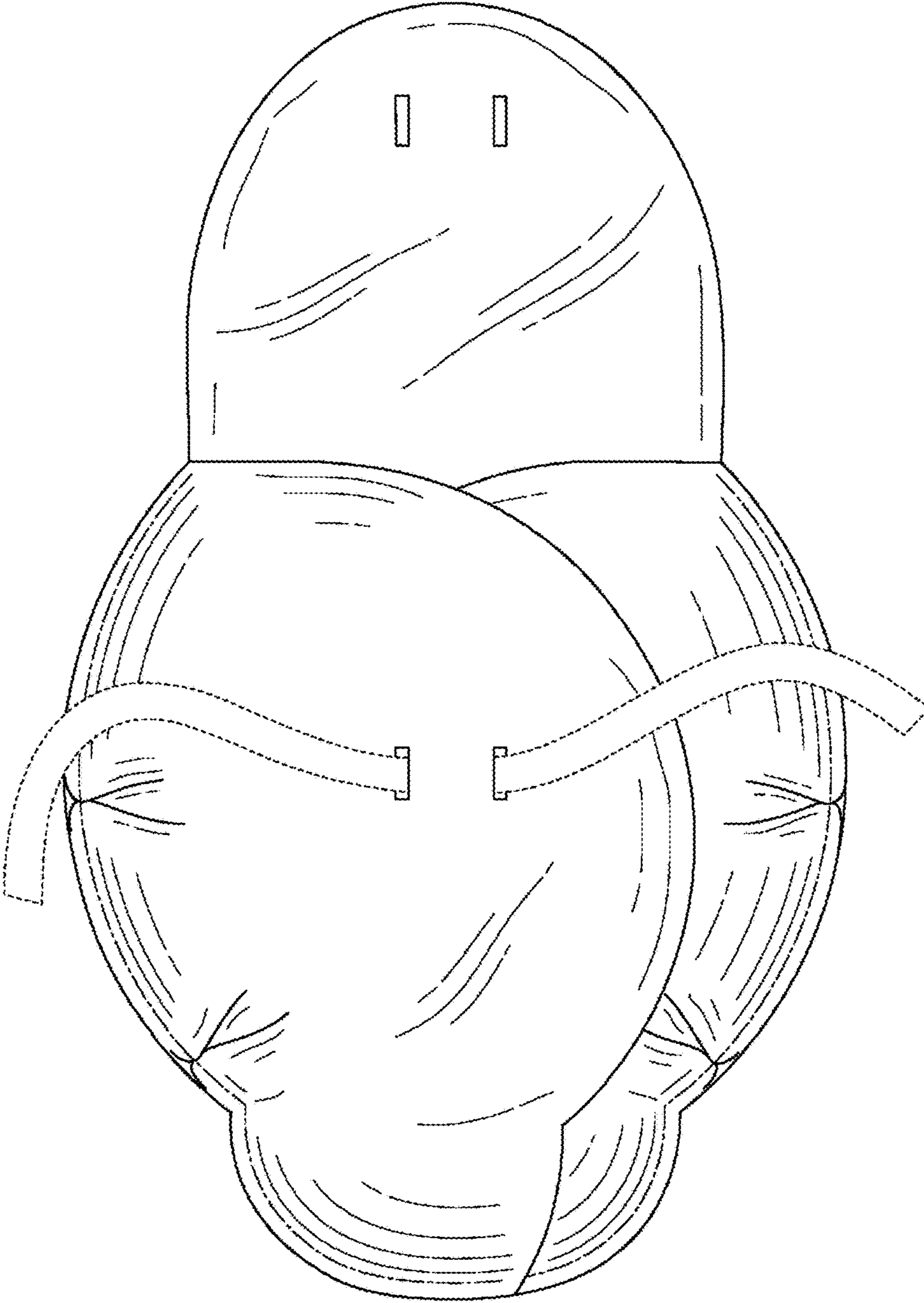

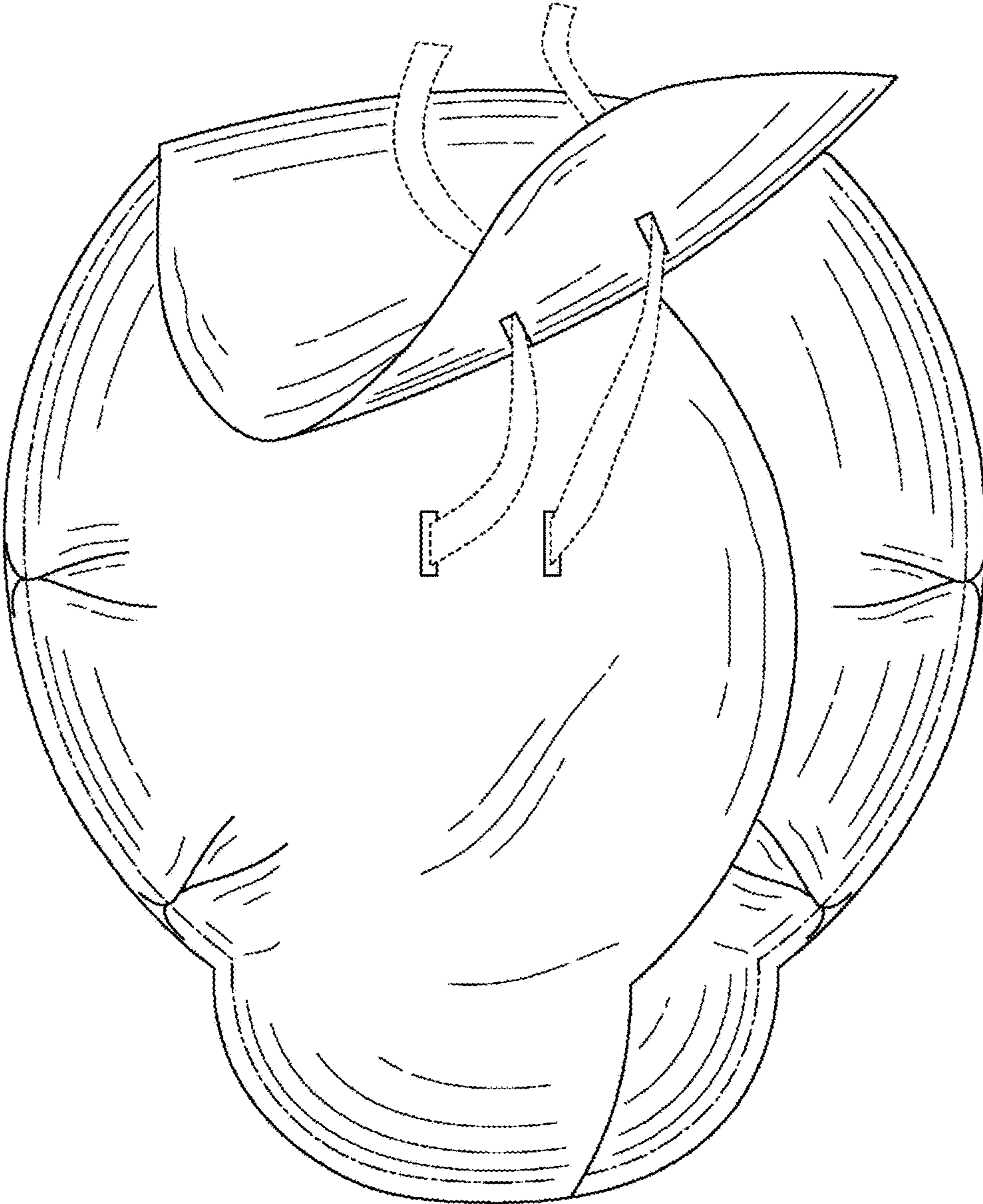

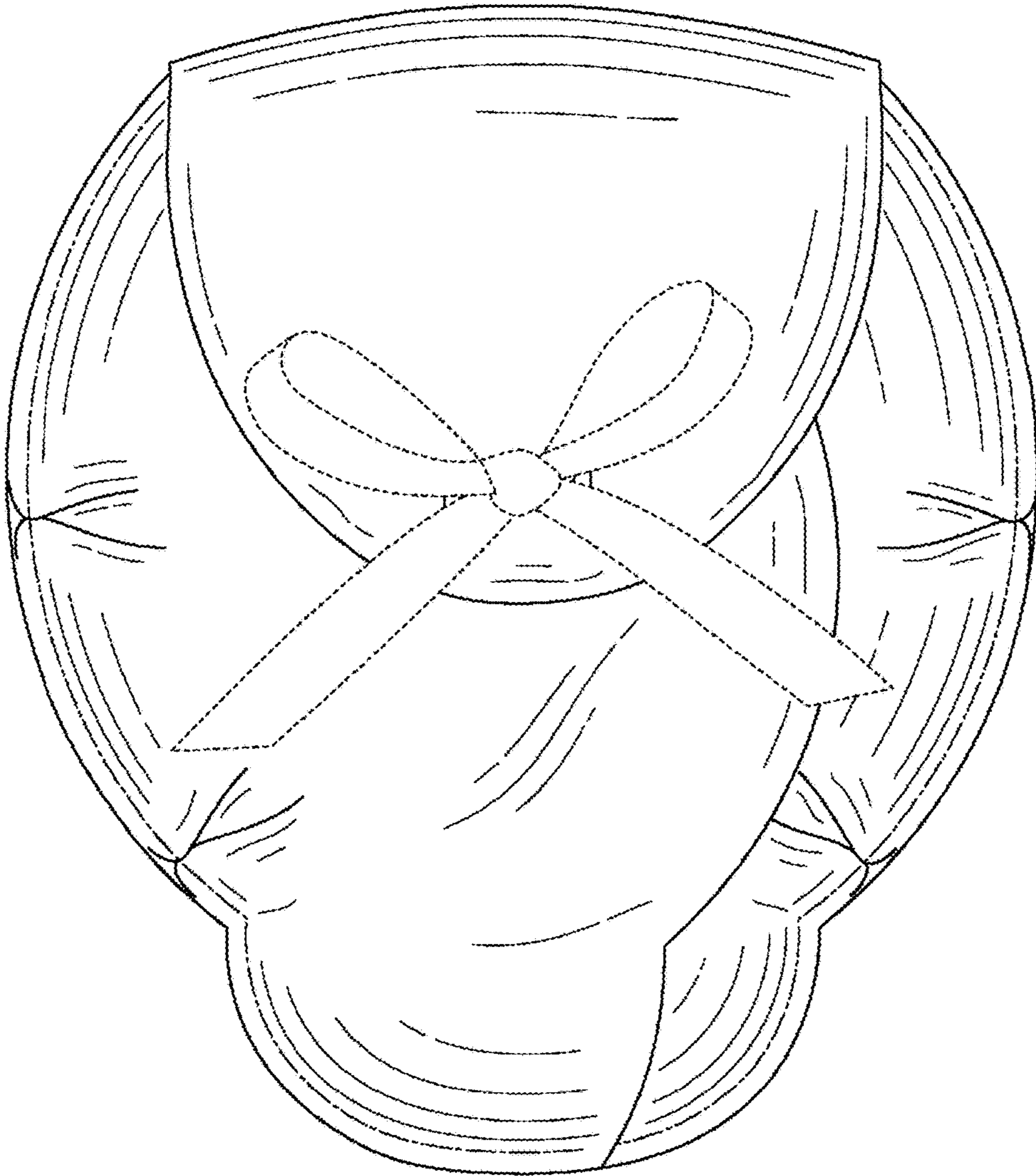
