FIG. 2 is an alternate front perspective view thereof.

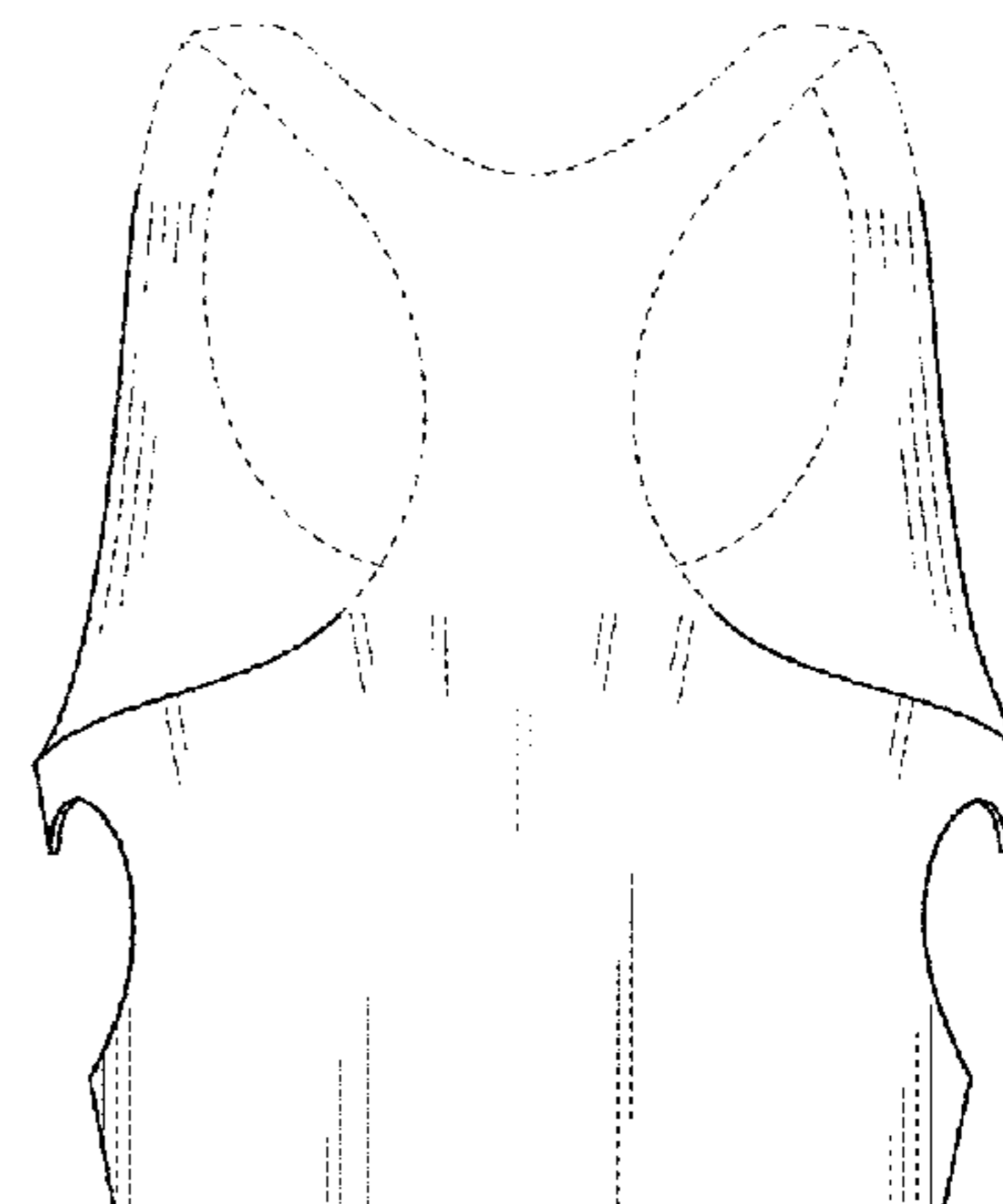
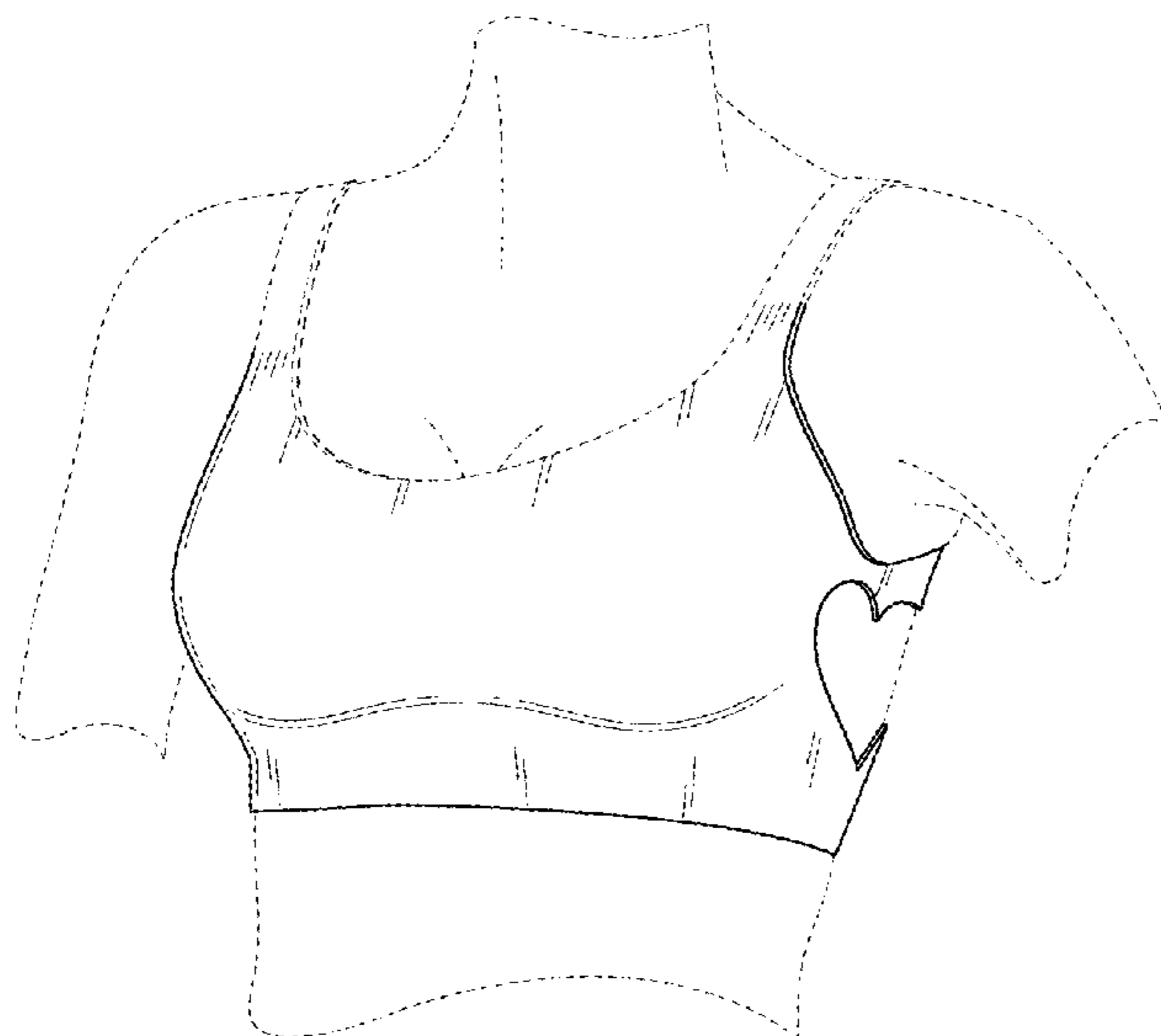
FIG. 3 is a side view without environment.

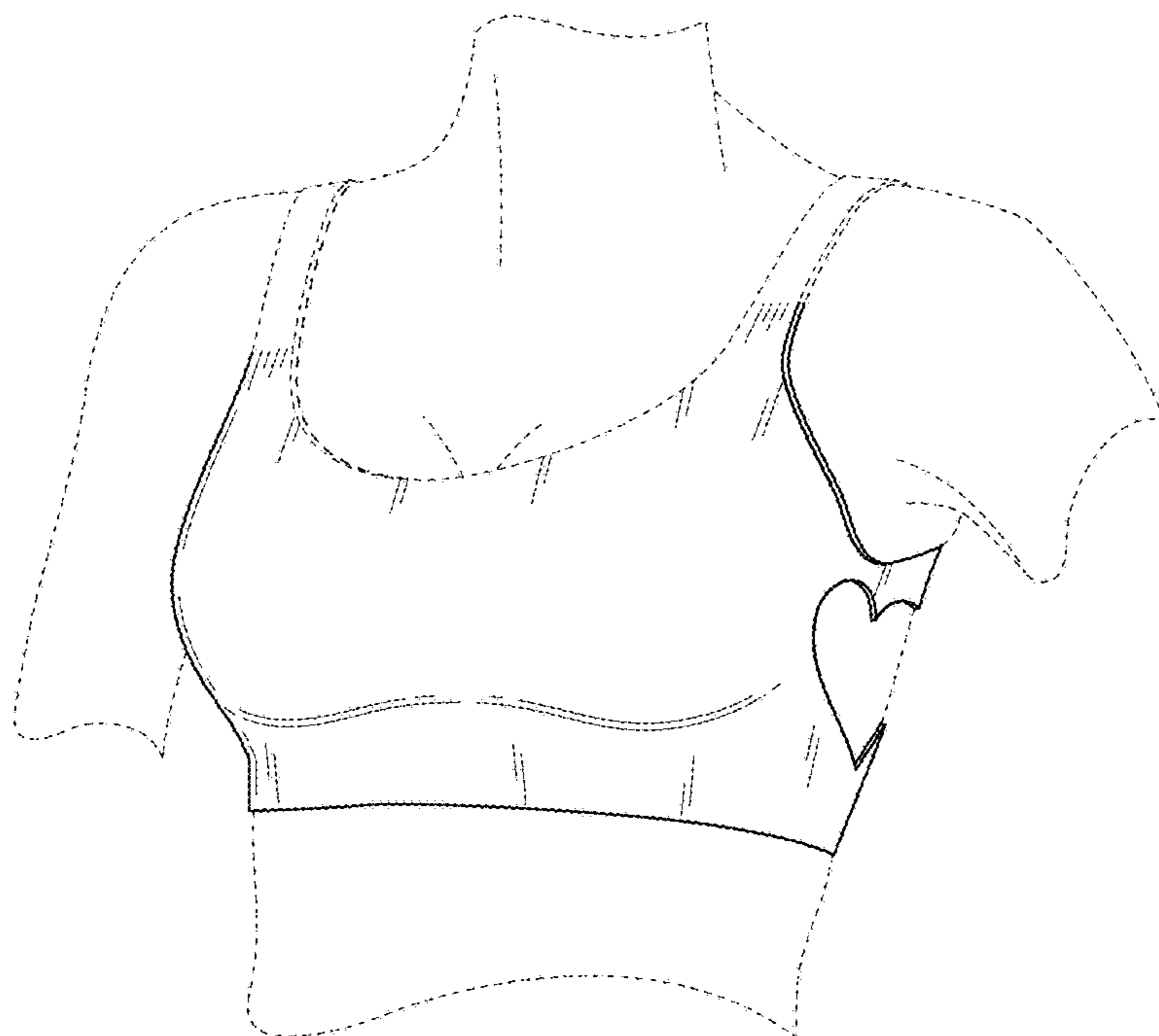

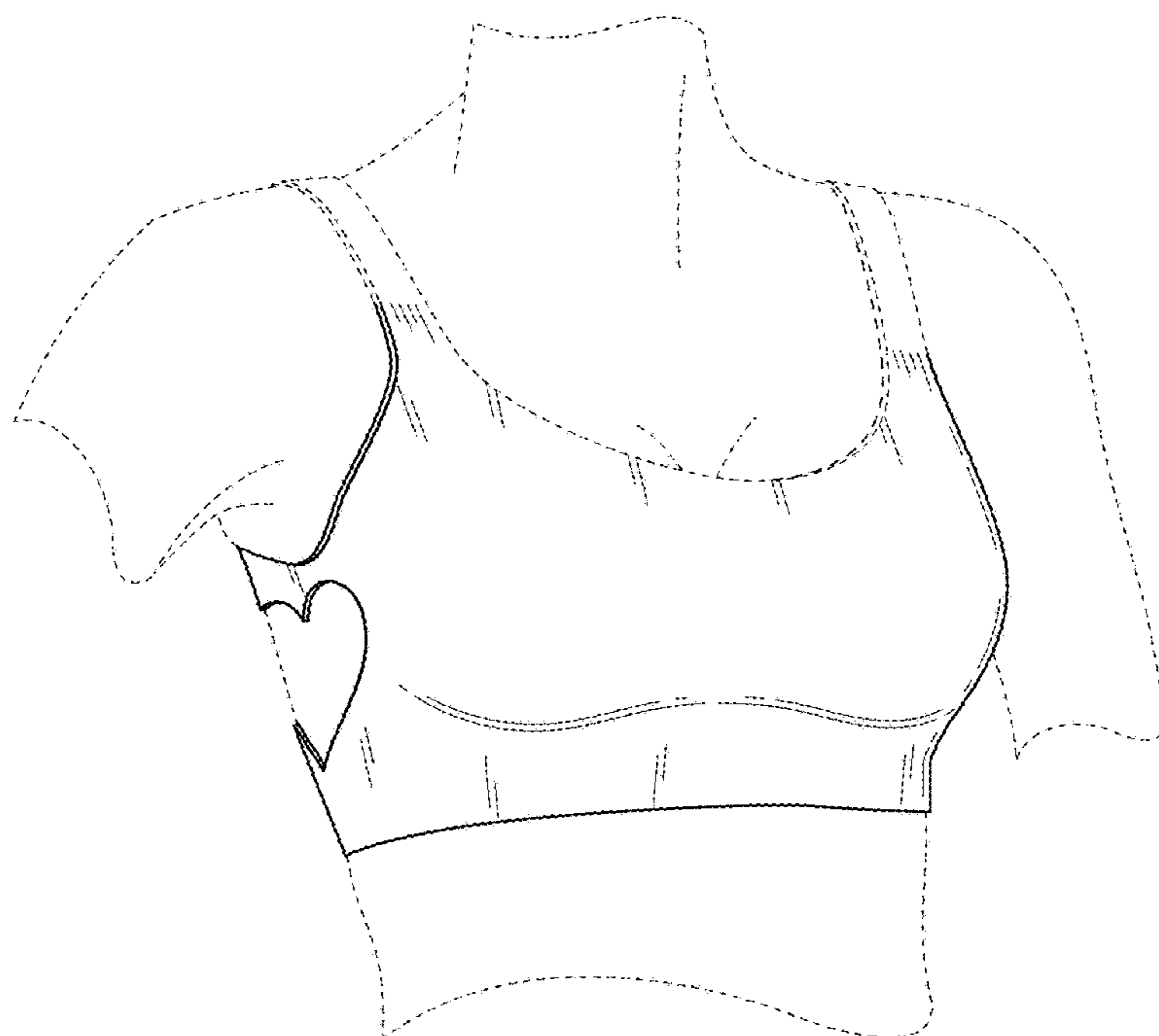

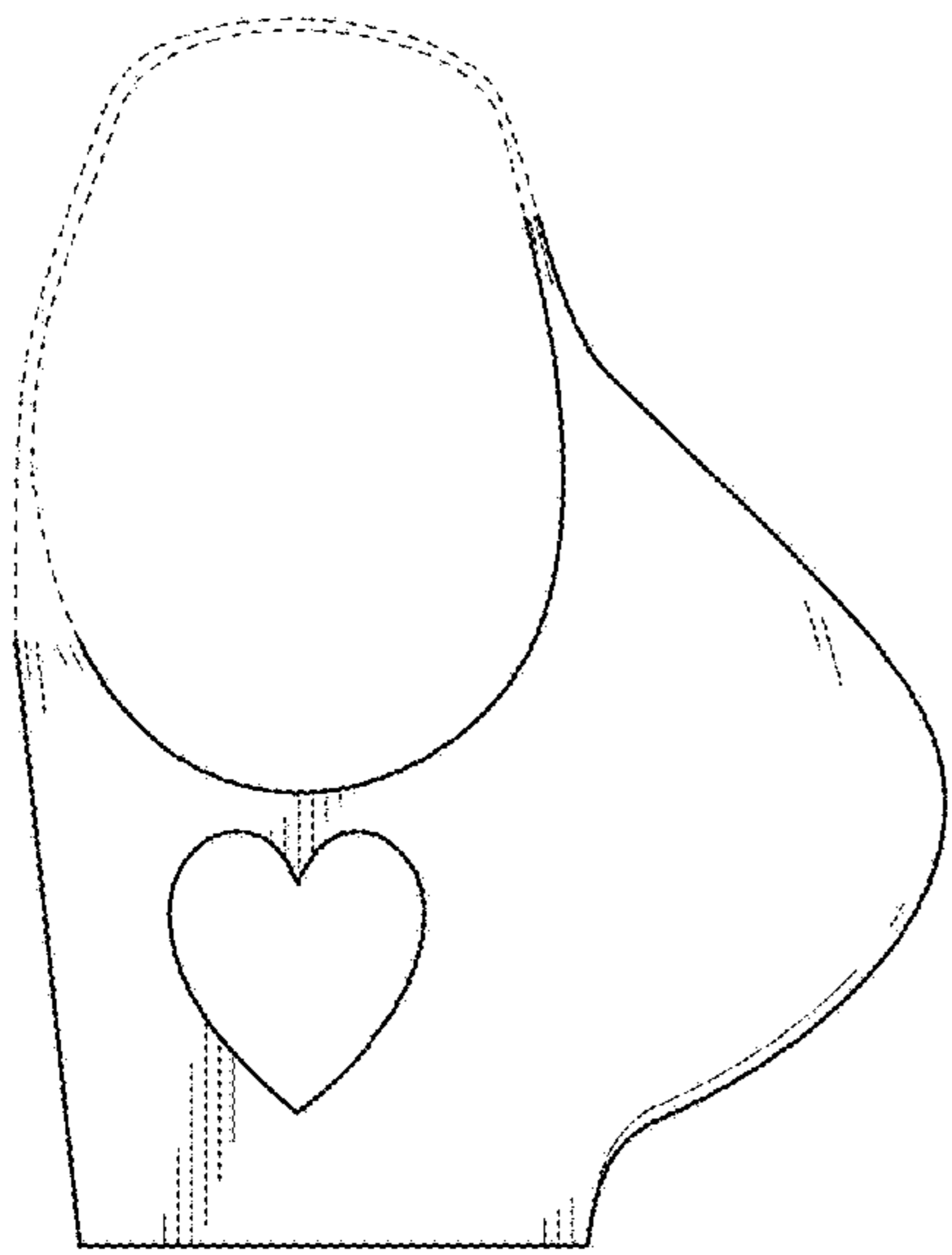

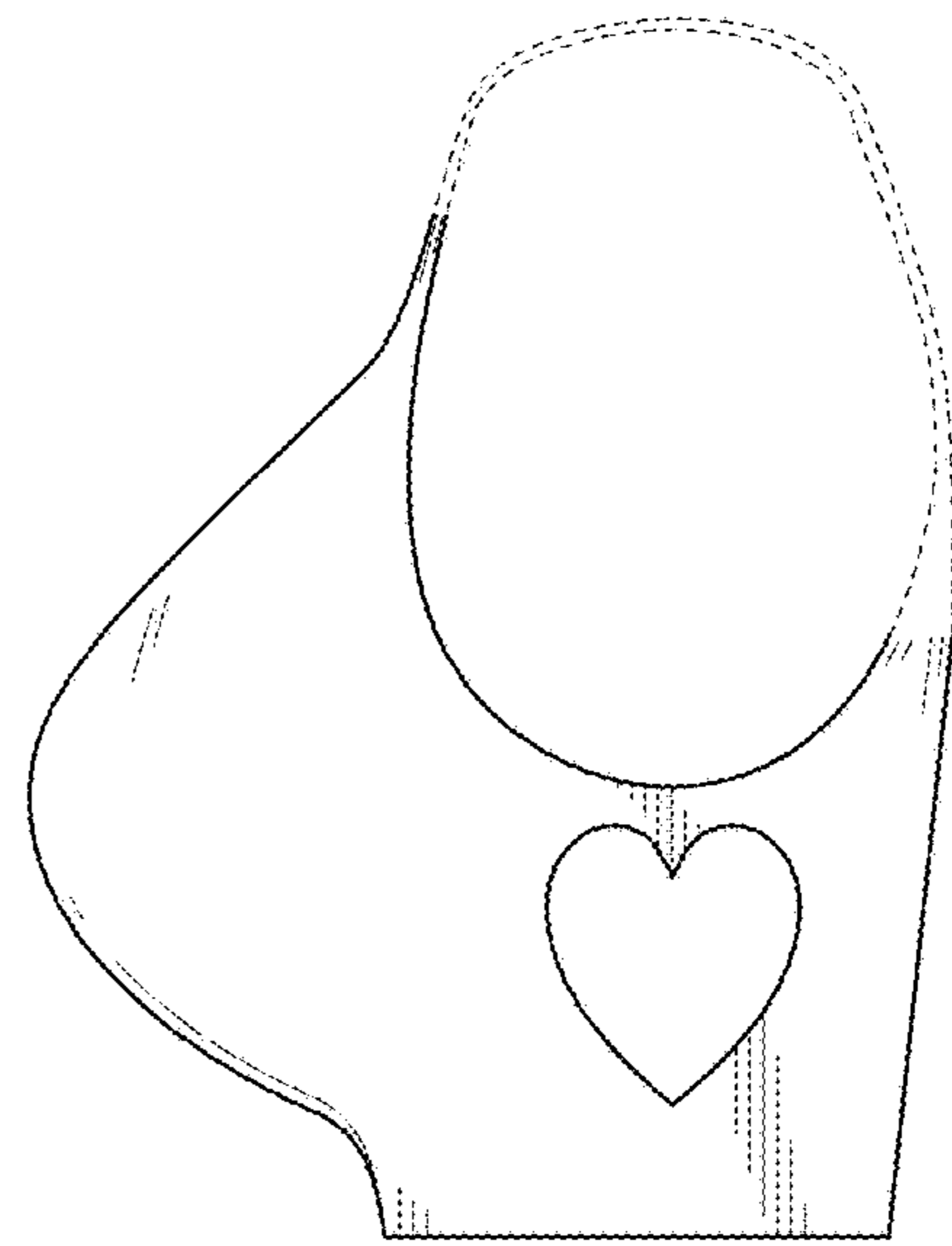

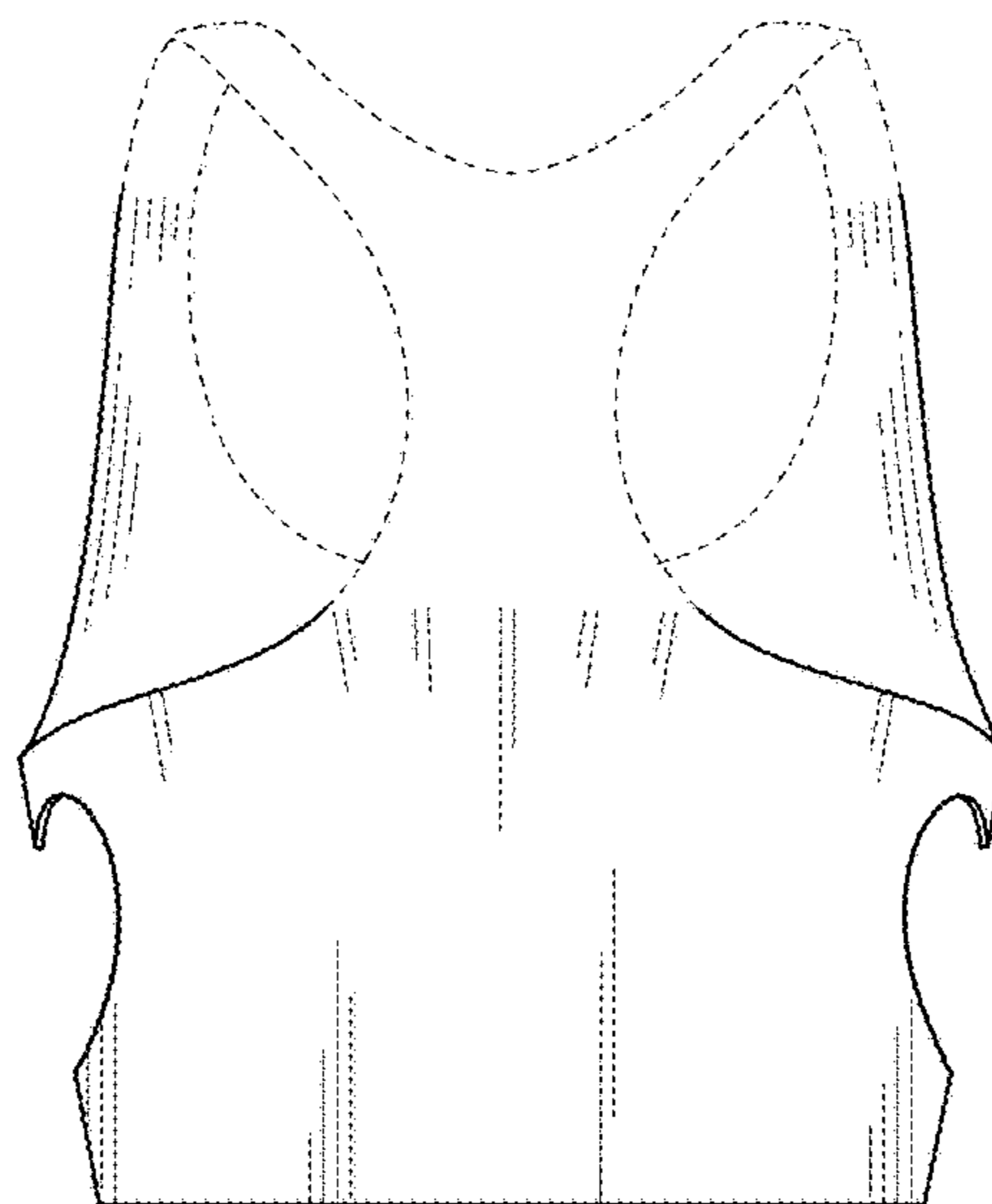
