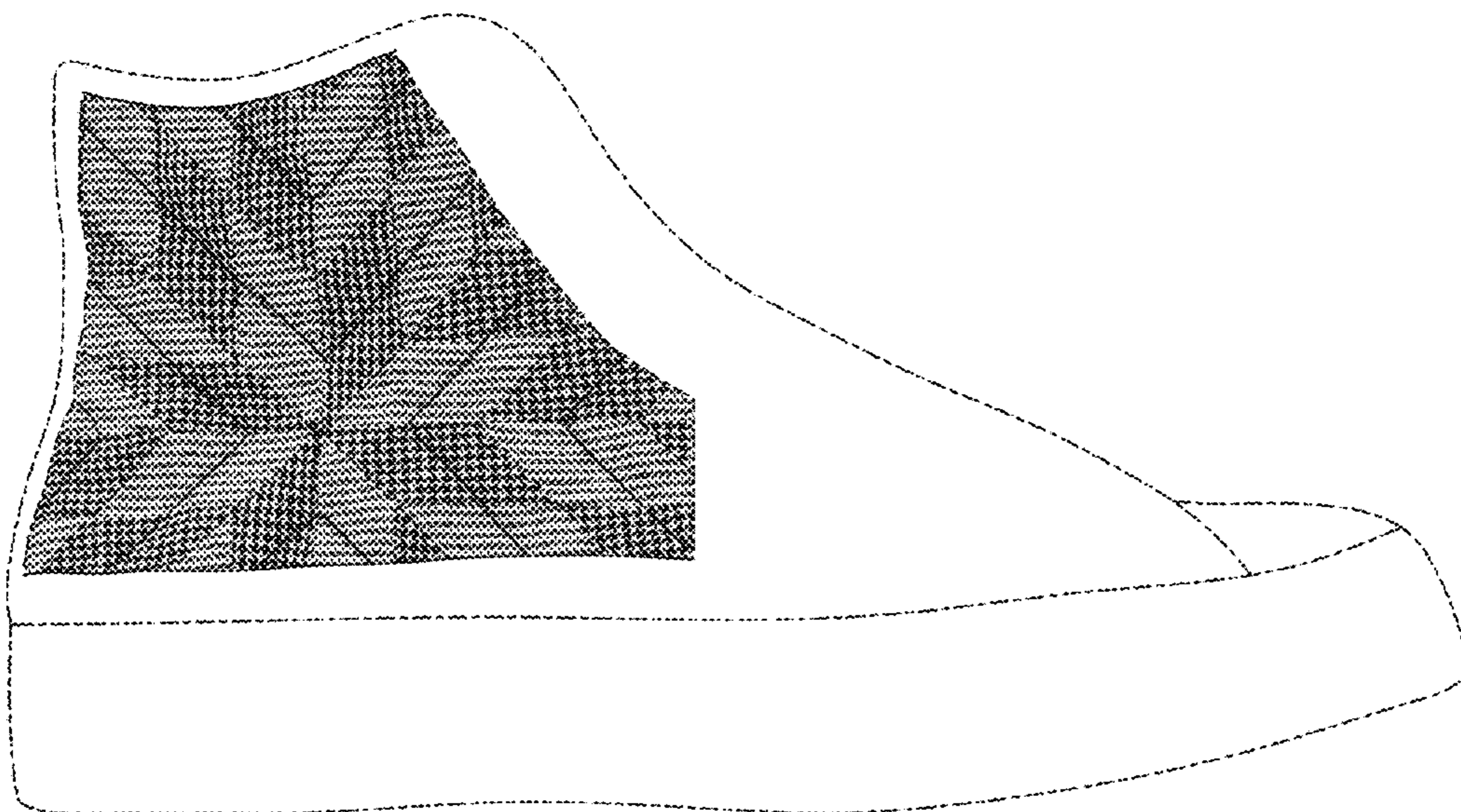
(57) **CLAIM**

The ornamental design for a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a front photographic perspective view of a shoe upper showing my new design; FIG. 2 is a photographic side view thereof; FIG. 3 is a photographic rear perspective view thereof; and, FIG. 4 is a photographic rear view thereof.
A greyscale photographic area is shown in the drawings. The broken lines immediately adjacent to the photographic area represent unclaimed boundaries of the design. The lack of a broken or solid line immediately adjacent to the photographic area indicates a claimed edge of the design. The broken lines showing the remainder of the shoe represent unclaimed subject matter and form no part of the claimed design.

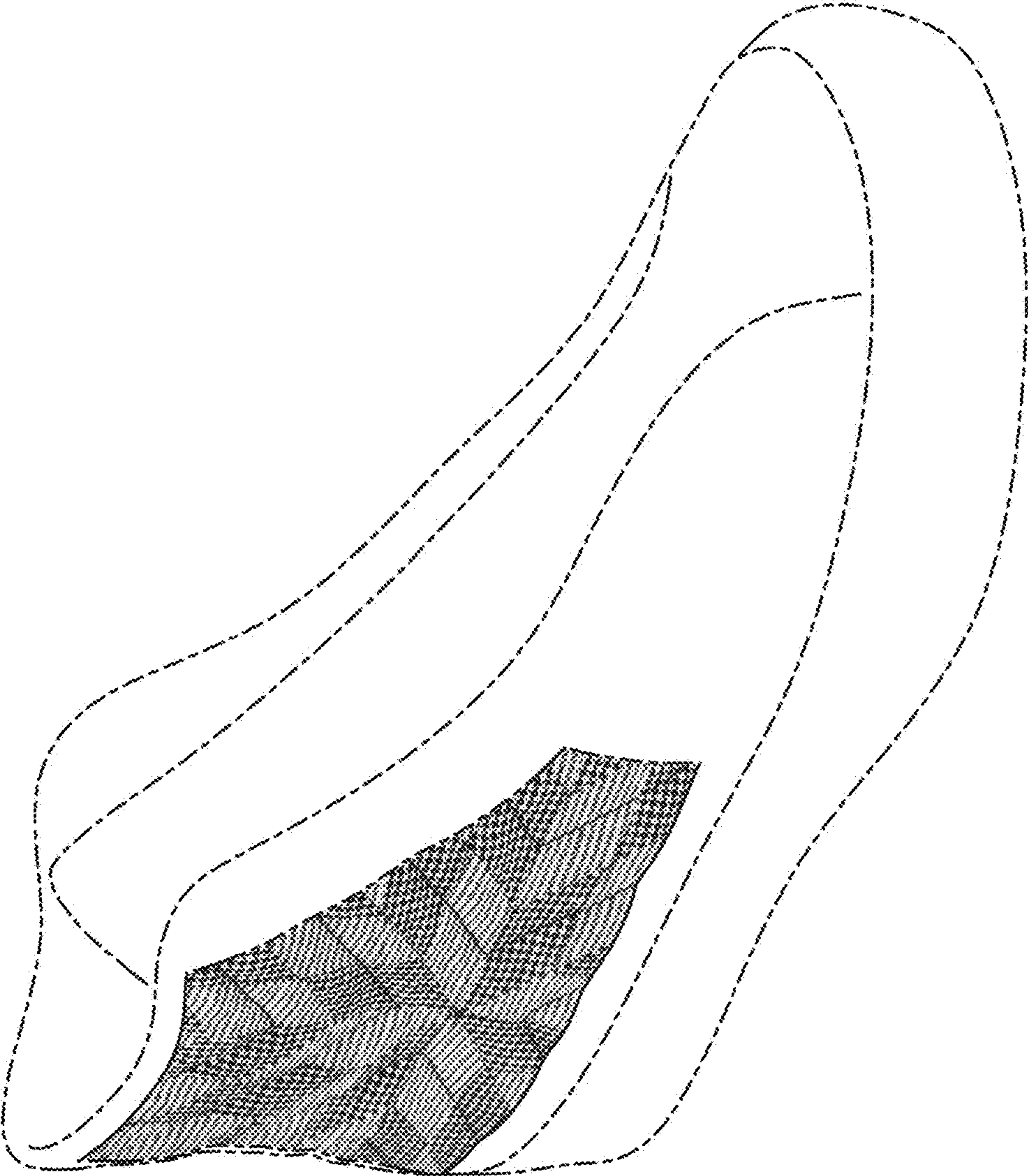

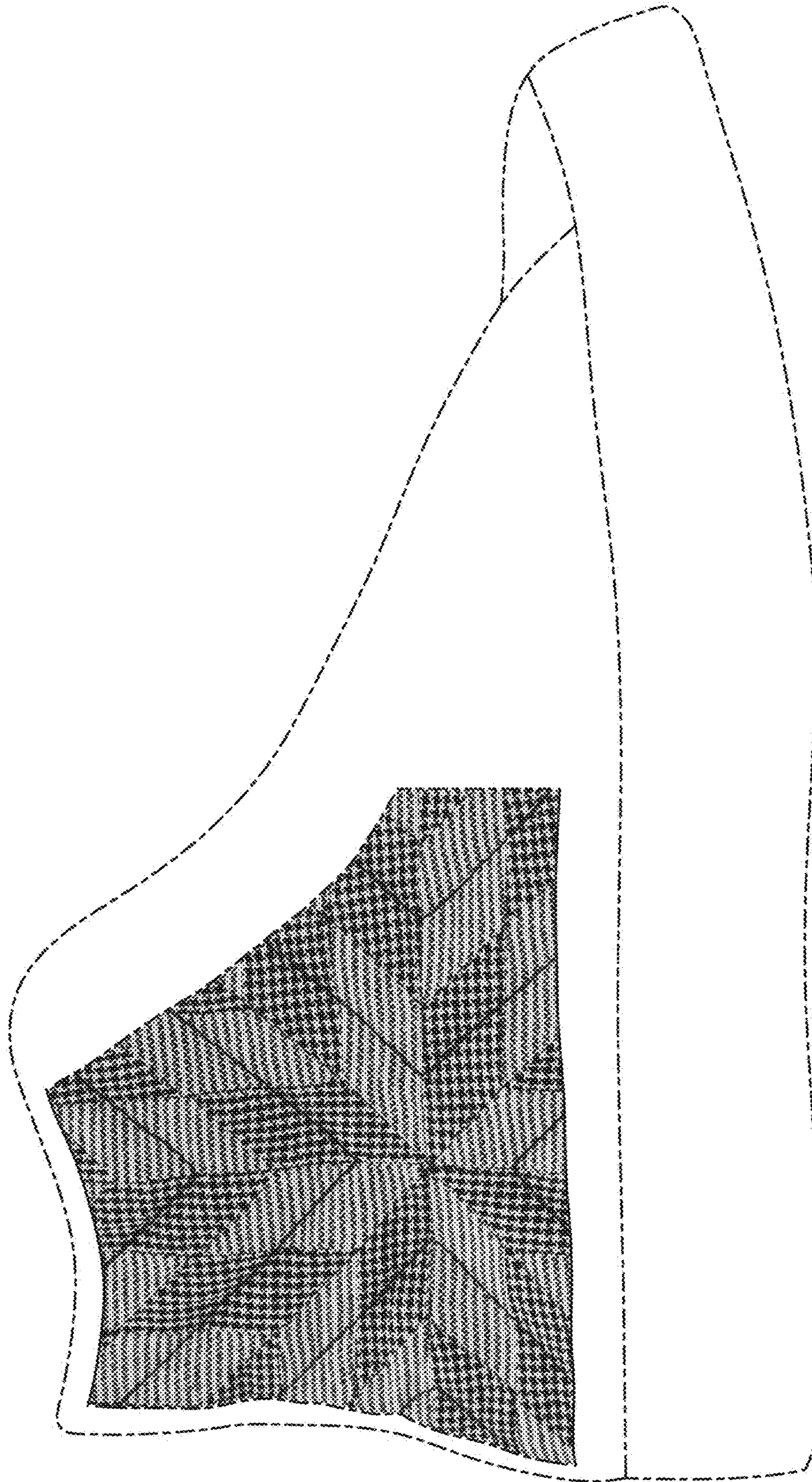

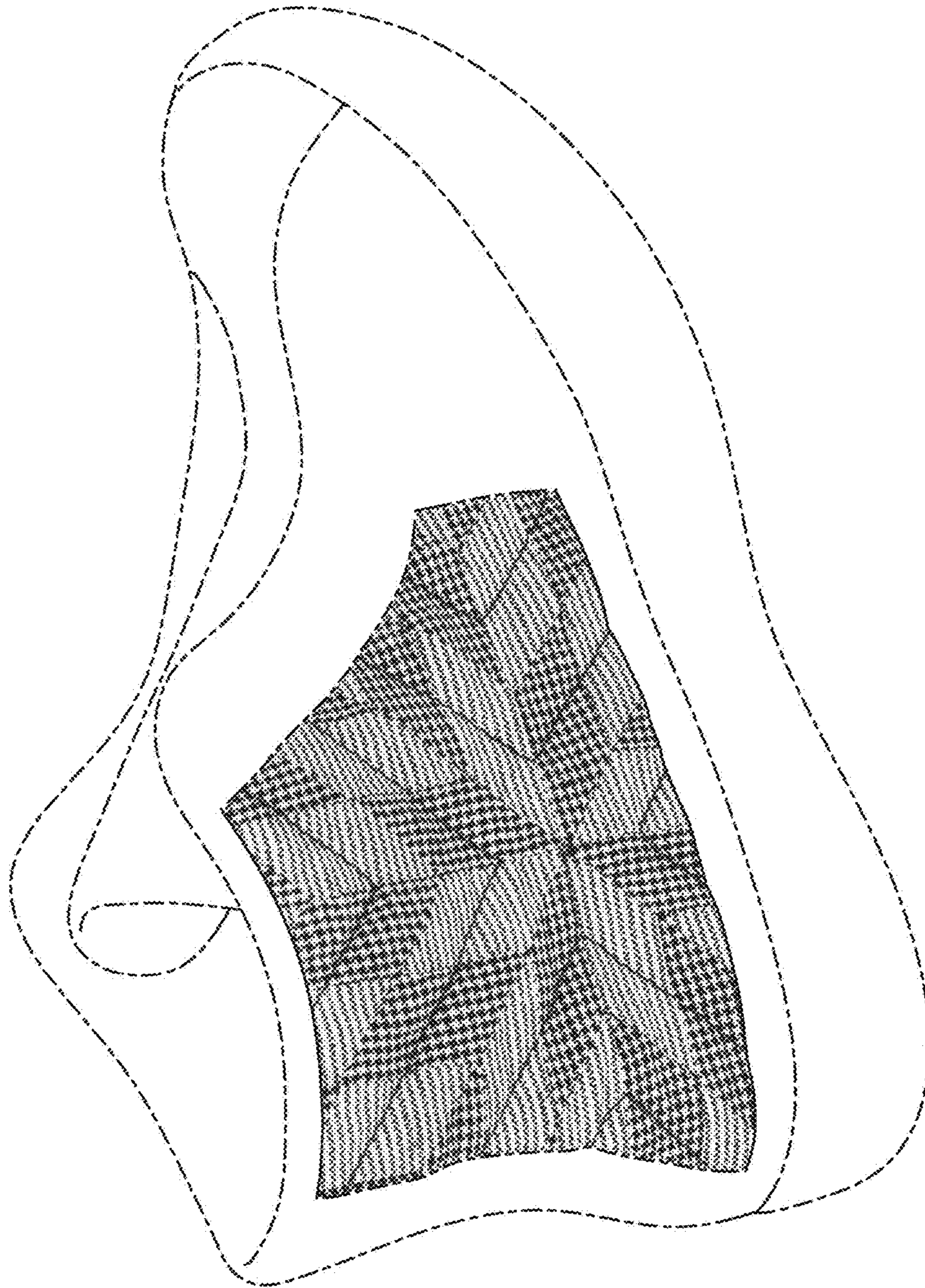

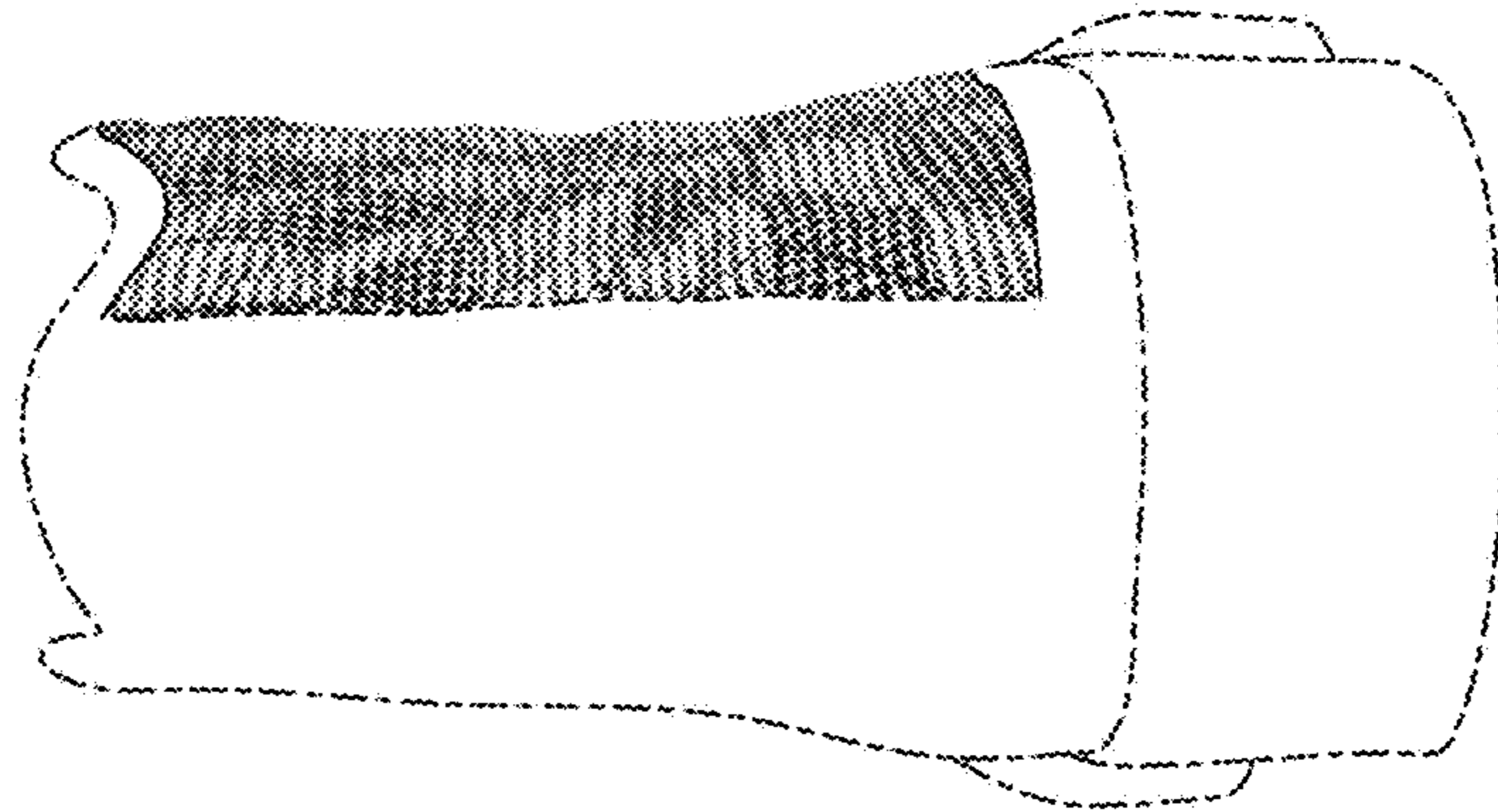
