The ornamental design for a pill storage and dispensing container, as shown and described.

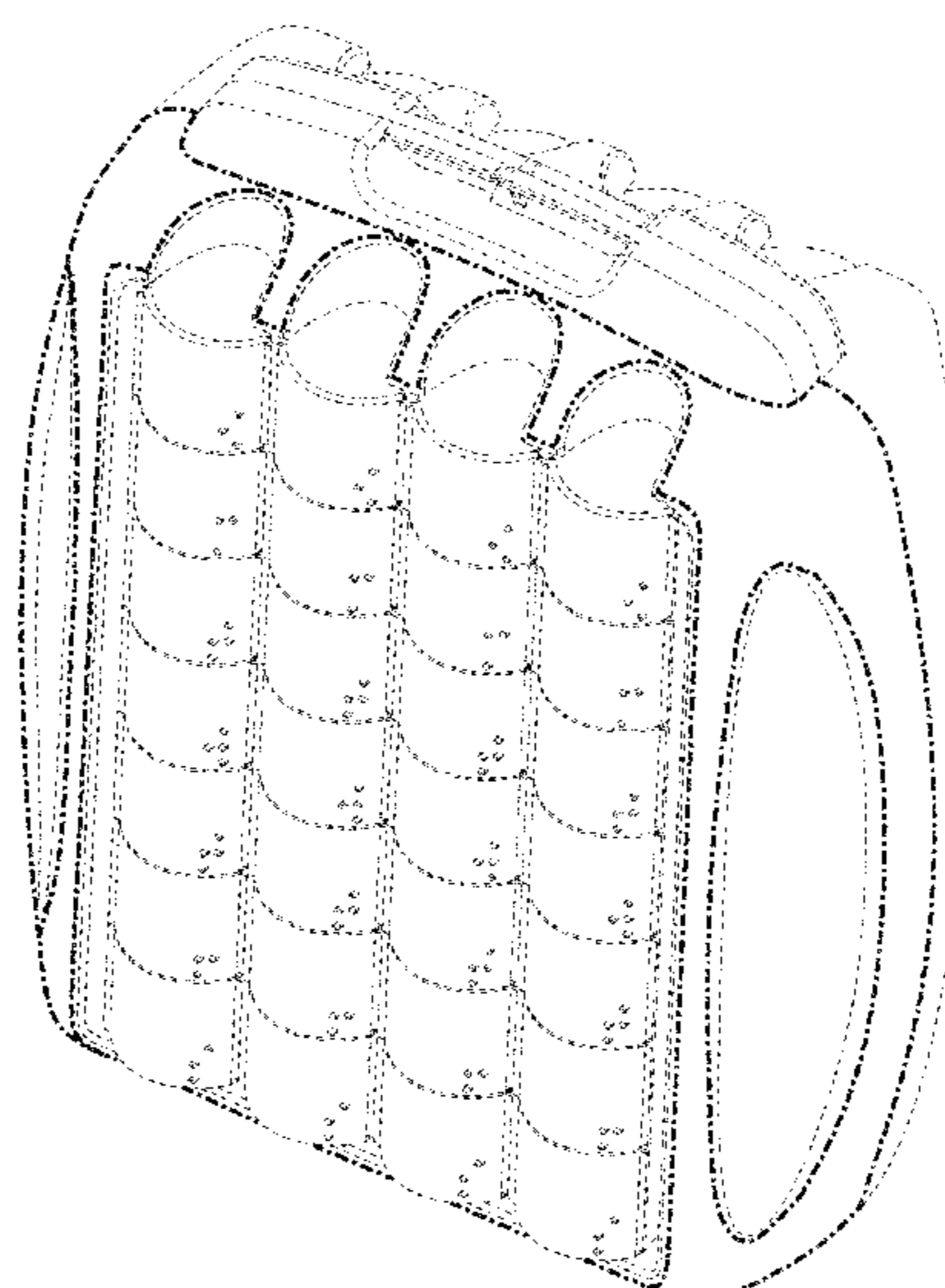
DESCRIPTION

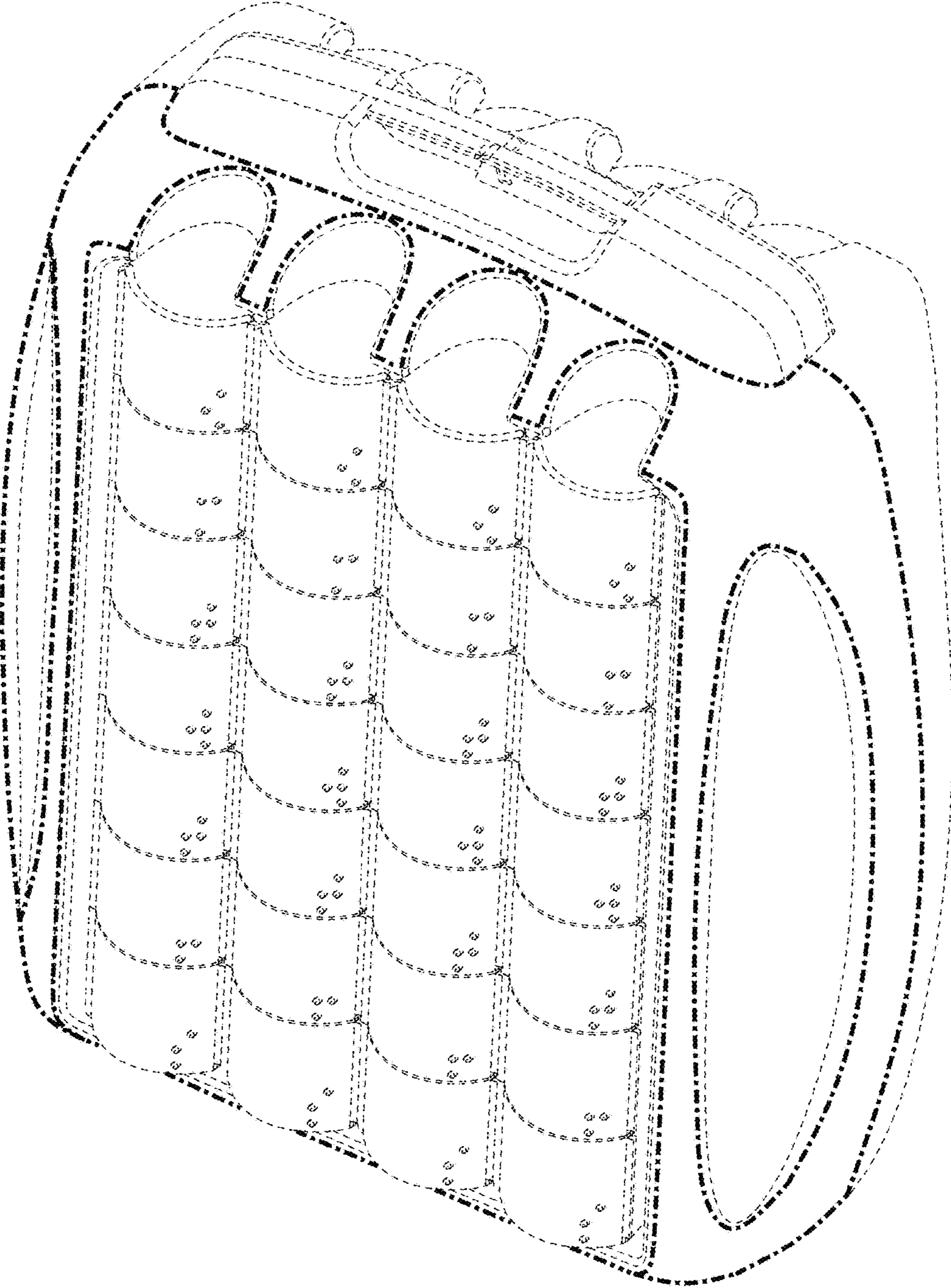

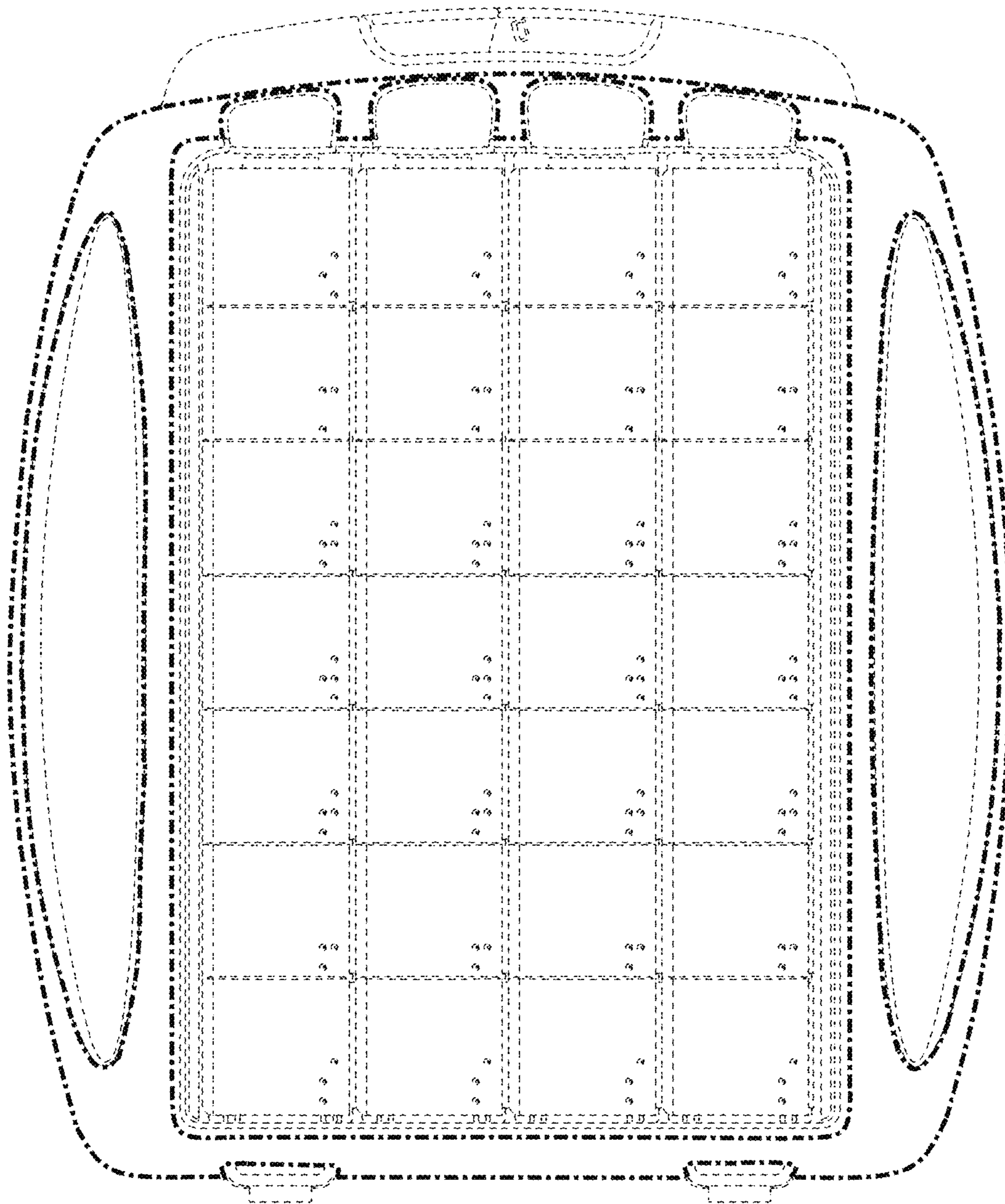

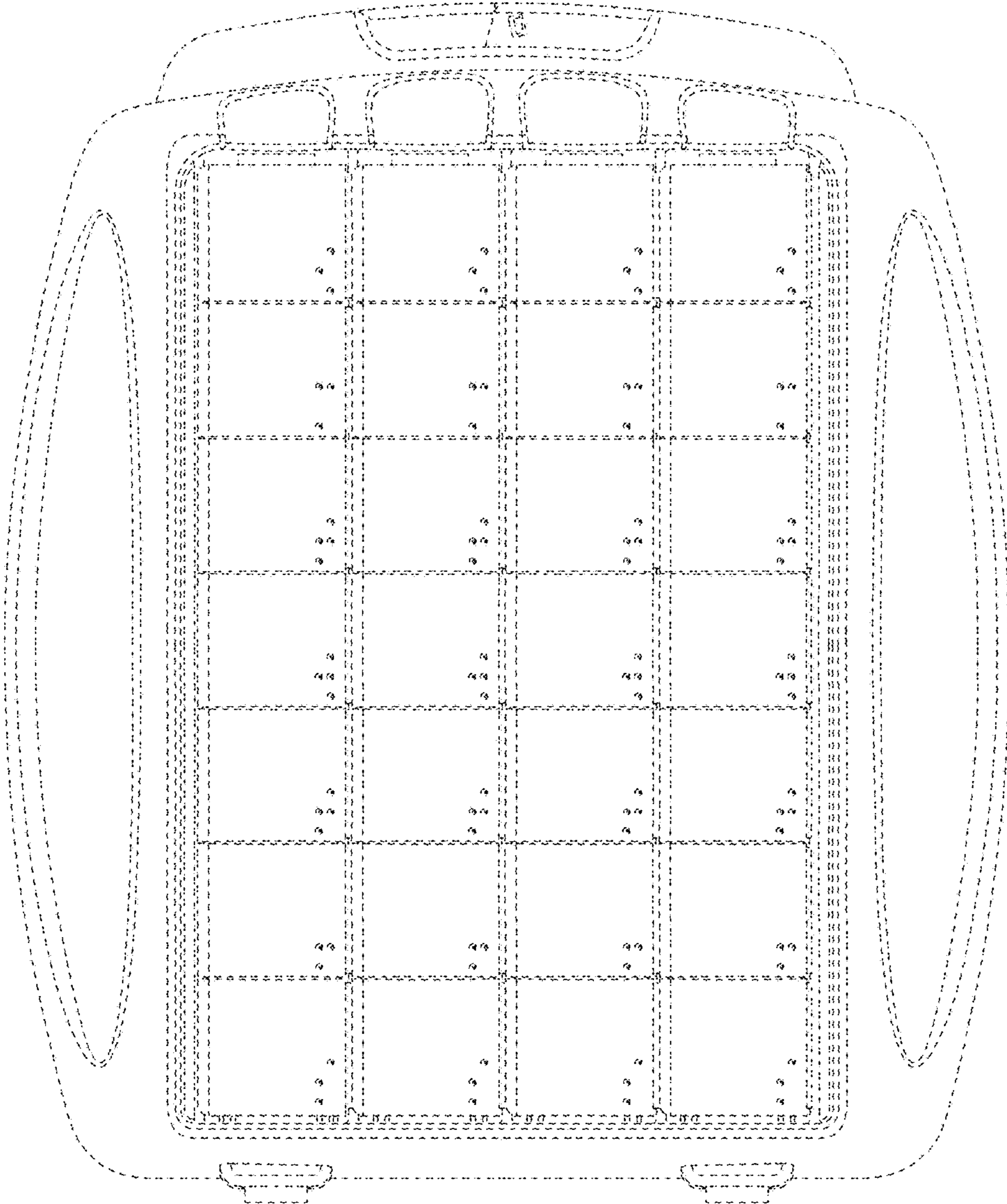

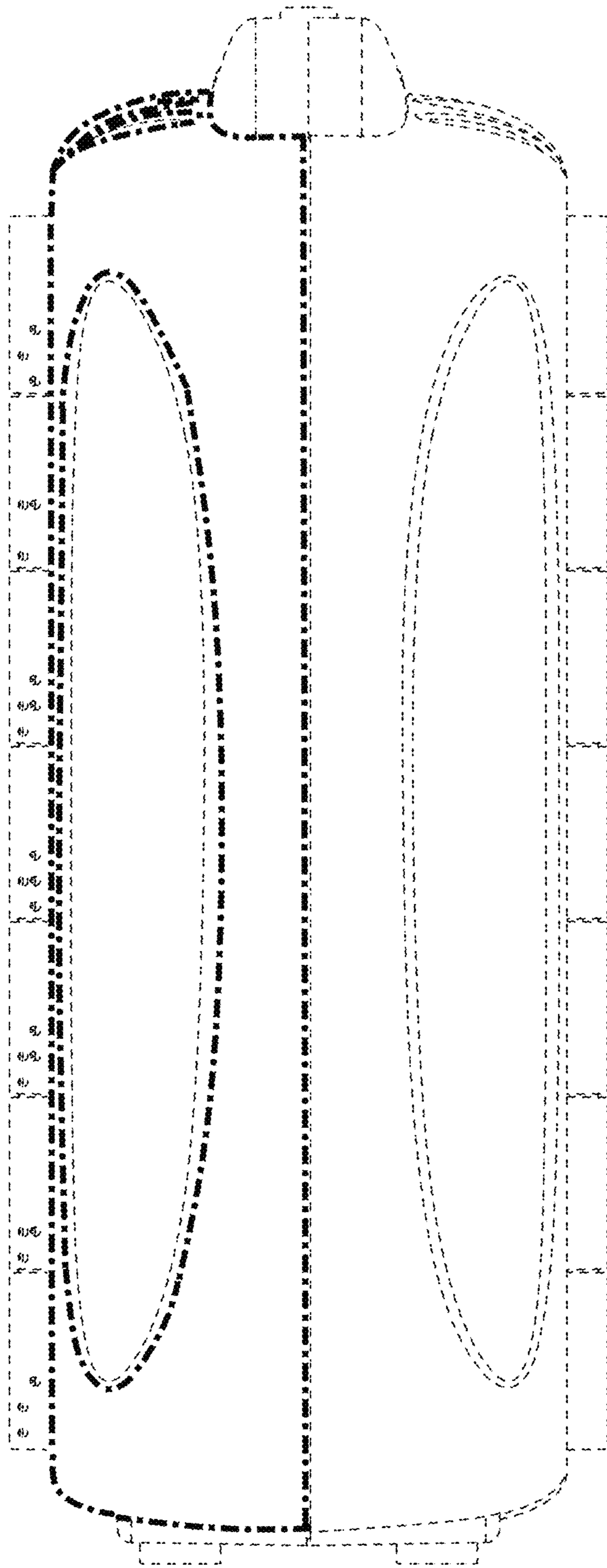

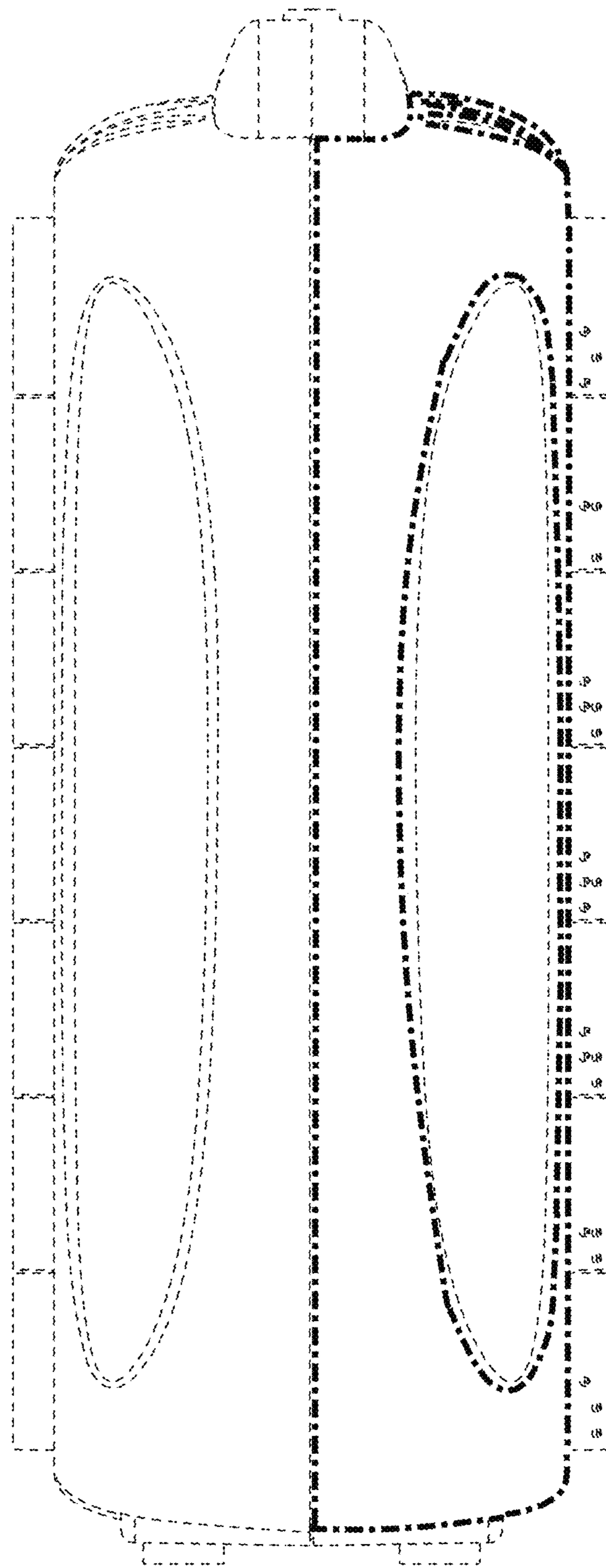

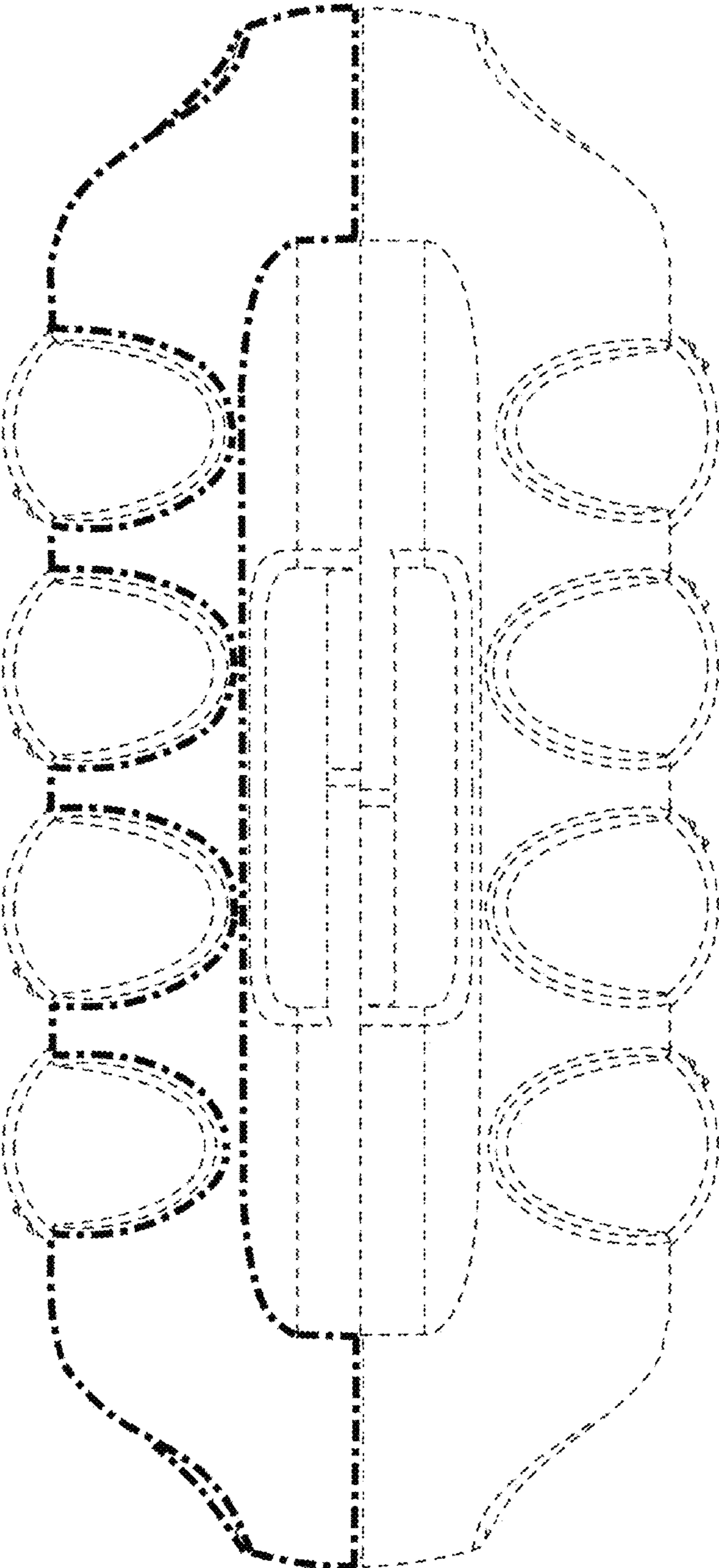

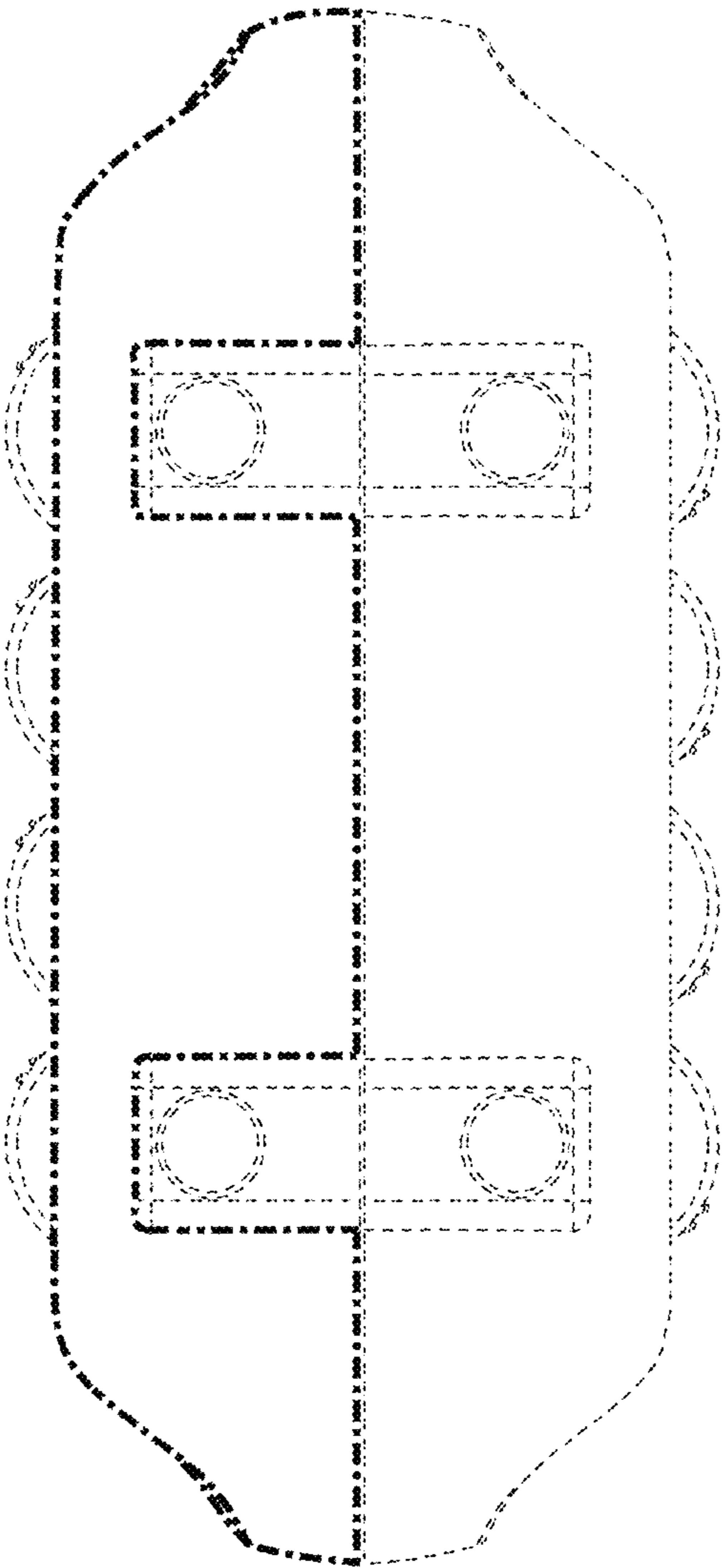
