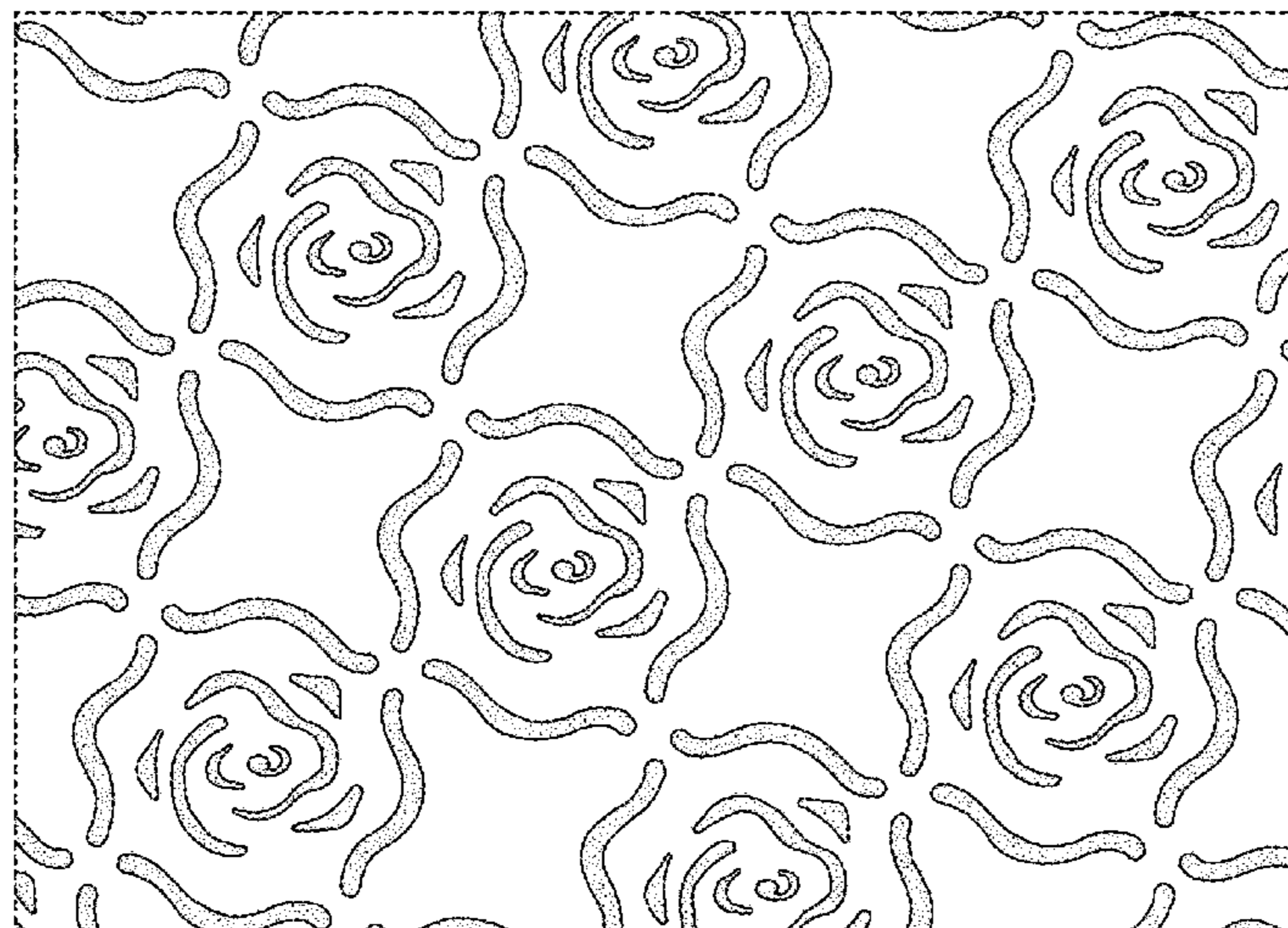
The ornamental design for a wipe with surface pattern, as shown and described.

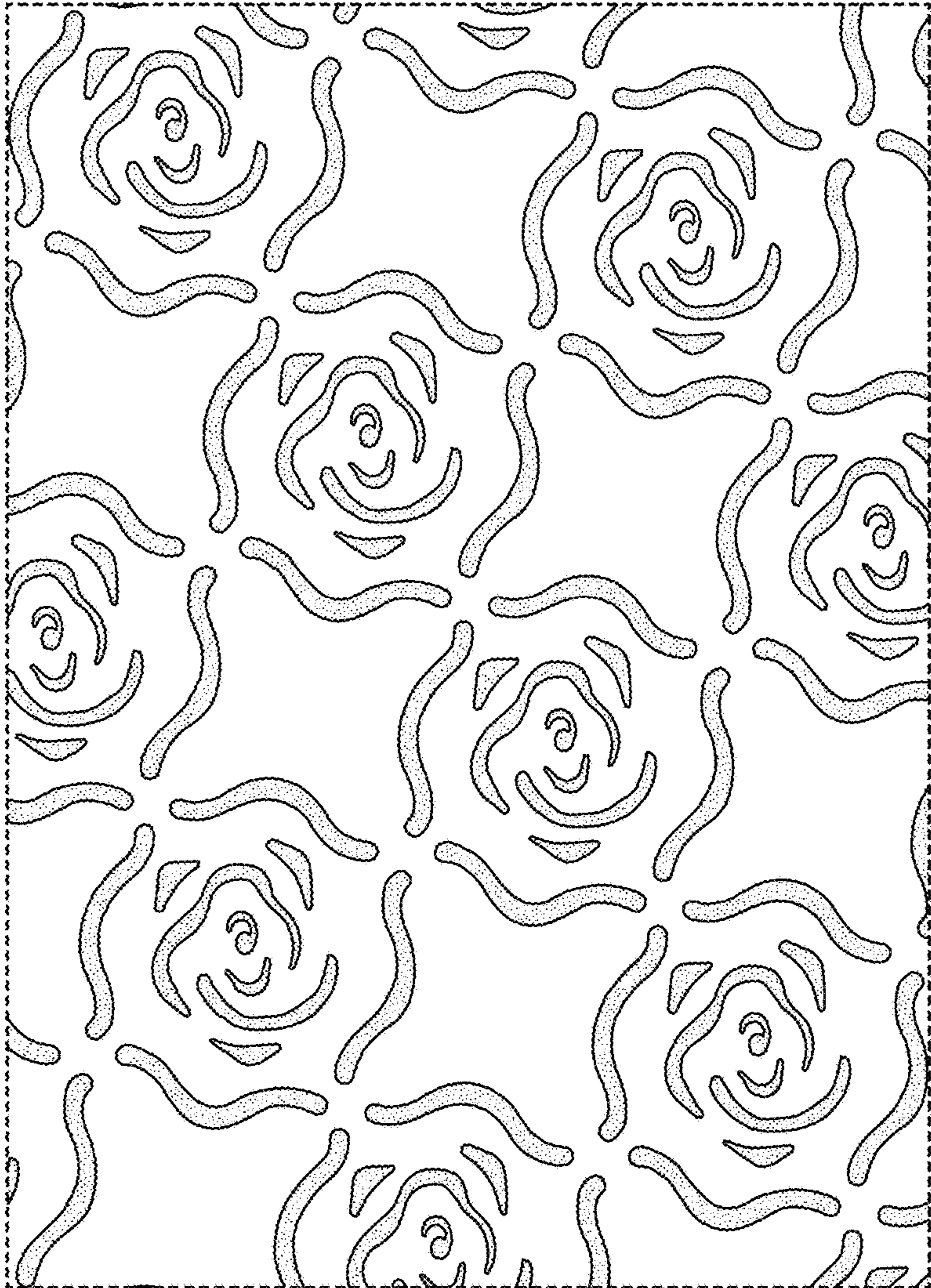

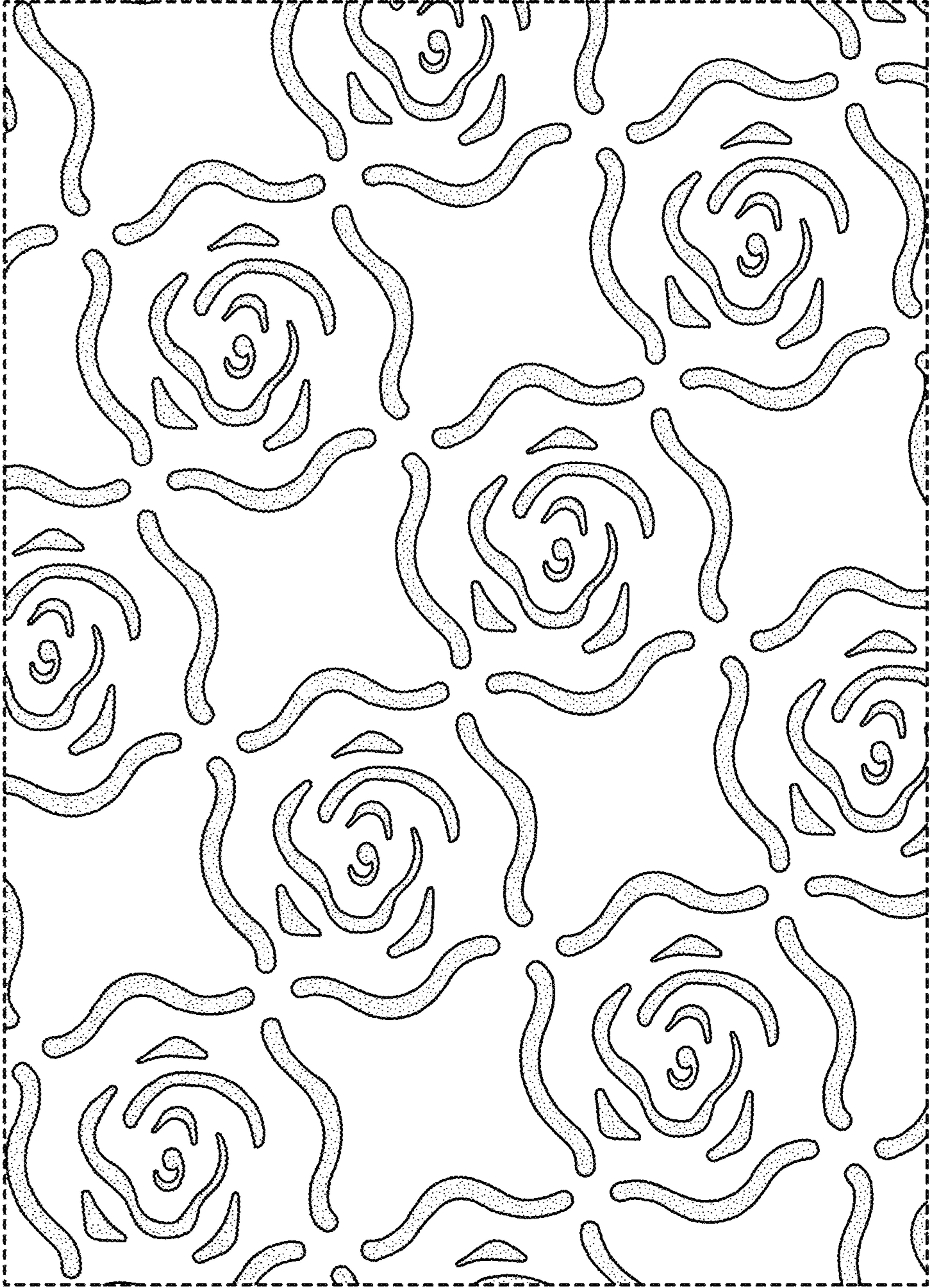

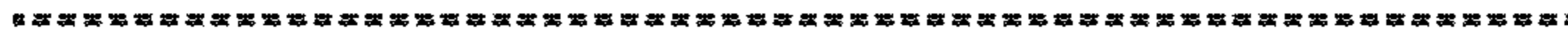

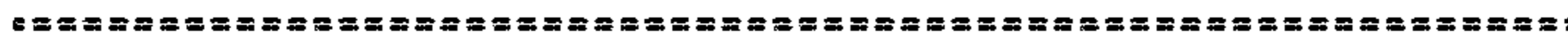
