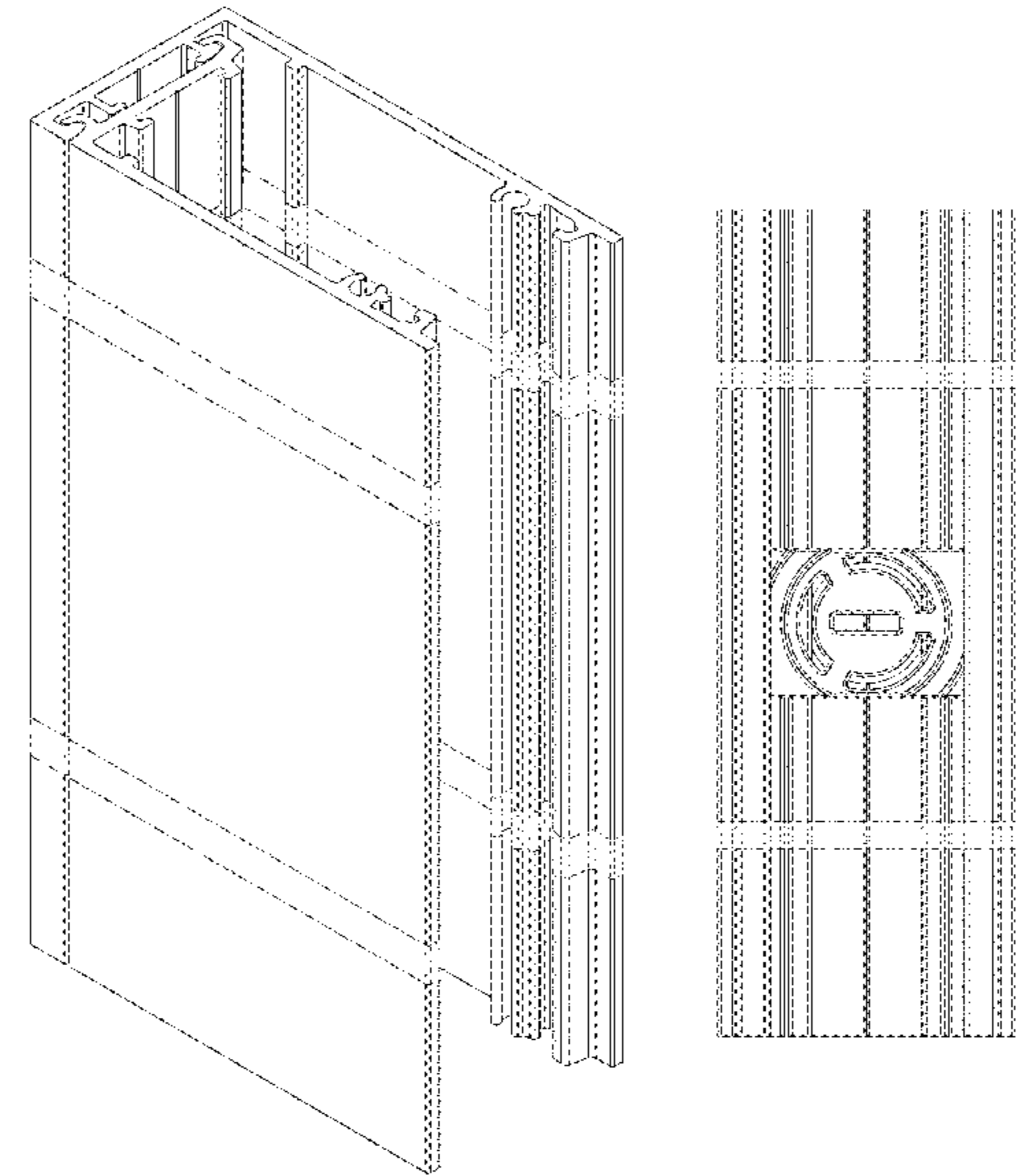

(57) **CLAIM**
The ornamental design for a guide track assembly for a blind system, as shown and described.

DESCRIPTION
FIG. 1 is a perspective front view of the guide track assembly for a blind system of the present invention; FIG. 2 is a perspective back view thereof; FIG. 3 is a top view thereof; FIG. 4 is a bottom view thereof; FIG. 5 is a front view thereof; FIG. 6 is a back view thereof; FIG. 7 is a right side view thereof; and, FIG. 8 is a left side view thereof.
The guide track assembly for a blind system is shown in FIGS. 1, 2 and 5 through 8 with a symbolic break in its length. The appearance of any portion of the article between the dot-dash lines form no part of the claimed design.

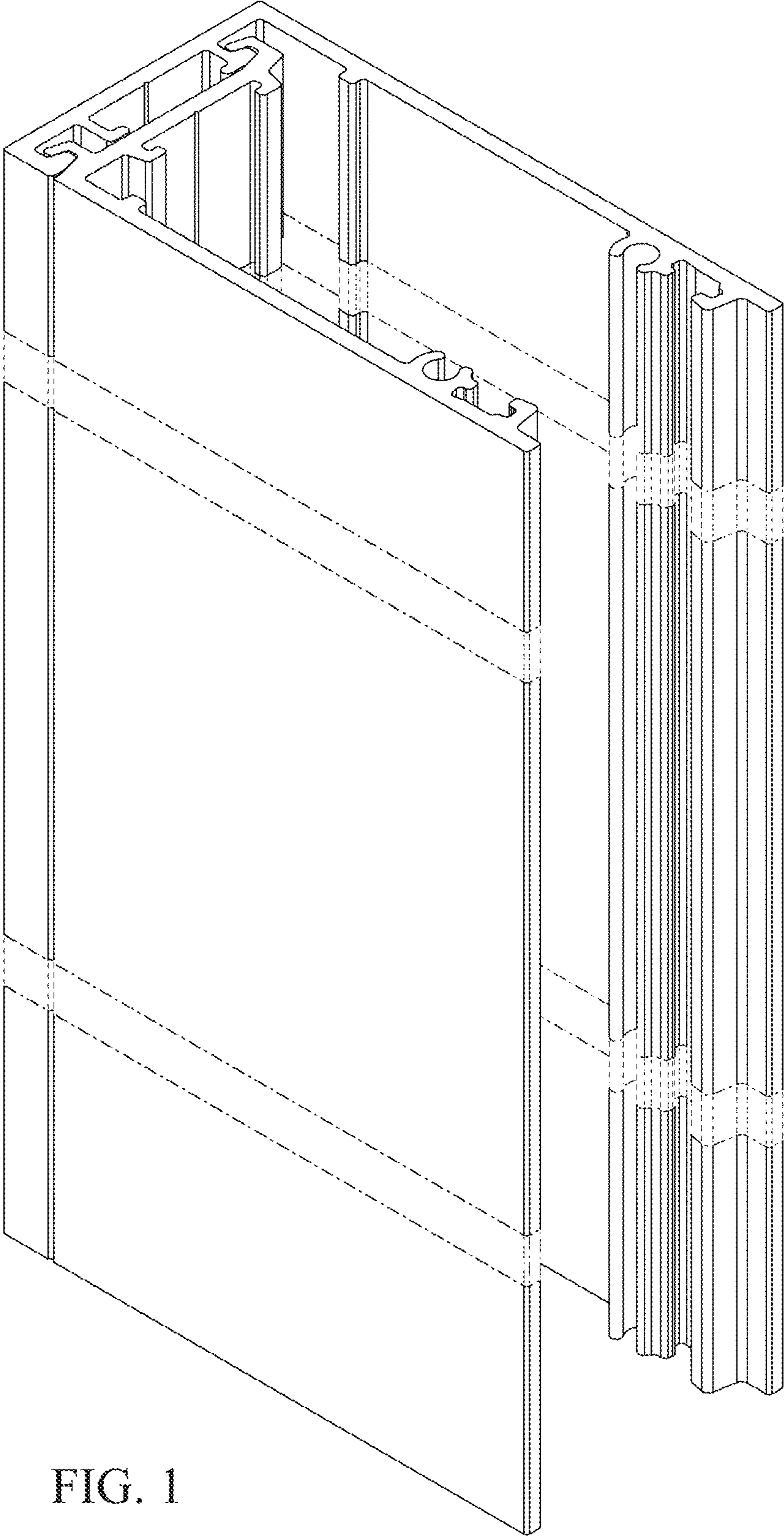

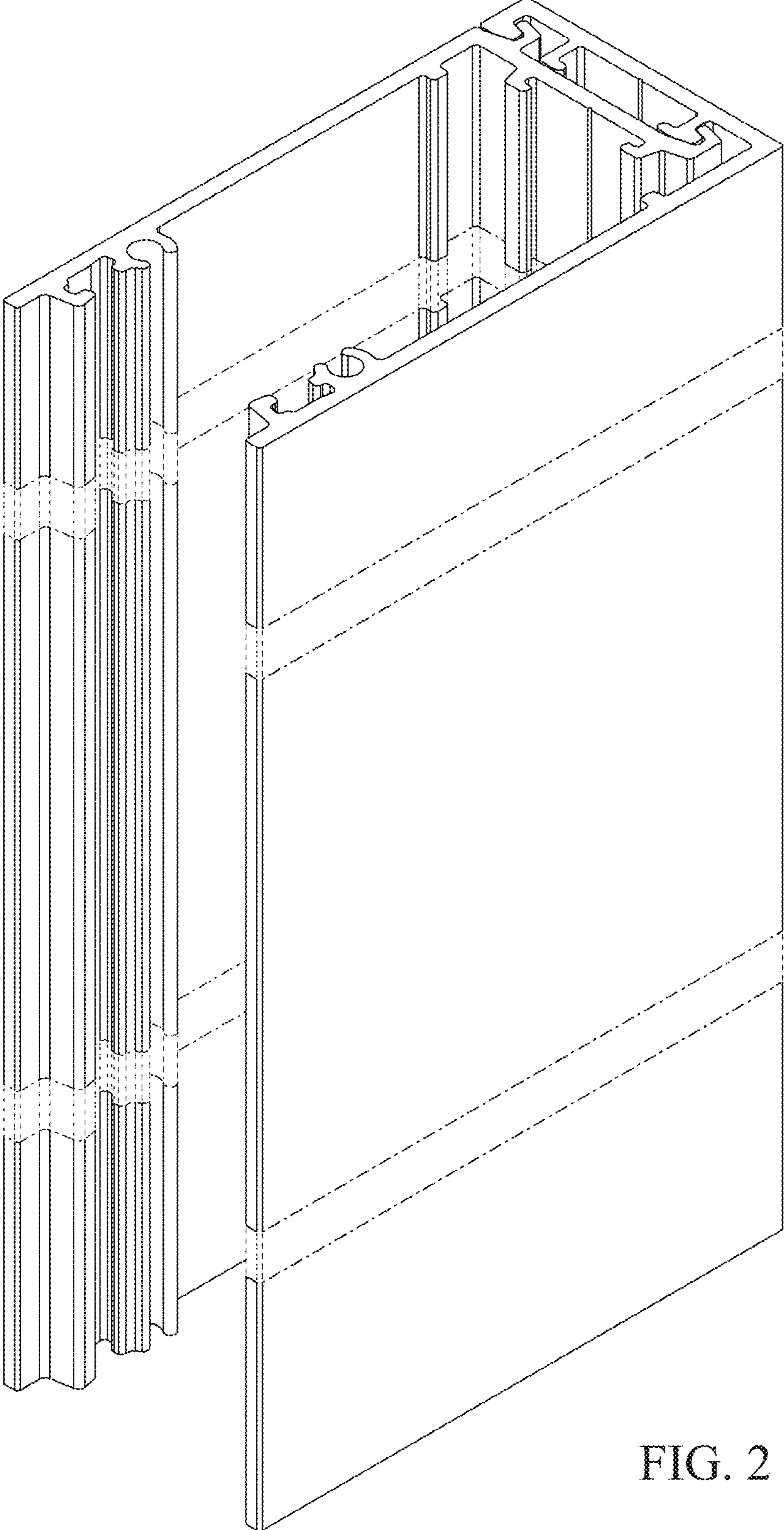

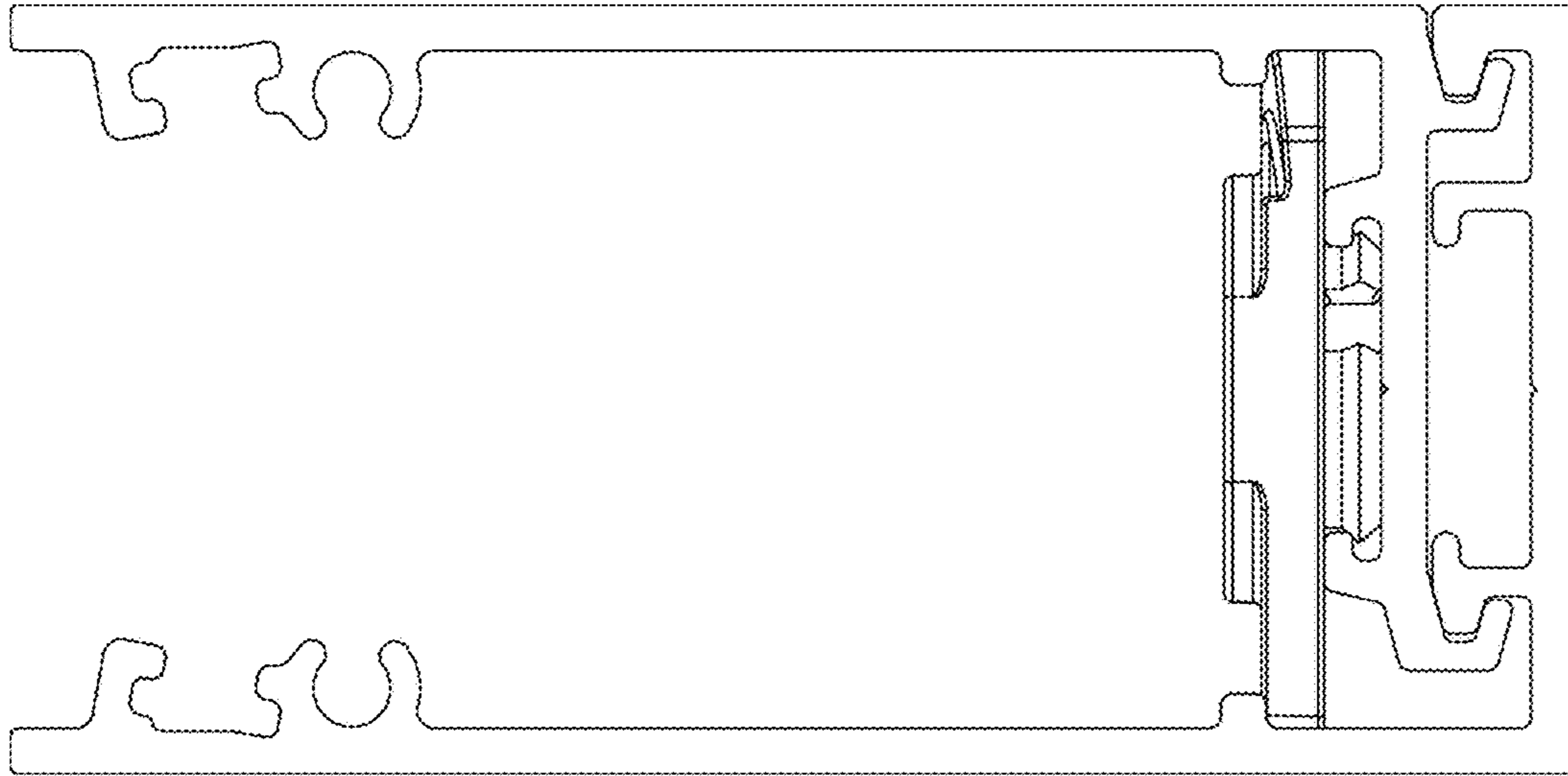

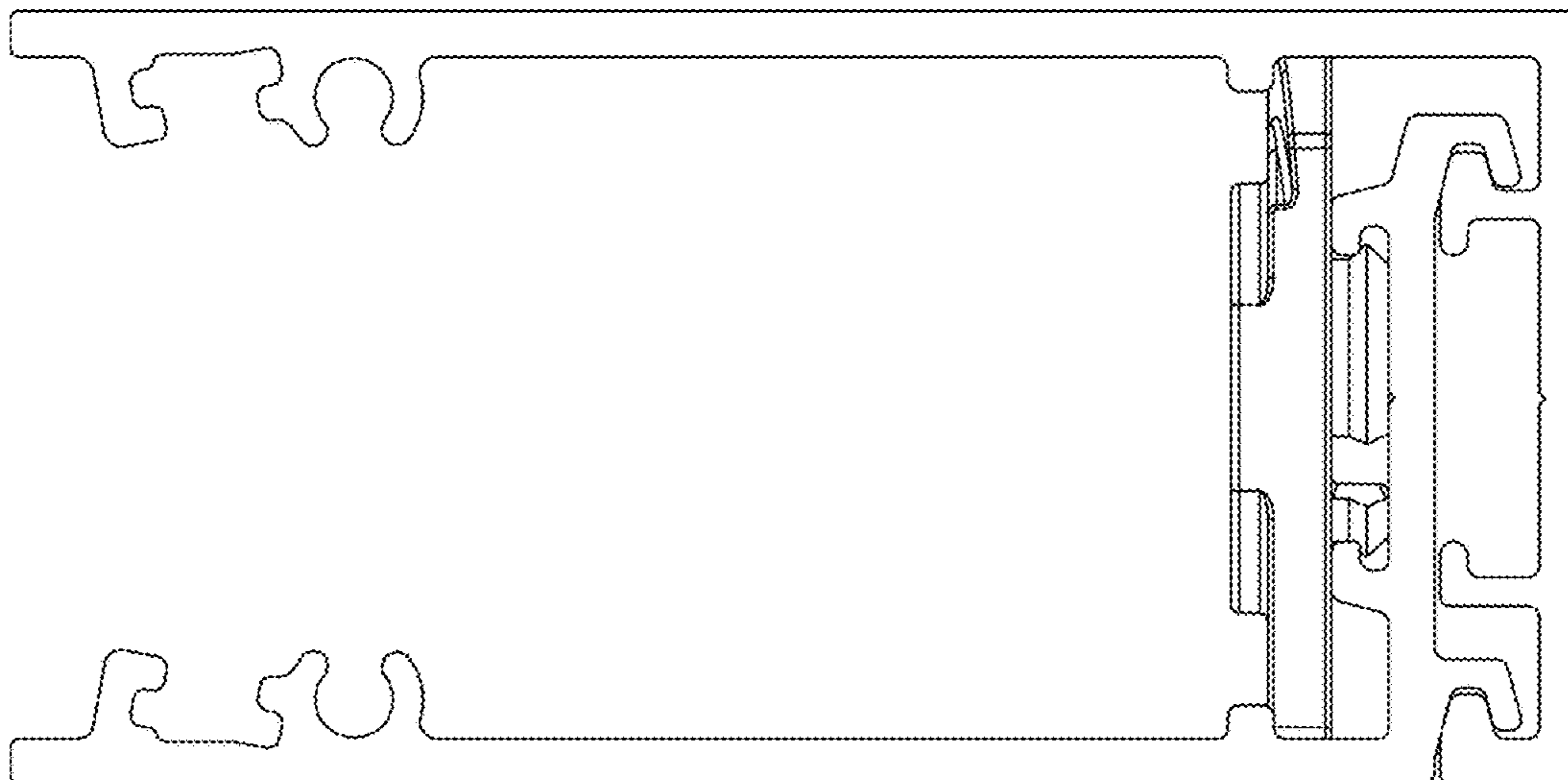

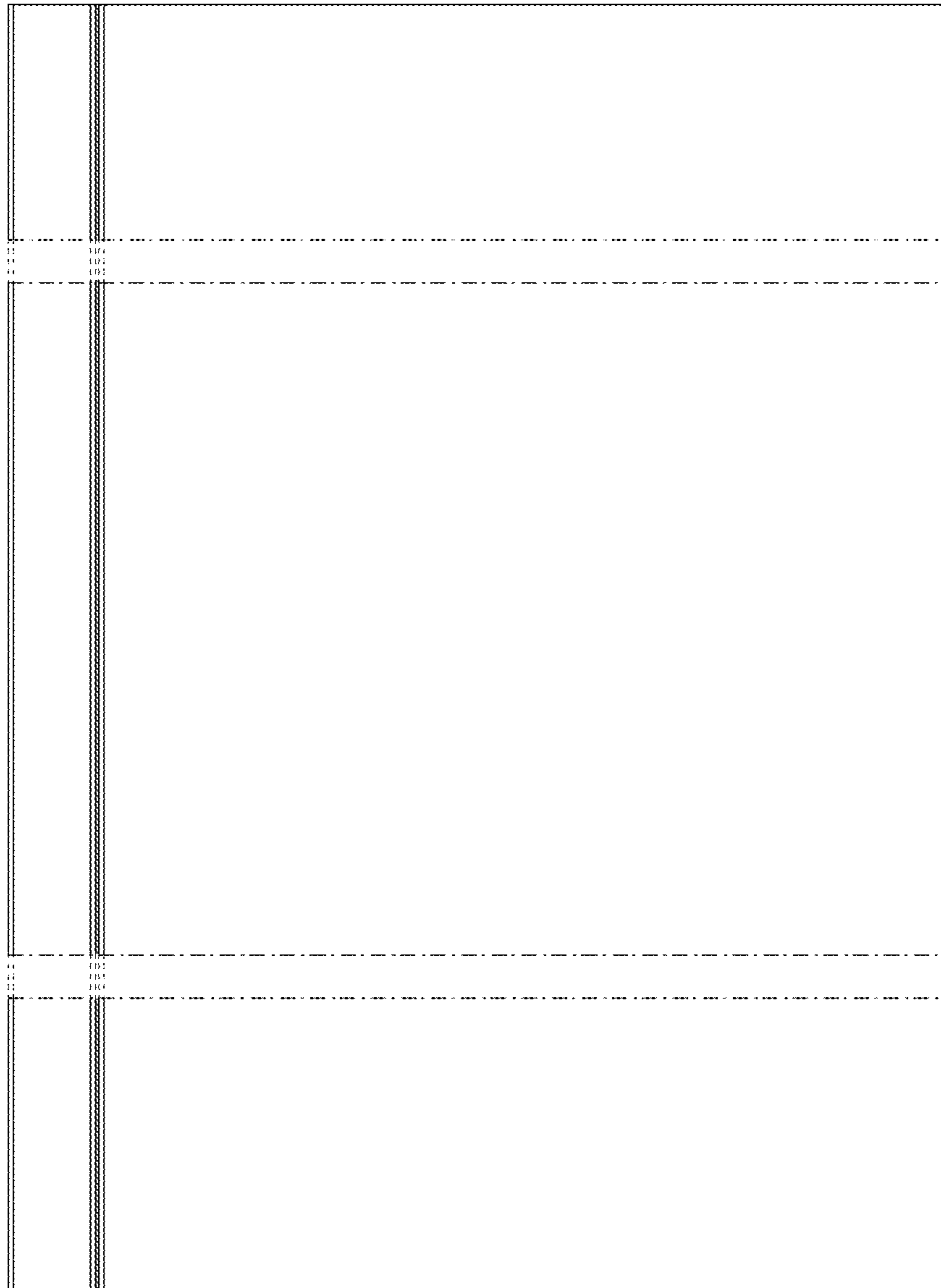

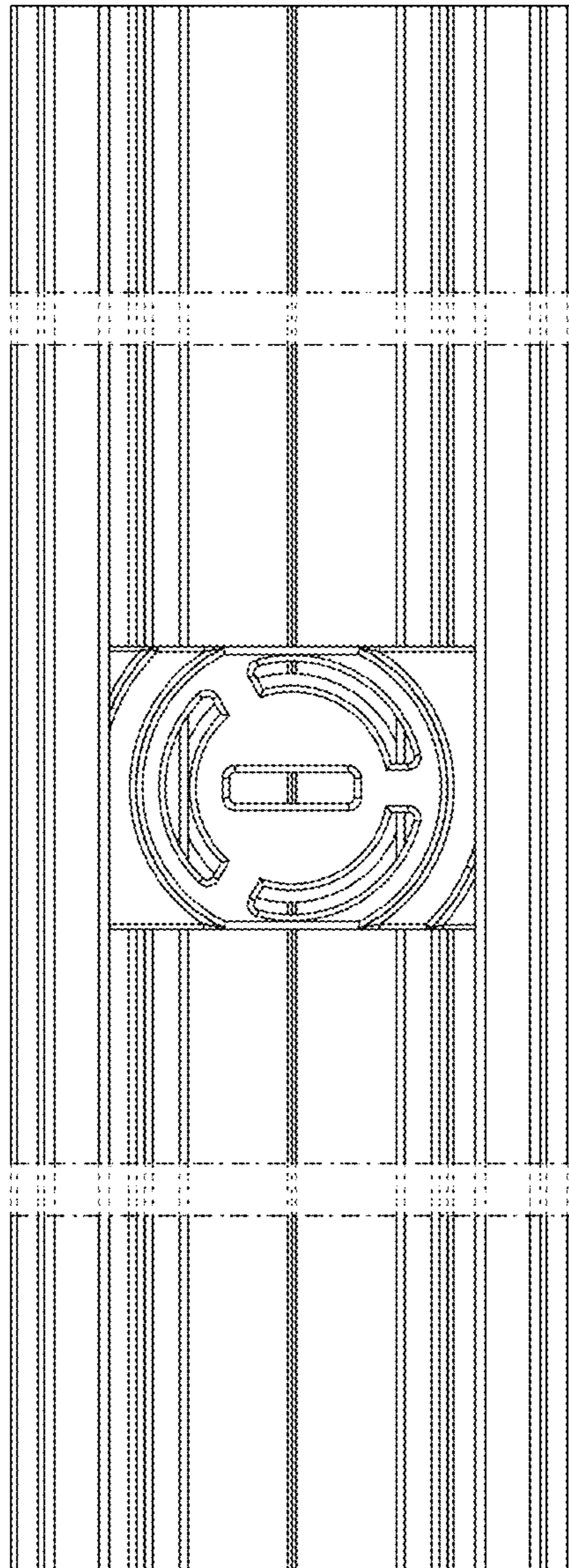

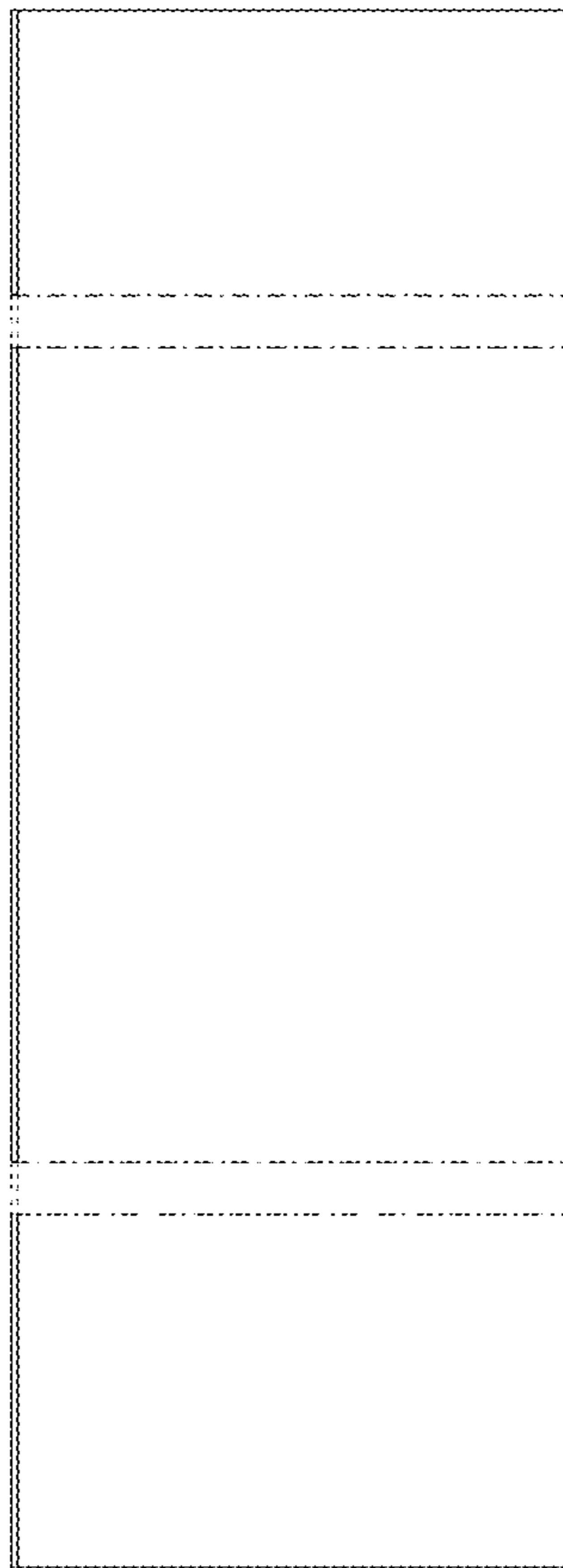
