DESCRIPTION

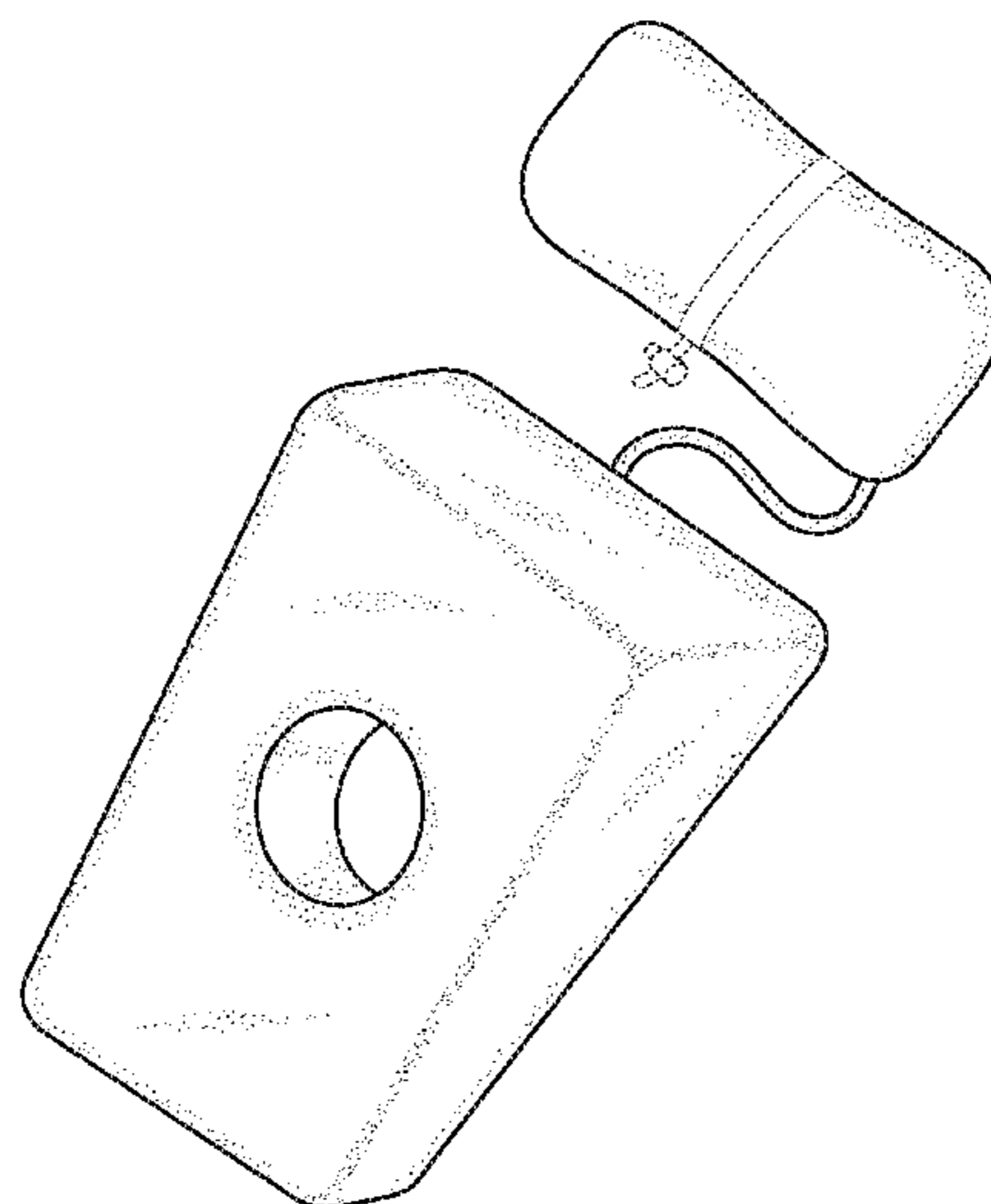
FIG. 1 is a front perspective view of the “pillow”, showing our new design.

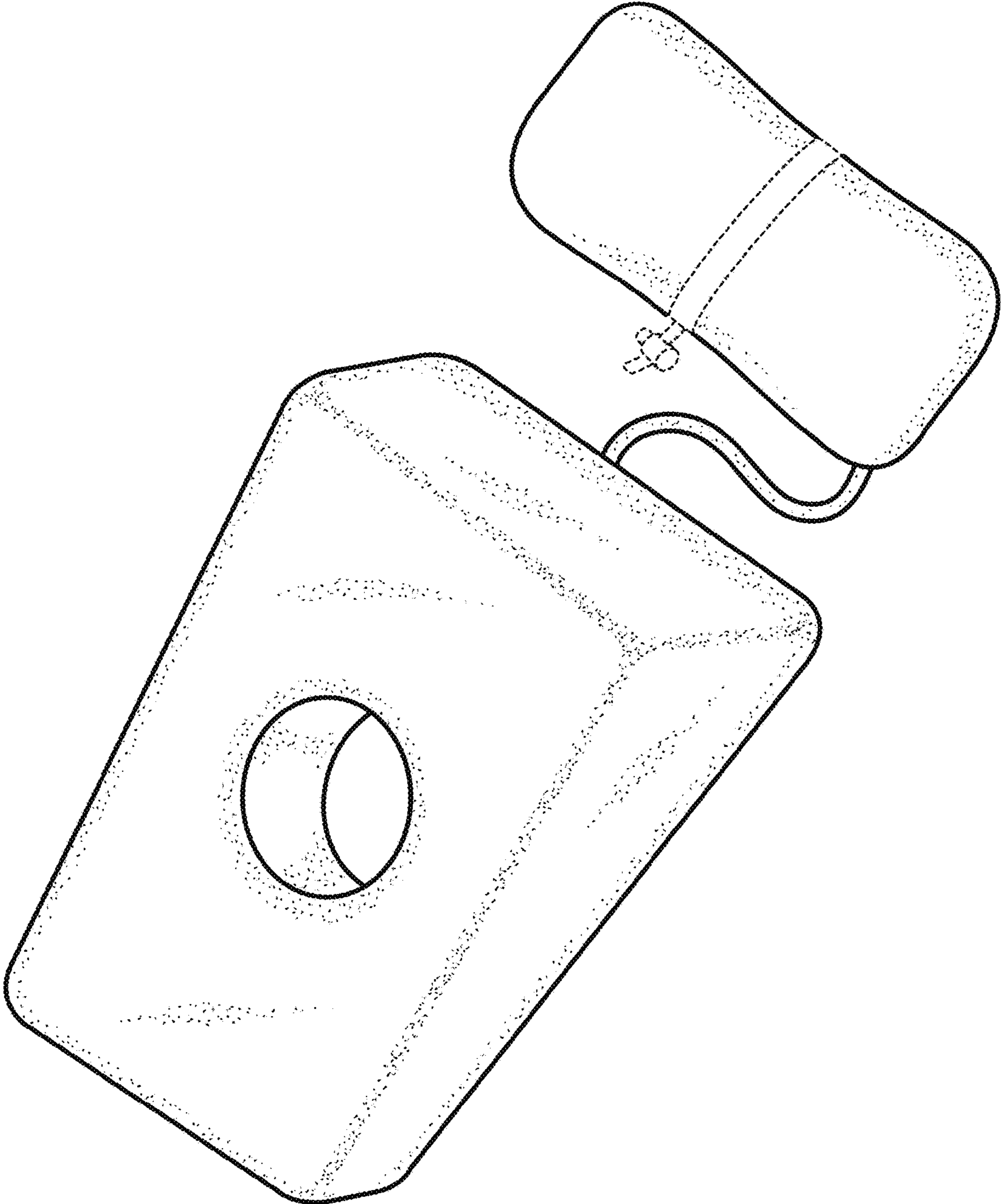

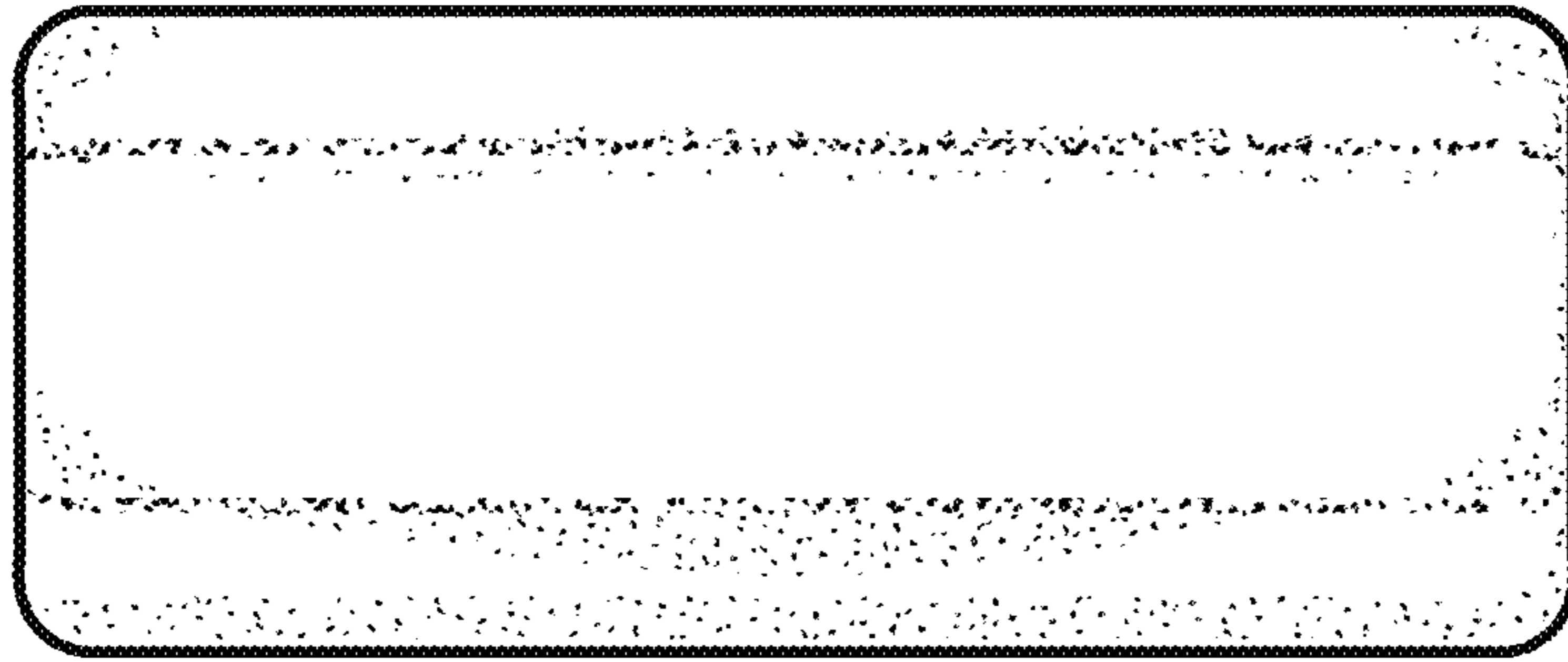

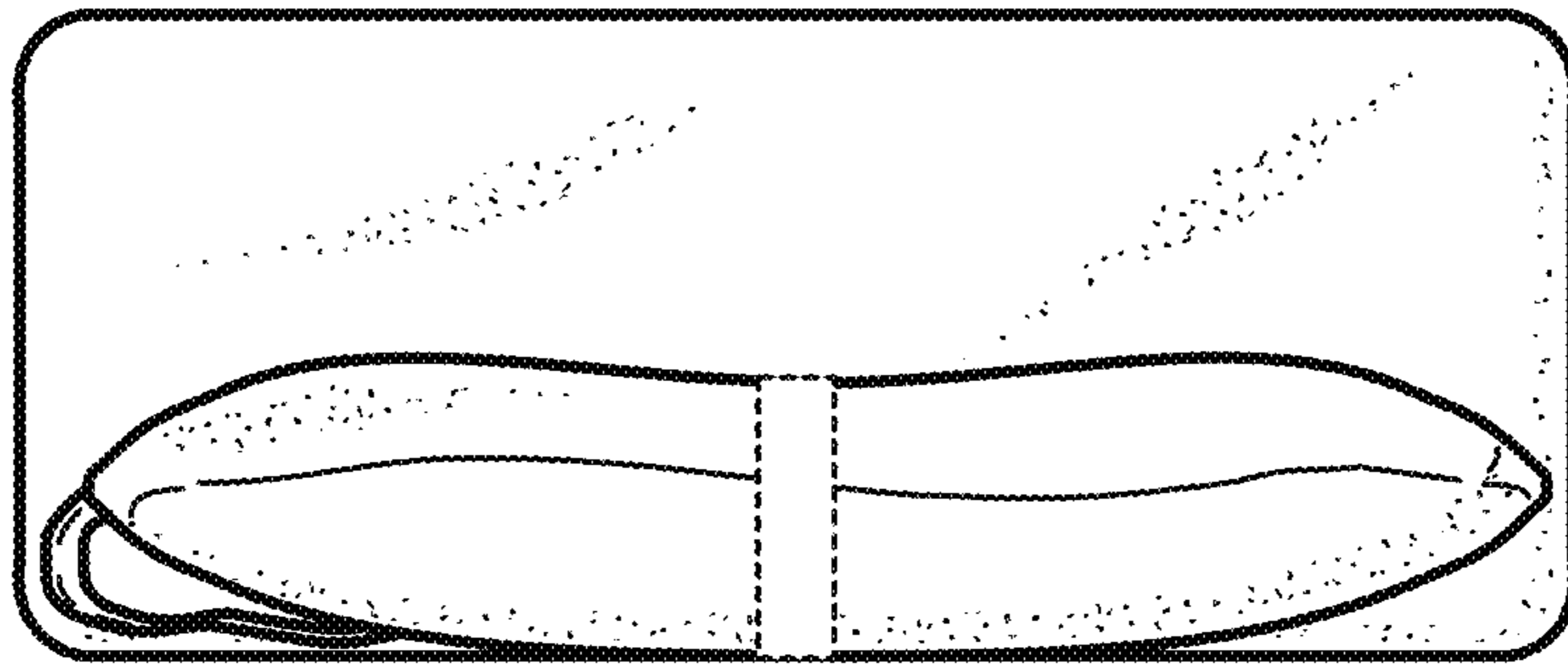

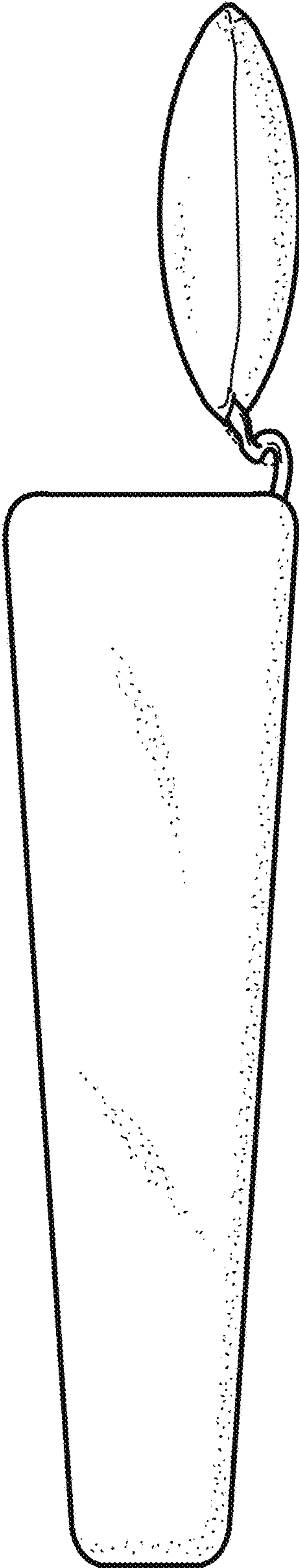

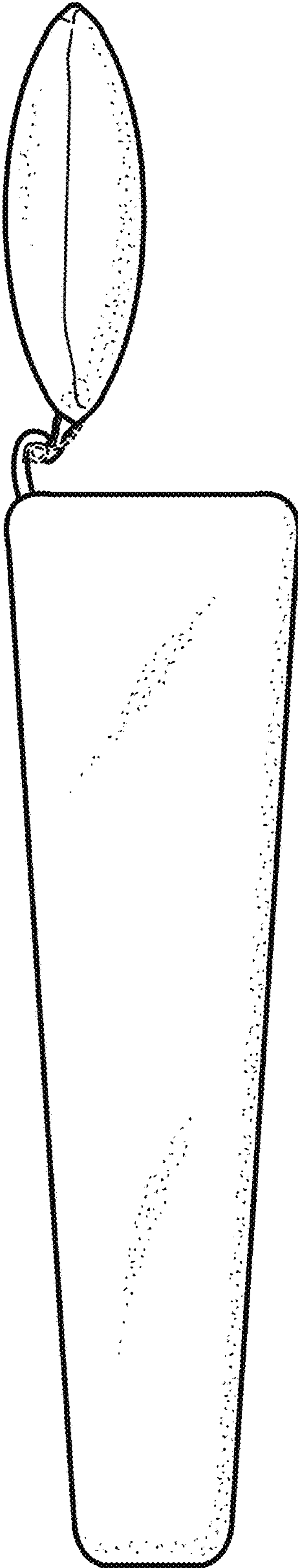

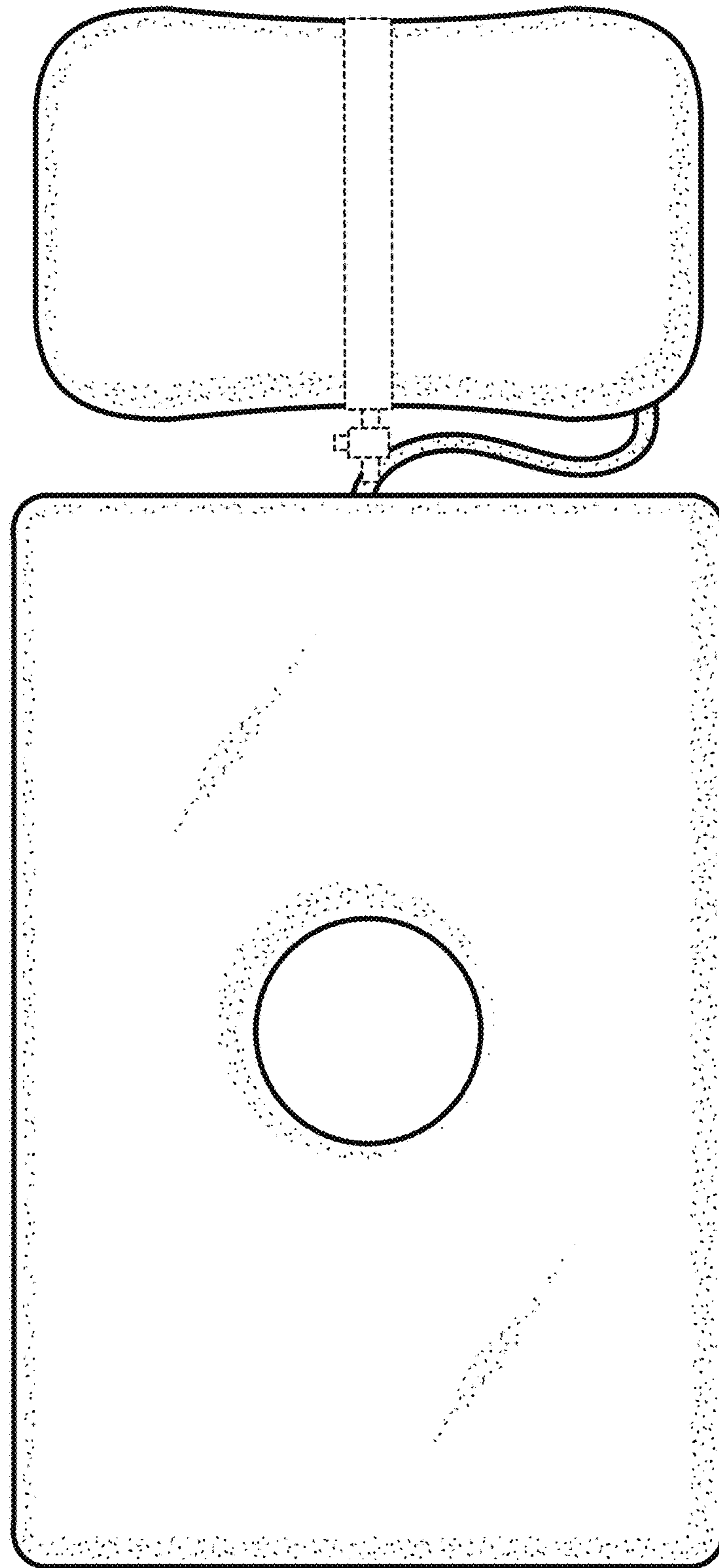

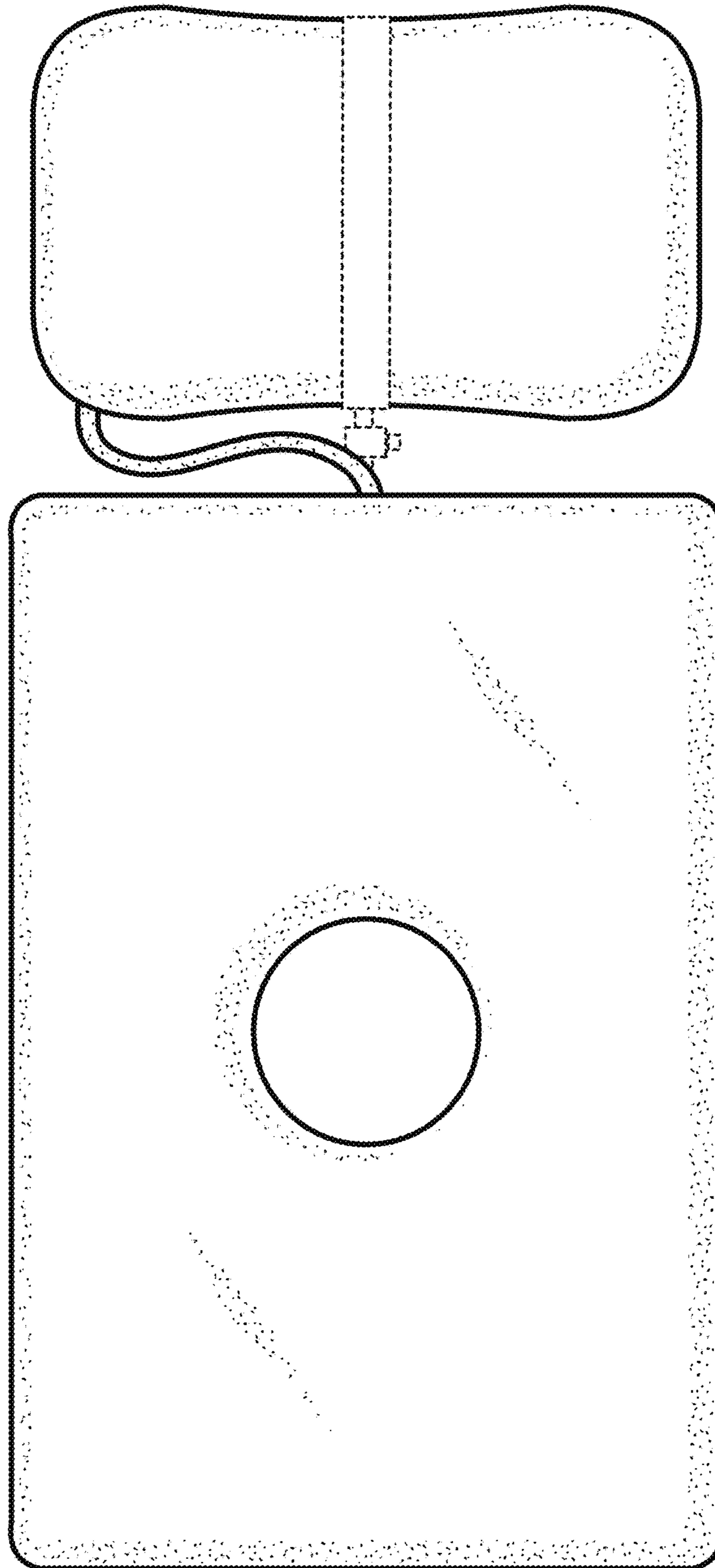
