**DESCRIPTION**

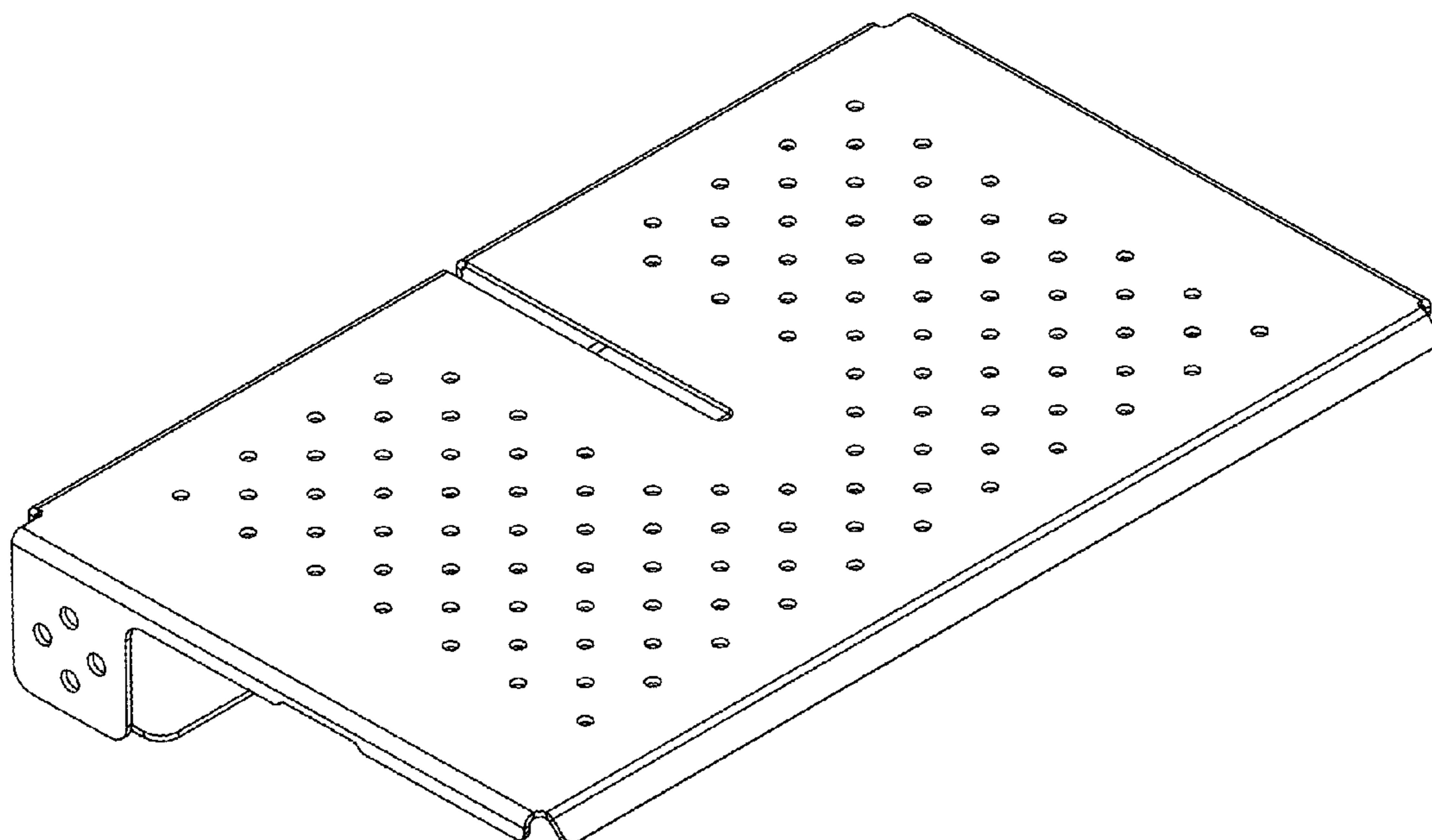

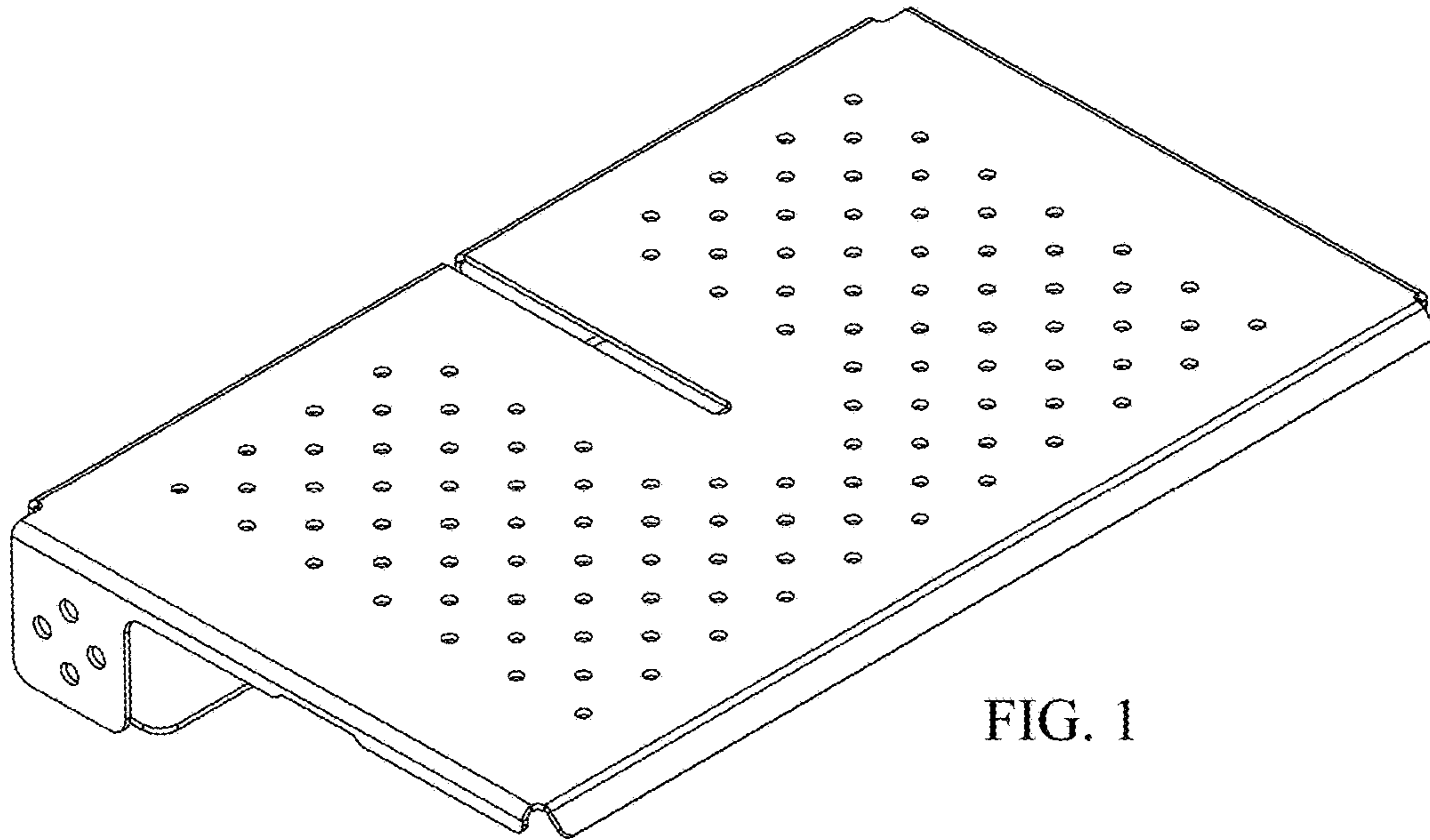

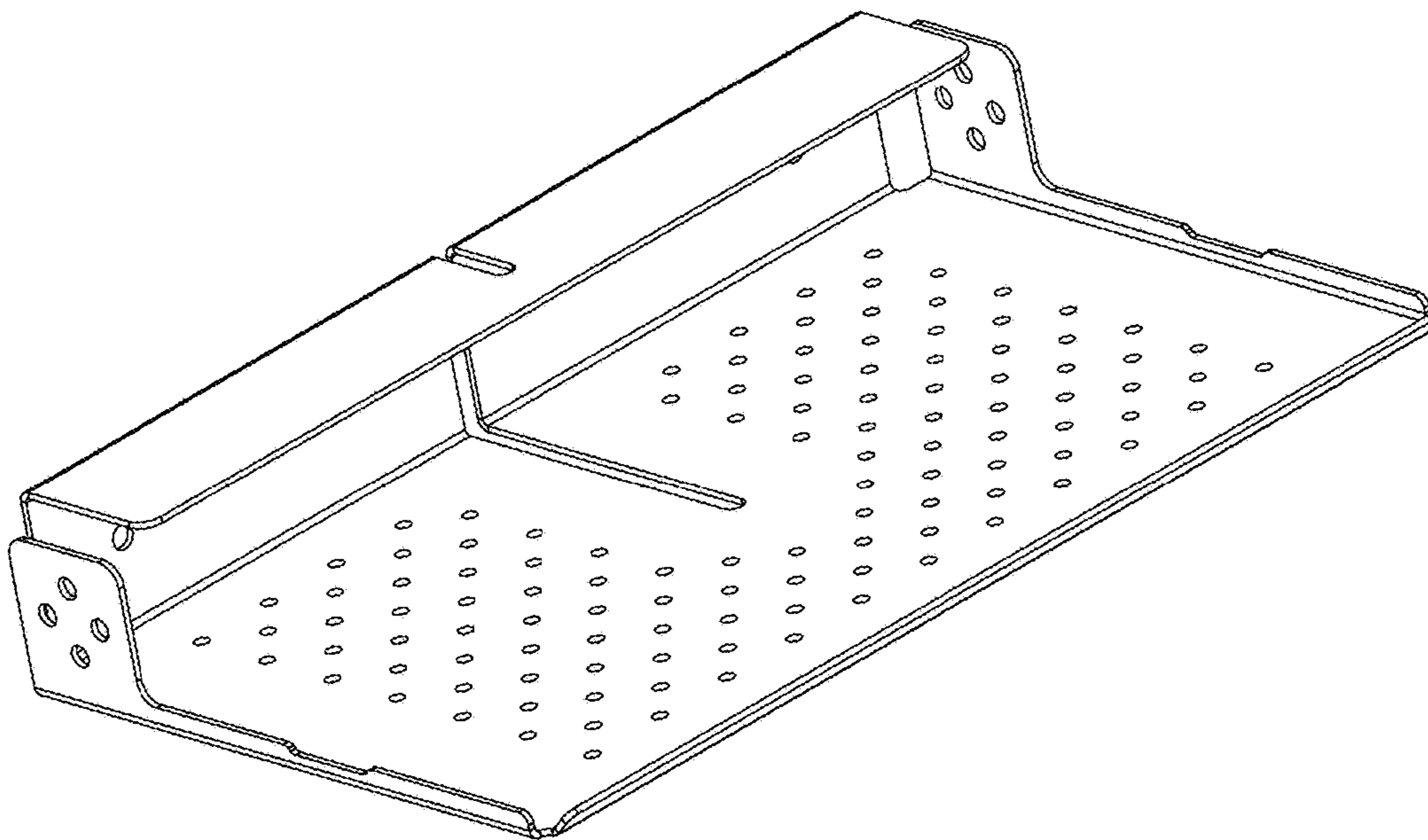

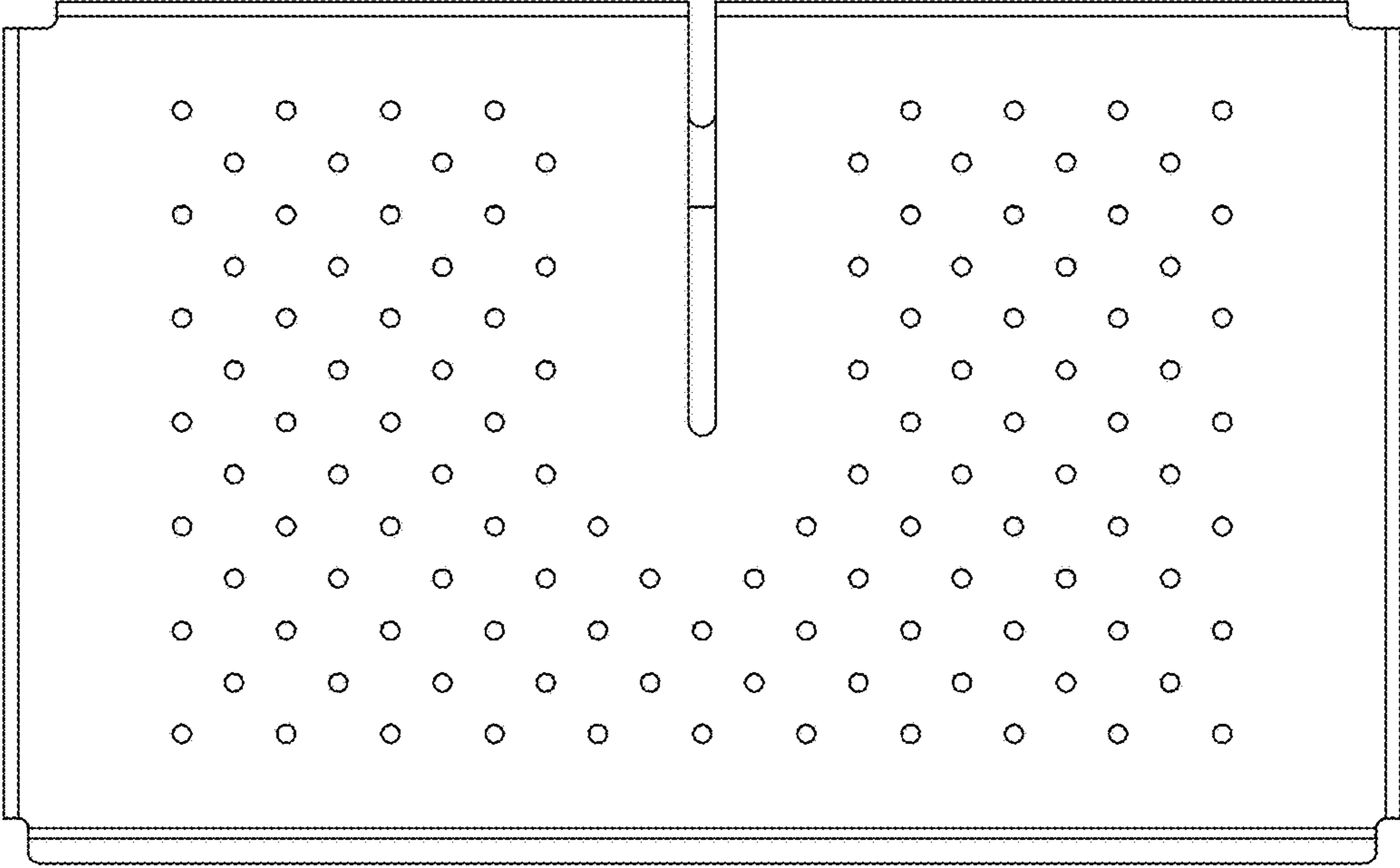

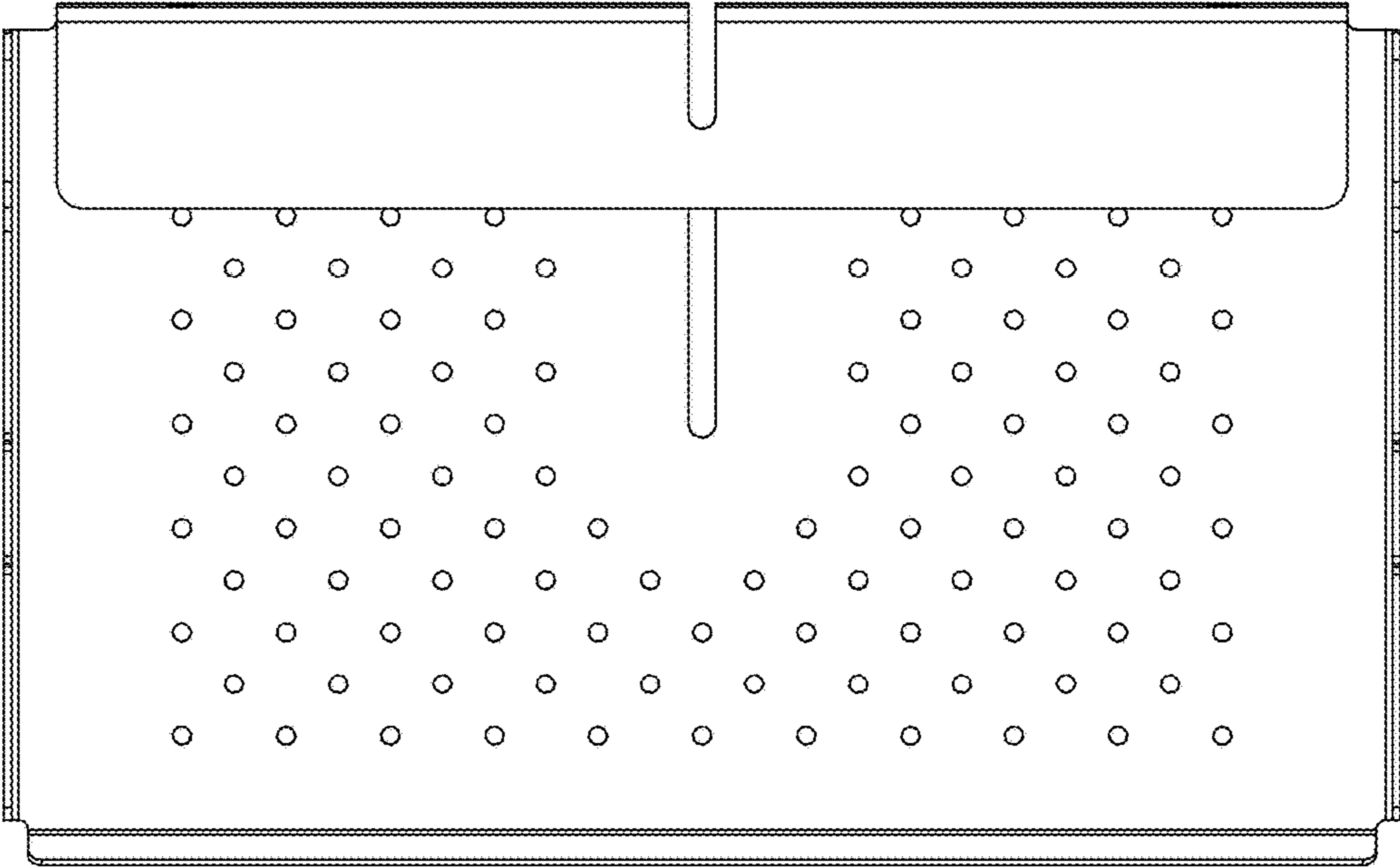

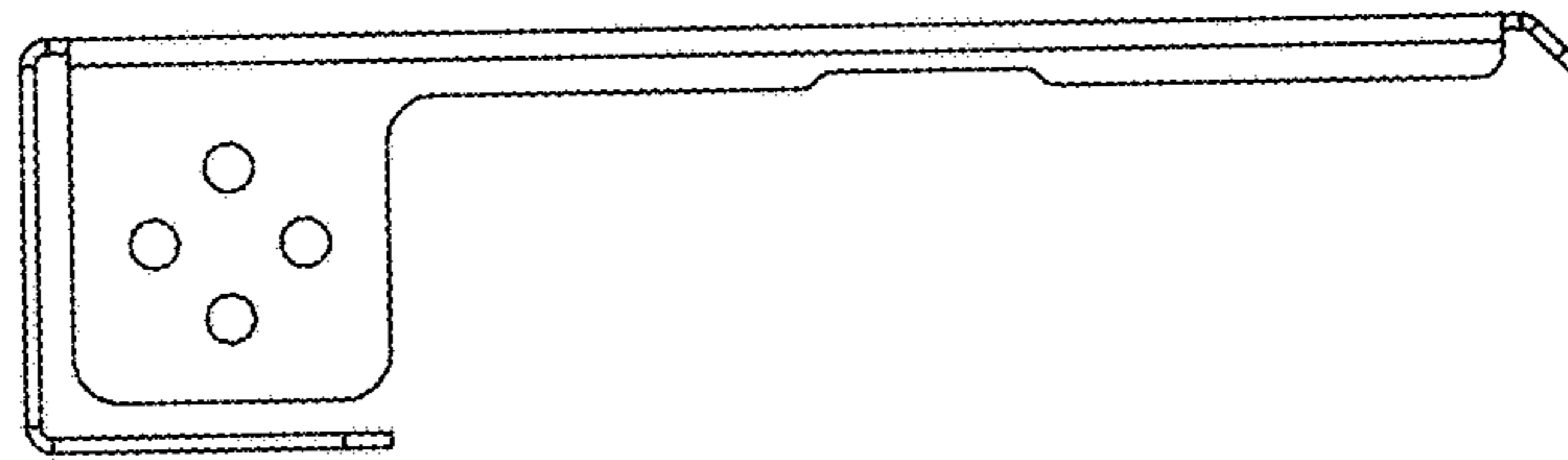

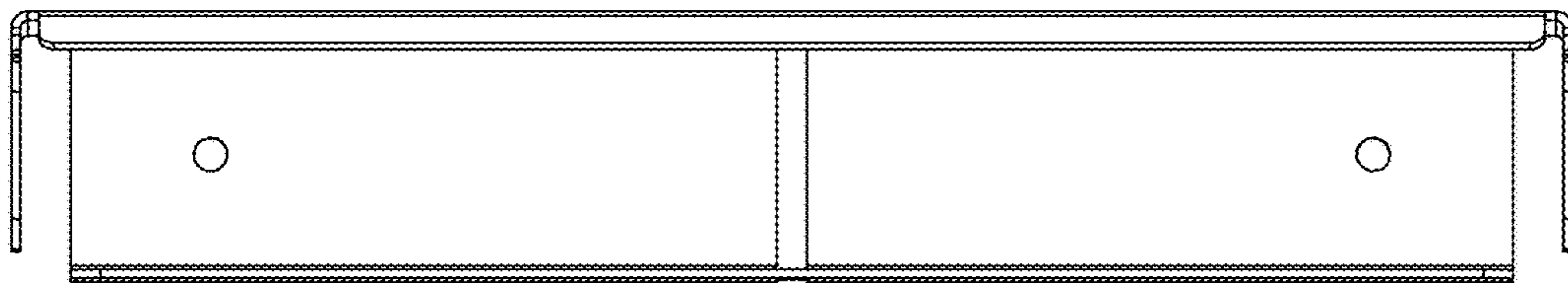

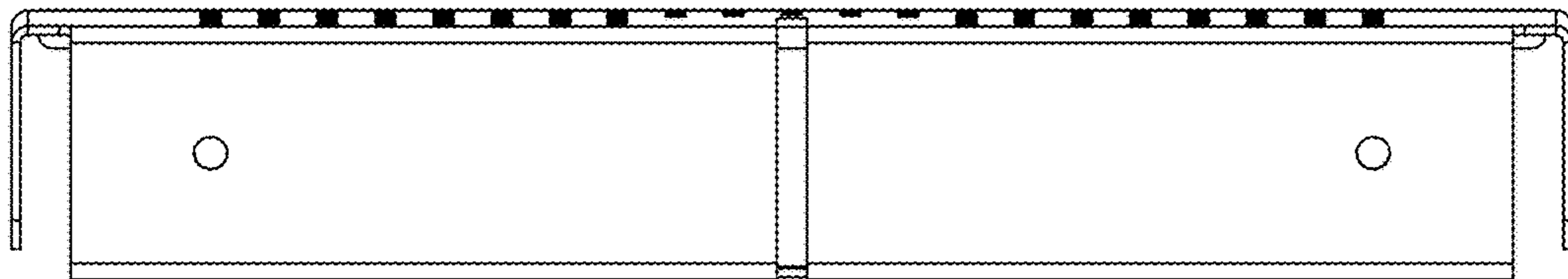
