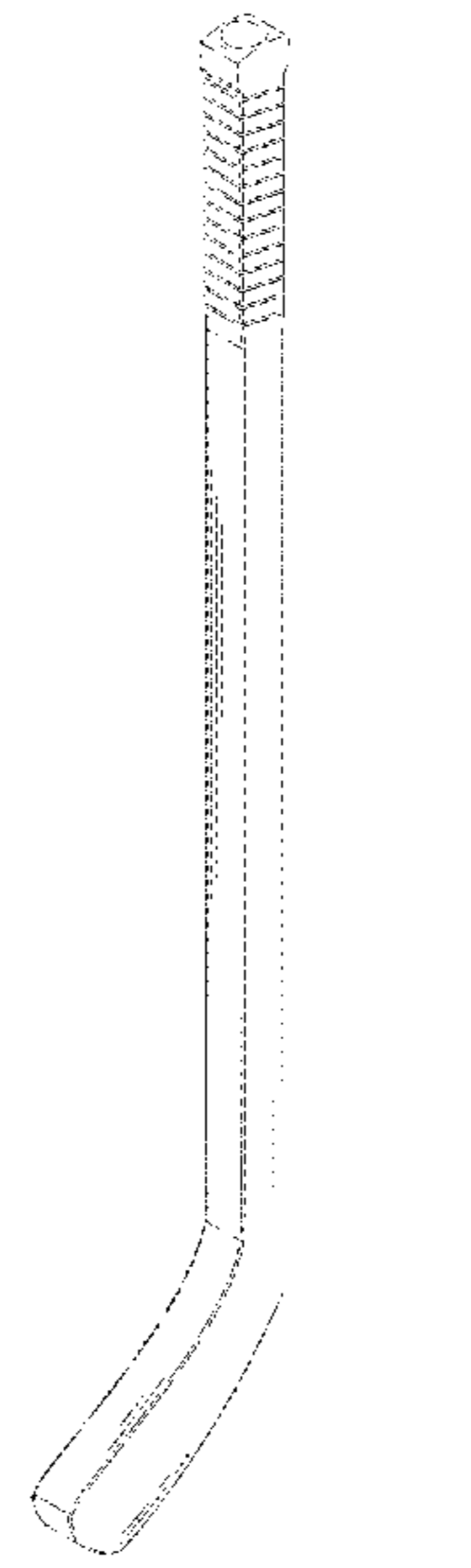
(57) **CLAIM**

We claim the ornamental design for a beverage consumption straw, as shown and described.

DESCRIPTION

FIG. 1 is a top left side perspective view of a beverage consumption straw, showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a bottom right side perspective view thereof; FIG. 4 is a rear elevational view thereof; and, FIG. 5 is a left side cross-sectional elevational view thereof, taken in the direction of line 5-5' of FIG. 4.

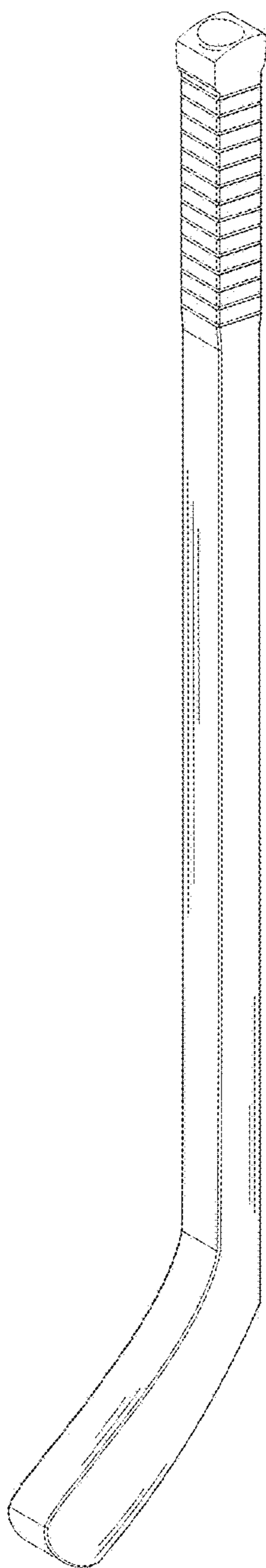

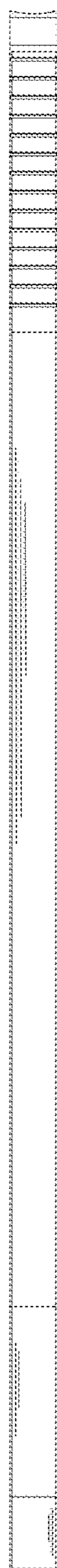

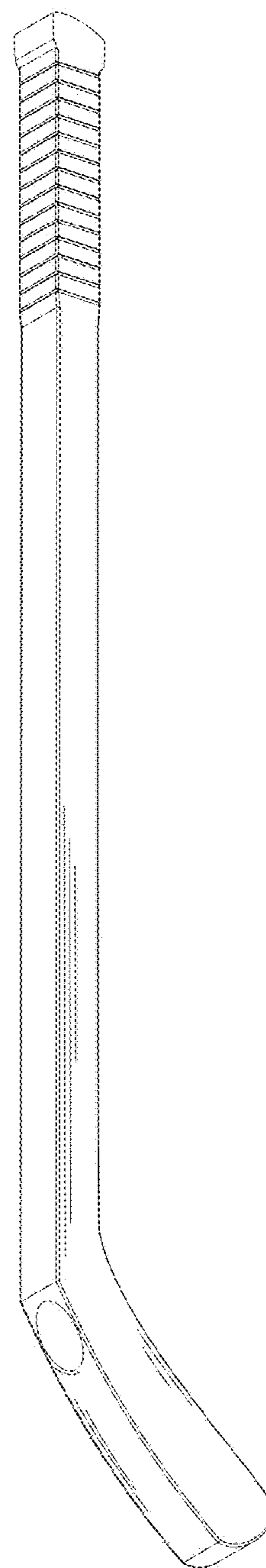

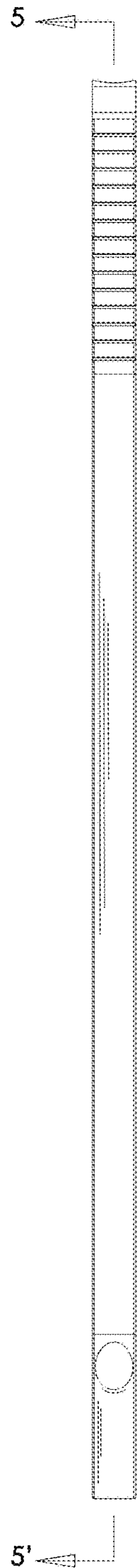

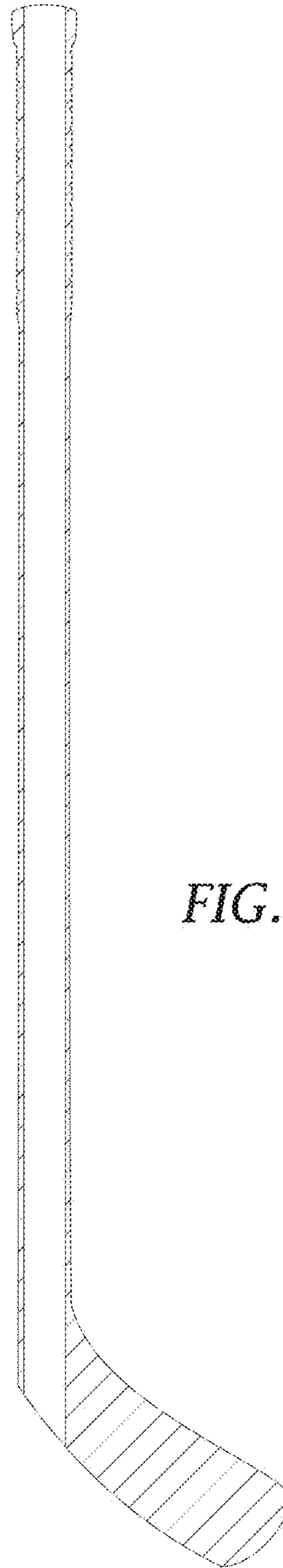
