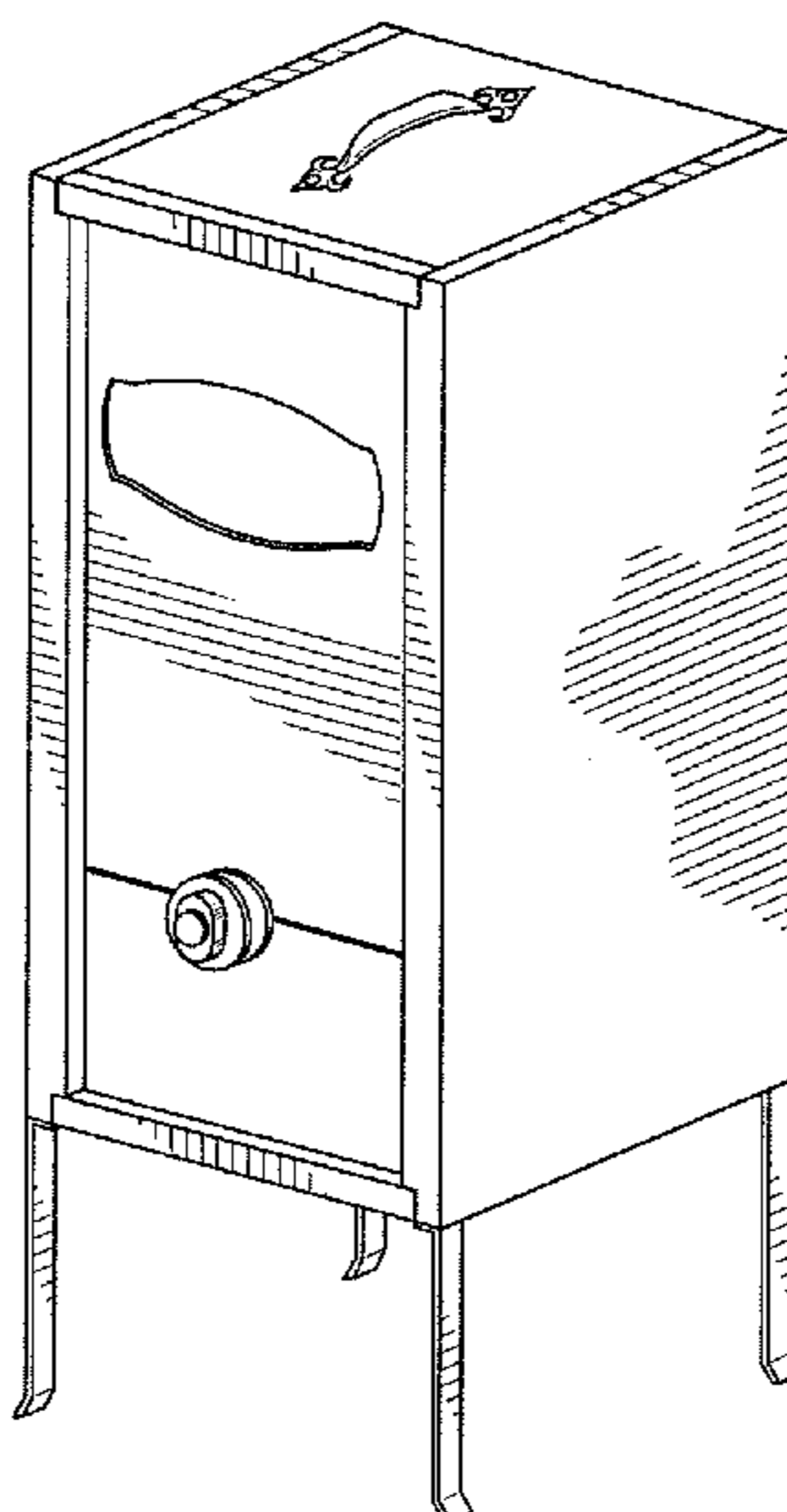
(57) **CLAIM**

We claim the ornamental design for a dispenser for beverage in bag, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a dispenser for beverage in bag showing our new design;  
FIG. 2 is a front elevational view of the dispenser for beverage in bag shown in FIG. 1.  
FIG. 3 is a rear elevational view of the dispenser for beverage in bag shown in FIGS. 1 and 2.  
FIG. 4 is a top plan view of the dispenser for beverage in bag shown in FIGS. 1-3.  
FIG. 5 is a bottom plan view of the dispenser for beverage in bag shown in FIGS. 1-4; and,  
FIG. 6 is a right side elevational view of the dispenser for beverage in bag shown in FIGS. 1-5. The left side elevational view is a mirror image of the right side.

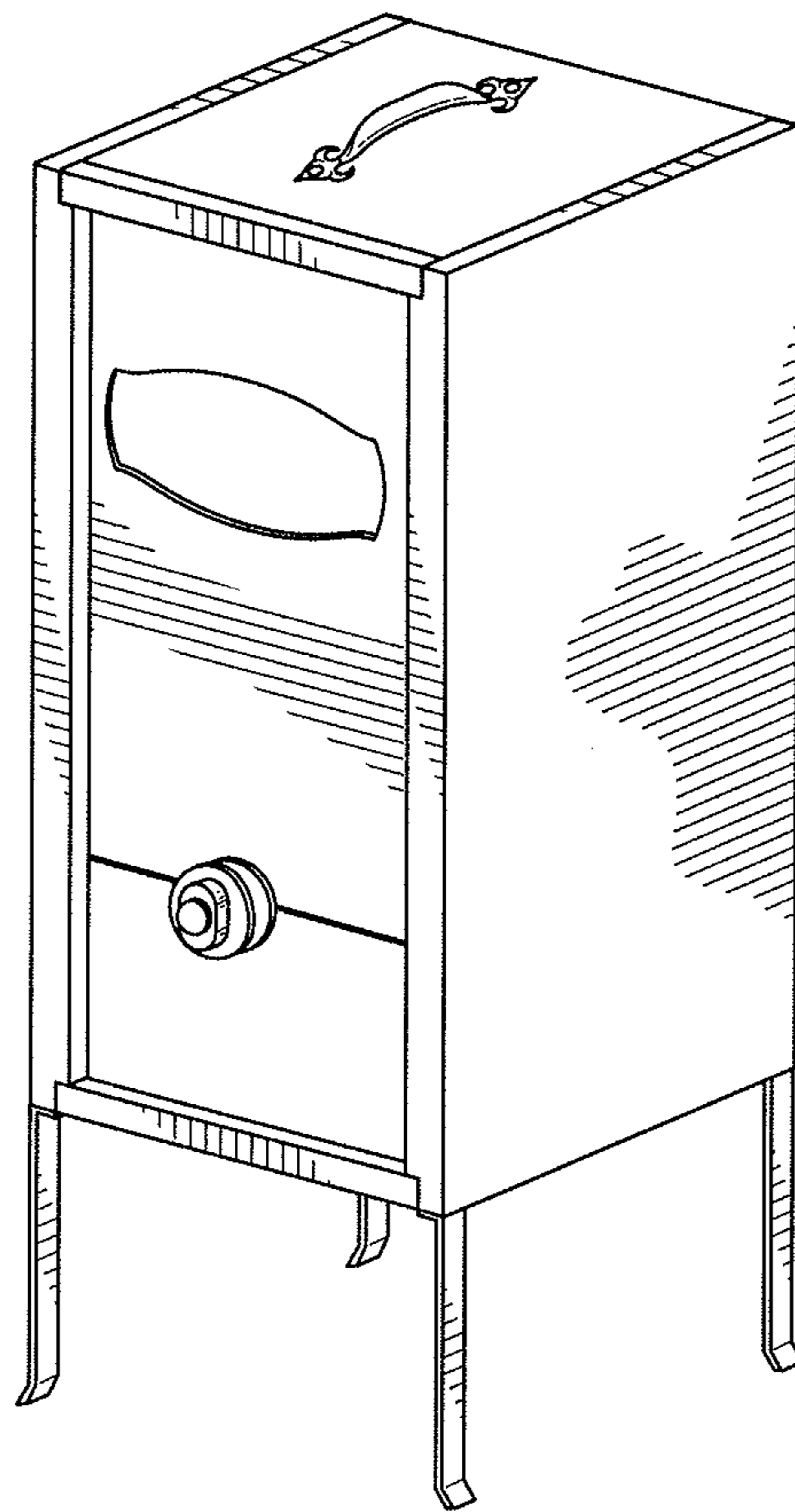

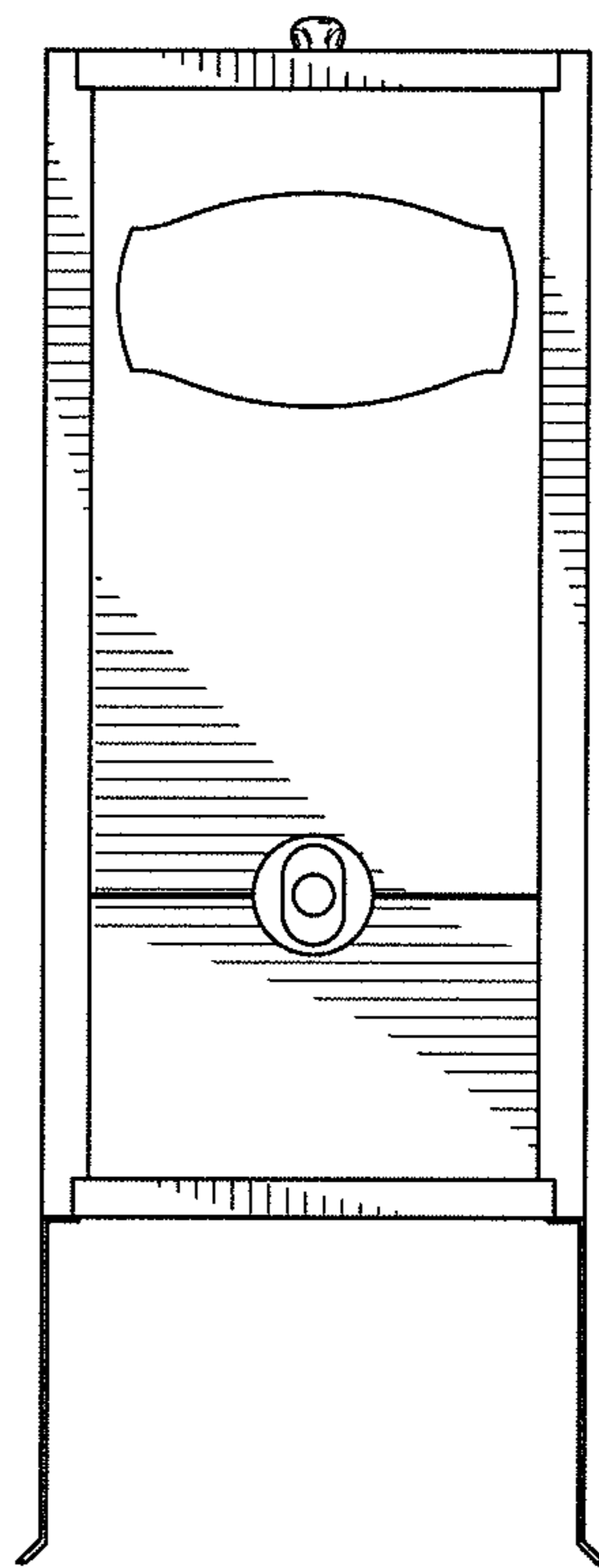

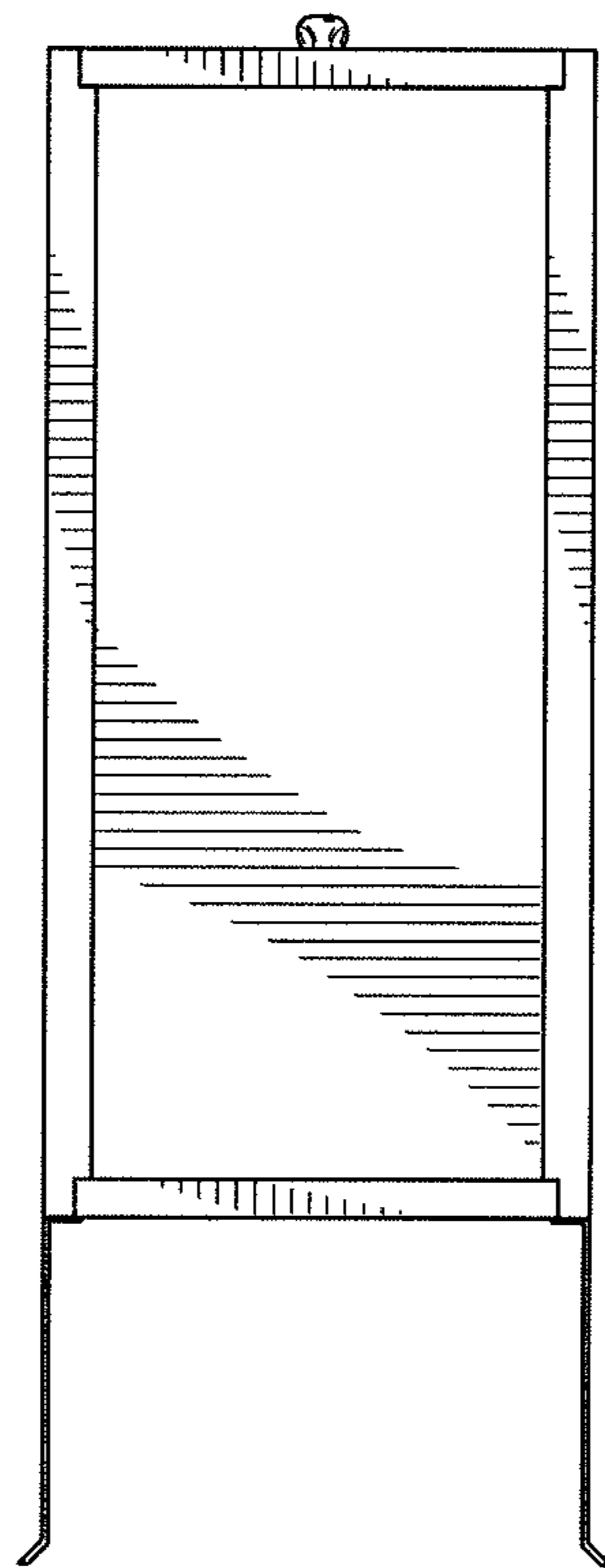

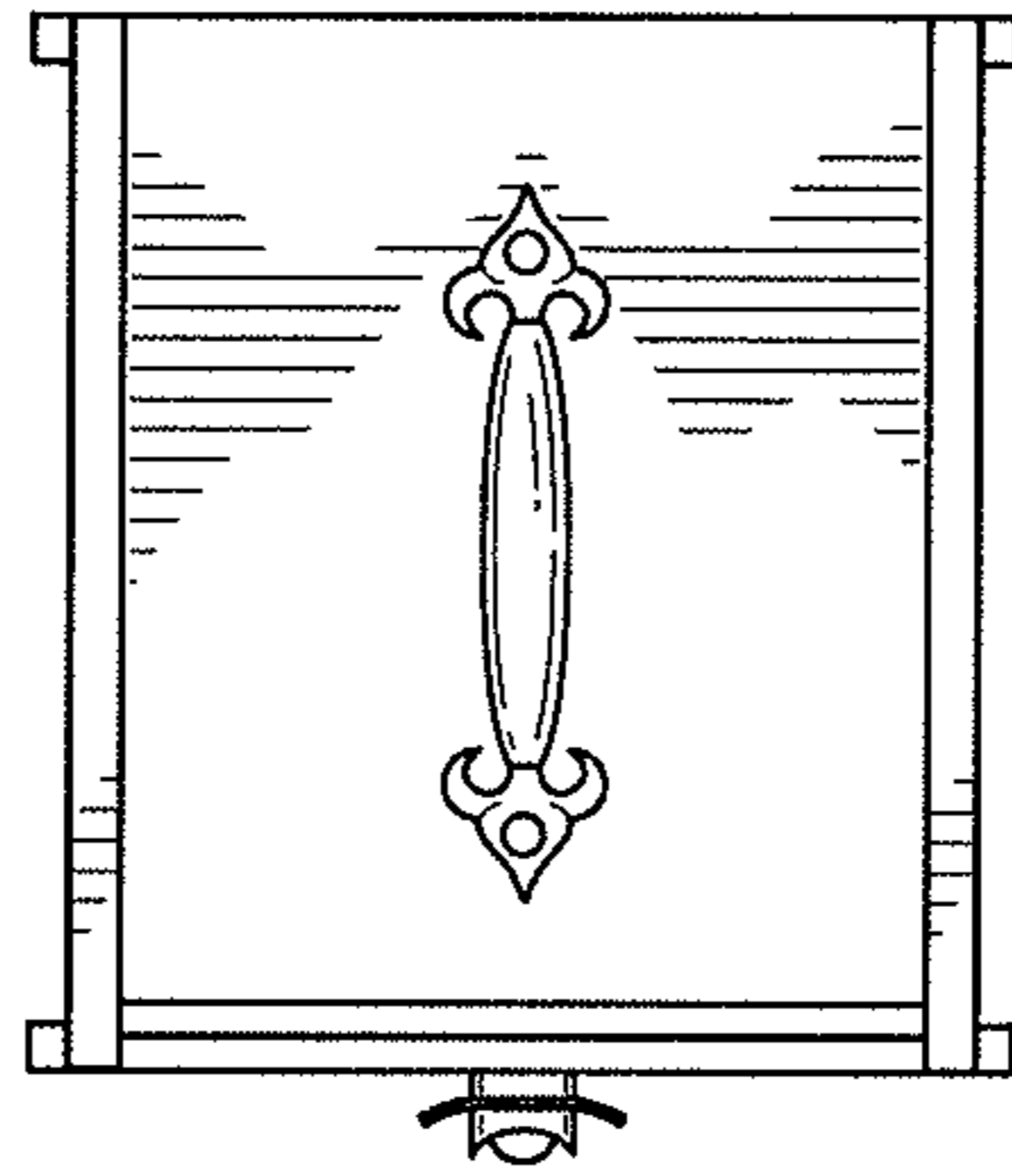

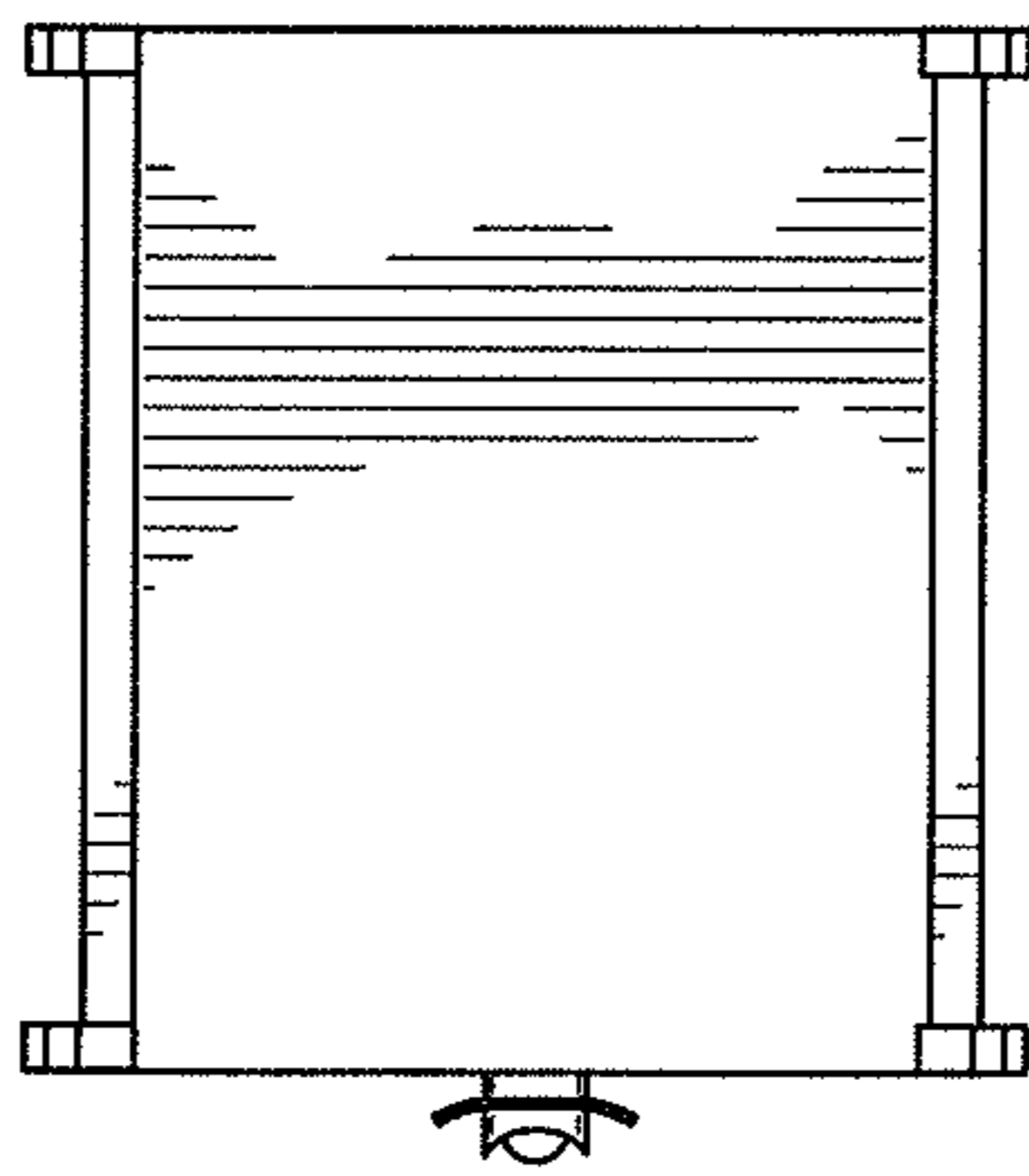

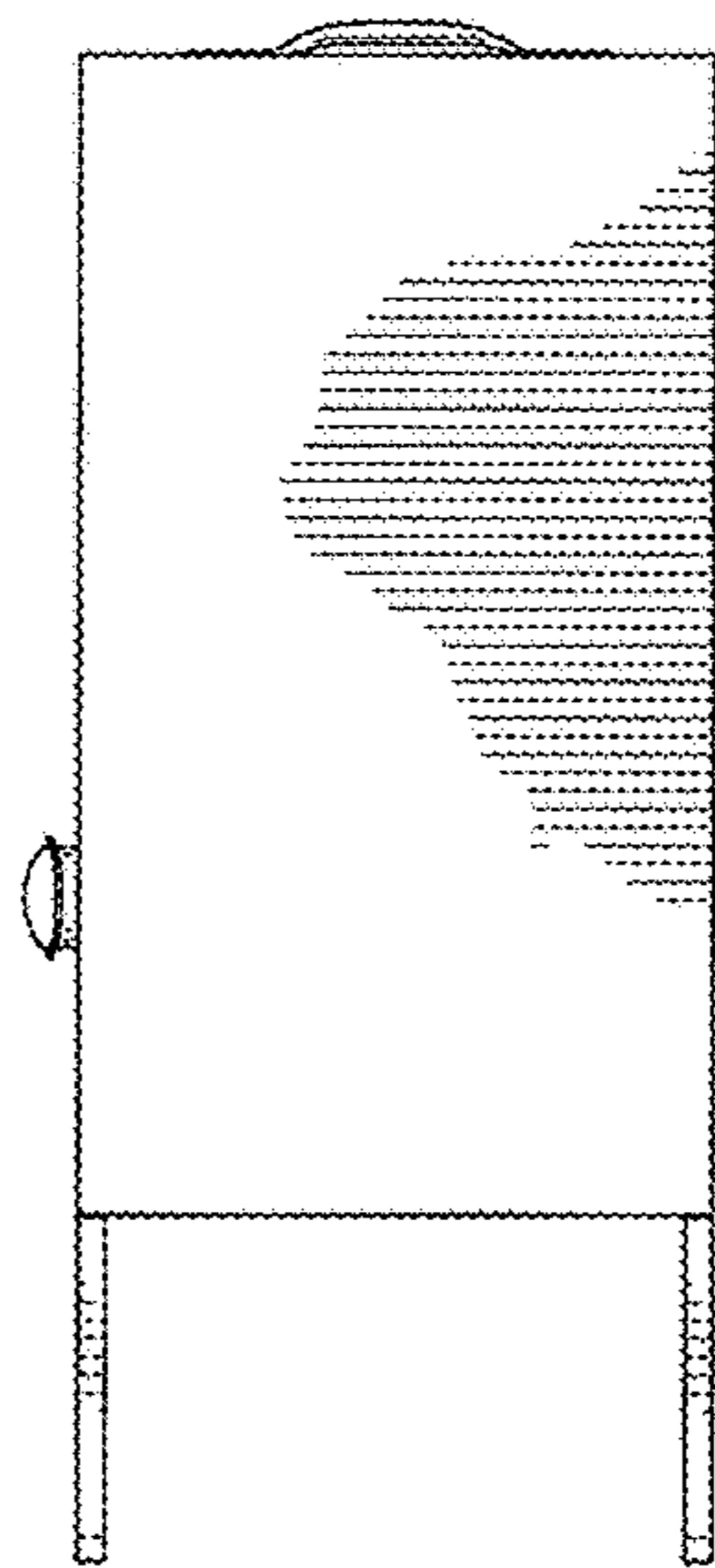
