(57) **CLAIM**

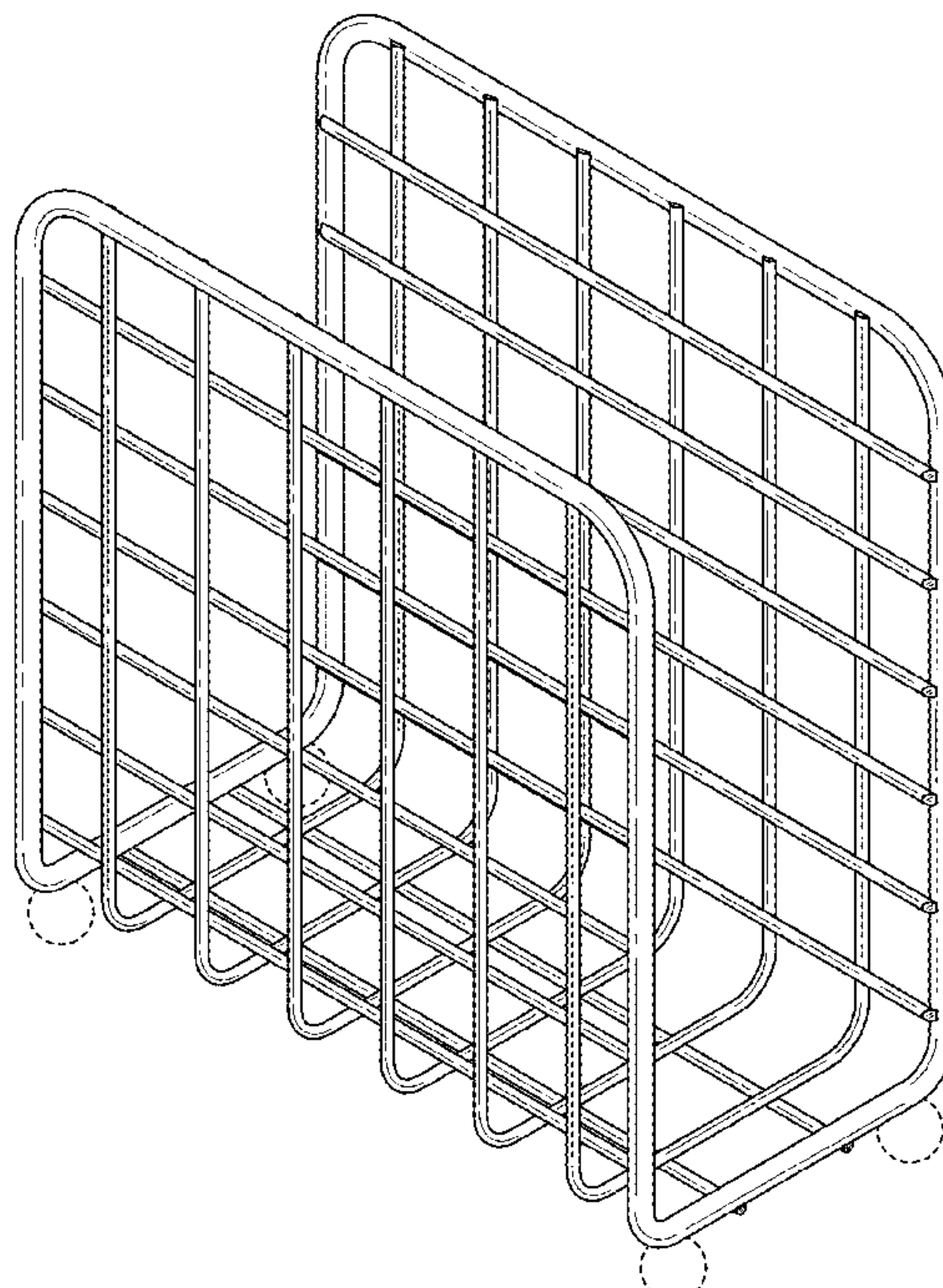
The ornamental design for a napkin holder, as shown and described.

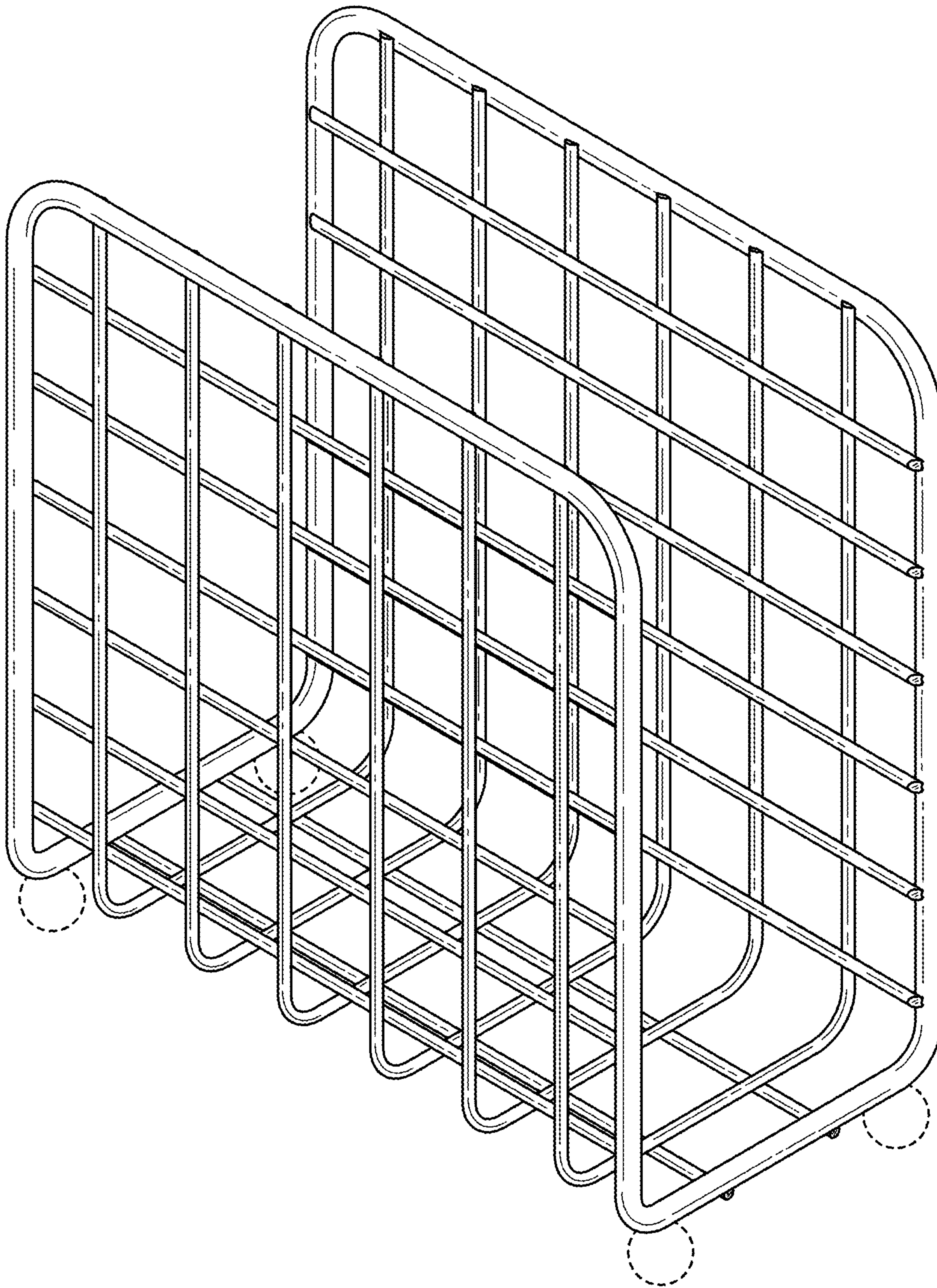

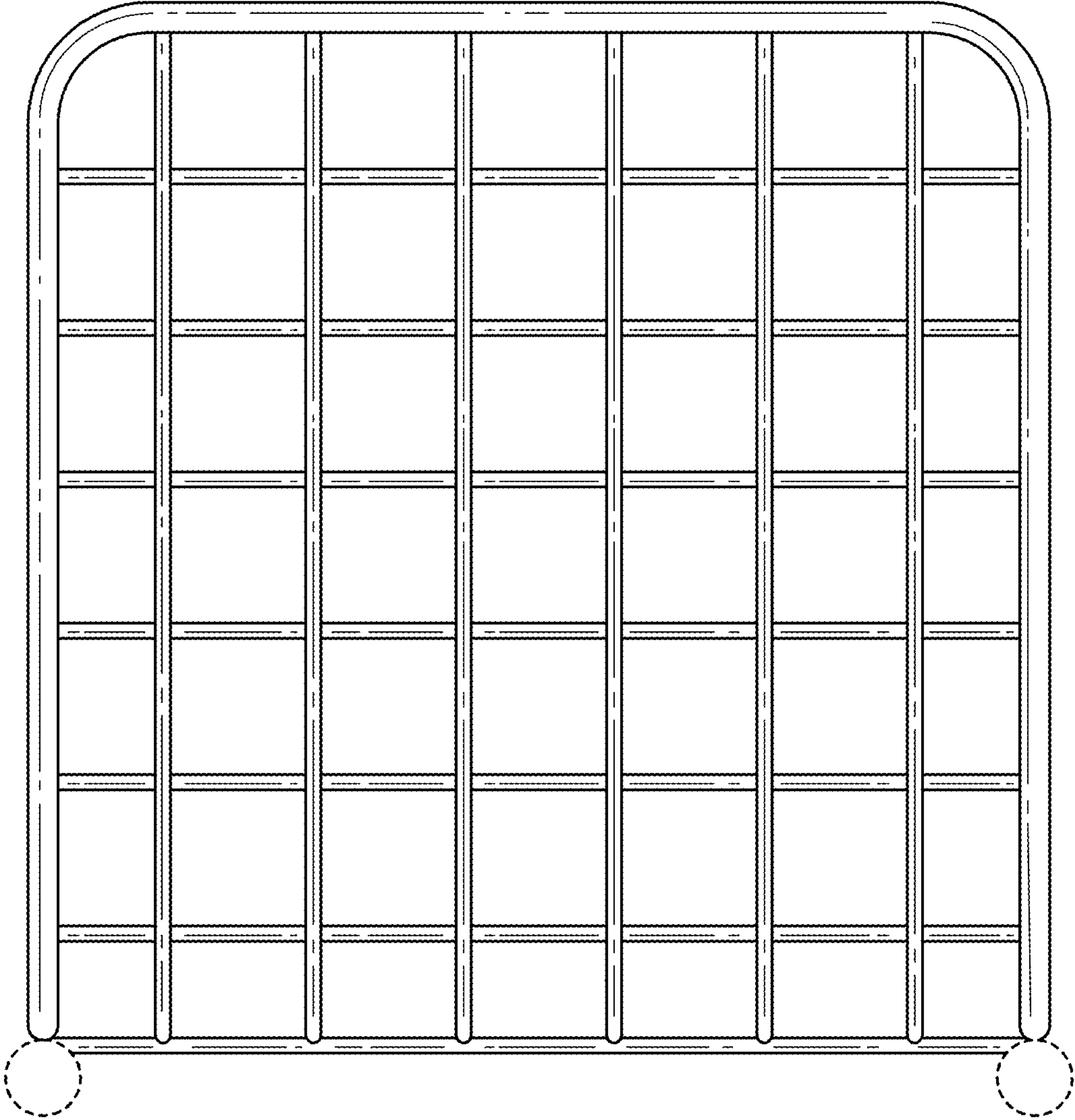

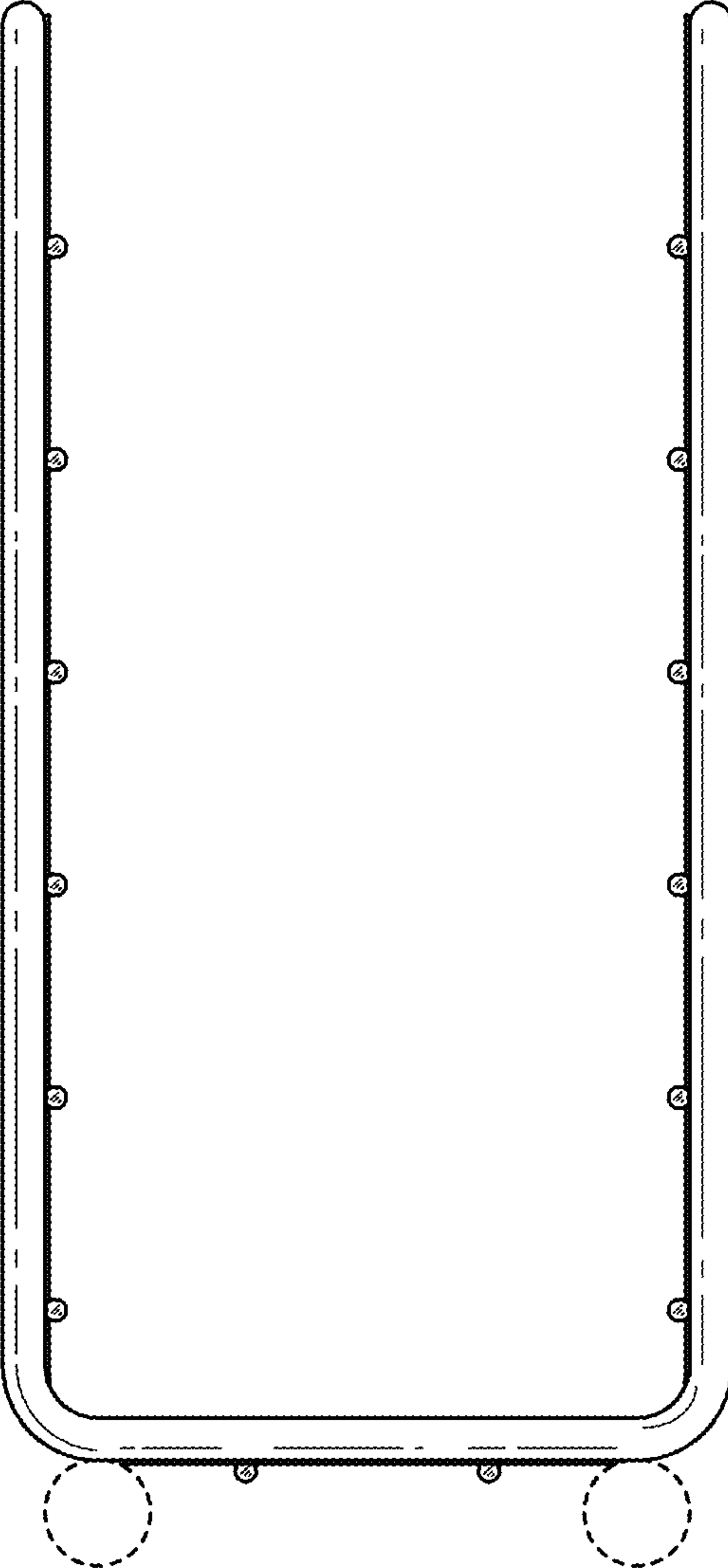

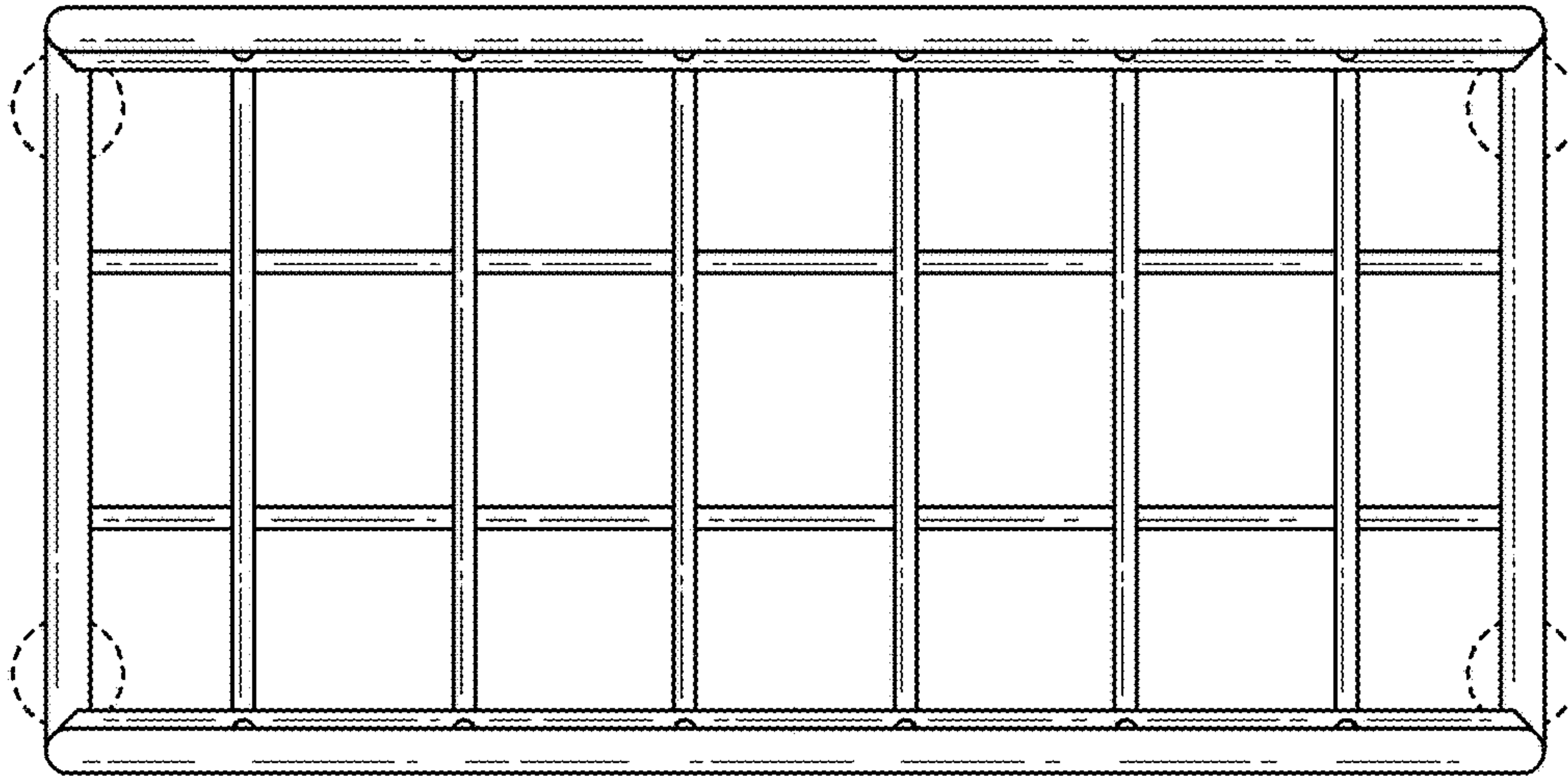

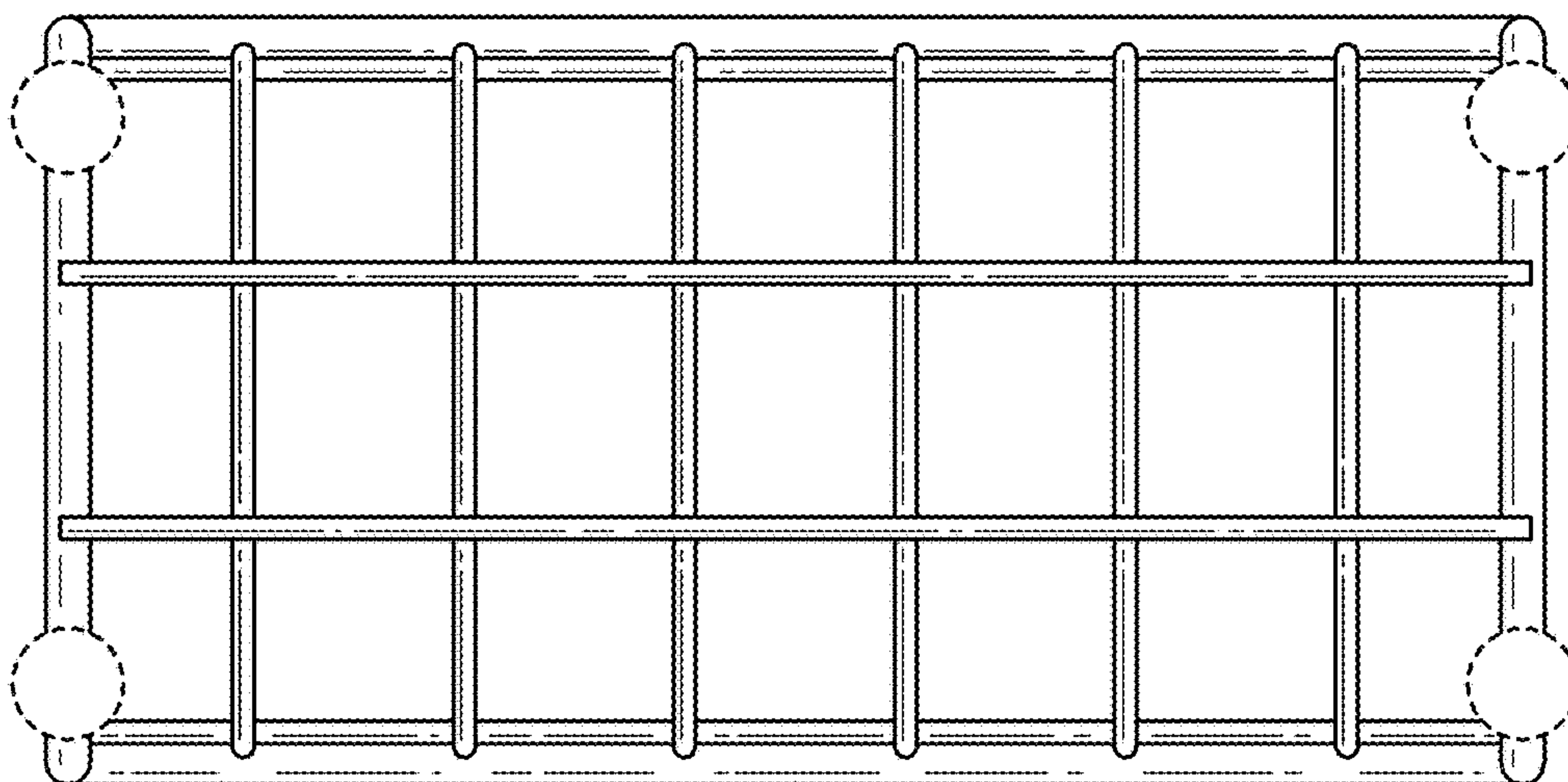
