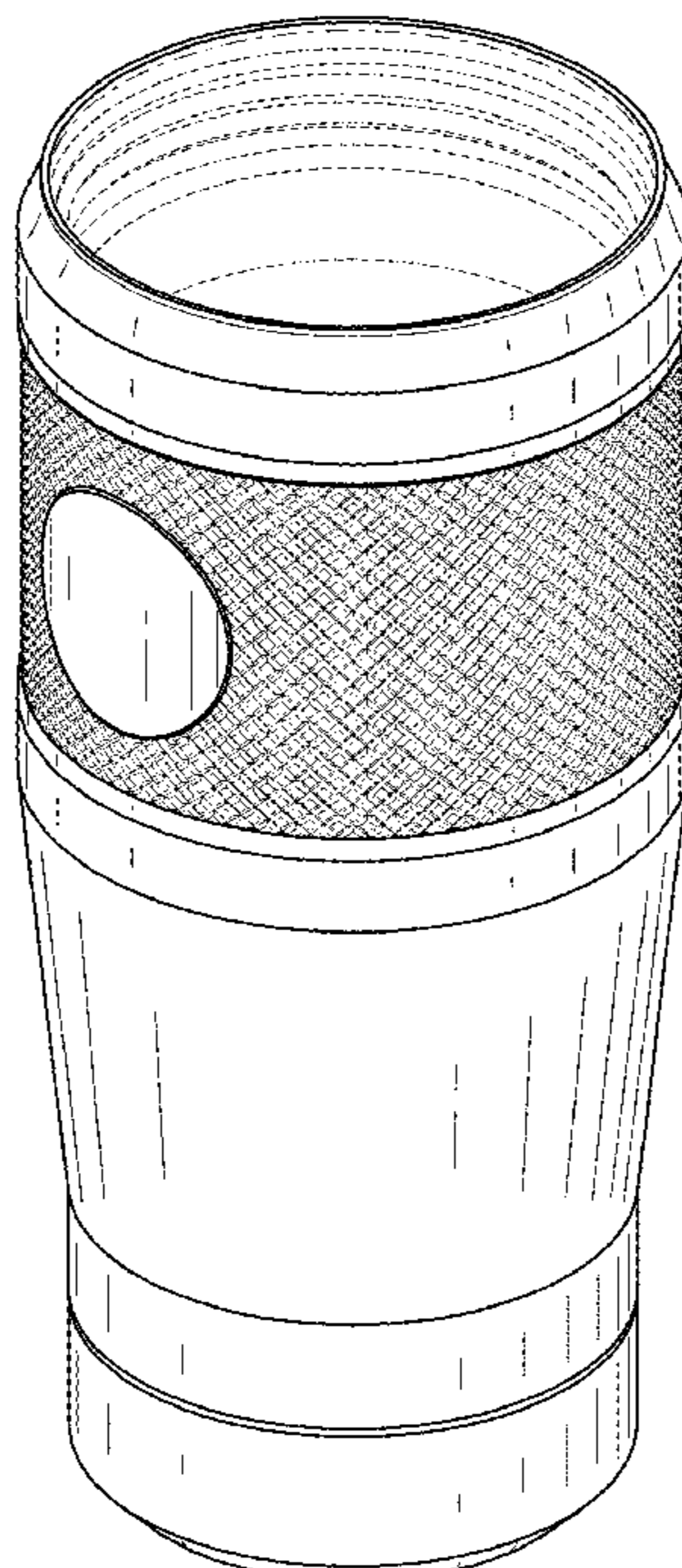

DESCRIPTION
FIG. 1 is a perspective view of a bottle;
FIG. 2 is a front view of the bottle;
FIG. 3 is a rear view of the bottle;
FIG. 4 is a left side view of the bottle;
FIG. 5 is a right side view of the bottle;
FIG. 6 is a top view of the bottle; and,
FIG. 7 is a bottom view of the bottle.

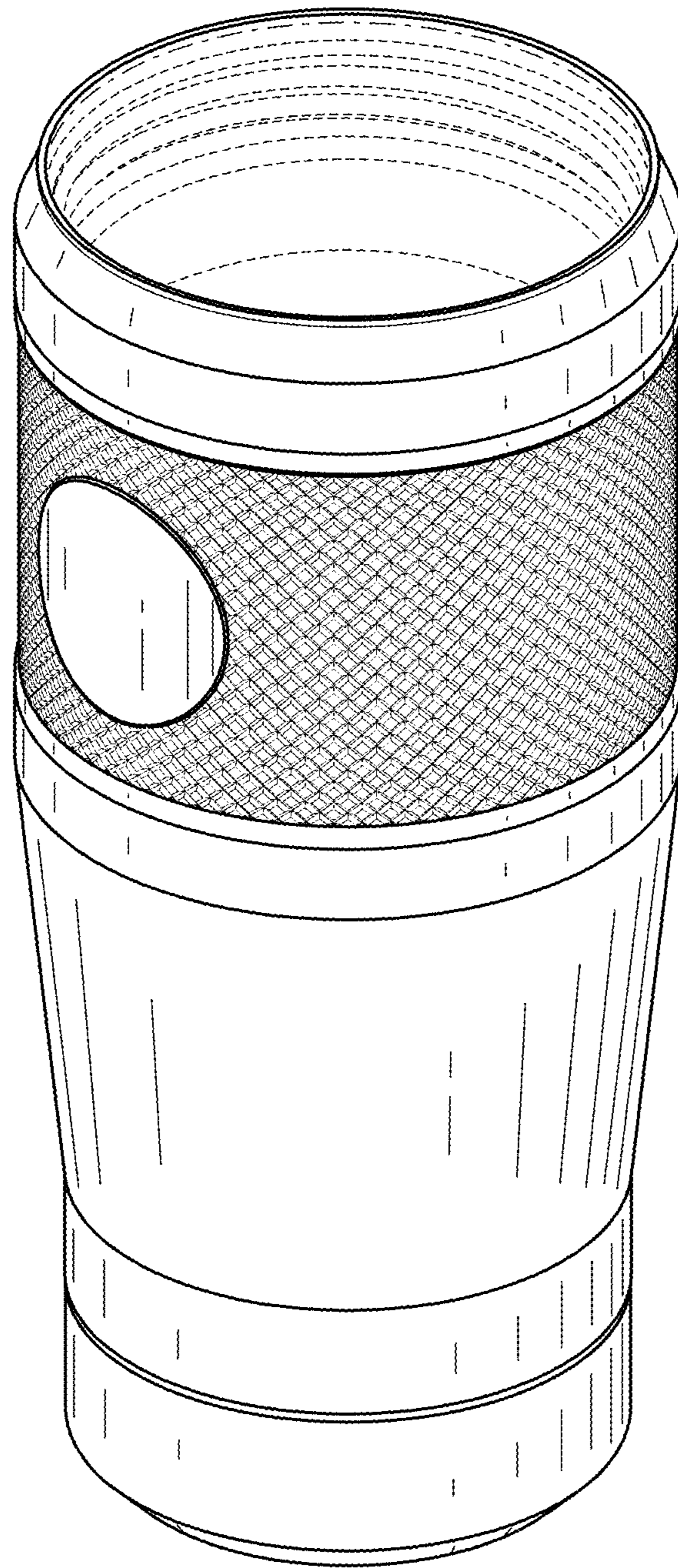

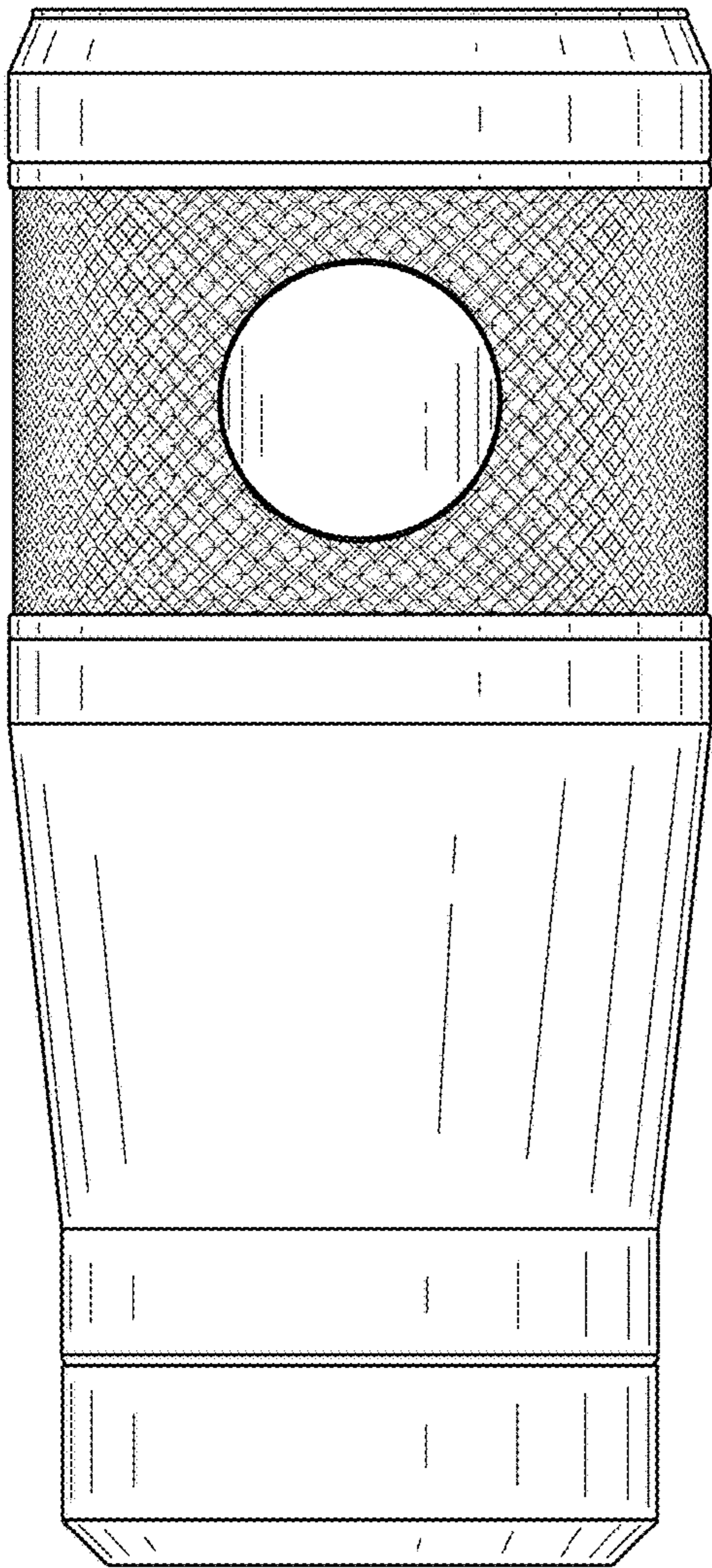

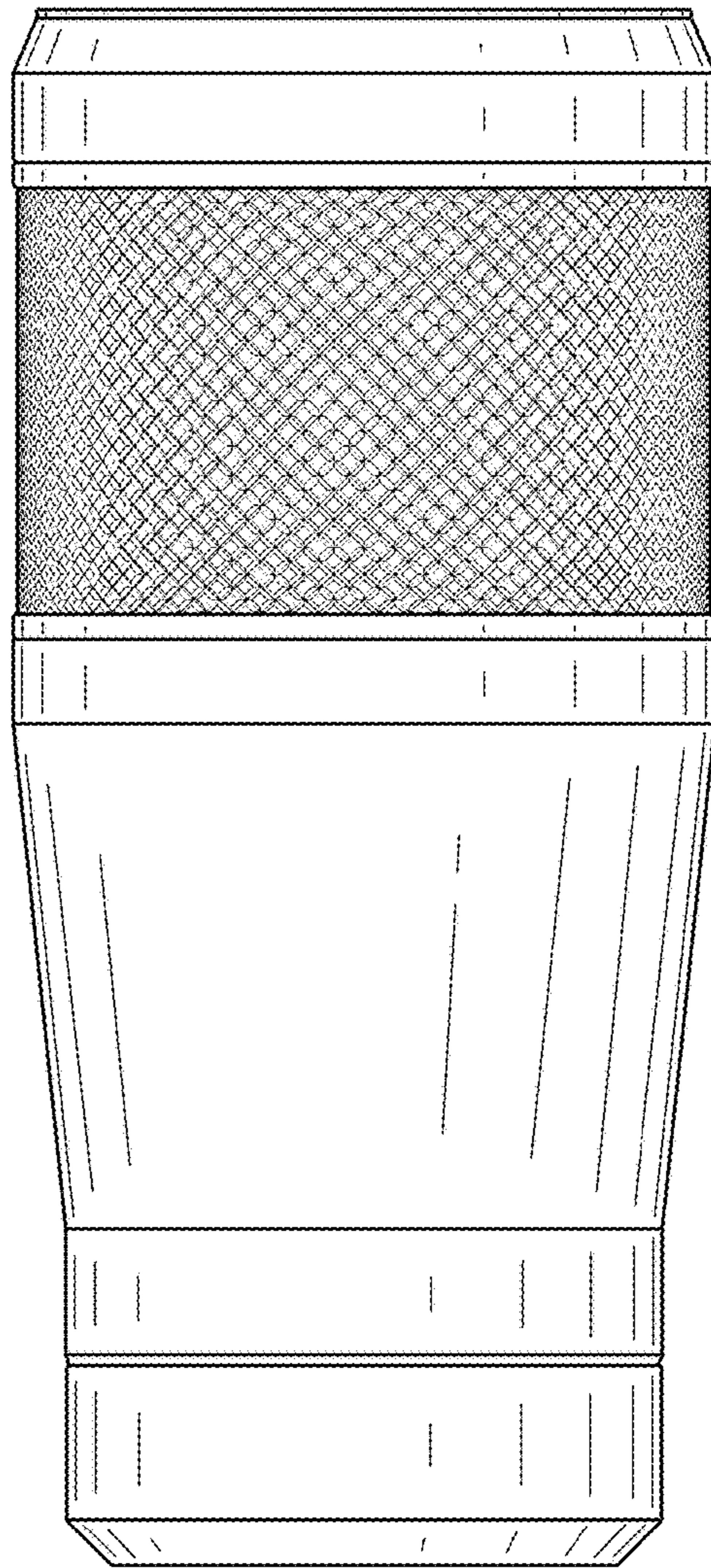

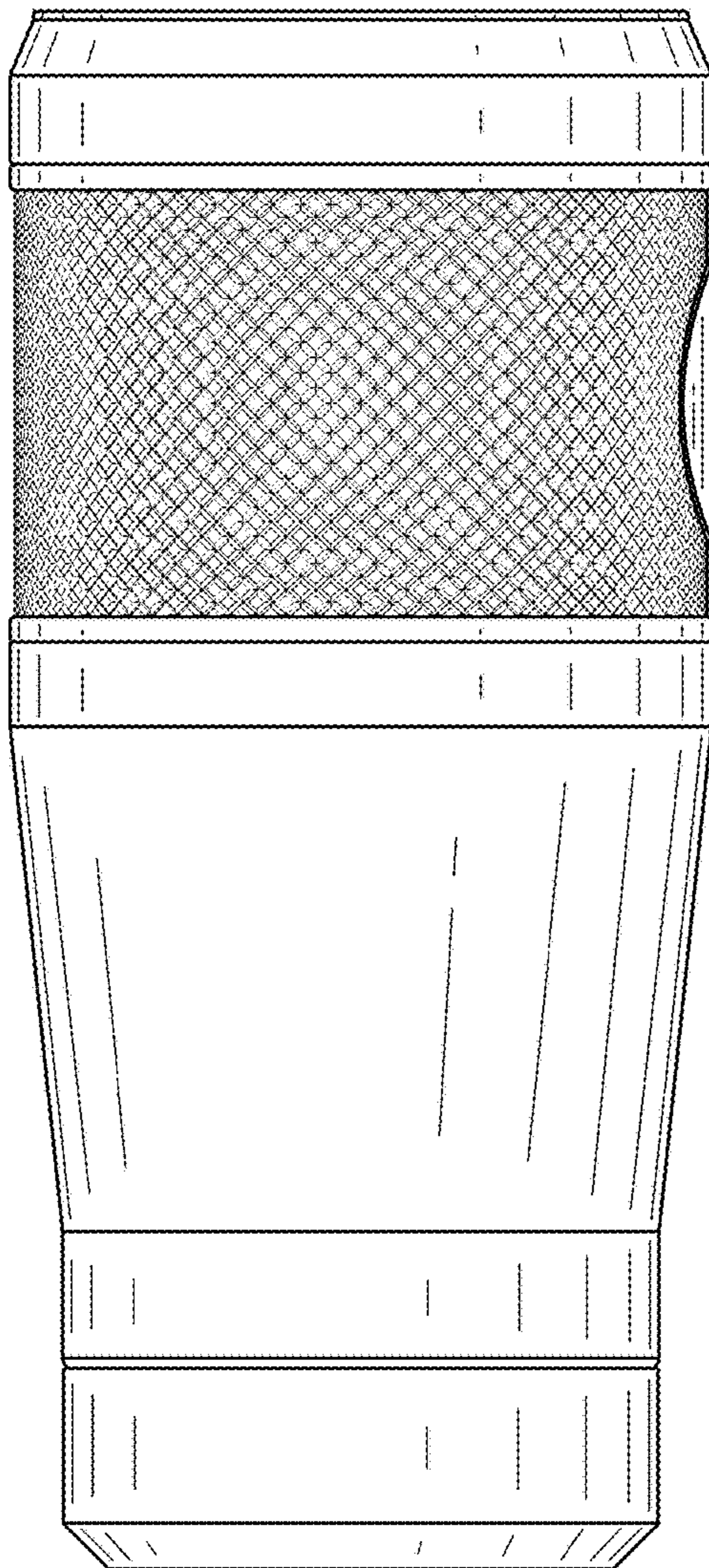

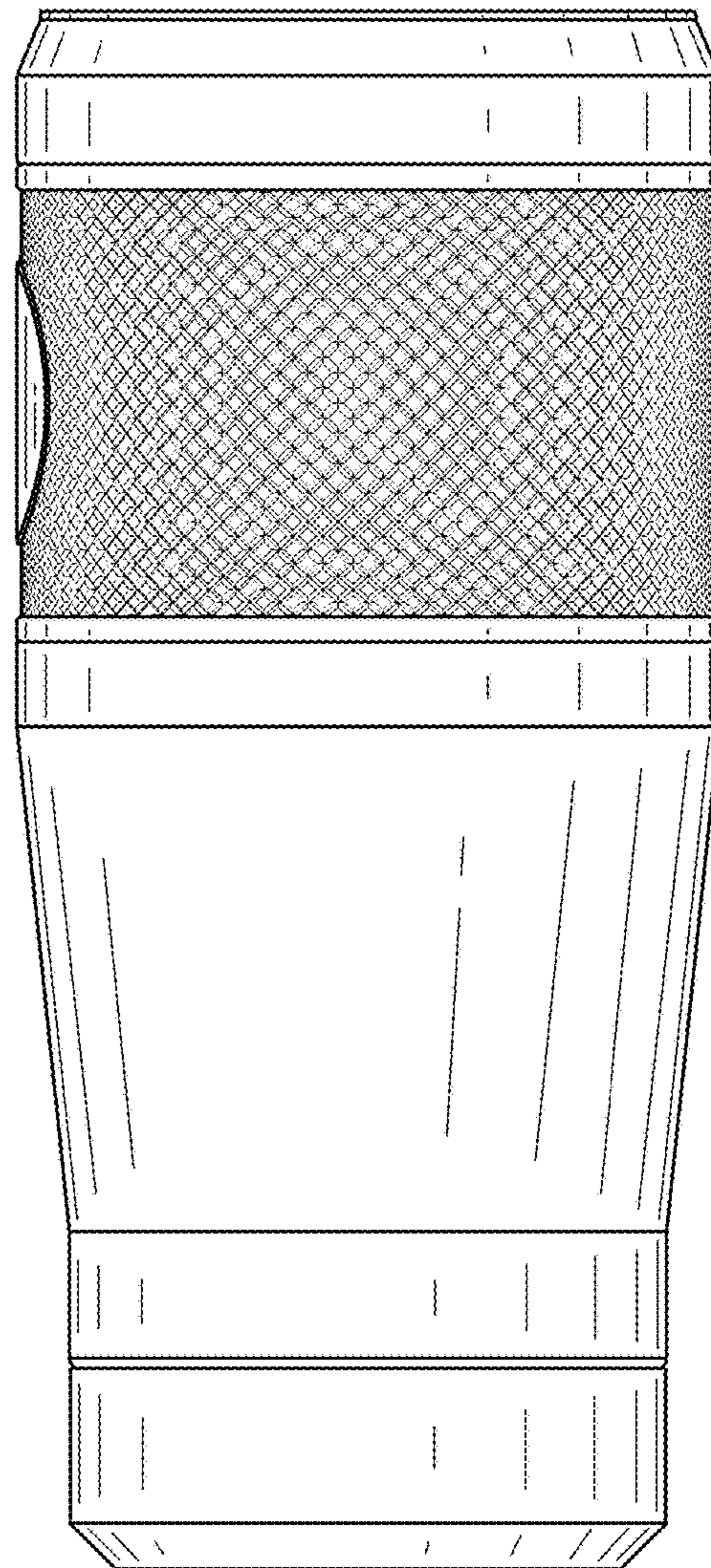

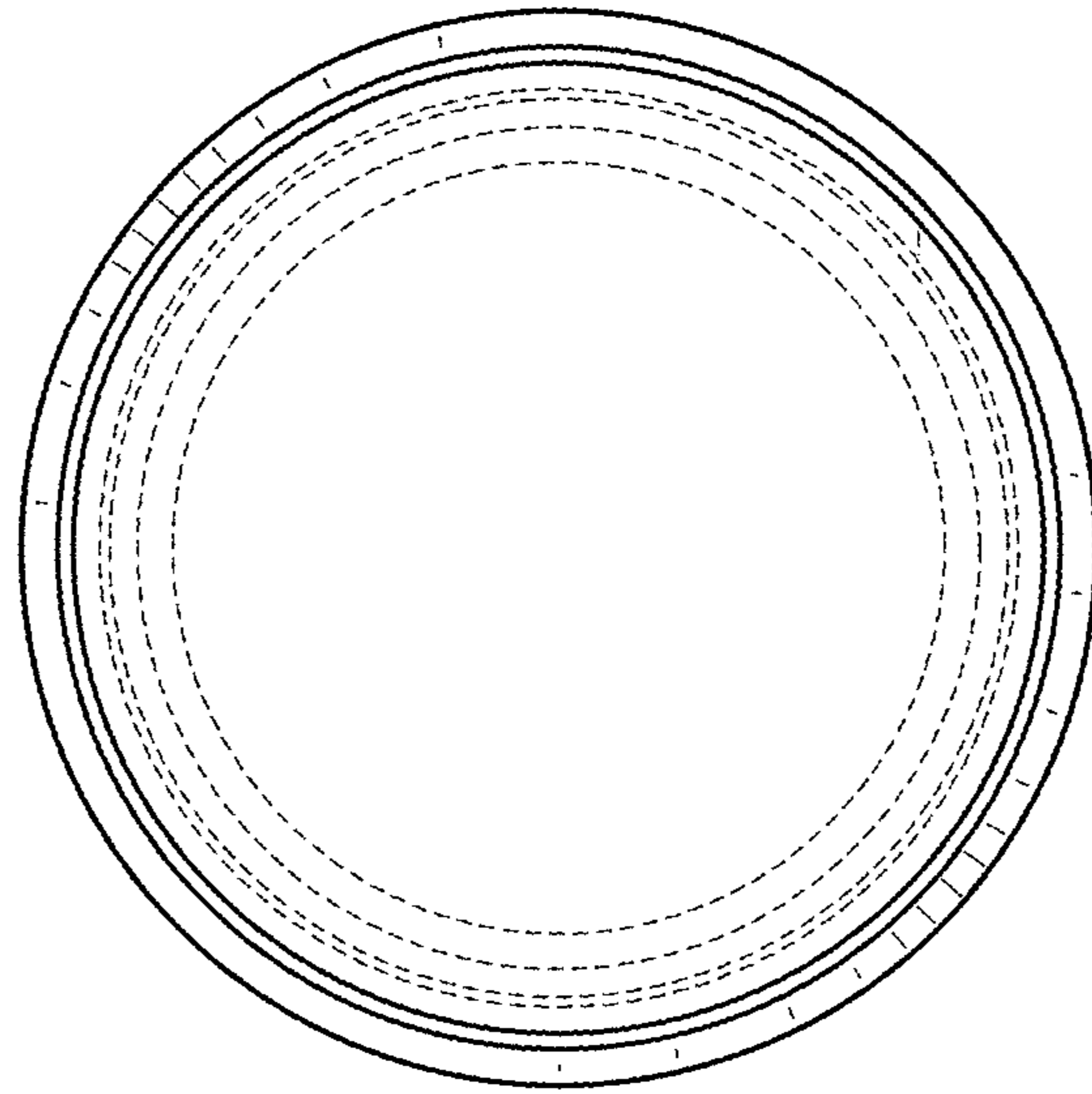

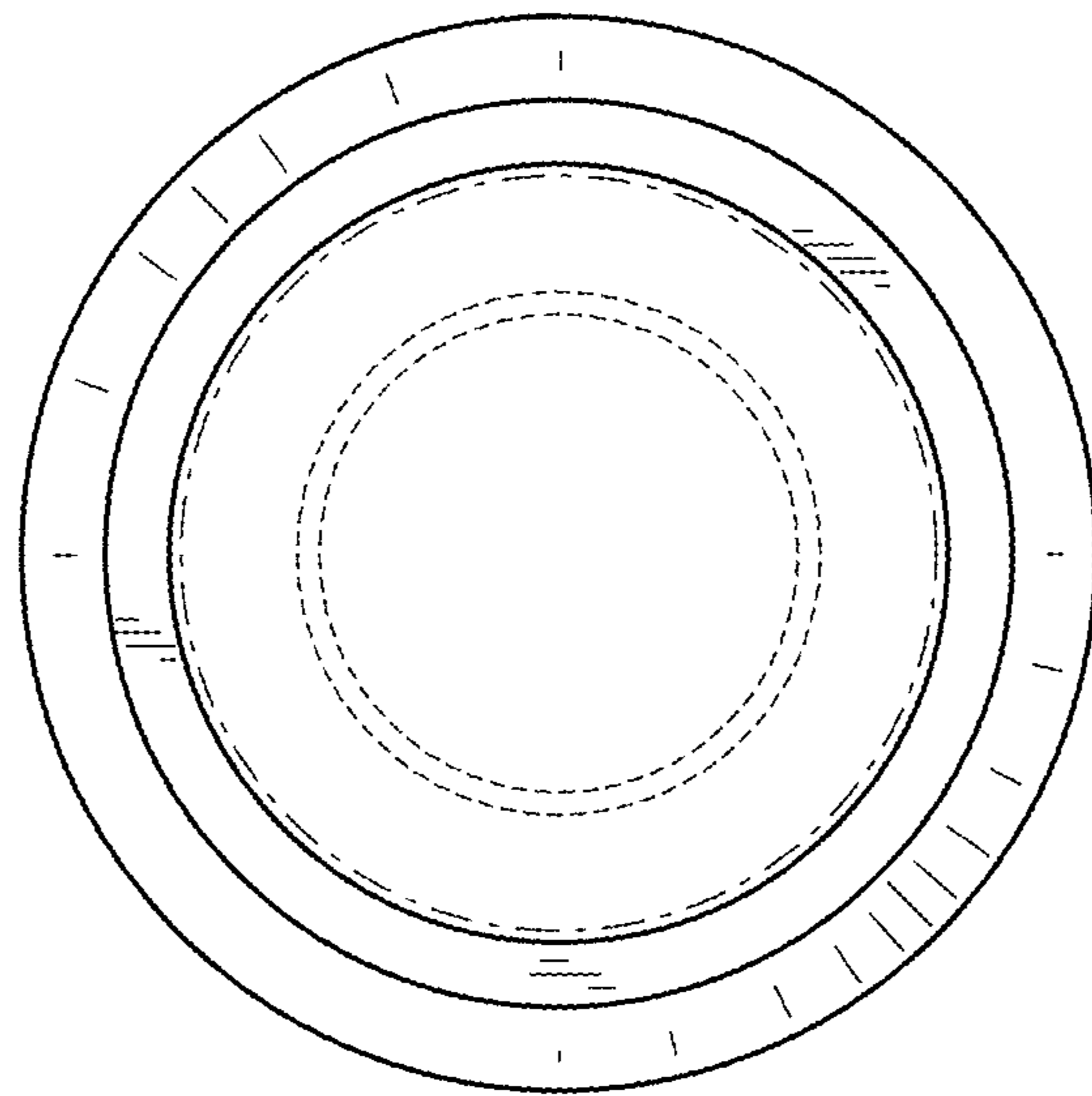
