FIG. 16 is another front perspective view thereof.

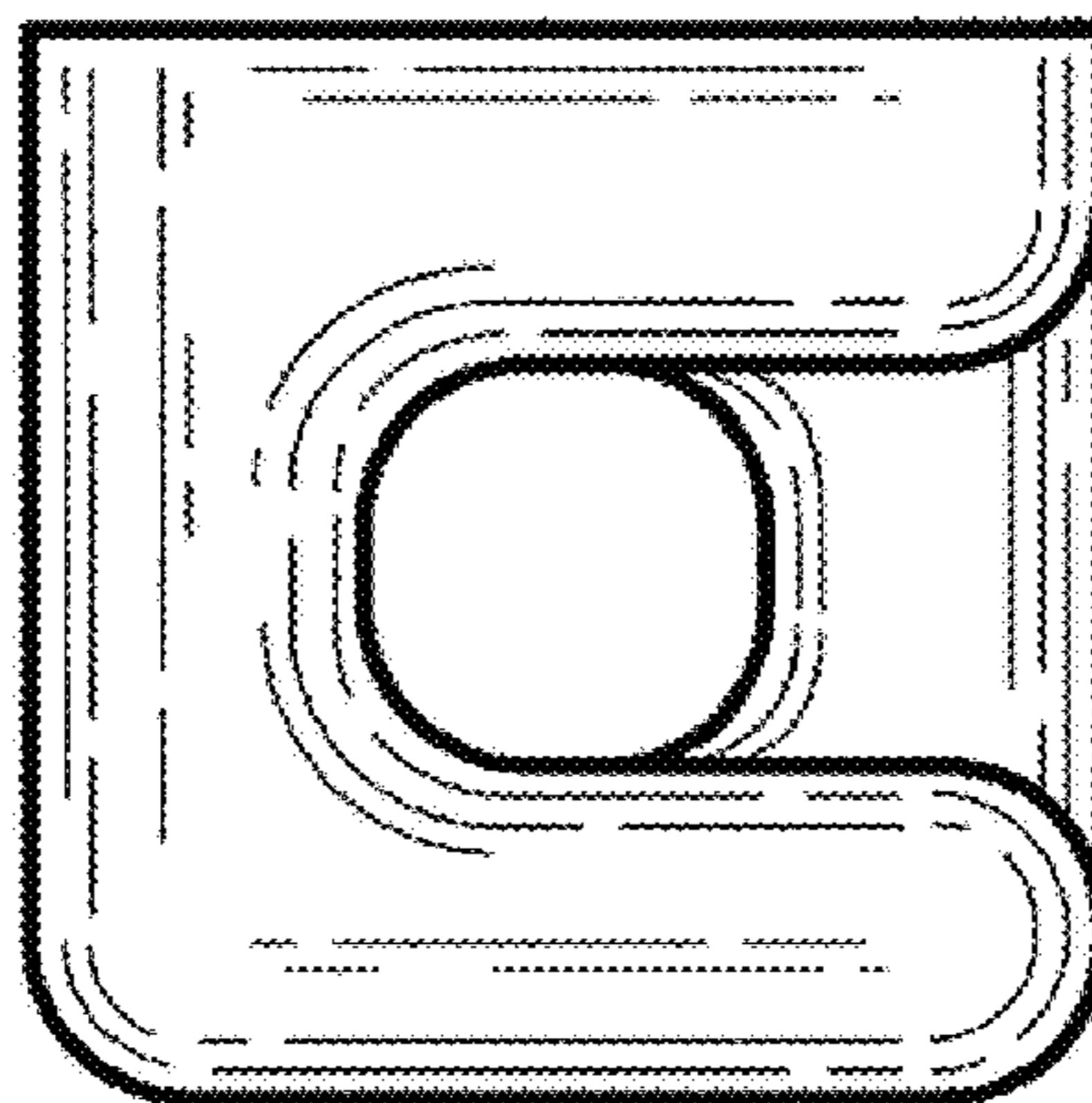

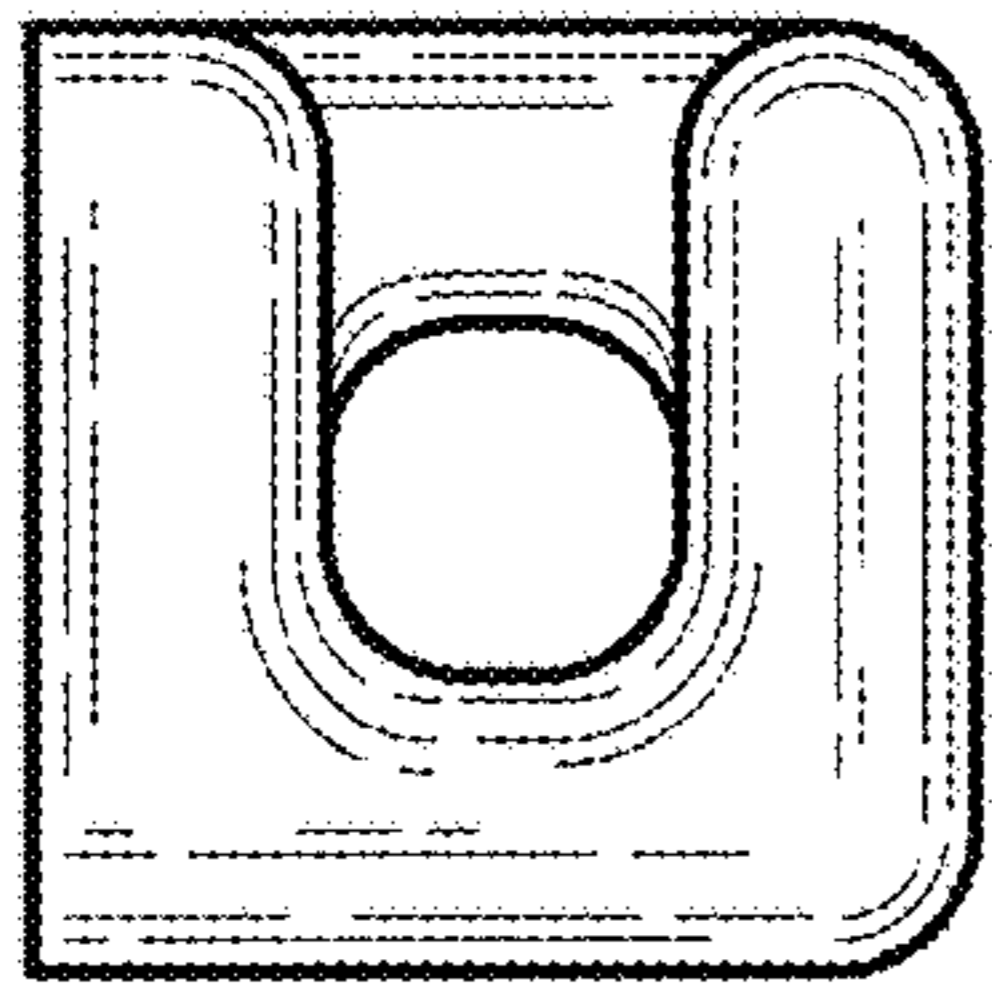

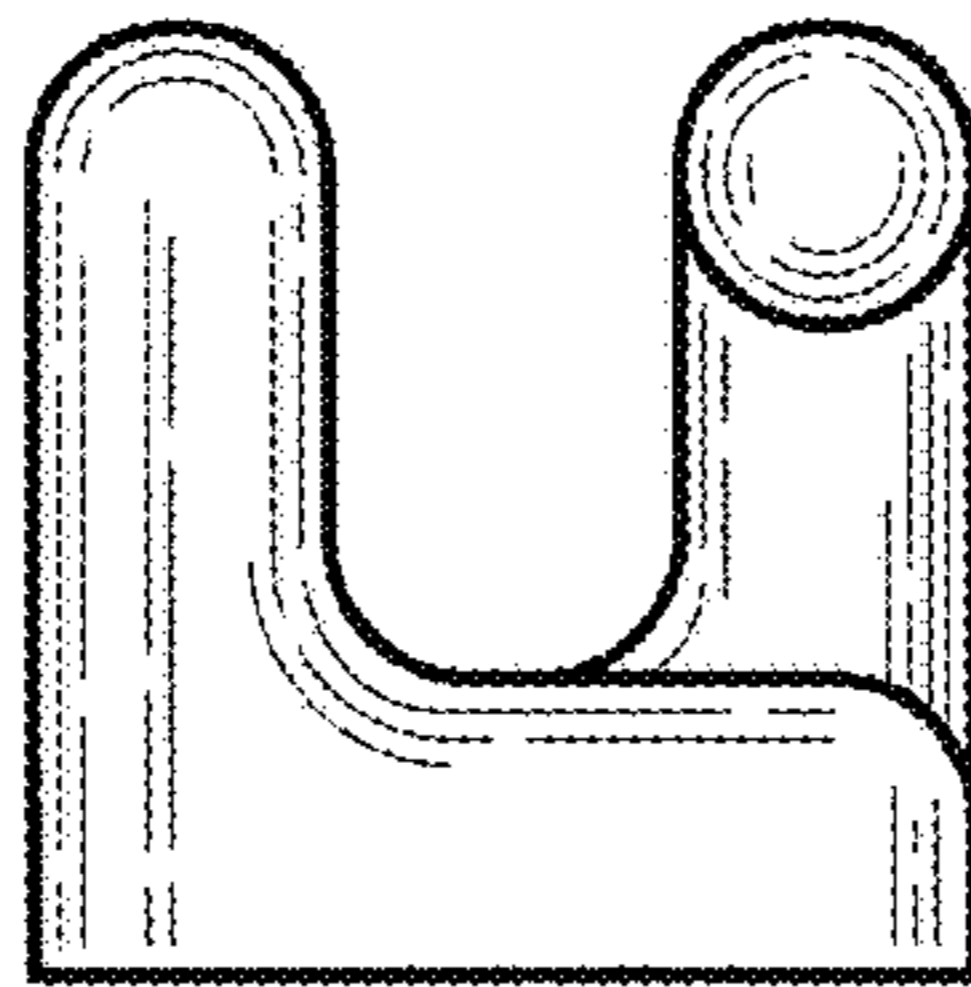

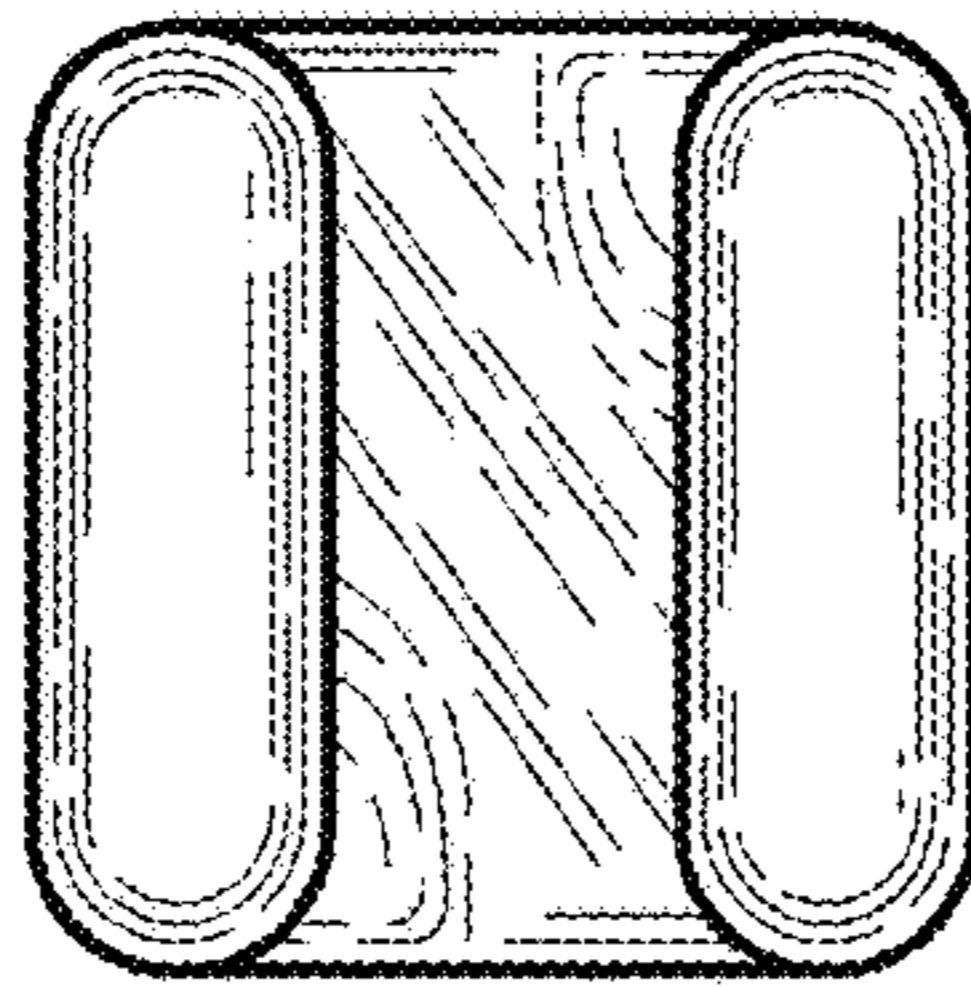

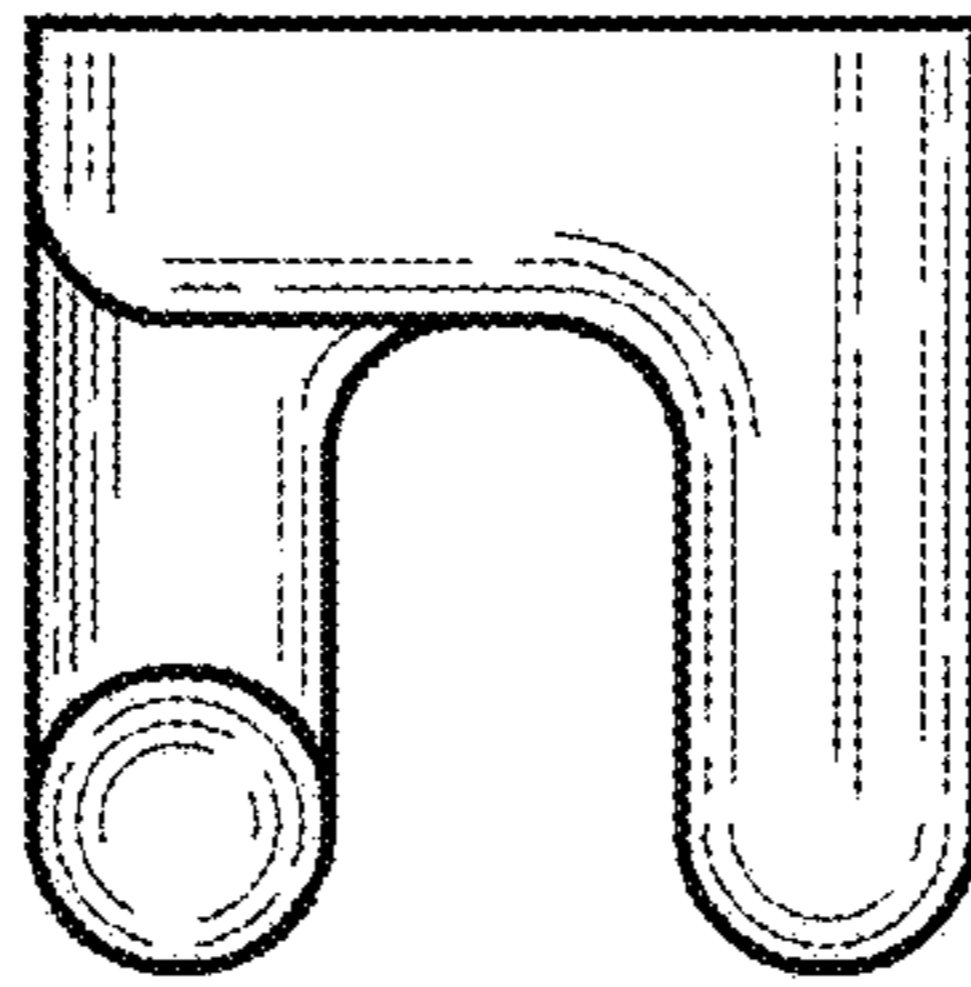

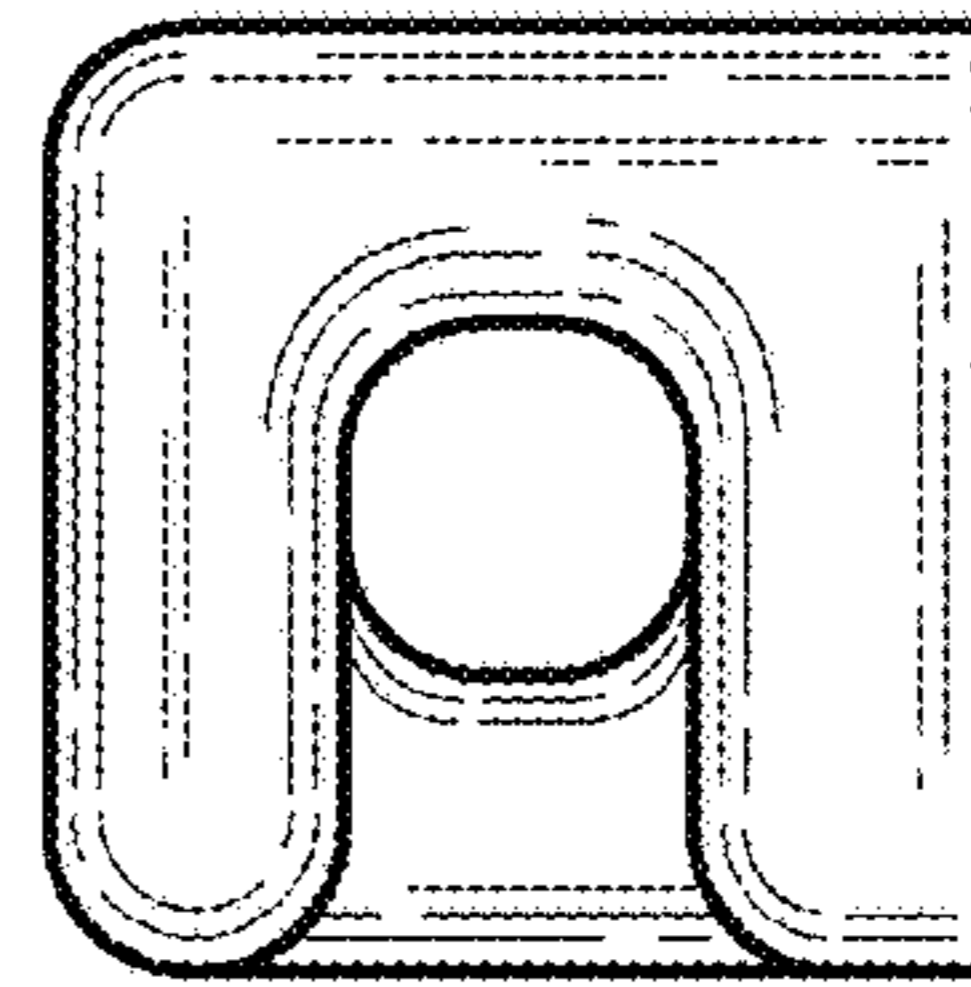

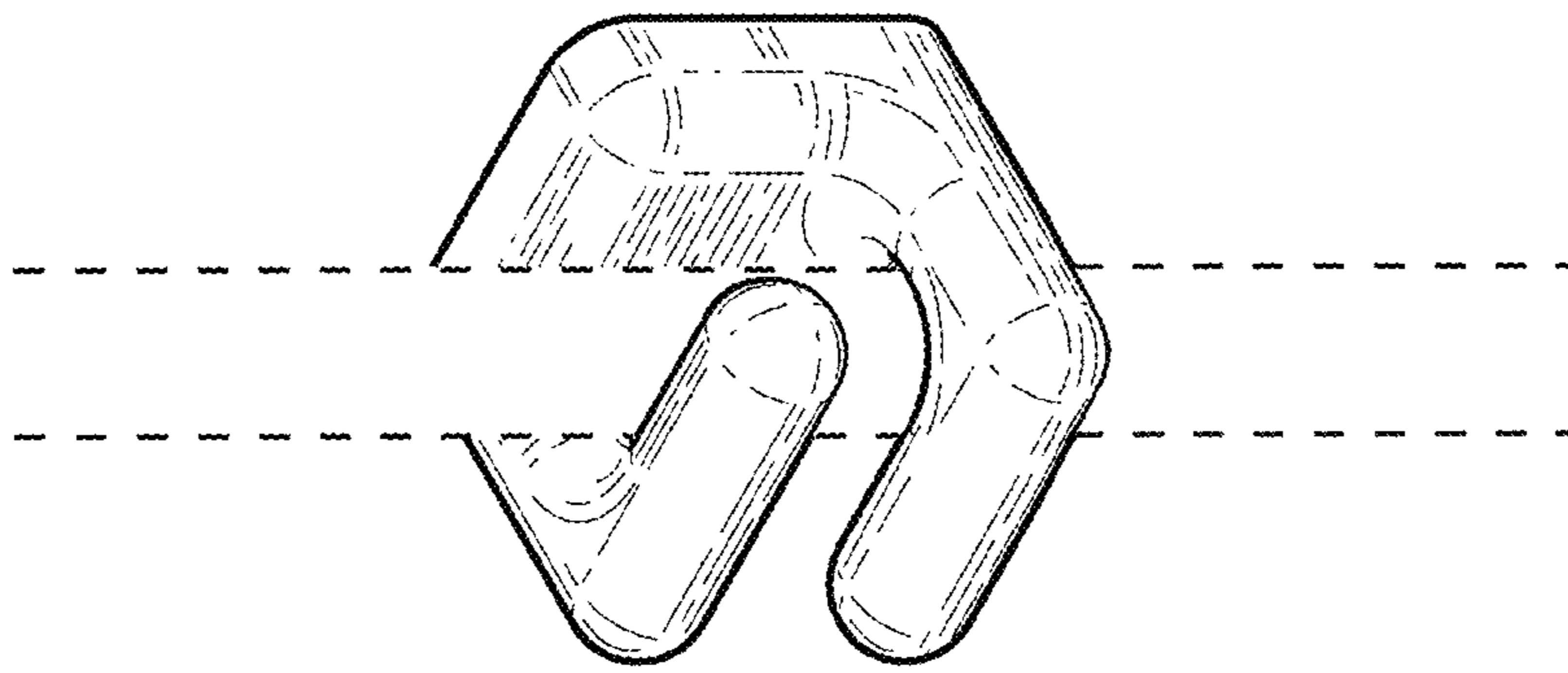

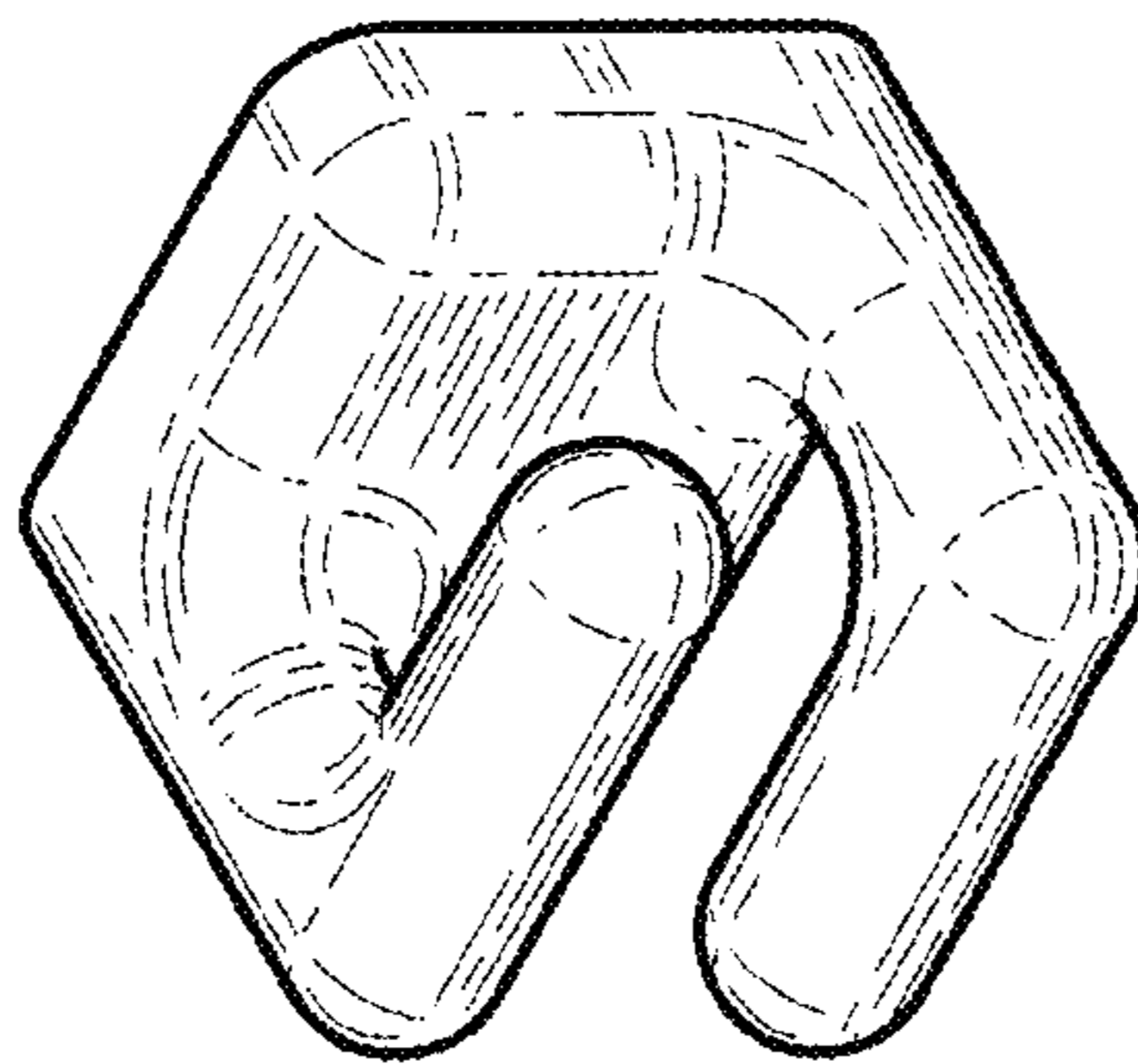

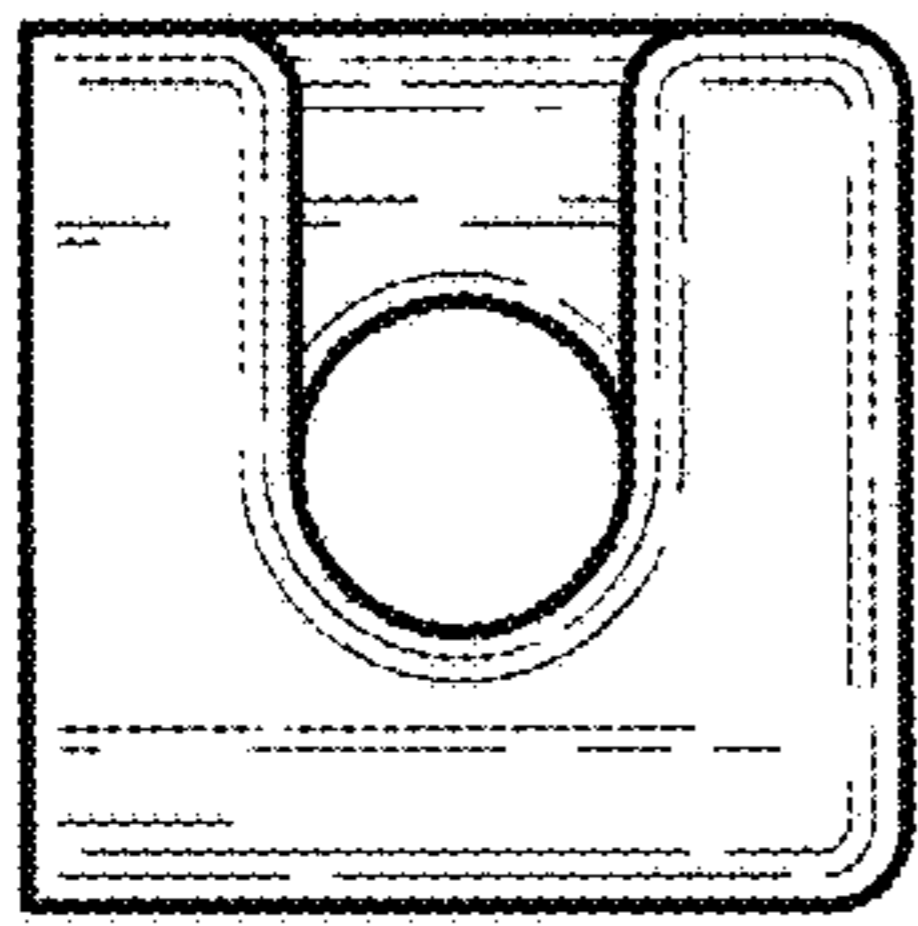

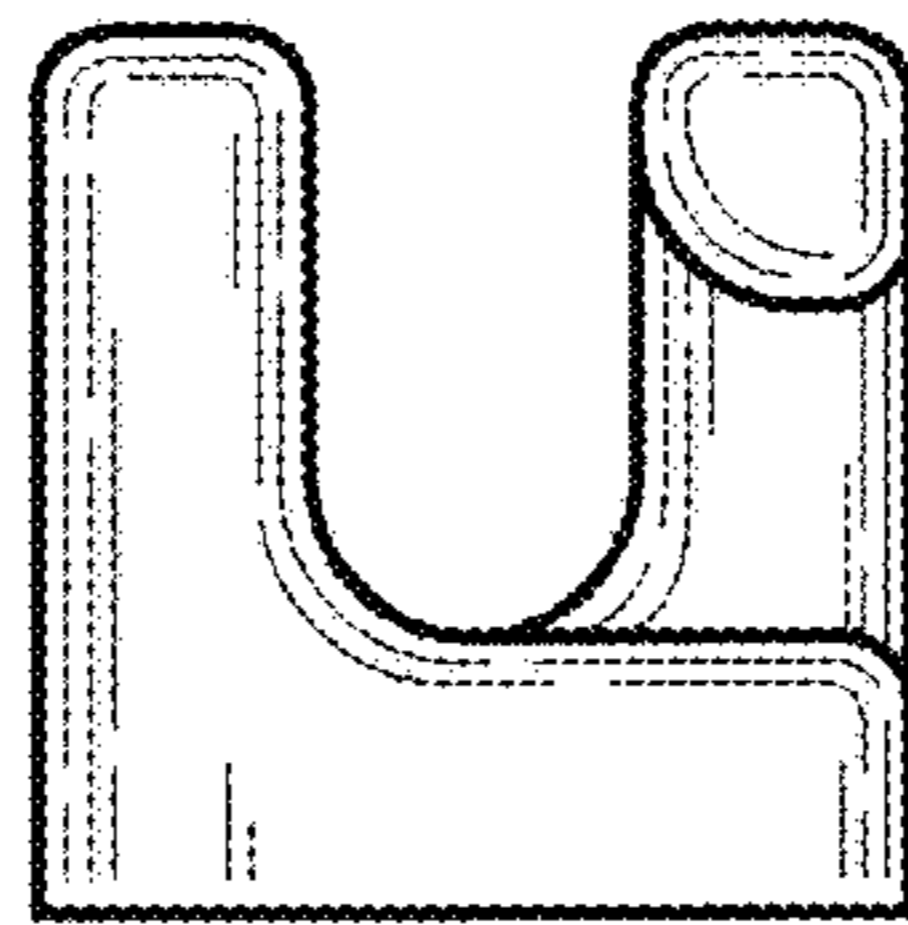

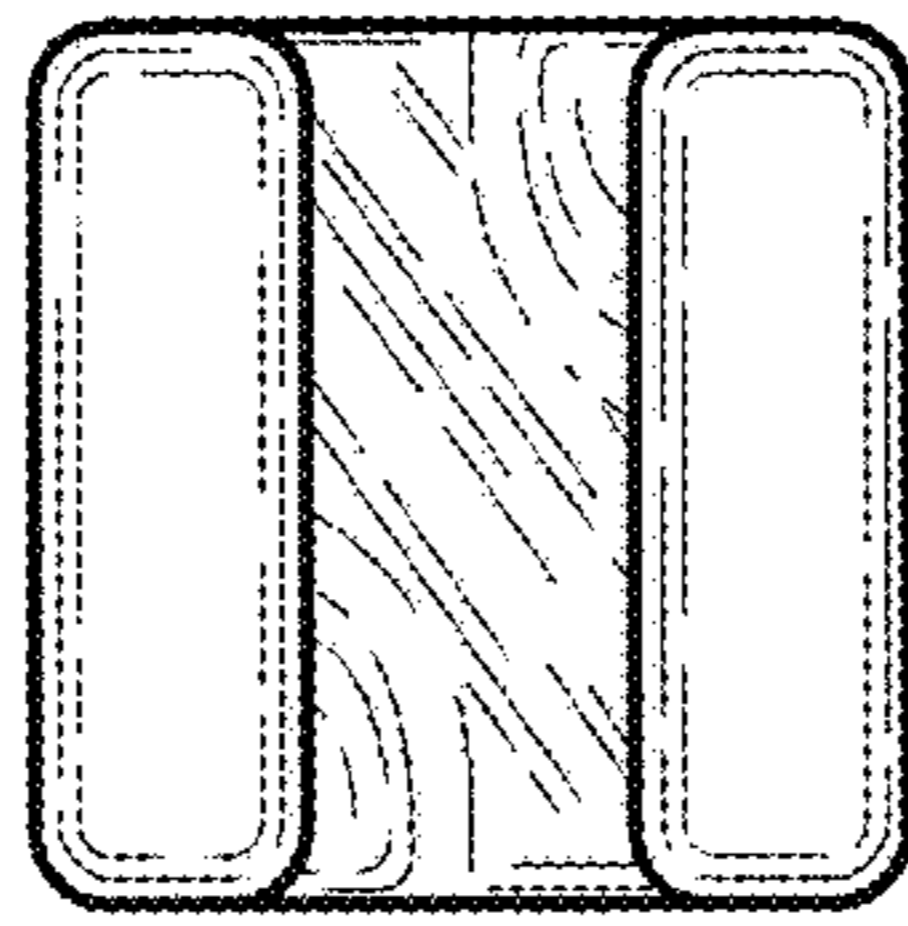

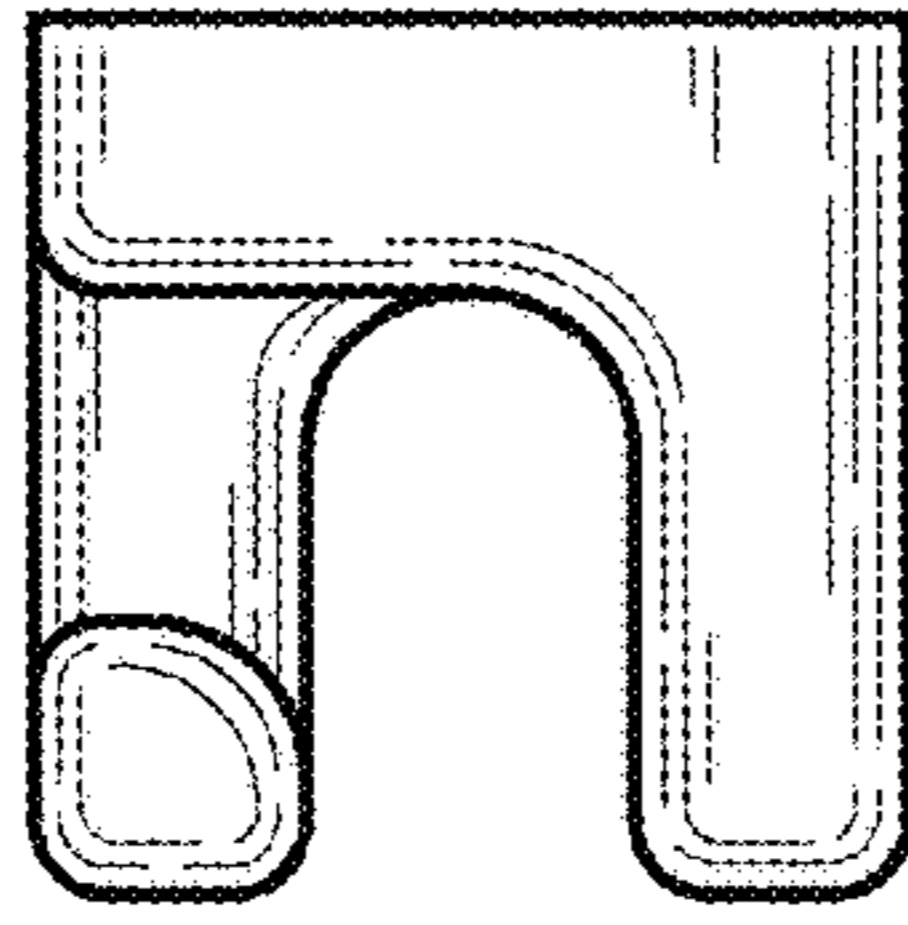

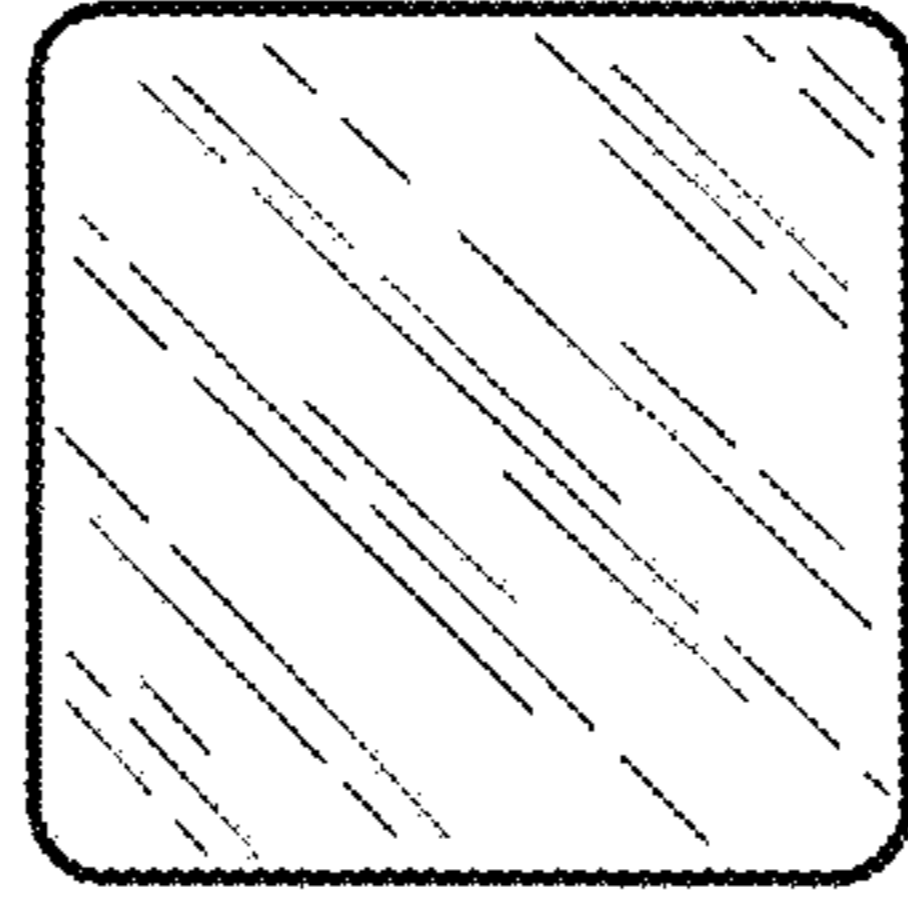

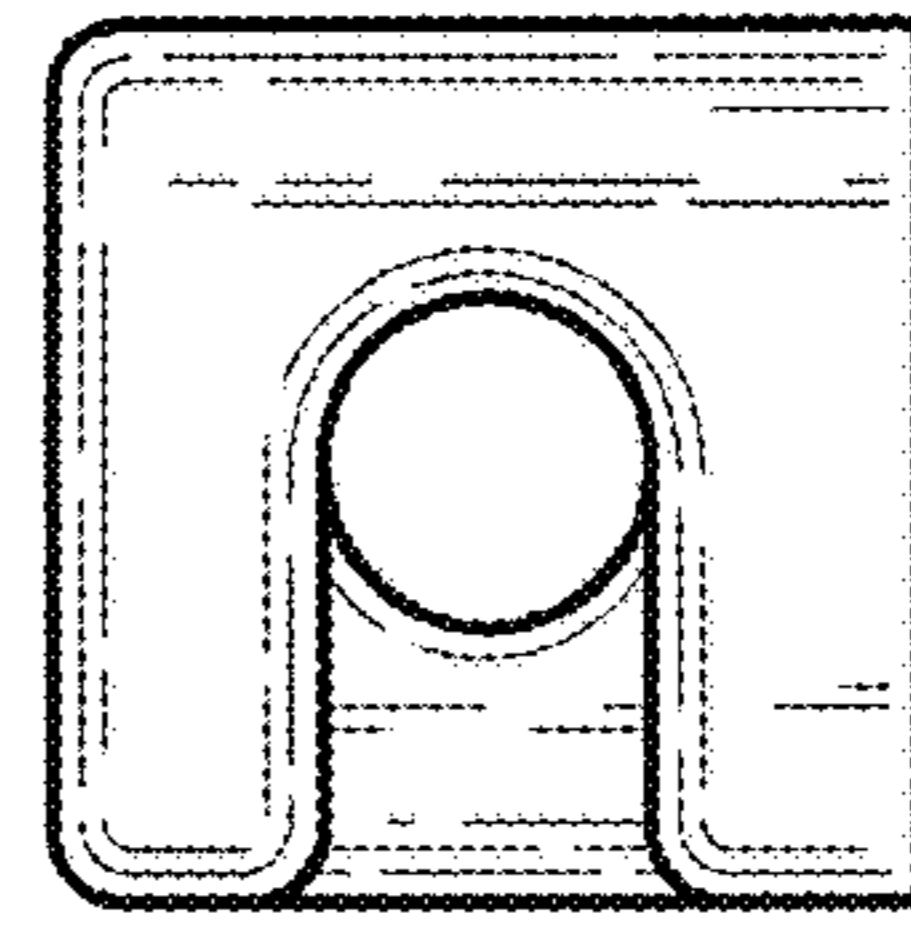

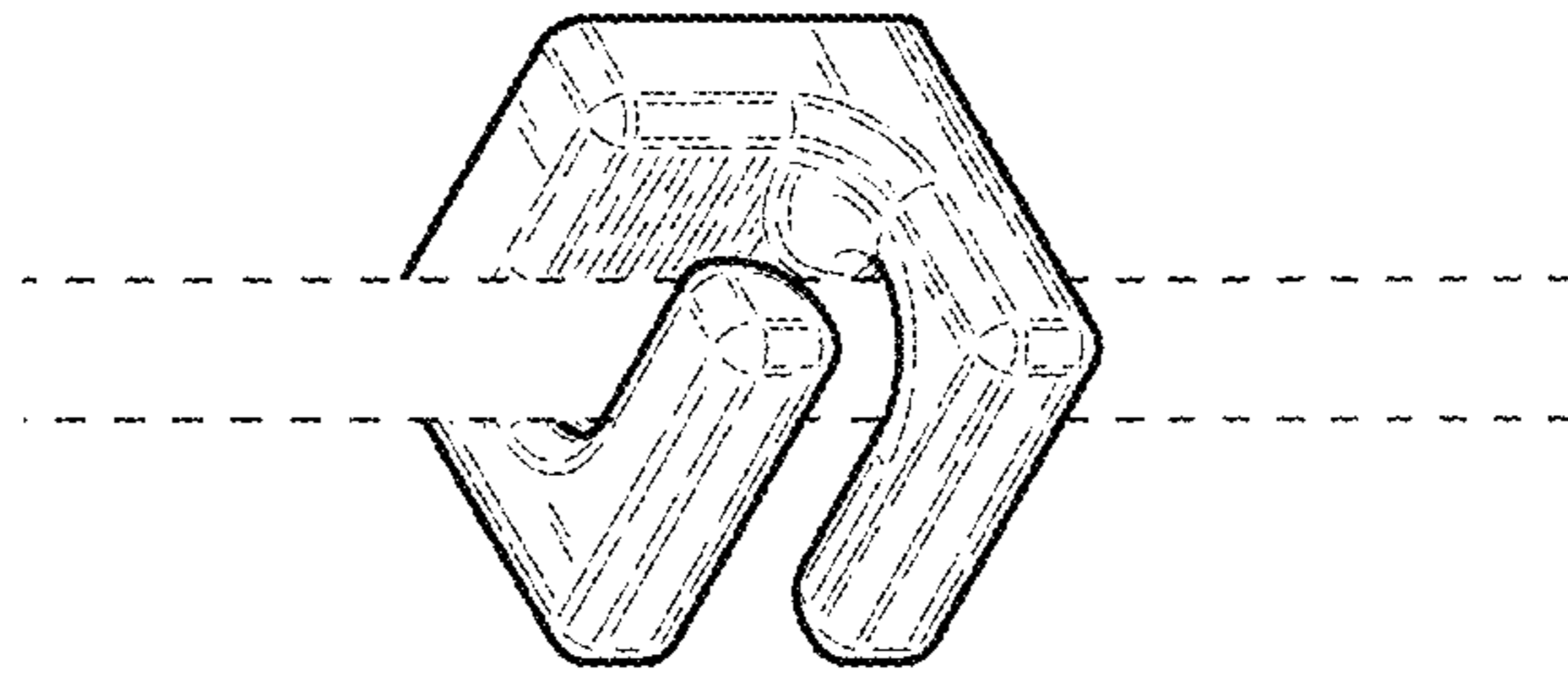

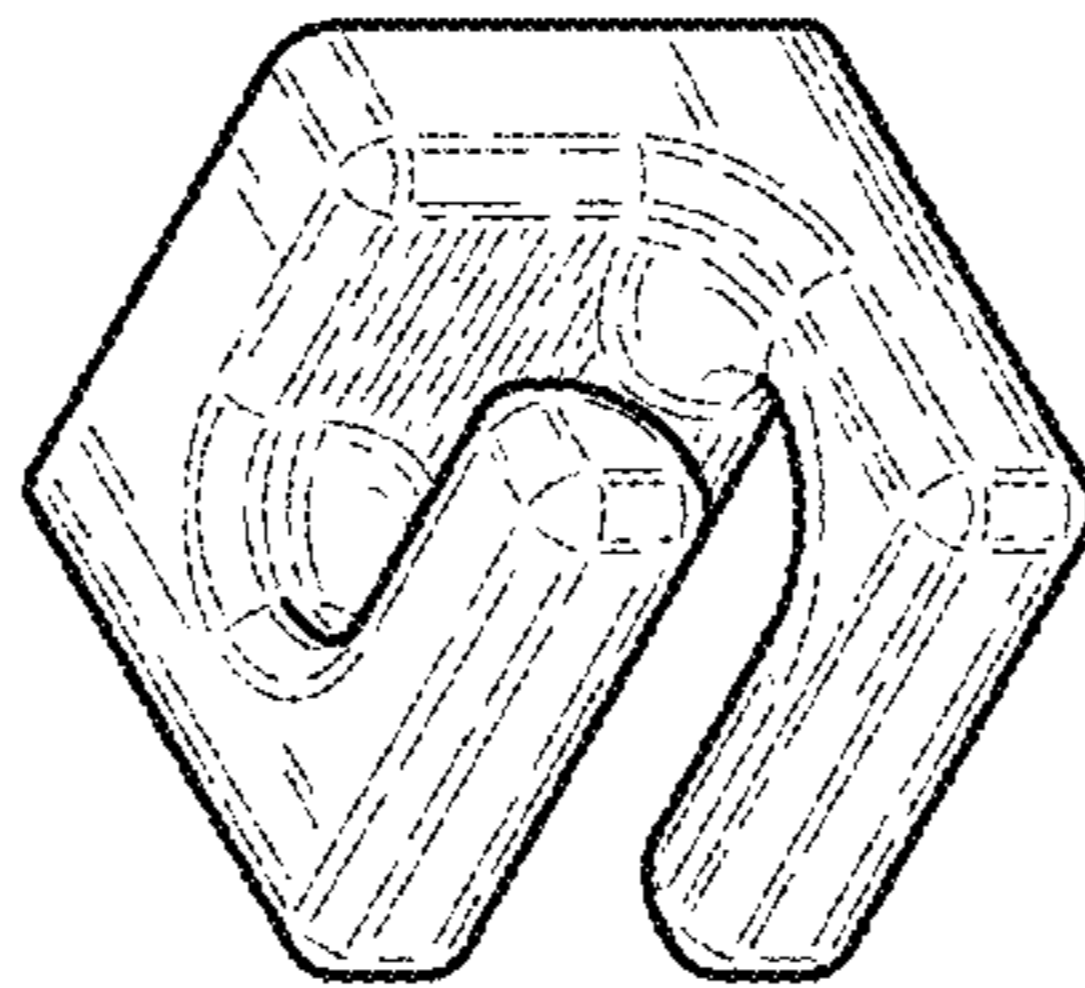
