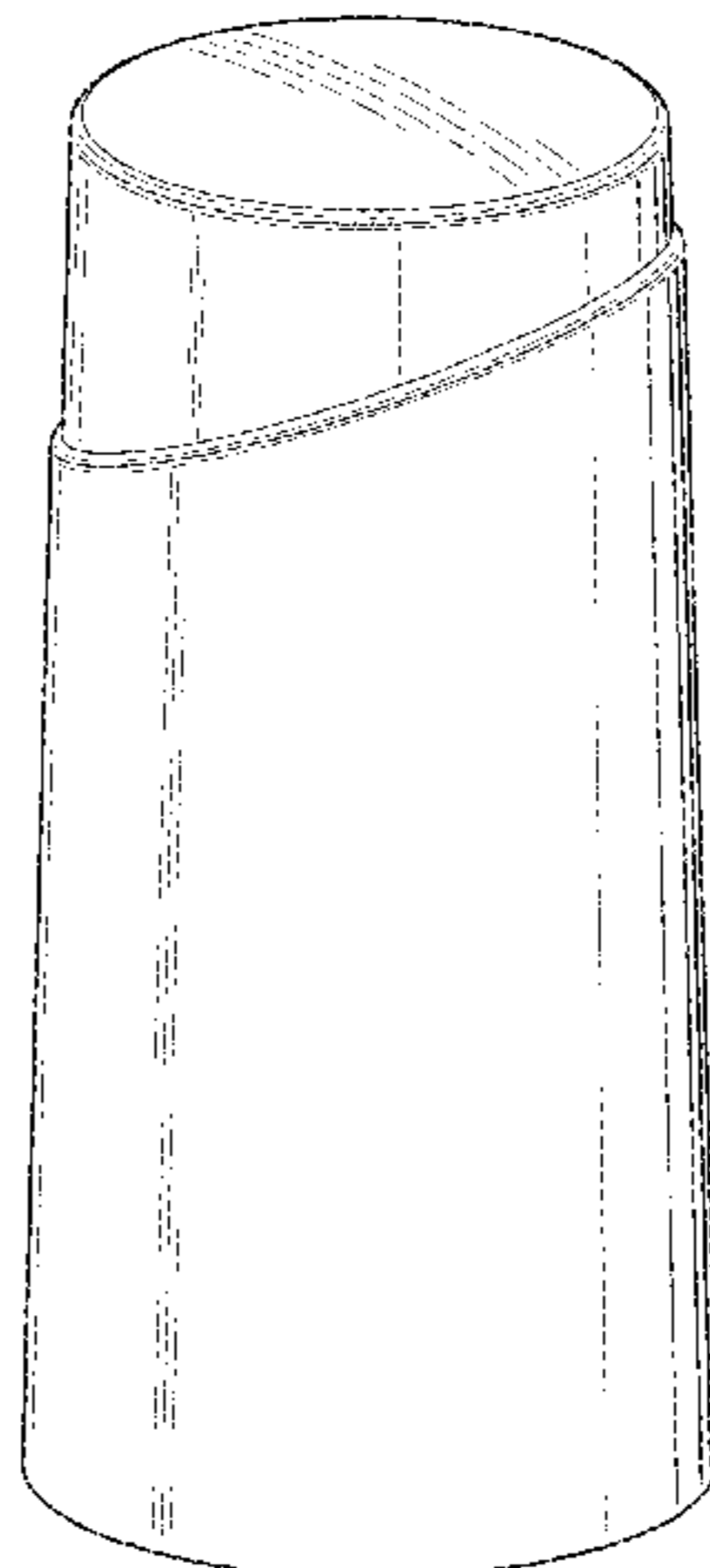
(57) **CLAIM**

The ornamental design for a cap for a personal care product container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the cap for a personal care product container embodying the new design;
FIG. 2 is a right side view thereof, the left side view being a mirror image thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a bottom view thereof; and,
FIG. 6 is a top view thereof.
FIG. 5 shows portions of the design in phantom lines. These features are shown for environmental purposes and do not form any part of the claimed design.

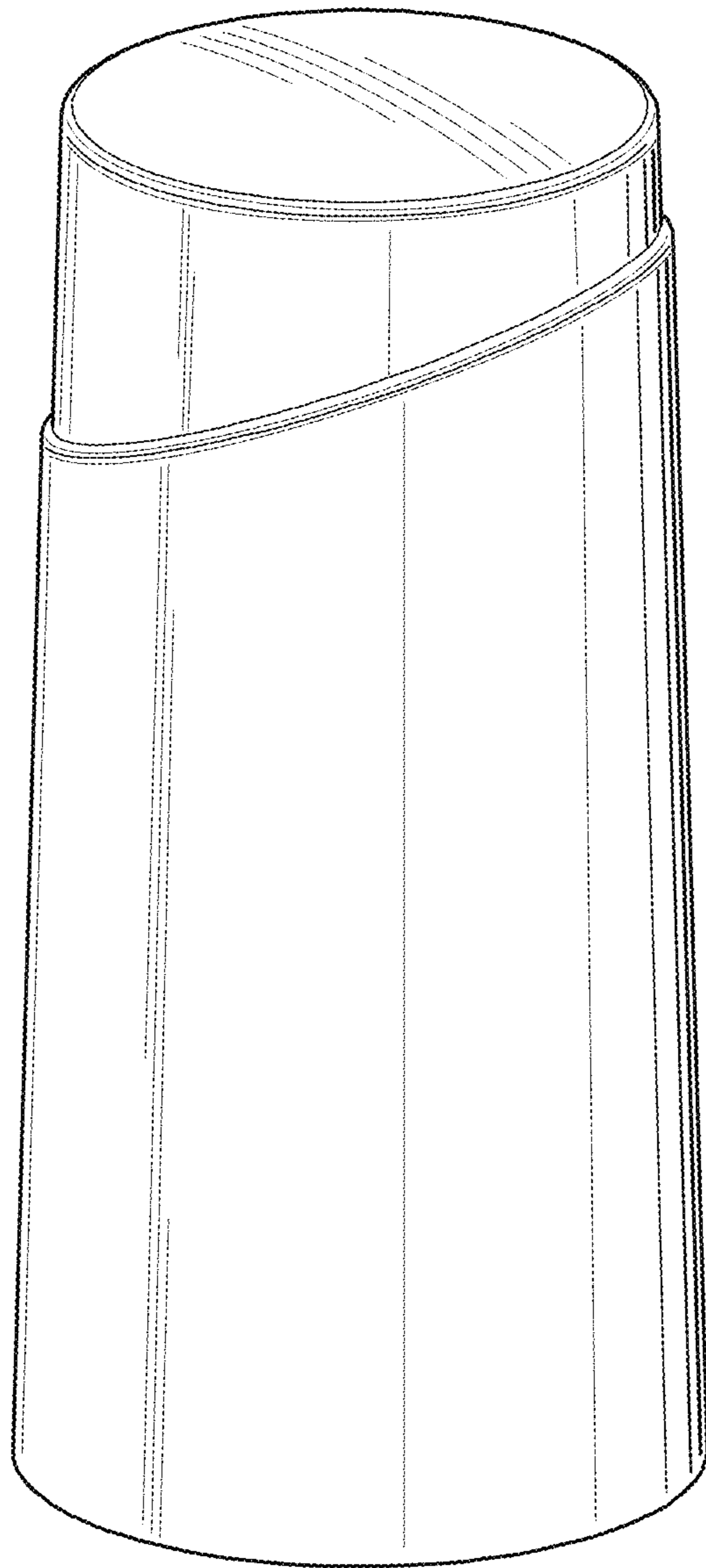

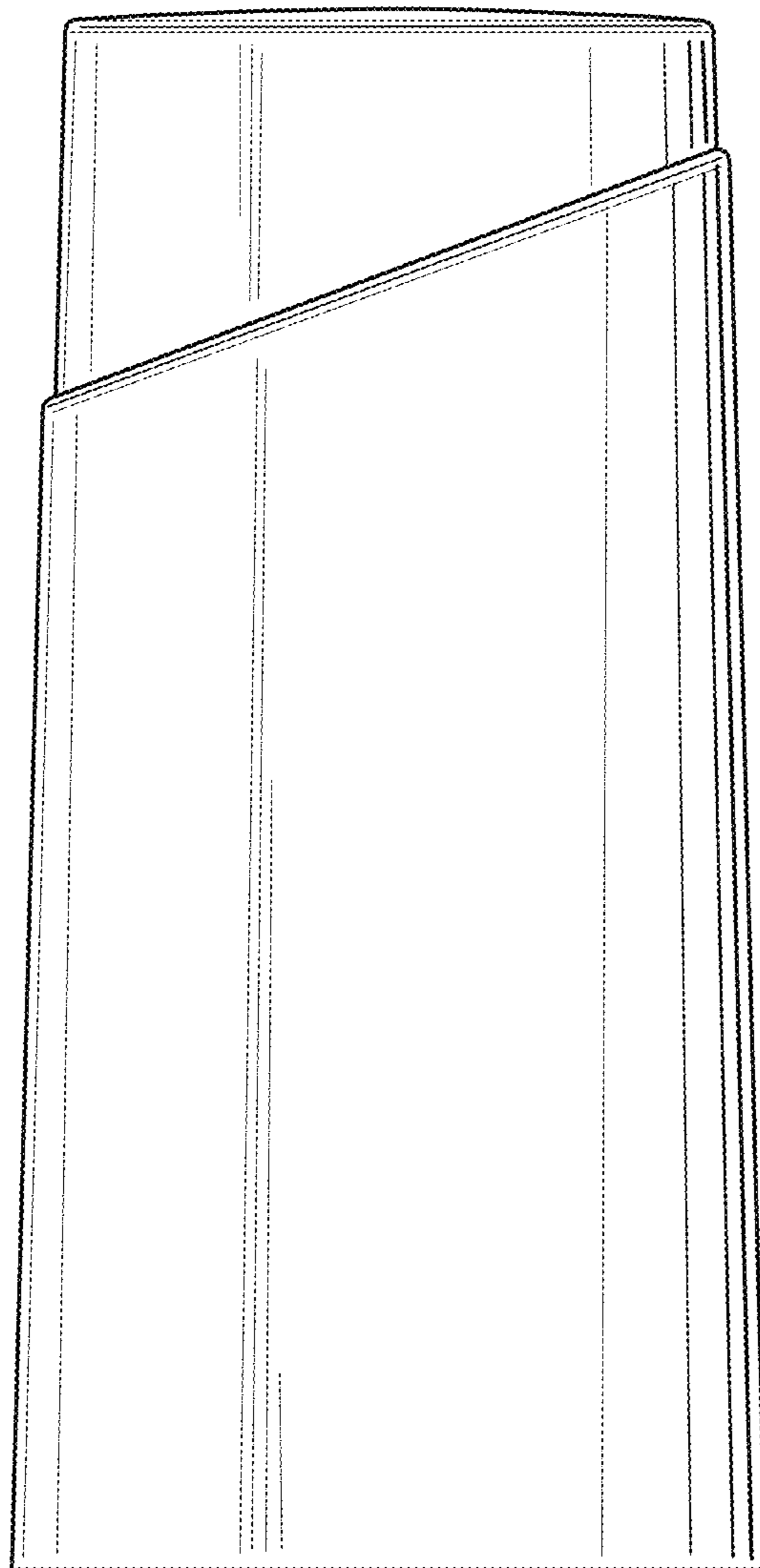

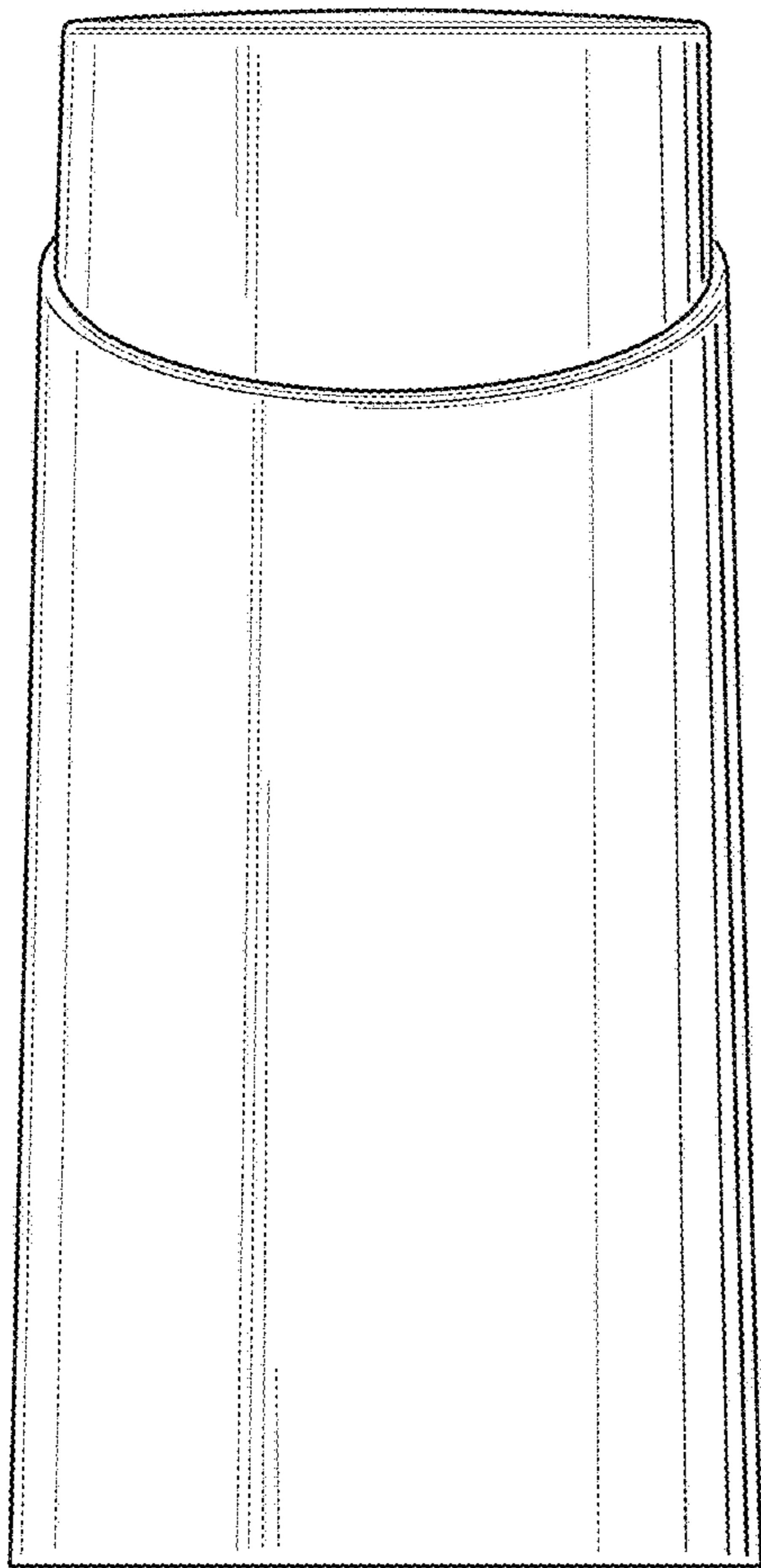

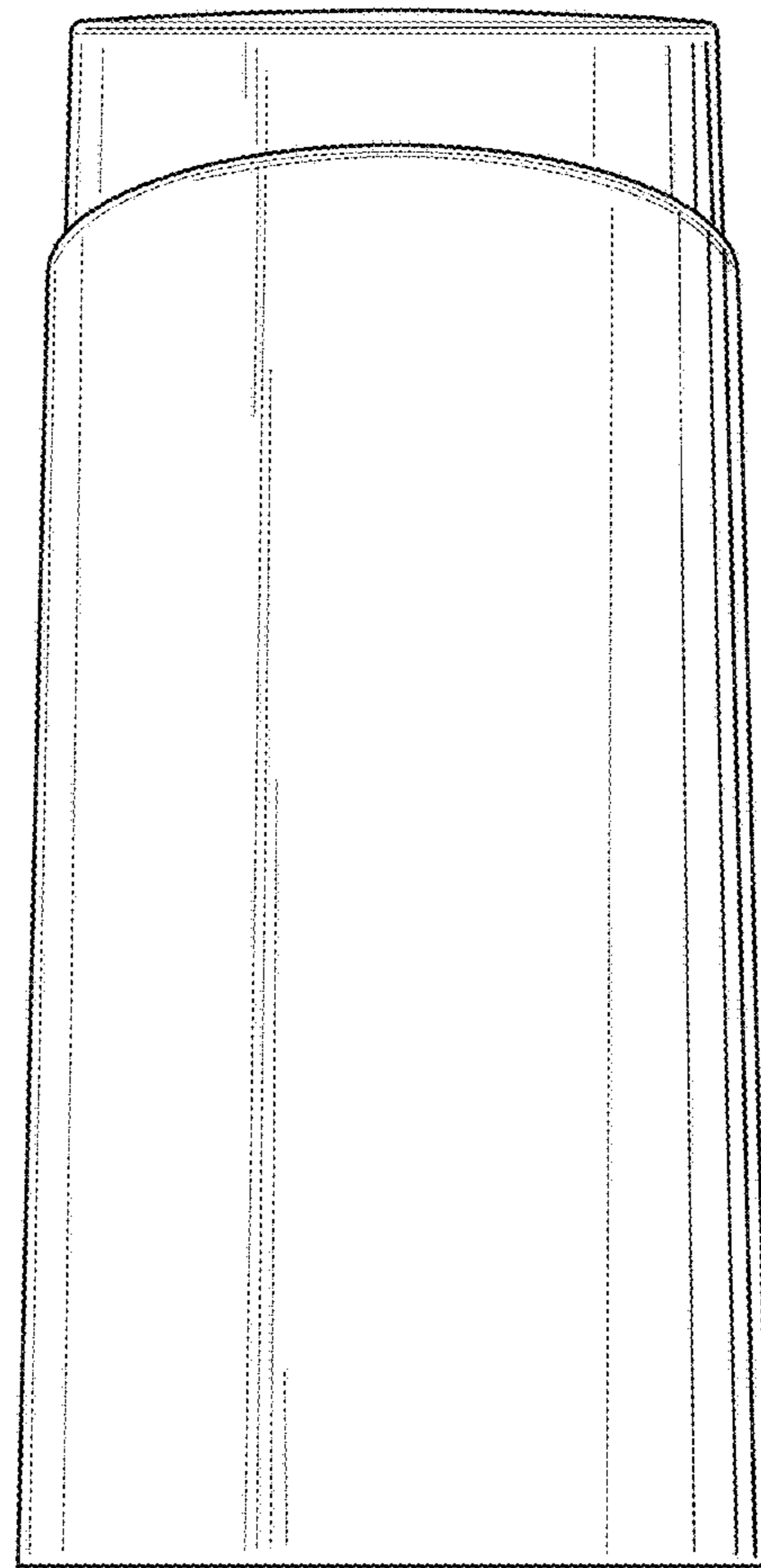

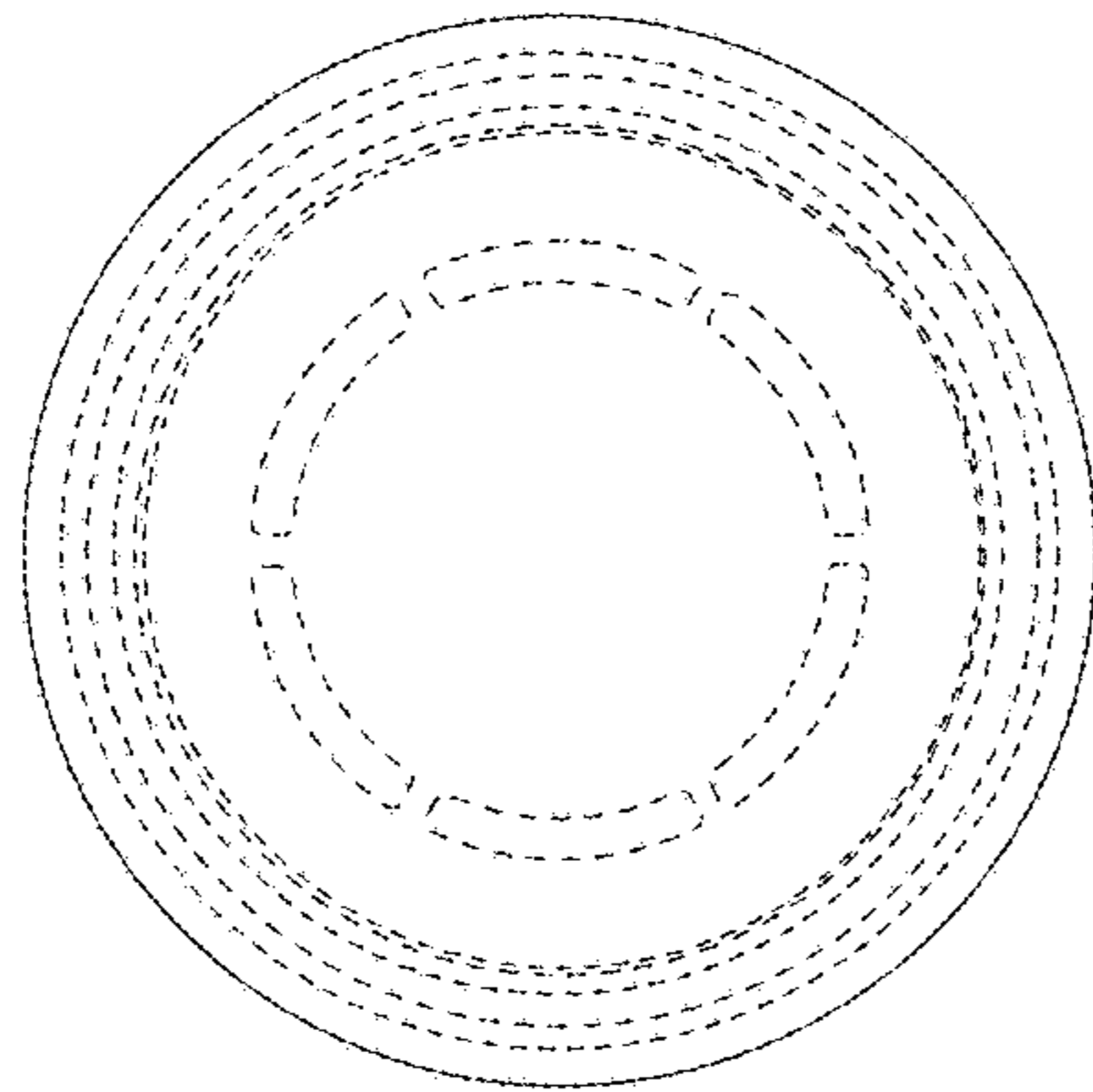

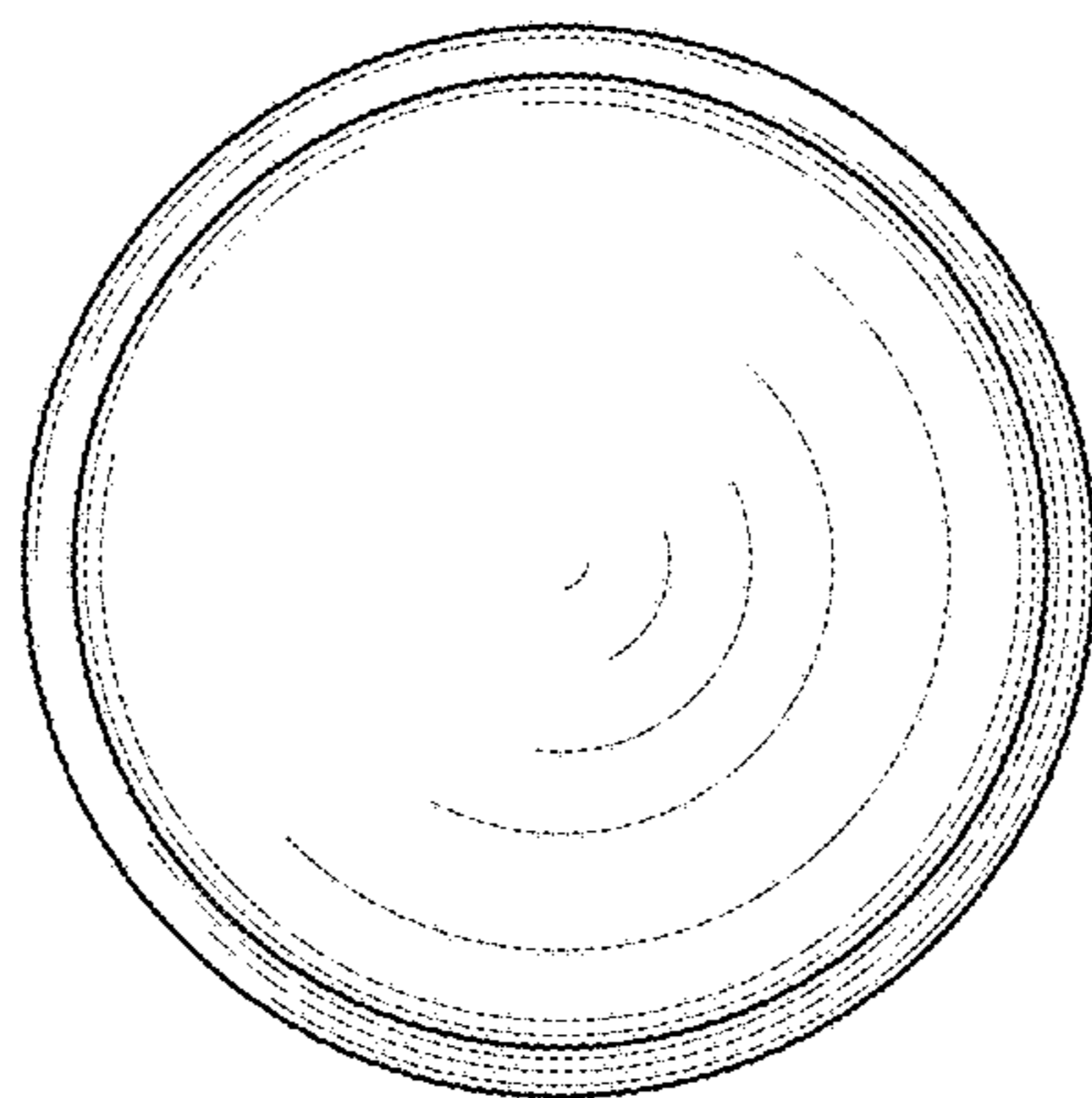
