(57) **CLAIM**

The ornamental design for the decorative container, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a decorative container in accordance with the present invention, shown with the container in a closed condition; and, FIG. 2 is another front perspective view thereof, shown with the container in an open condition with the removable container cover above the hollow container base. The top, bottom, and rear surfaces of the snowman shaped container for ice melting materials that are not illustrated form no part of the claimed design. The broken lines shown in FIG. 2 depict boundaries of the claimed subject matter and form no part of the claimed design.

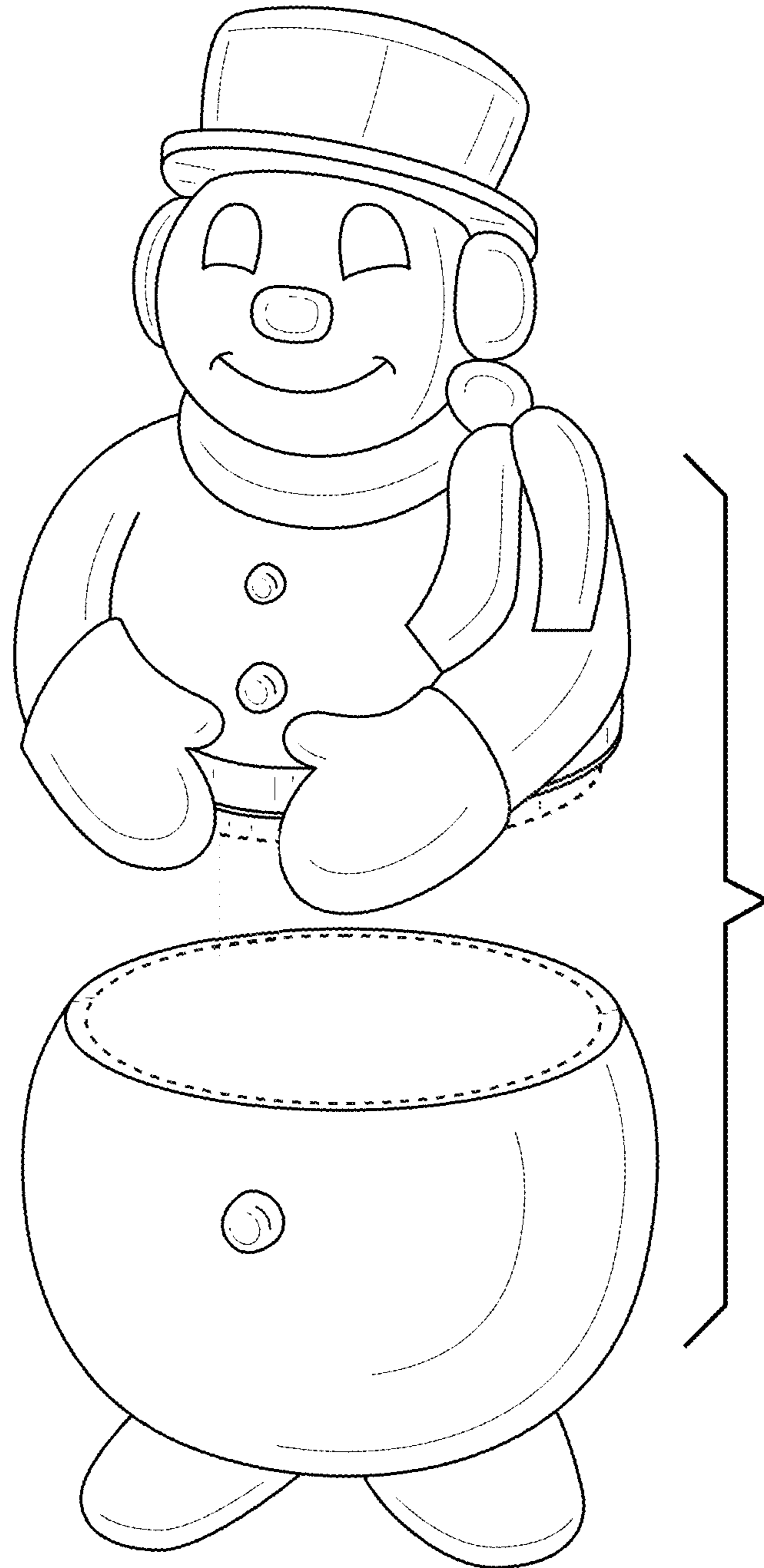
