1.1 is a left side perspective view of a styloid bracelet showing my new design;

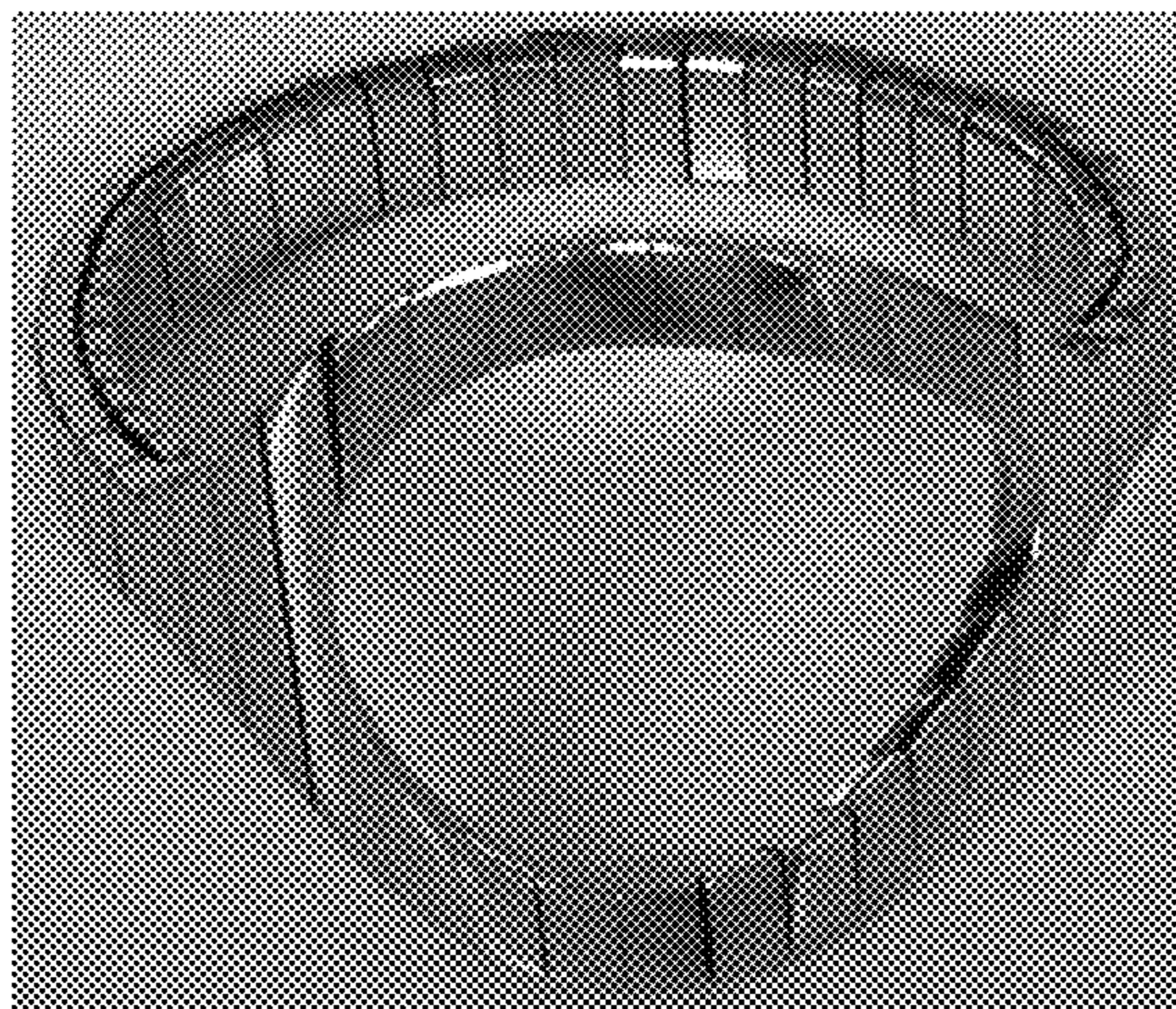
1.2 is a left side perspective view thereof;

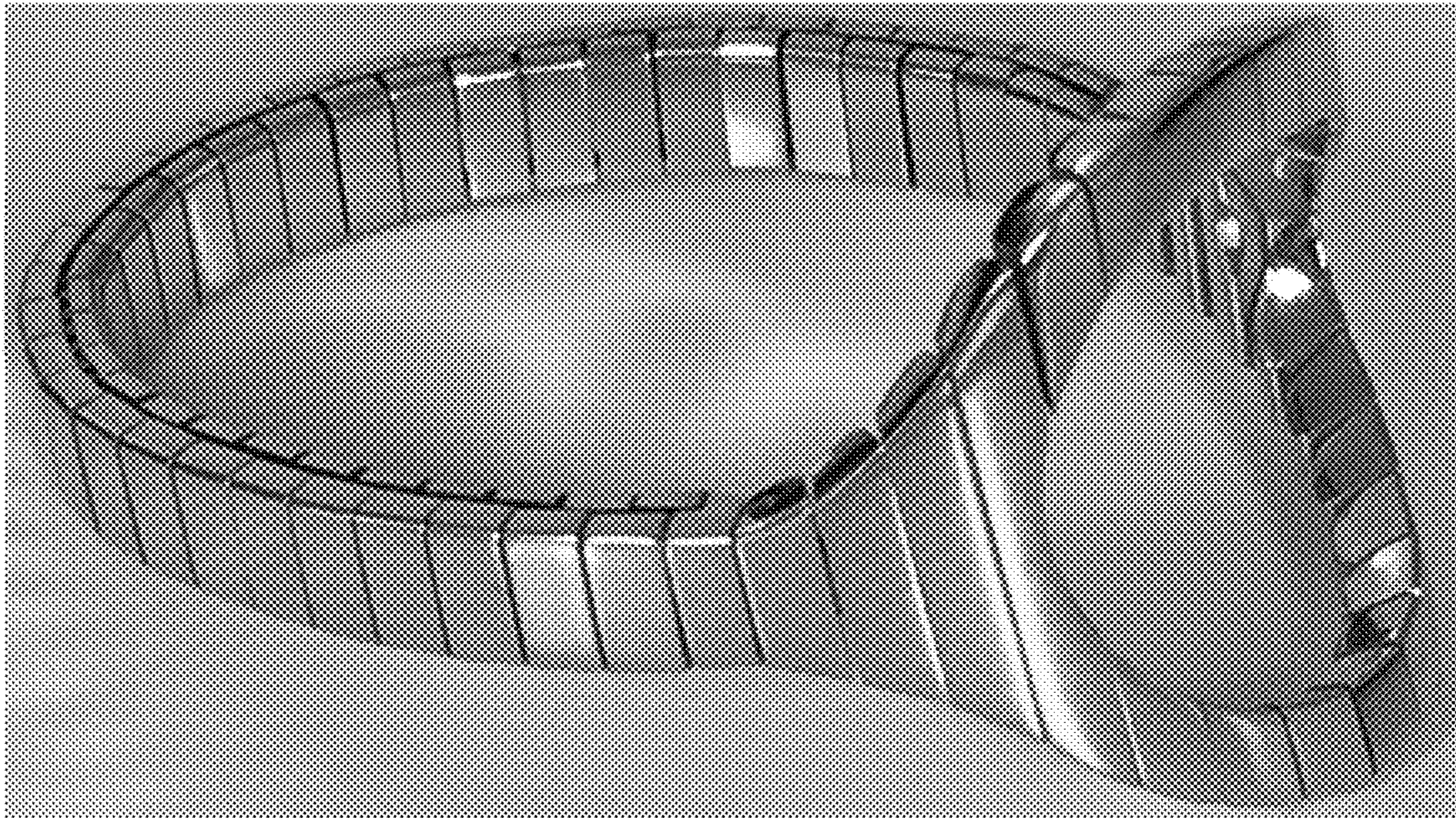

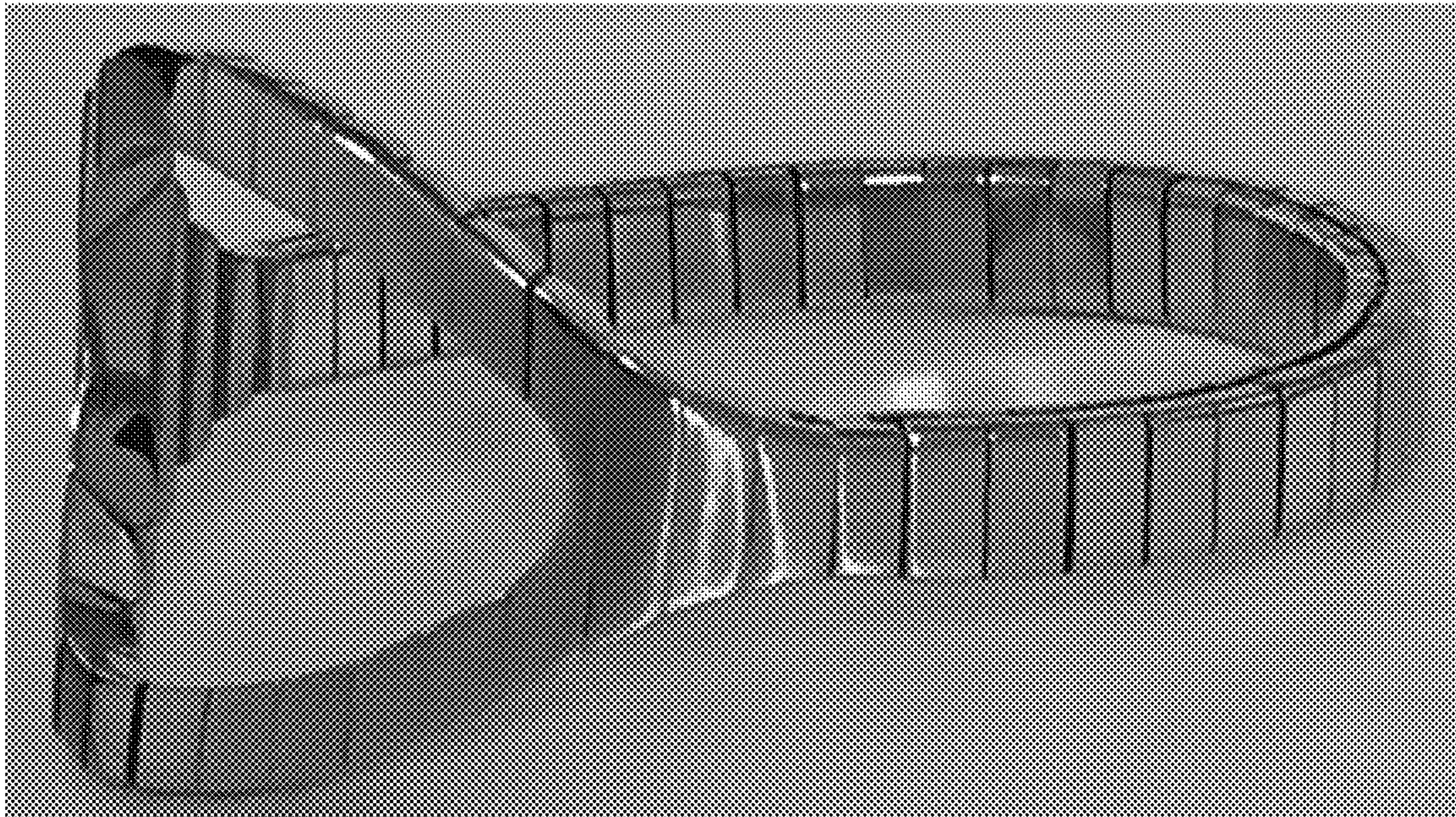

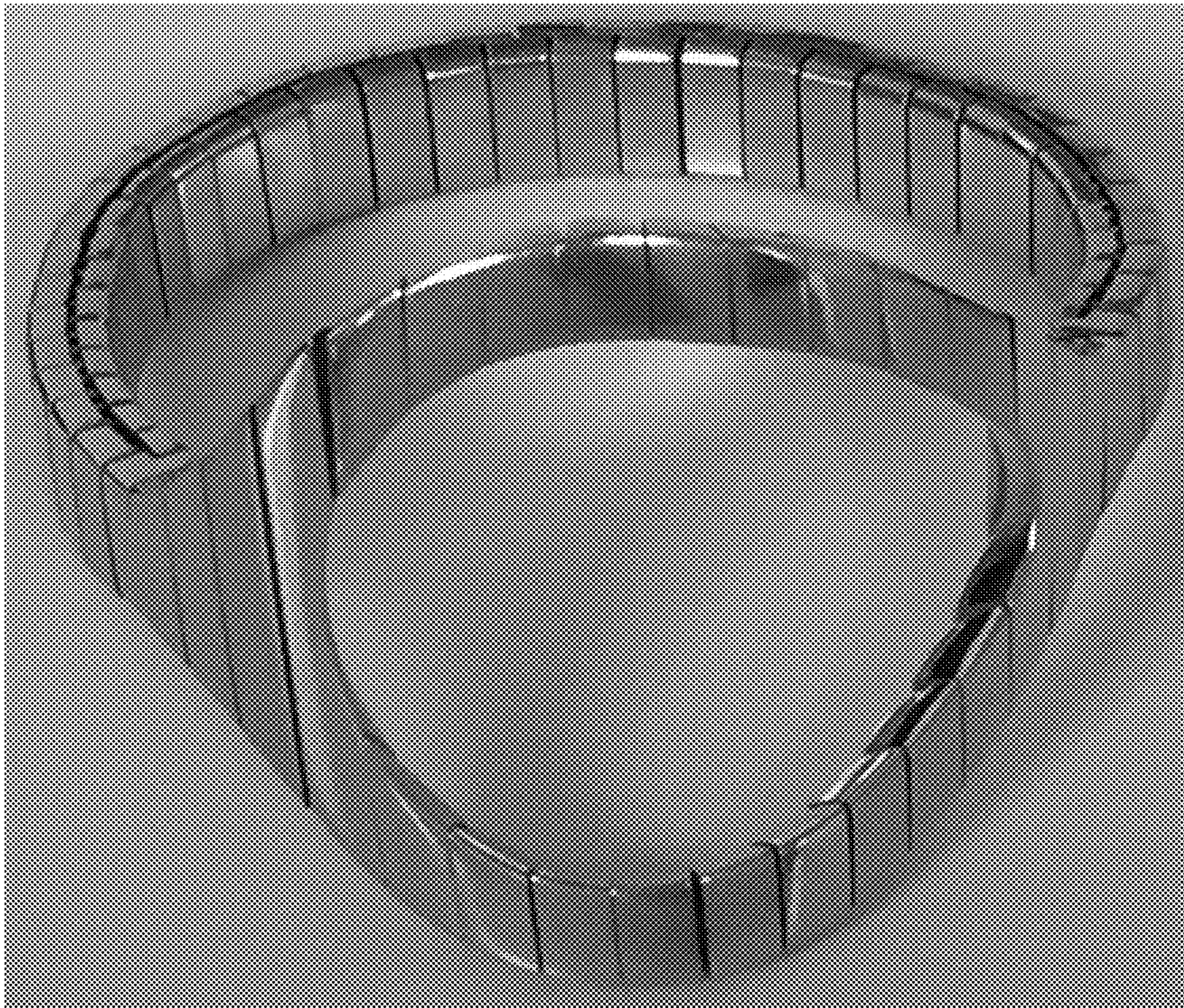
