(57) **CLAIM**

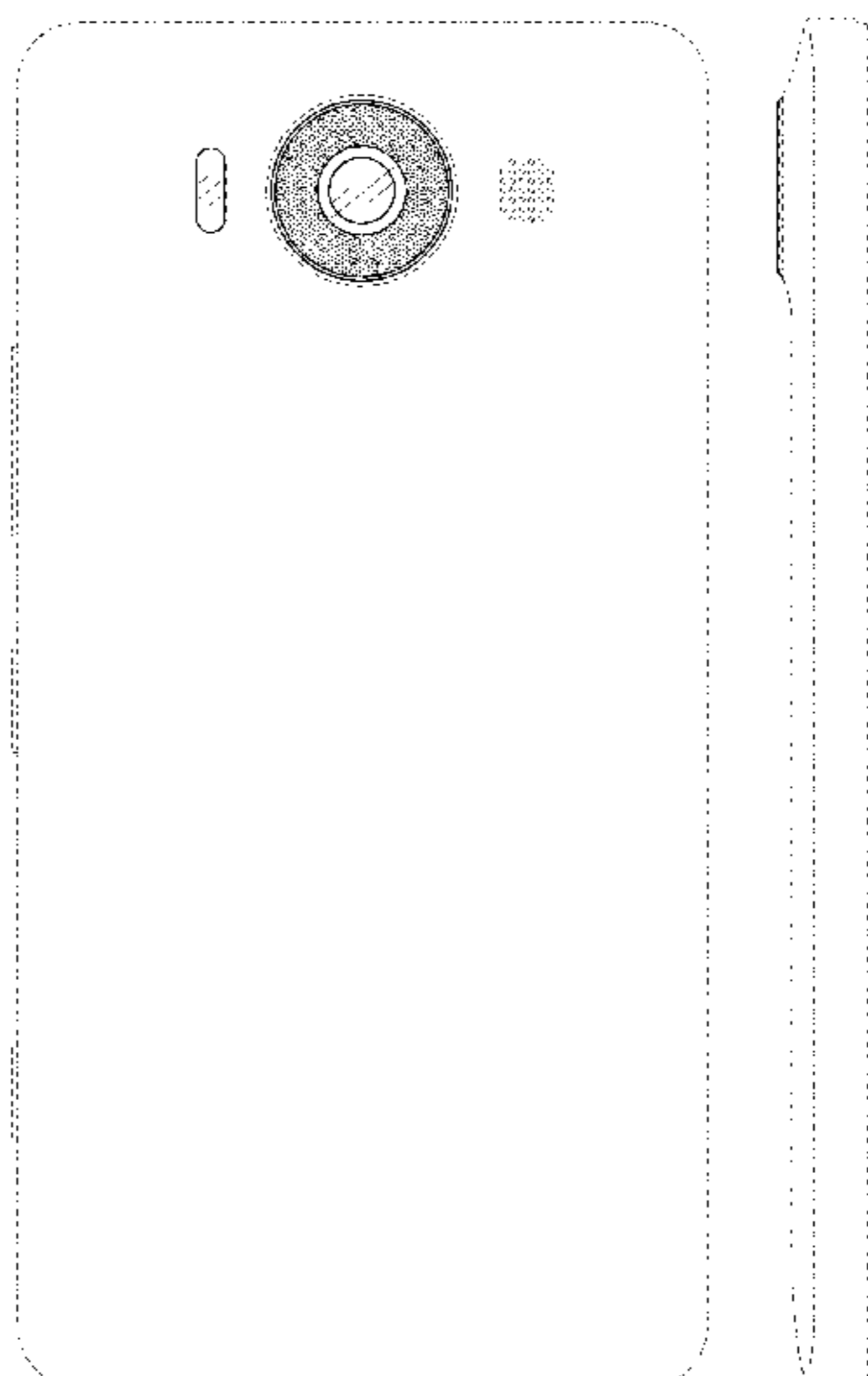
The ornamental design for a handset, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective front view of a first embodiment of a handset showing our new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a right side view thereof;  
FIG. 5 is a left side view thereof;  
FIG. 6 is a top view thereof; and,  
FIG. 7 is a bottom view thereof.

The broken lines shown in the figures are directed to environment; the broken lines form no part of the claimed design. In FIG. 3, the unshaded surface that directly adjoins the claimed solid line edges forms no part of the claimed design. The contrast in shading in the figures represents surfaces having the contrast in appearance shown.

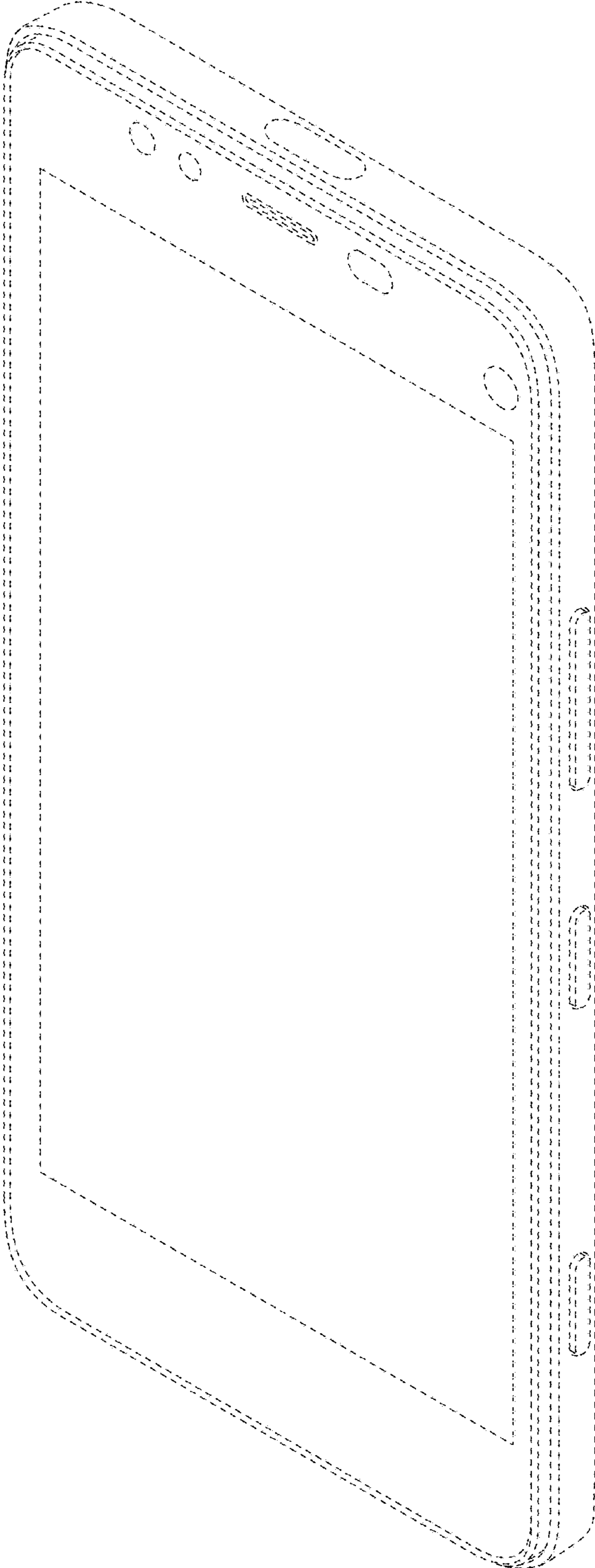

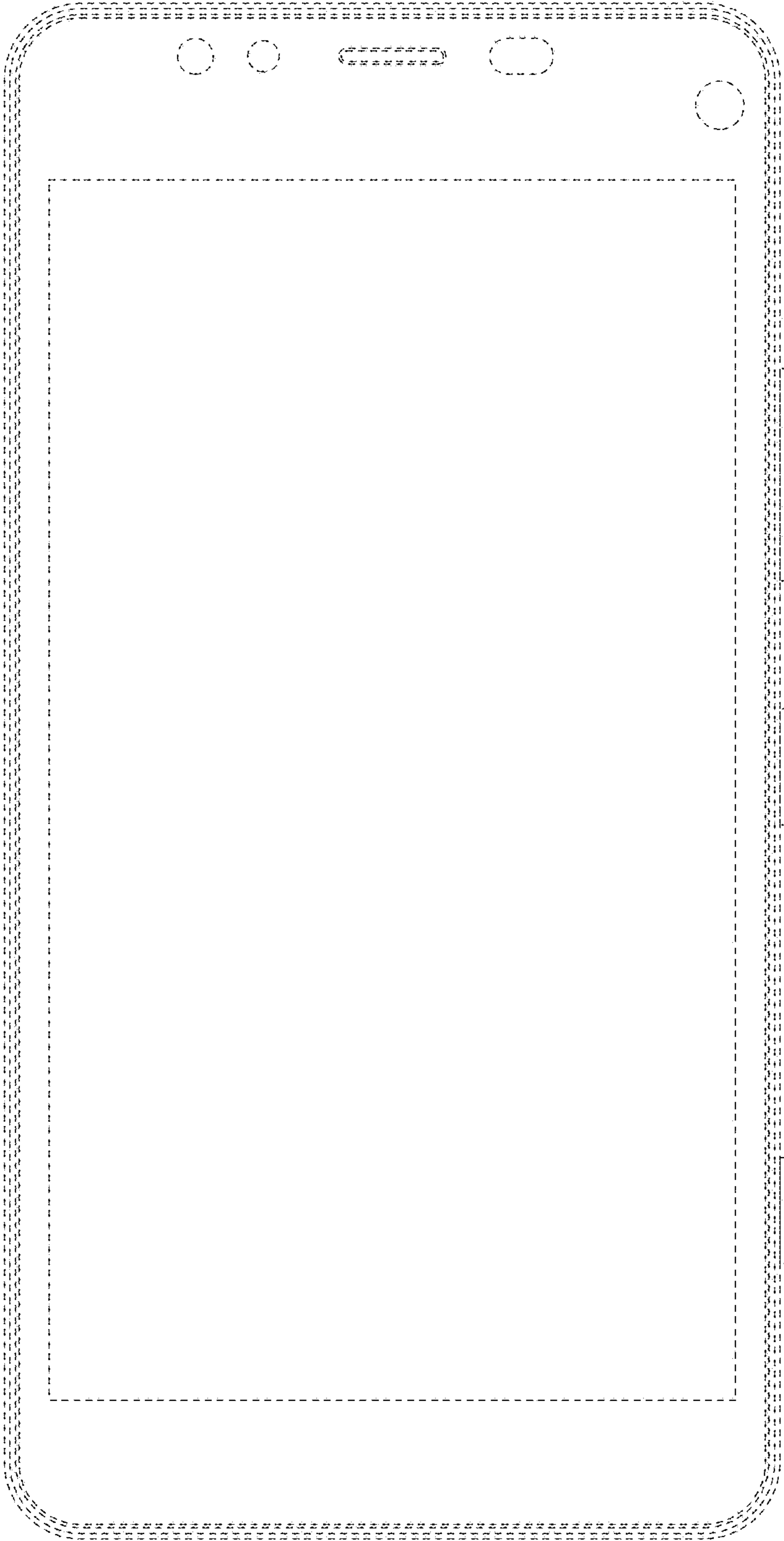

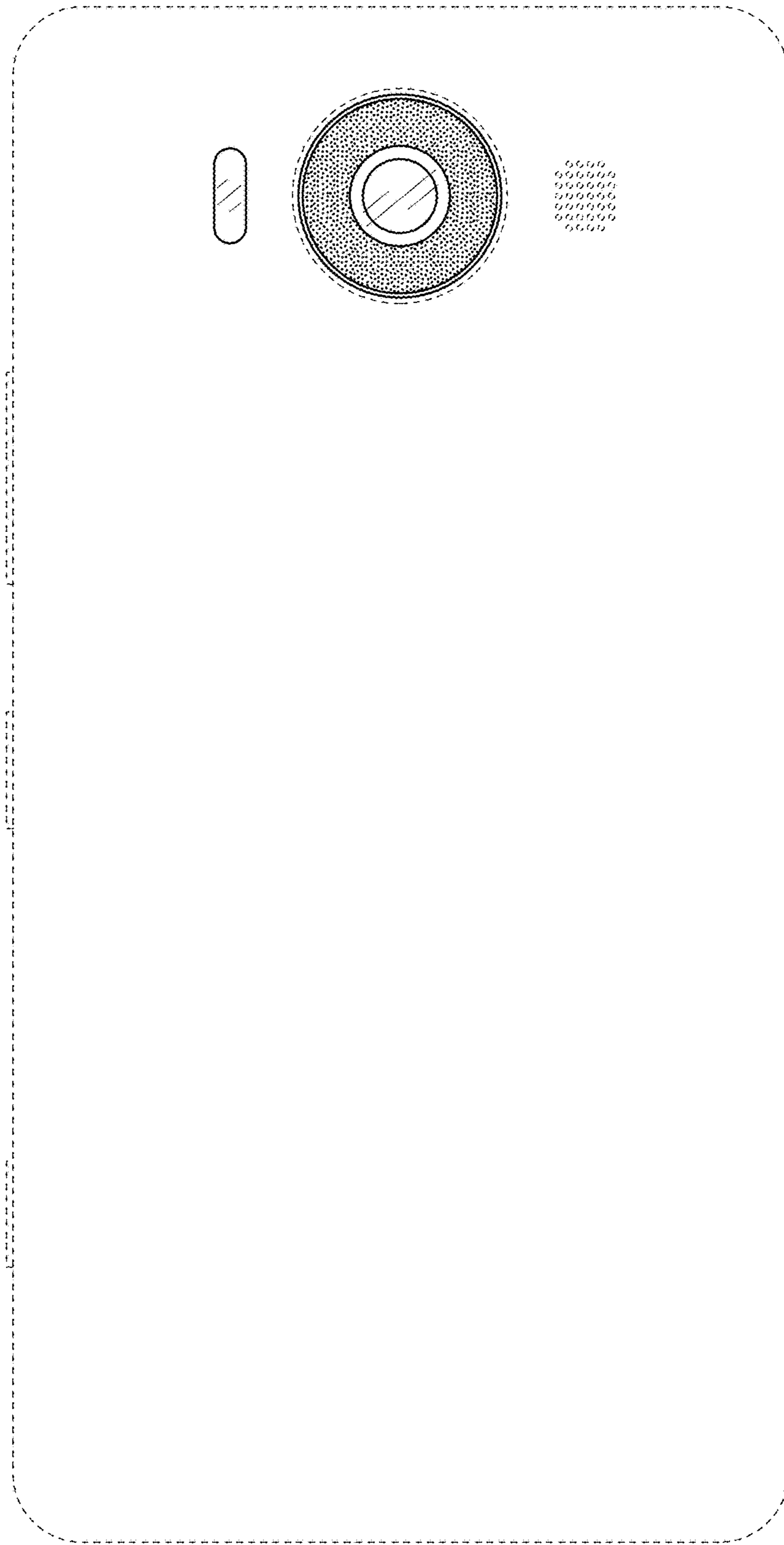

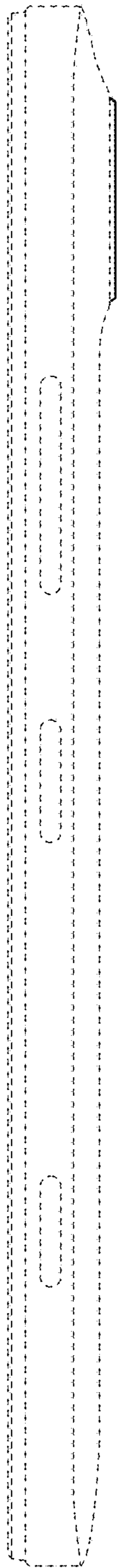

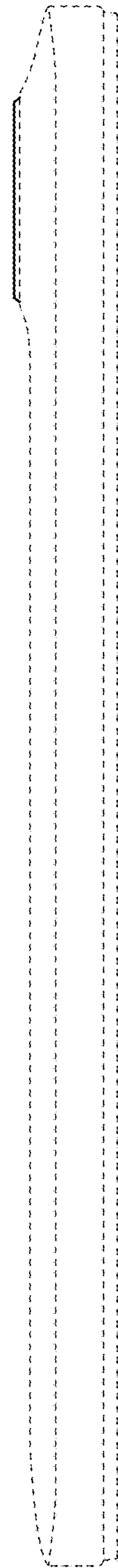
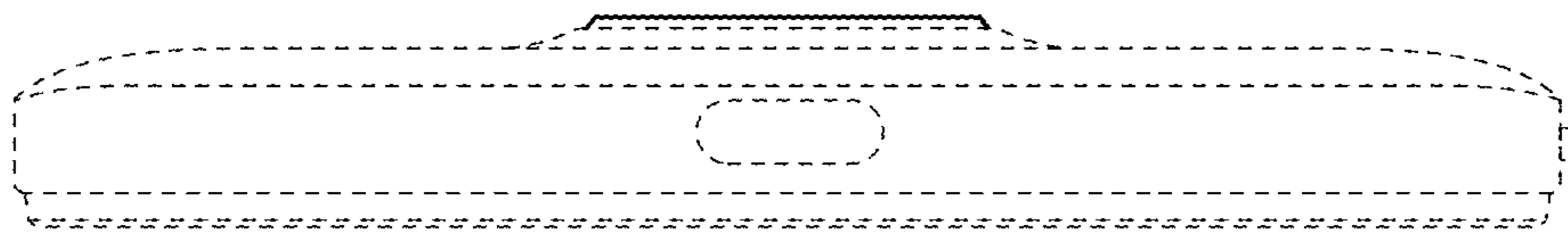
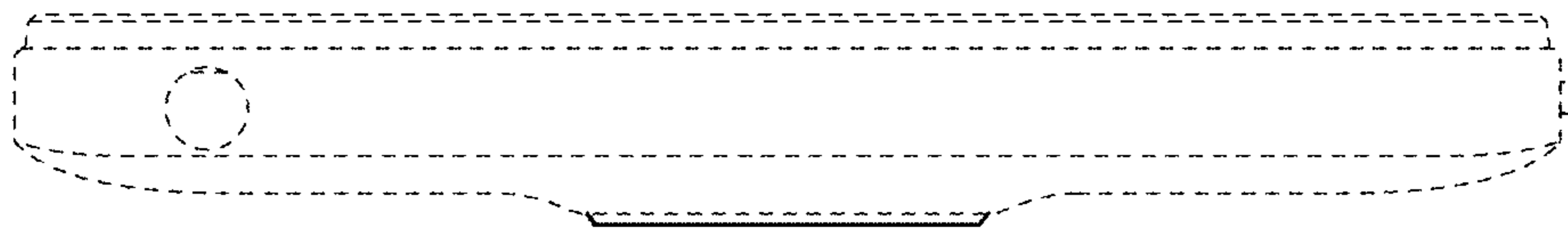
