(57) **CLAIM**

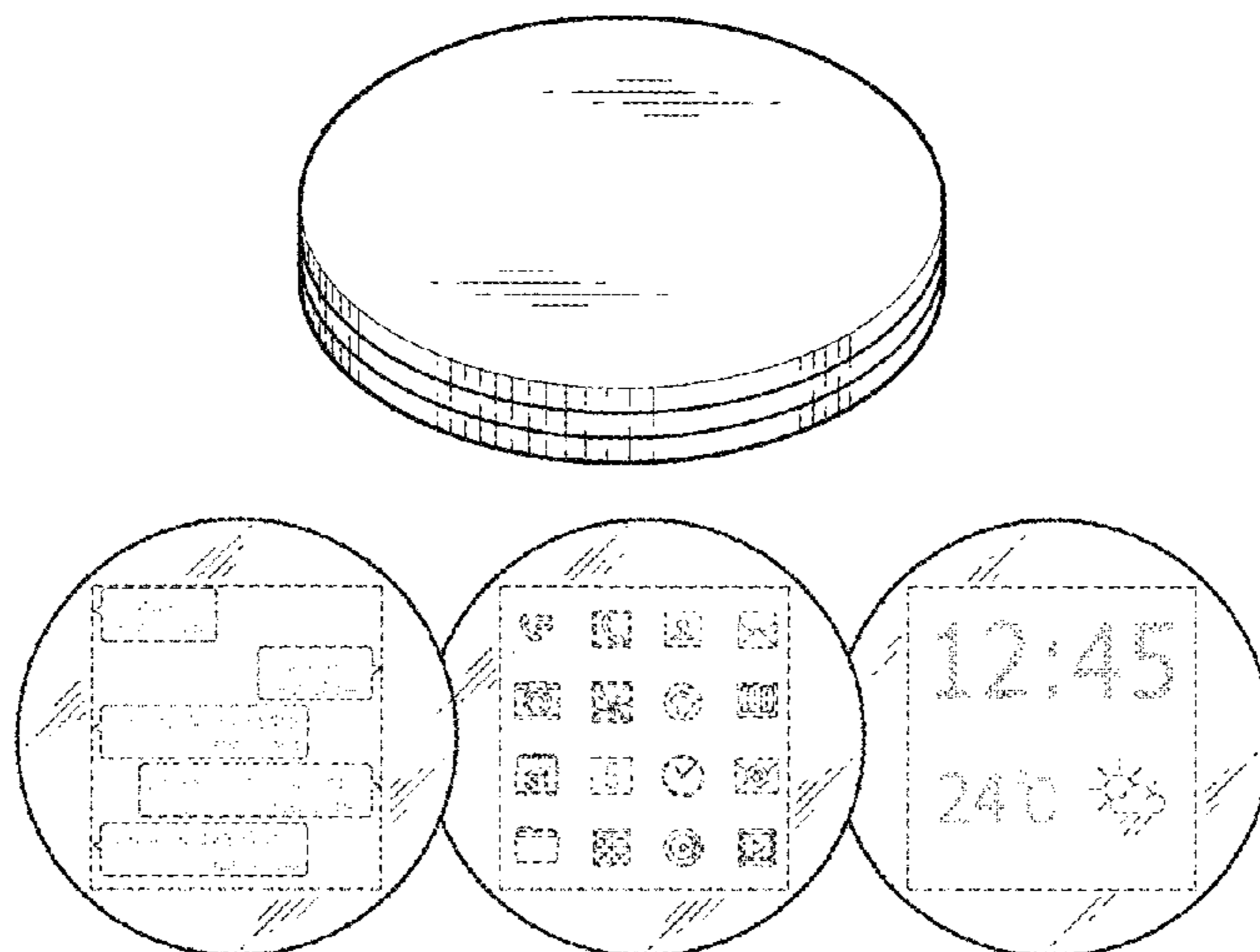
The ornamental design for a display device, as shown and
described.

DESCRIPTION

FIG. 1 is a perspective view of a display device showing our new design, shown in a folded state;
 FIG. 2 is a front view thereof;
 FIG. 3 is a rear view thereof;
 FIG. 4 is a left side view thereof, the right side view being a mirror image thereof;
 FIG. 5 is a top view thereof, the bottom view being a mirror image thereof;
 FIG. 6 is a perspective view of the display device in an unfolded state;
 FIG. 7 is a front view thereof;
 FIG. 8 is a rear view thereof;
 FIG. 9 is a left side view thereof, the right side view being a mirror image thereof;
 FIG. 10 is a top view thereof, the bottom view being a mirror image thereof; and,
 FIG. 11 is a front view of the display device in the unfolded state in which images, such as icons and widgets, are displayed thereon, the images forming no part of the claimed design.

The broken lines shown in the drawings illustrate portions of the display device that form no part of the claimed design.

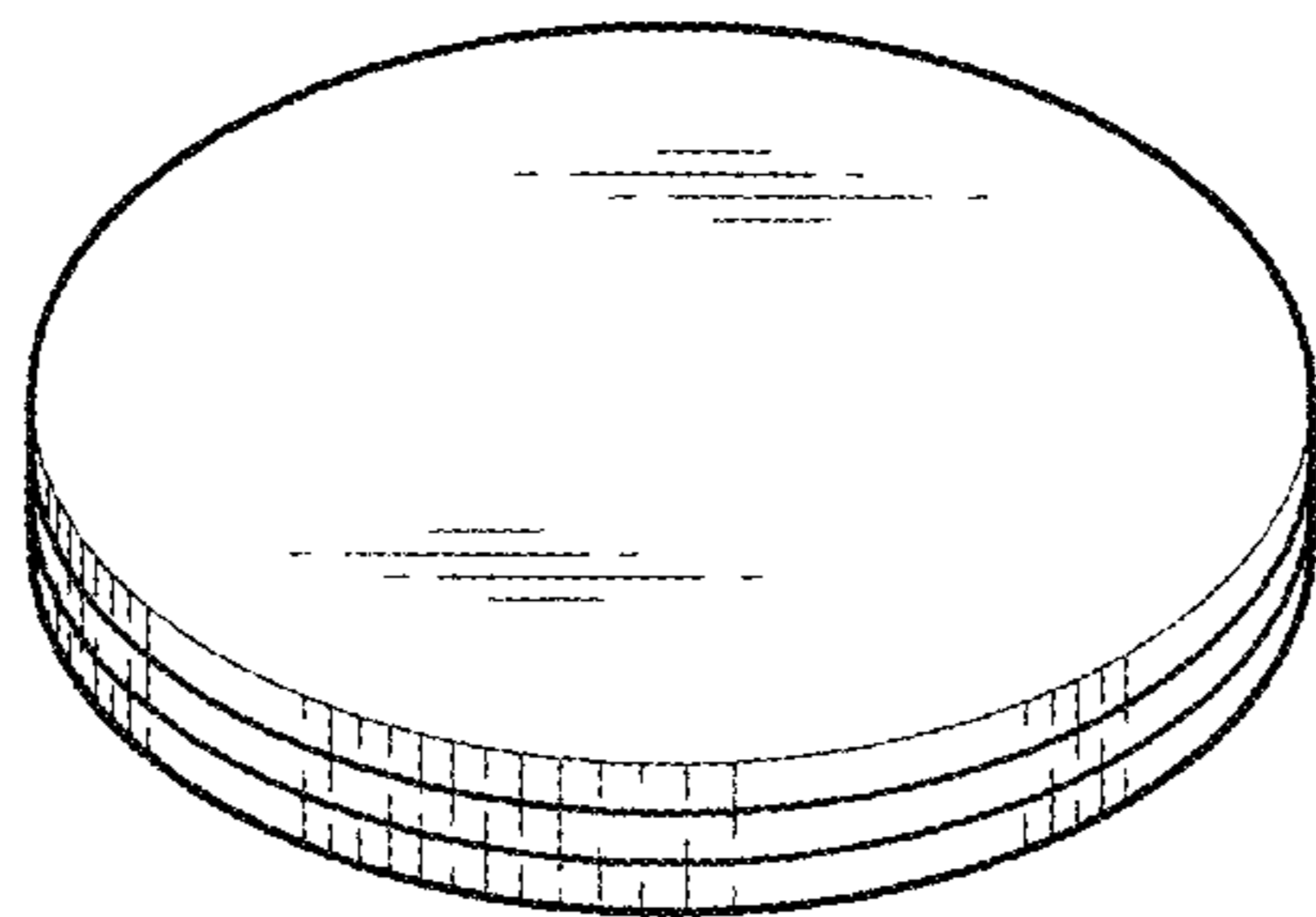

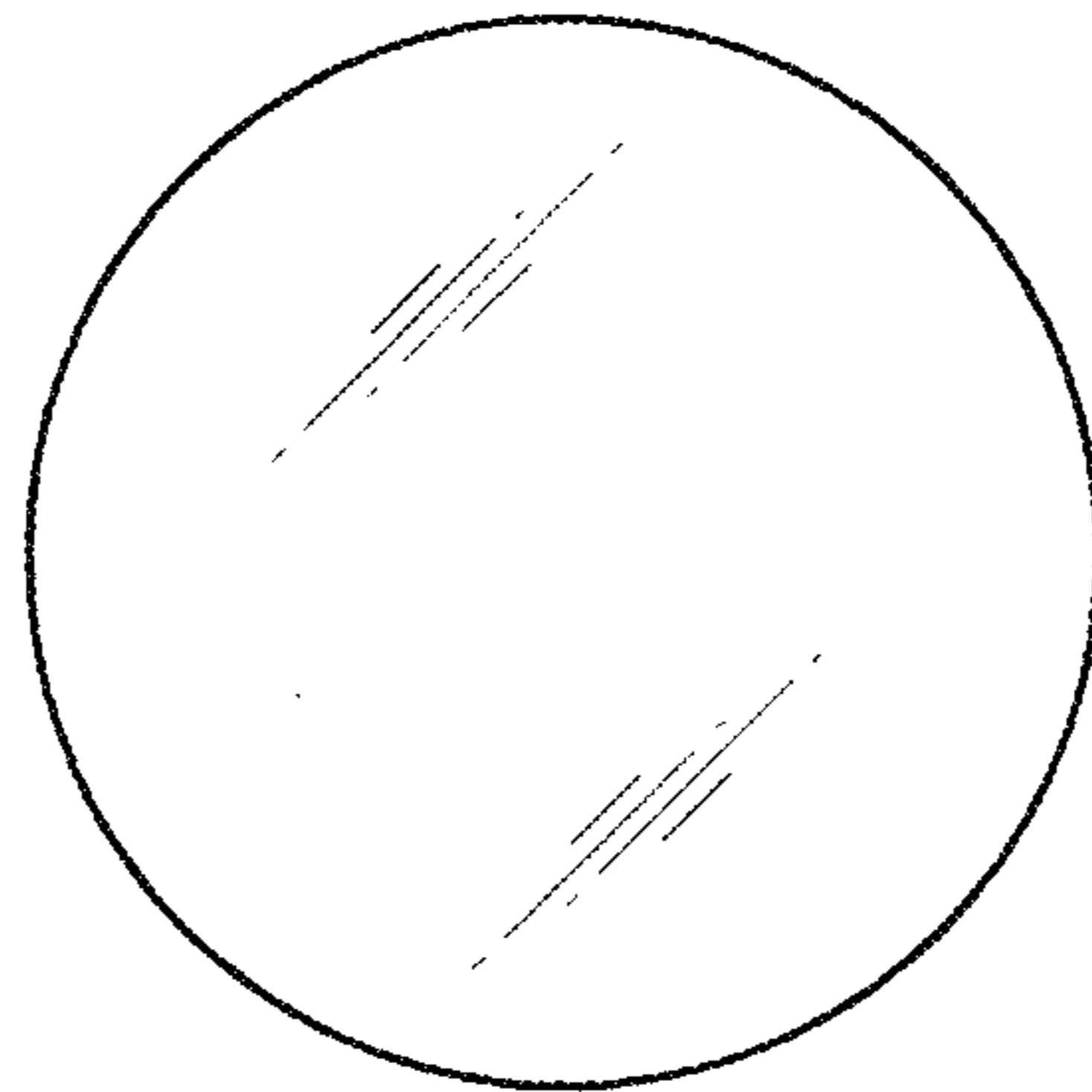

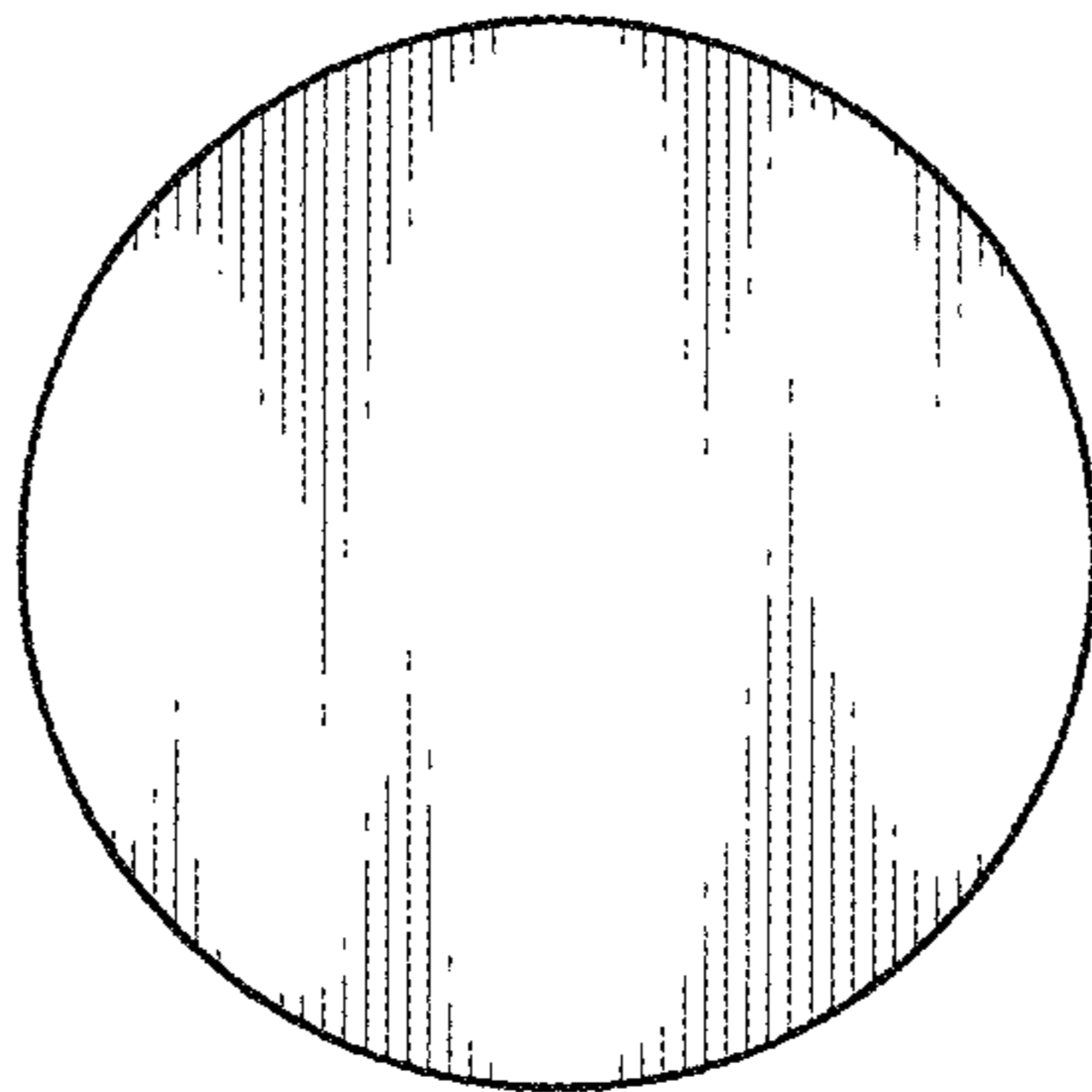

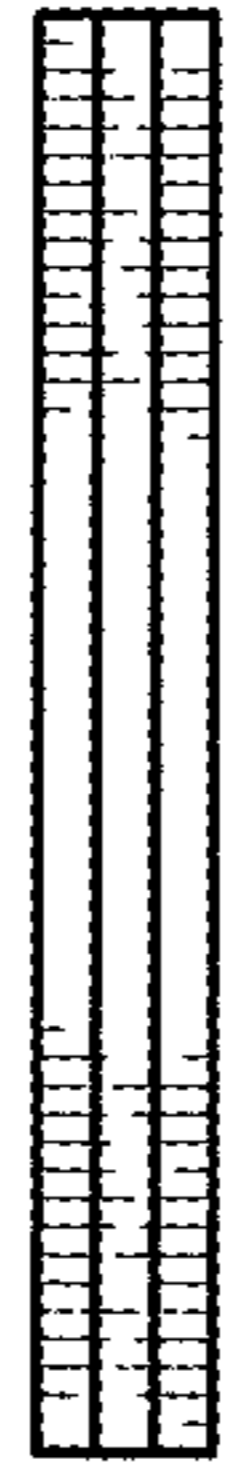

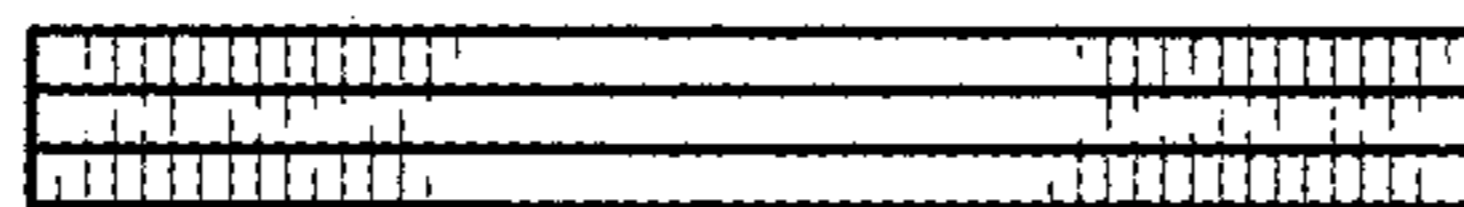

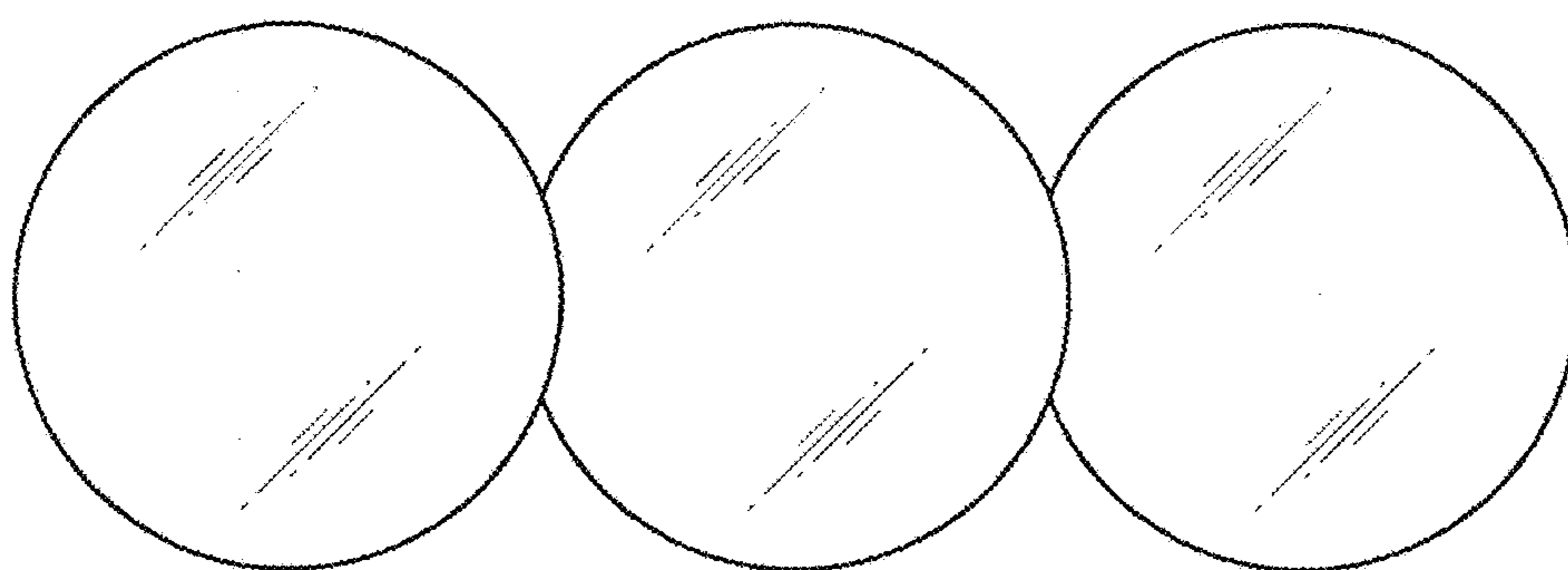

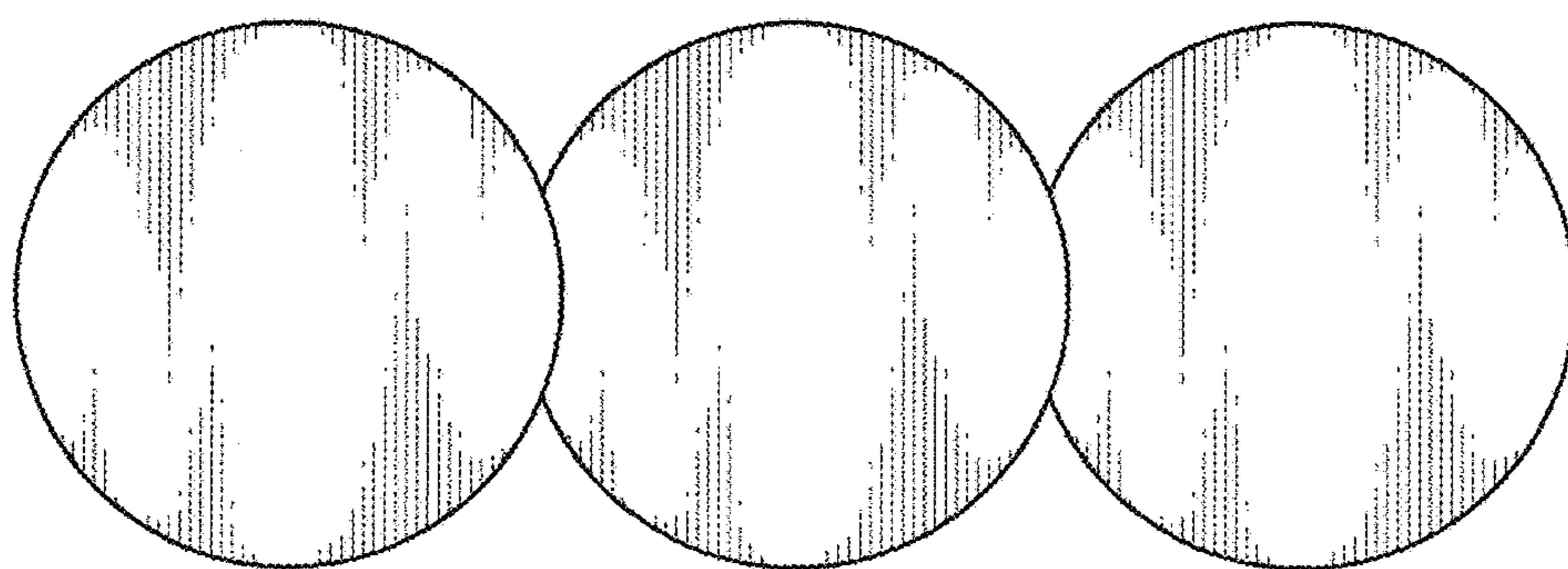

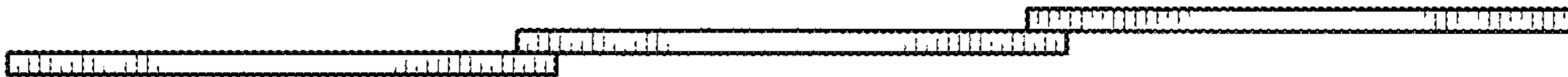
