The ornamental design for a portion of a display screen with graphical user interface, as shown and described.

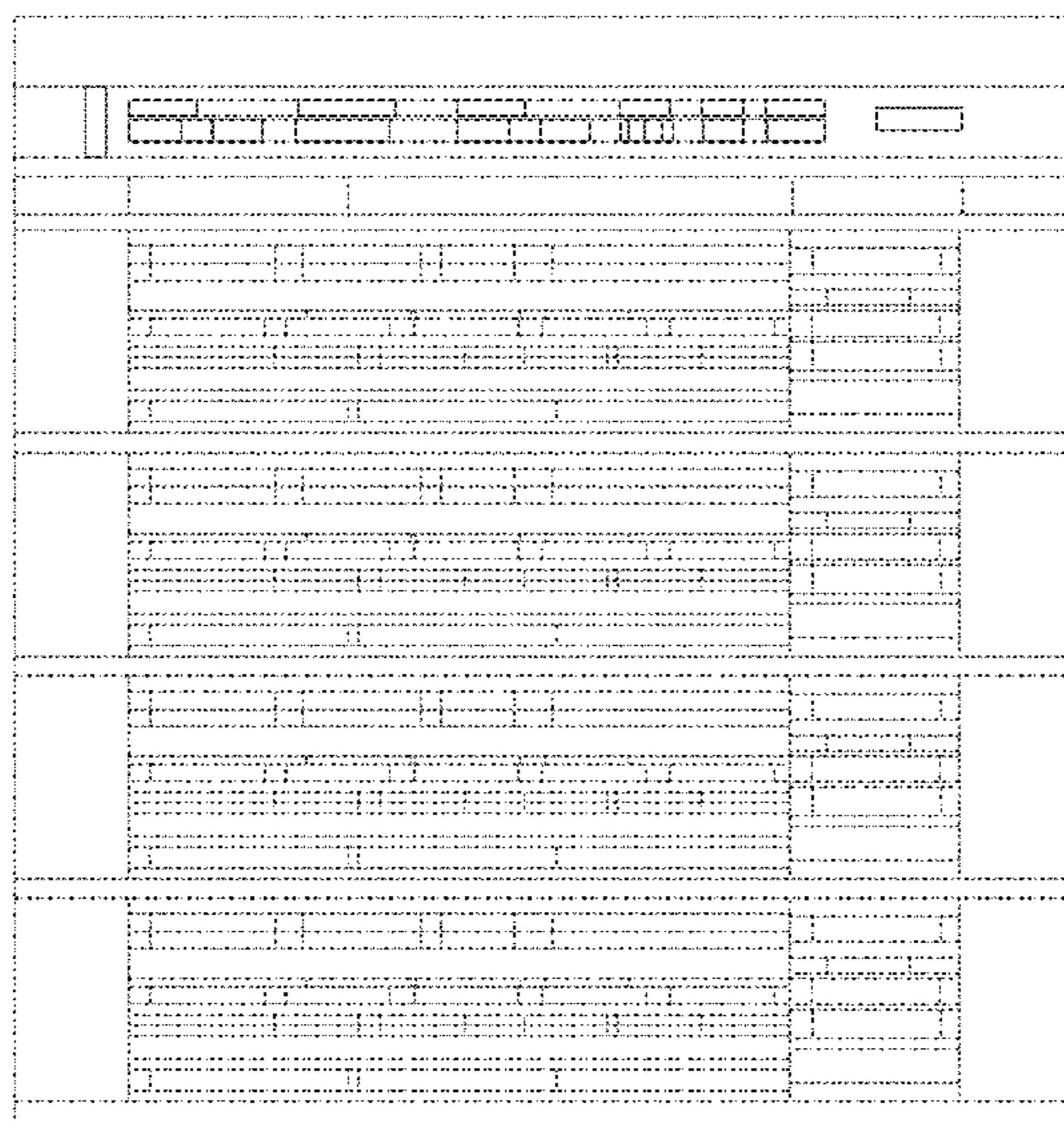
**DESCRIPTION**

The sole FIGURE is a front view of a portion of a display screen with graphical user interface, showing our new design.

The outer edge of the portion of the display screen is understood to be congruent with the outer edge of the graphical user interface.

The outermost broken lines illustrate a portion of a display screen and the edge of the graphical user interface, and form no part of the claimed design. The remaining broken lines, illustrating portions of the graphical user interface, form no part of the claimed design.
