(57) **CLAIM**

The ornamental design for a display device with a create new dialog box for a graphical user interface, as shown and described.

DESCRIPTION

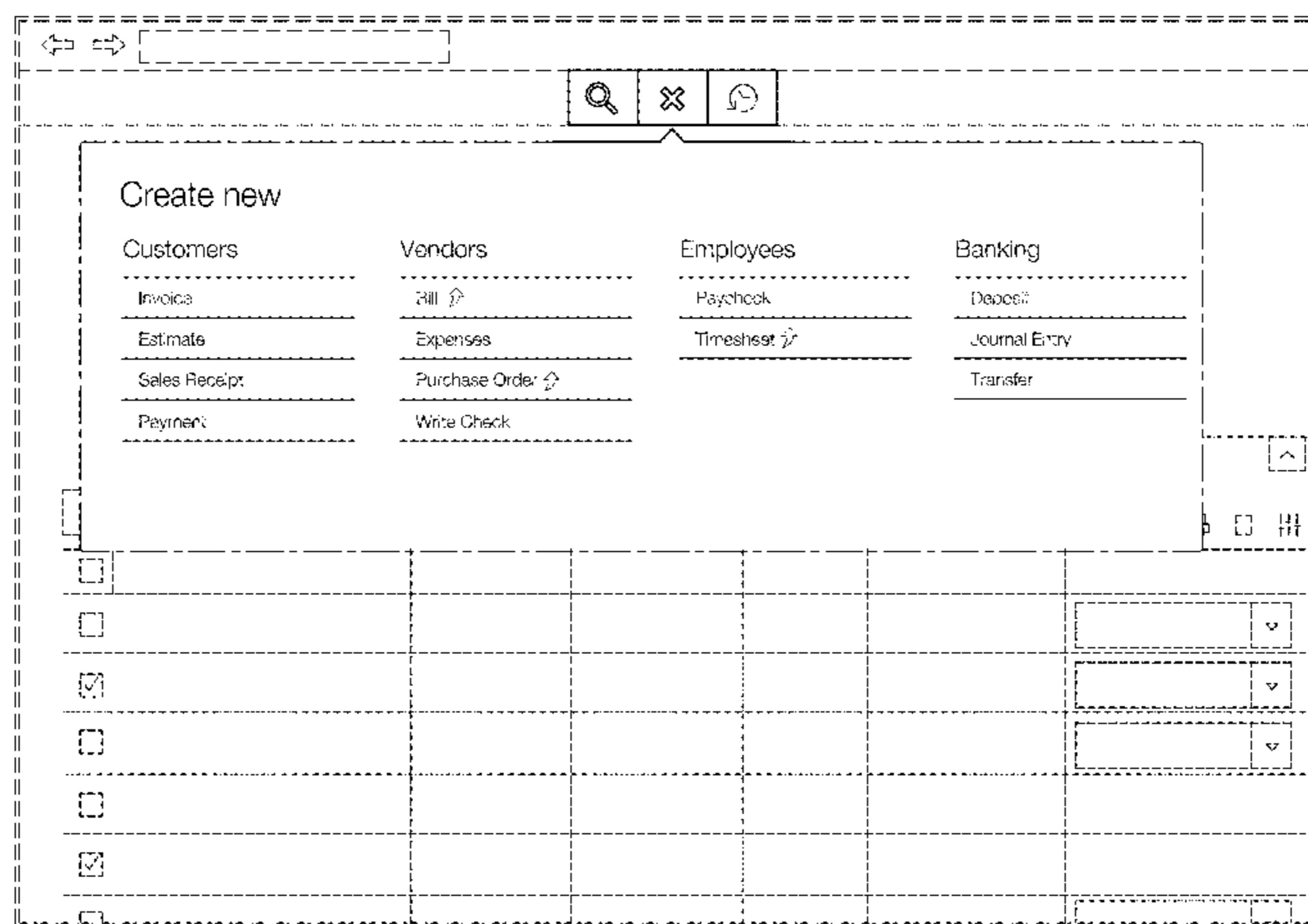
The FIGURE is a view of a display device with a create new dialog box for a graphical user interface.

The elements shown with dashed lines are for illustrative purposes only showing an example interface environment and form no part of the claimed design. The dashed line in the third icon, next to the 'x' icon that is referenced by the create new dialog box does, forms a part of the claimed design.

The dot dashed line represents a boundary of the create new dialog box shown for illustrative purposes and forms no part of the claimed design.

The broken lines along the outer perimeter represent a display device and form no part of the claimed design. All other broken line elements illustrate an example interface environment and form no part of the claimed design.
