**DESCRIPTION**

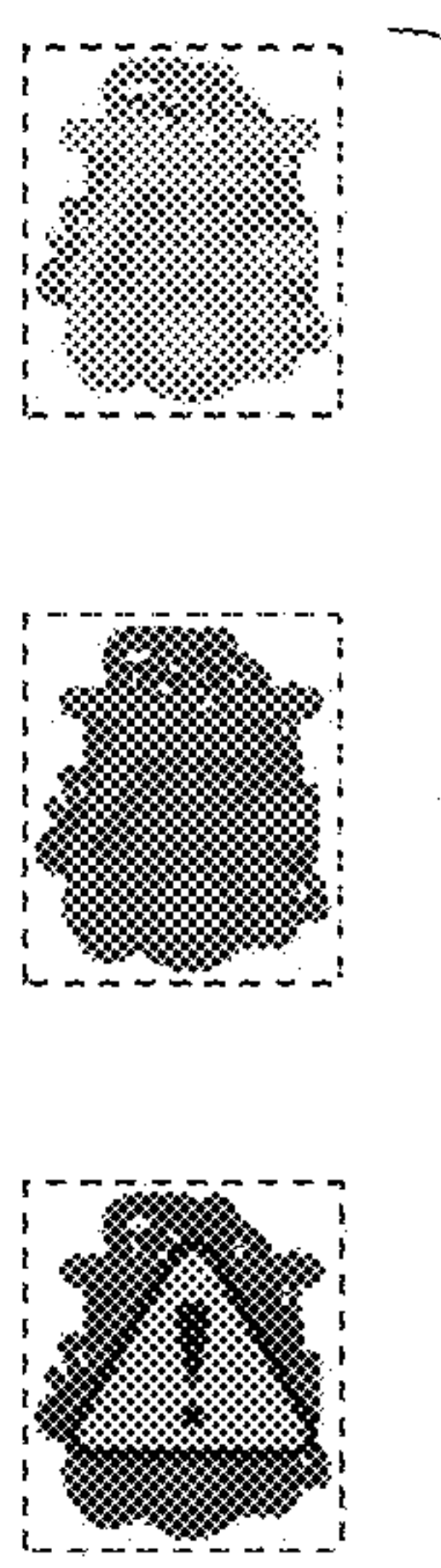
