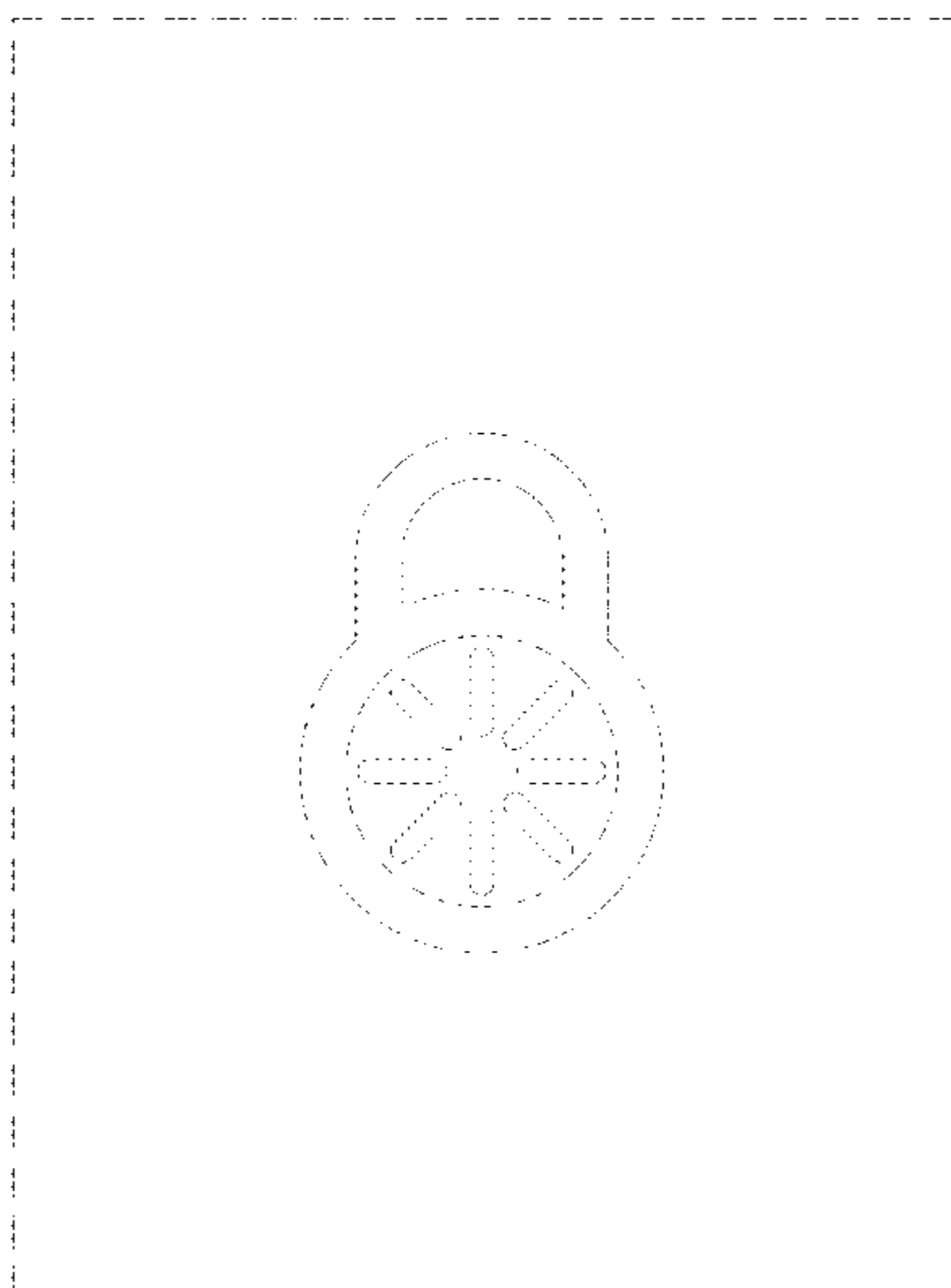
(57) **CLAIM**

The ornamental design for an electronic display screen with an icon, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of an electronic display screen including a first embodiment of an icon.  
FIG. 2 is a front view of an electronic display screen including a second embodiment of an icon.  
FIG. 3 is a front view of an electronic display screen including a third embodiment of an icon.  
FIG. 4 is a front view of an electronic display screen including a fourth embodiment of an icon; and,  
FIG. 5 is a front view of an electronic display screen including a fifth embodiment of an icon.

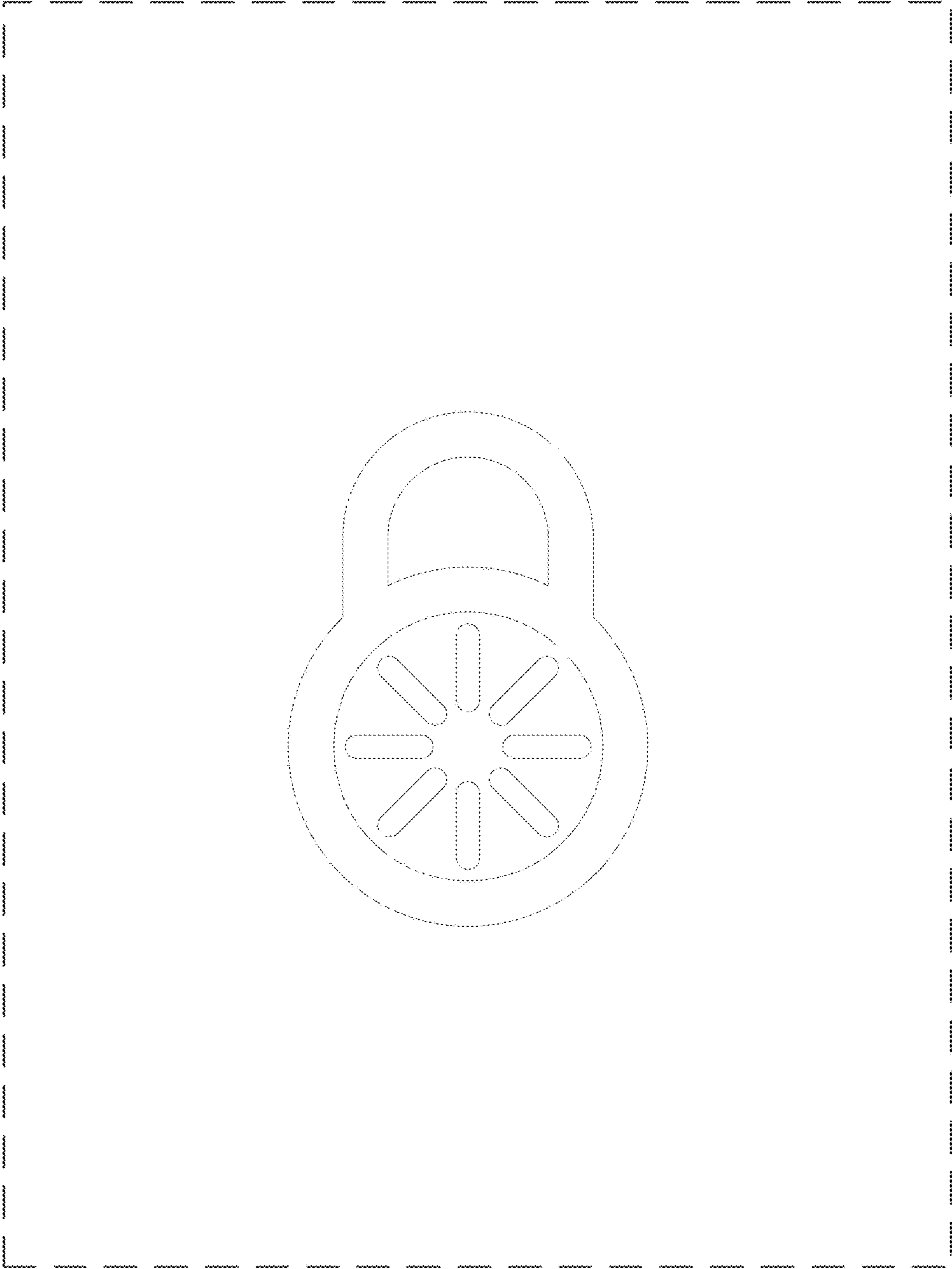
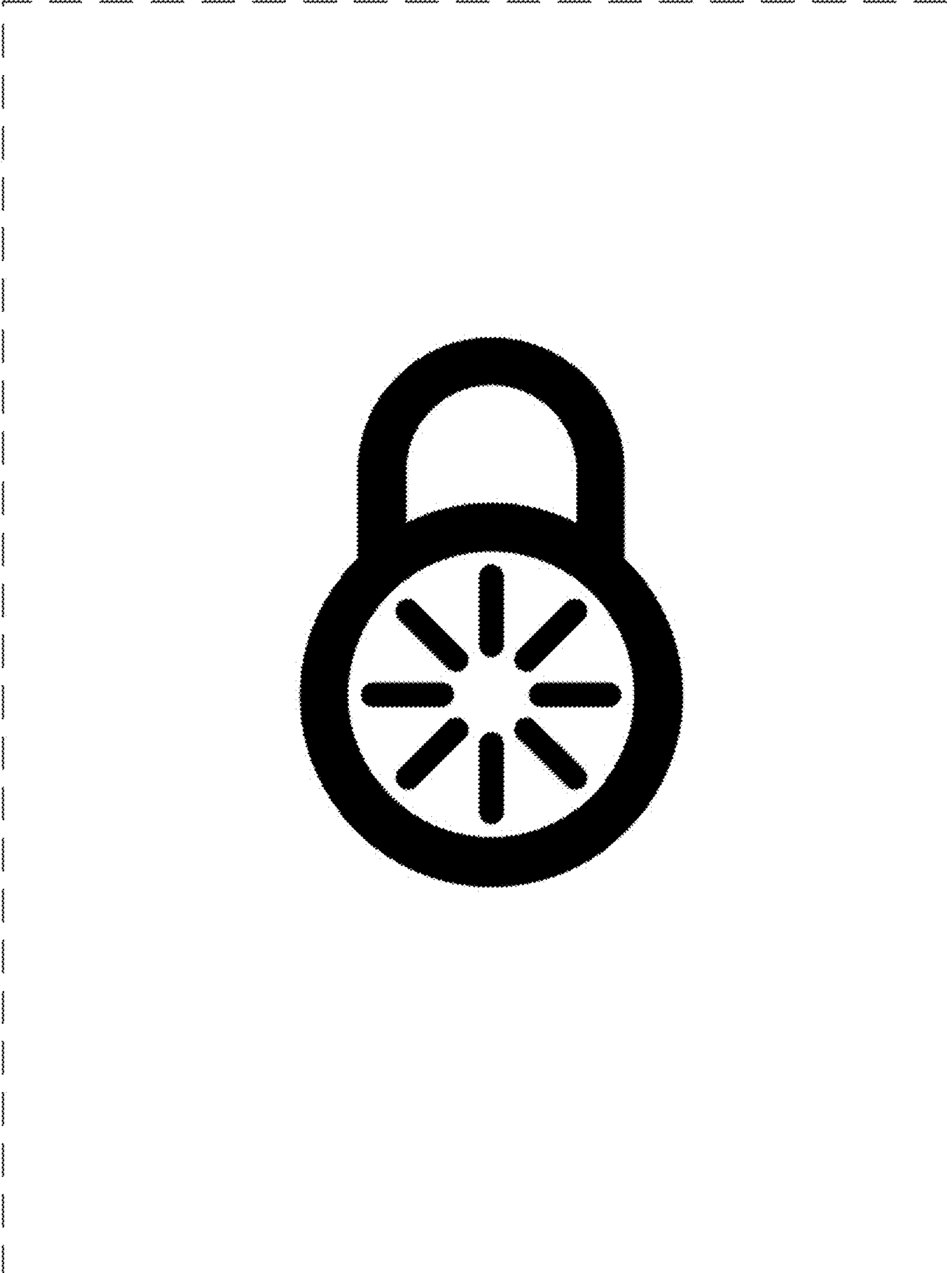

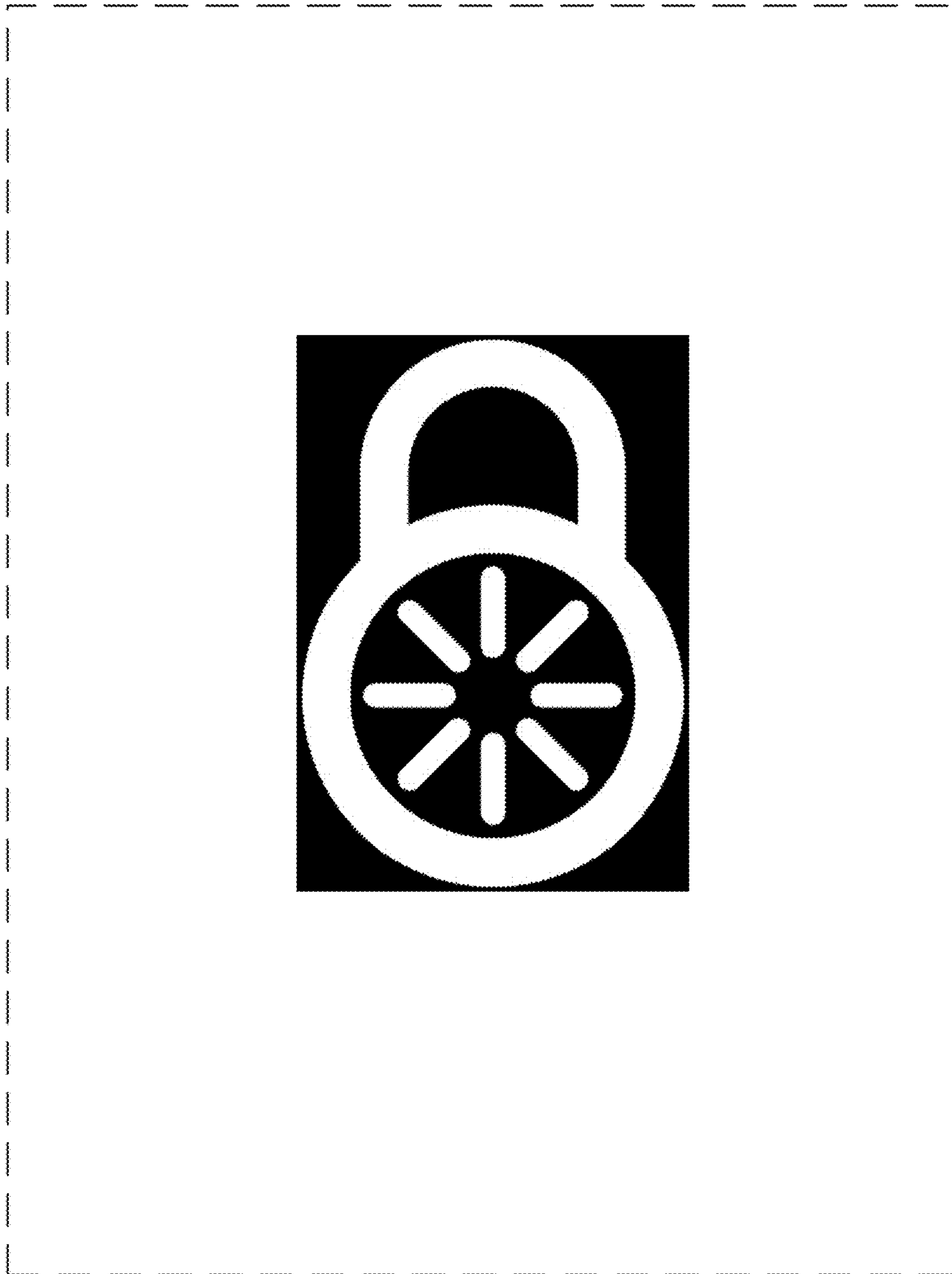

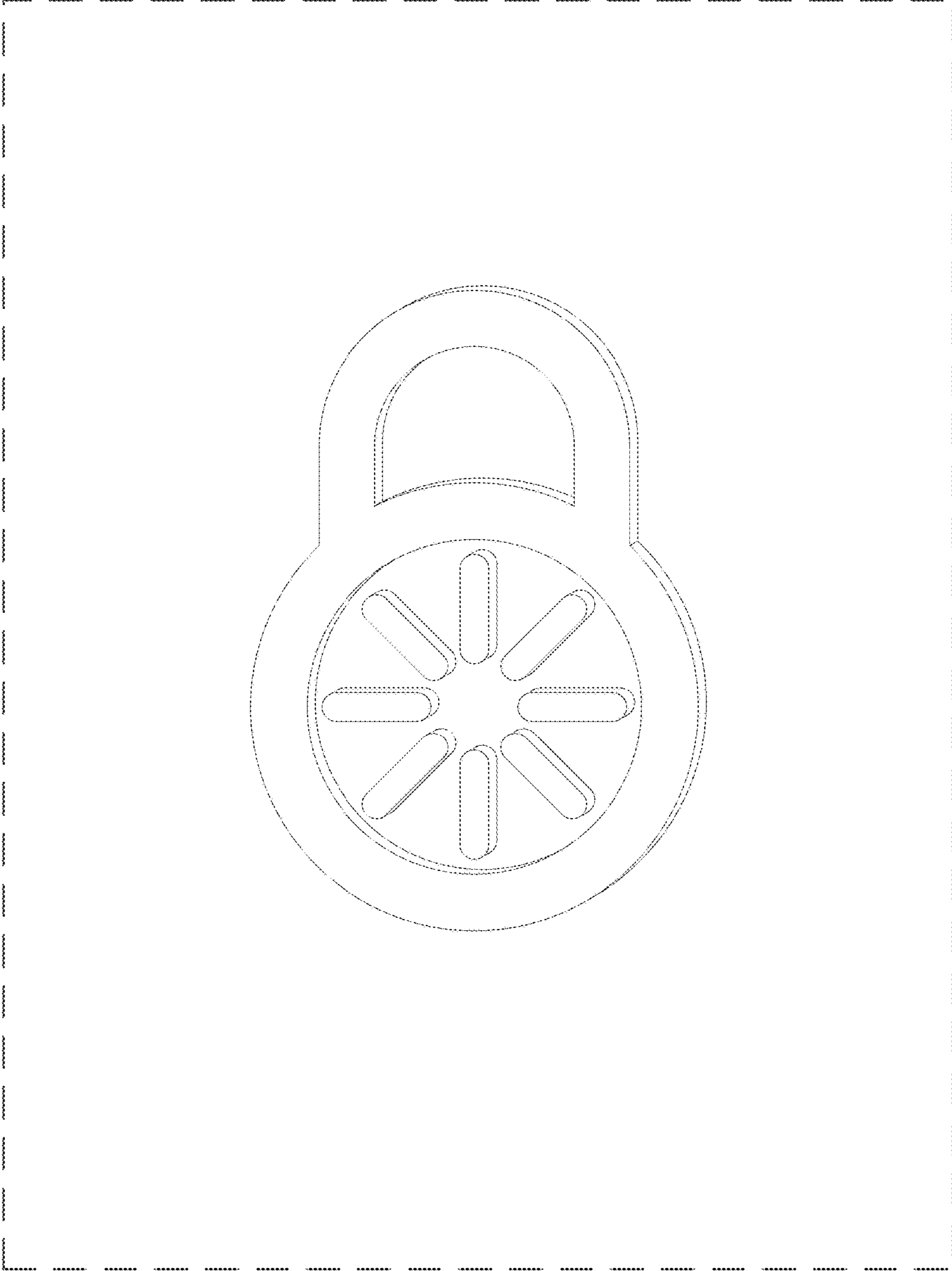
