7.

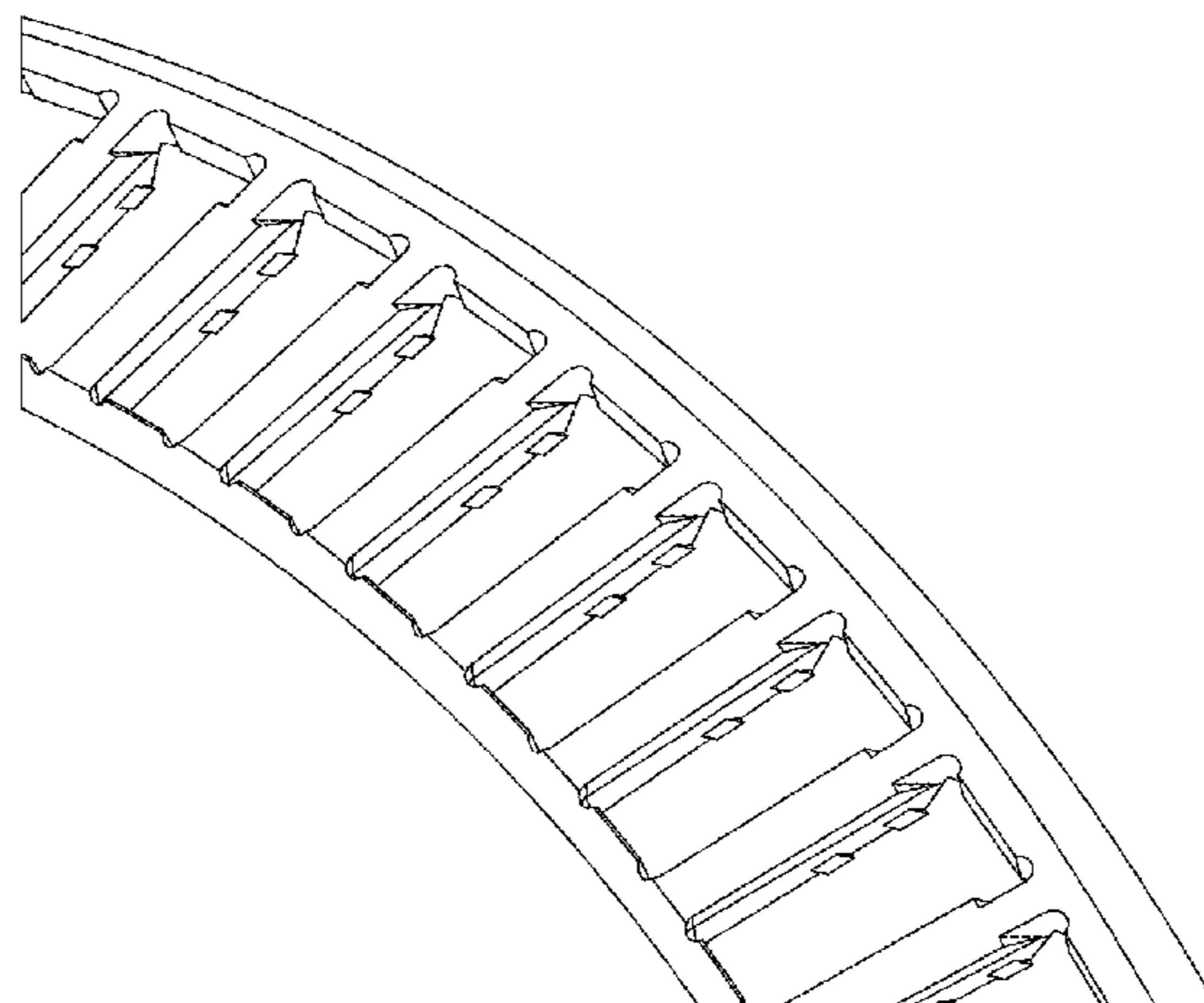
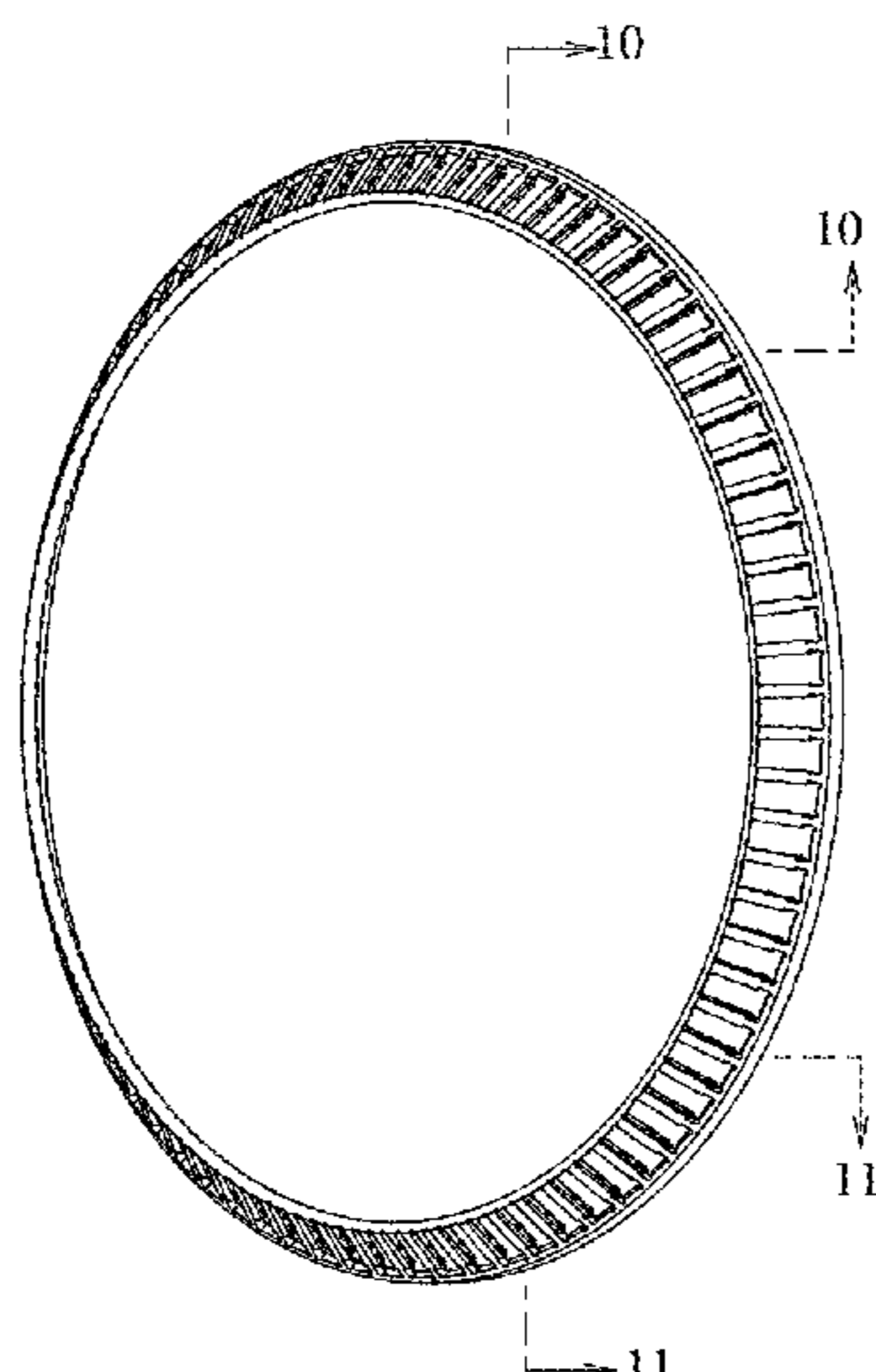

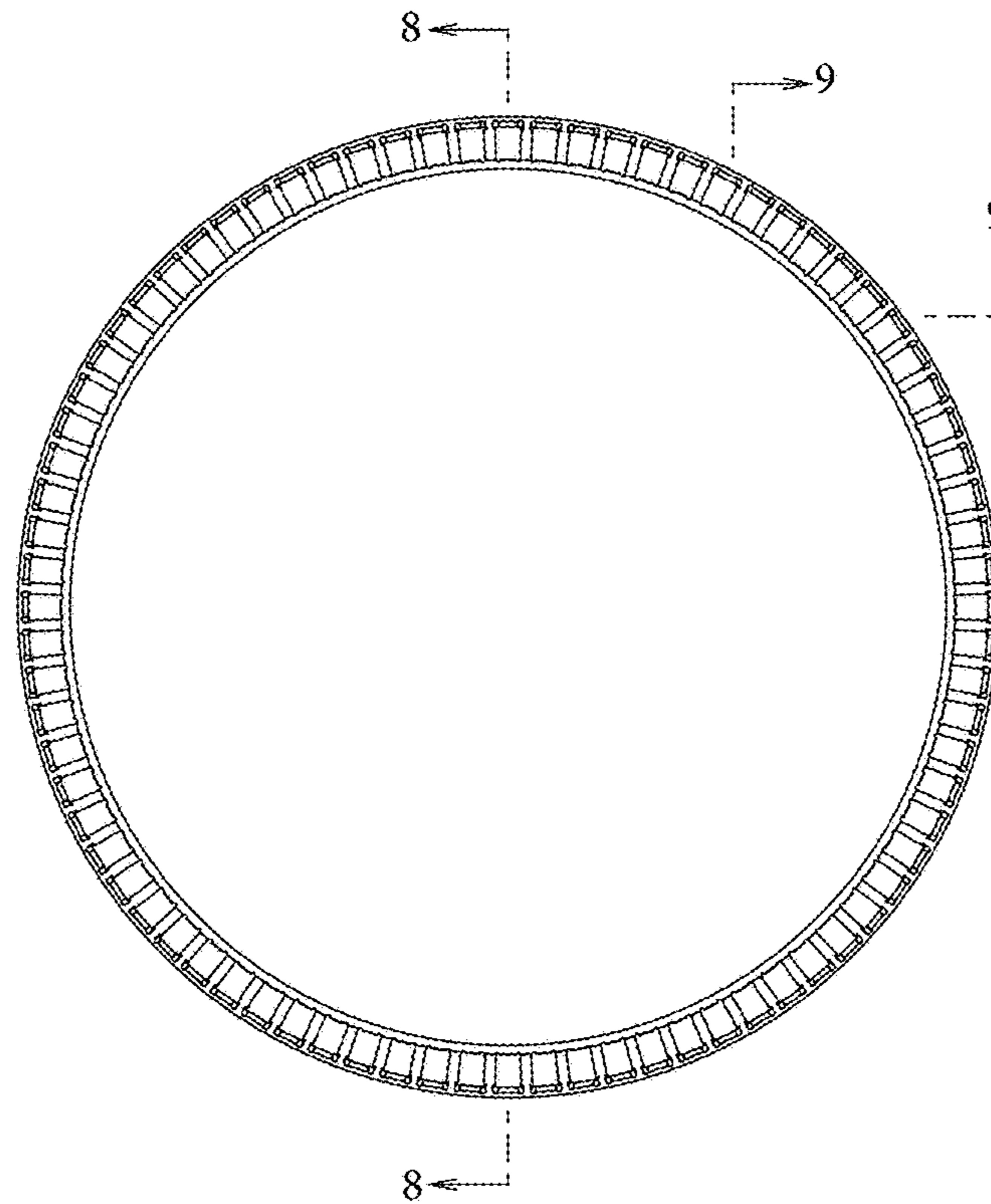

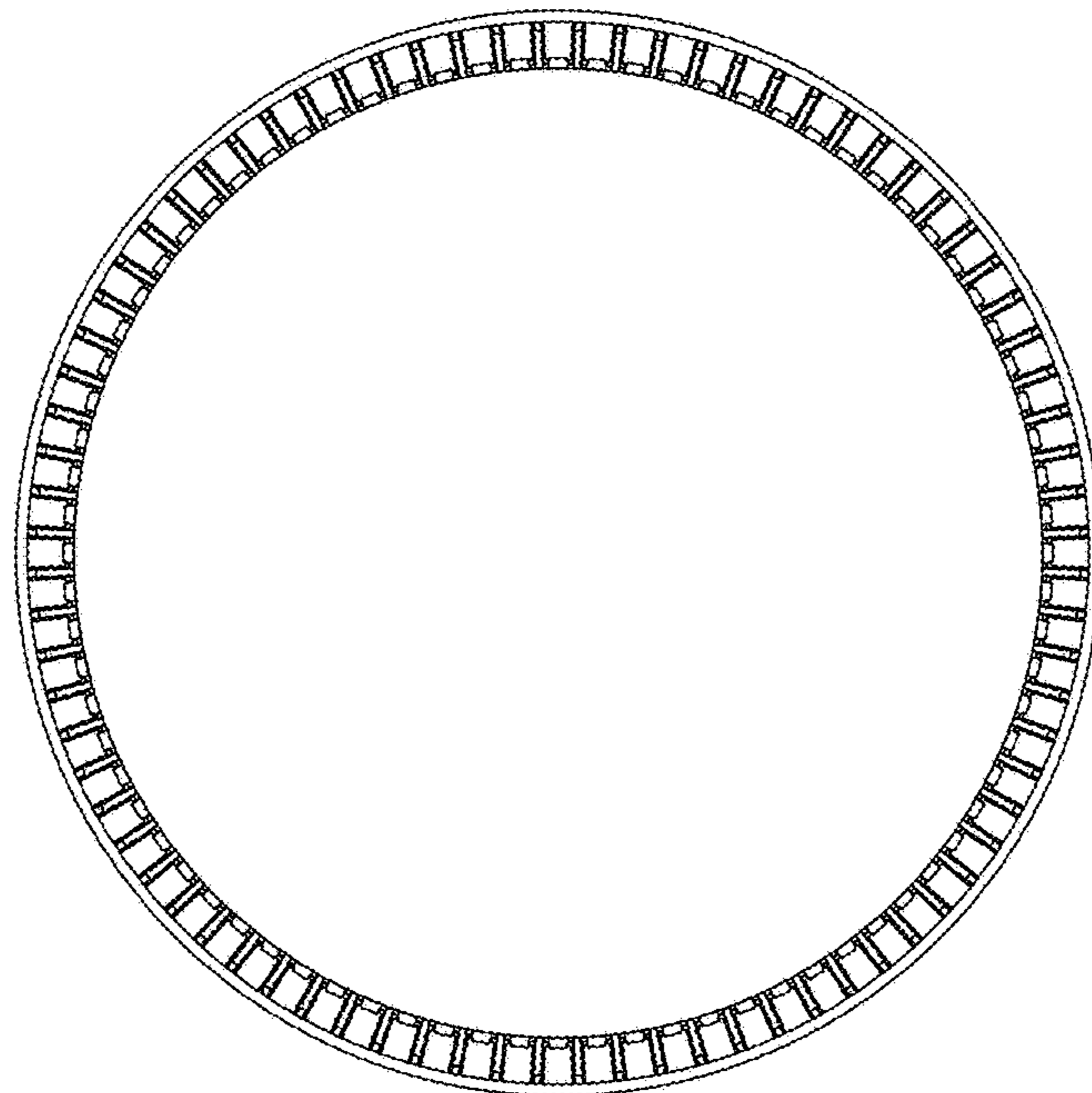

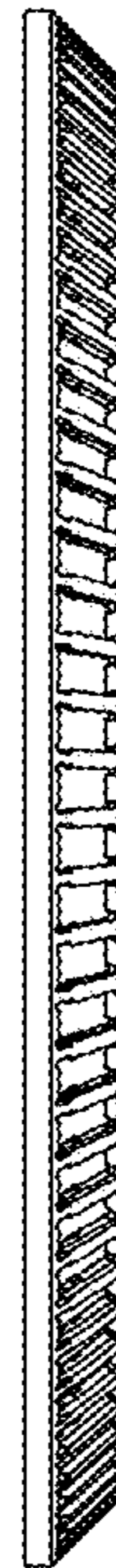

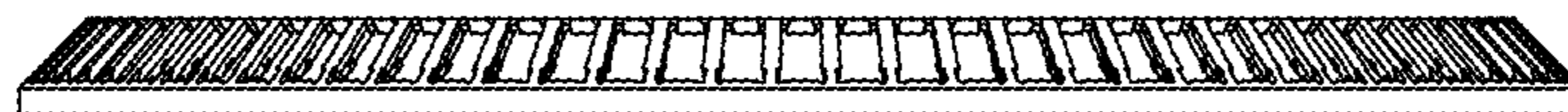

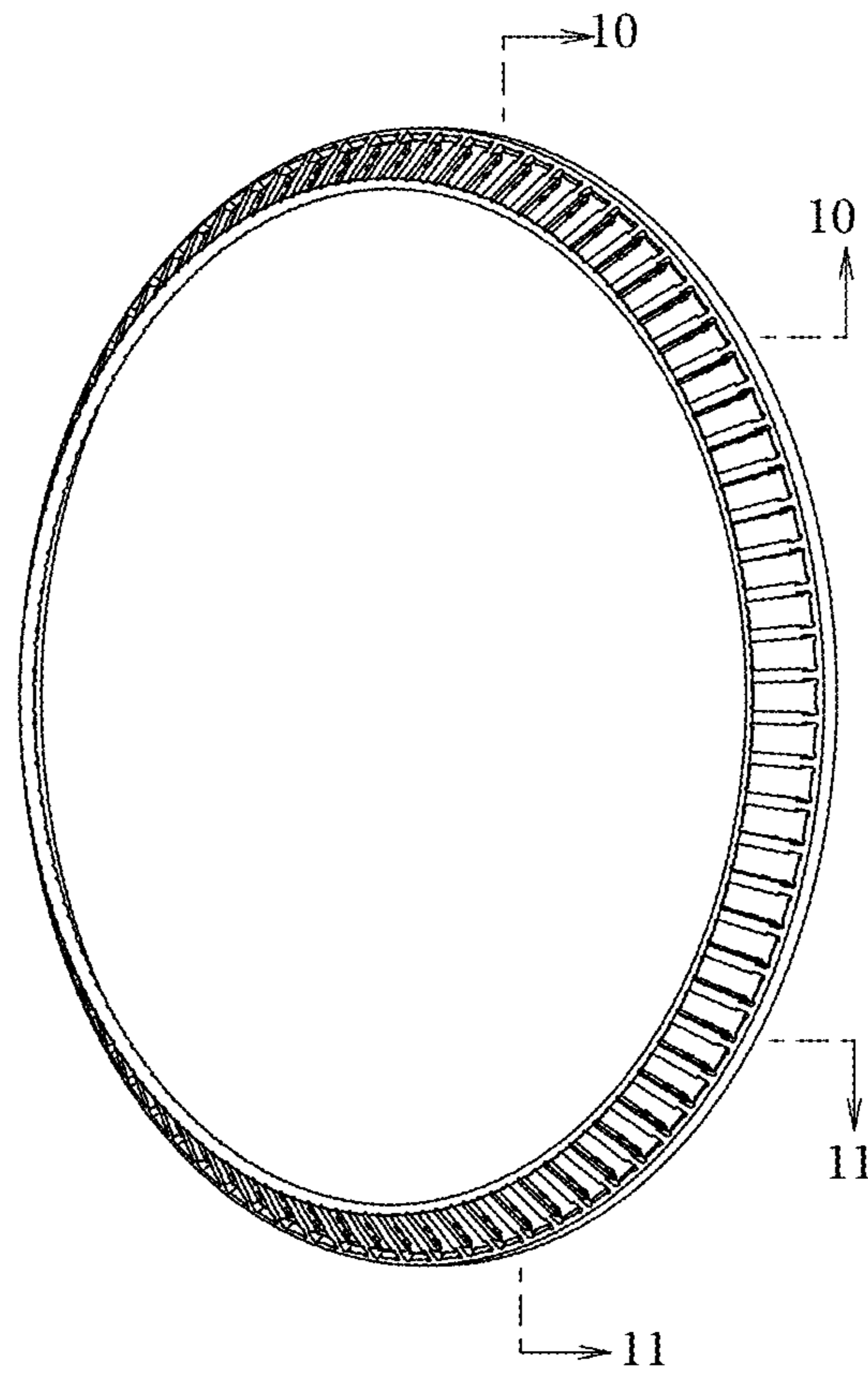

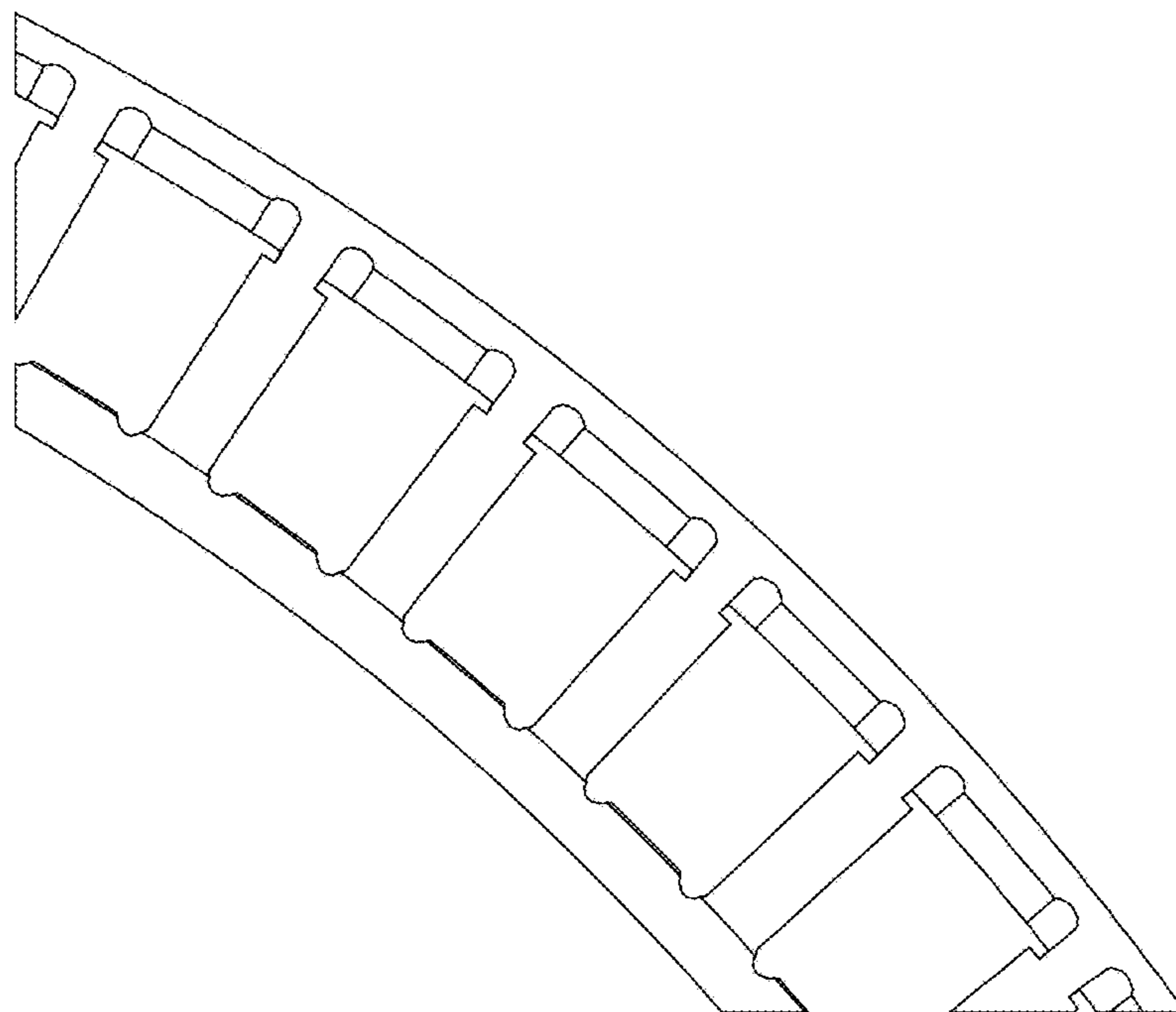

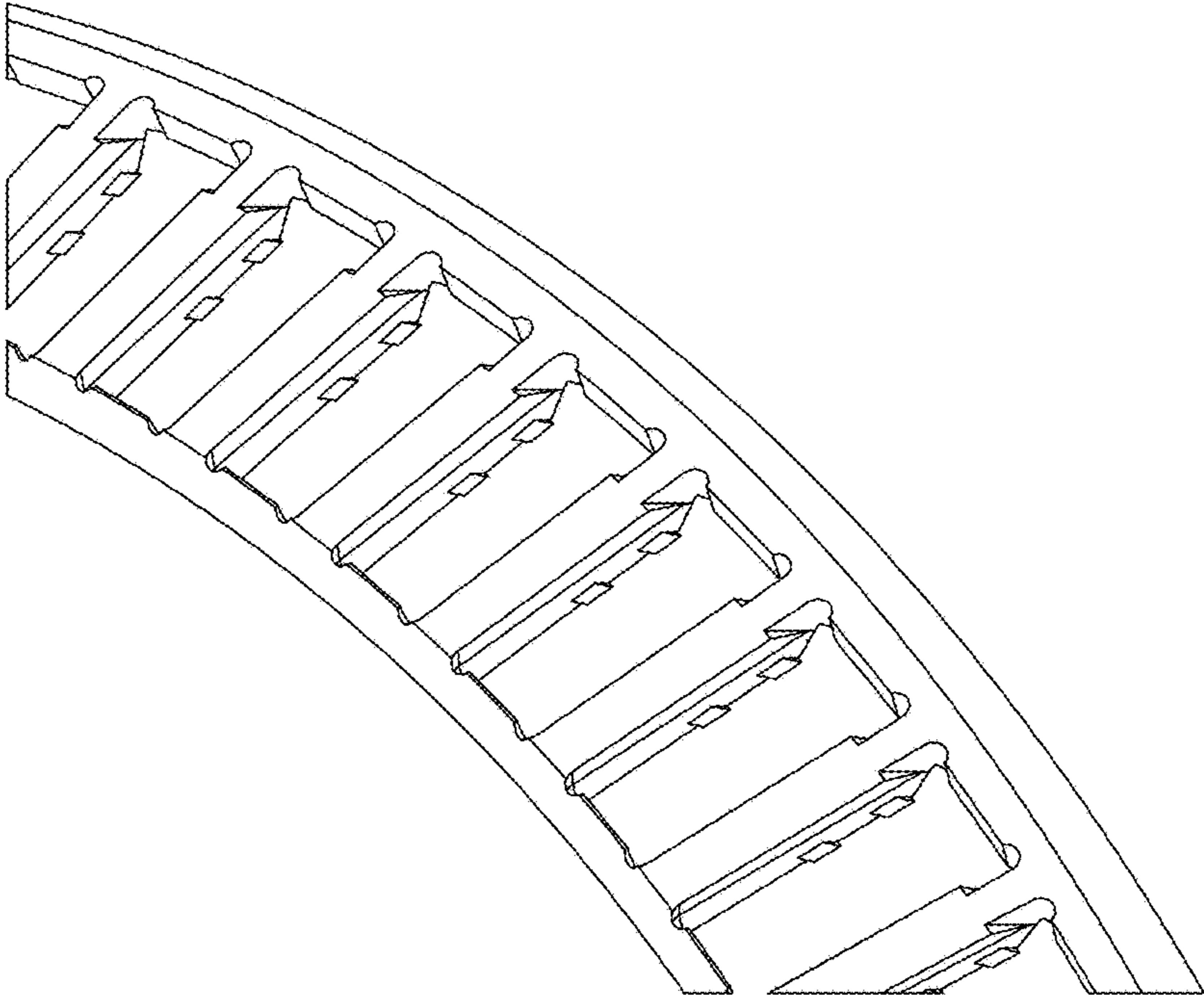
