(57) **CLAIM**
 I claim the ornamental design for a hang tag, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the hang tag, the rear perspective view being a mirror image thereof.
 FIG. 2 is a front elevational view of the hang tag of the present design; the rear elevational view being a mirror image thereof.
 FIG. 3 is a left side elevational view of the hang tag of the present design.
 FIG. 4 is a right side elevational view of the hang tag of the present design.
 FIG. 5 is a bottom plan view of the hang tag showing the design; and,
 FIG. 6 is a top plan view of the hang tag showing the design.

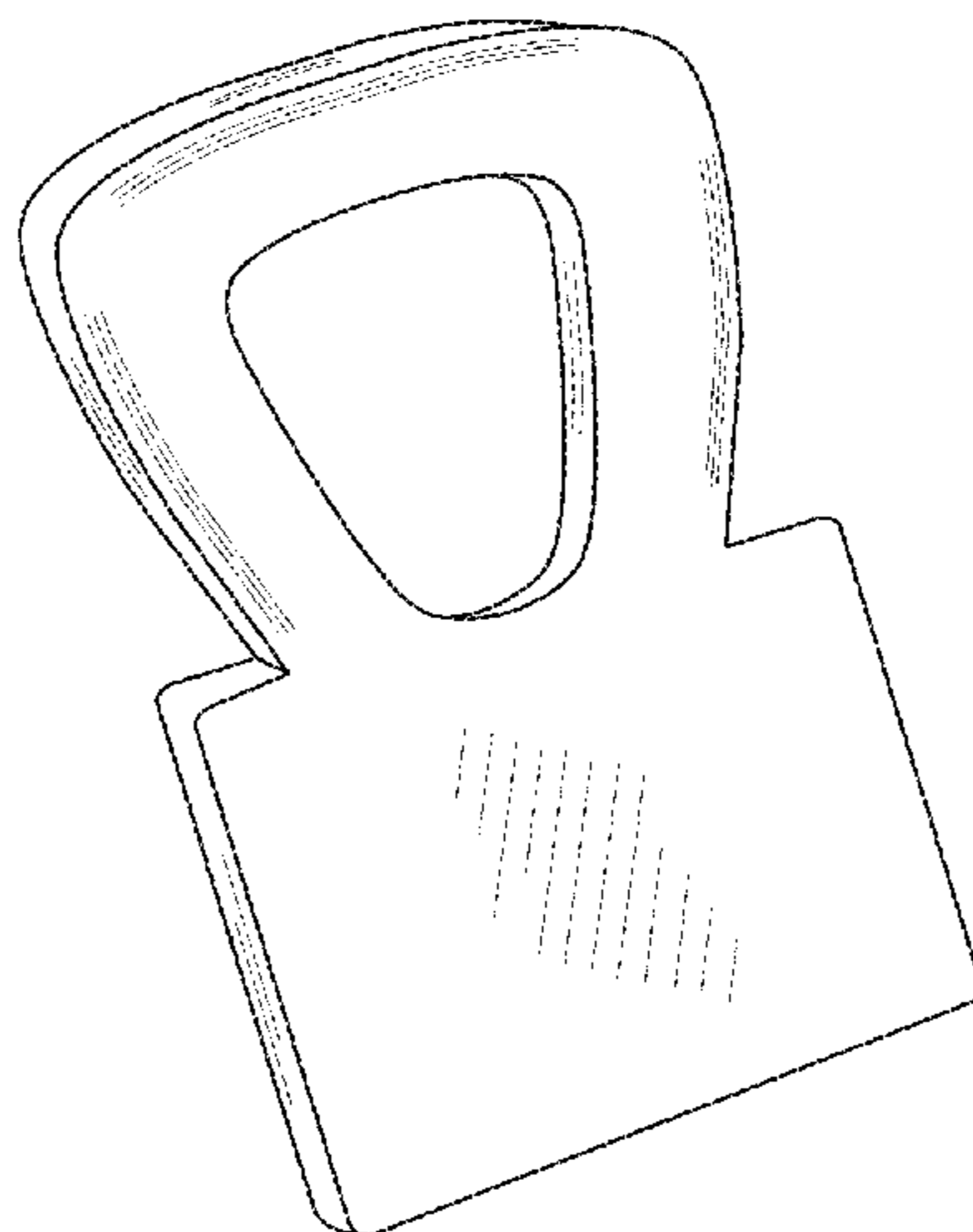

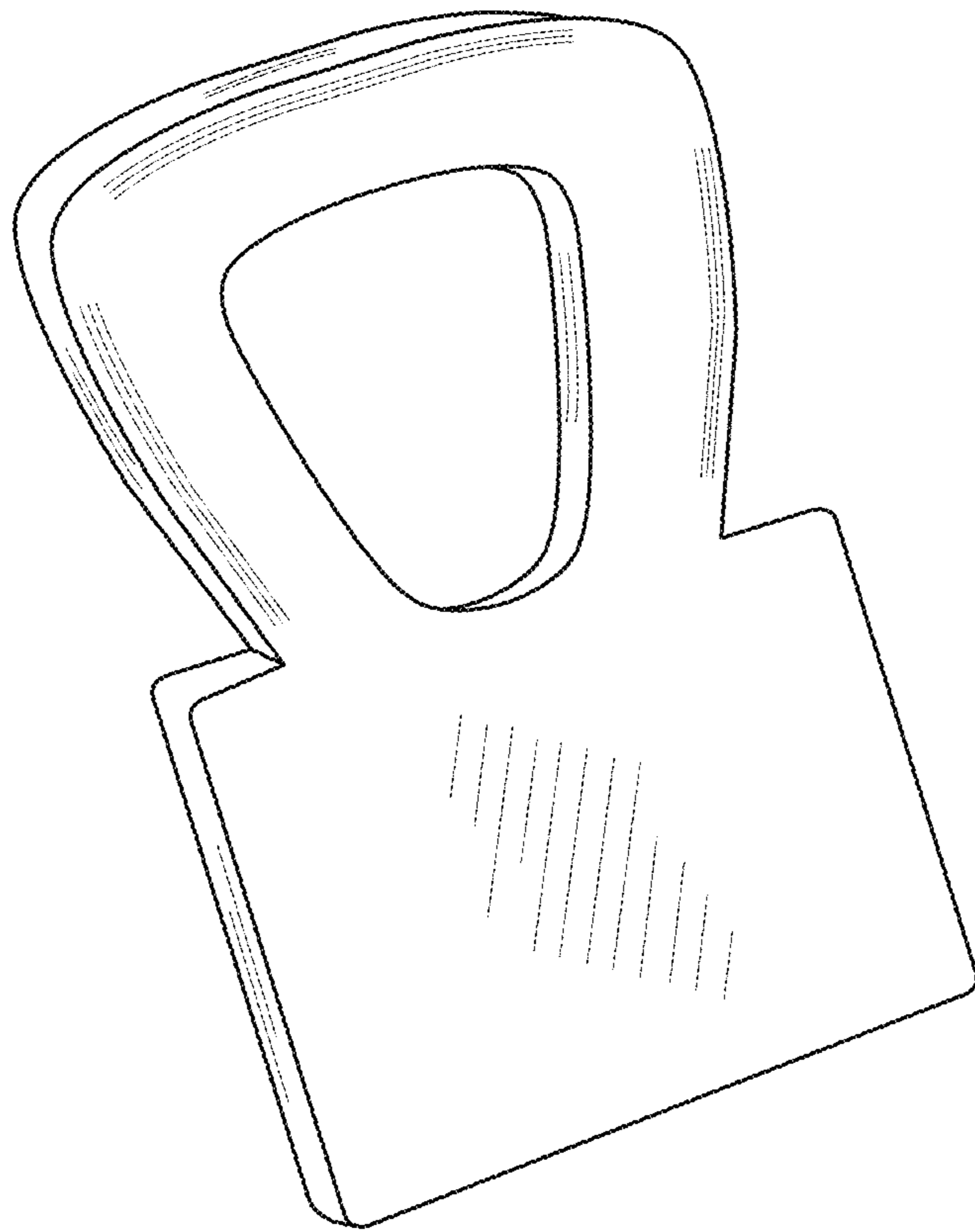

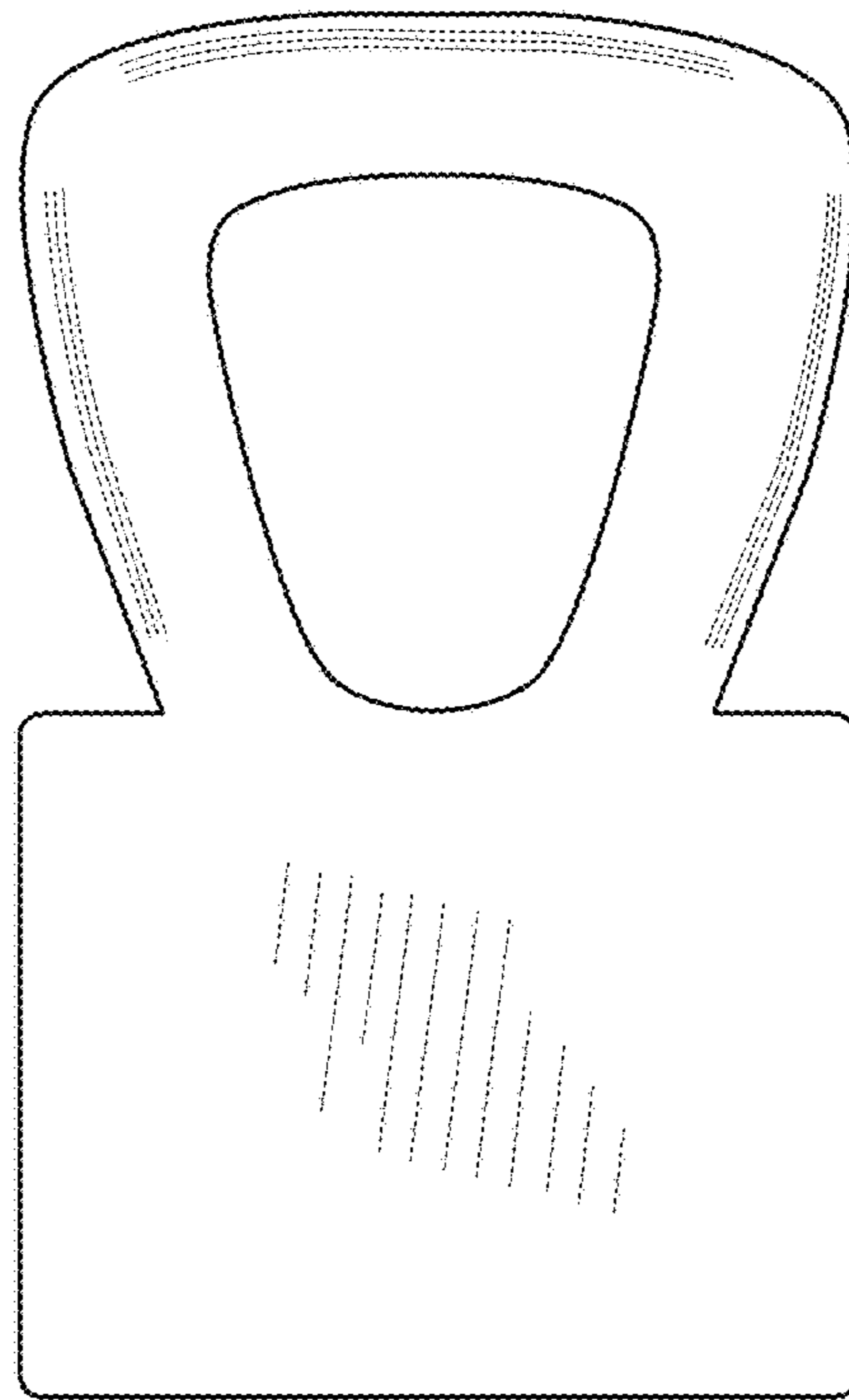

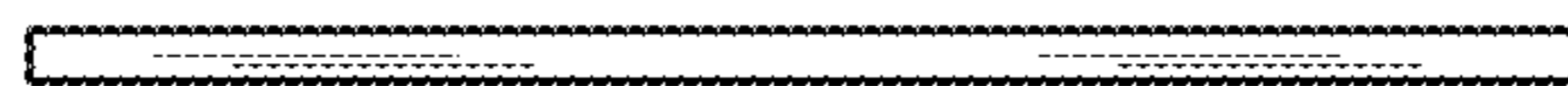
