FIG. 5 is a right side view of the goal of FIG. 1;

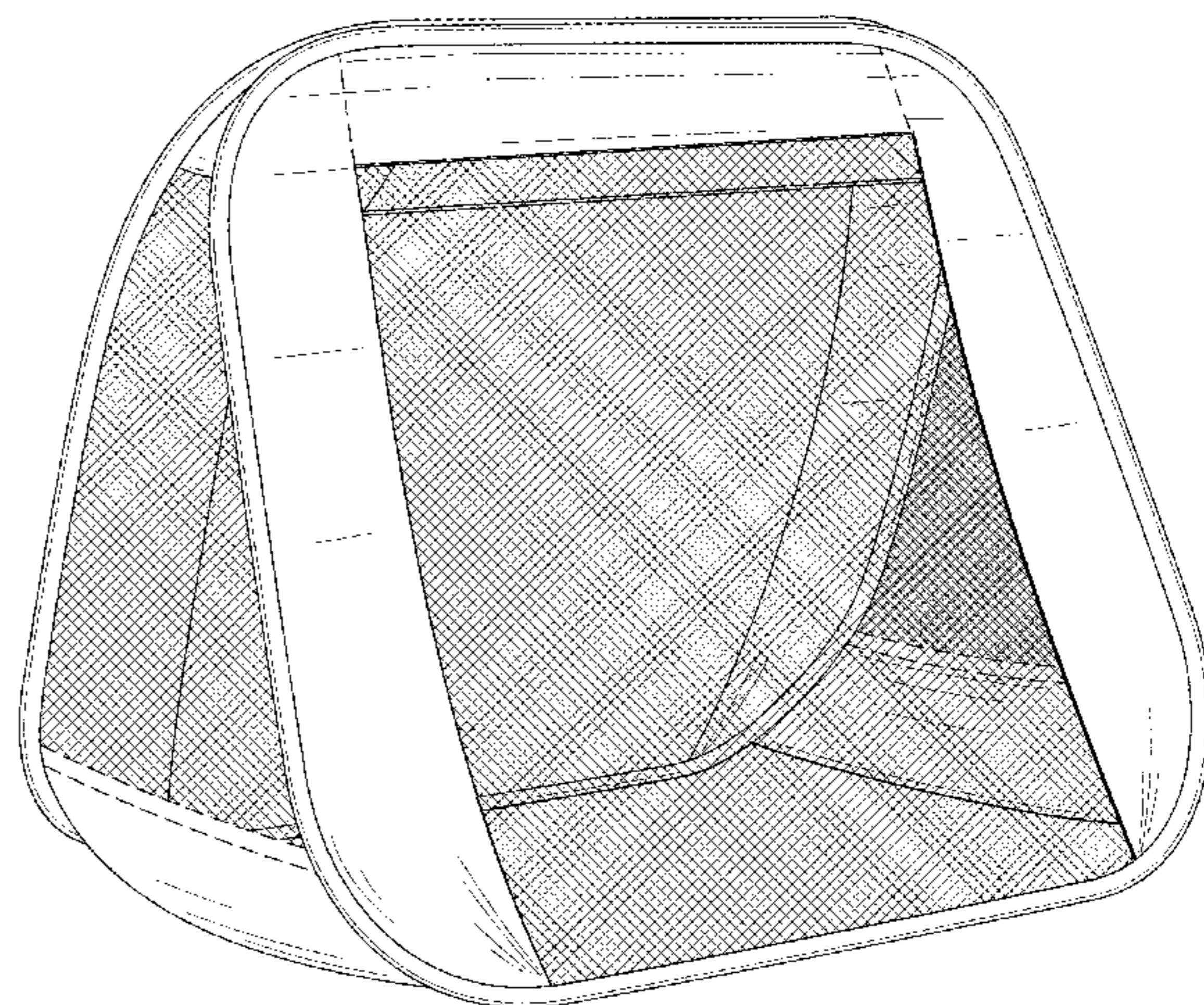
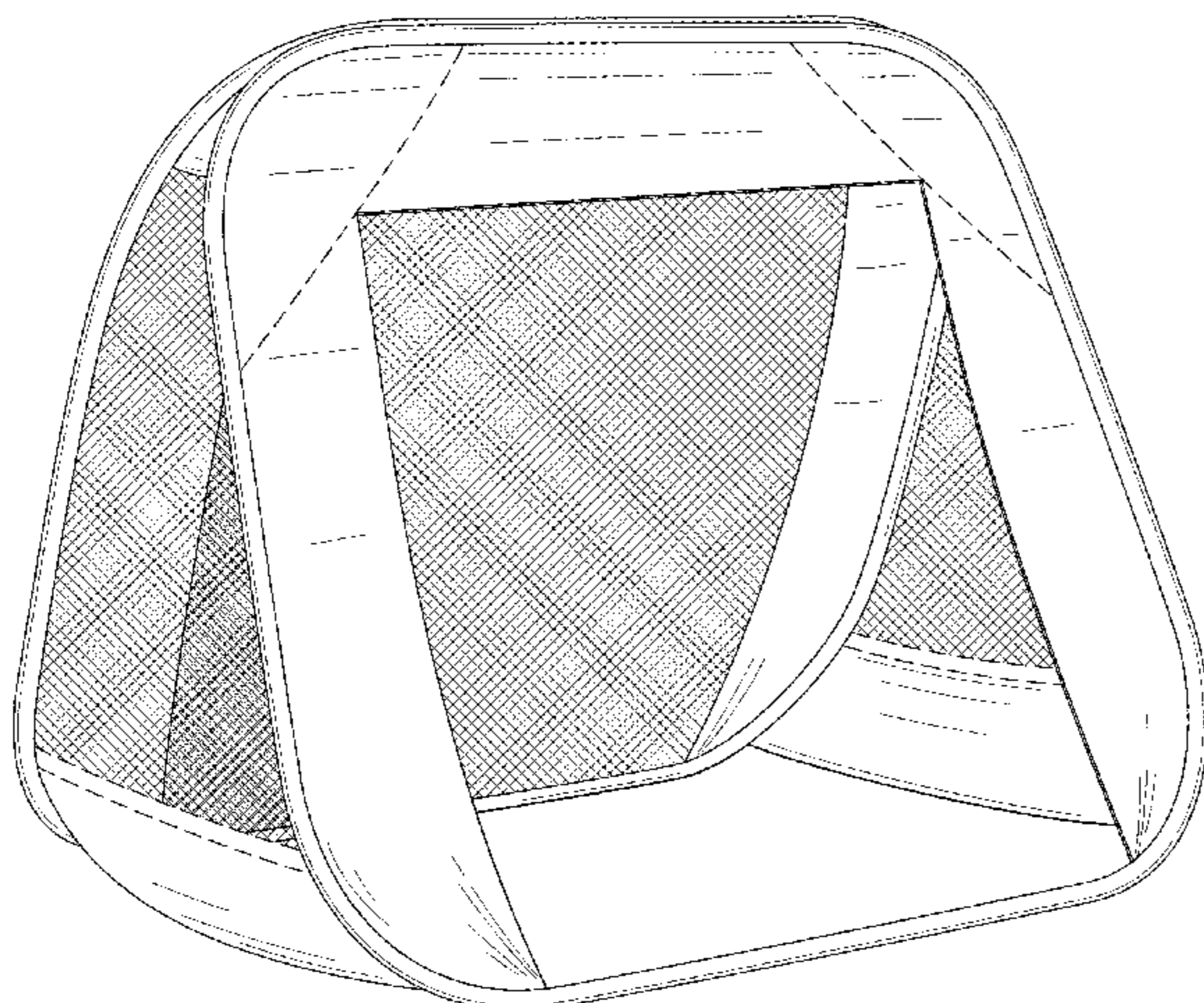
FIG. 6 is a left side view of the goal of FIG. 1;

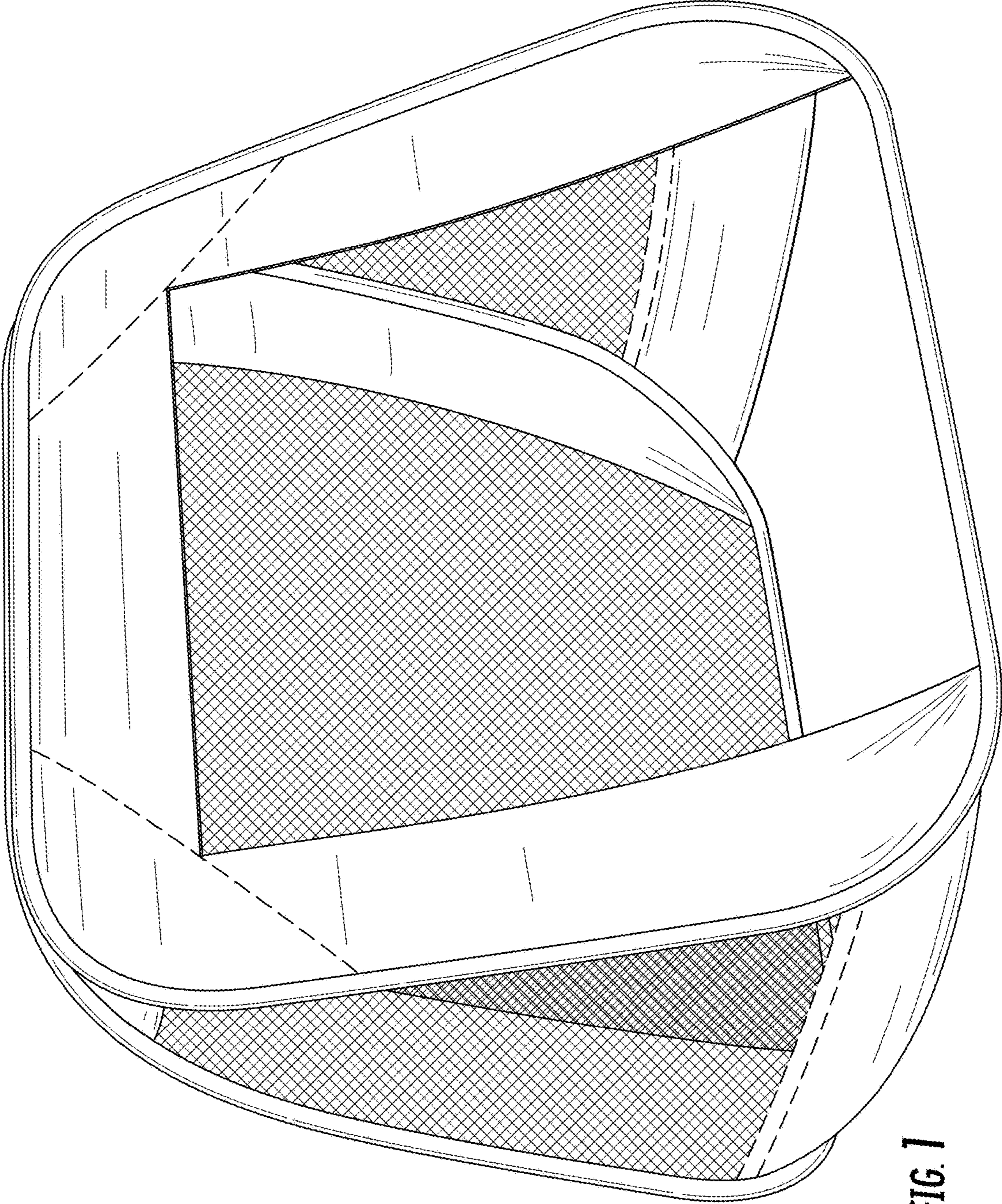

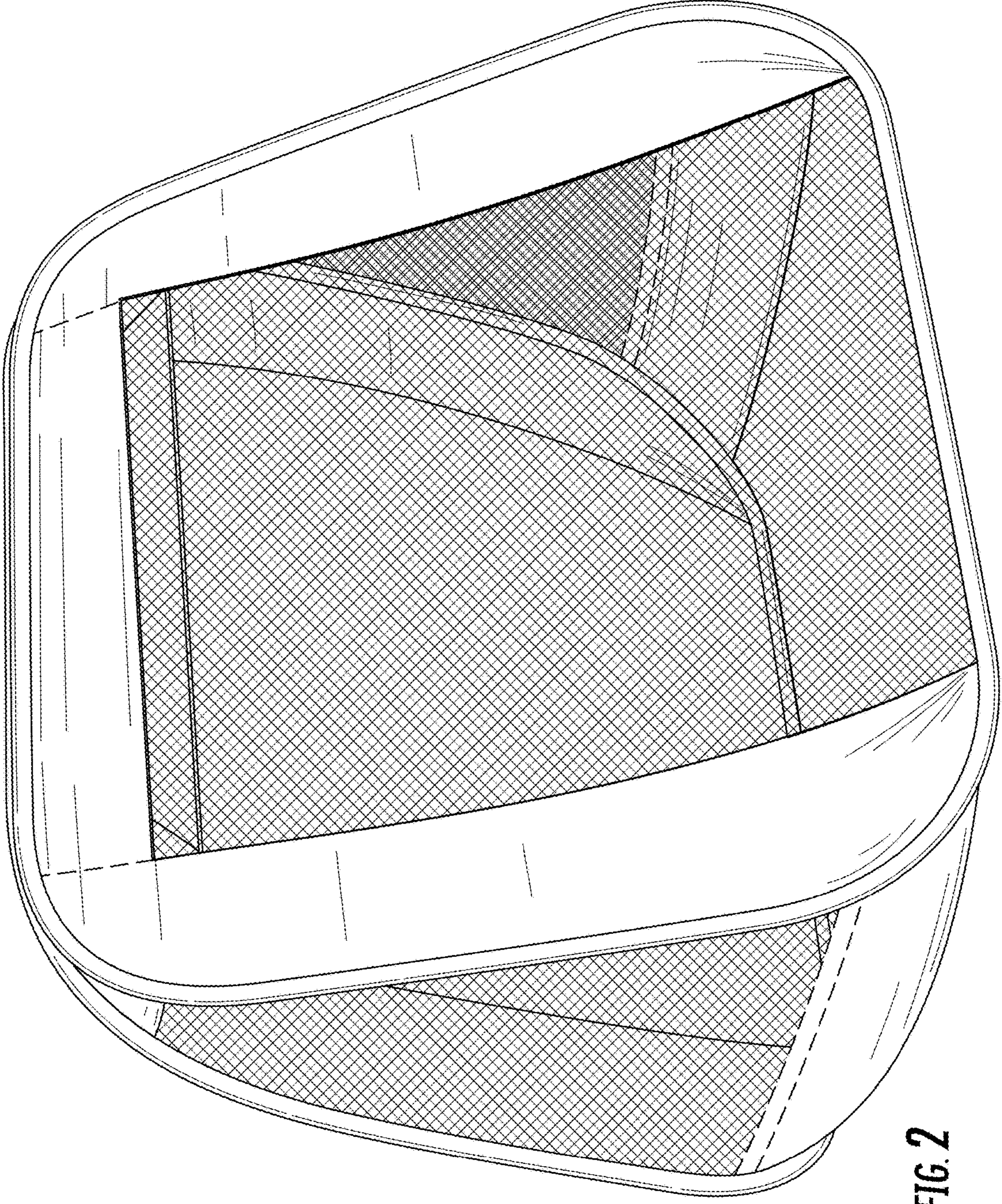

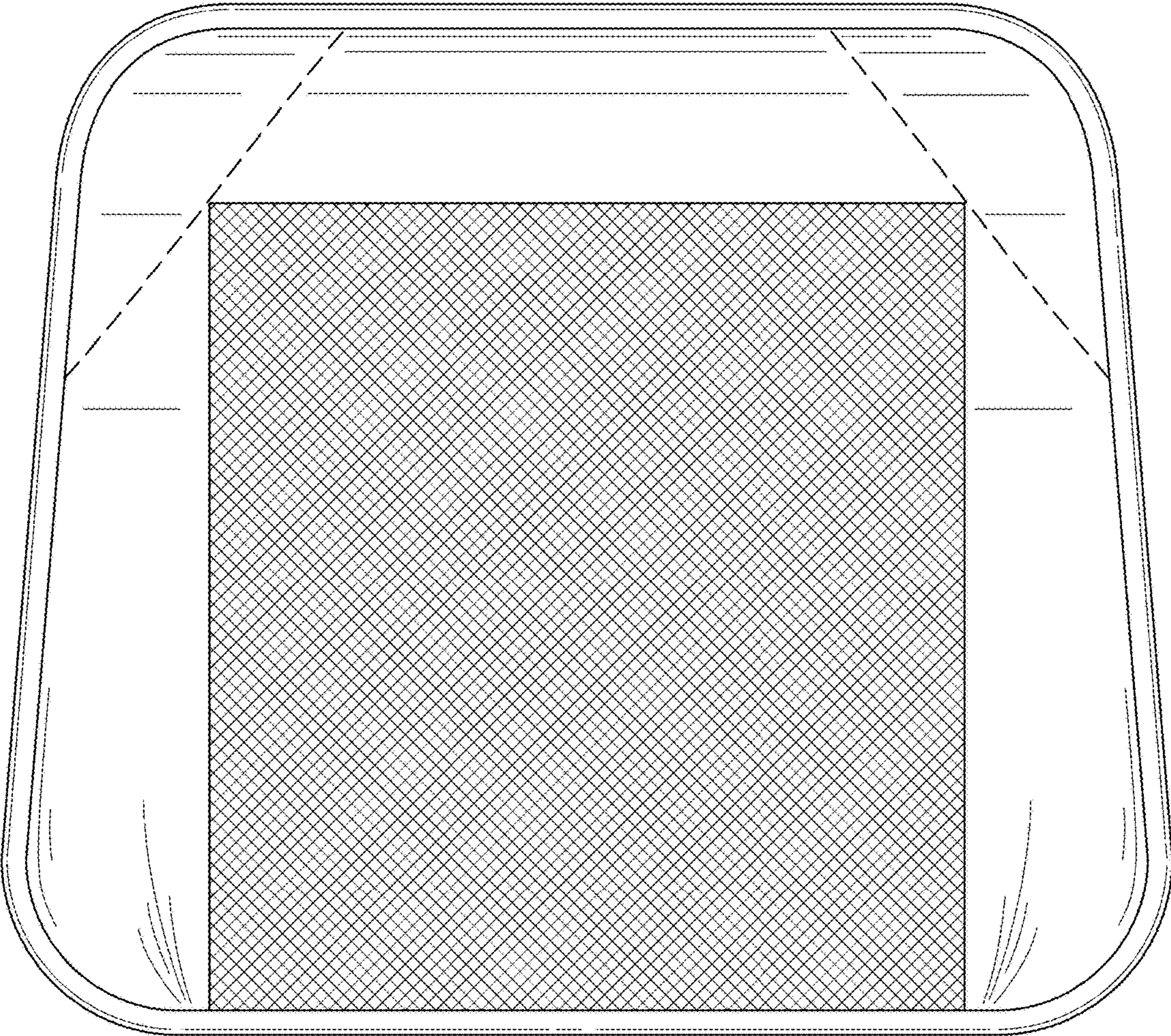

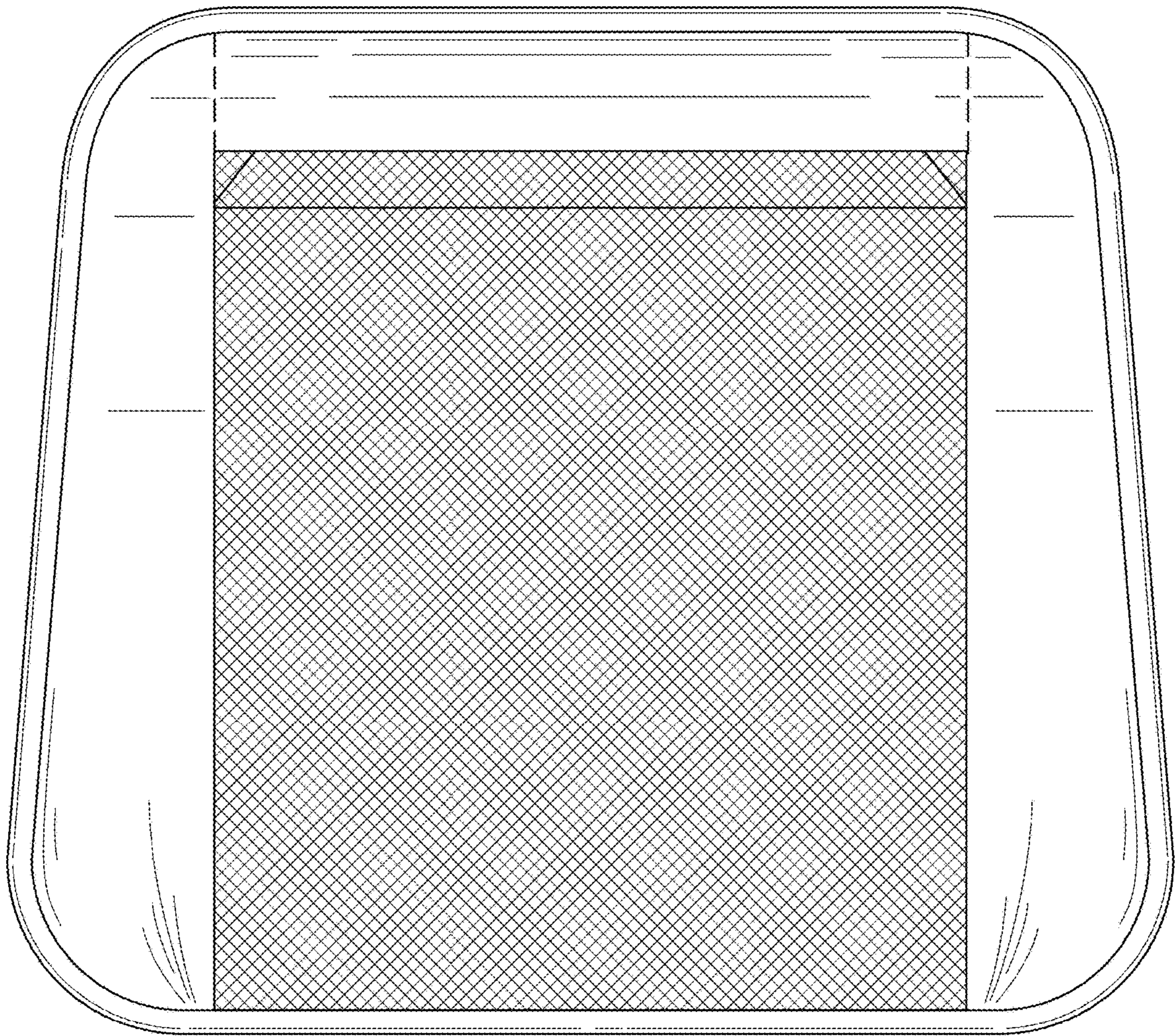

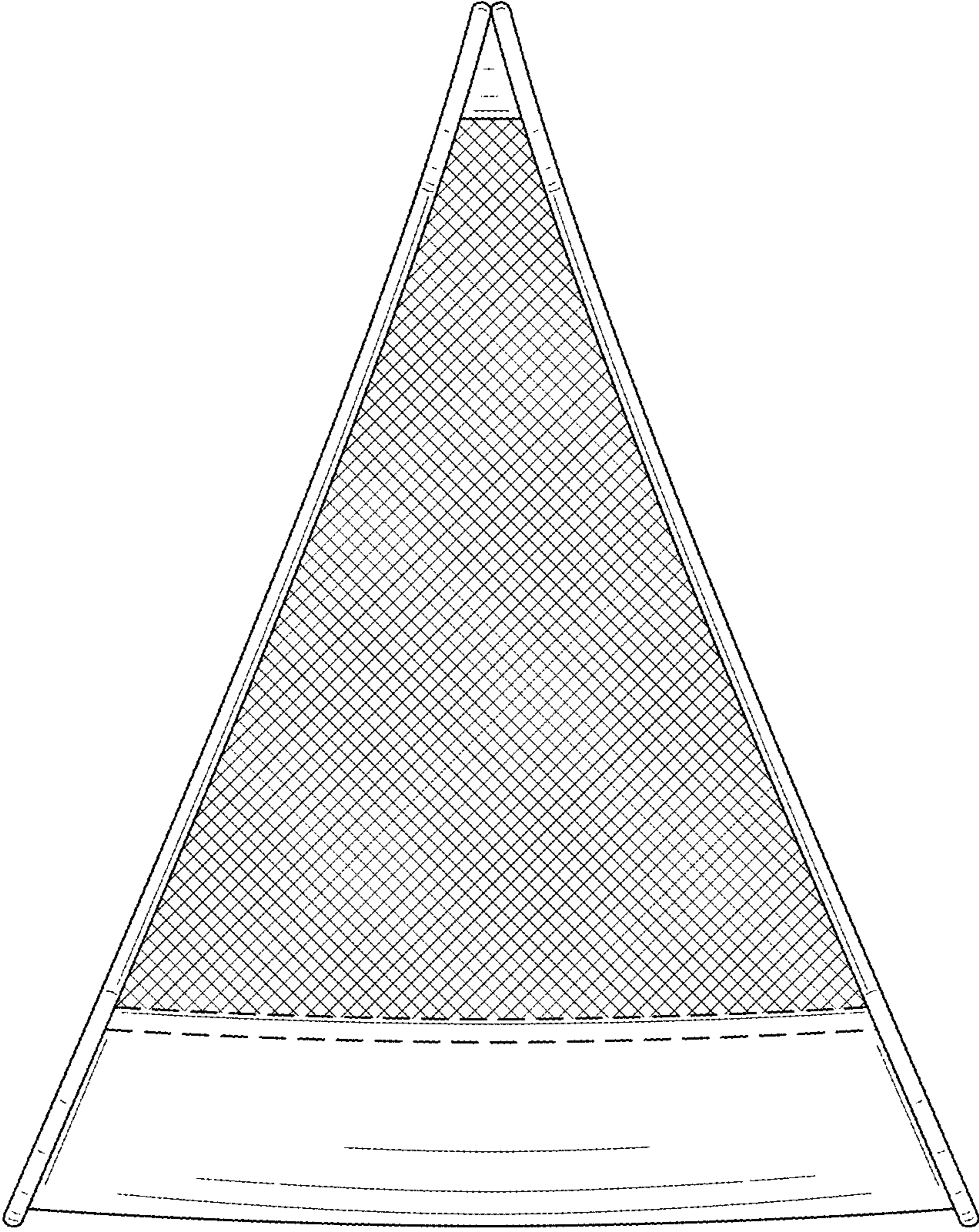

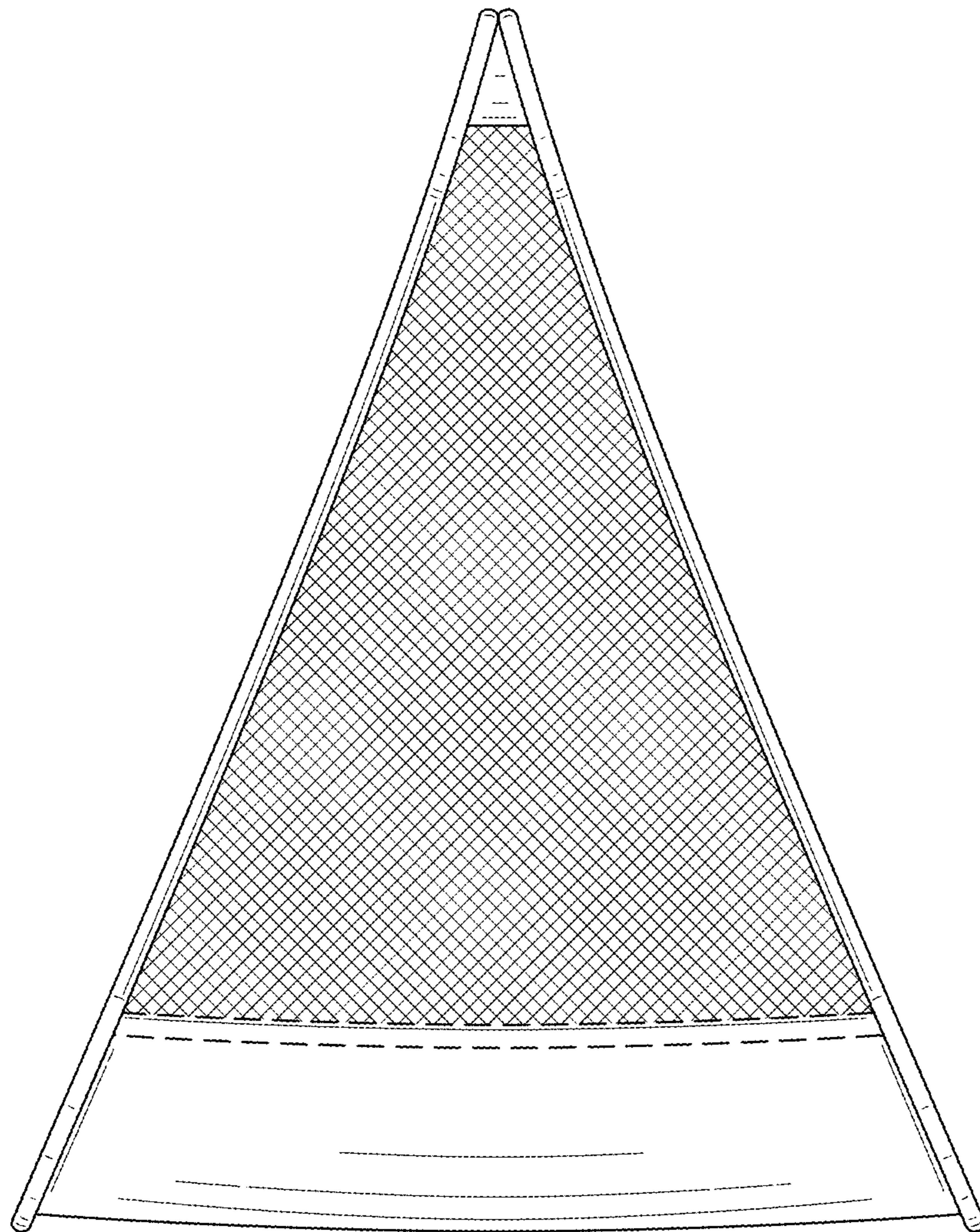

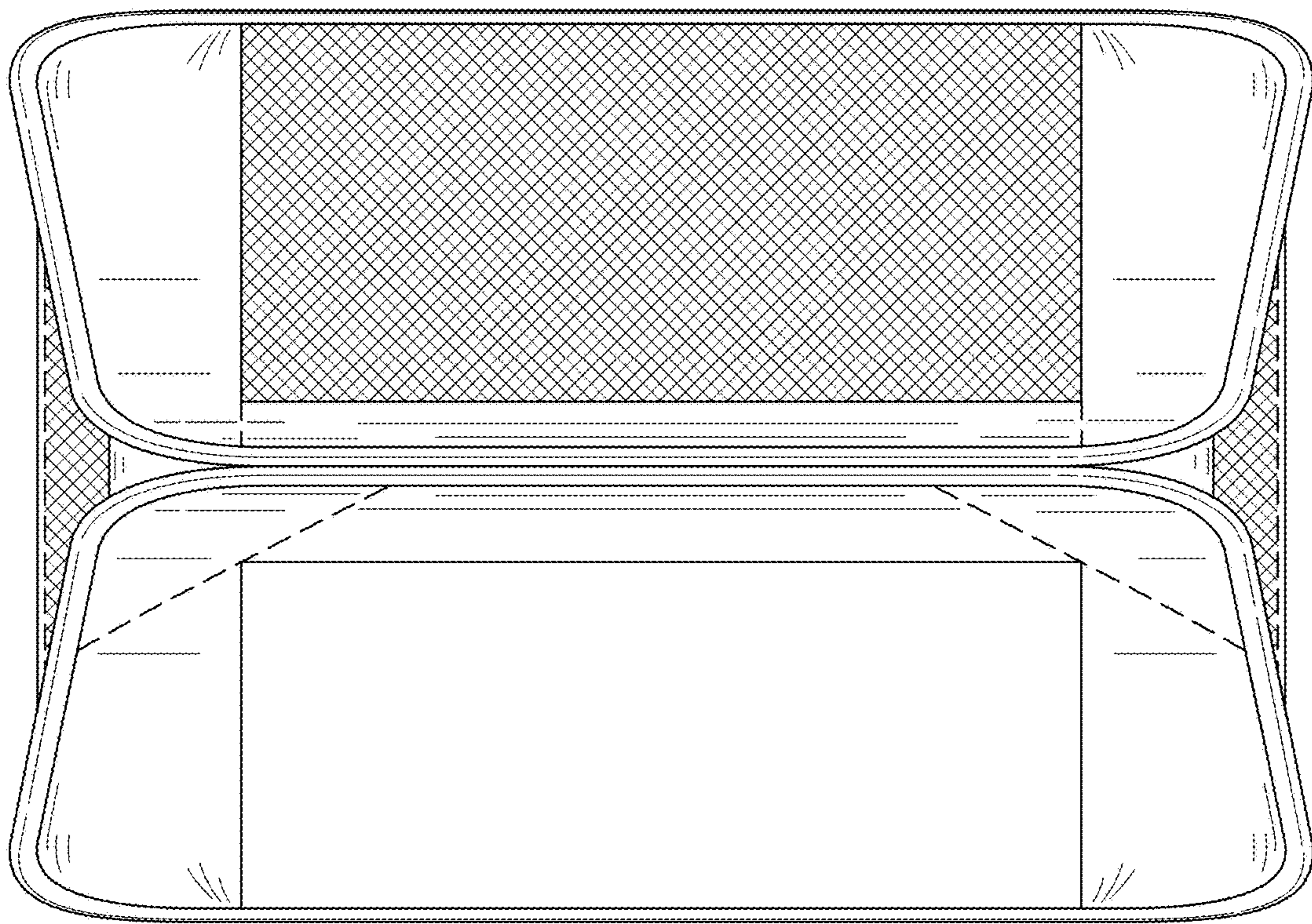

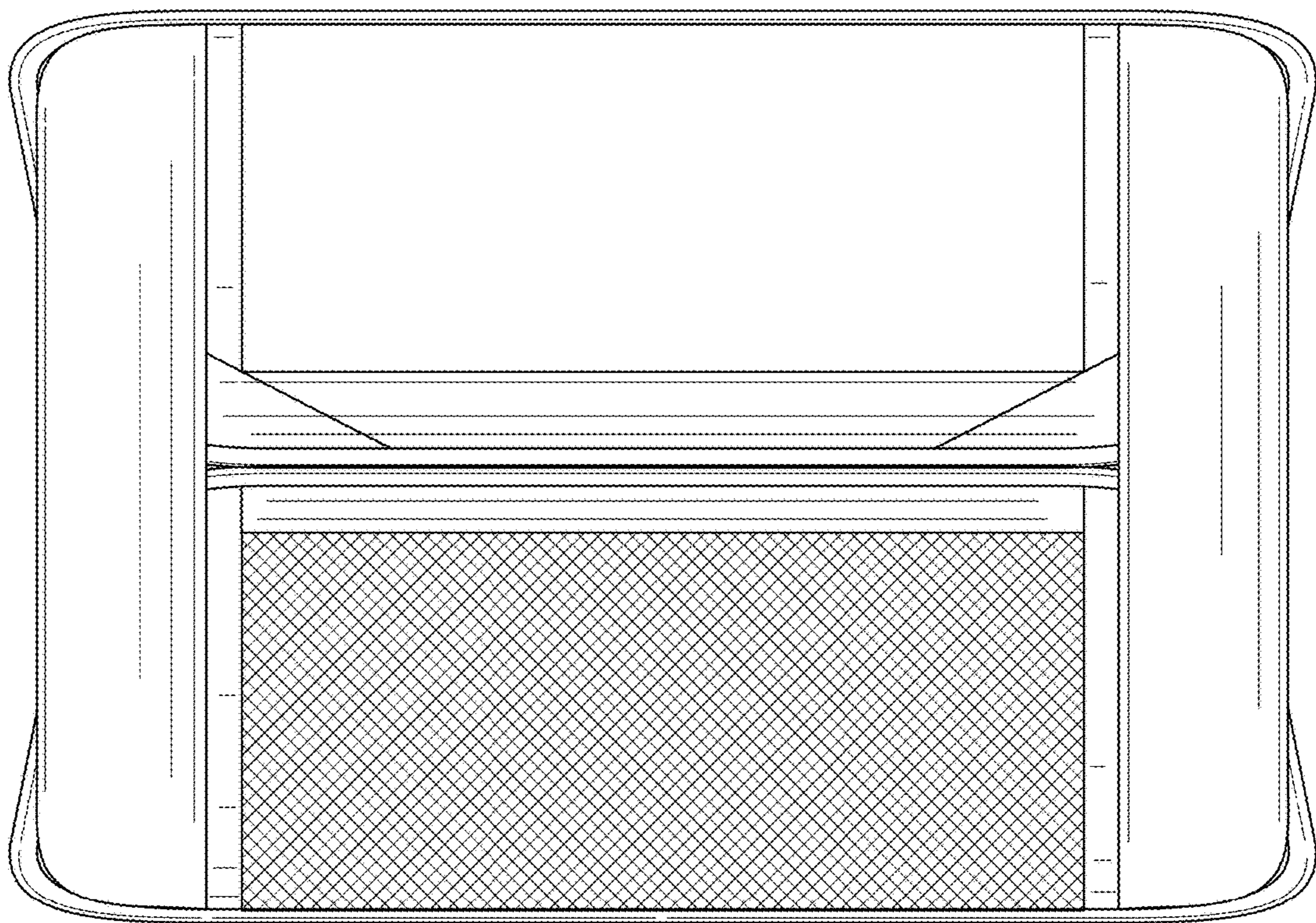
