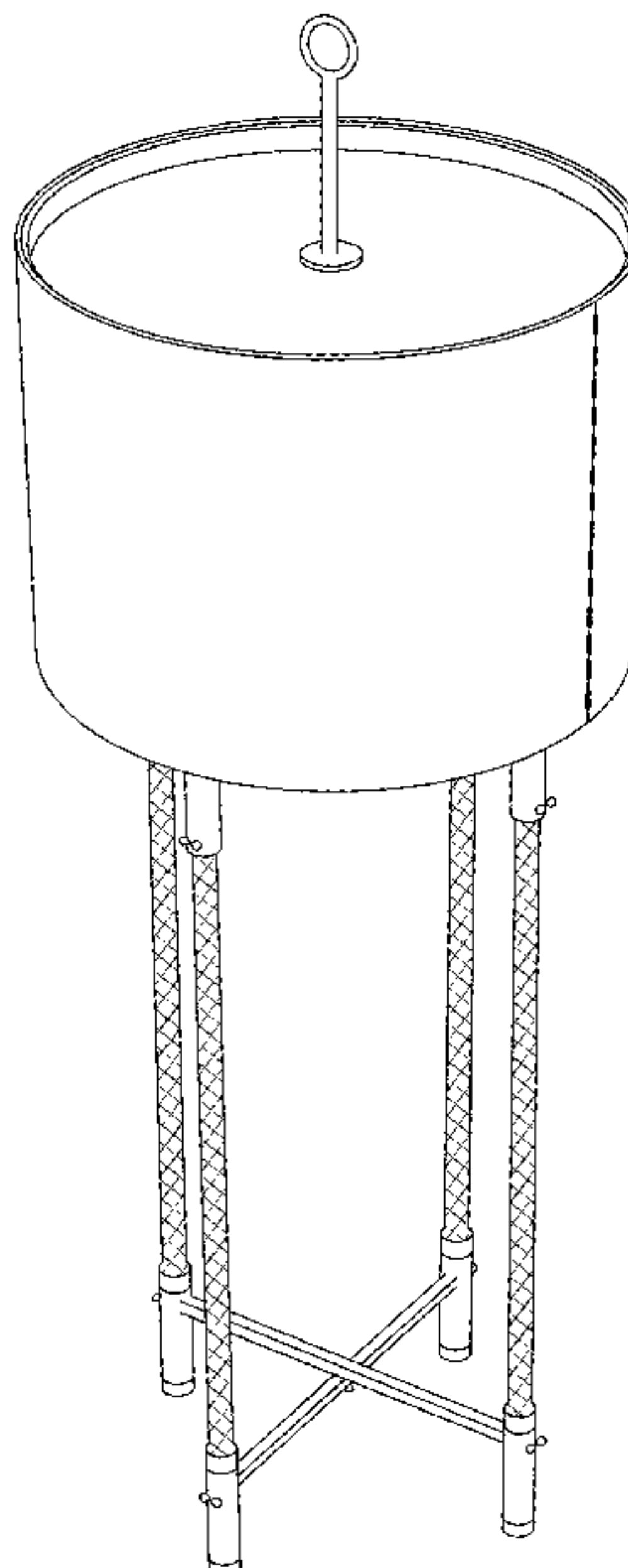
The ornamental design for a lamp, as shown and described.

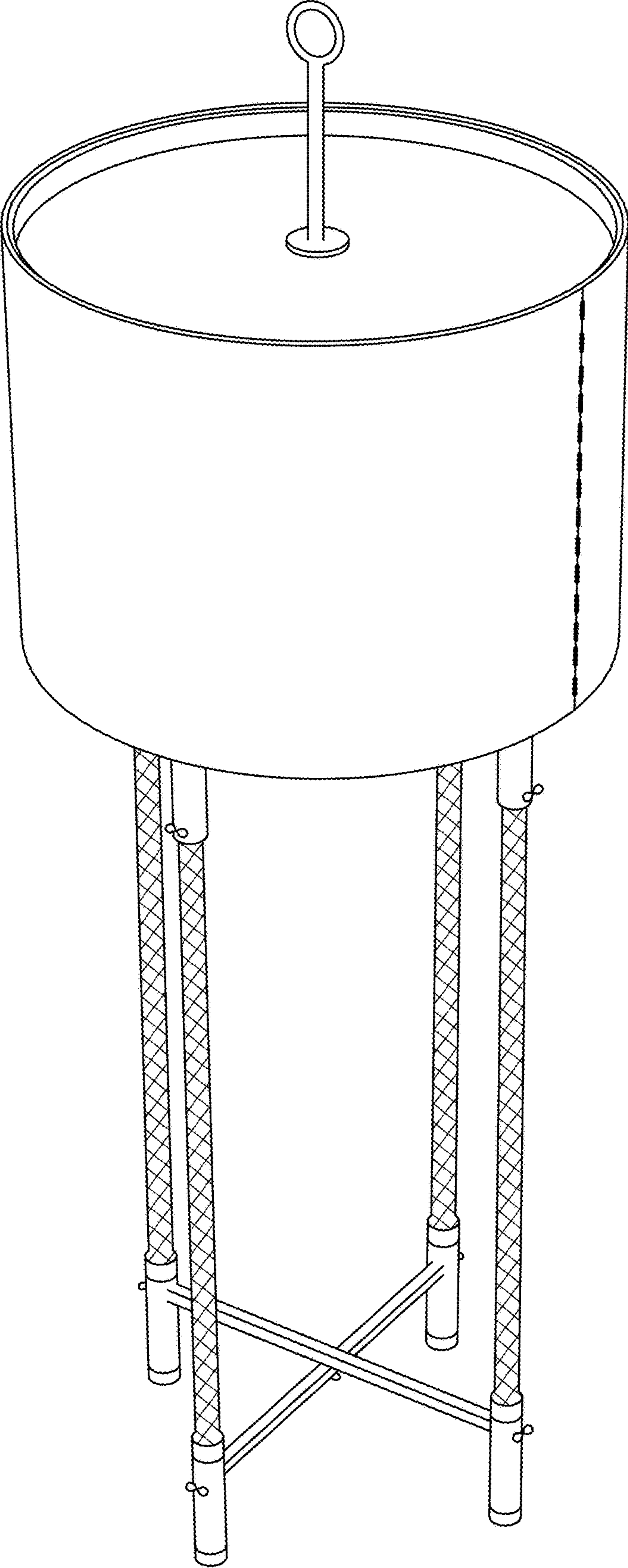

The broken lines showing portions of the lamp form no part of the claimed design.

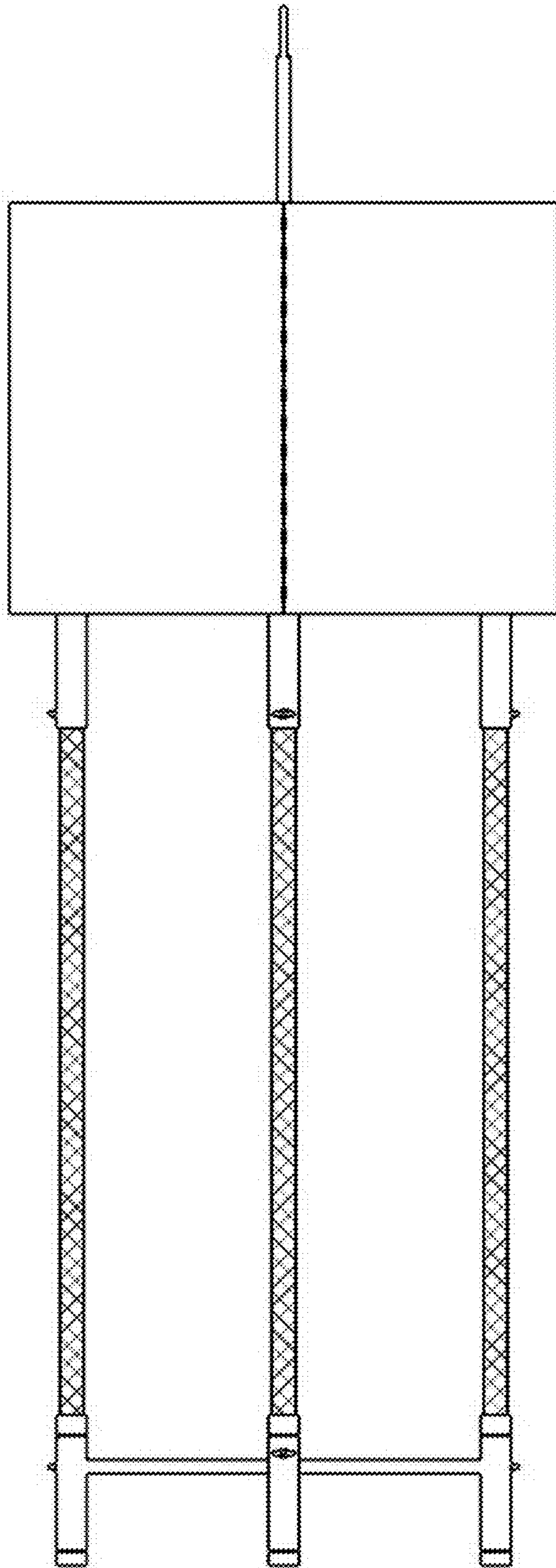

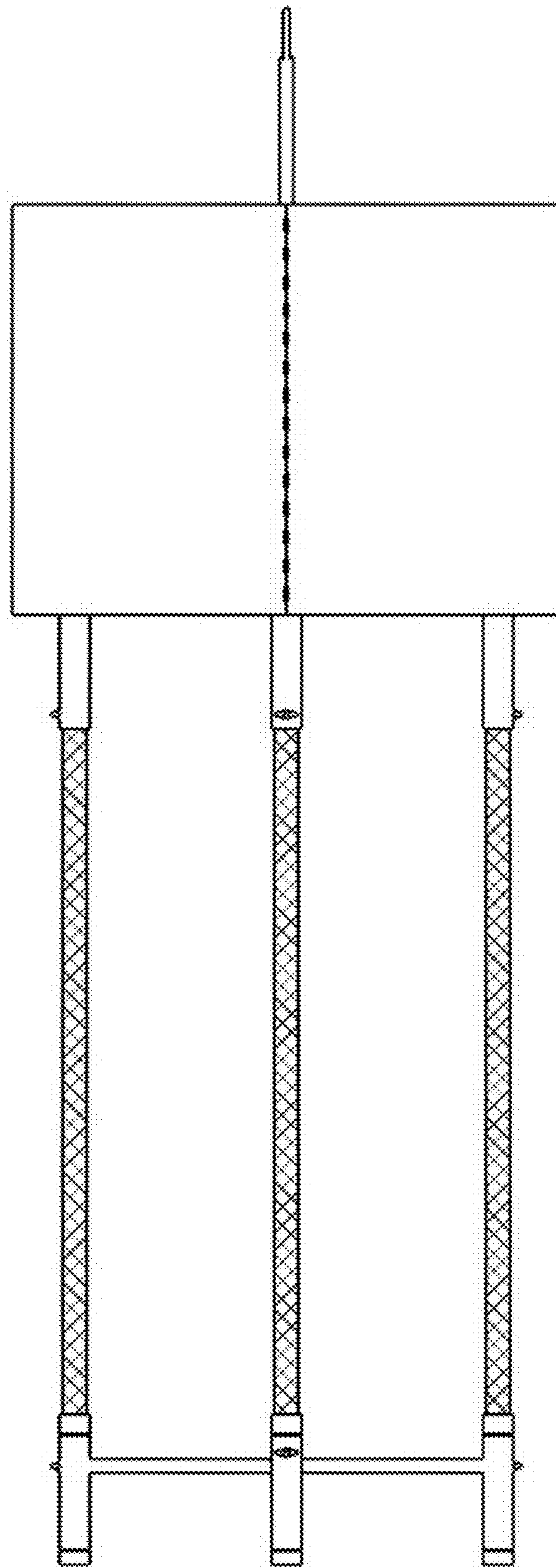

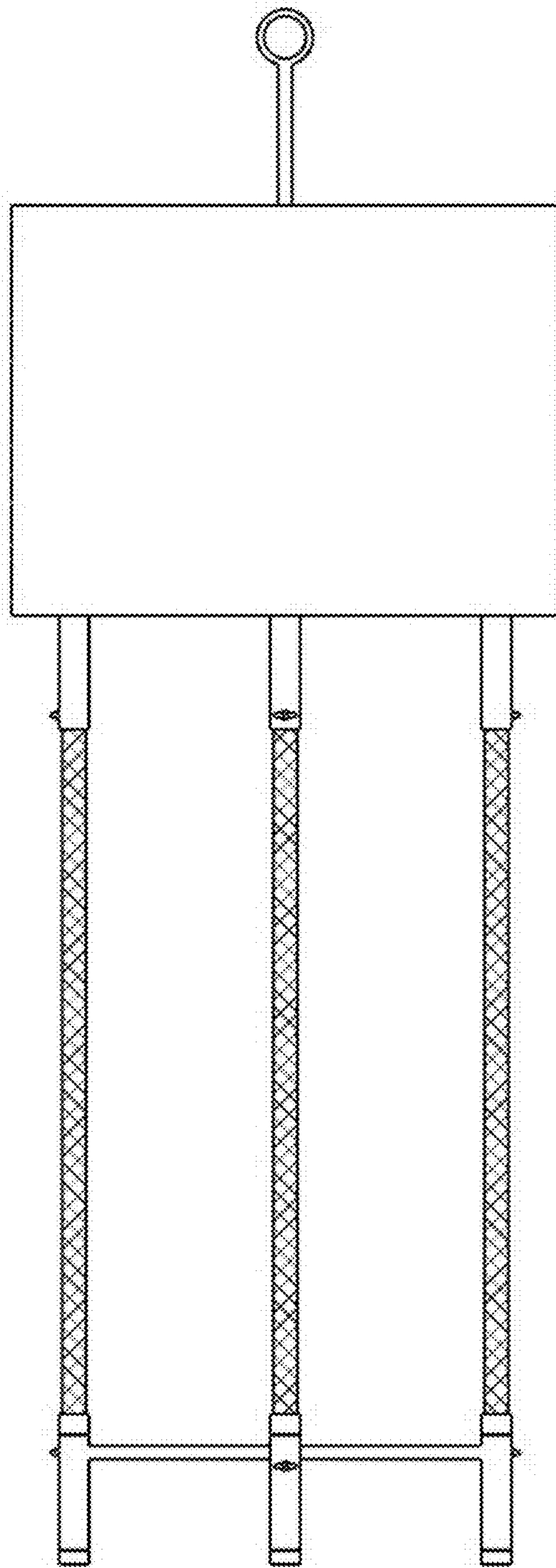

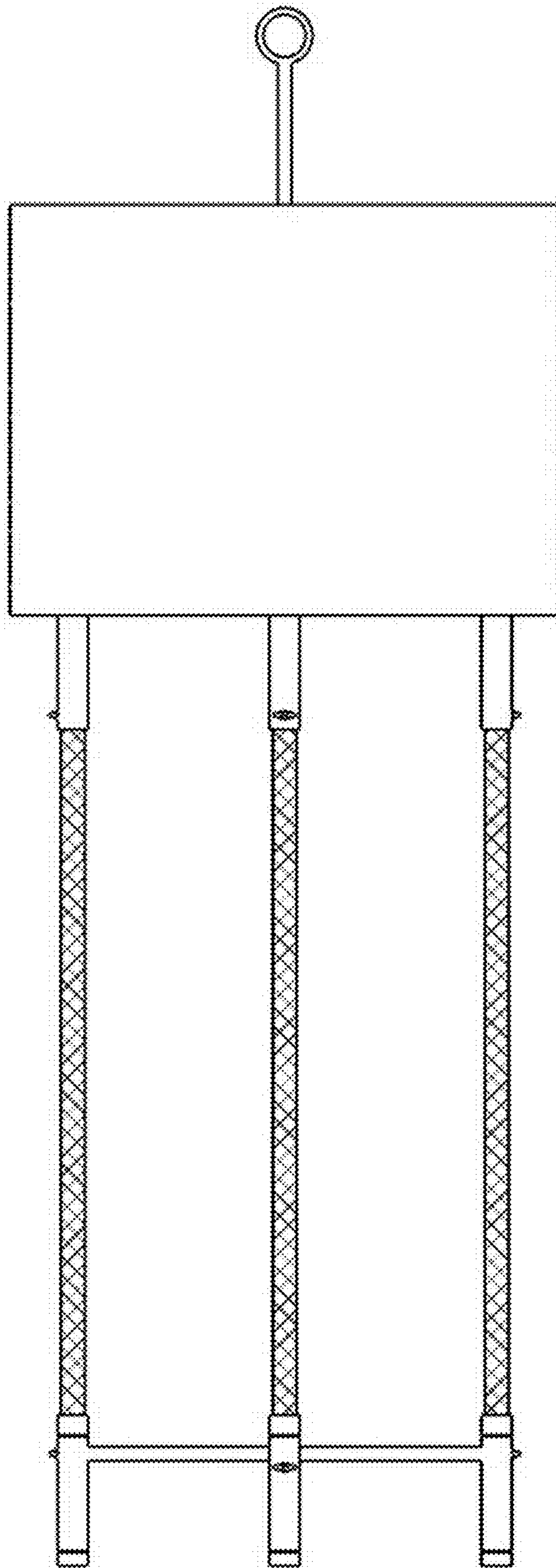




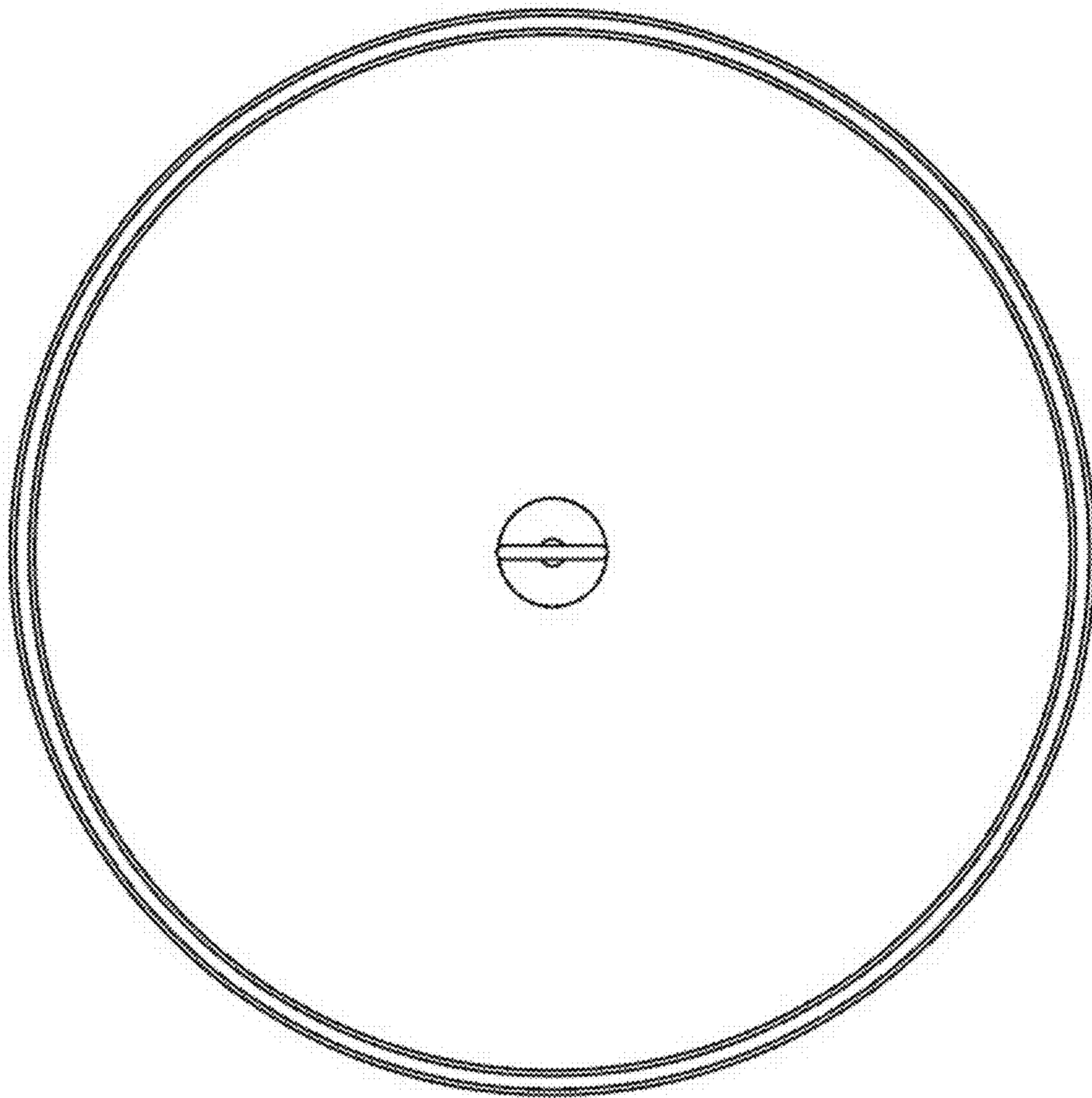

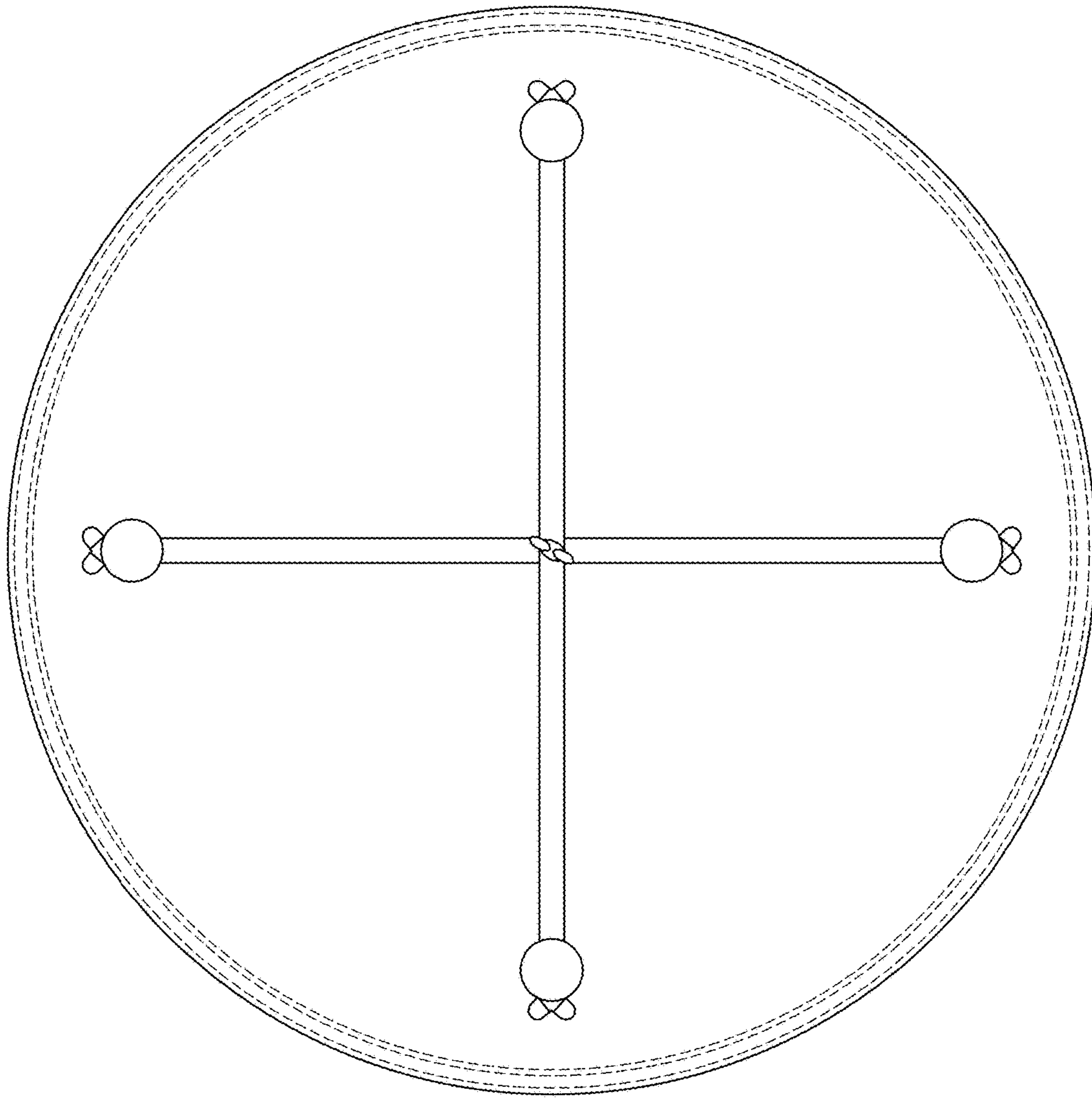
