Fig. 1.4 is a left side elevational view thereof;

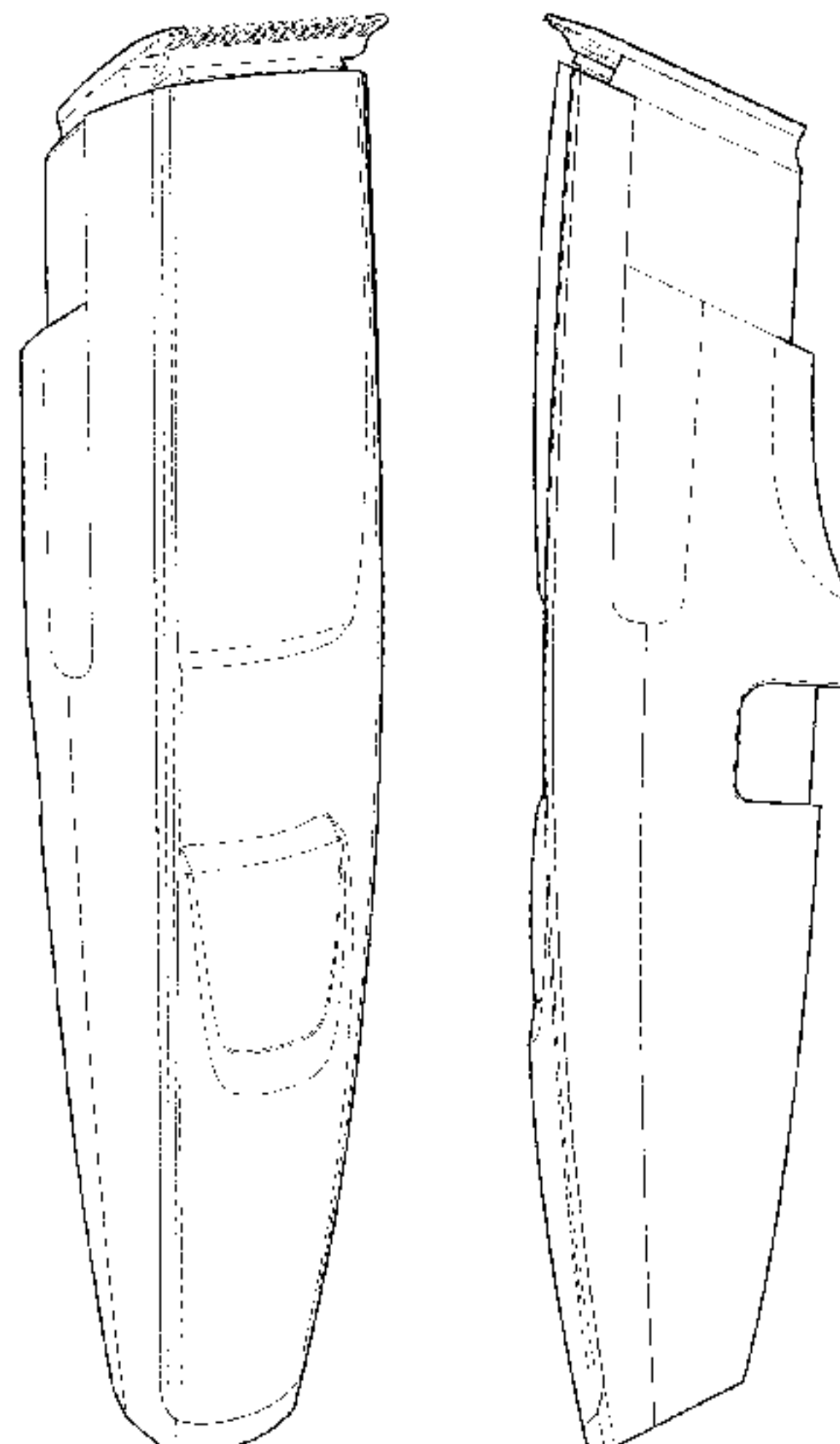
Fig. 1.5 is a right side elevational view thereof;

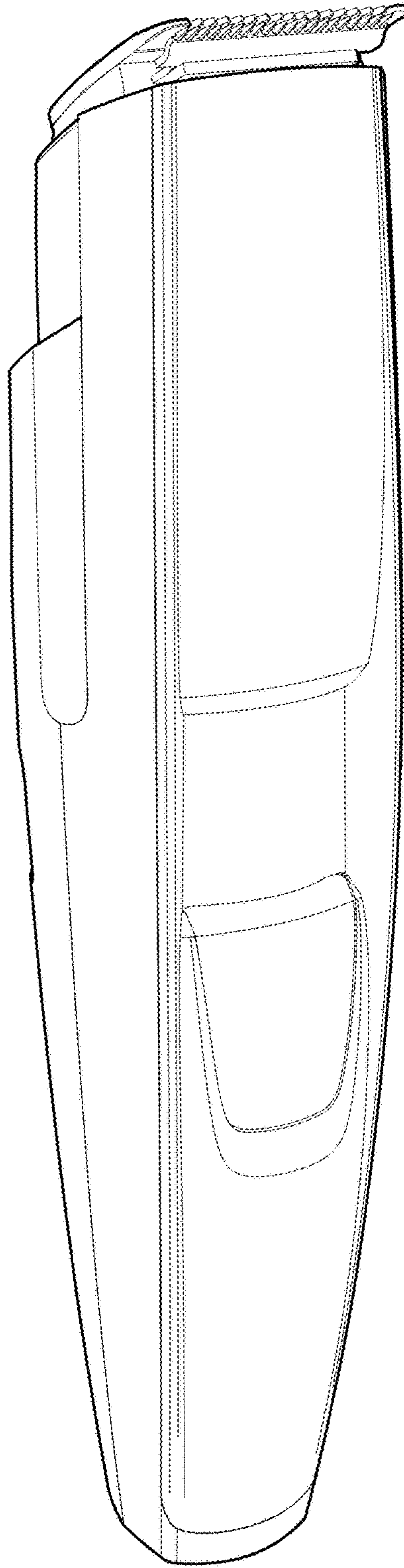
Fig. 1.6 is a top plan view thereof; and

Fig. 1.7 is a bottom view thereof.

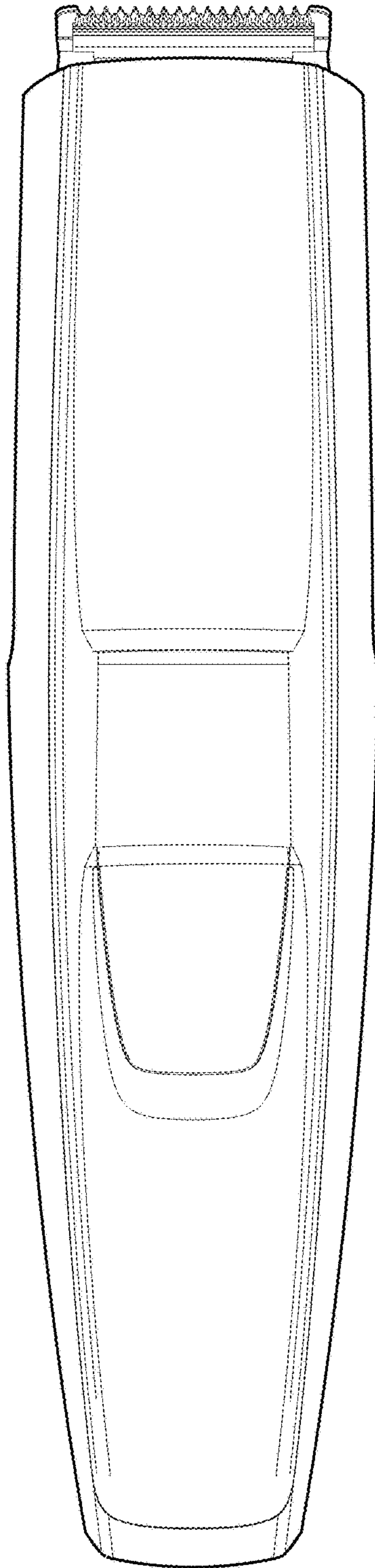
The portions of the beard trimmer shown in broken lines are included for the purpose of illustrating unclaimed portions of the beard trimmer and form no part of the claimed design.

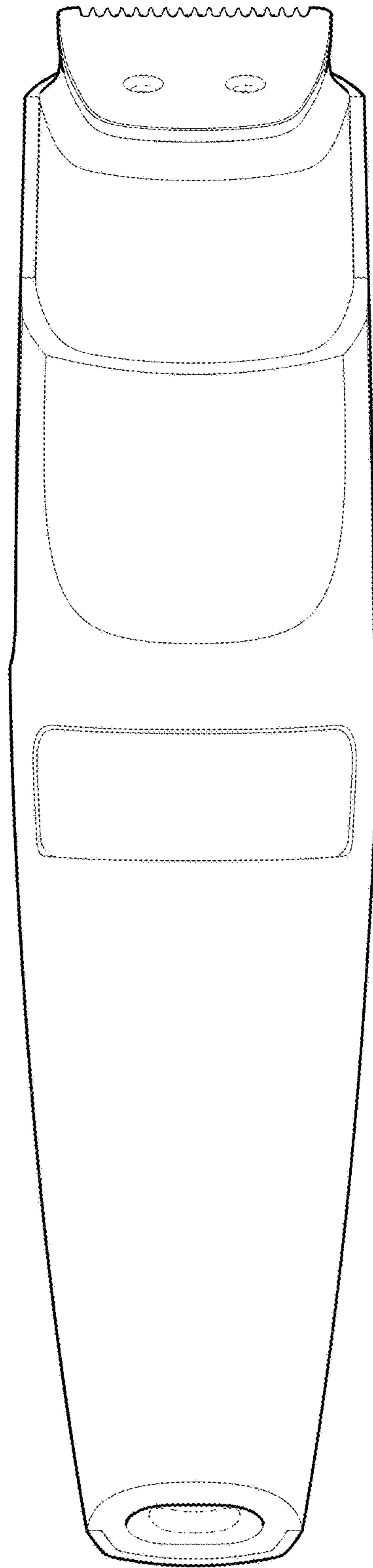




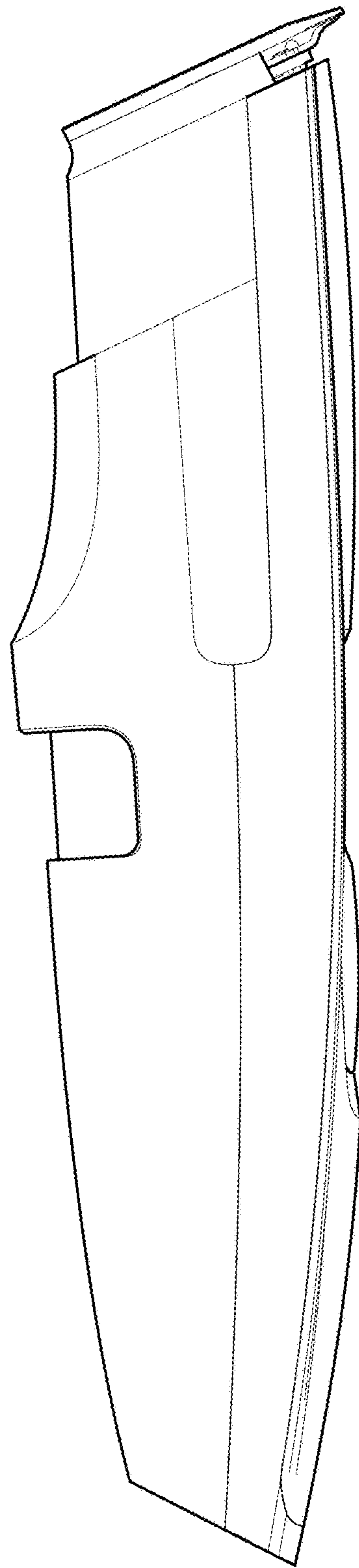

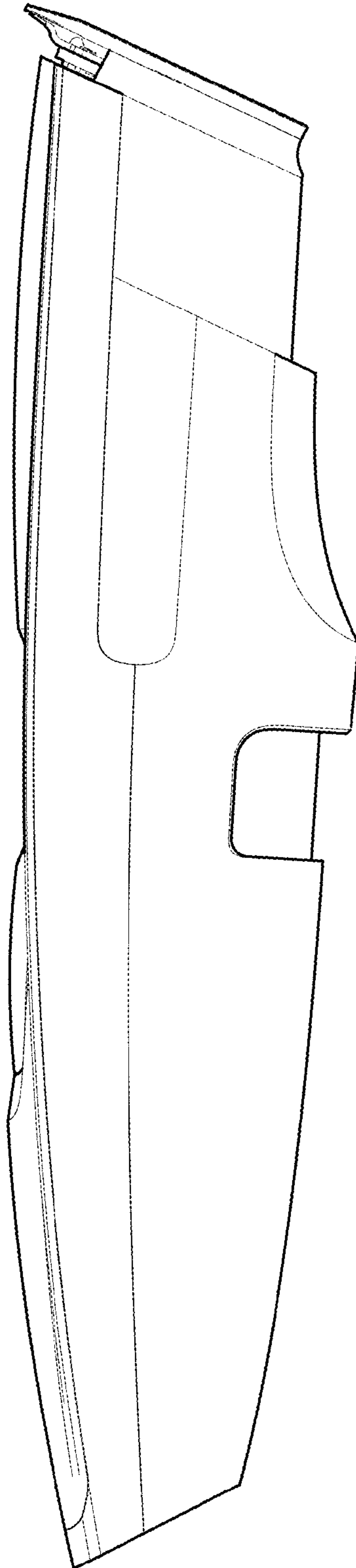

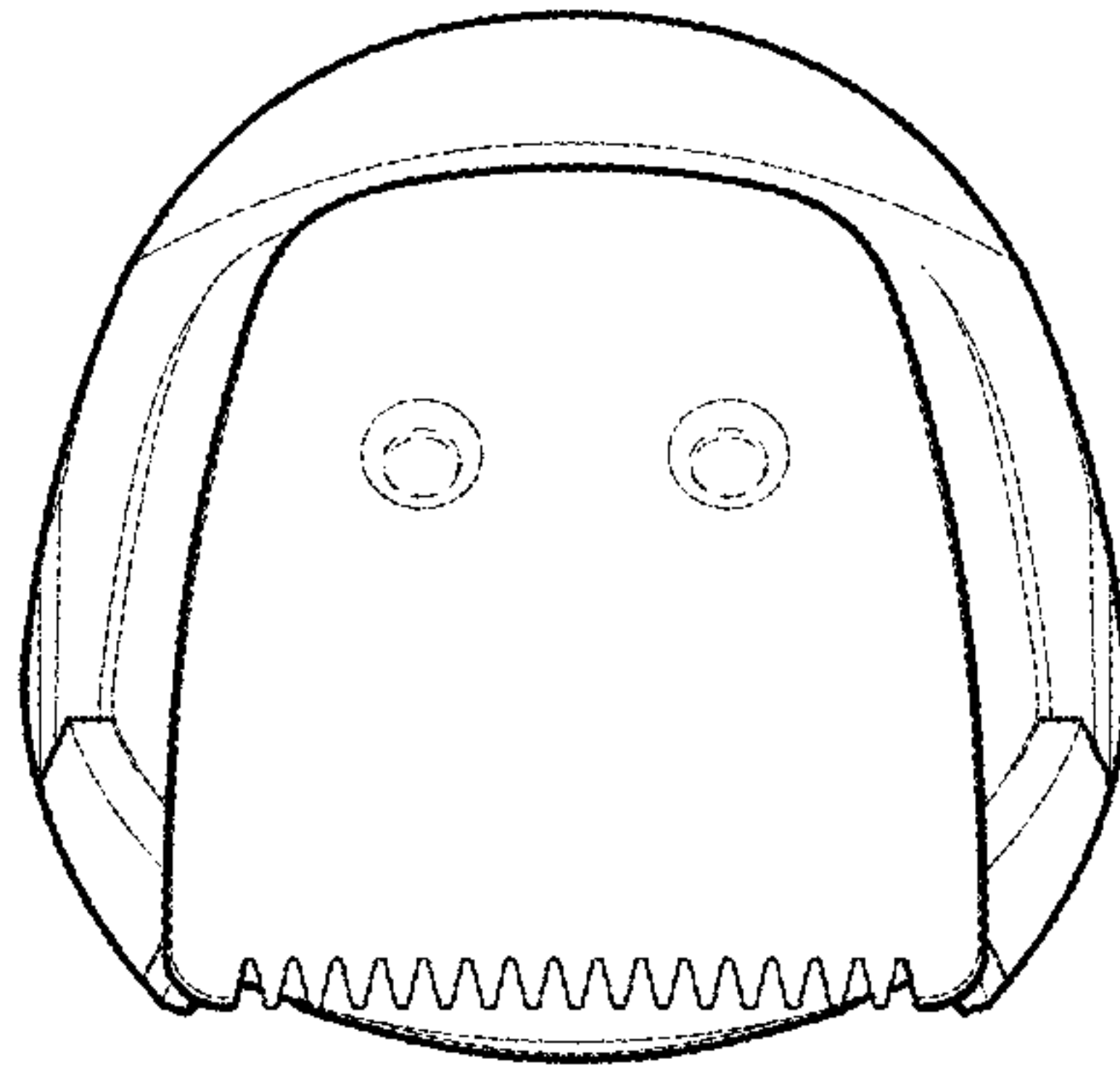

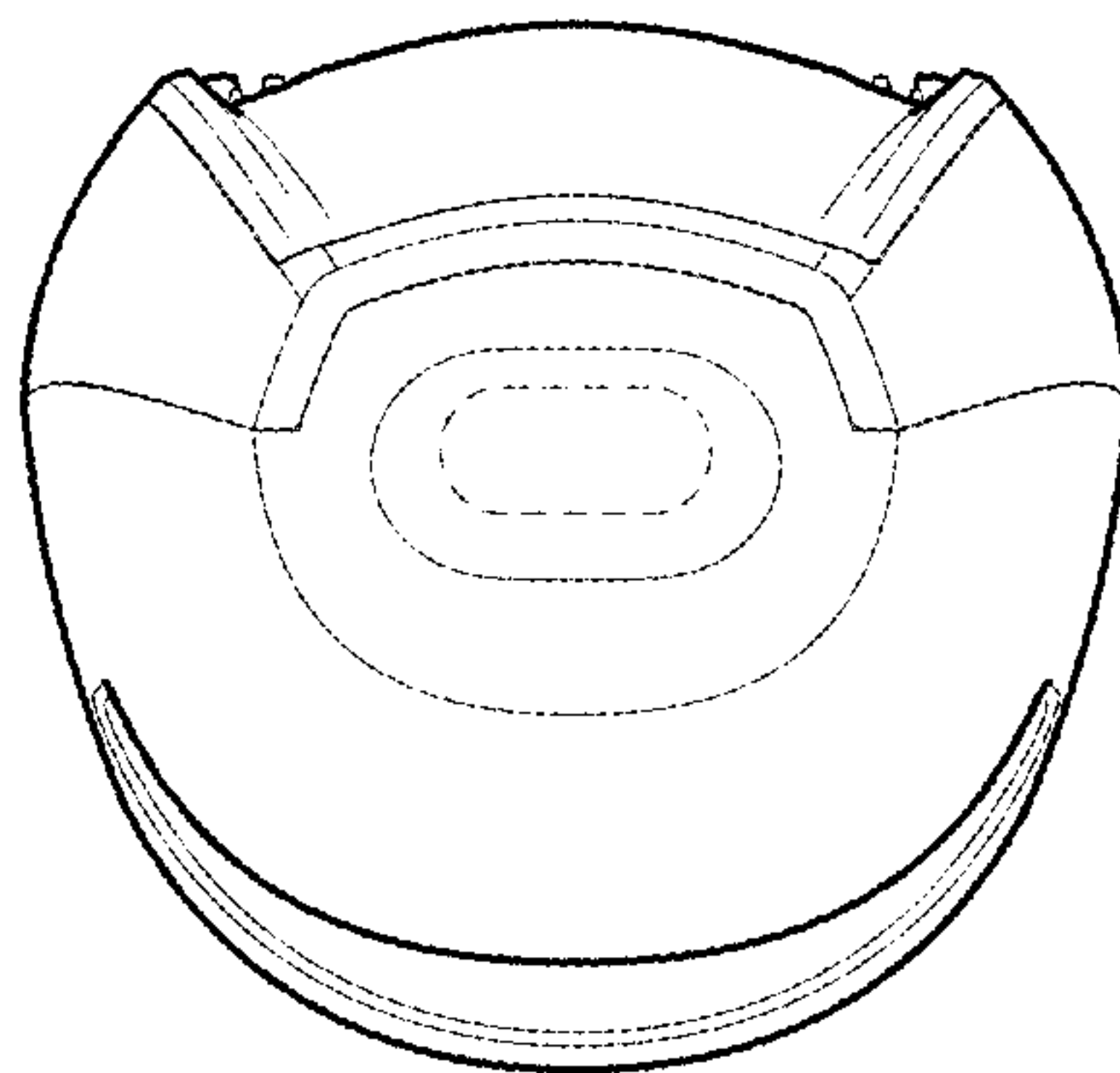
