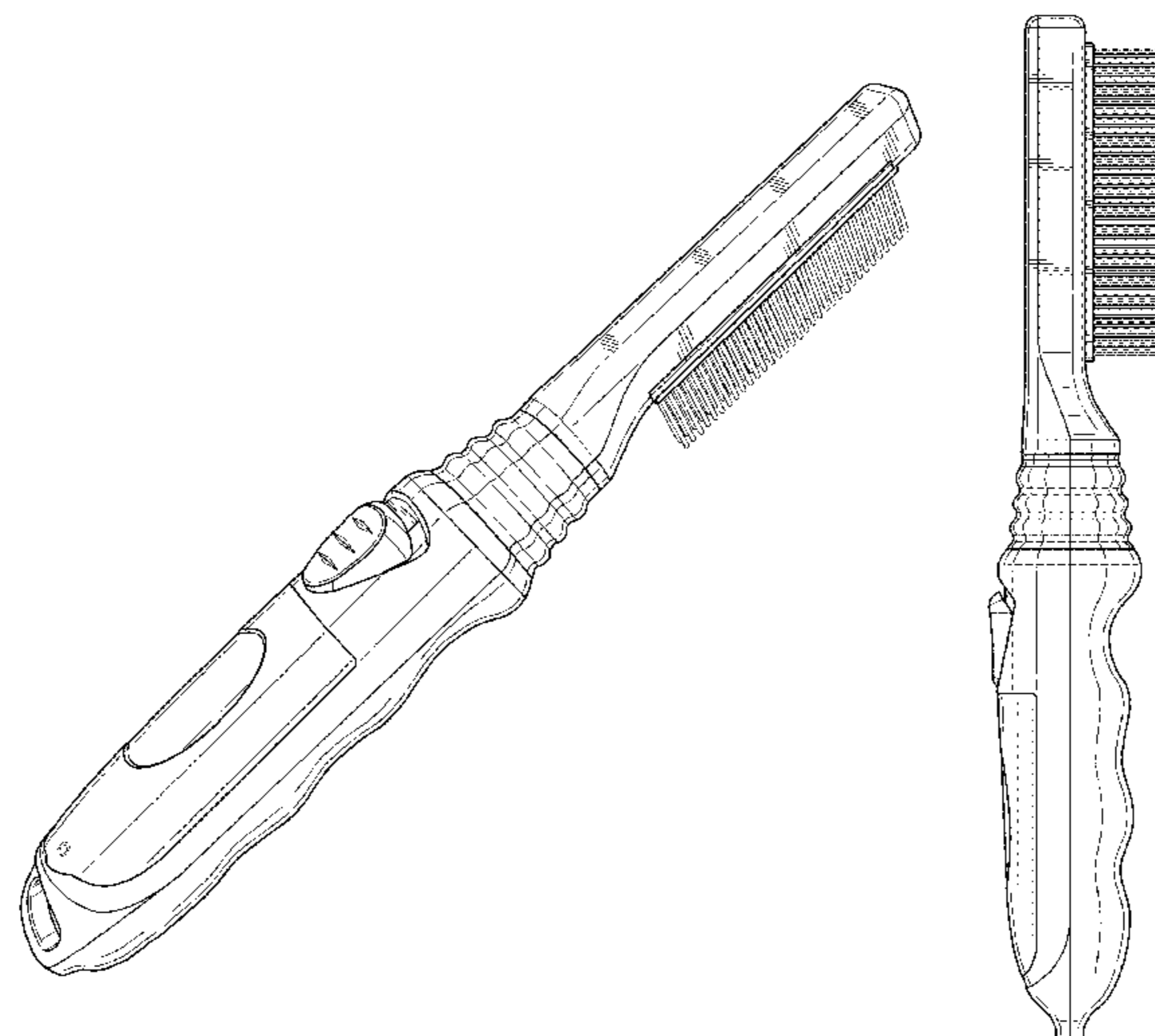
(57) **CLAIM**

and described.

DESCRIPTION

FIG. 1 is a perspective view of a flea comb of the present
invention;
FIG. 2 is a back view of the flea comb of FIG. 1;
FIG. 3 is a front view of the flea comb of FIG. 1;
FIG. 4 is a left side view of the flea comb of FIG. 1, the right
side view being a mirror image thereof;
FIG. 5 is a top end view of the flea comb of FIG. 1; and,
FIG. 6 is a bottom end view of the flea comb of FIG. 1.

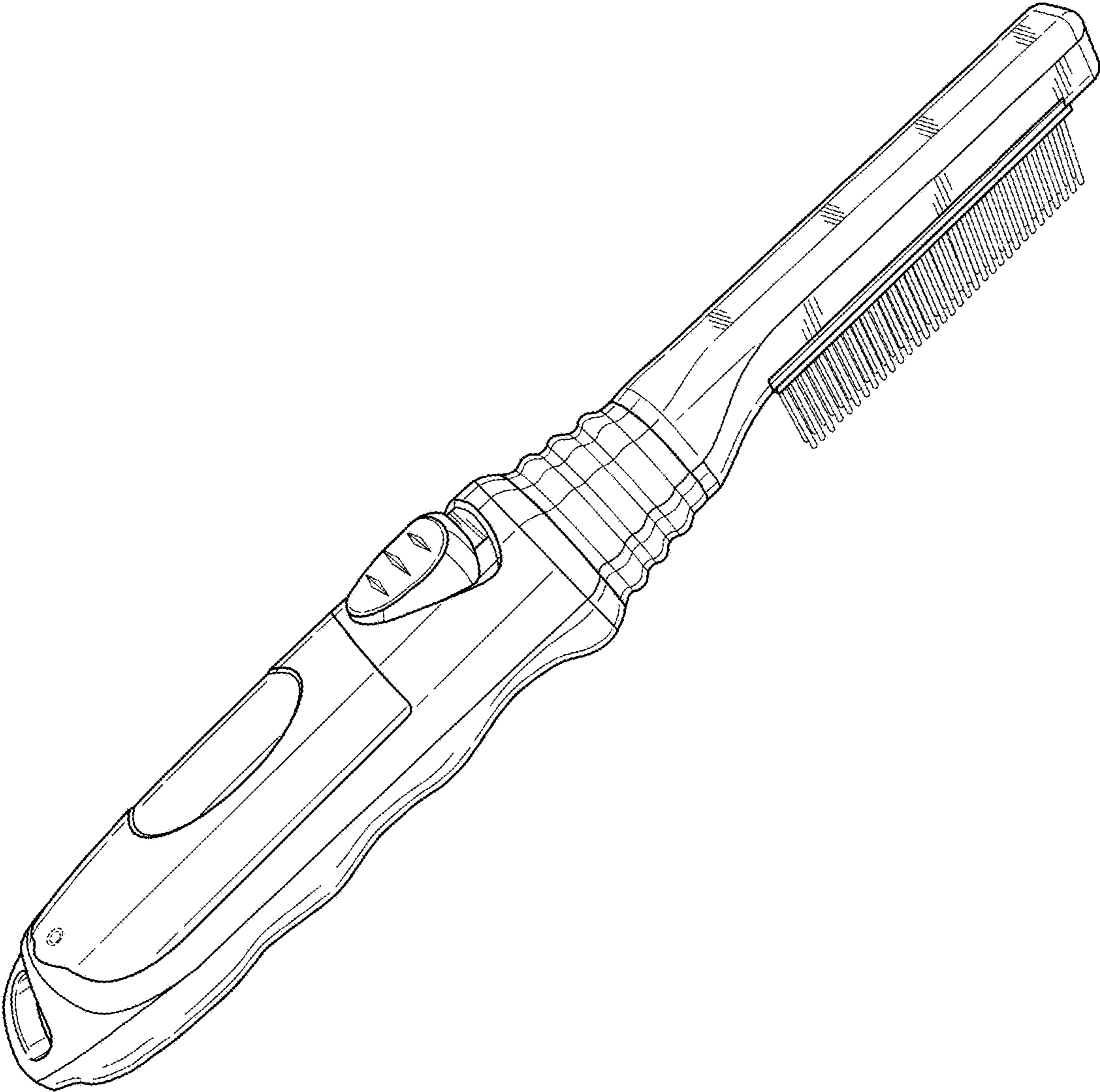

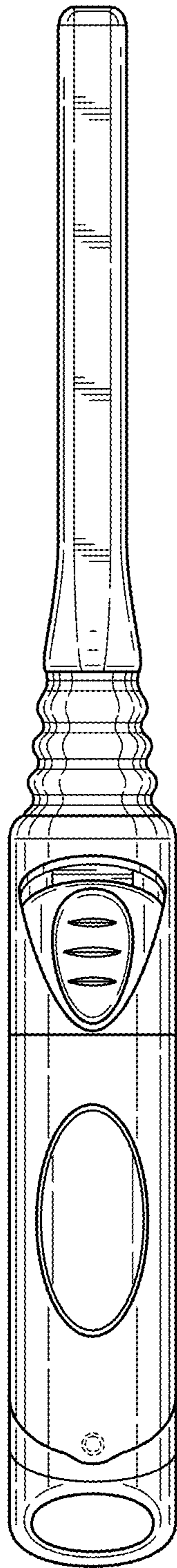

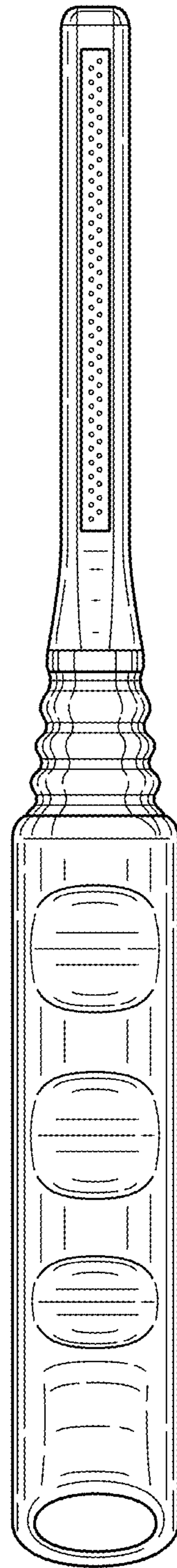

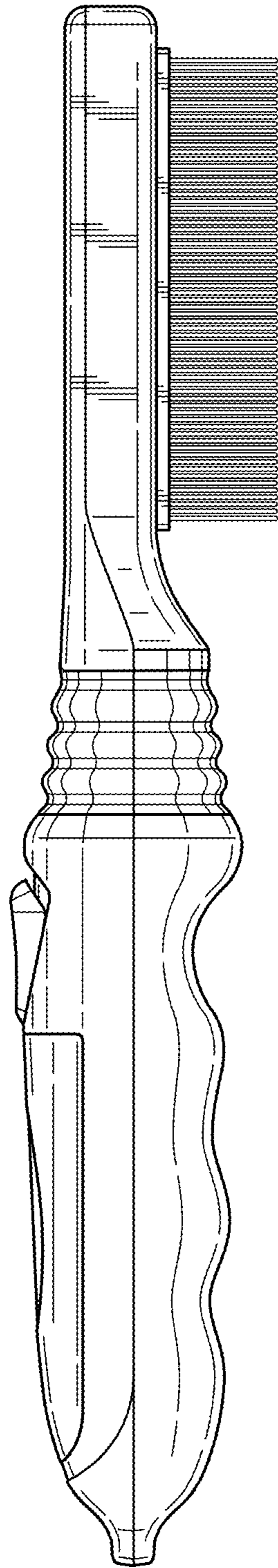

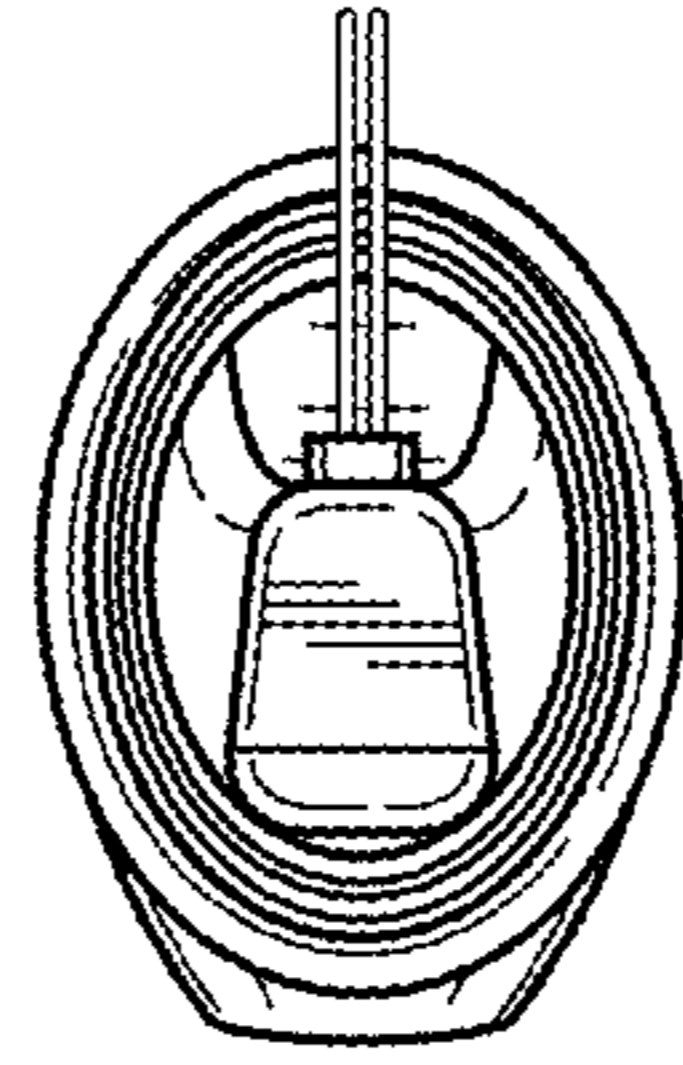

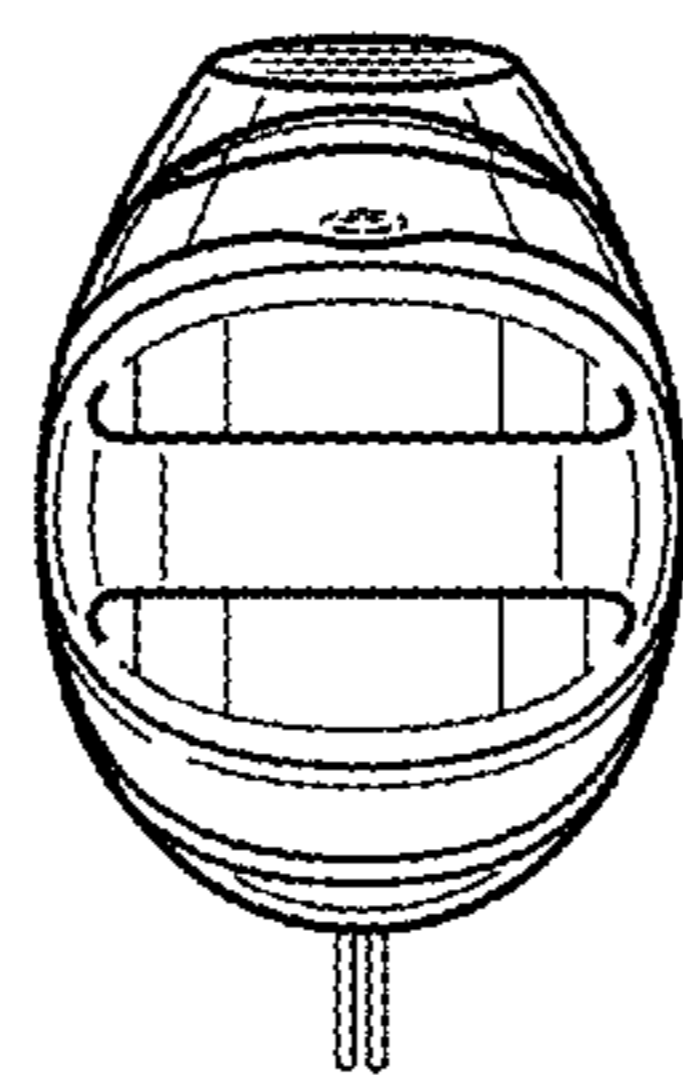
