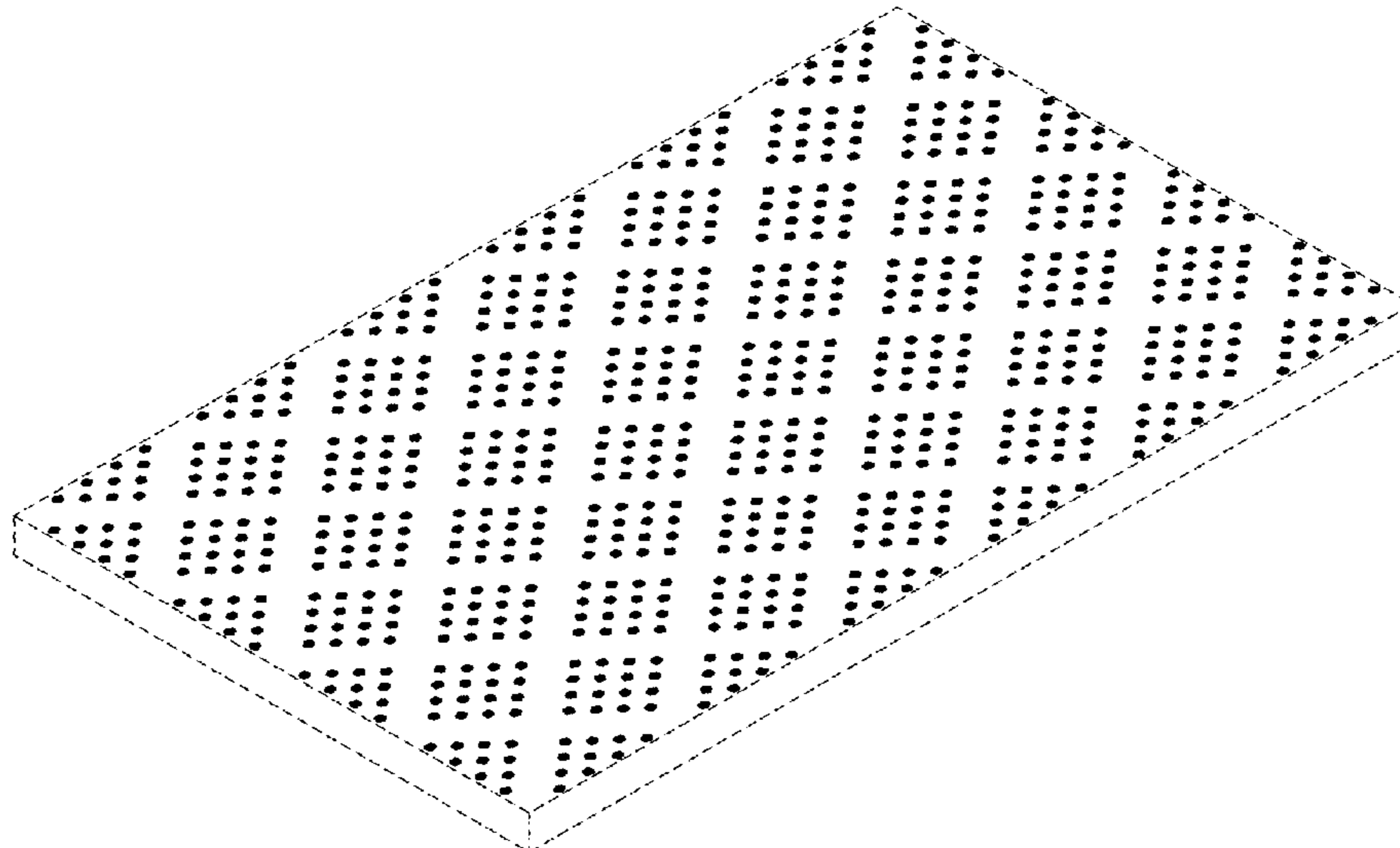
(57) **CLAIM**

The ornamental design for a nonwoven abrasive with dot surface pattern, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a nonwoven abrasive with dot surface pattern showing the new design;
 FIG. 2 is a top view thereof;
 FIG. 3 is a bottom view thereof;
 FIG. 4 is a front view thereof, the rear view being a mirror image of the front view shown; and,
 FIG. 5 is a left side view thereof, the right side view being a mirror image of the left side view shown.
 The broken lines which define the bounds of the claimed design form no part thereof.

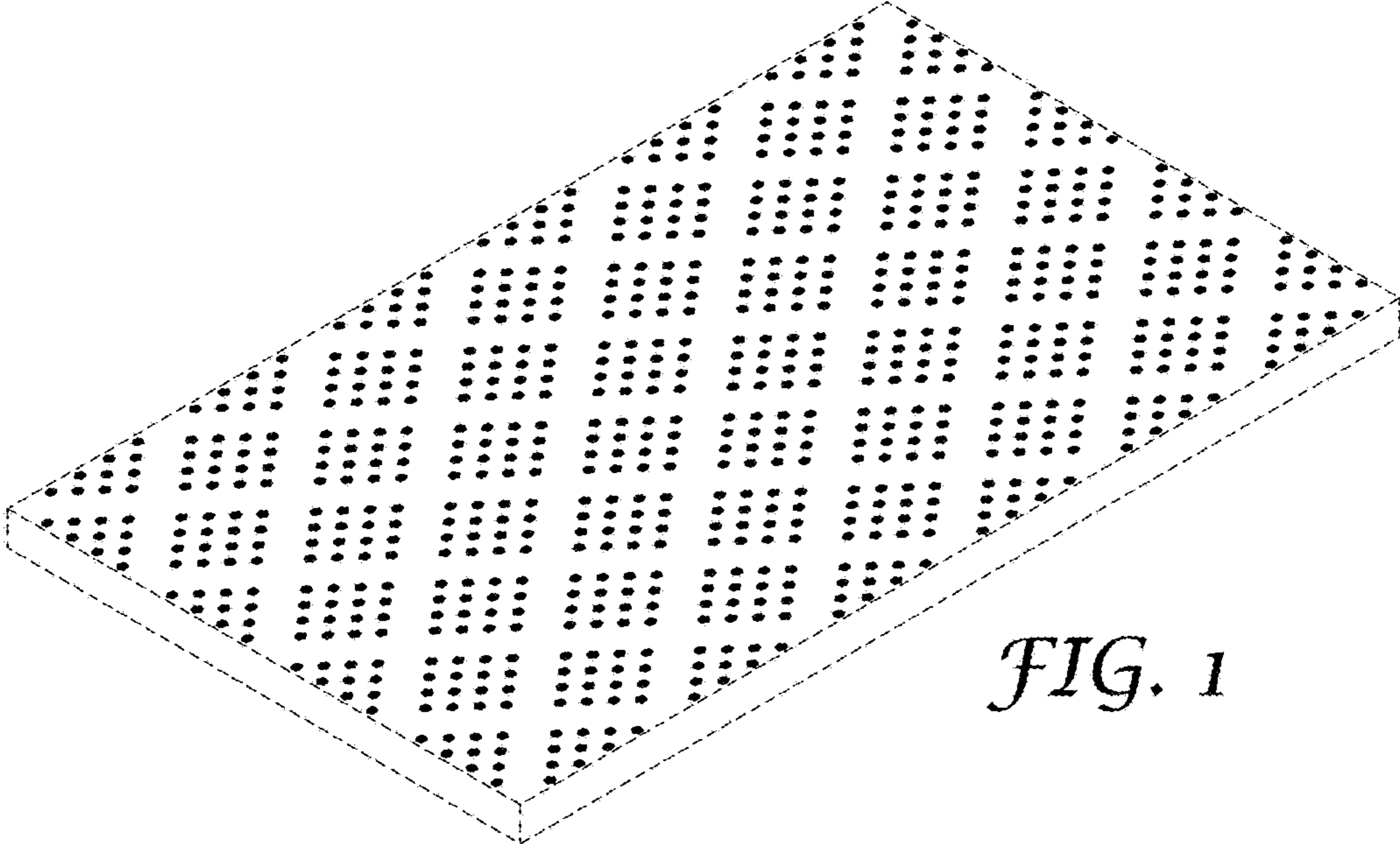

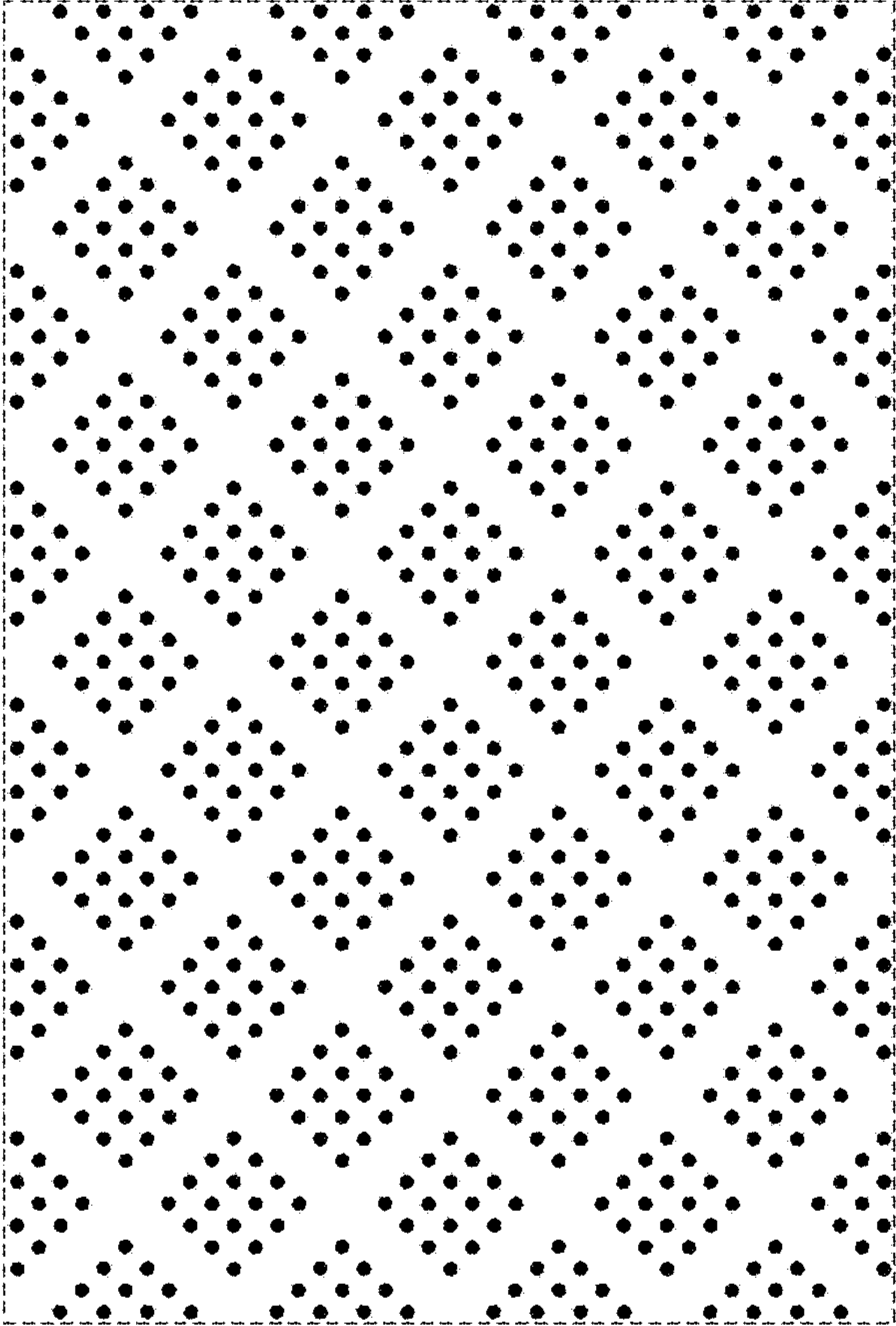
