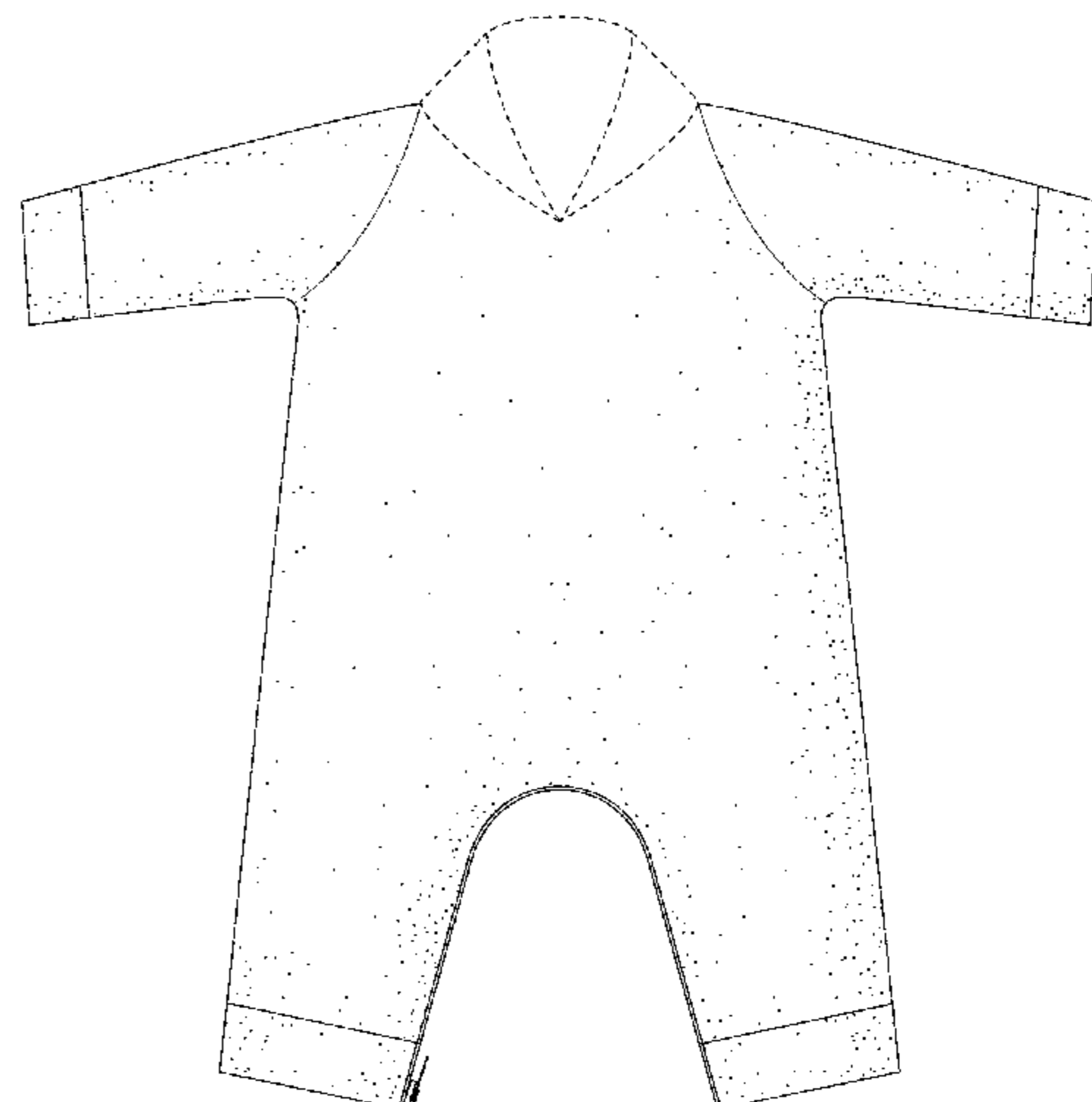
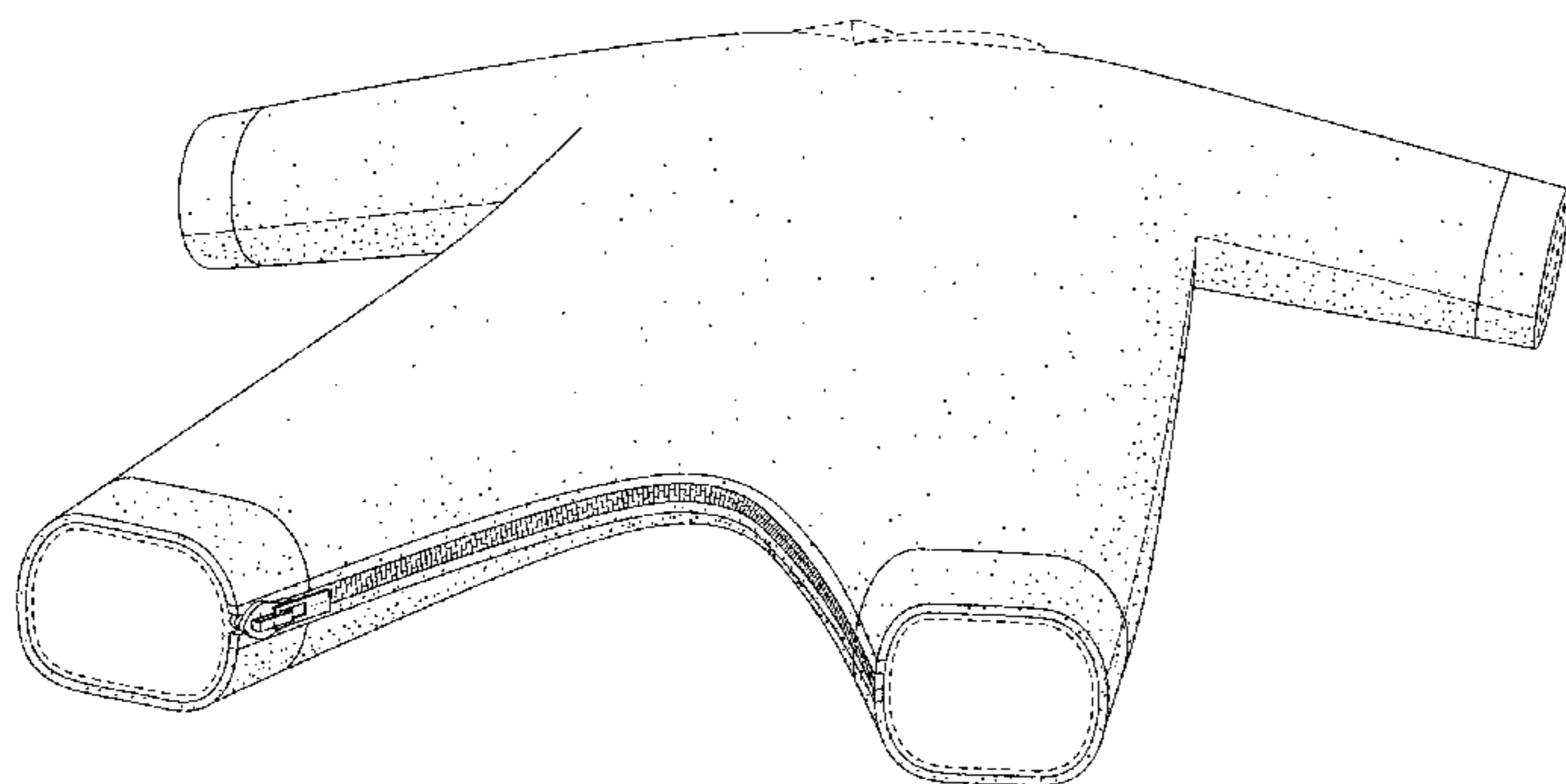
The ornamental design for a one piece baby garment with a zipper inseam, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of a one piece baby garment with a zipper inseam;
FIG. 2 is a front plan view of the one piece baby garment with a zipper inseam of FIG. 1;
FIG. 3 is a back plan view of the one piece baby garment with a zipper inseam of FIG. 1;
FIG. 4 is a left side elevation view of the one piece baby garment with a zipper inseam of FIG. 1;
FIG. 5 is a right side elevation view of the one piece baby garment with a zipper inseam of FIG. 1;
FIG. 6 is a top plan view of the one piece baby garment with a zipper inseam of FIG. 1;
FIG. 7 is a bottom plan view of the one piece baby garment with a zipper inseam of FIG. 1; and,
FIG. 8 is a bottom perspective view of the one piece baby garment with a zipper inseam of FIG. 1 shown in an open position.

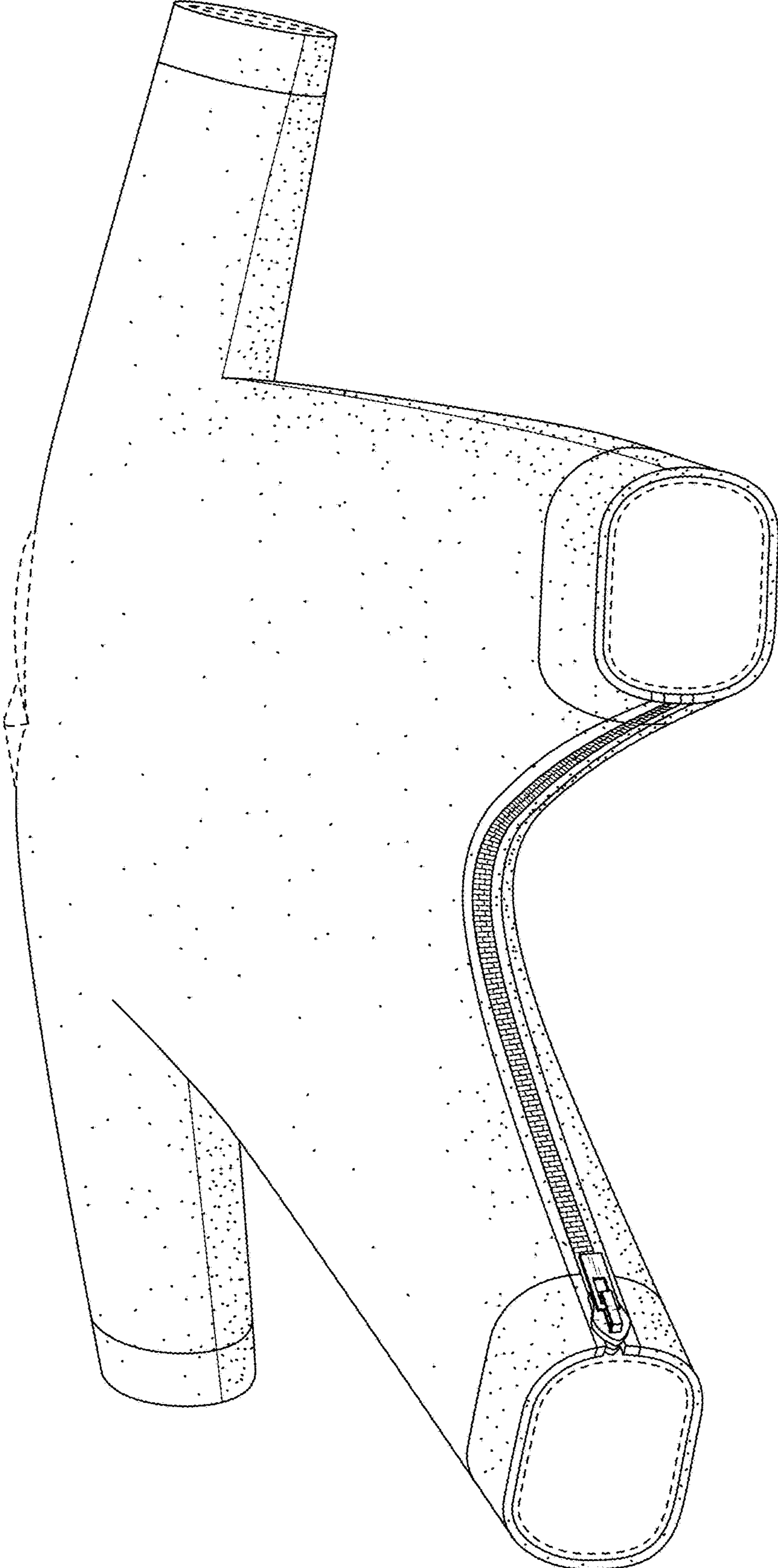

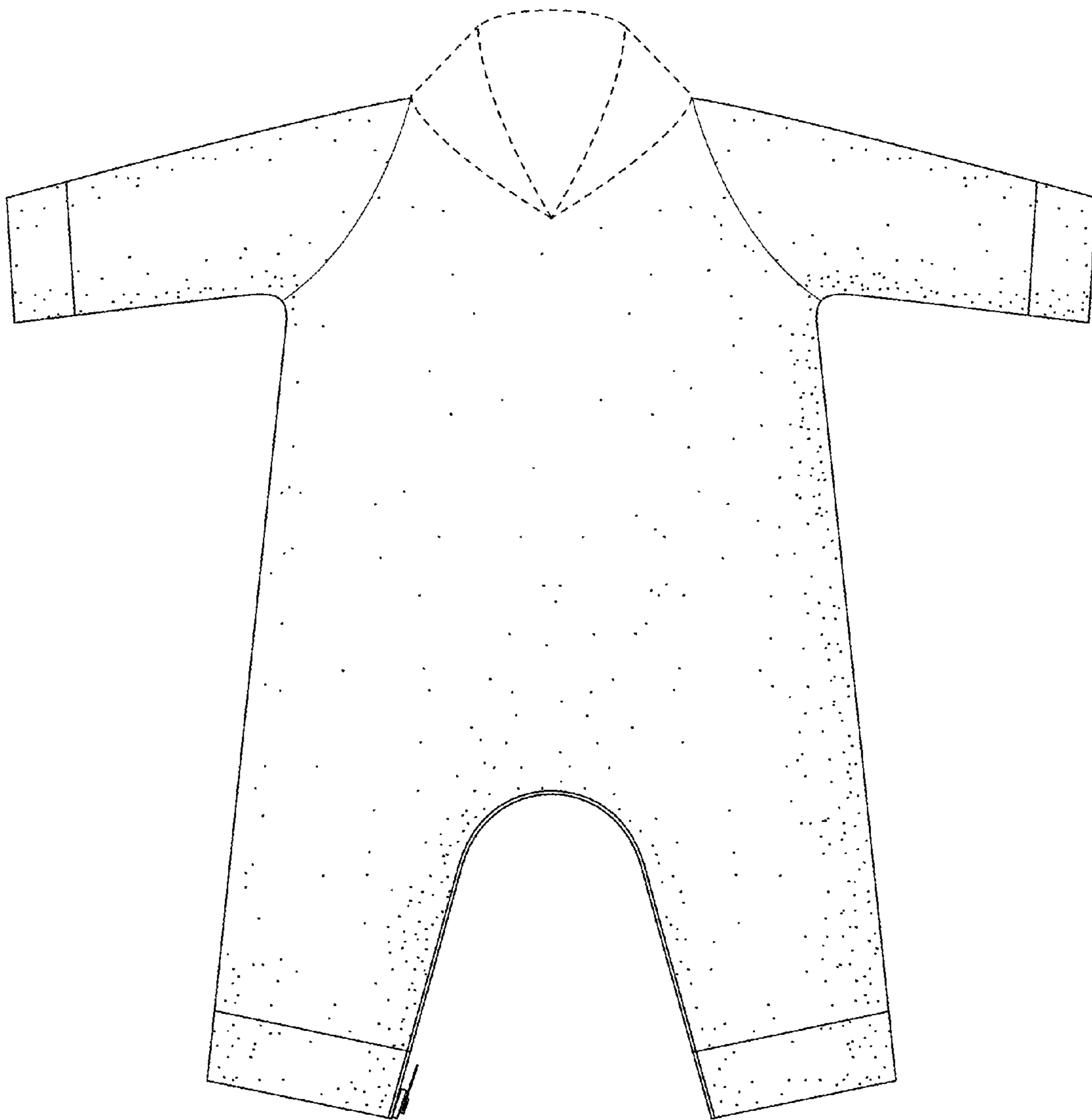

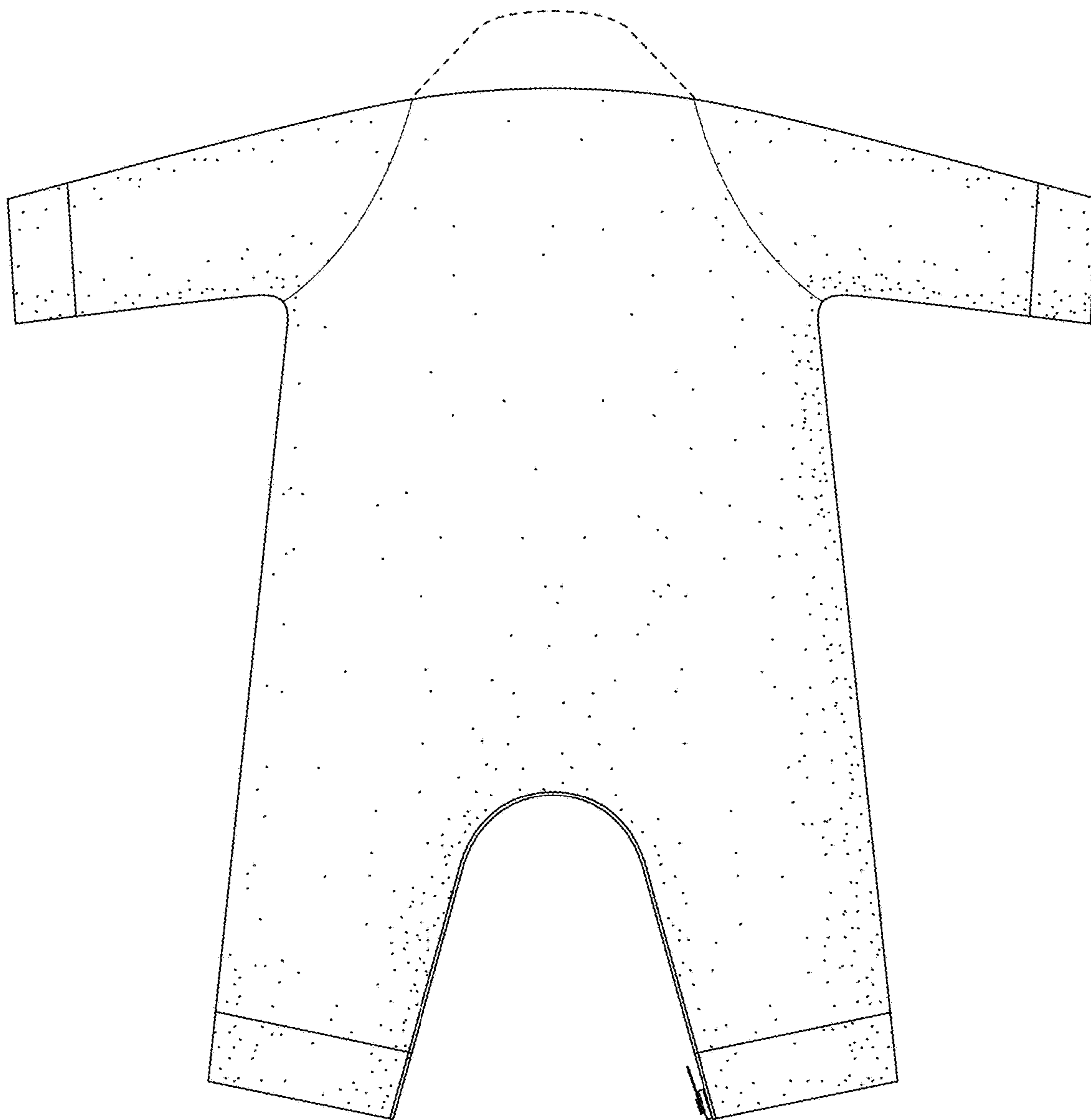

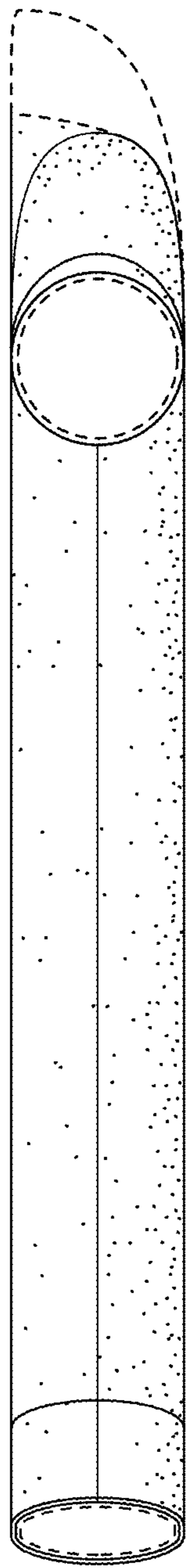

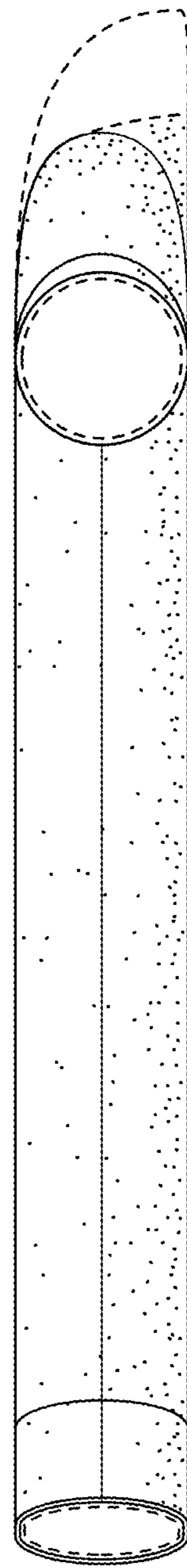

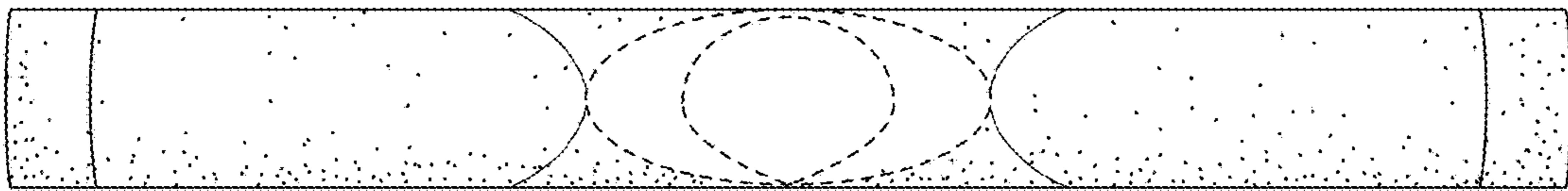

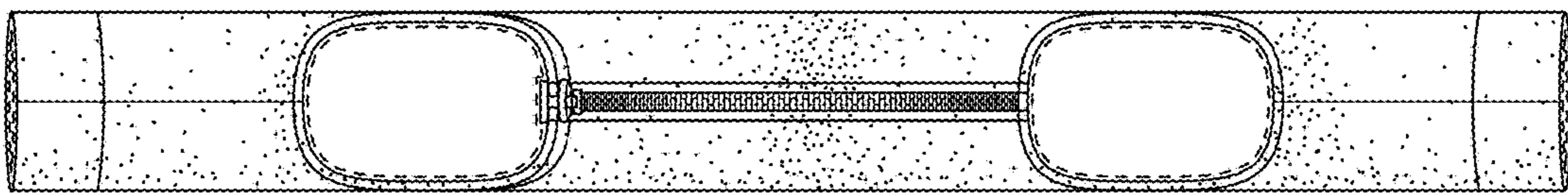

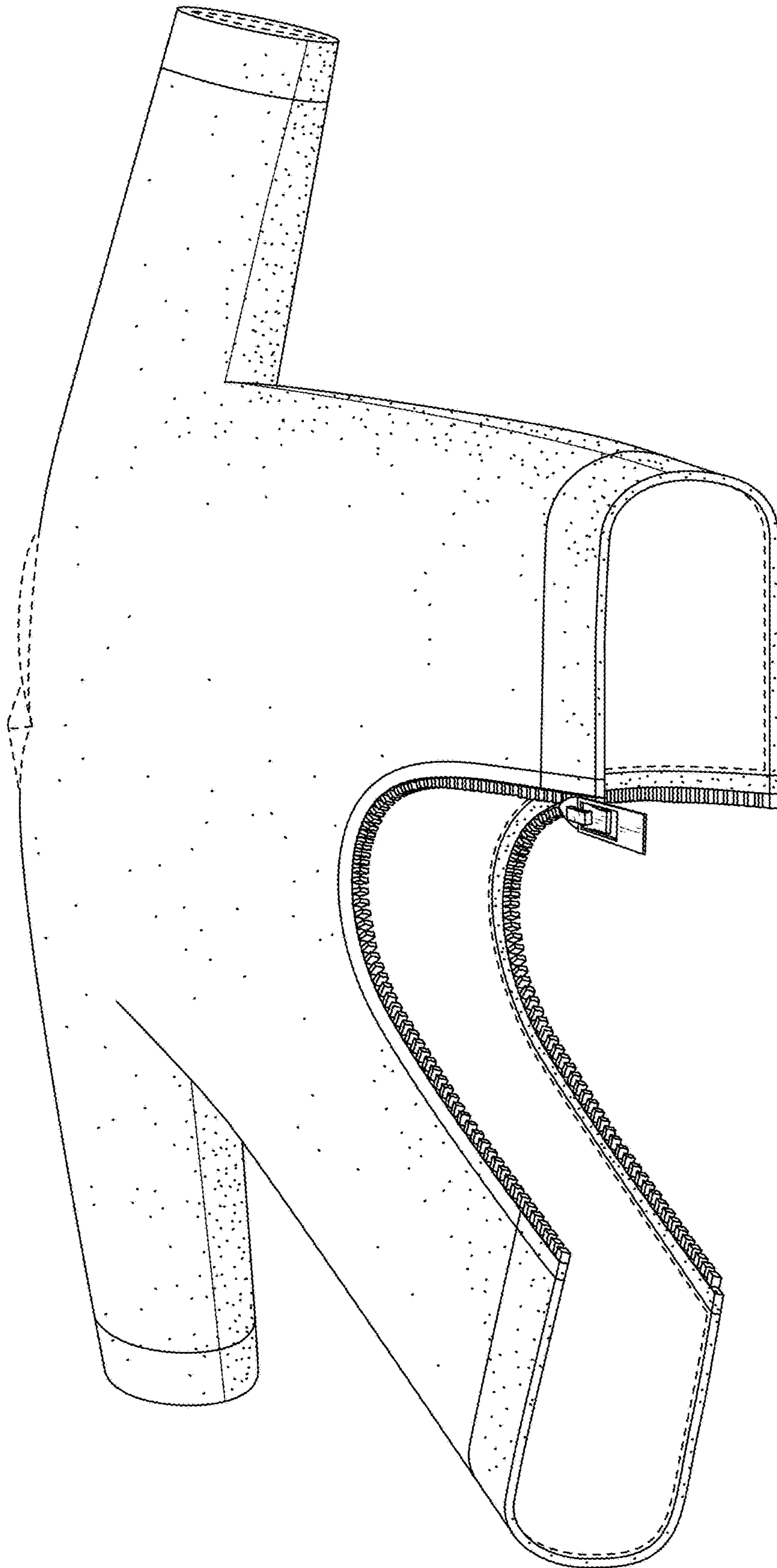
