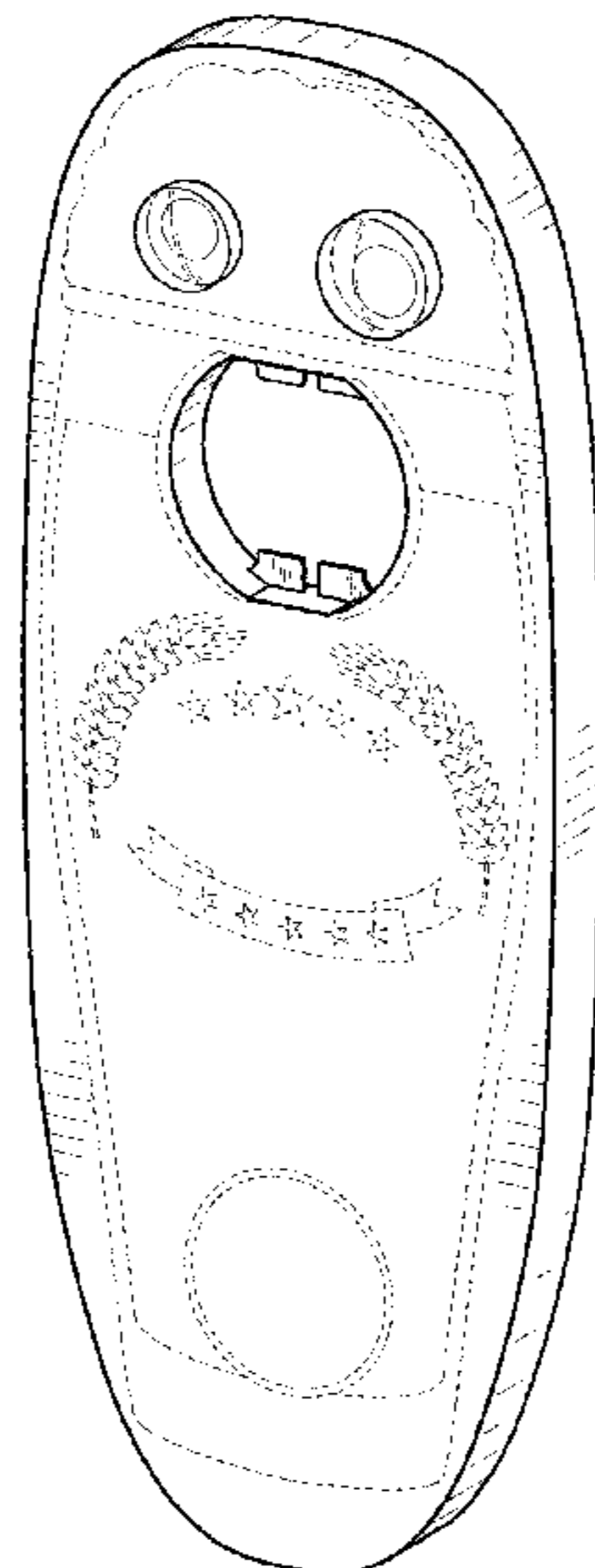
CLAIM

DESCRIPTION

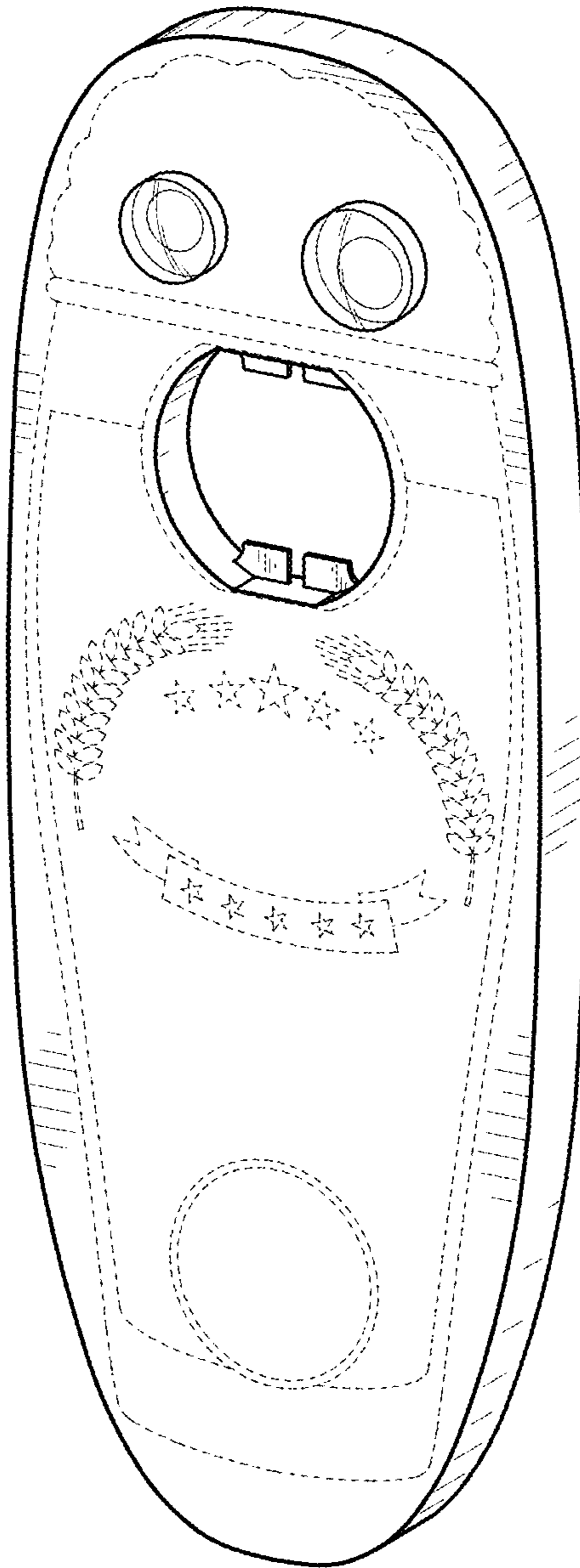

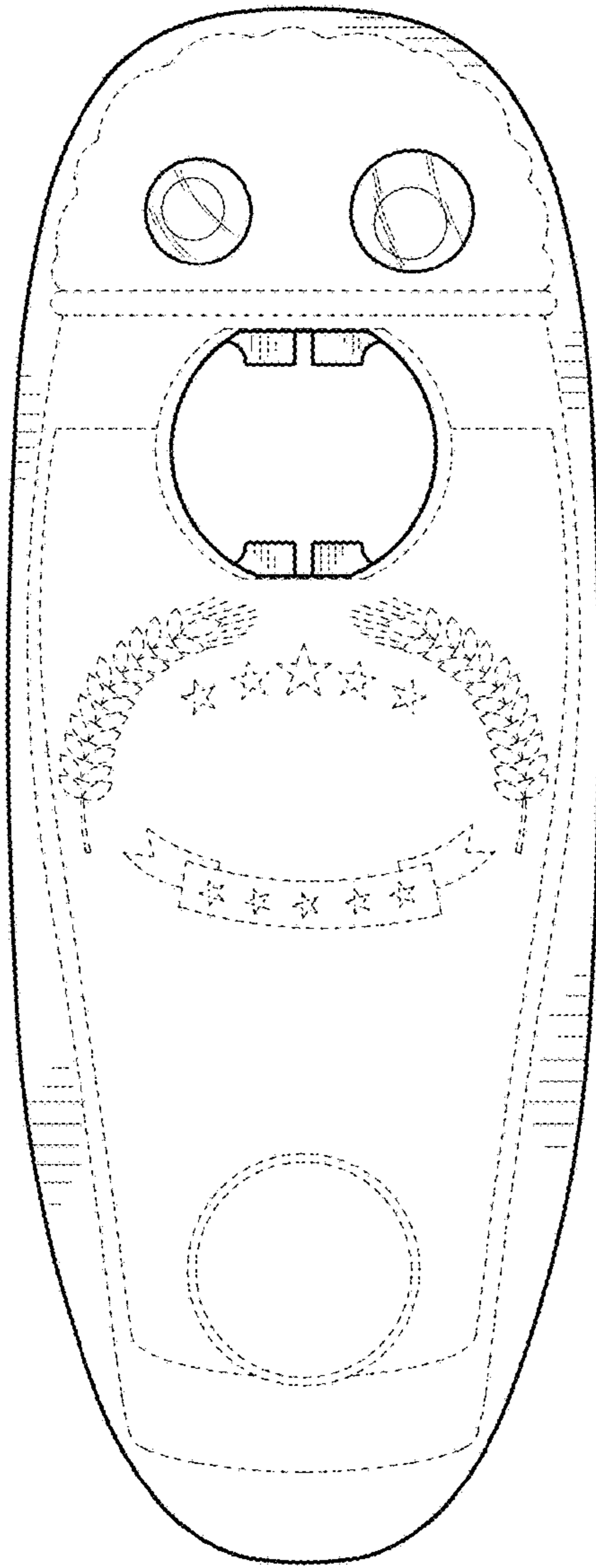

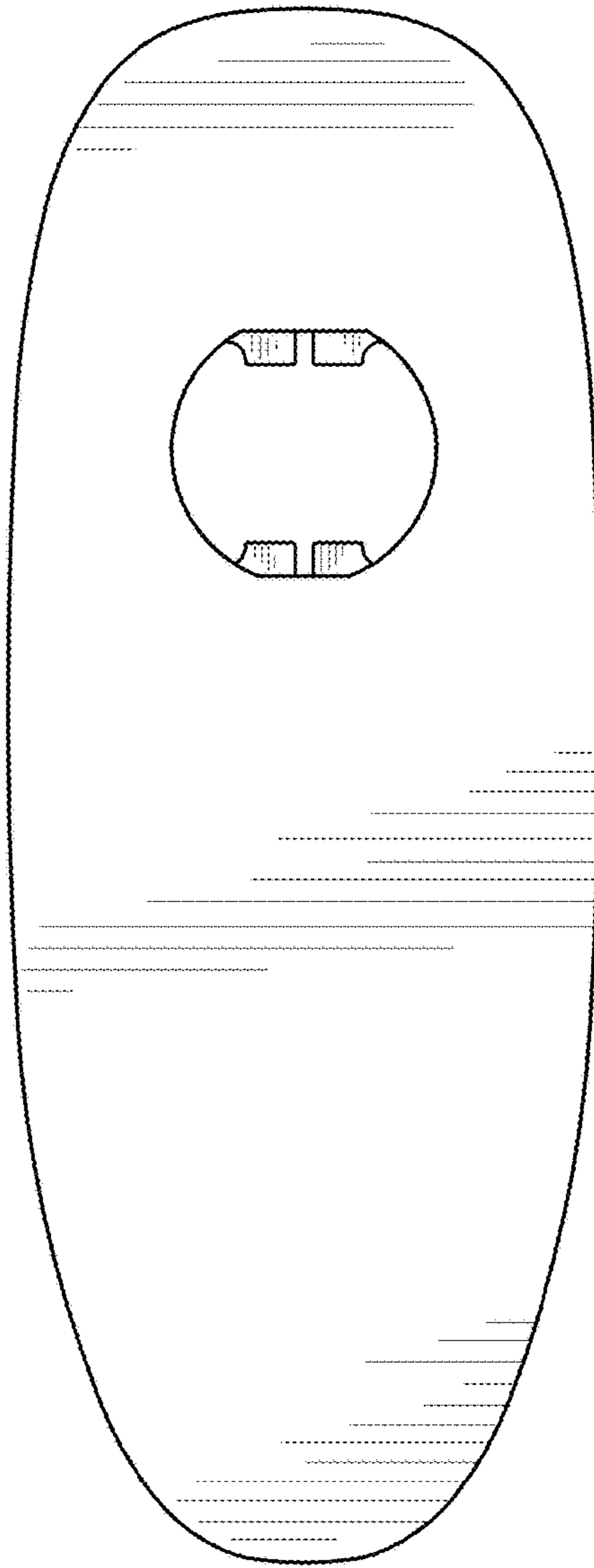

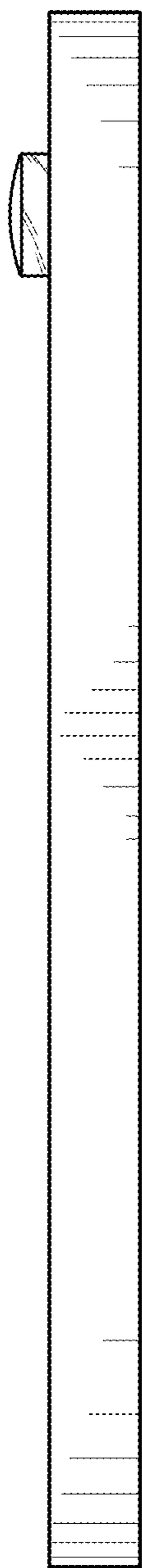

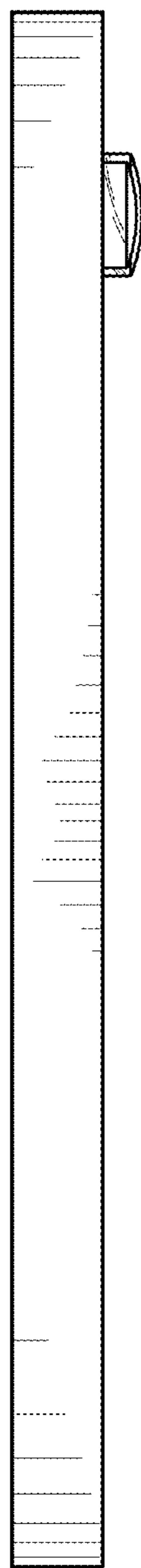

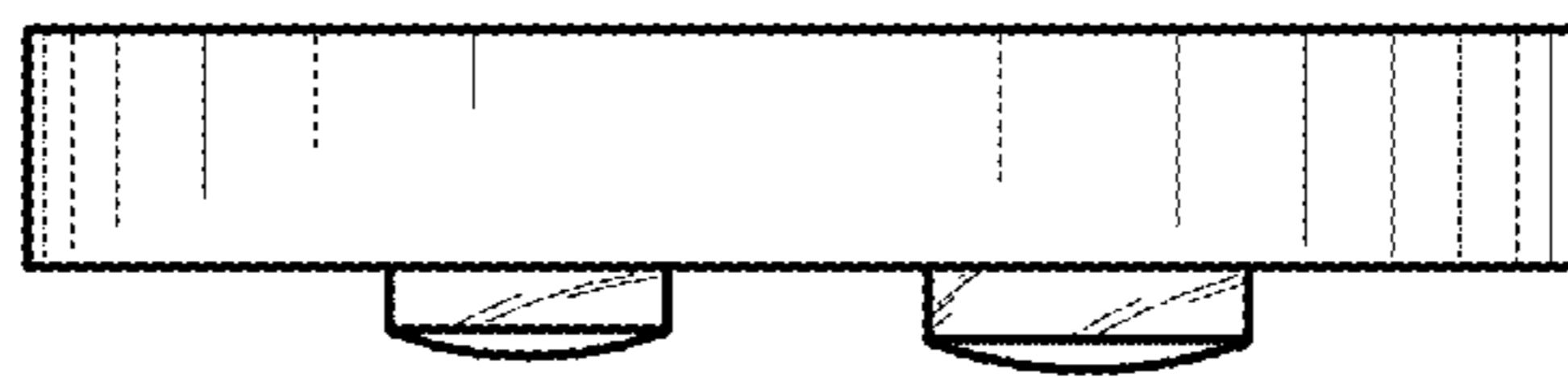

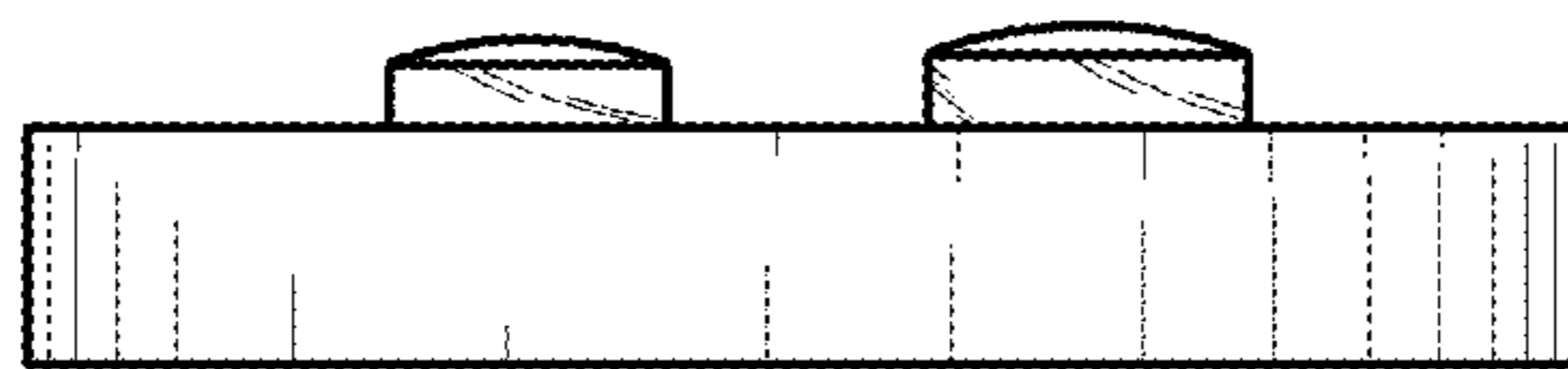
